(57) **CLAIM**

I claim the ornamental design for a guitar stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a guitar stand, showing a first embodiment of my new design;
 FIG. 2 is a right-side elevational view of FIG. 1, the left-side elevational view being a mirror image thereof;
 FIG. 3 is a top plan view of FIG. 1;
 FIG. 4 is a front elevational view of FIG. 1;
 FIG. 5 is a rear elevational view of FIG. 1;
 FIG. 6 is a bottom plan view of FIG. 1;
 FIG. 7 is a perspective view of a second embodiment thereof;
 FIG. 8 is a top plan view of FIG. 7;
 FIG. 9 is a right-side elevational view of FIG. 7, the left-side elevational view being a mirror image thereof;
 FIG. 10 is a rear elevational view thereof;
 FIG. 11 is a front elevational view thereof; and,
 FIG. 12 is a bottom plan view thereof.

The broken lines showing a guitar in FIGS. 1 and 7 depict environmental matter and form no part of the claimed design.

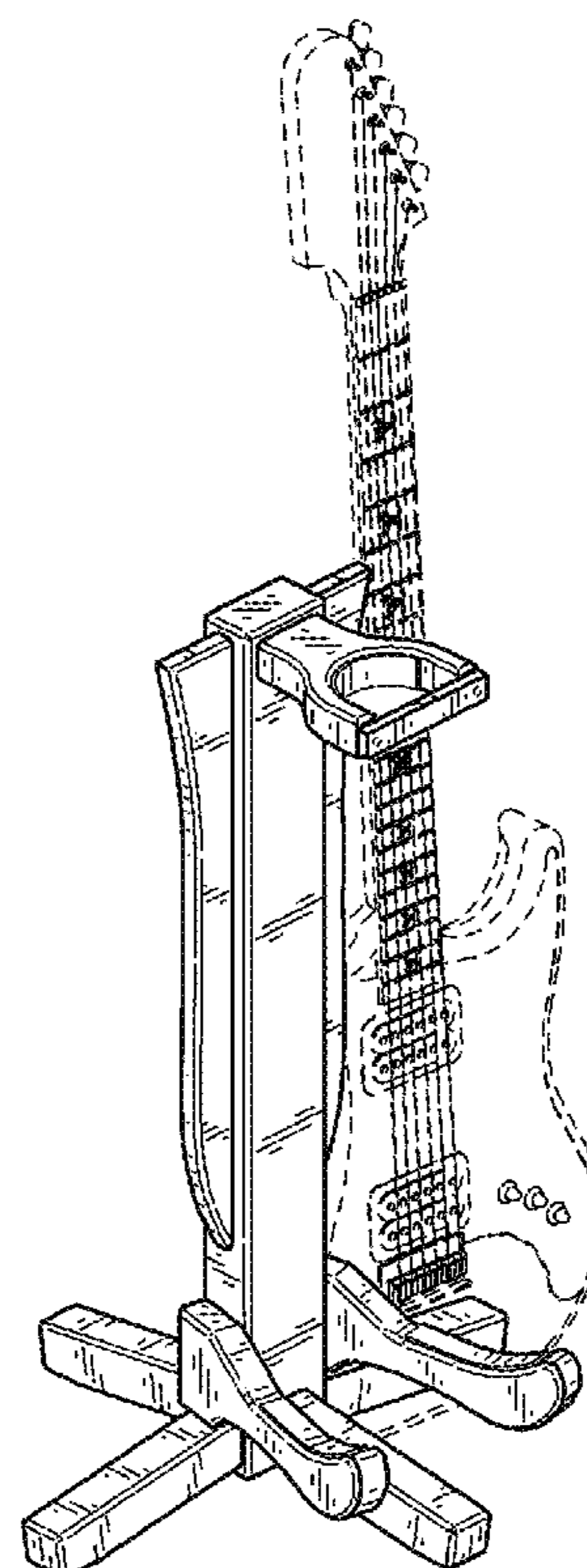
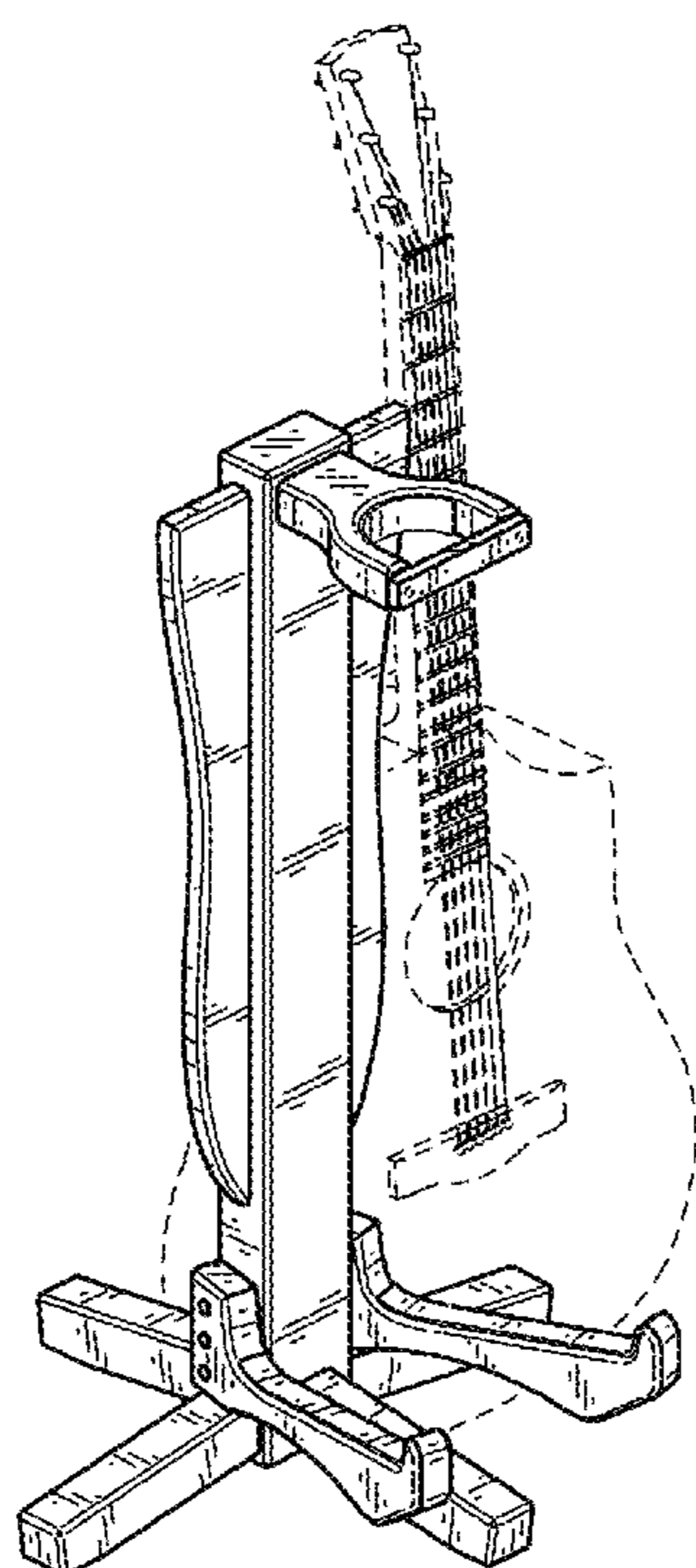

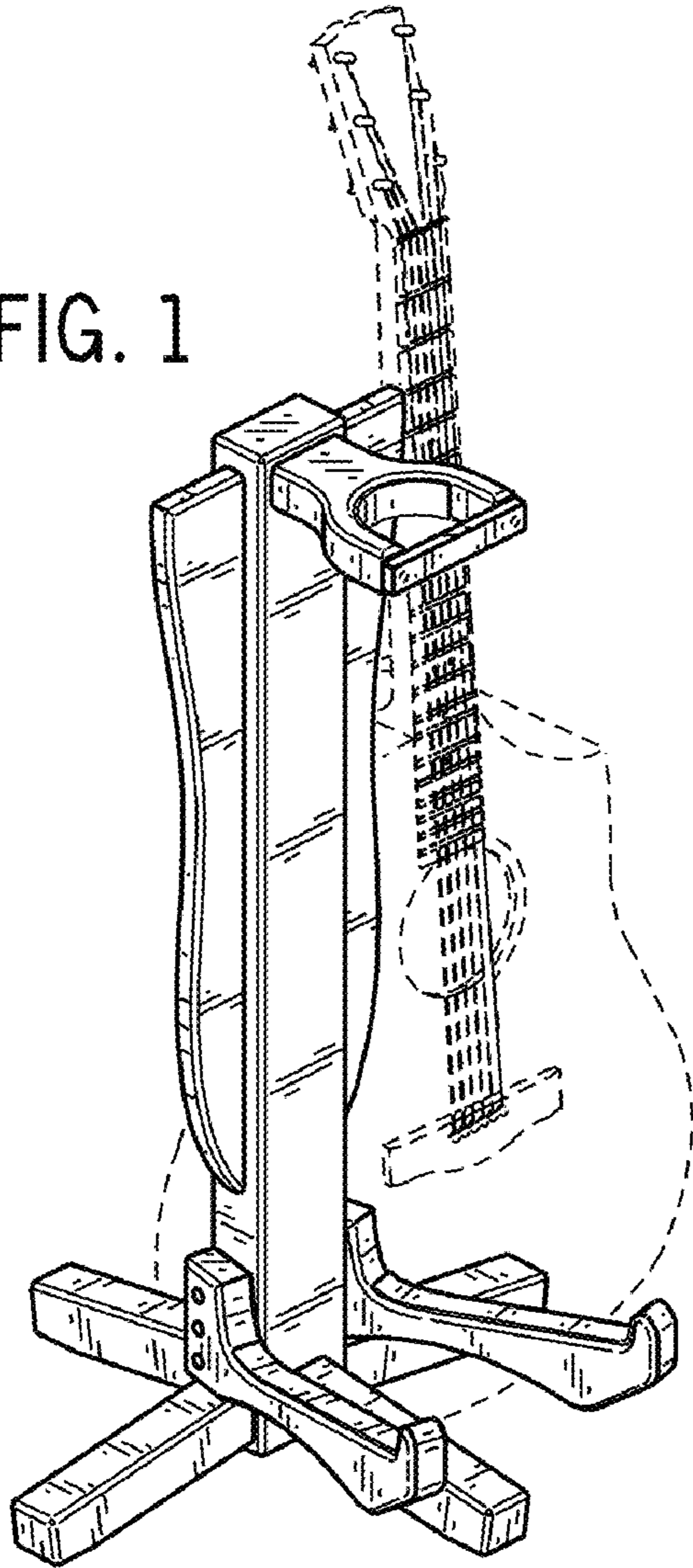

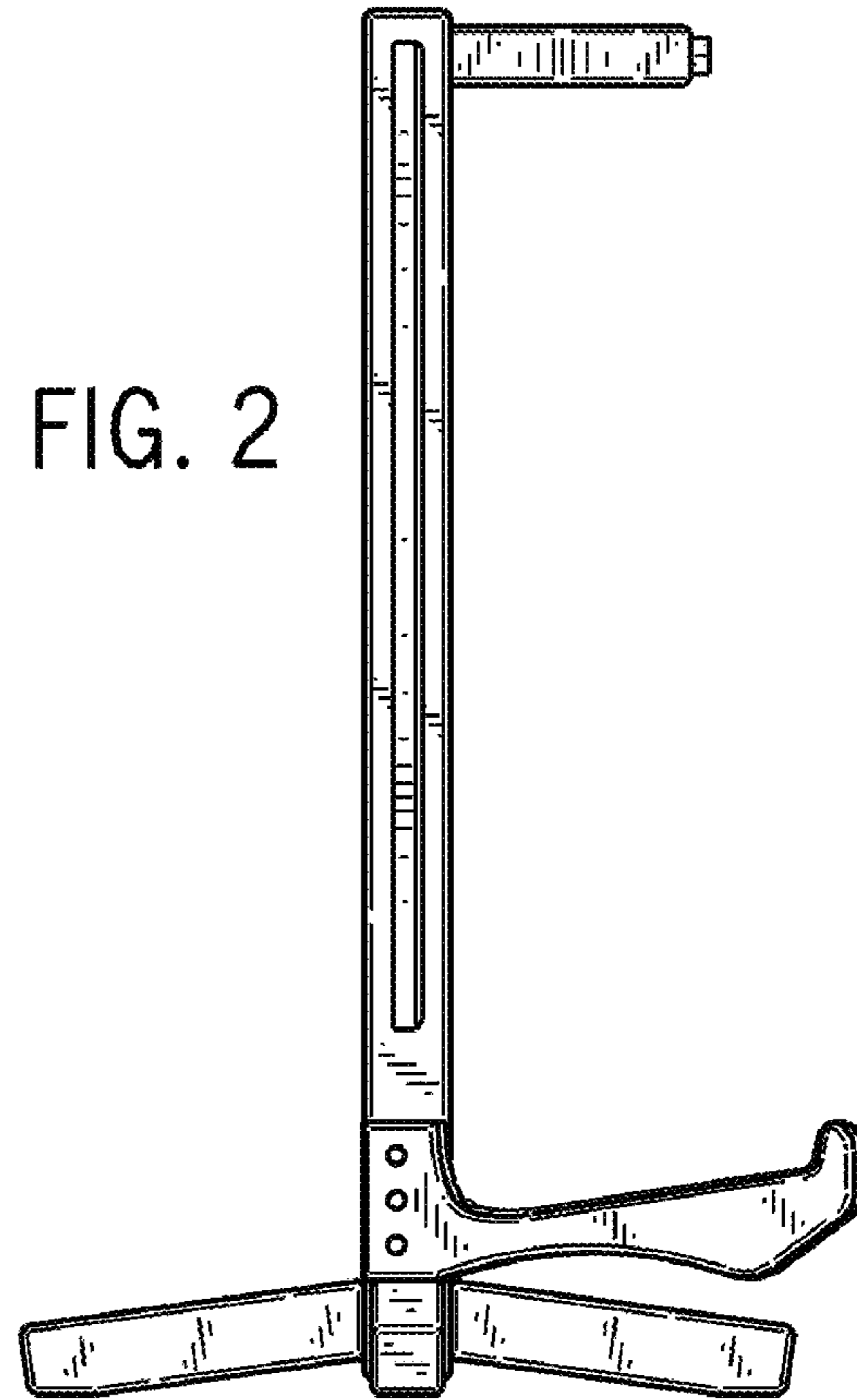

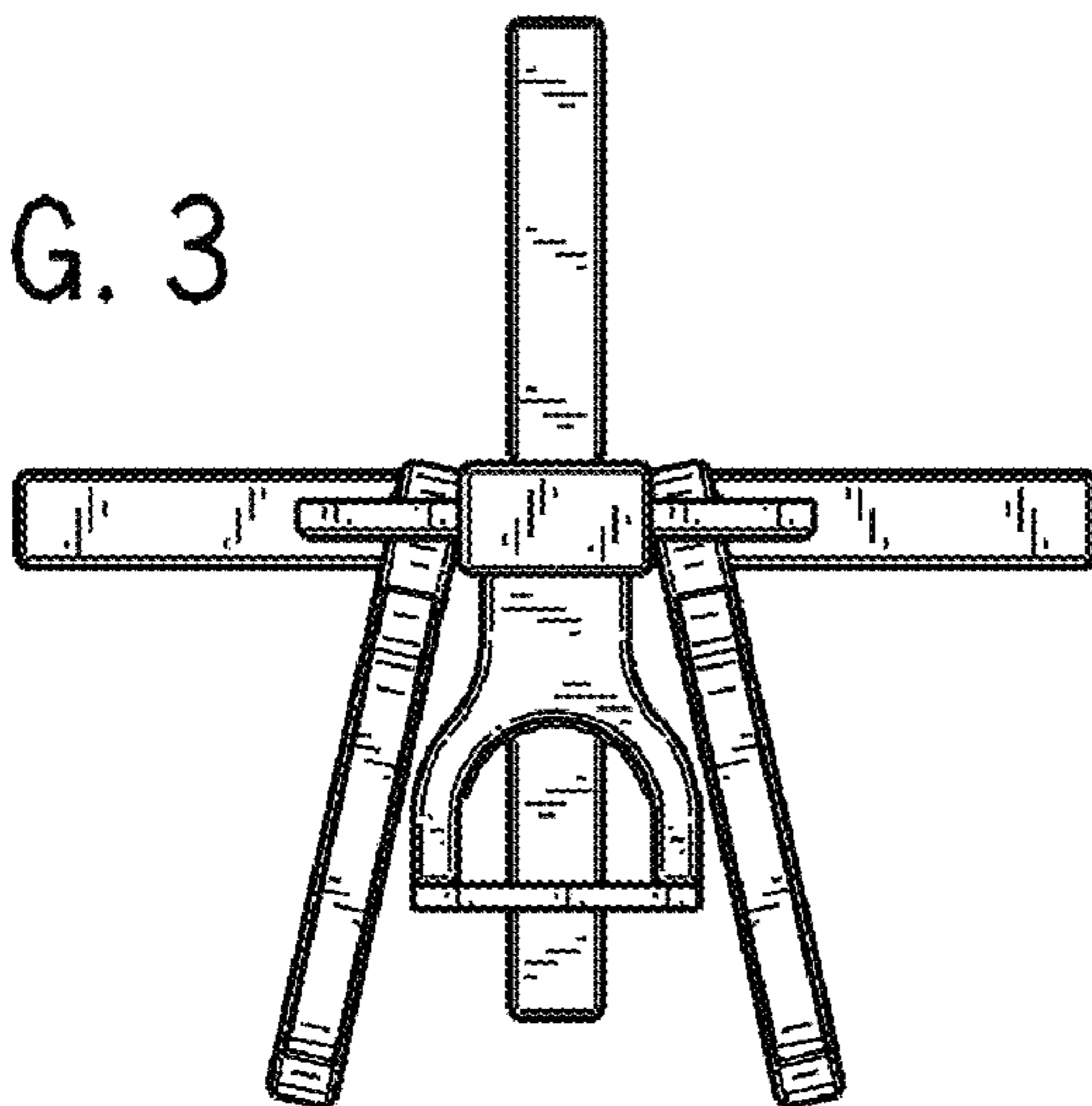

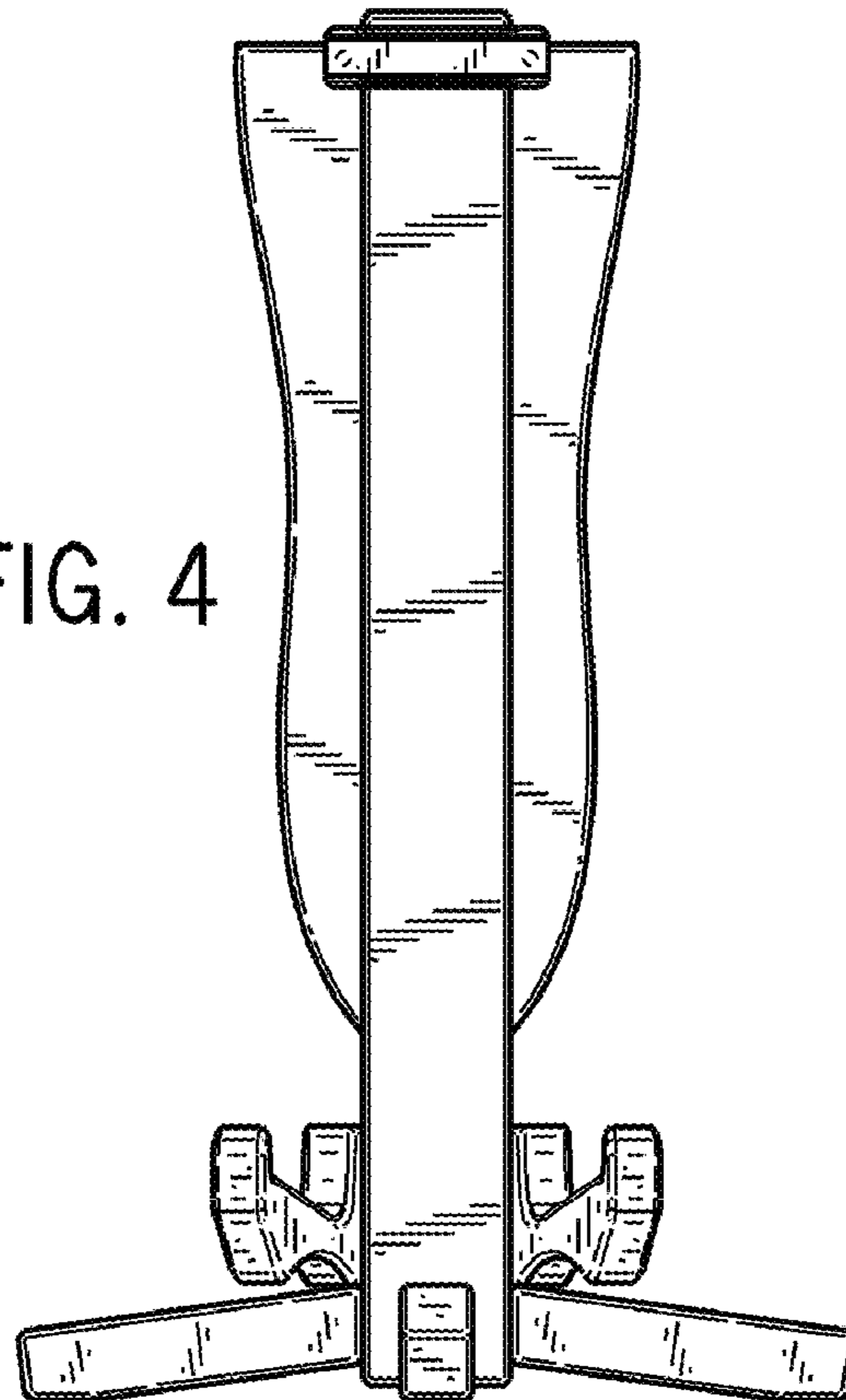

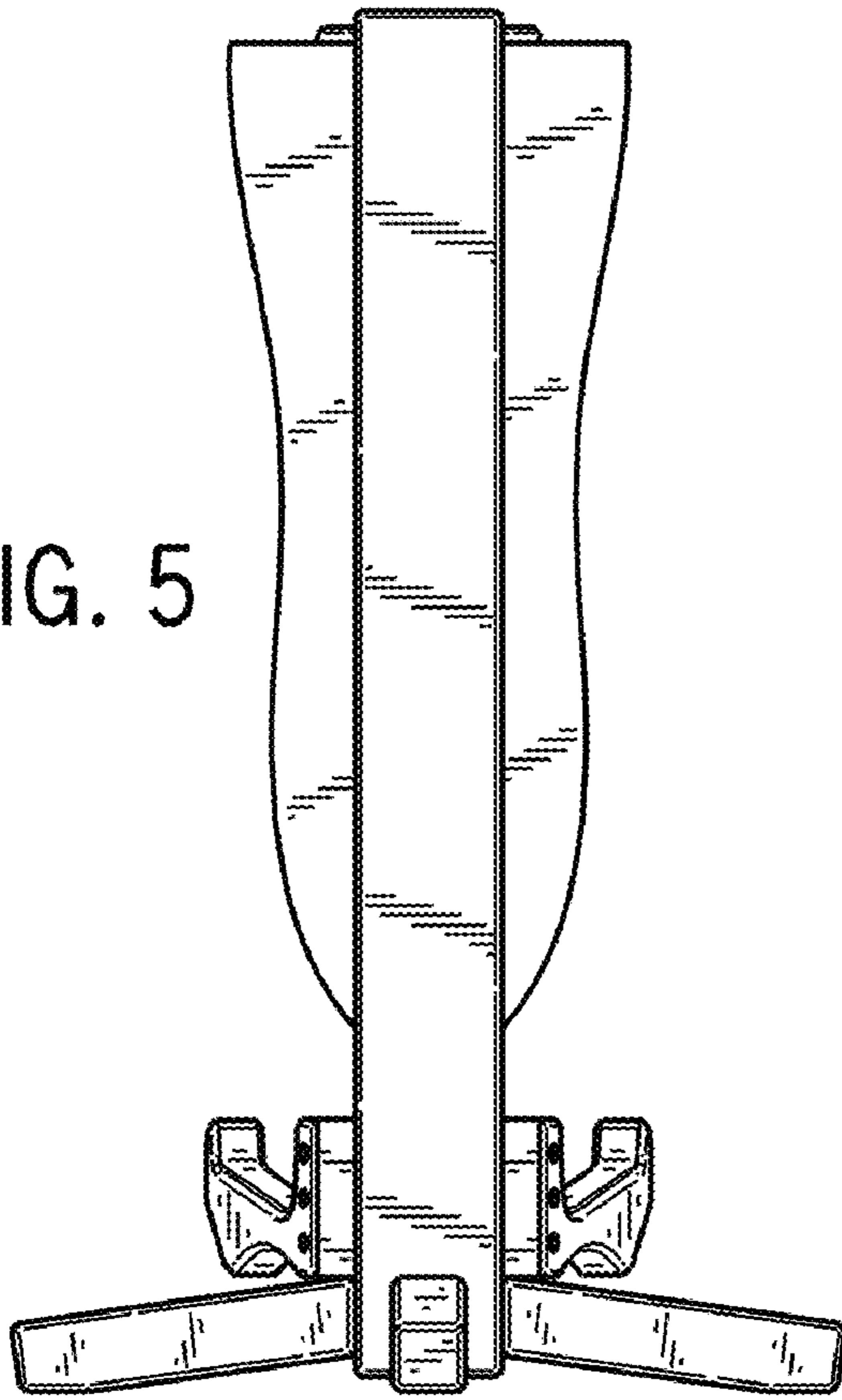

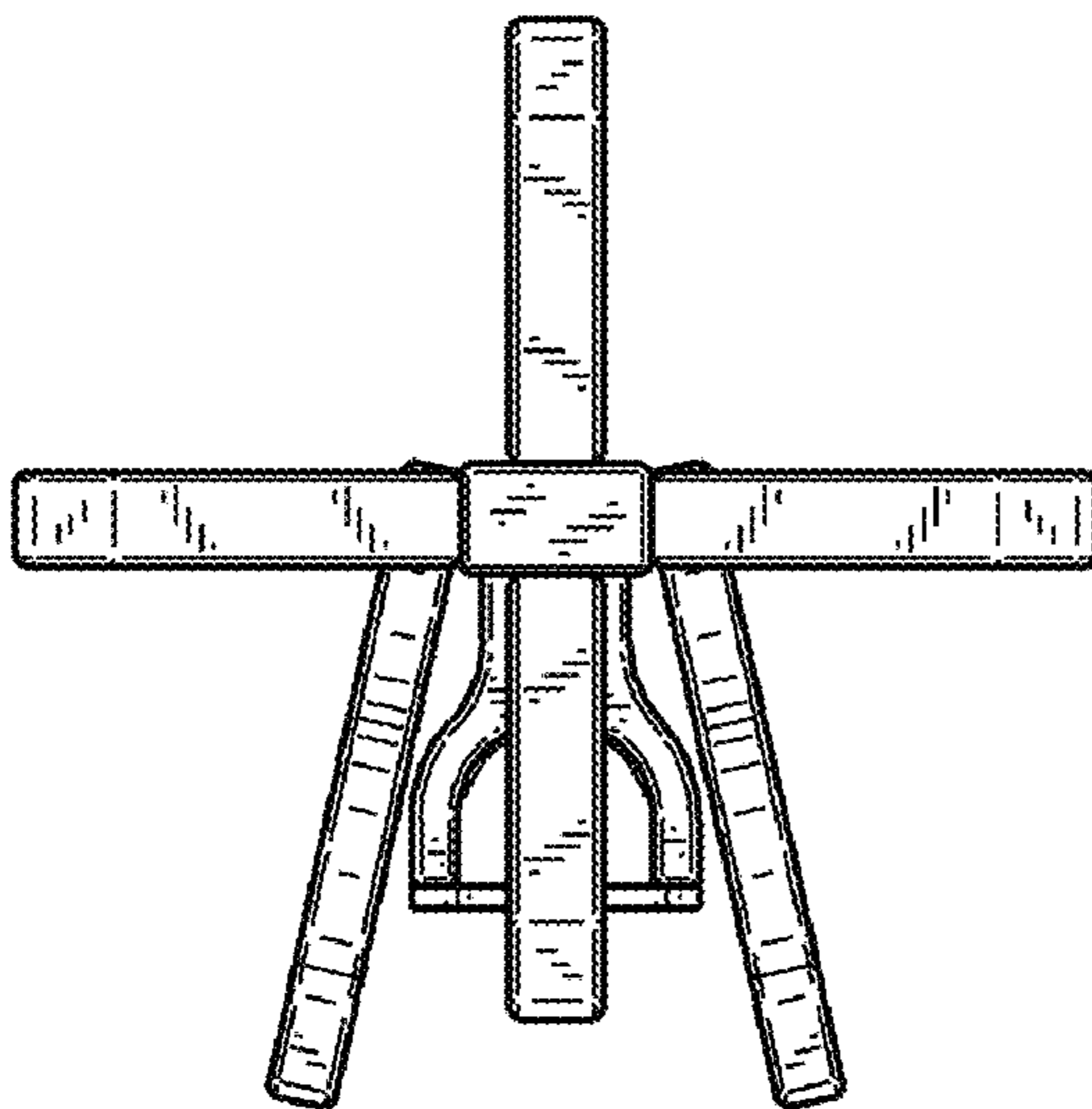
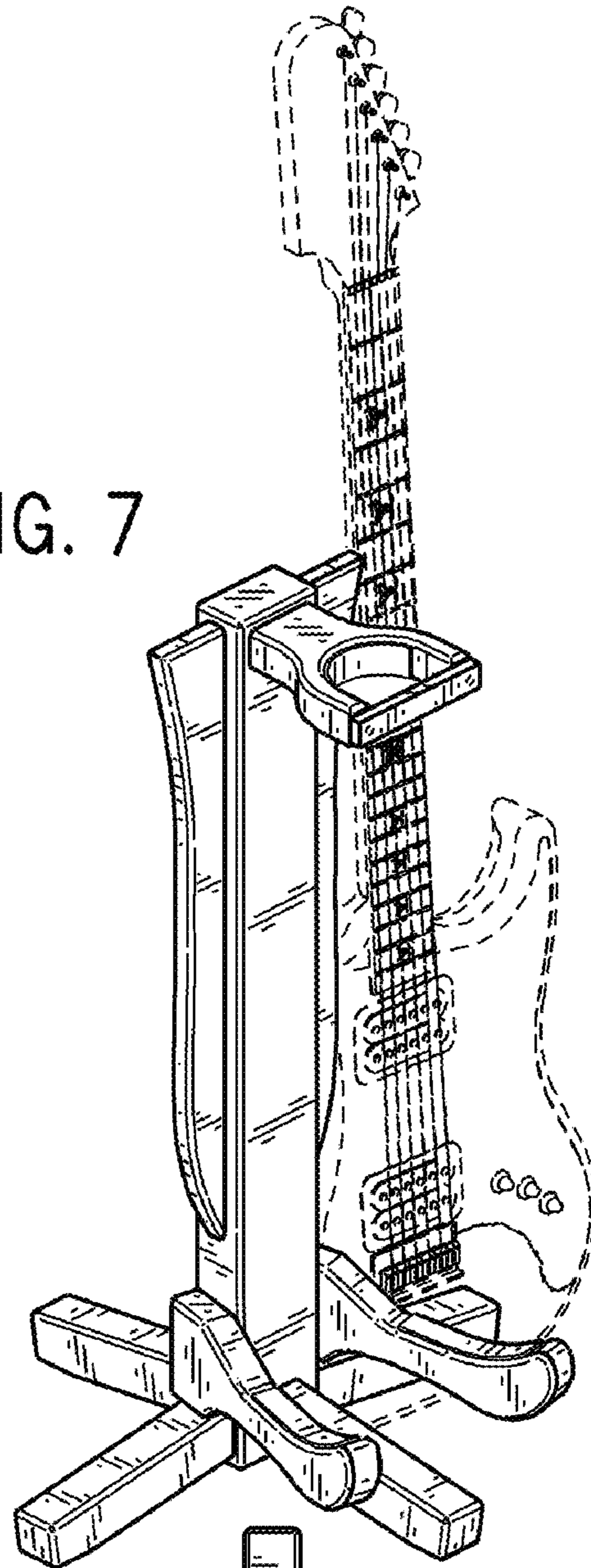

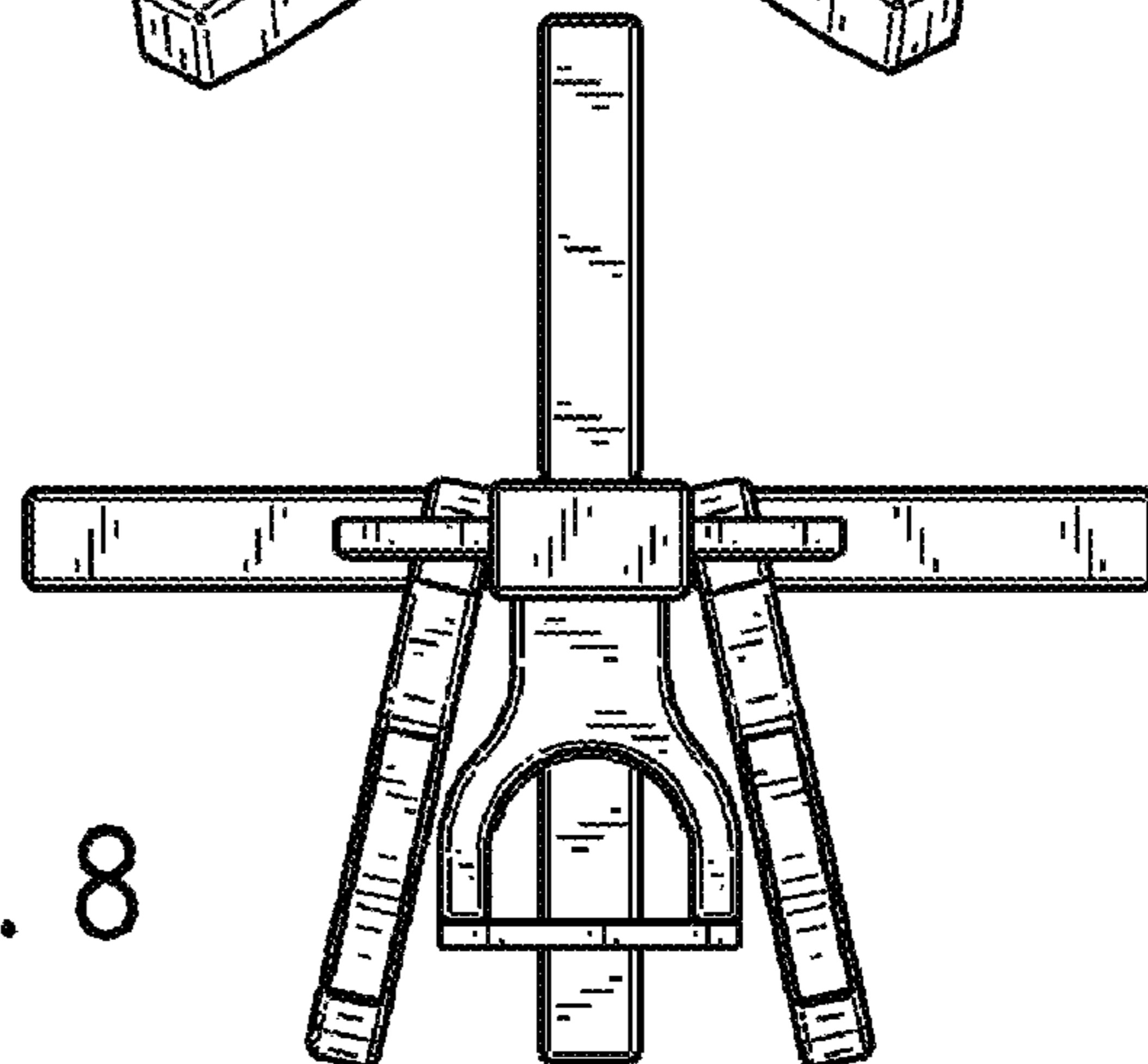

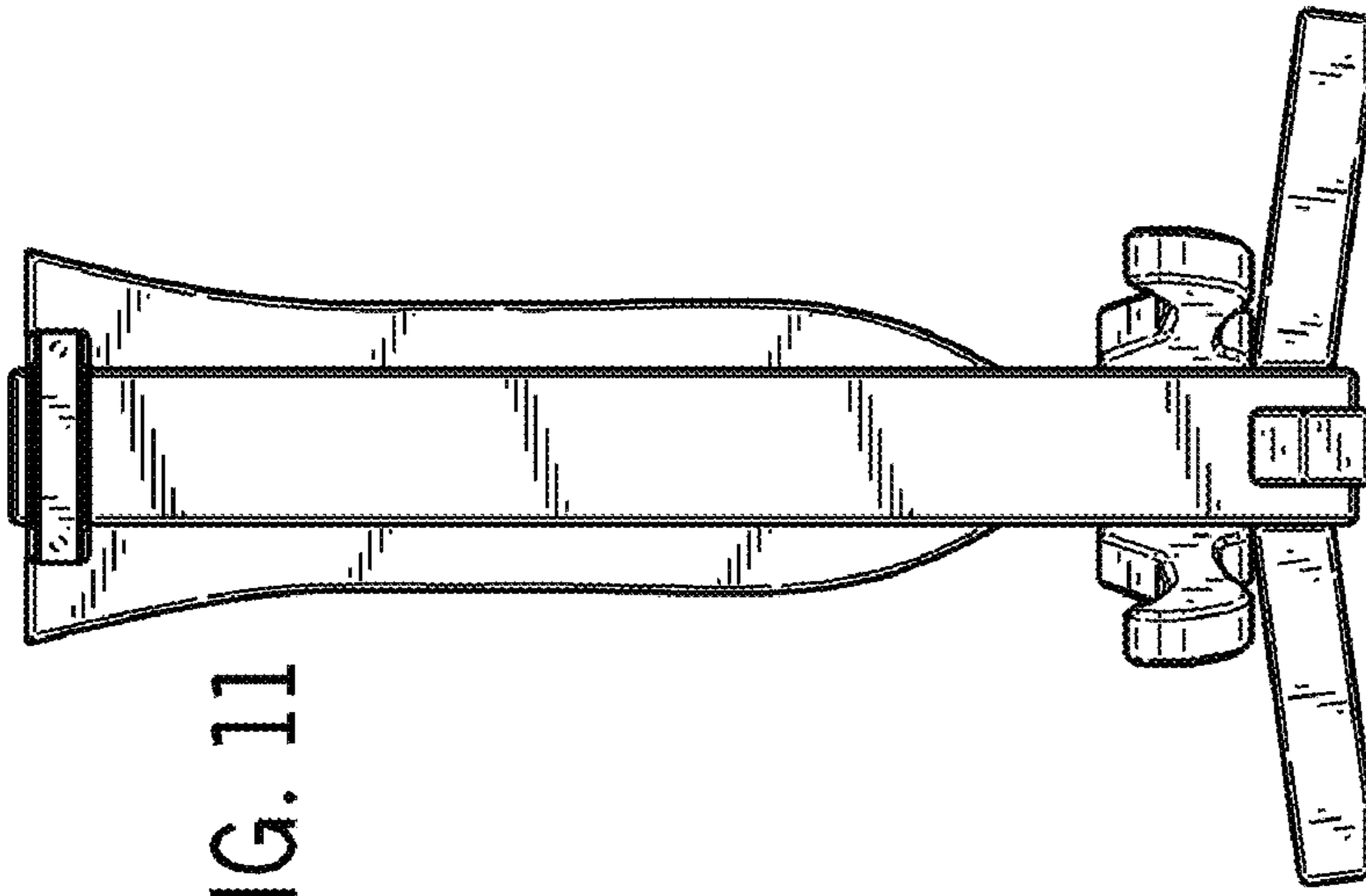

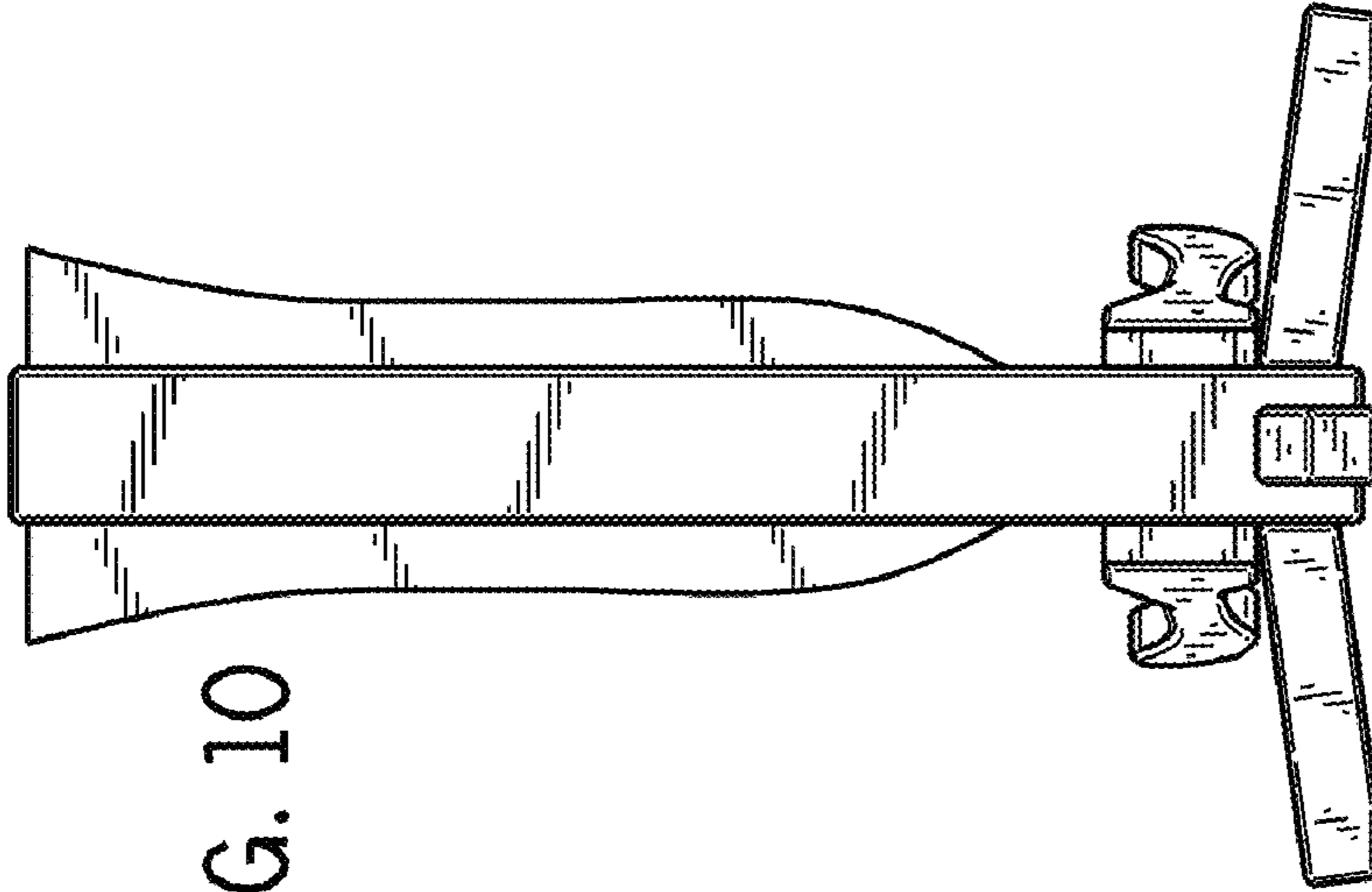

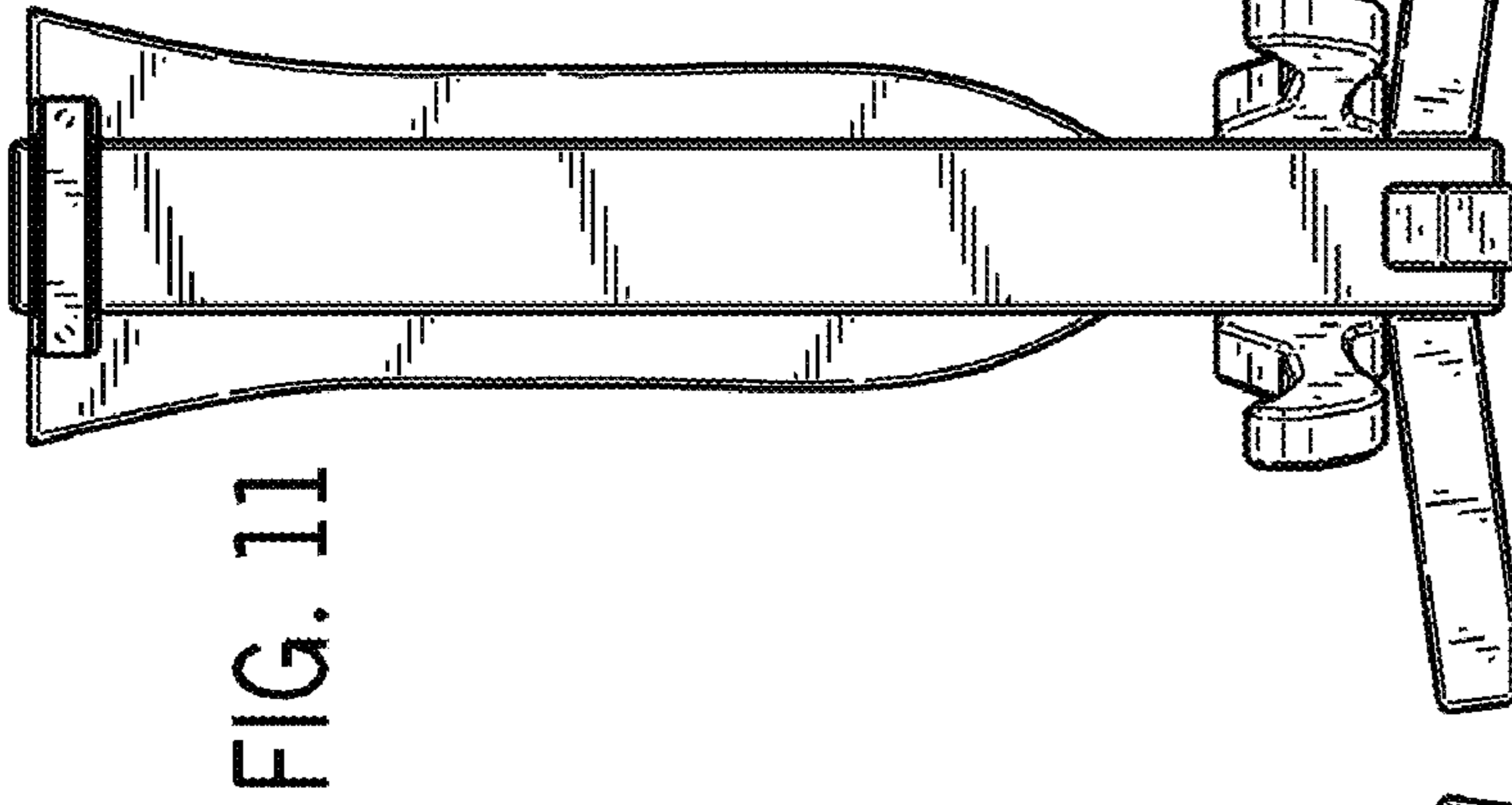

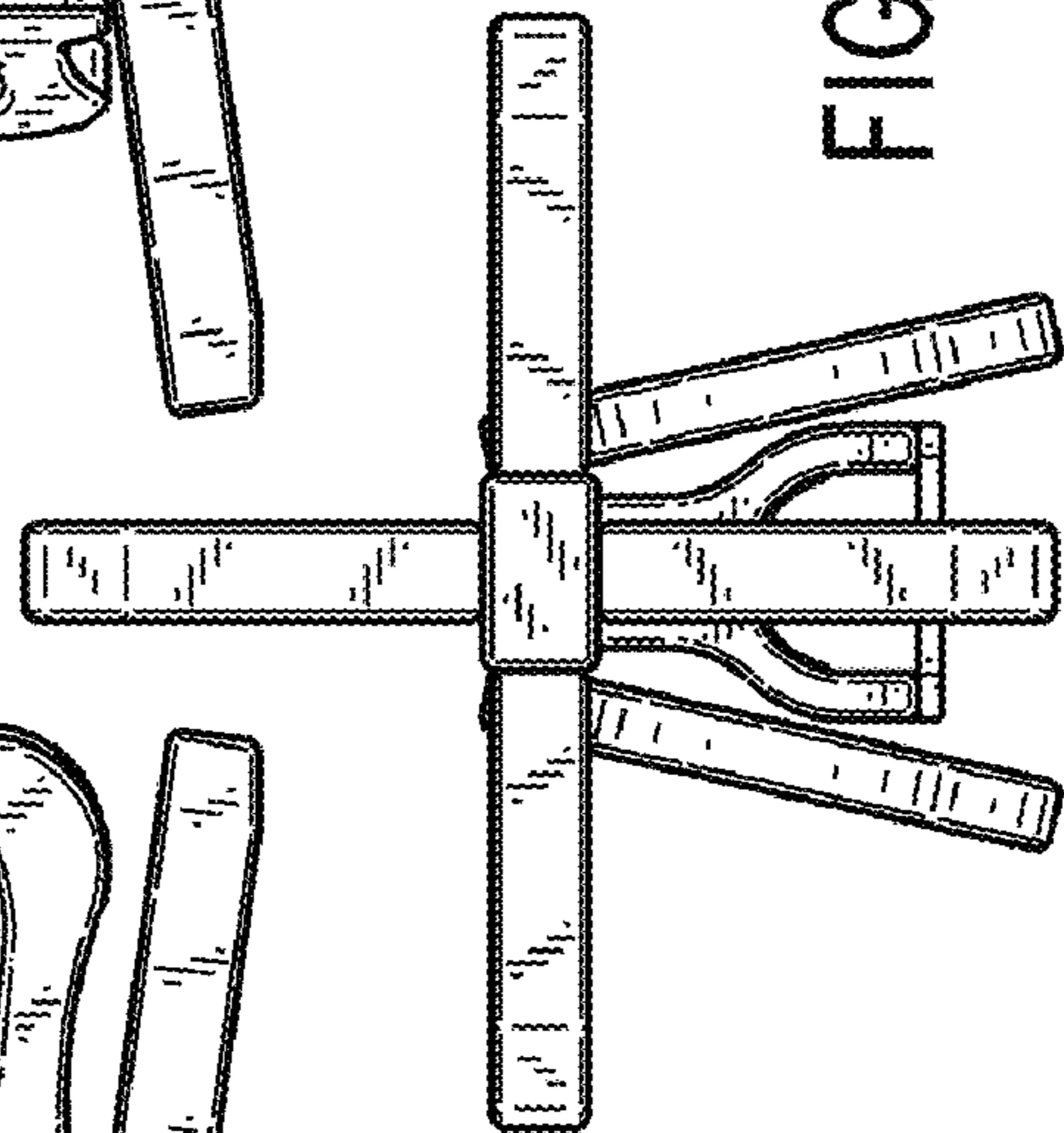
