DESCRIPTION

FIG. 1 is a perspective view of the knife handle of the present invention;

FIG. 2 is a top plan view of the knife handle of FIG. 1;

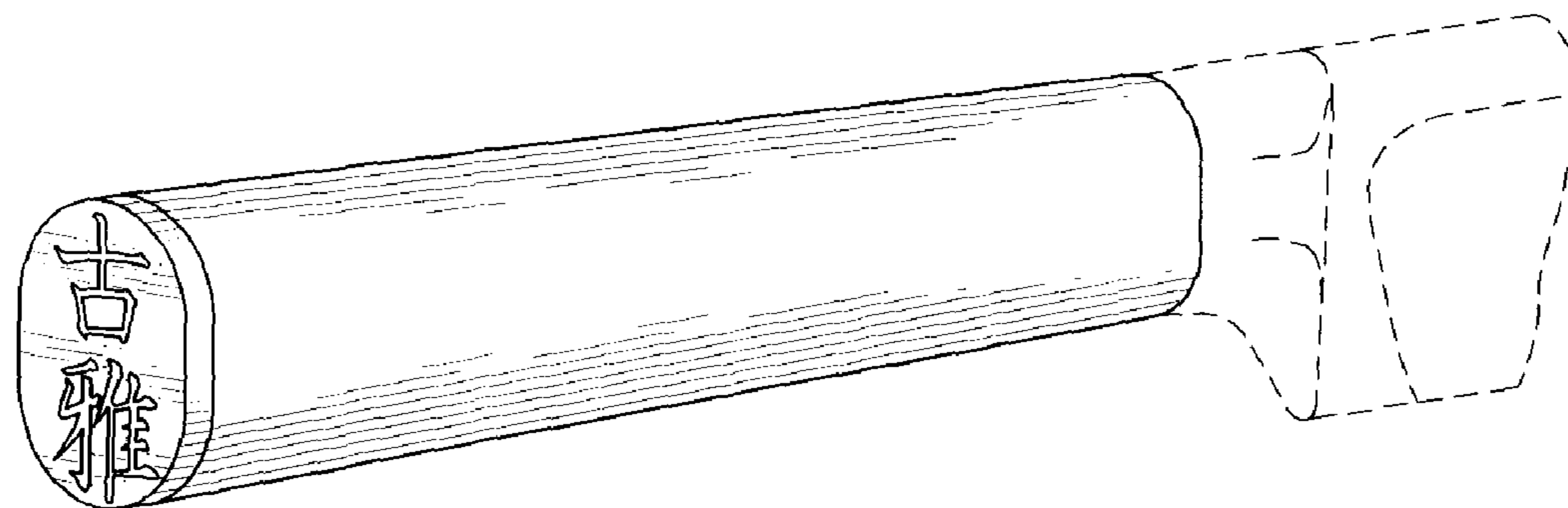
FIG. 3 is a side elevation of the knife handle of FIG. 1;

FIG. 4 is a butt end view of the knife handle of FIG. 1; and,

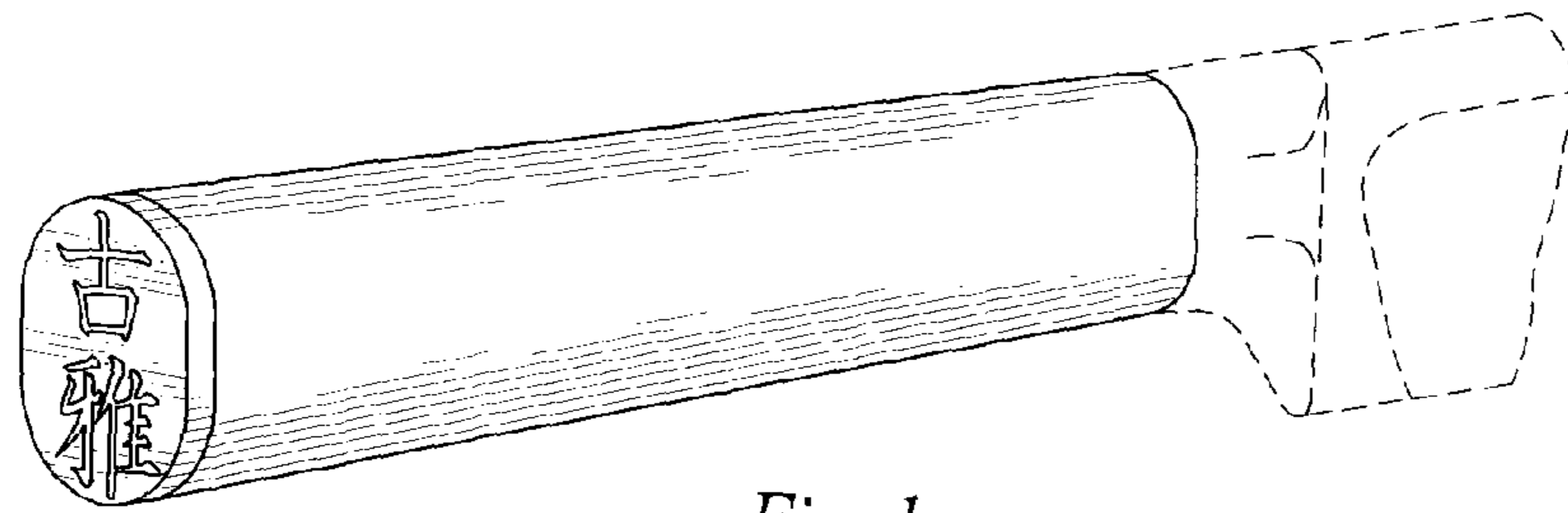

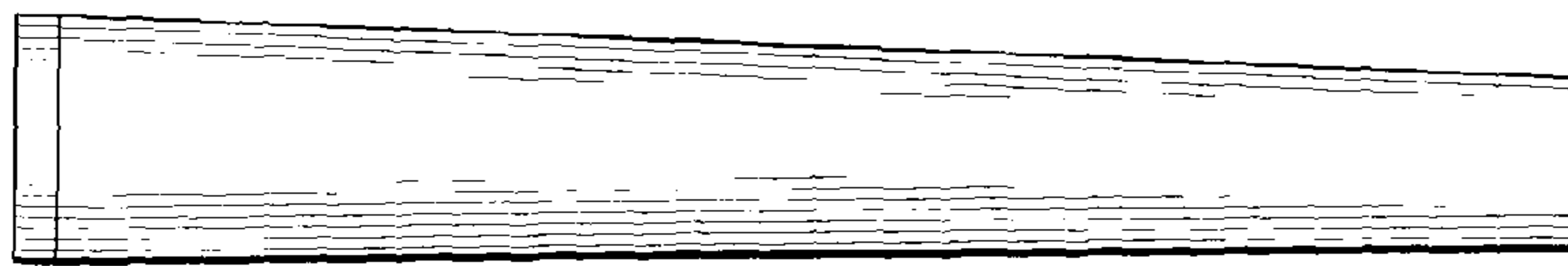

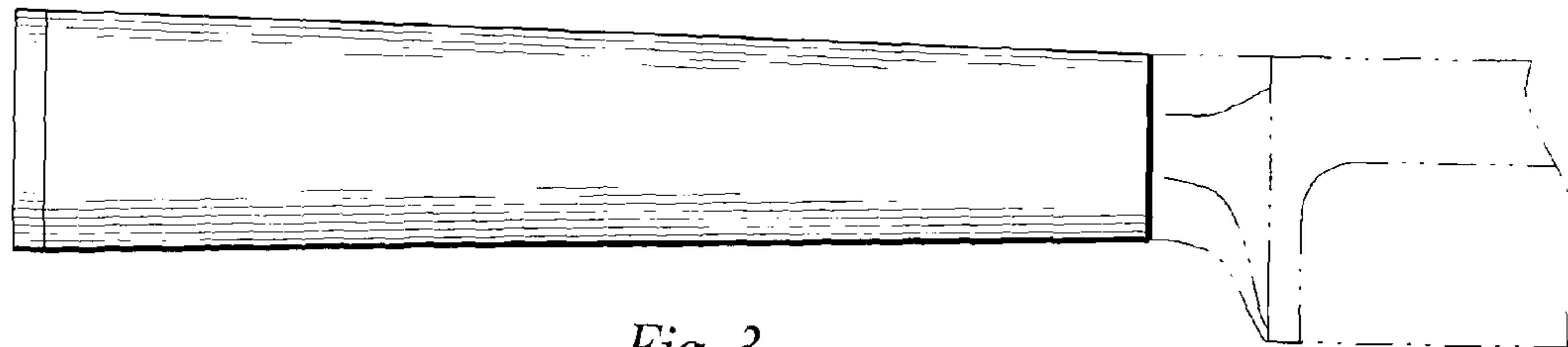

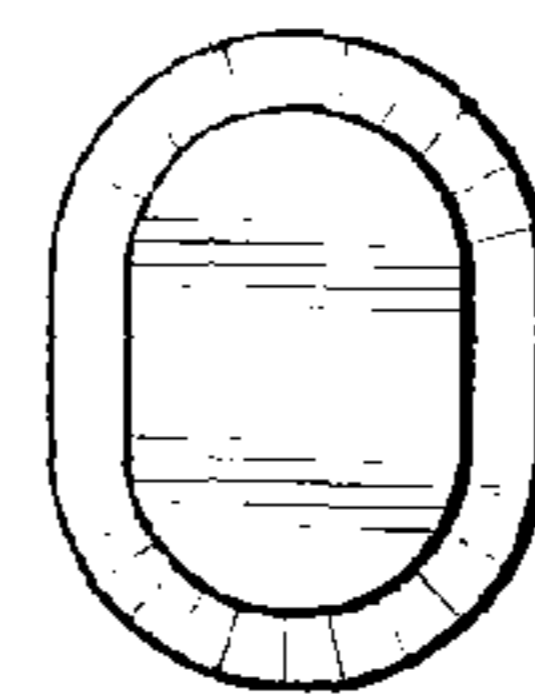
