FIG. 1 is a perspective view, of a T bar handle showing my new design;

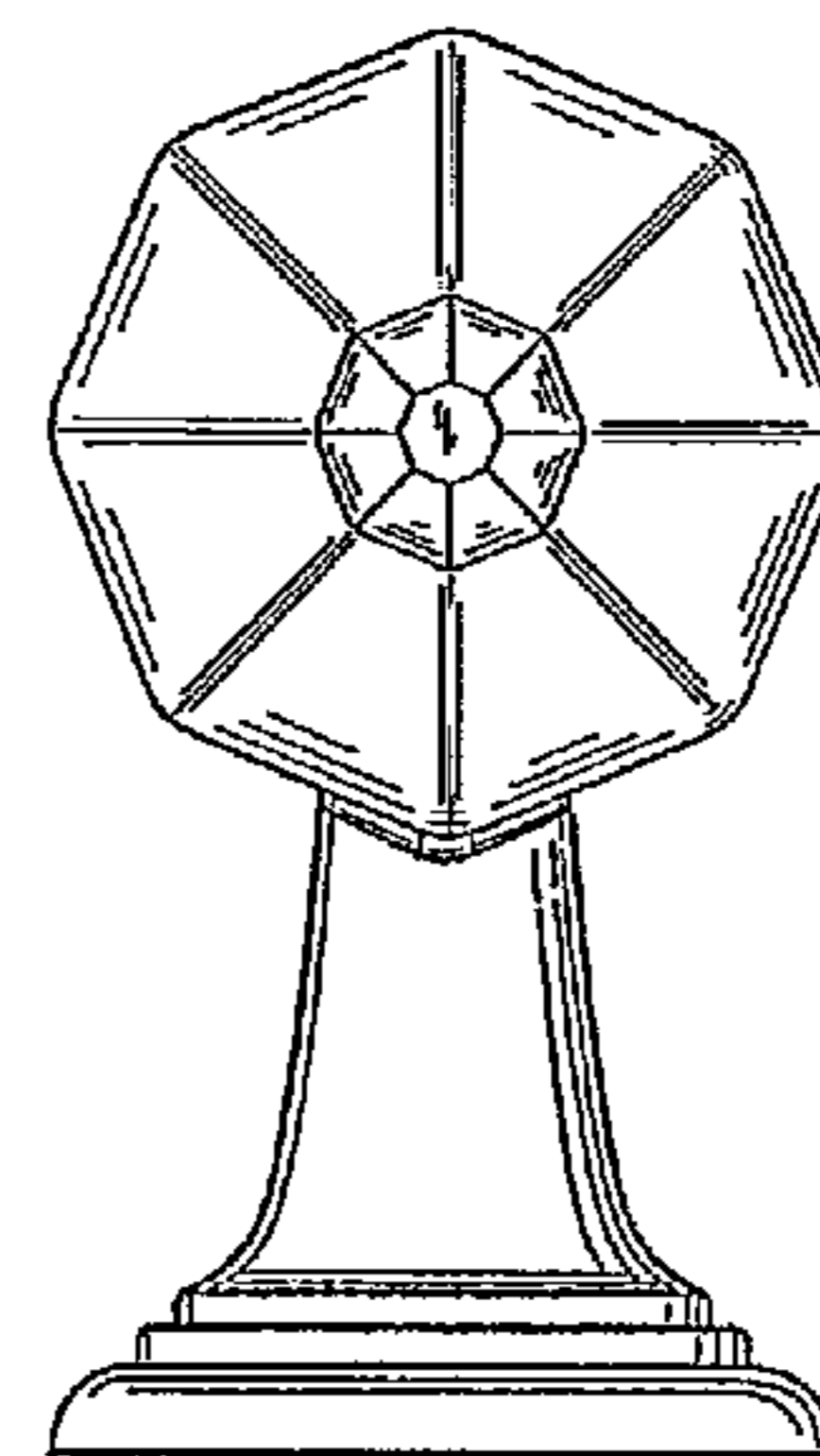
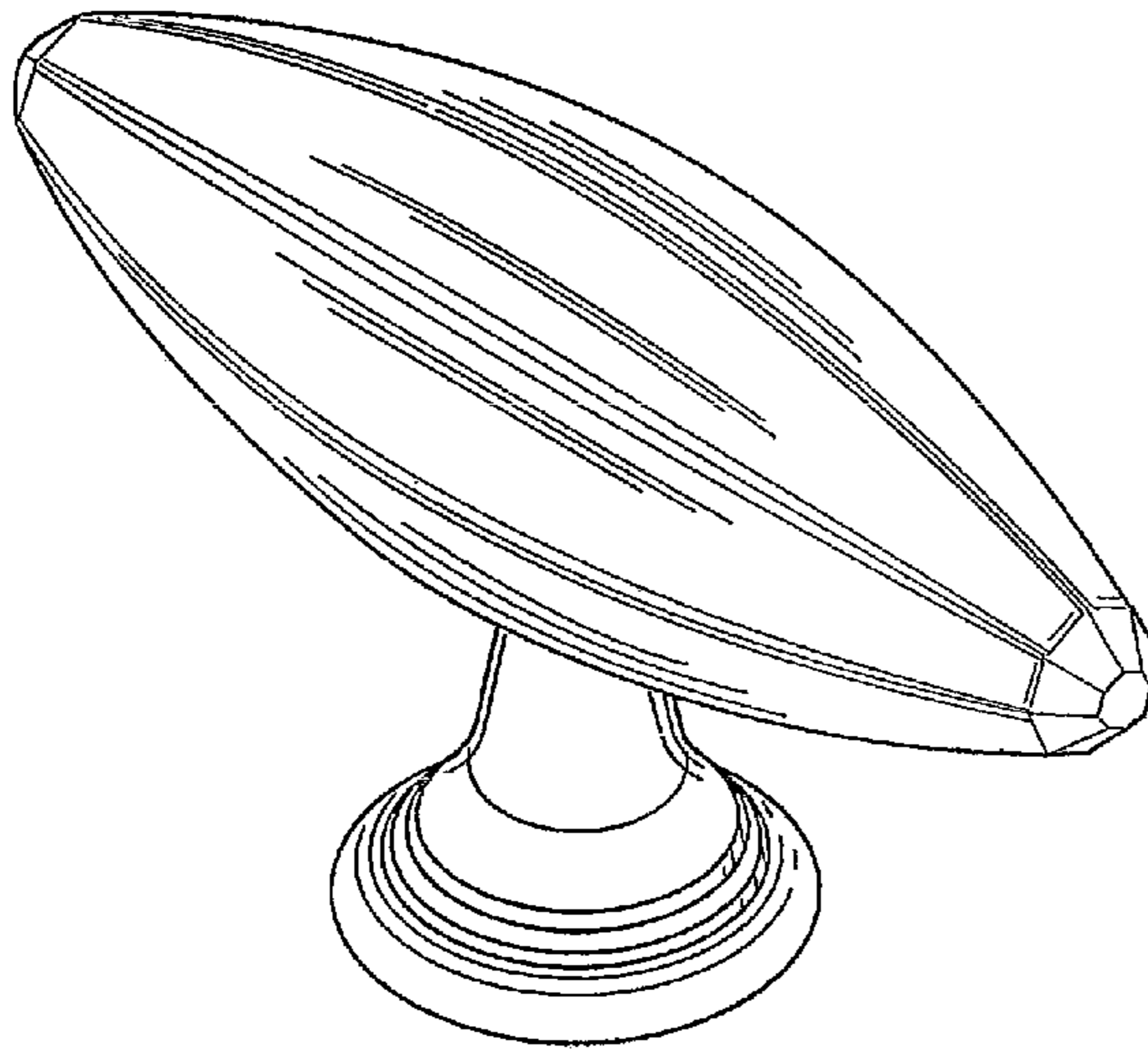
FIG. 2 is a first end elevational view thereof, the opposite end elevational view being identical thereto;

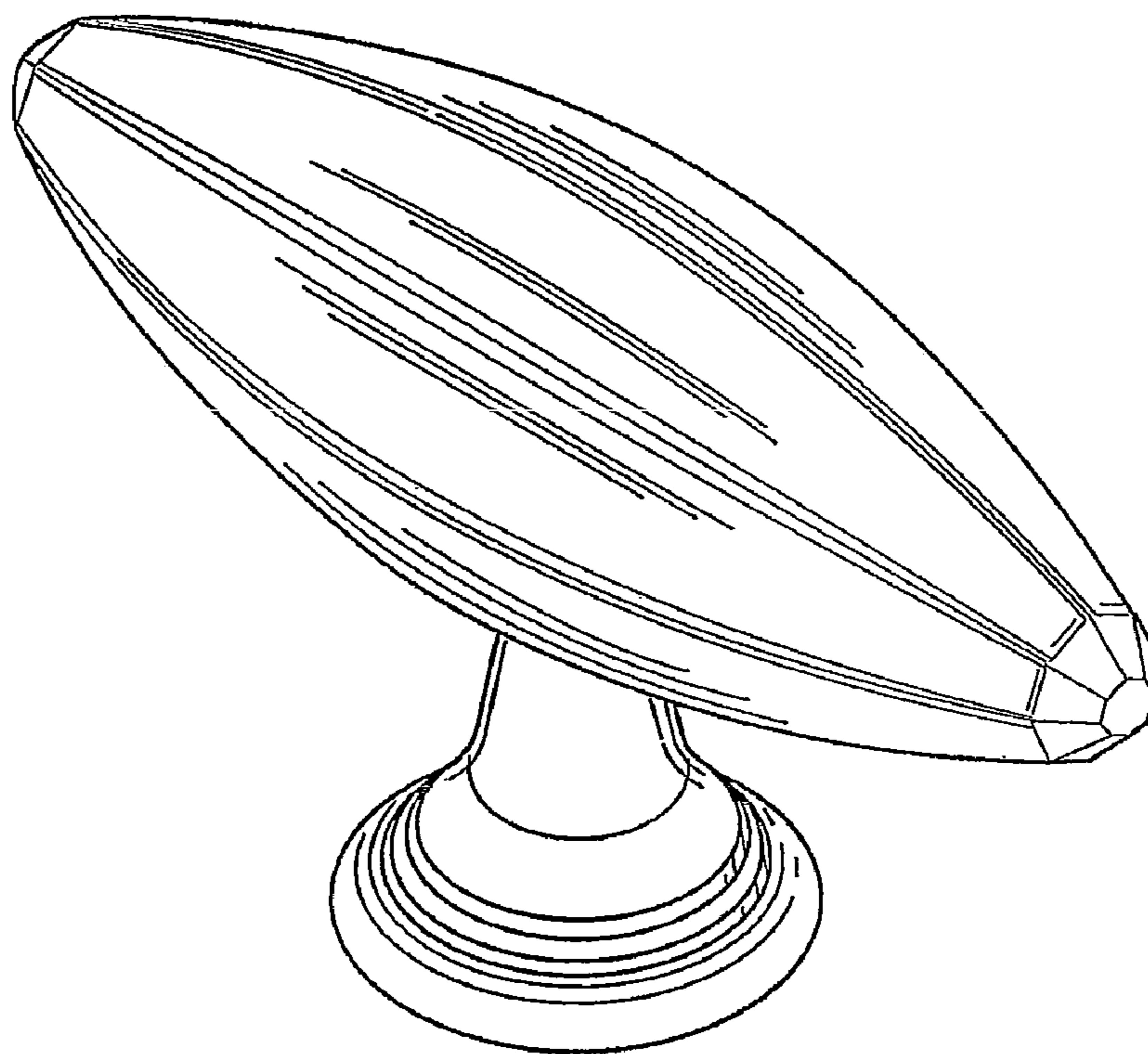

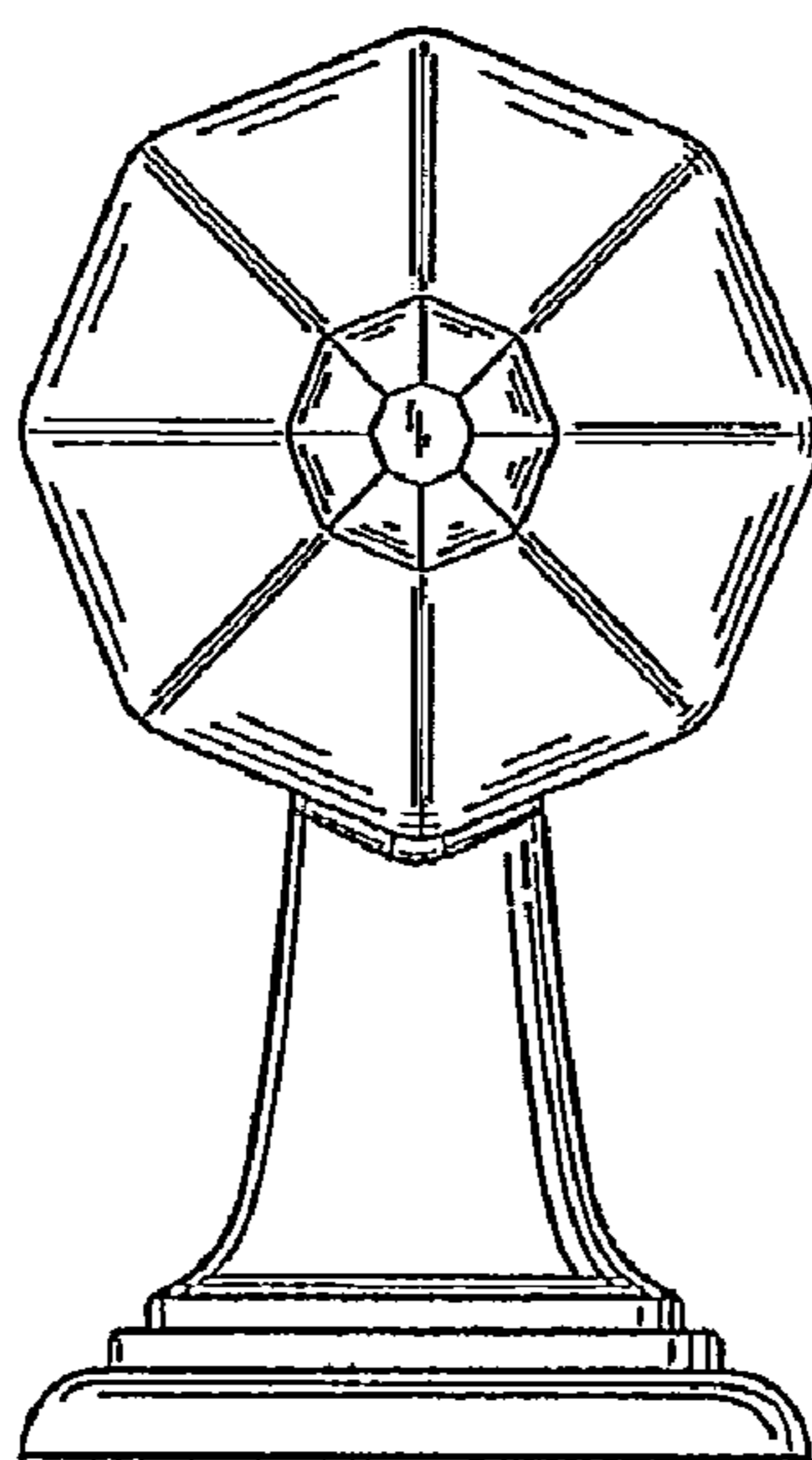

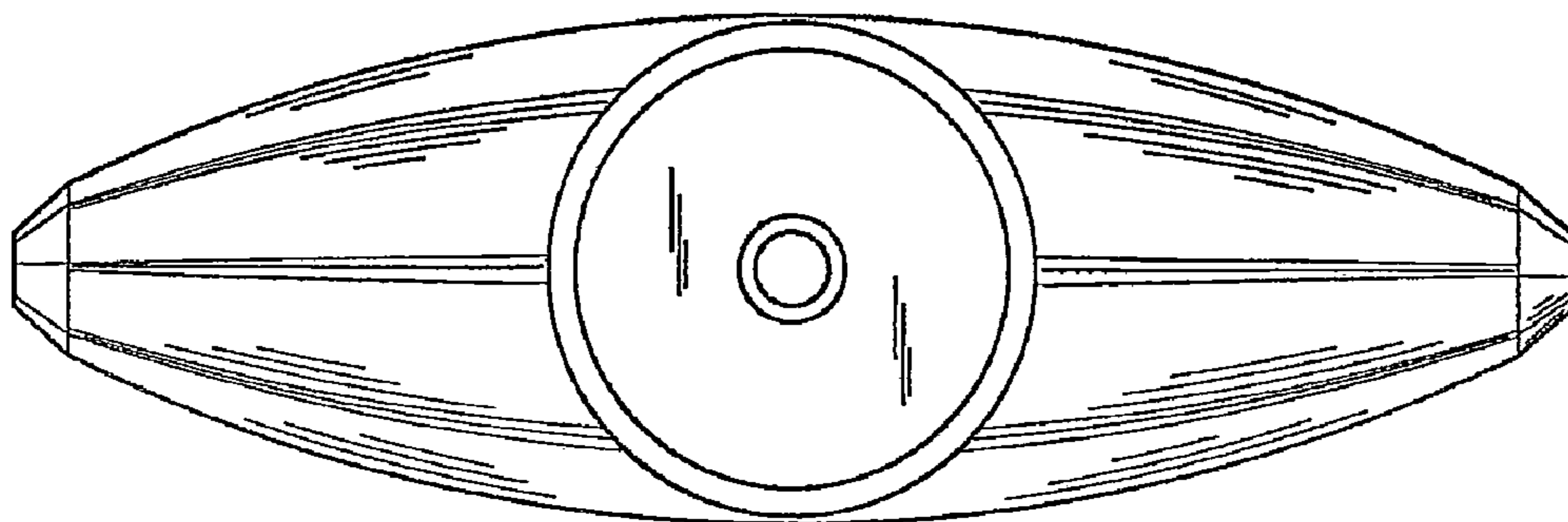

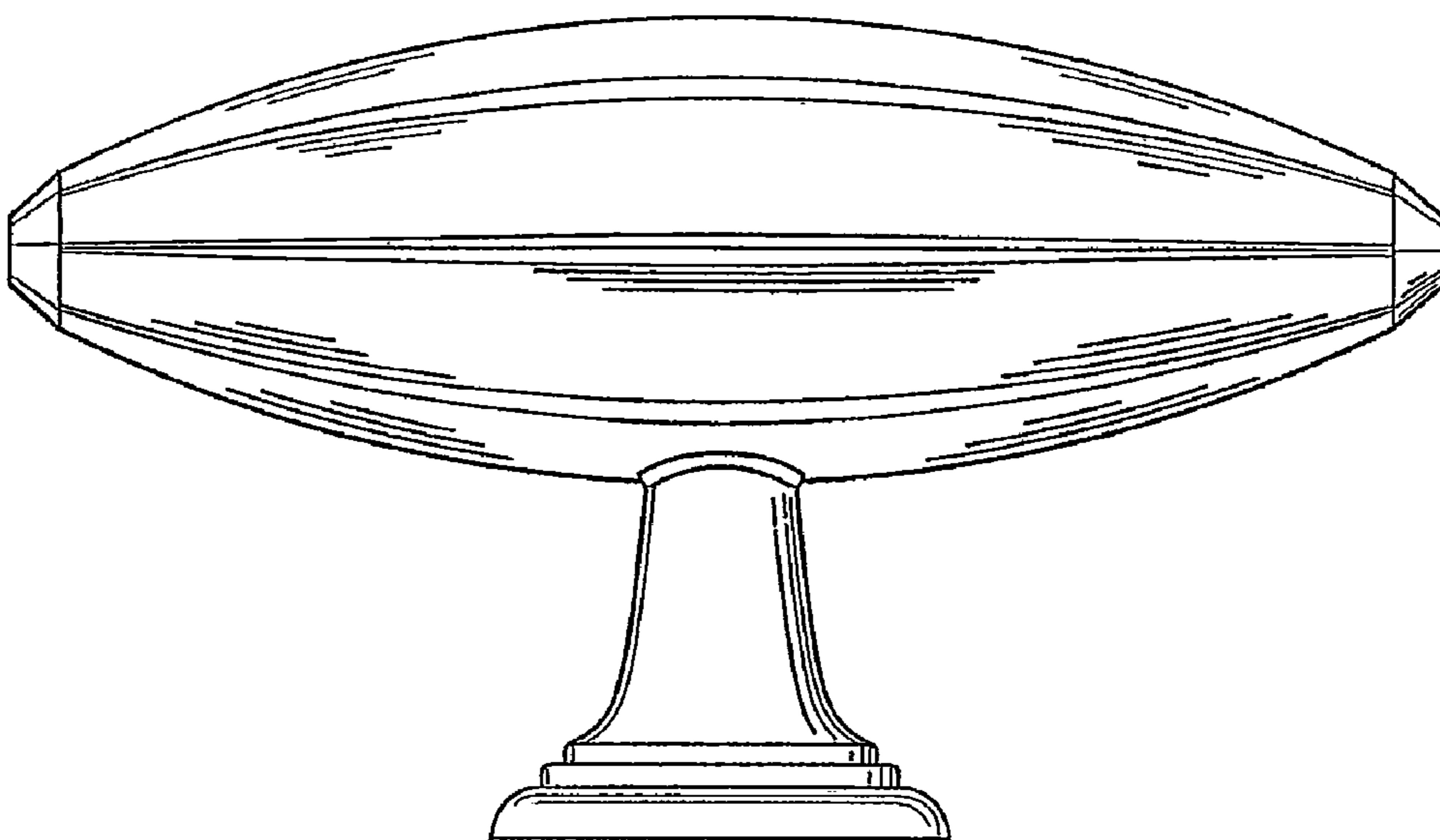

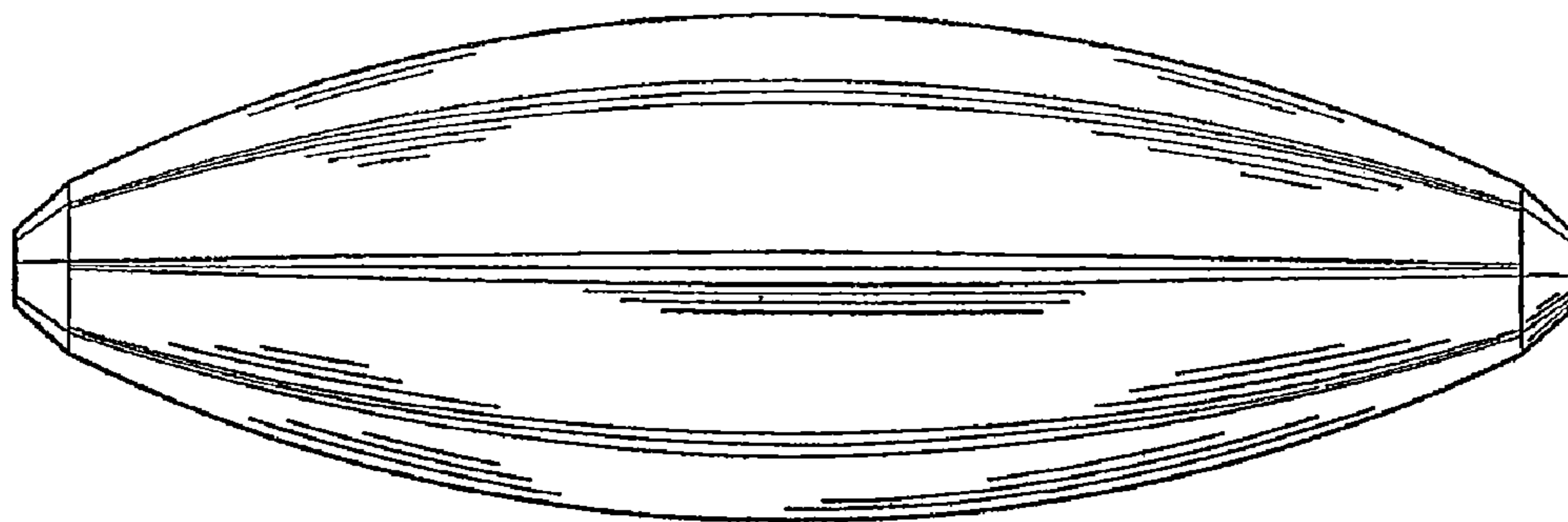
