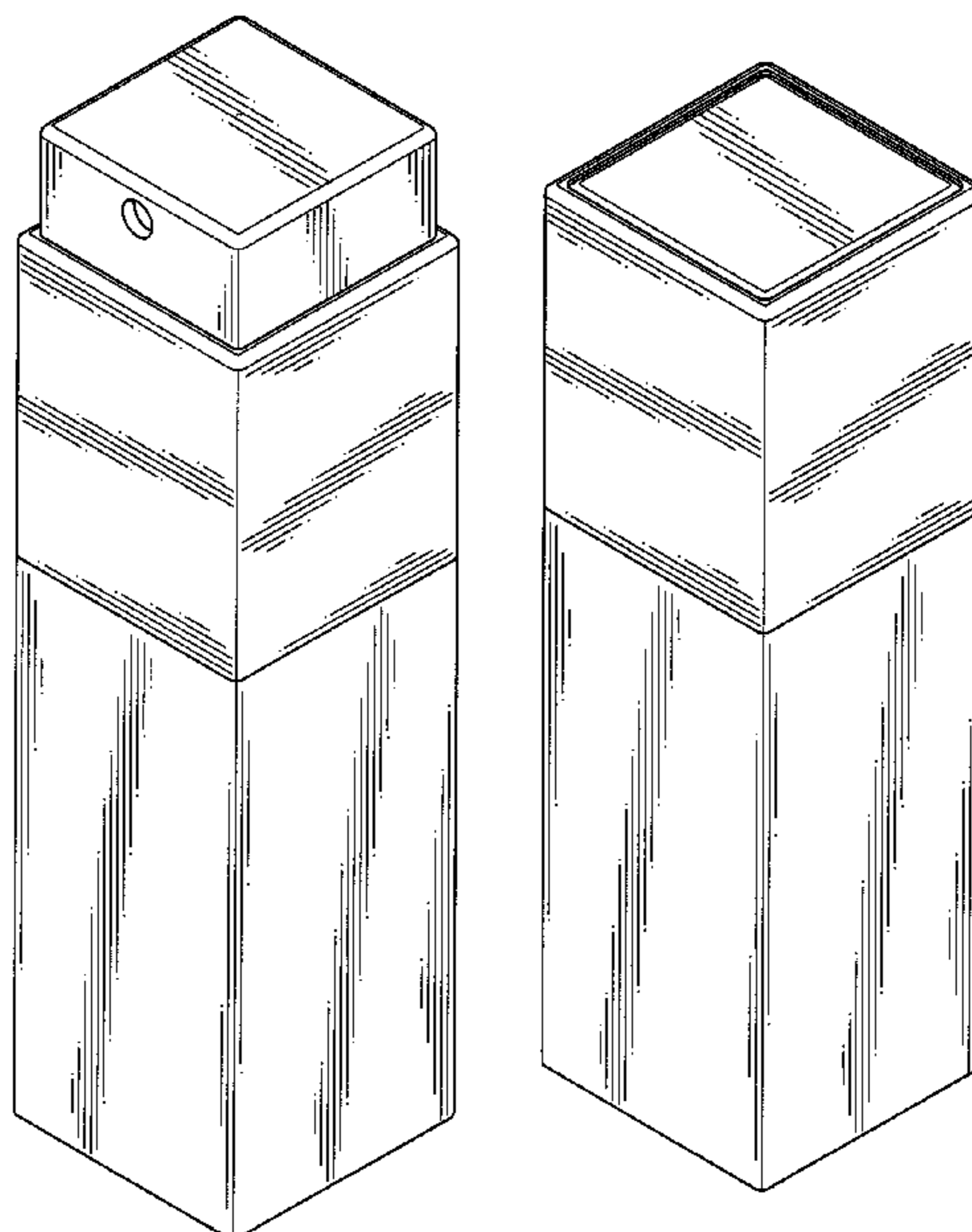
(57) **CLAIM**

The ornamental design for a bottle for cosmetics, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle for cosmetics, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a perspective view similar to FIG. 1 but showing the head element in a retracted position; and,
FIG. 7 is a front view of FIG. 6.

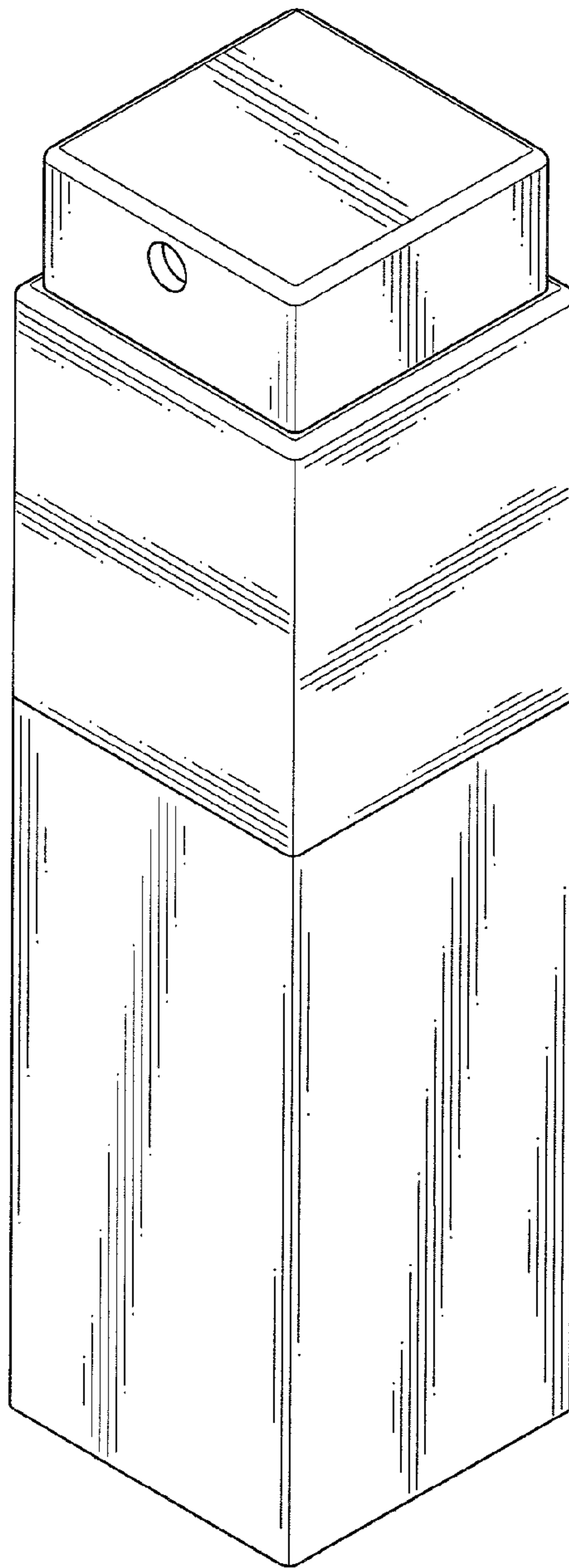

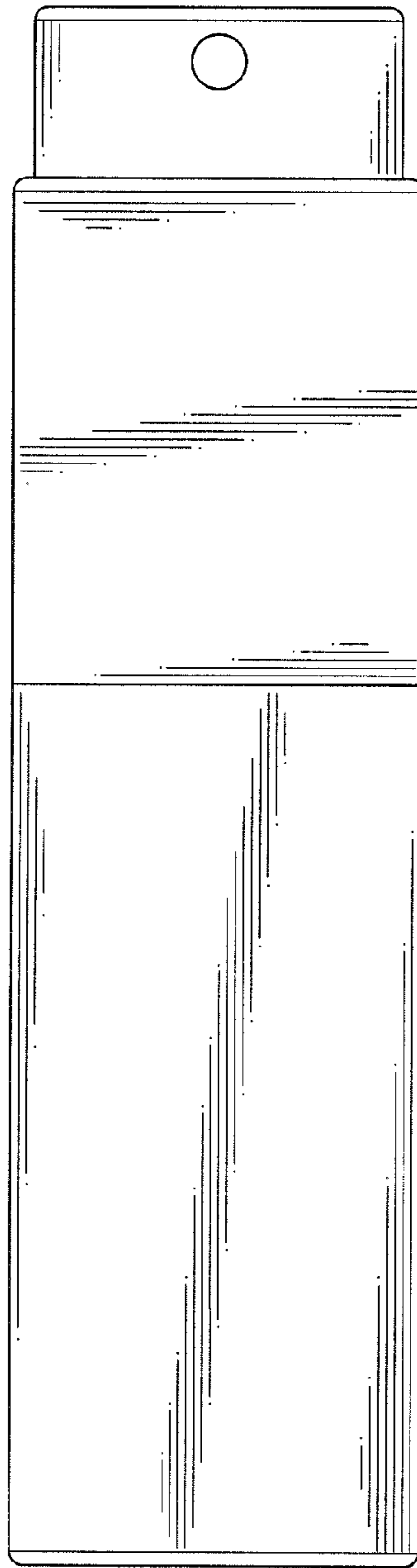

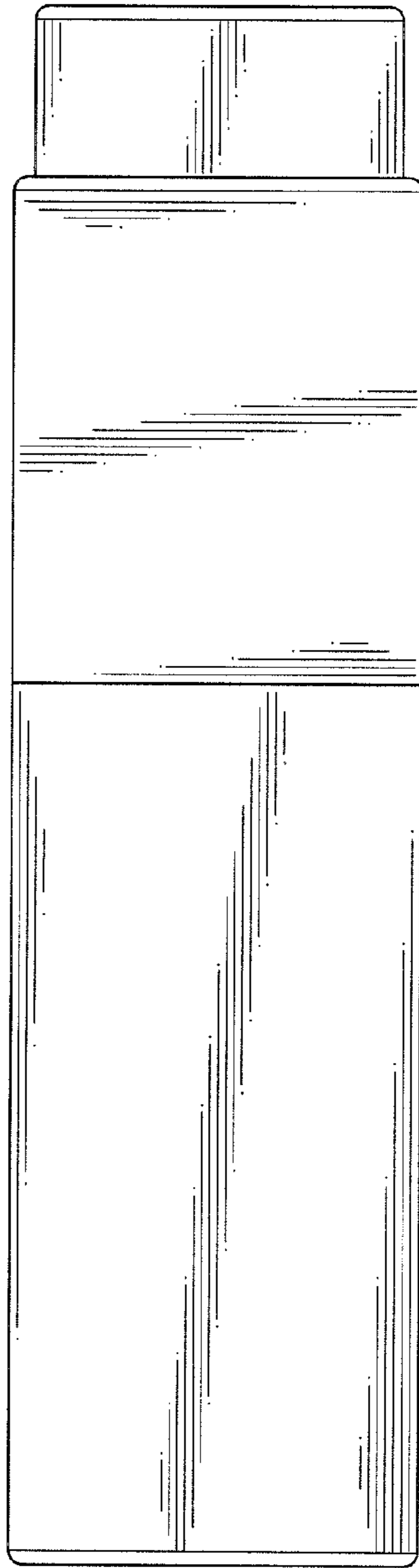

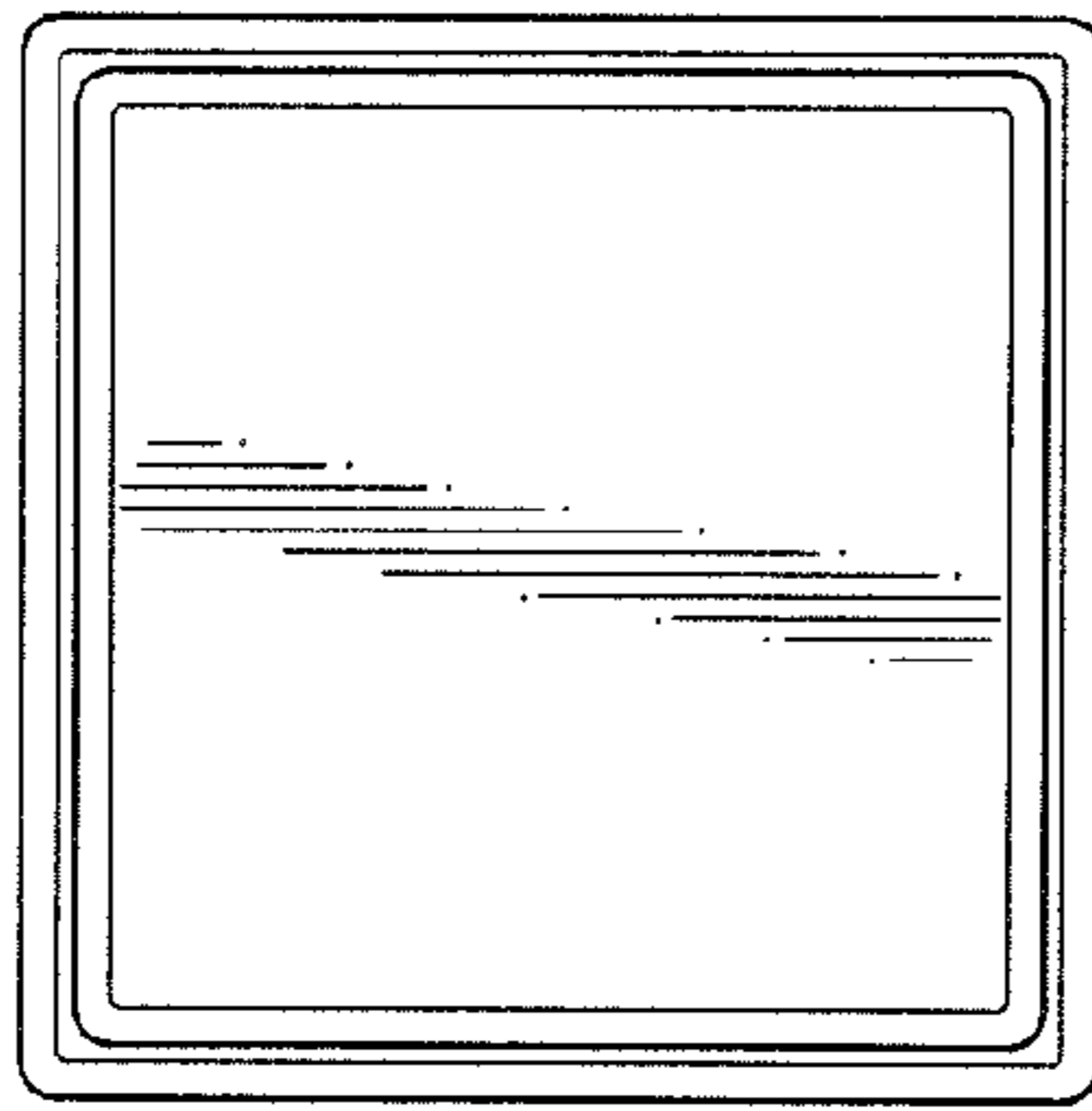

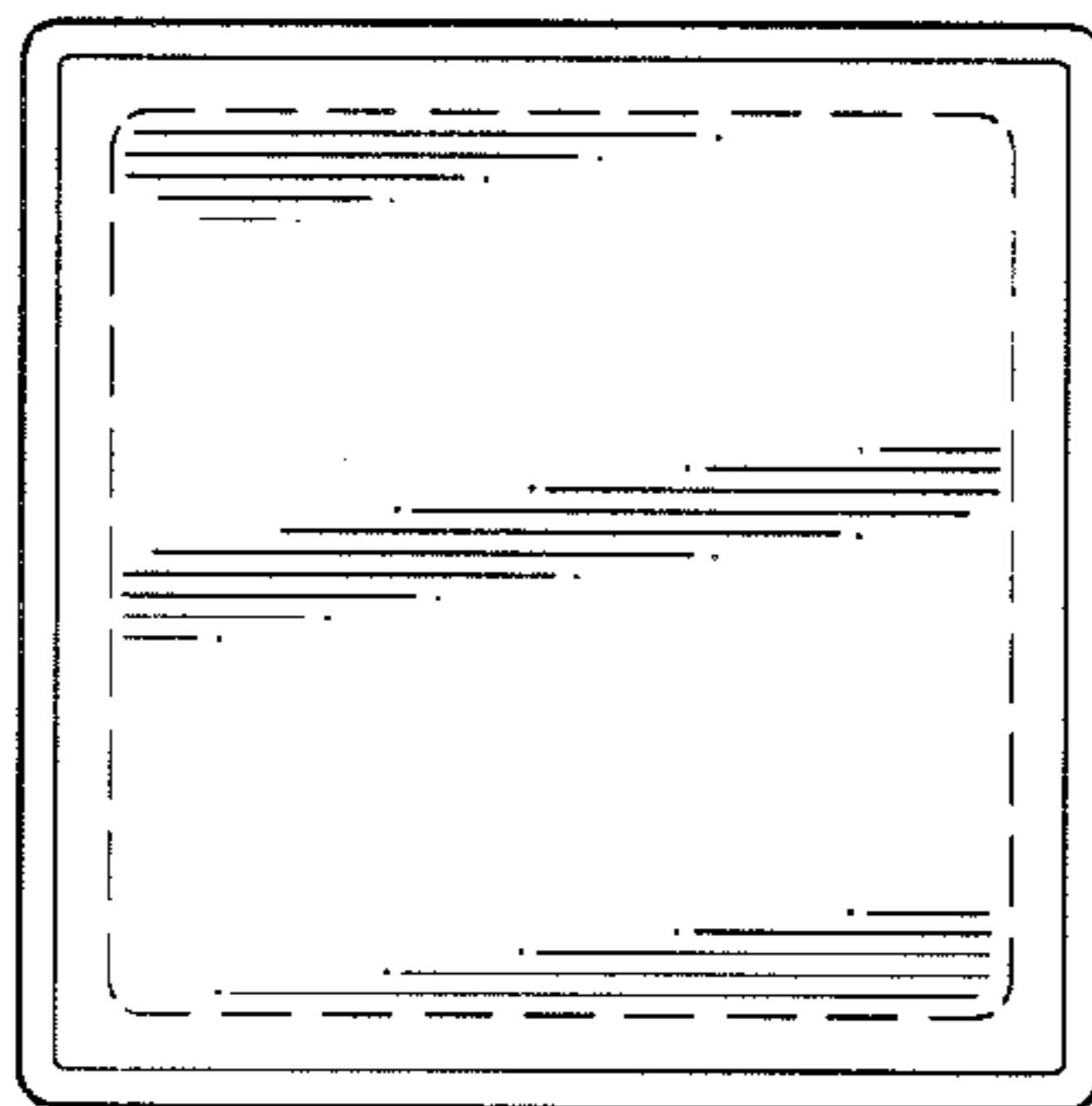

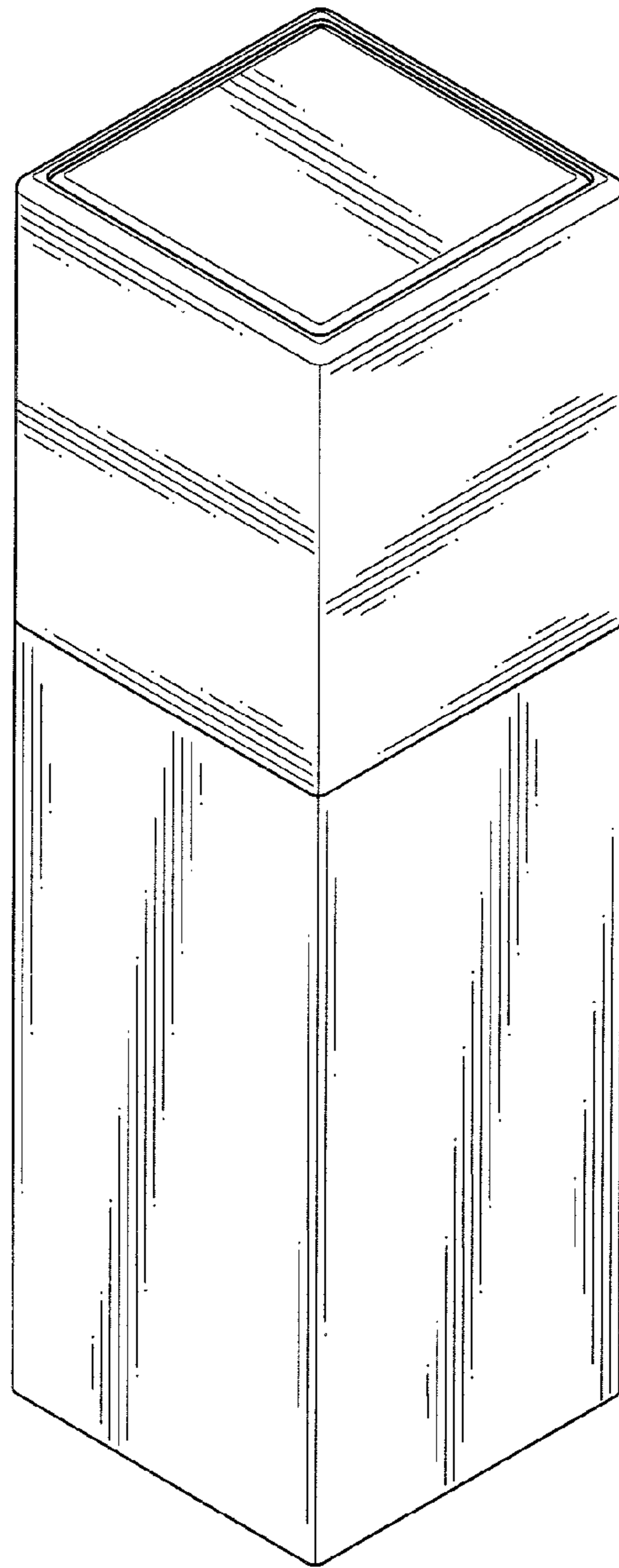

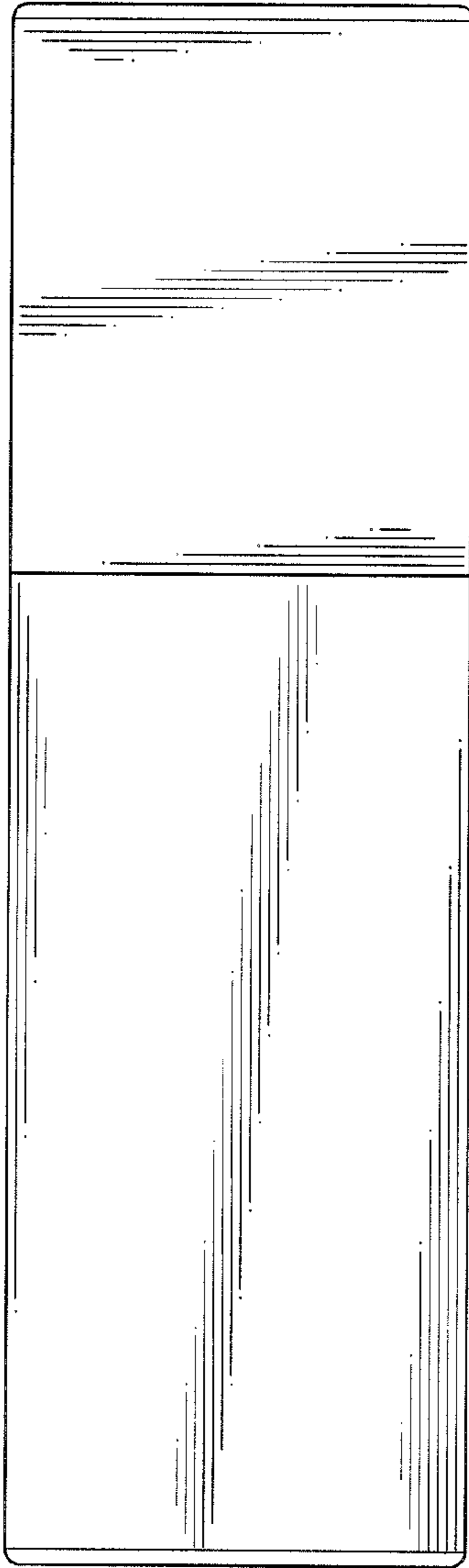
