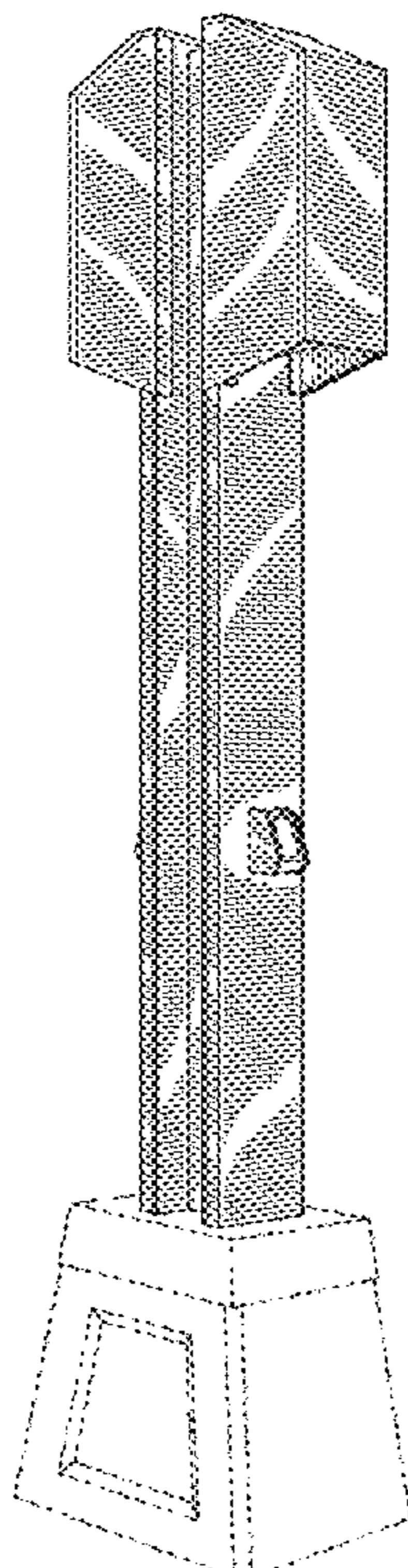
(57) **CLAIM**

The ornamental design for the pedestal mount housing for electric vehicle service equipment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pedestal mount housing for electric vehicle service equipment showing my new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of a second embodiment of FIG. 1; FIG. 9 is a left side elevational view of the pedestal mount housing for electric vehicle service equipment of FIG. 8; FIG. 10 is a right side elevational view of the pedestal mount housing for electric vehicle service equipment of FIG. 8; FIG. 11 is a front elevational view of the pedestal mount housing for electric vehicle service equipment of FIG. 8; FIG. 12 is a rear elevational view of the pedestal mount housing for electric vehicle service equipment of FIG. 8; FIG. 13 is a top plan view of the pedestal mount housing for electric vehicle service equipment of FIG. 8; and, FIG. 14 is a bottom plan view of the pedestal mount housing for electric vehicle service equipment of FIG. 8. The broken lines in the drawings illustrate unclaimed portions of the pedestal for the pedestal mount housing for electric vehicle service equipment and form no part of the claimed design.

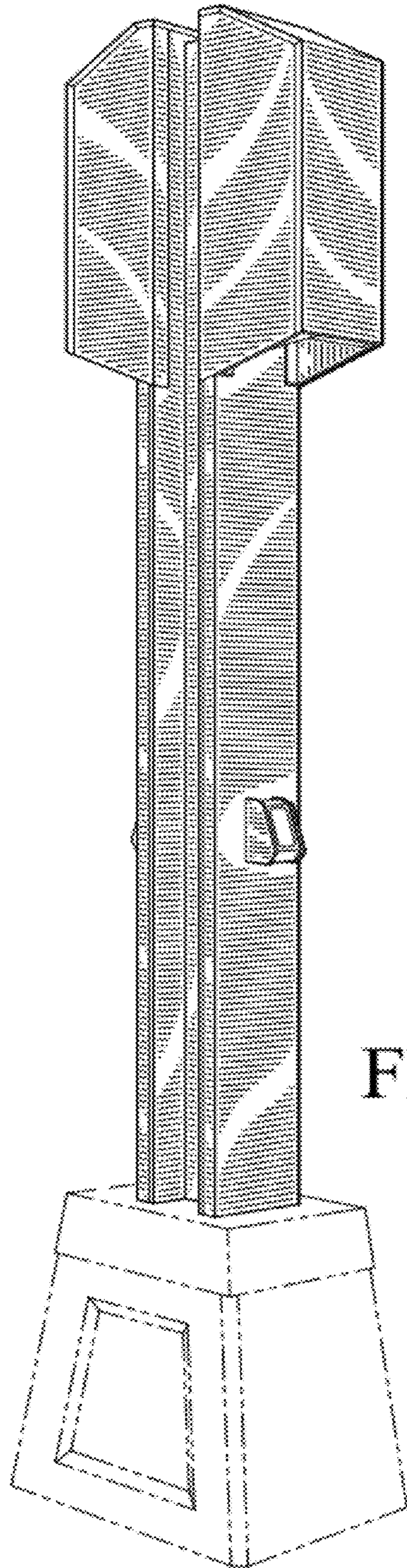

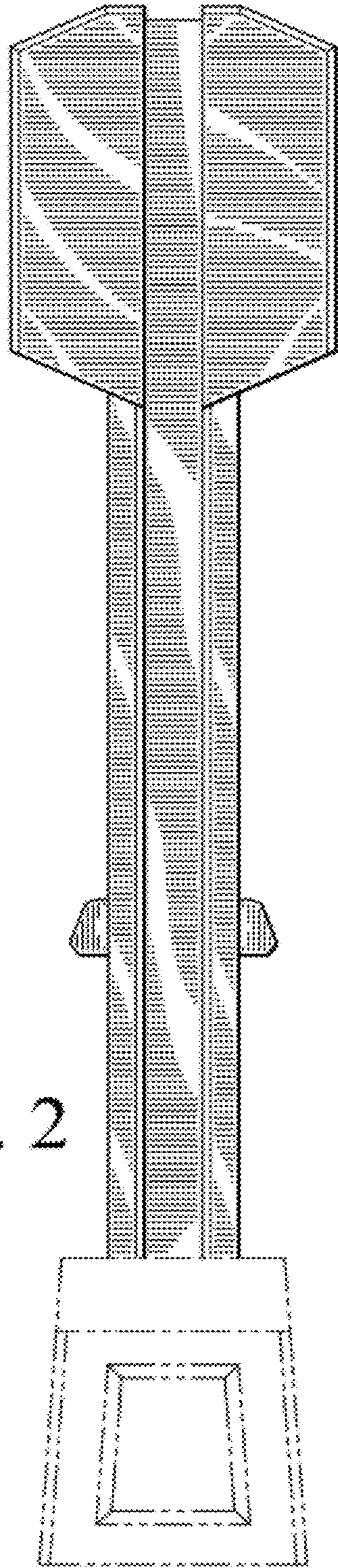

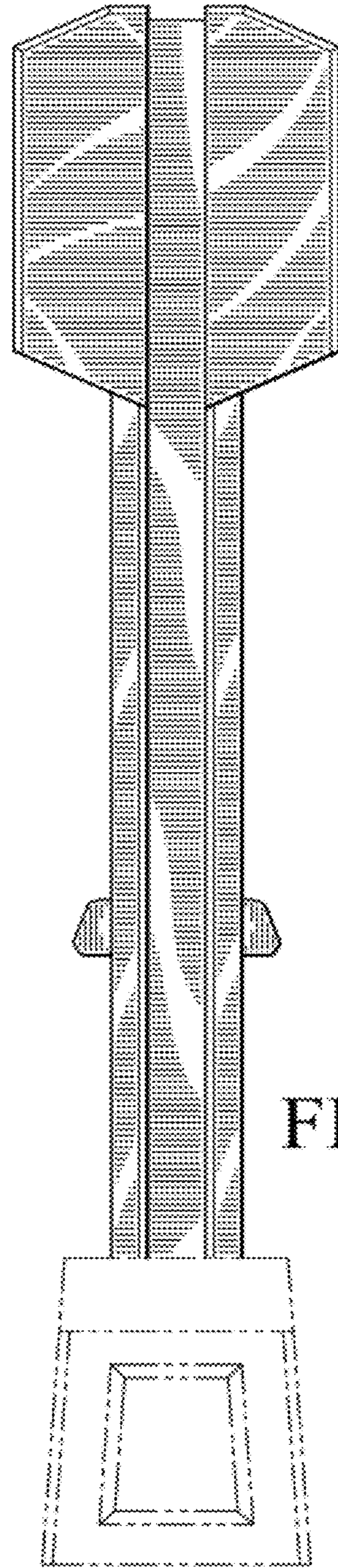

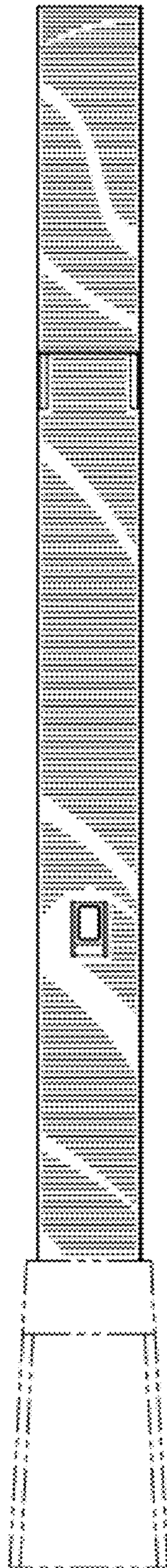

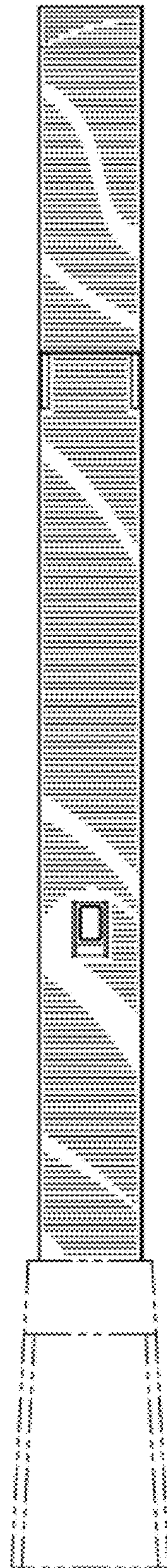

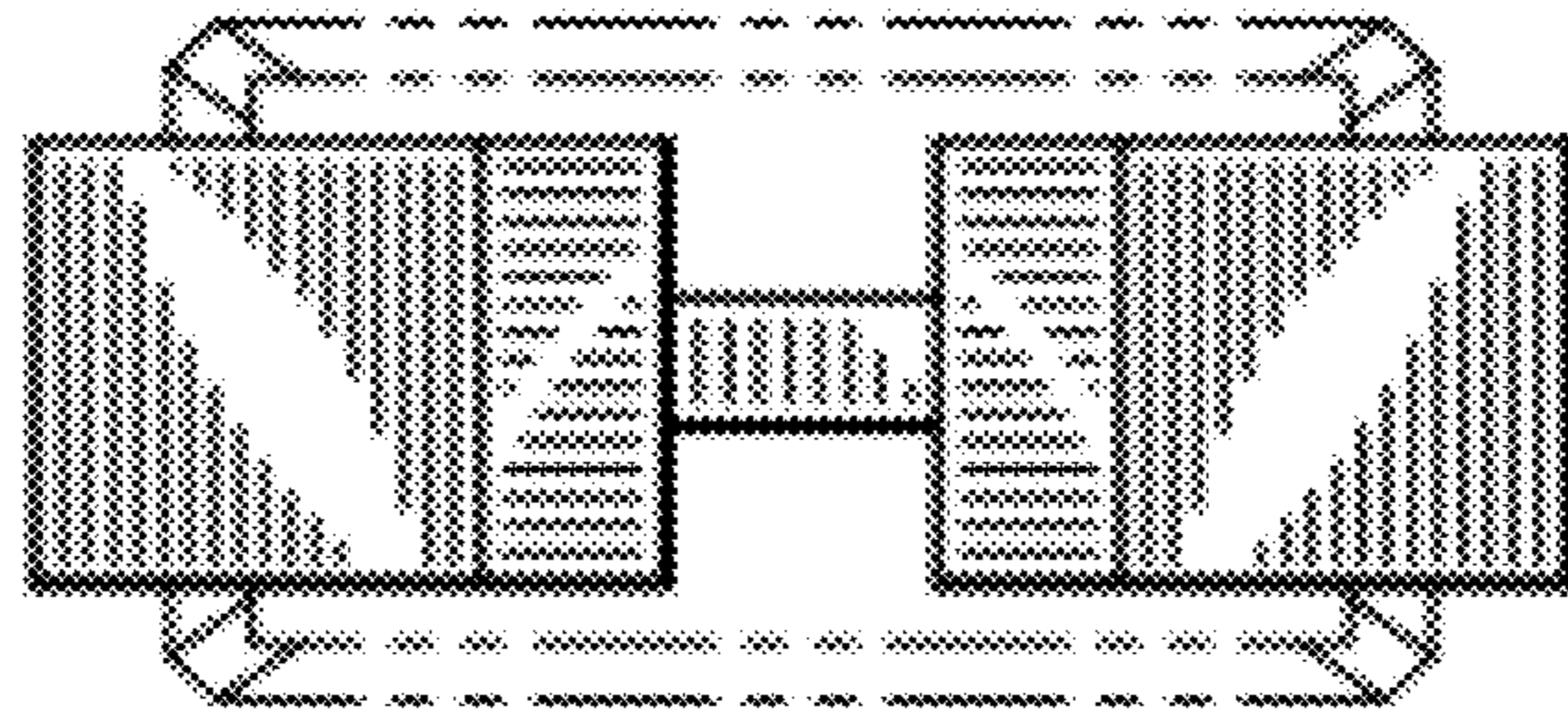

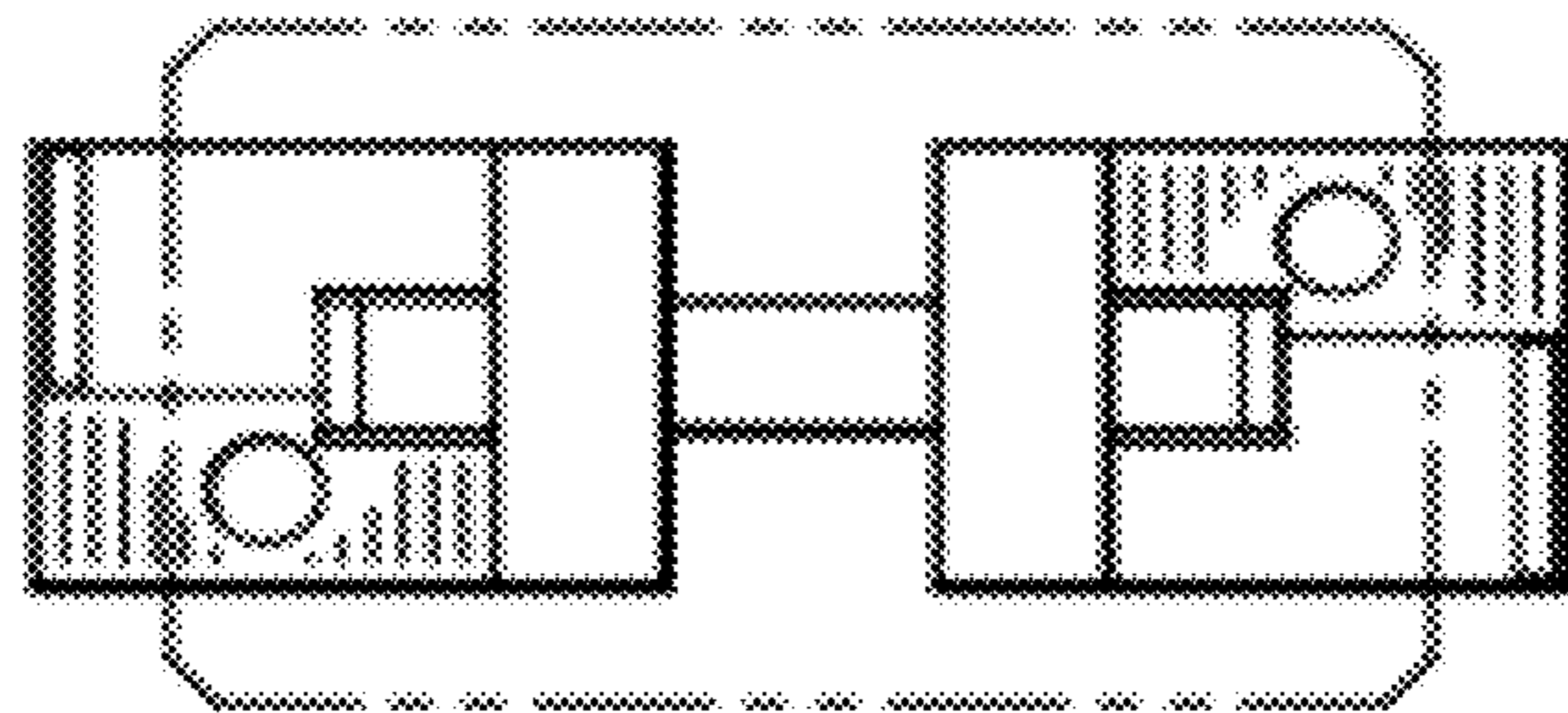

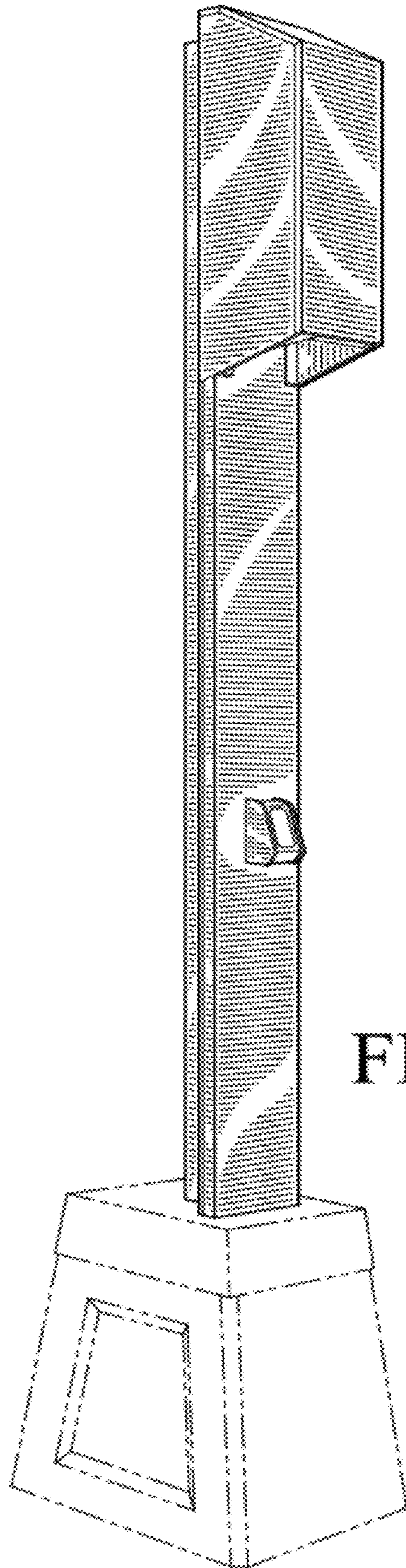

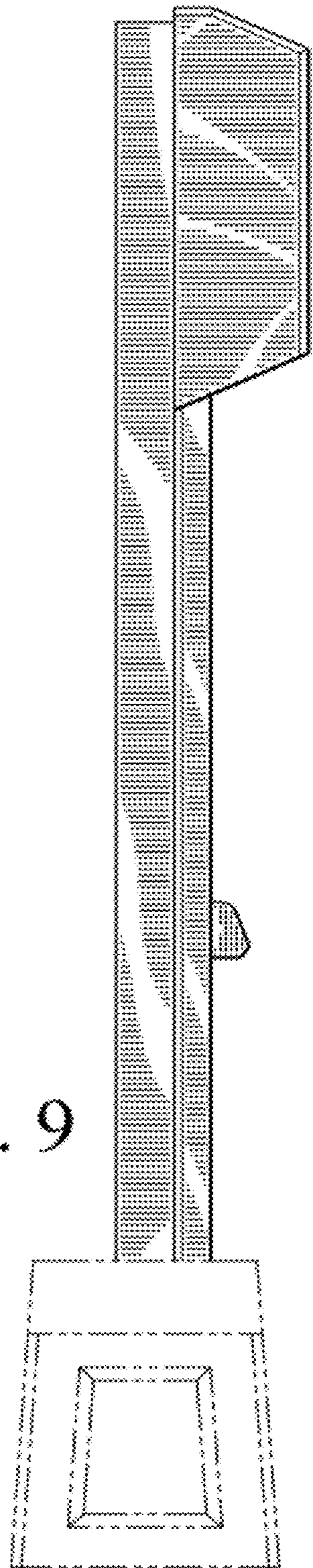

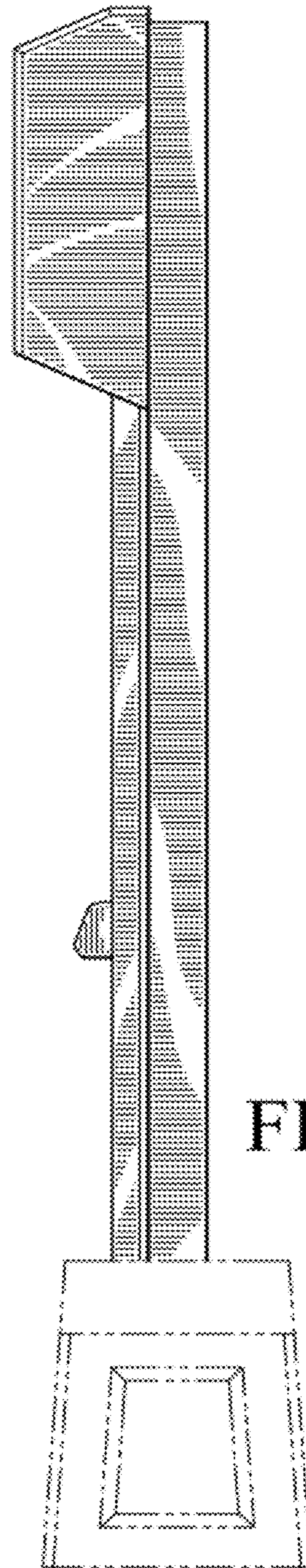

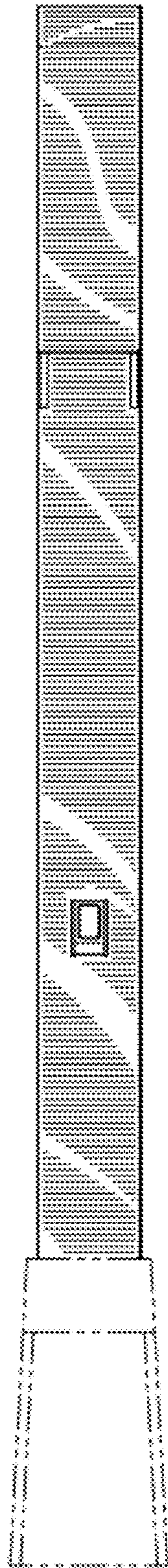

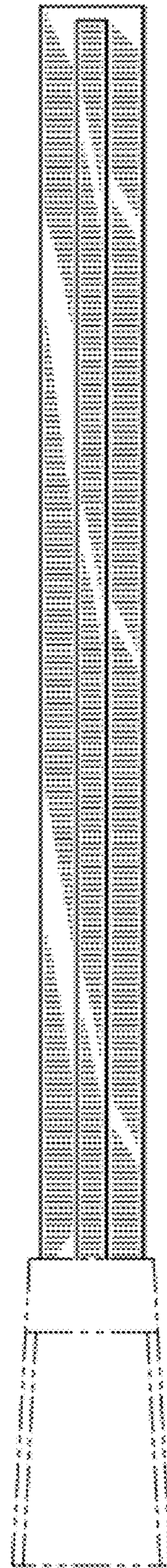

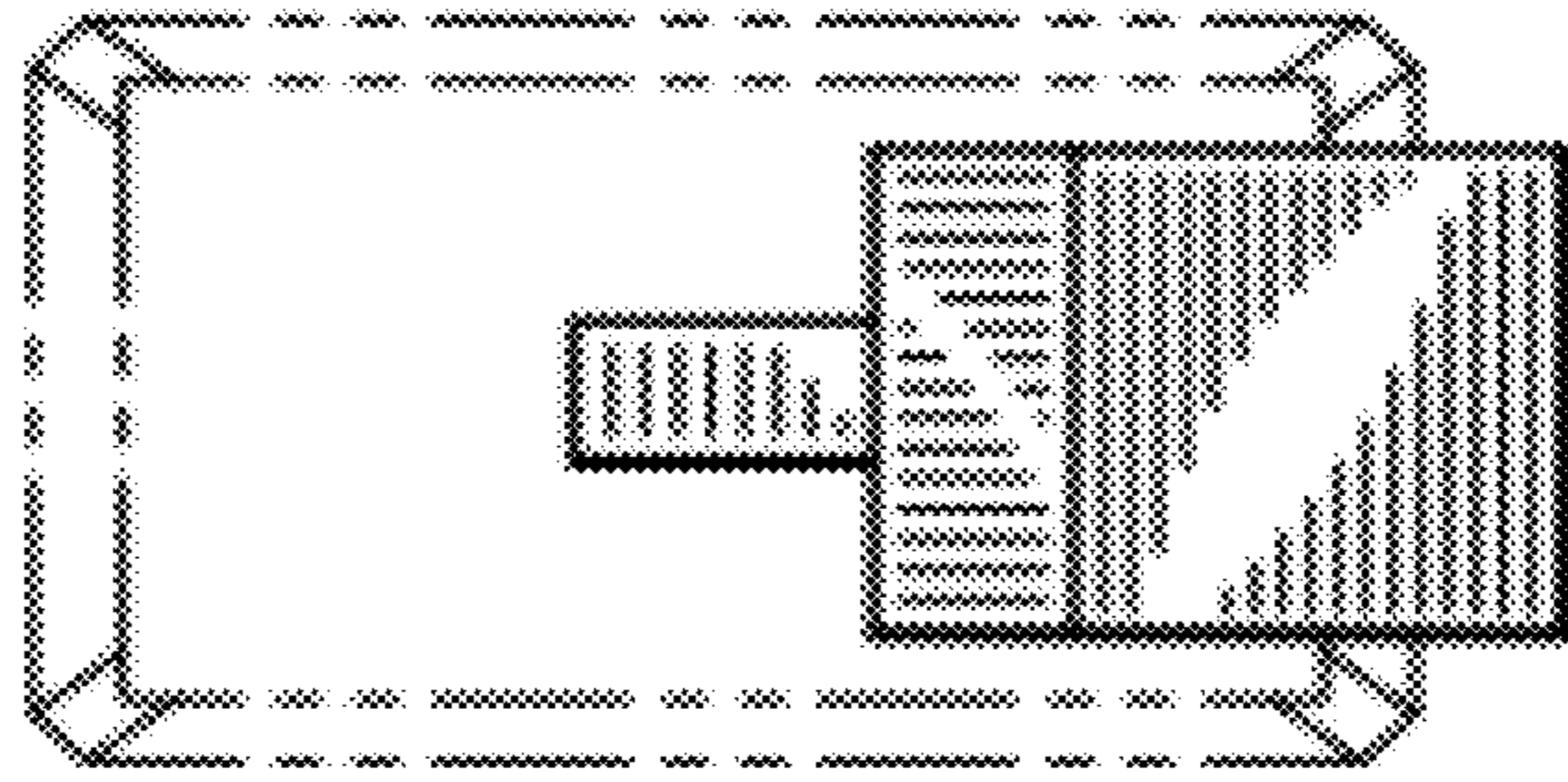

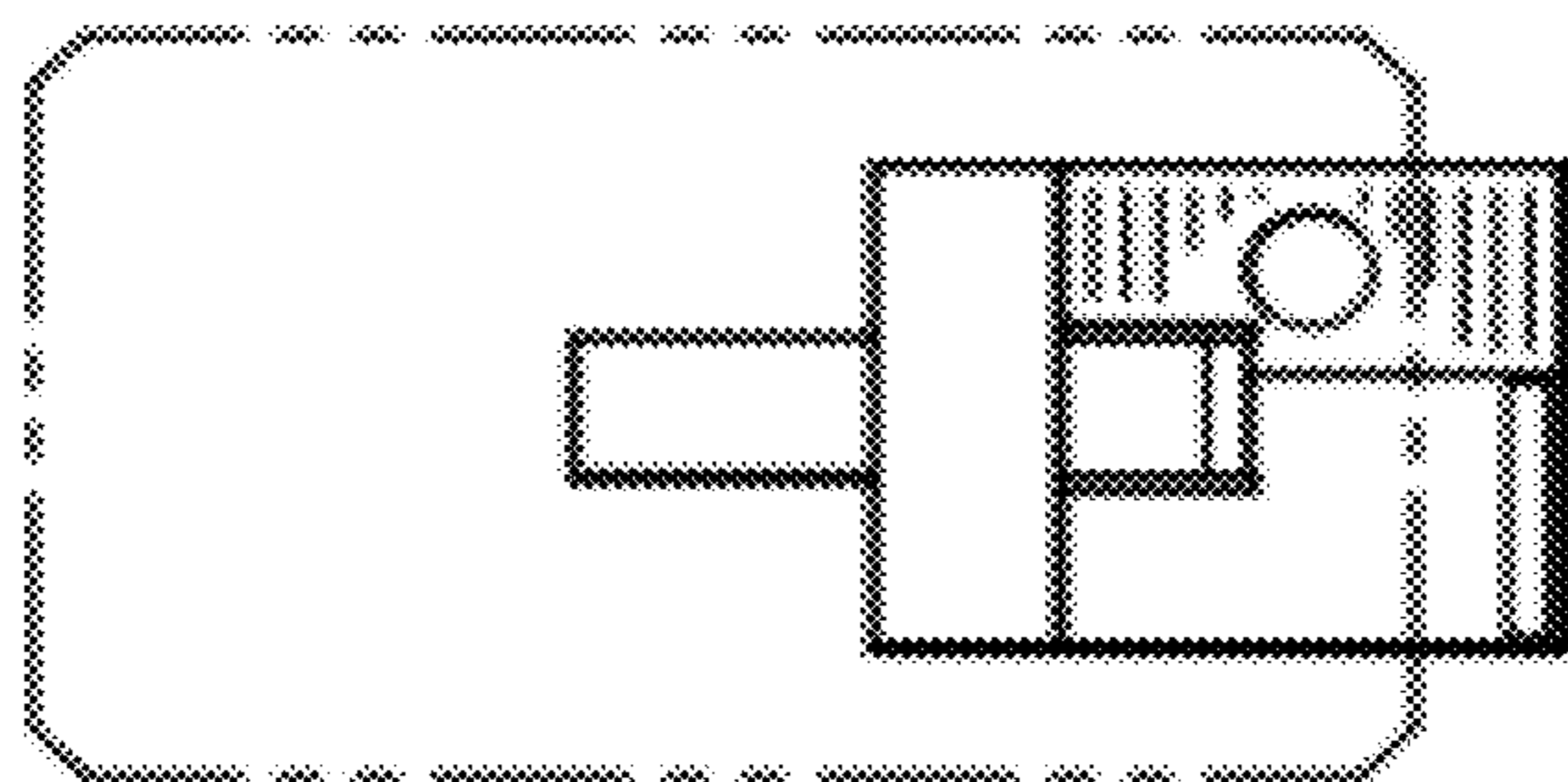
