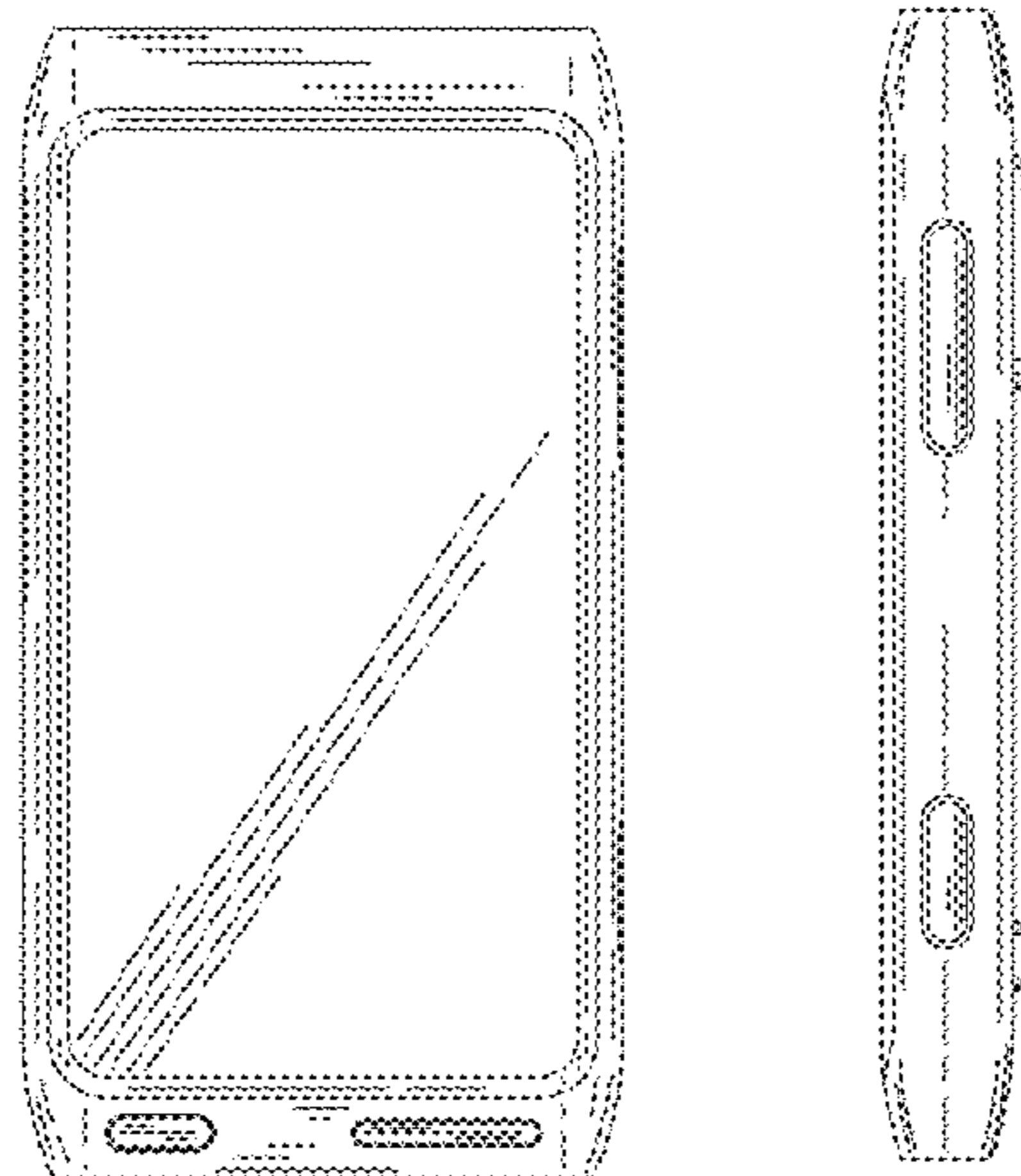
CLAIM

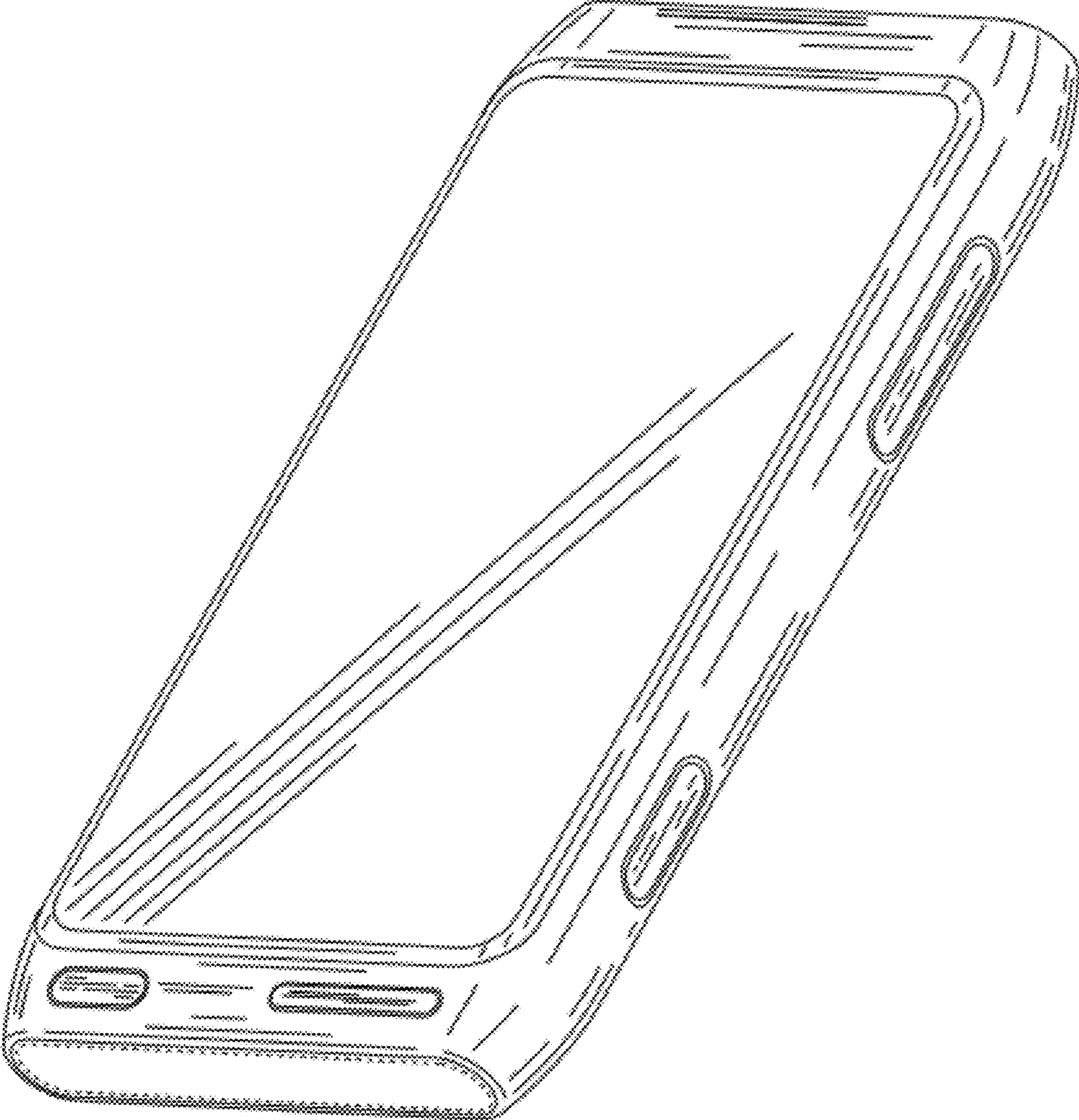

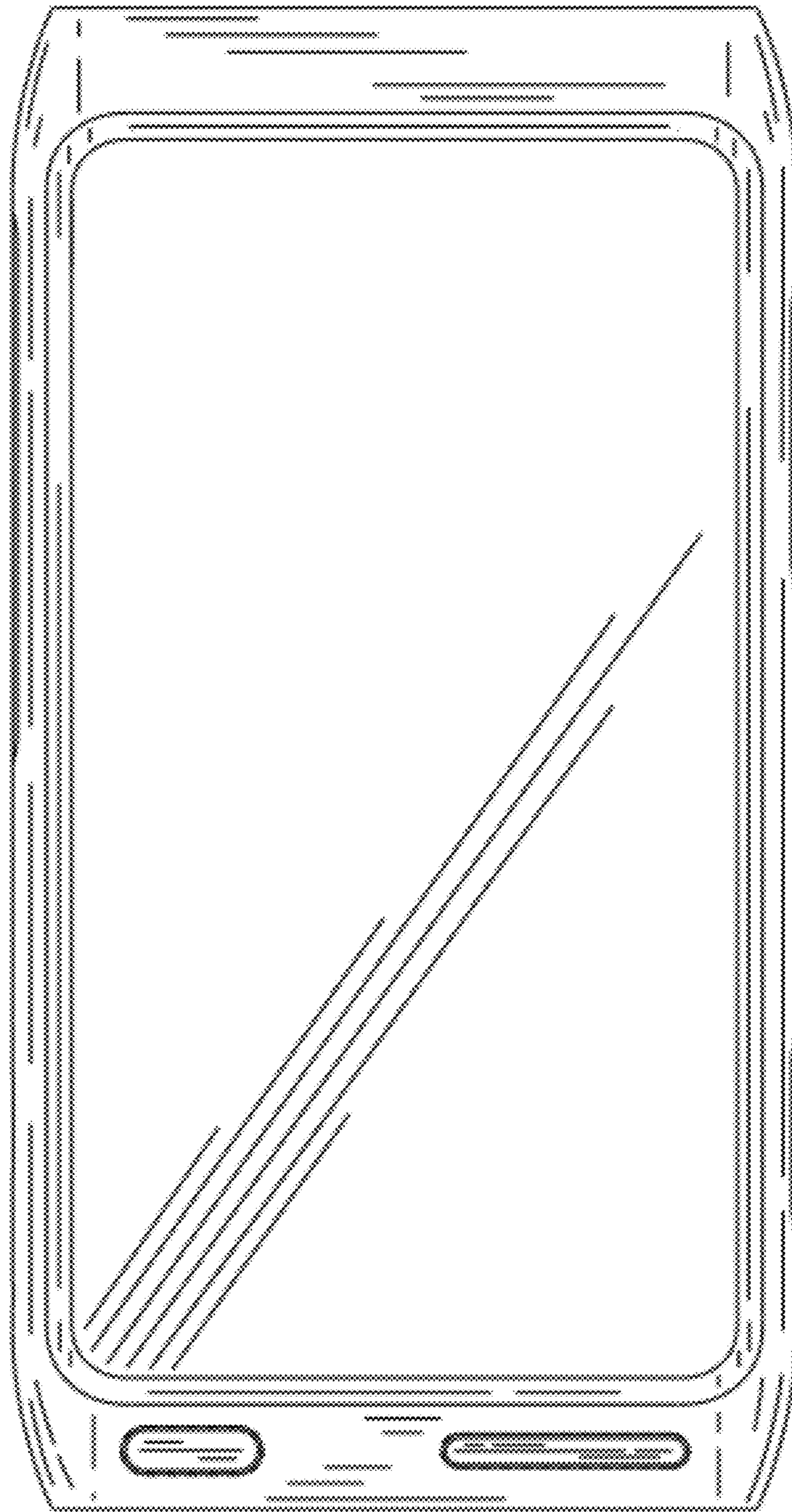

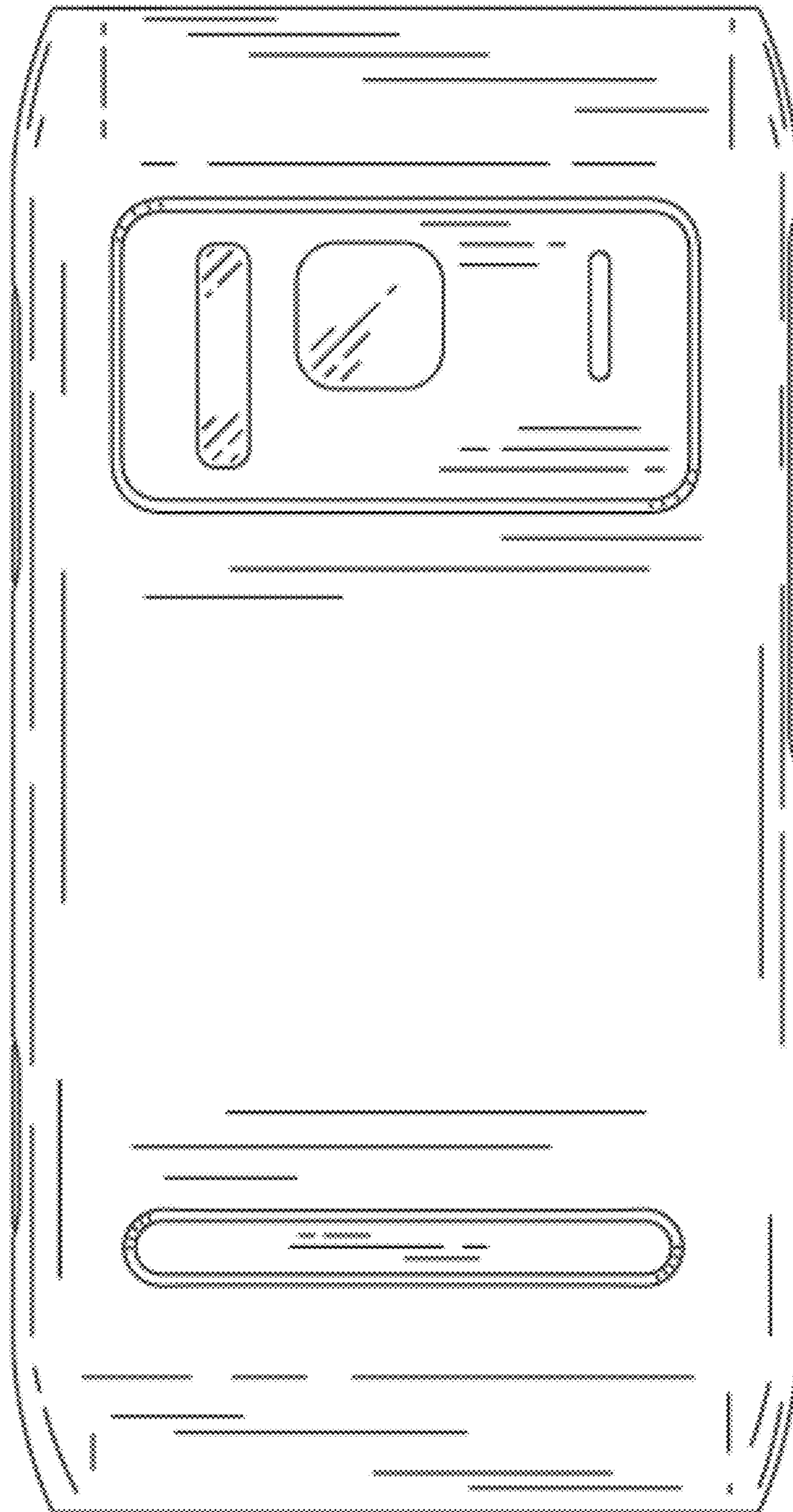

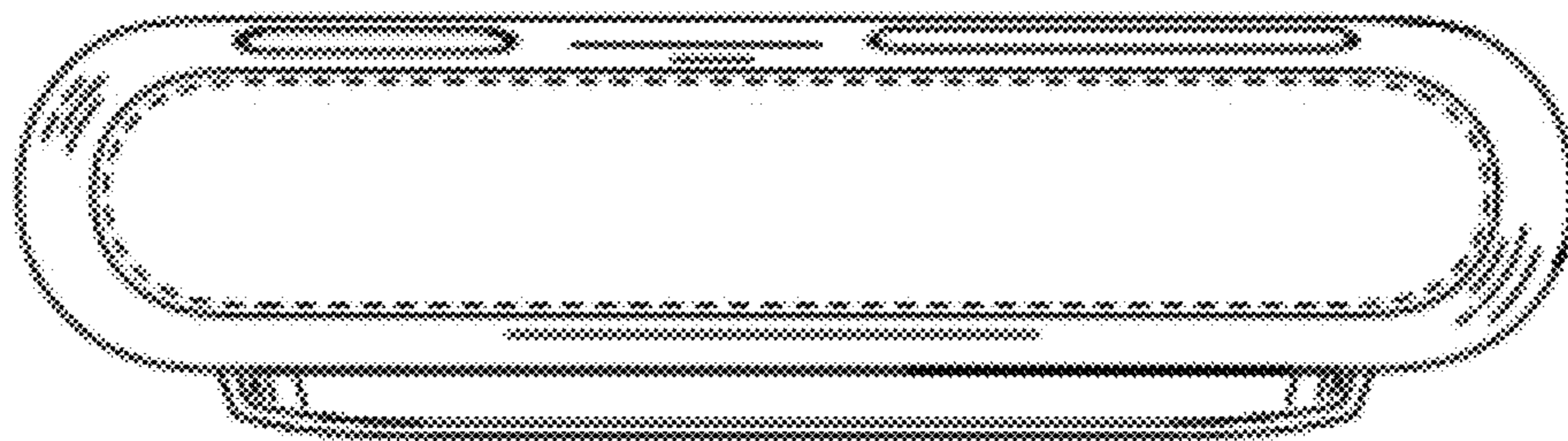

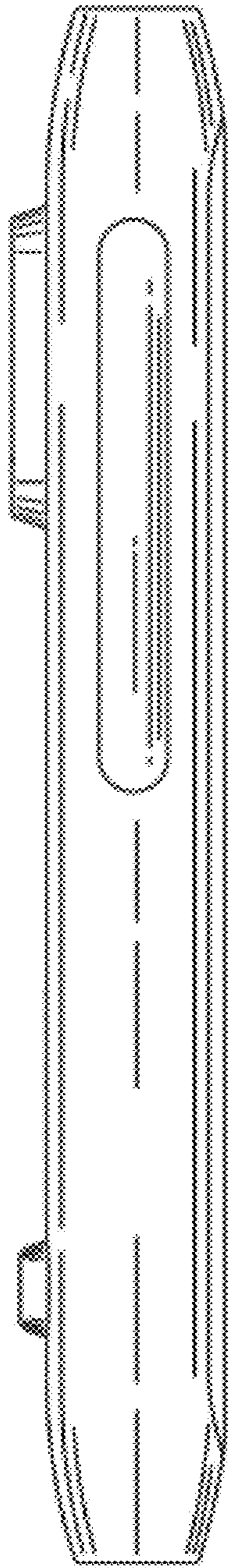

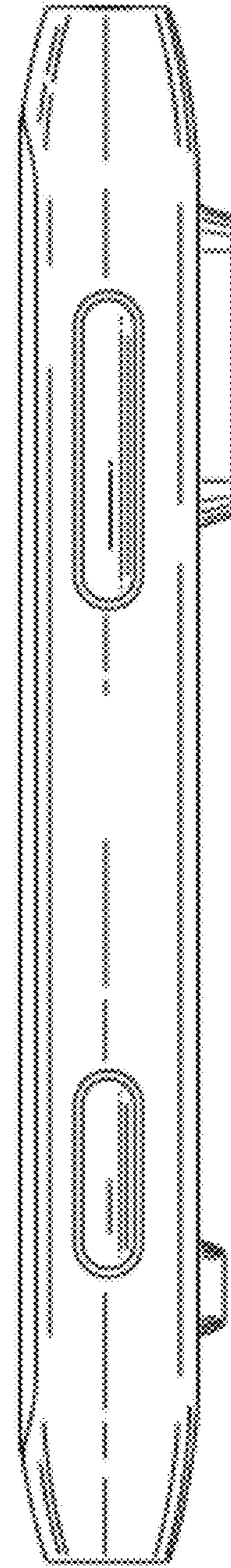
