(57) **CLAIM**

The ornamental design for a display screen with keyboard layout, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a display screen with keyboard layout; and, FIG. 2 is a front elevational view of another display screen with keyboard layout. The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines showing the outer border of the display screen and the keyboard layout for a display screen in the drawings form no part of the claimed design.

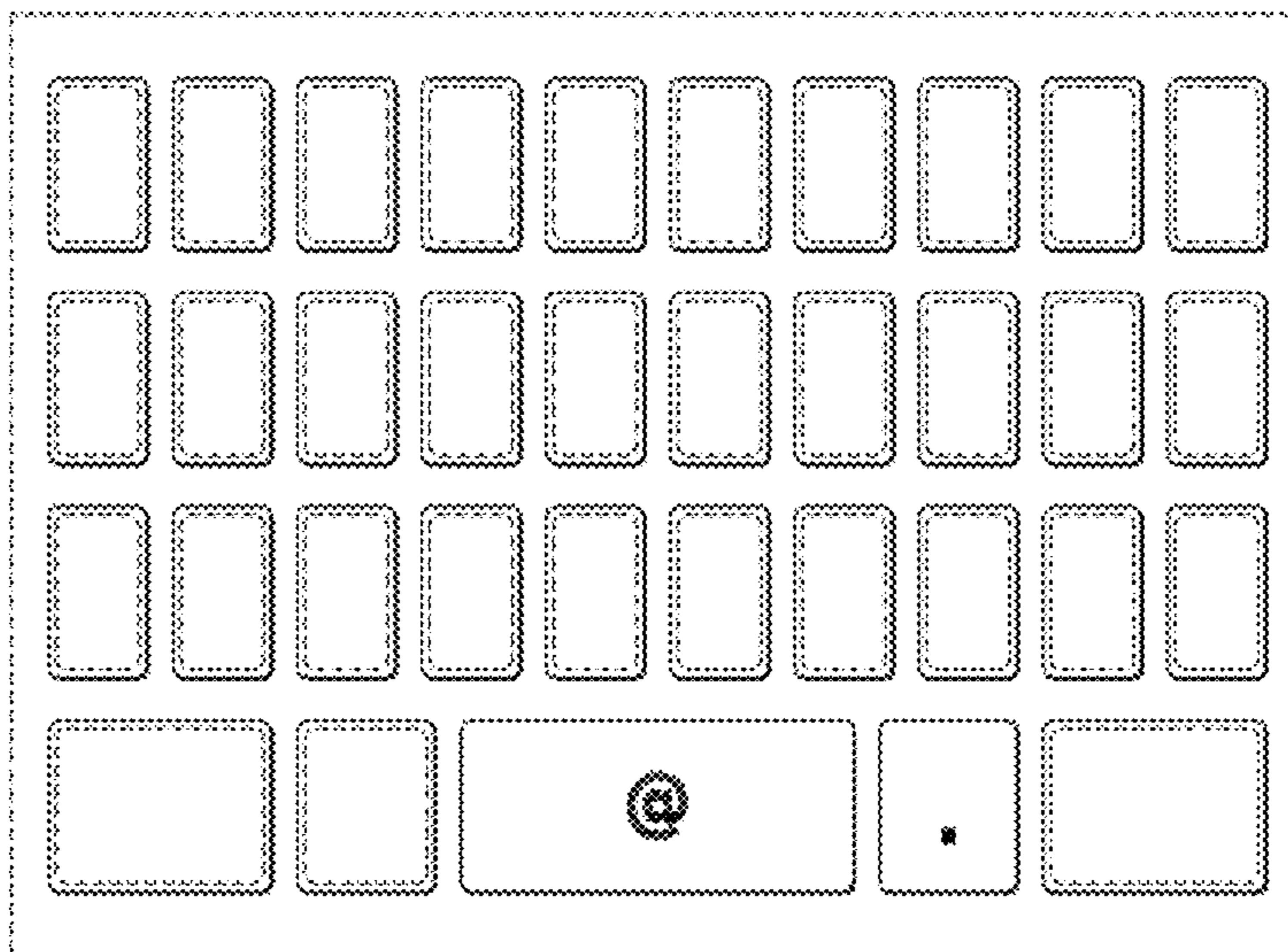

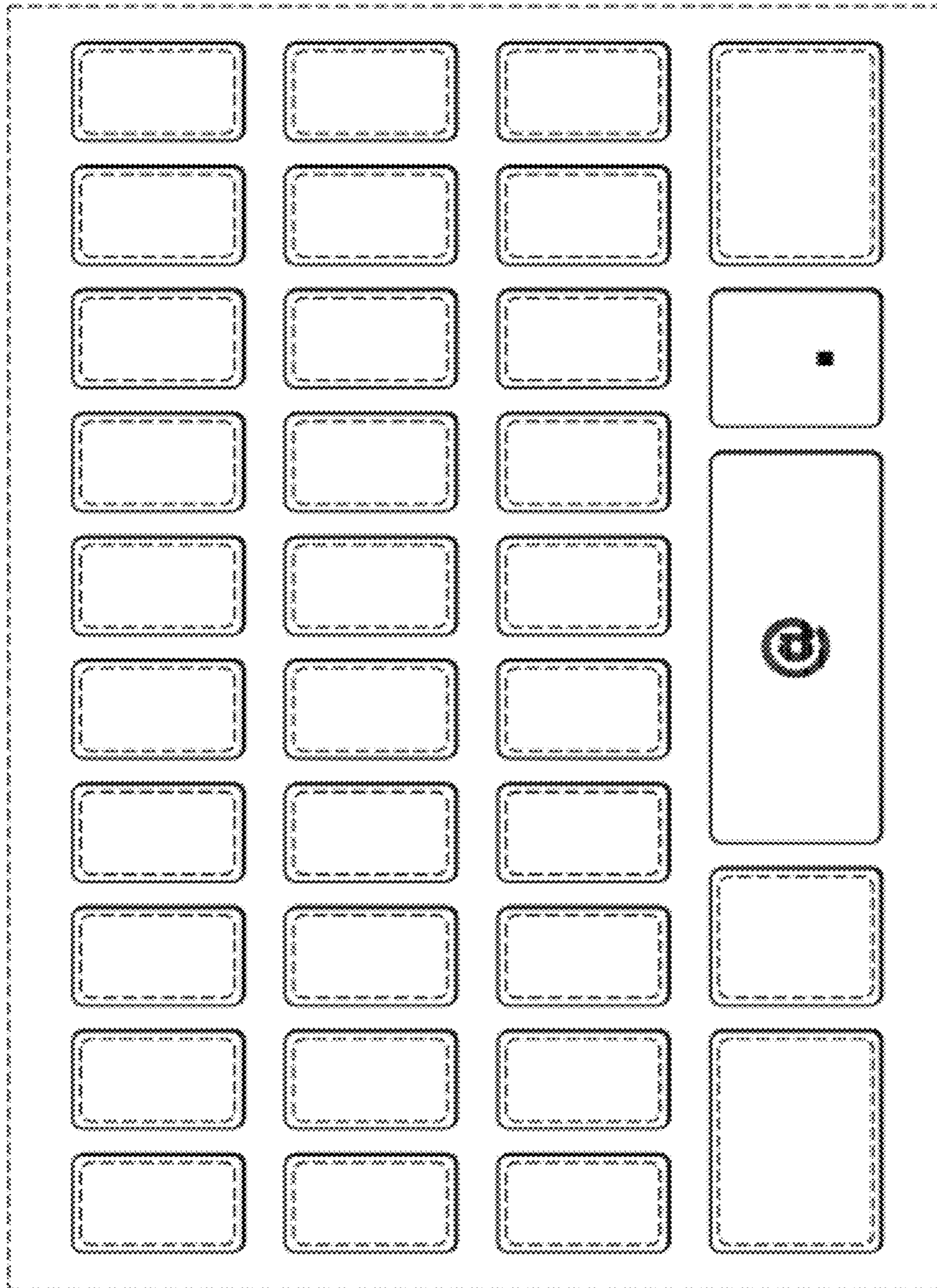
