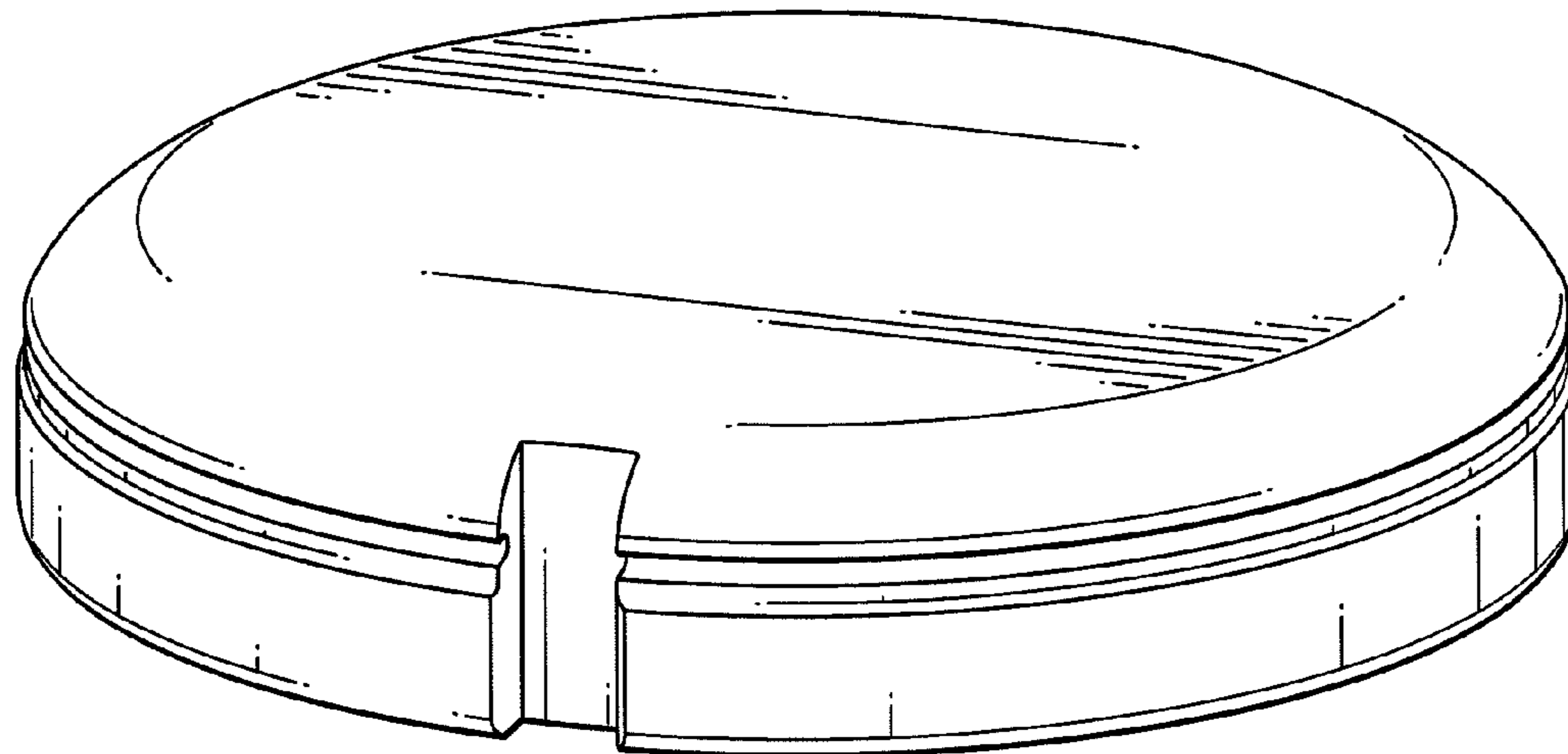
(57) **CLAIM**

We claim the ornamental design for a die tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of our new design for a die tool;  
FIG. 2 is a top view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a side view thereof, the opposite side view being a  
mirror image thereof; and,

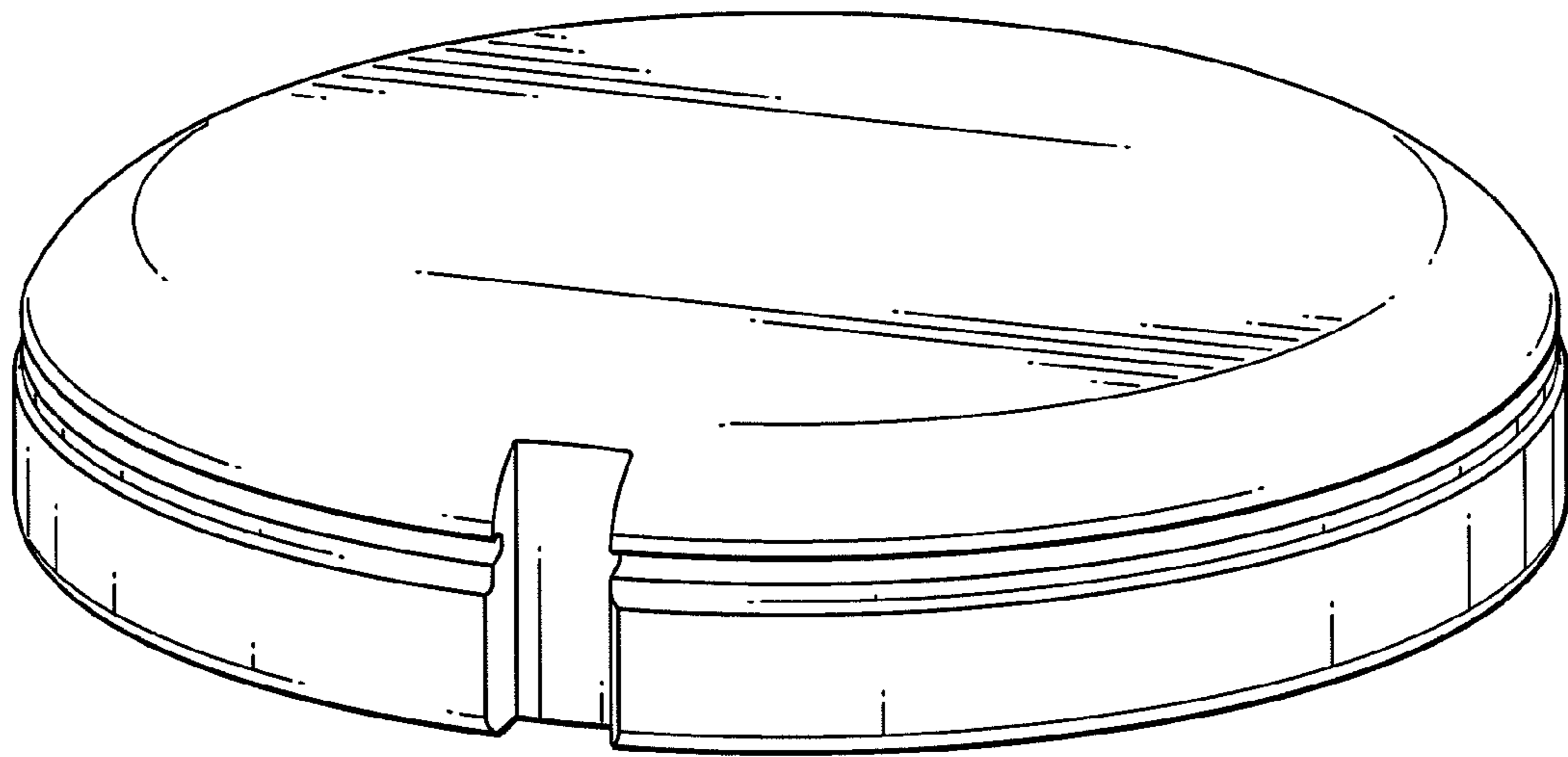

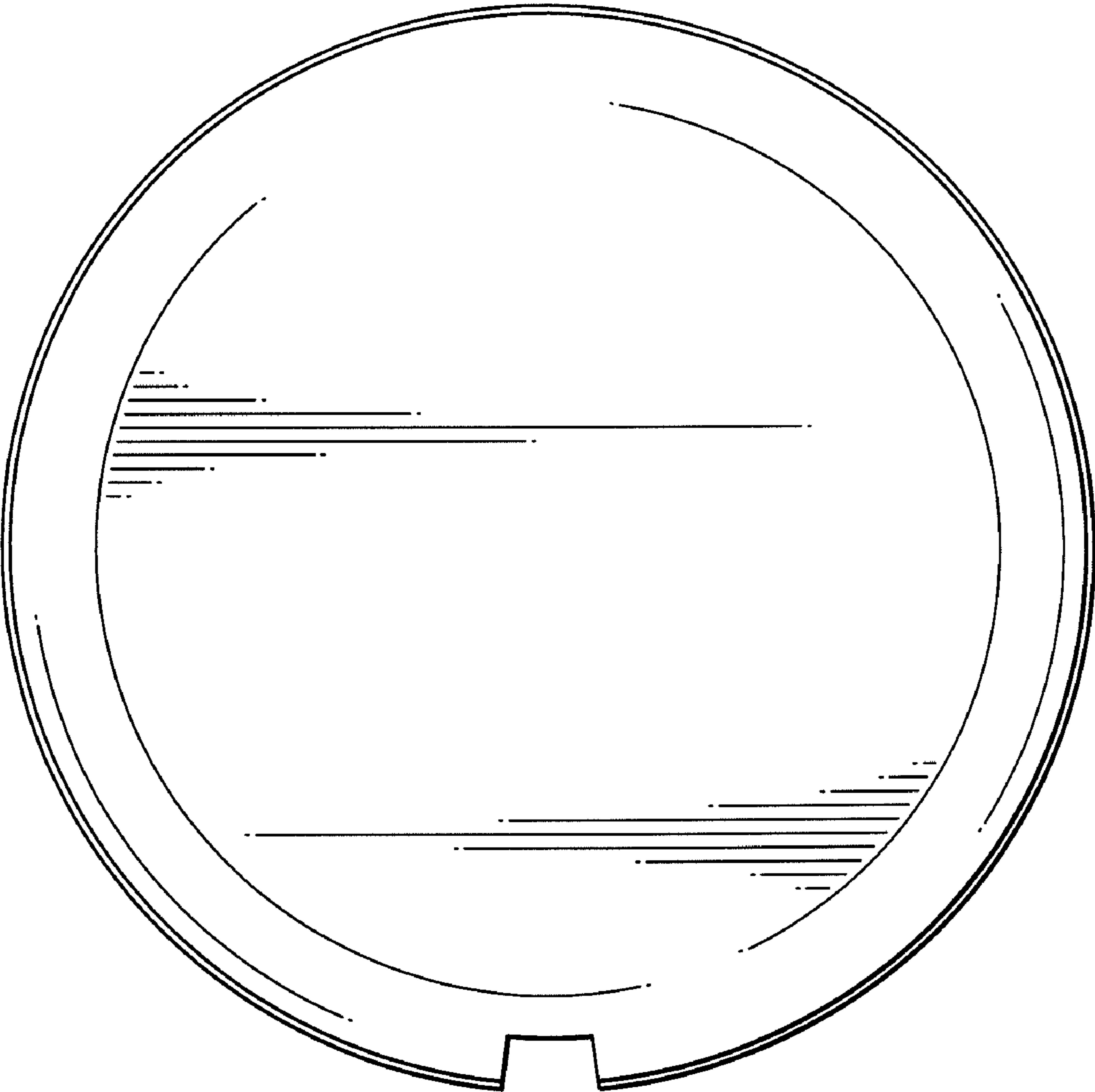

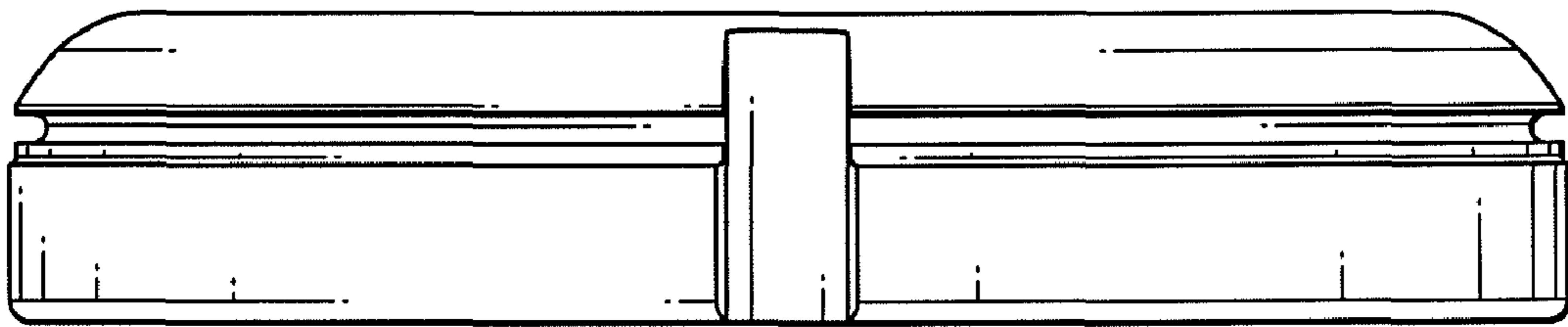

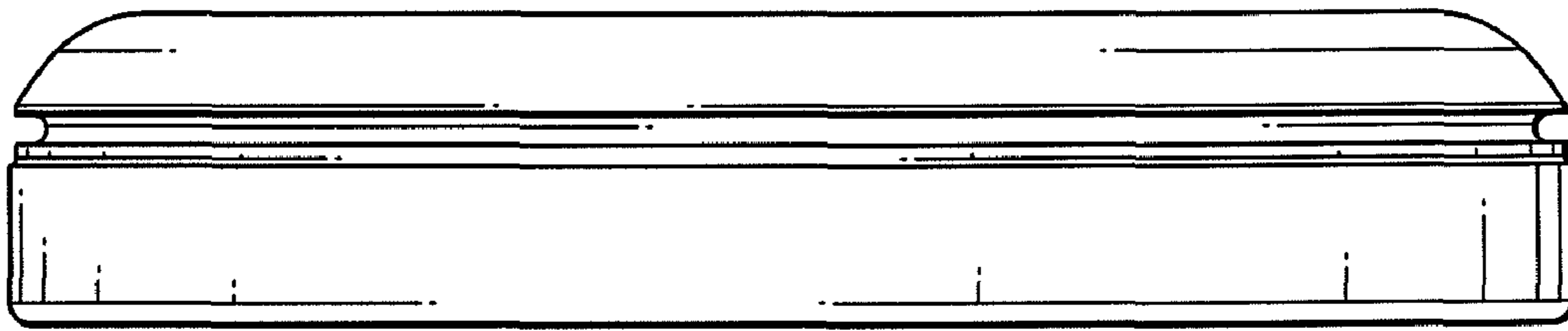

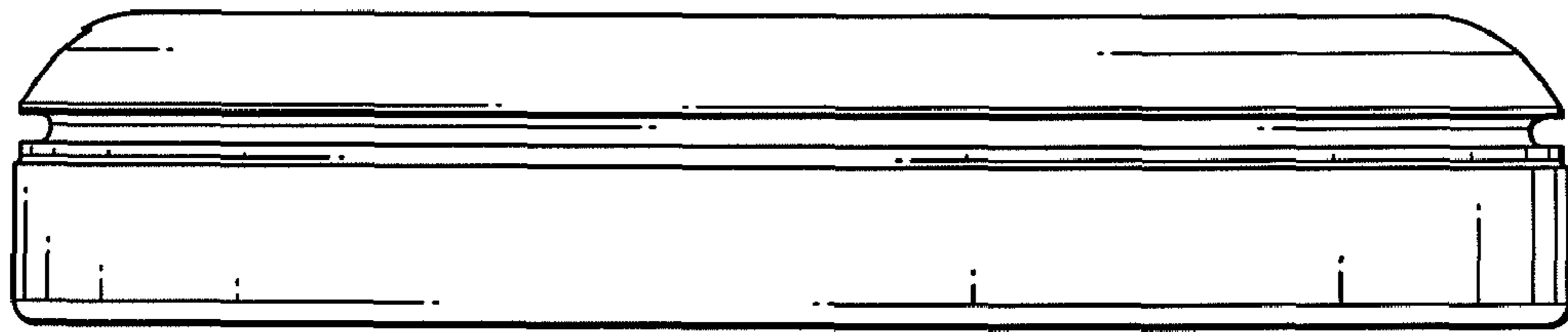

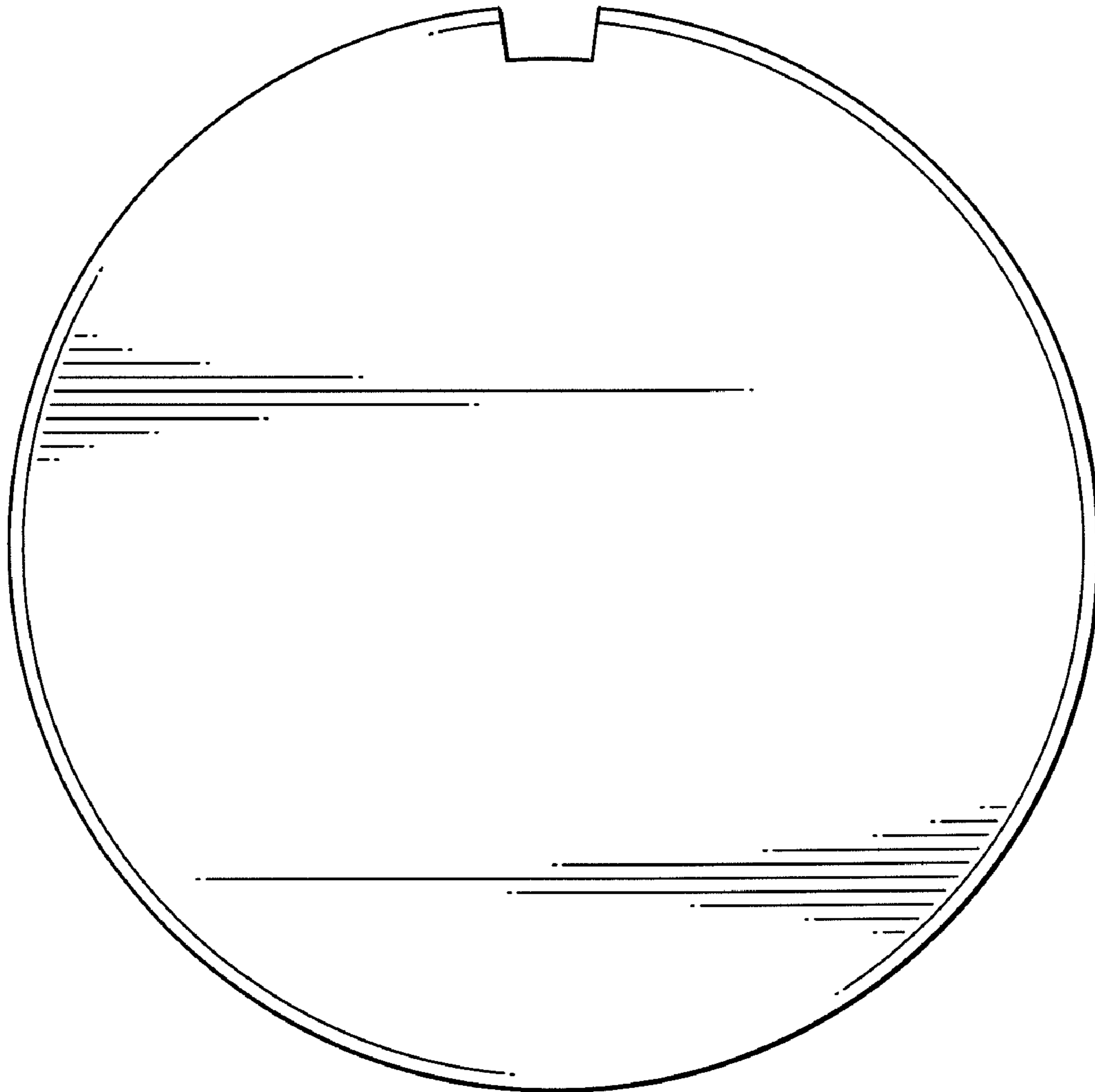
