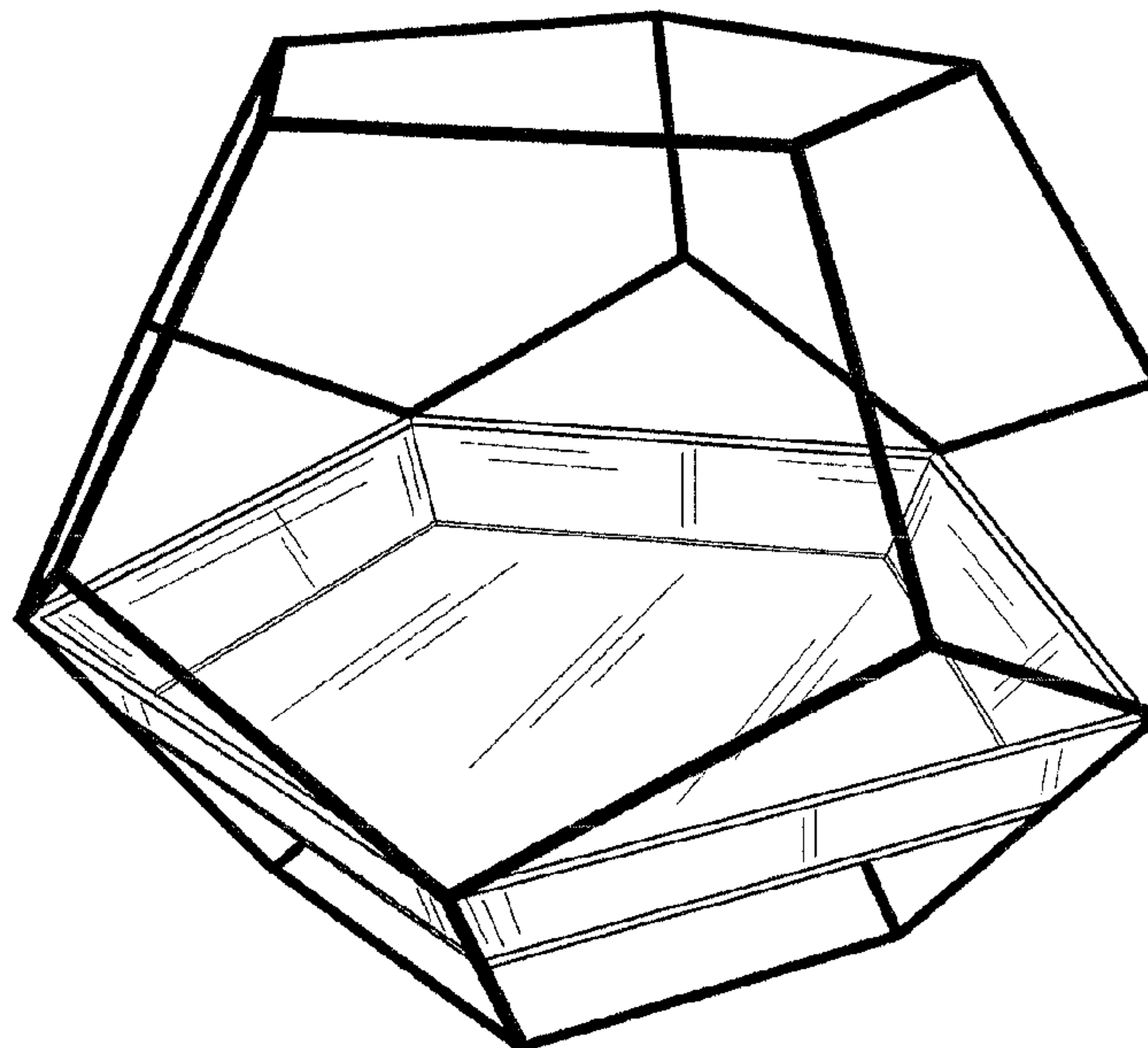
(57) **CLAIM**

The ornamental design for a swimming pool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front, top, and right side of the swimming pool embodying my new design;
FIG. 2 is a perspective view from the rear and bottom thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;

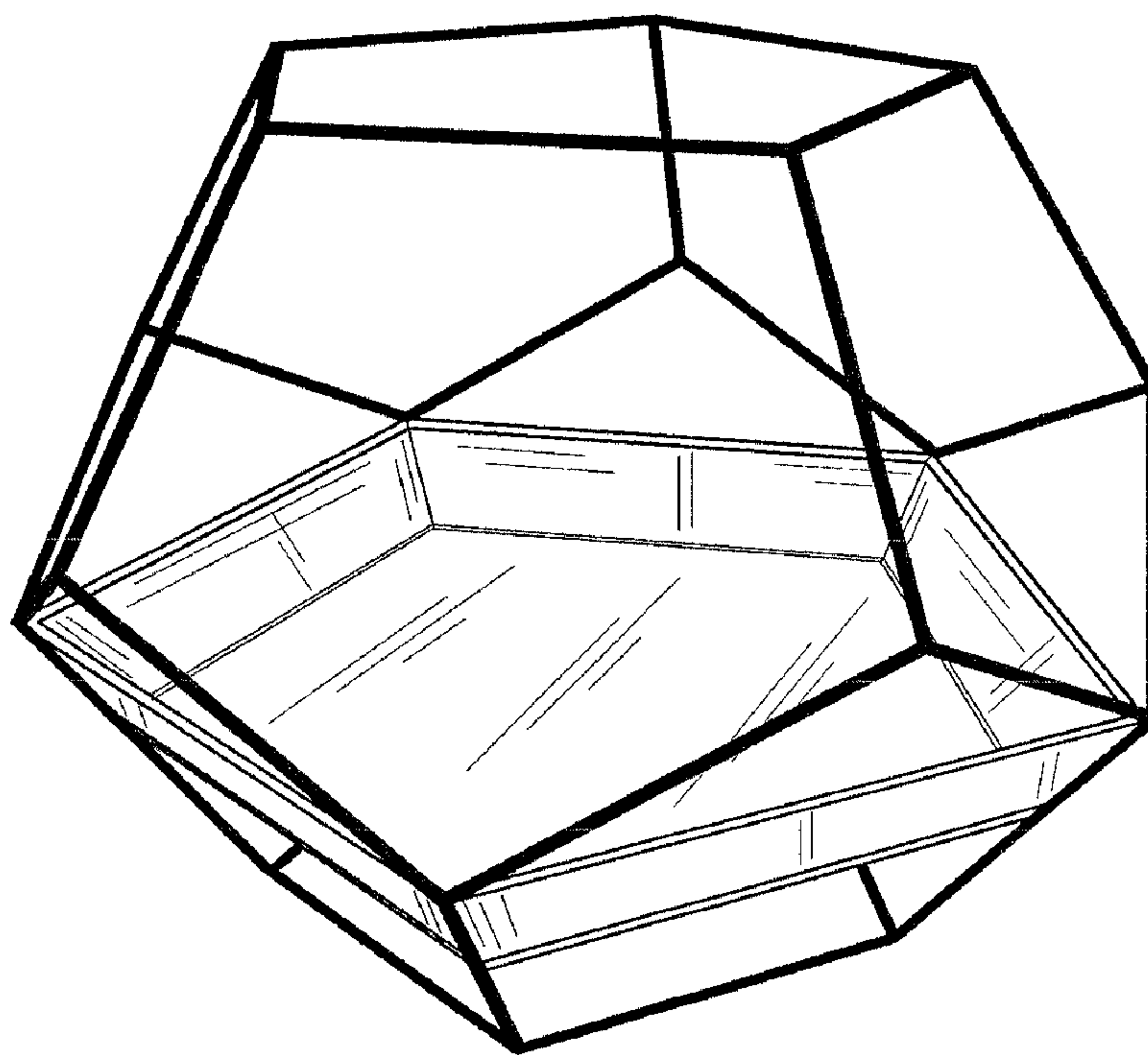

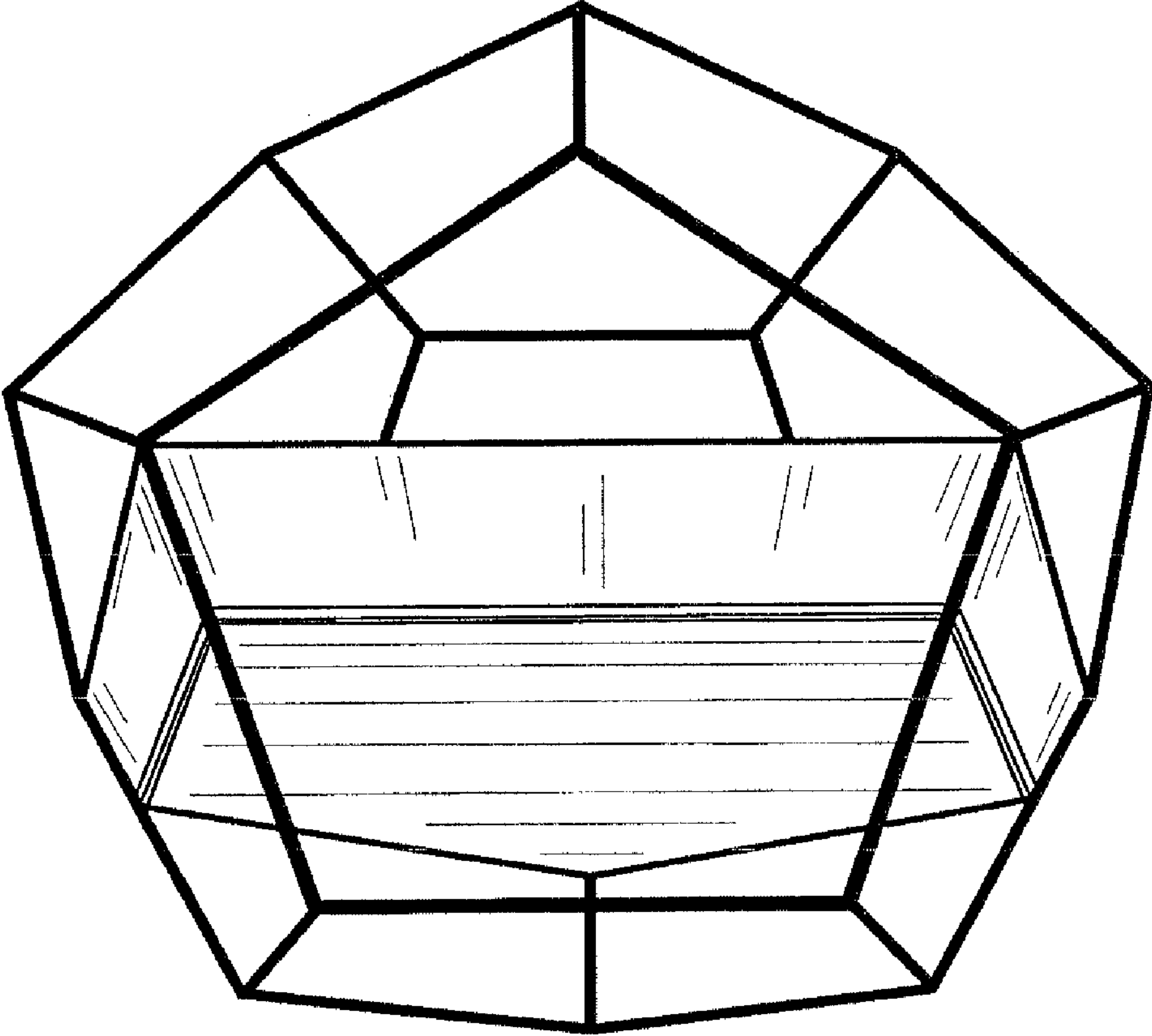

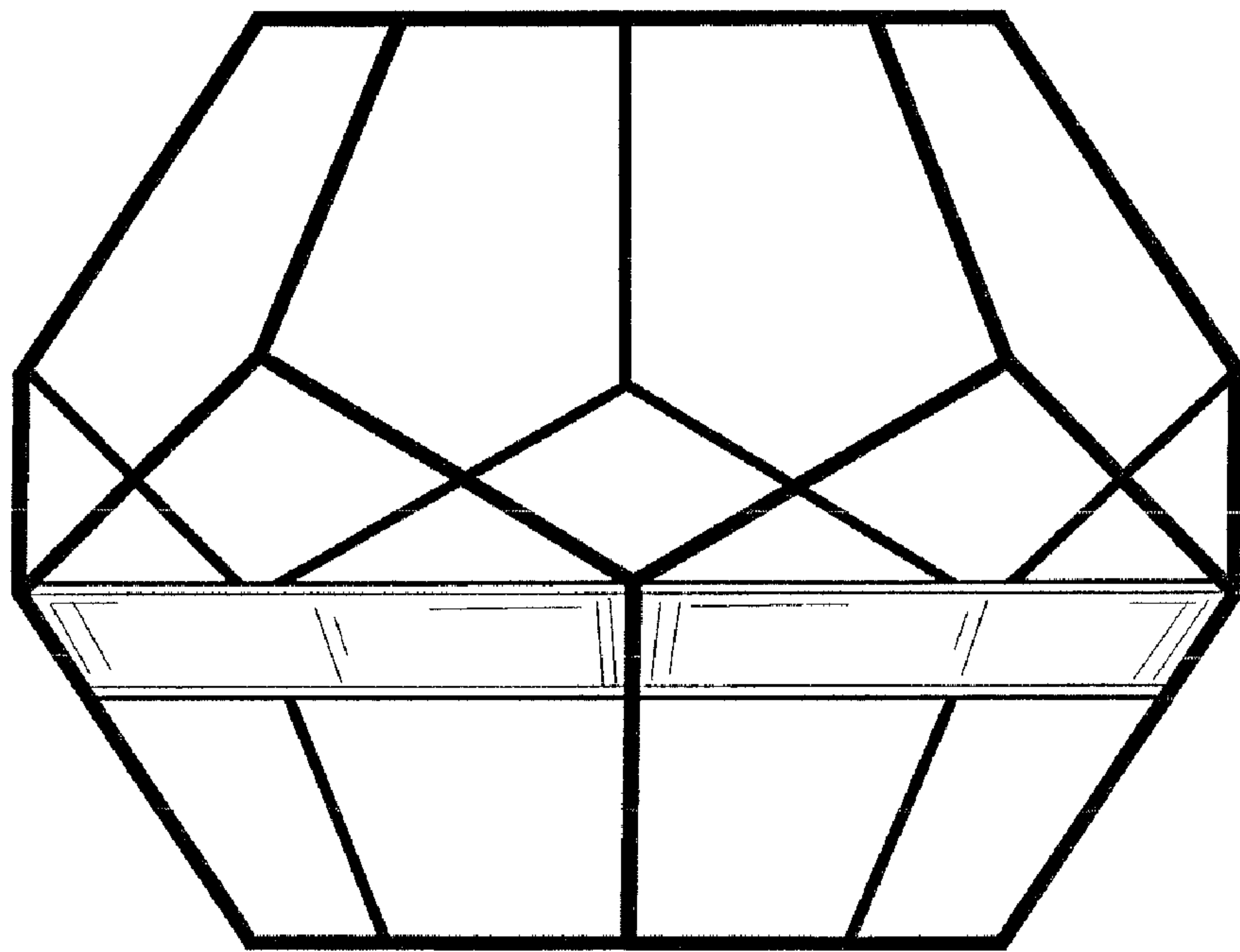

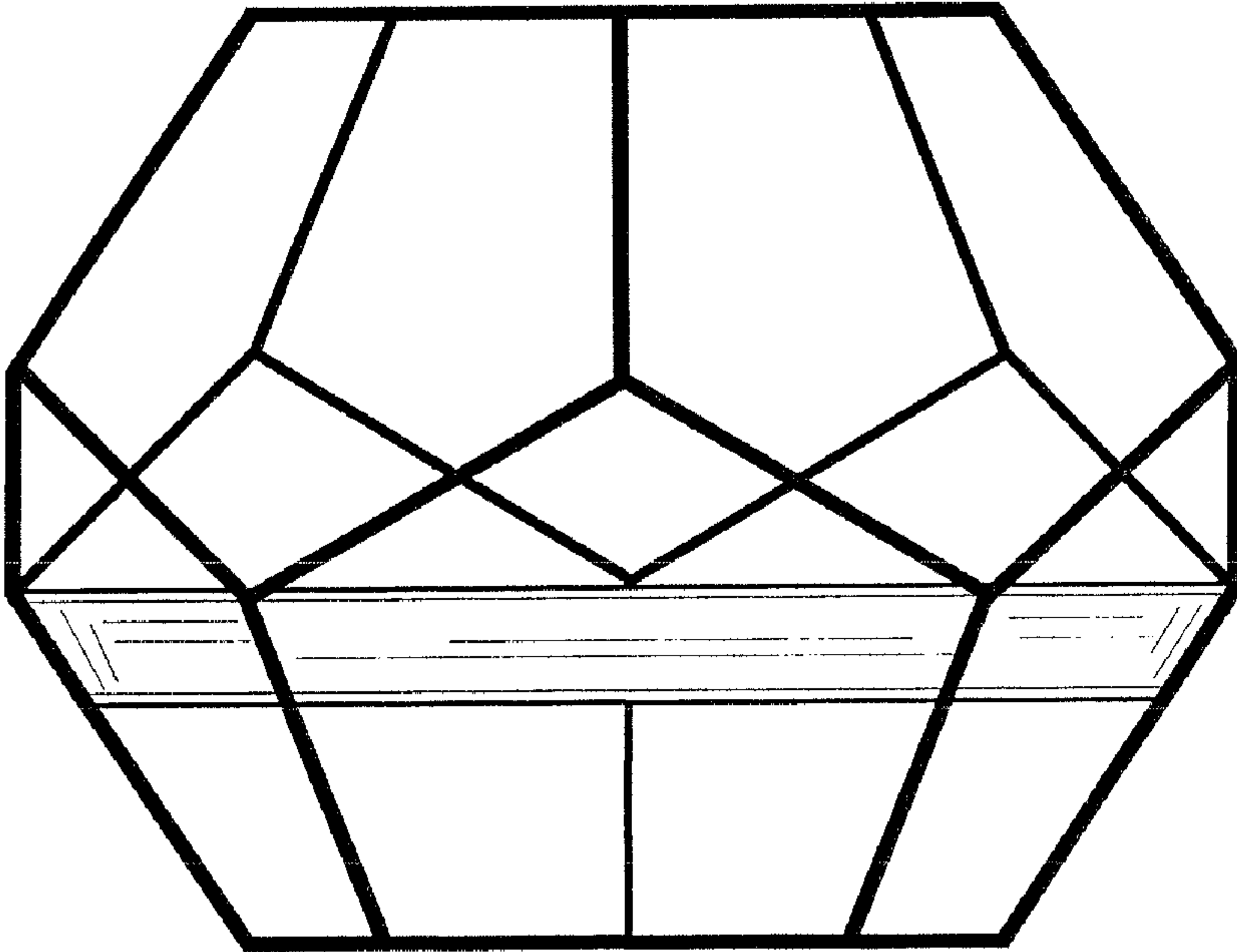

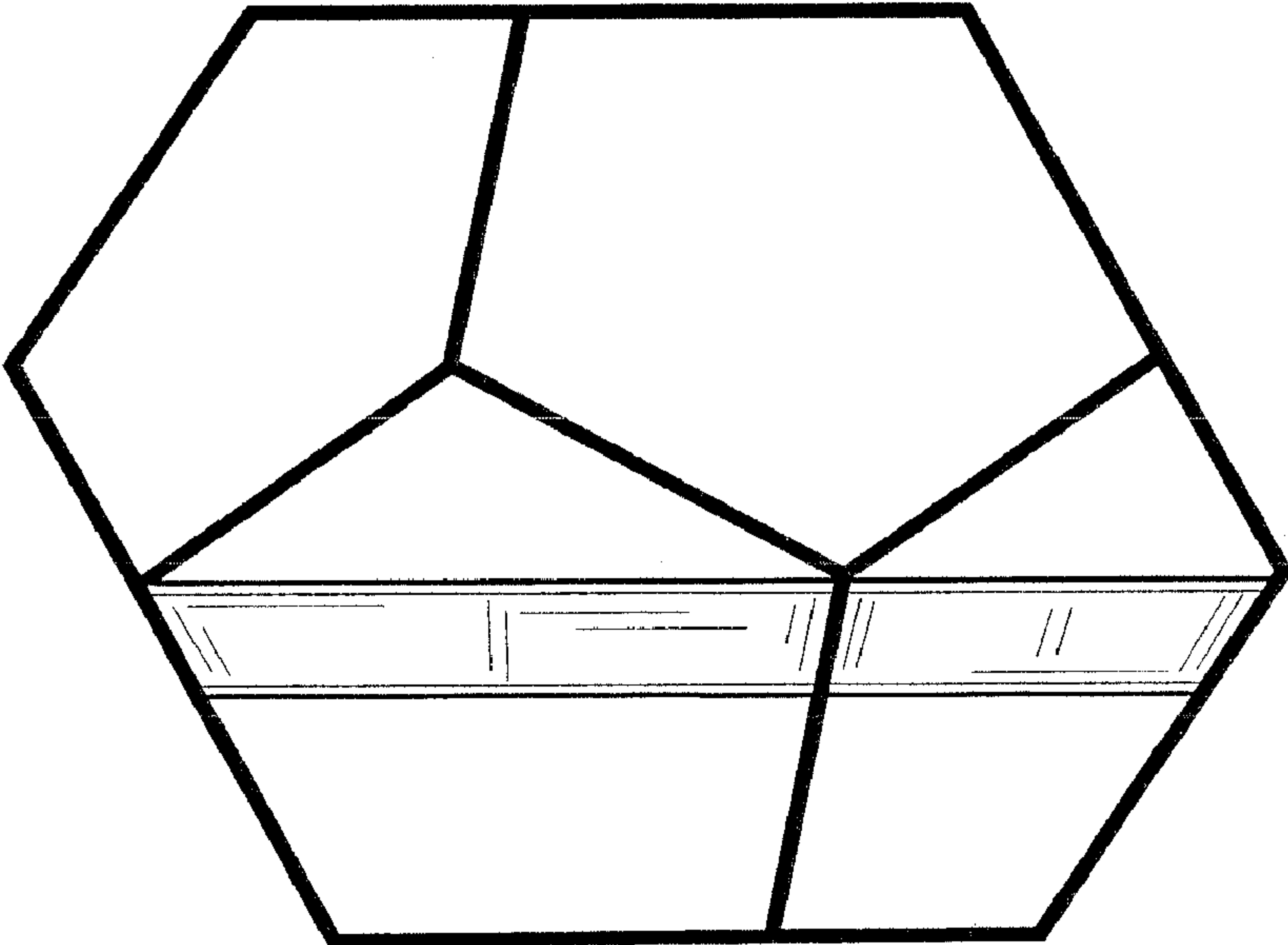

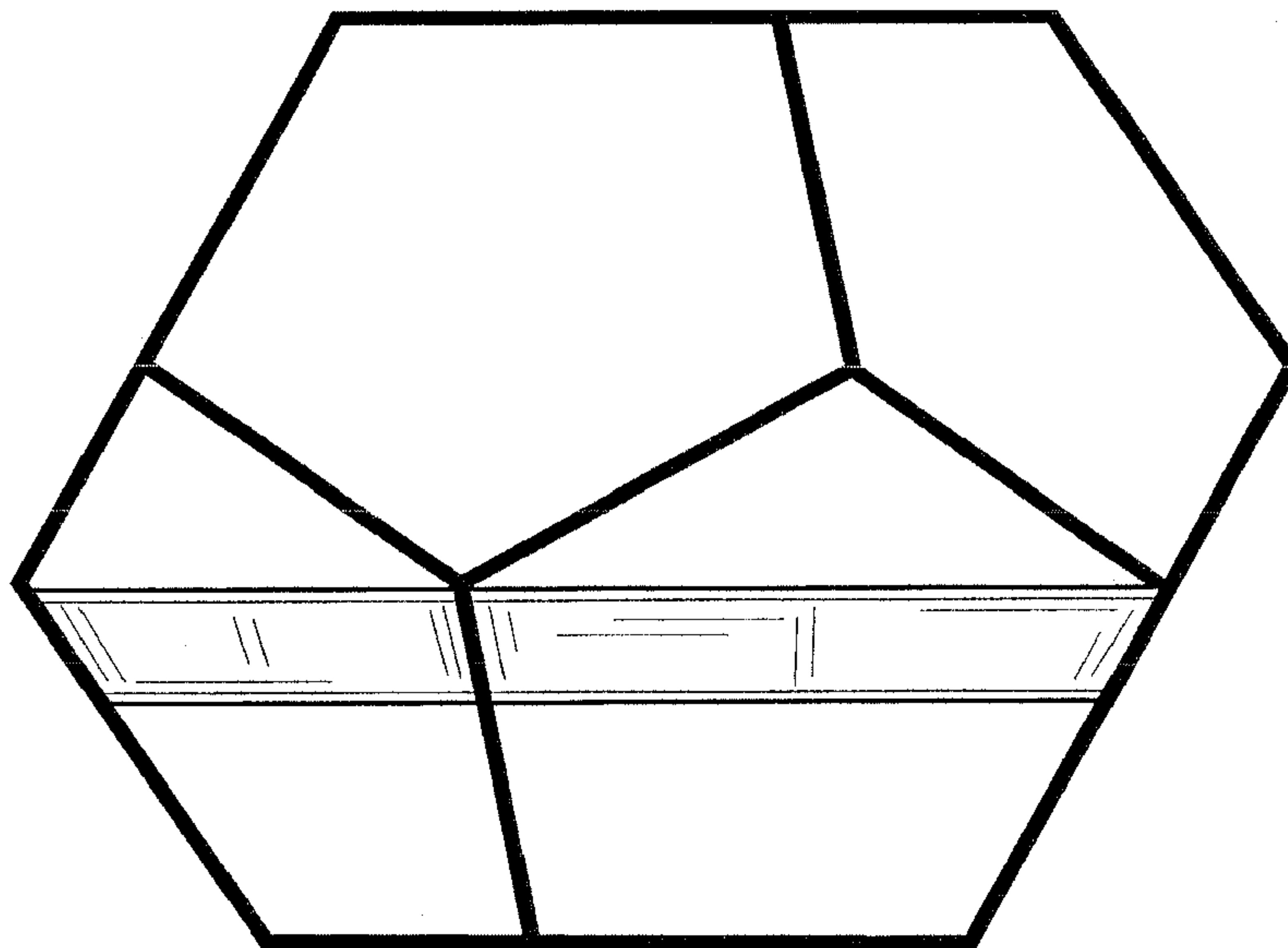

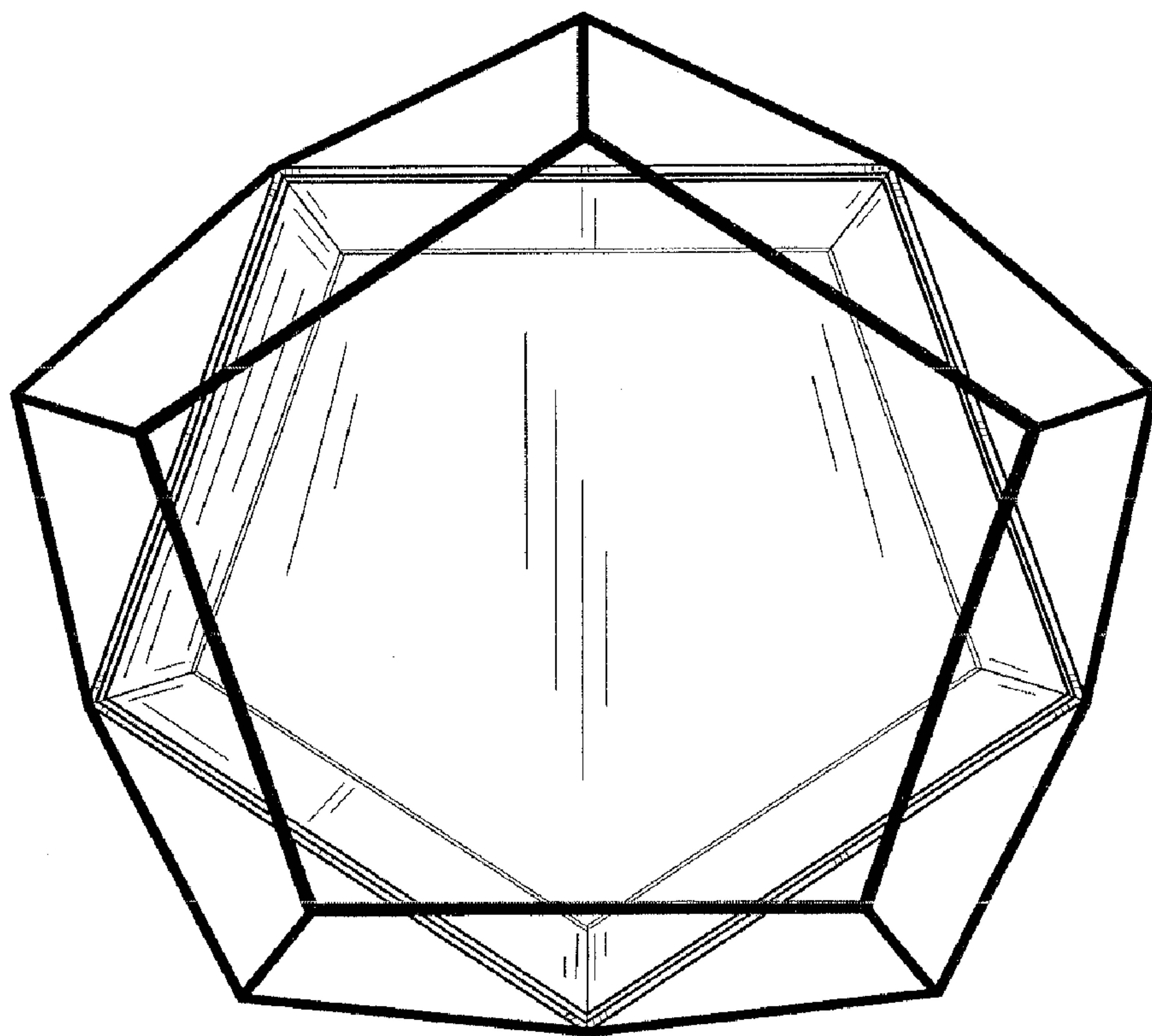

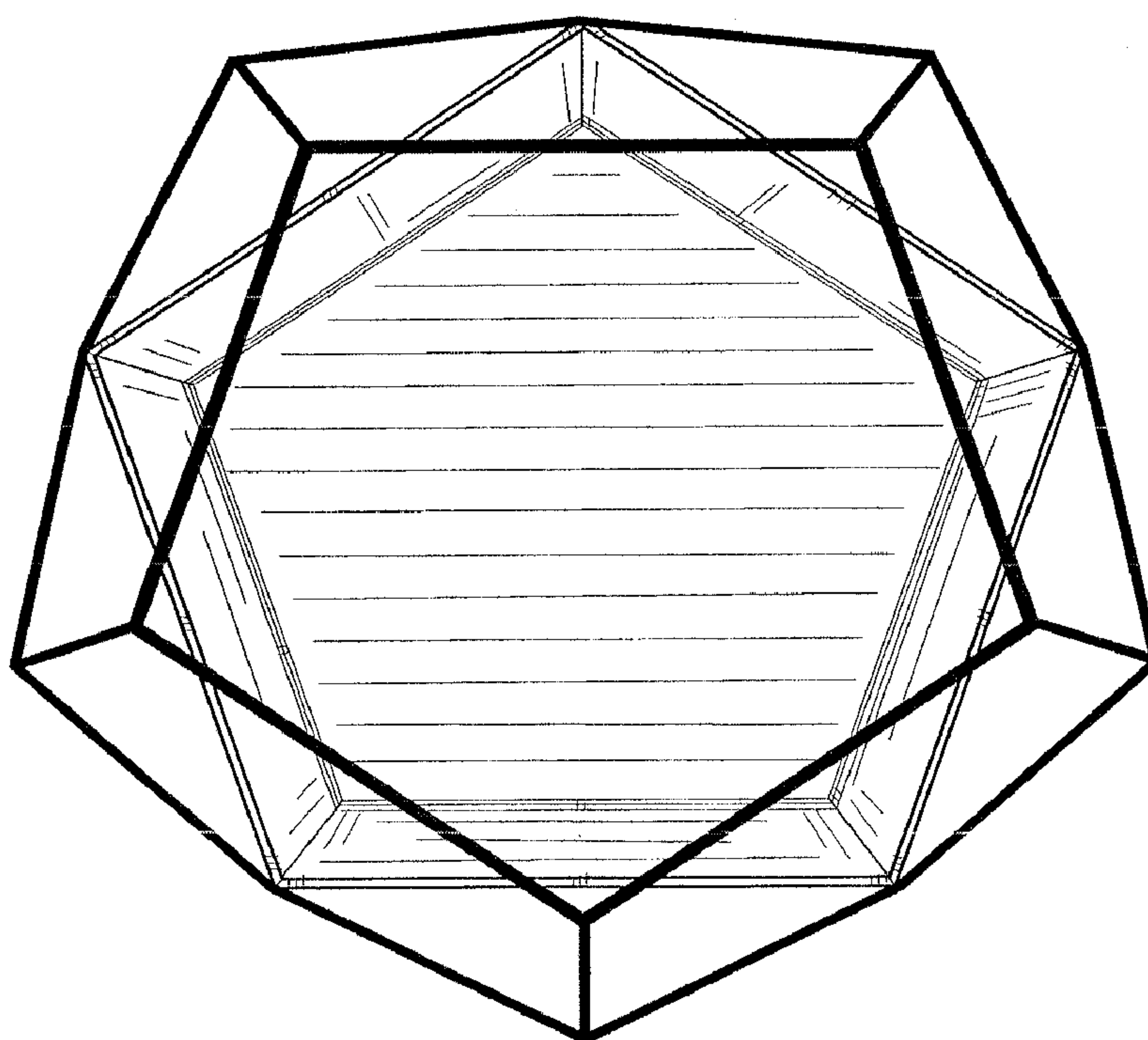
