I claim the ornamental design for a flashlight, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the flashlight;

FIG. 2 is a different perspective view of the flashlight illustrated in FIG. 1;

FIG. 3 is a top view of the flashlight illustrated in FIG. 1;

FIG. 4 is a bottom view of the flashlight illustrated in FIG. 1;

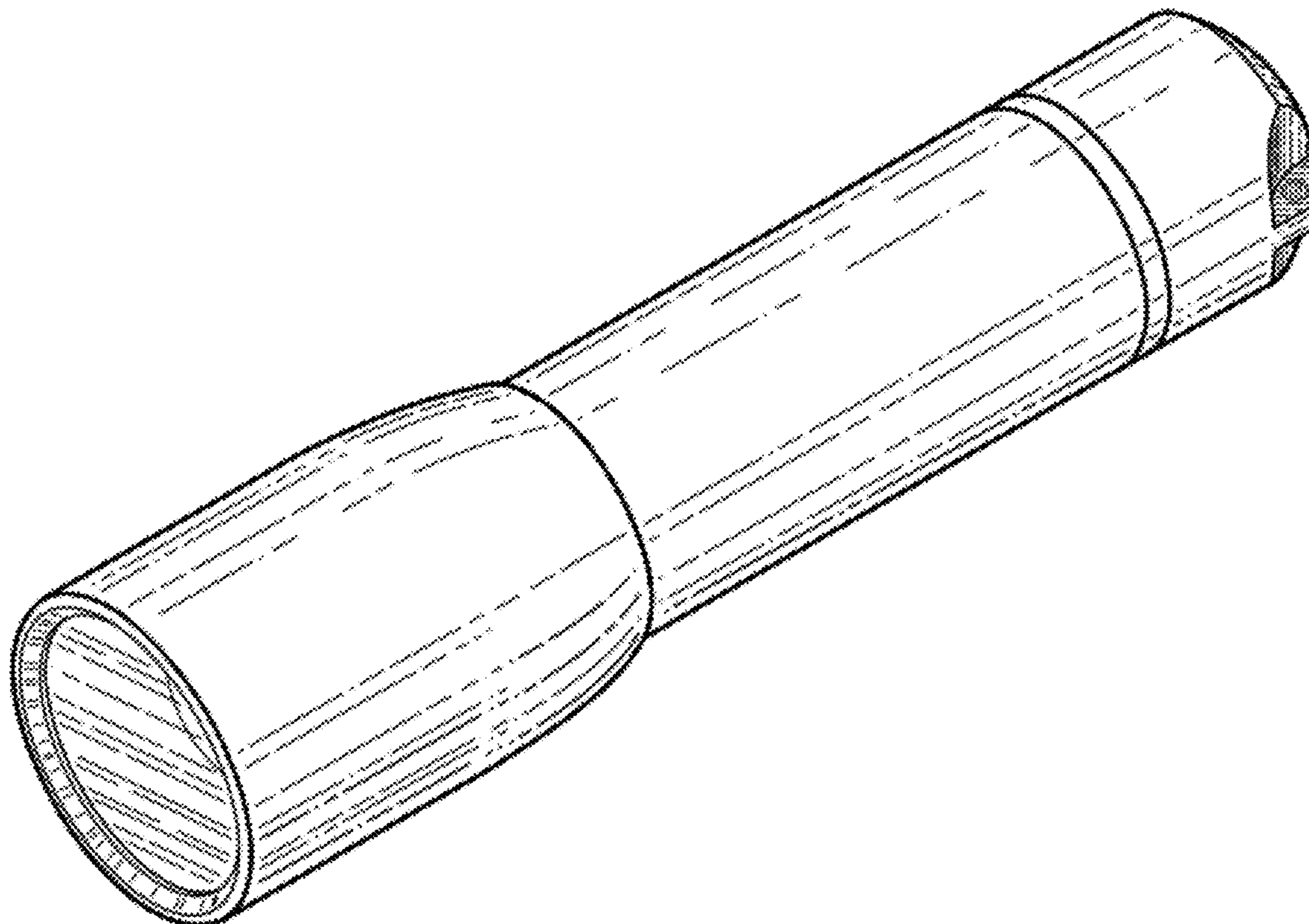
FIG. 5 is a right side view of the flashlight illustrated in FIG. 1,

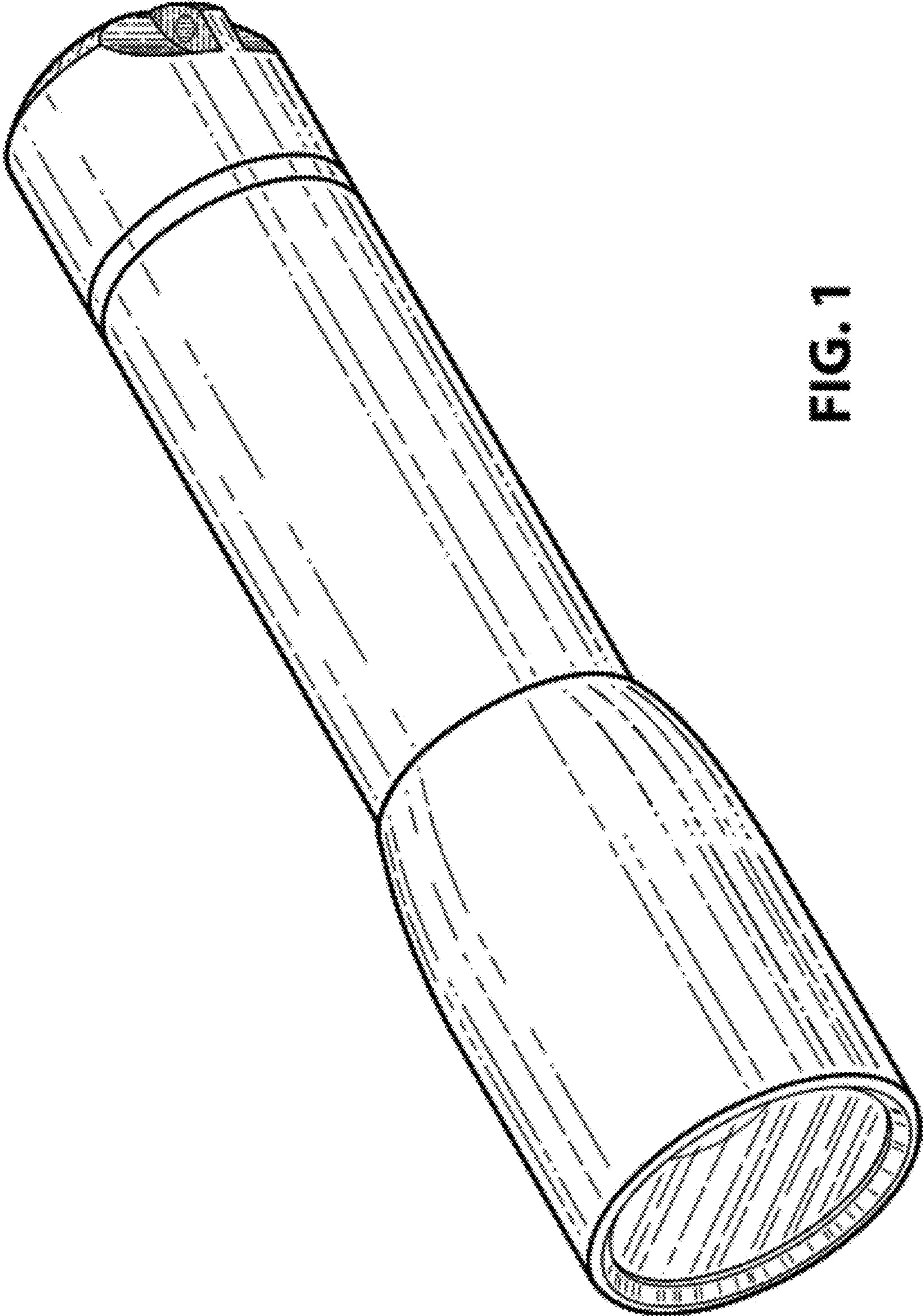

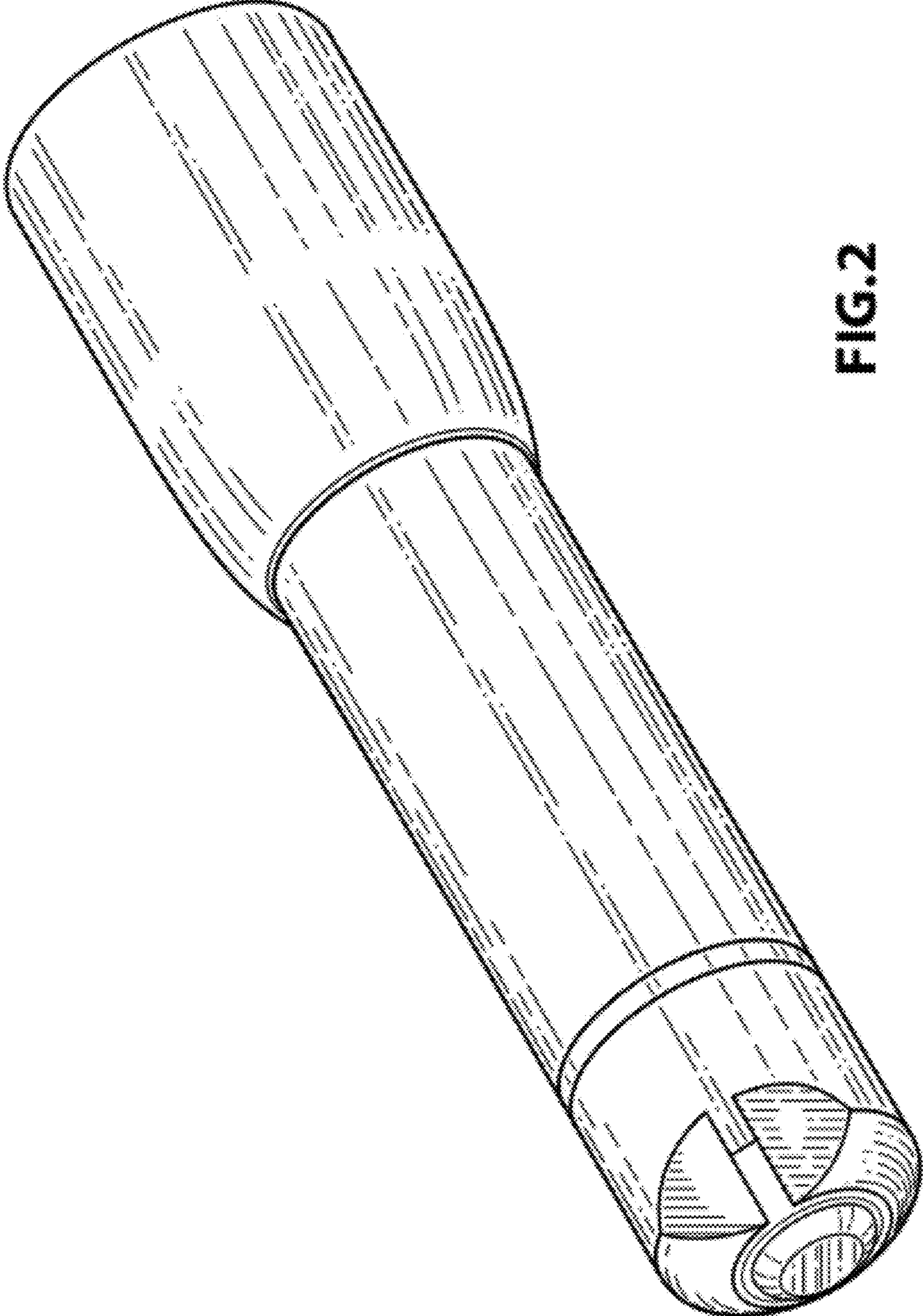

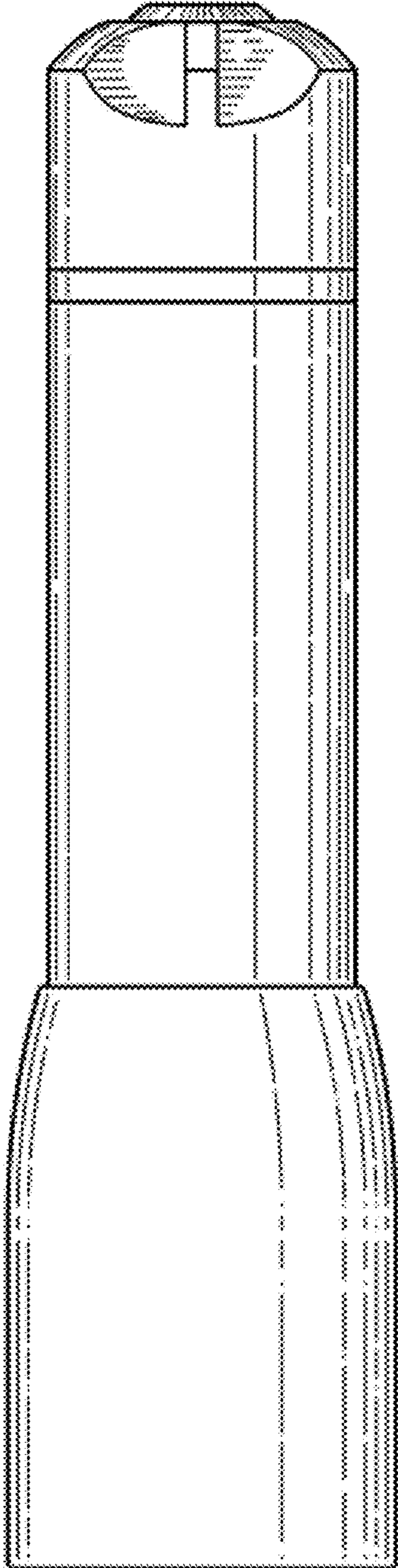

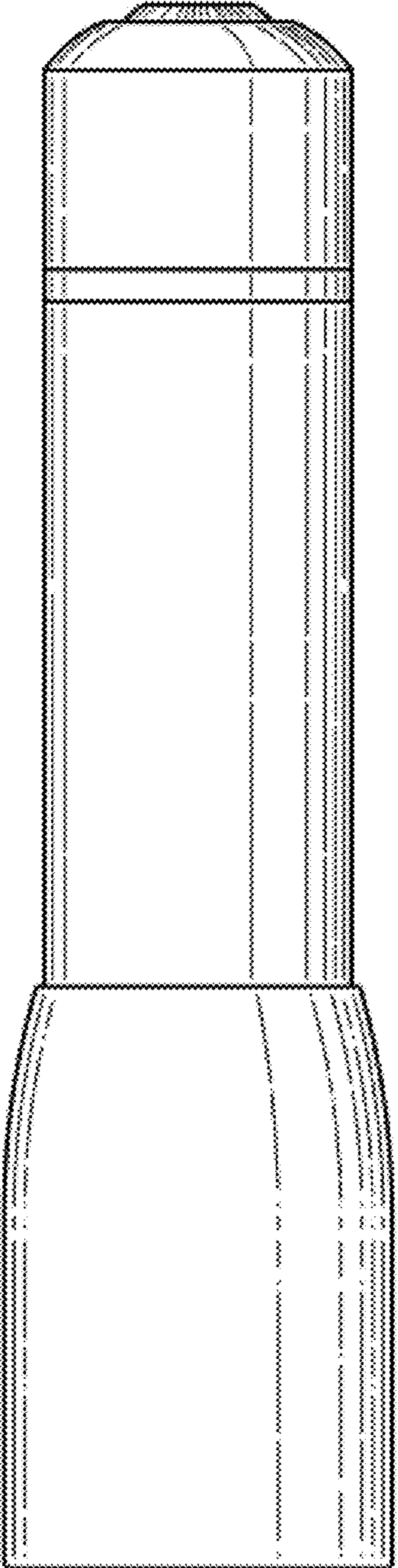

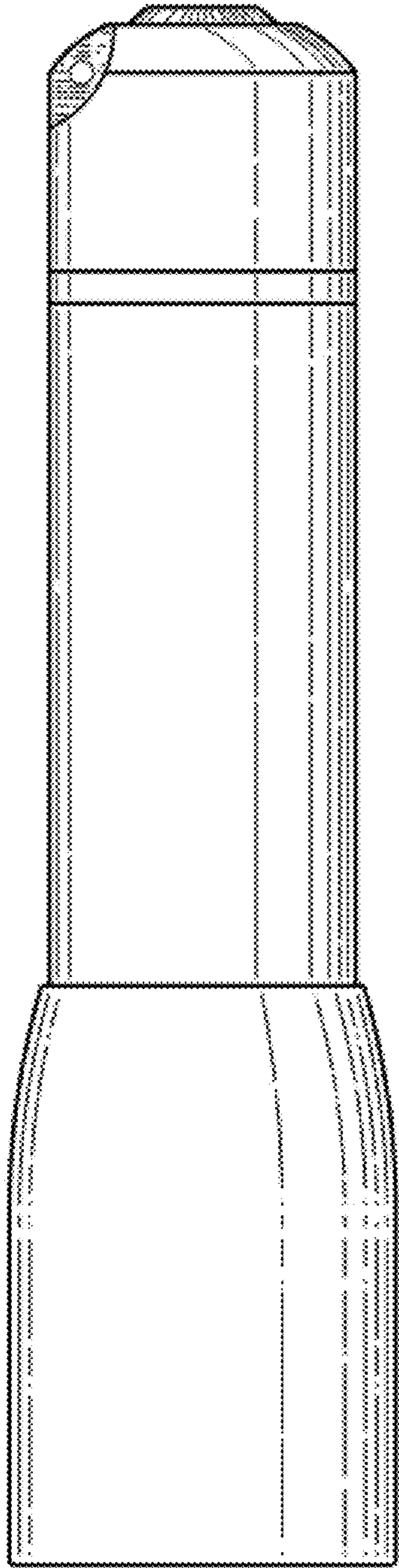

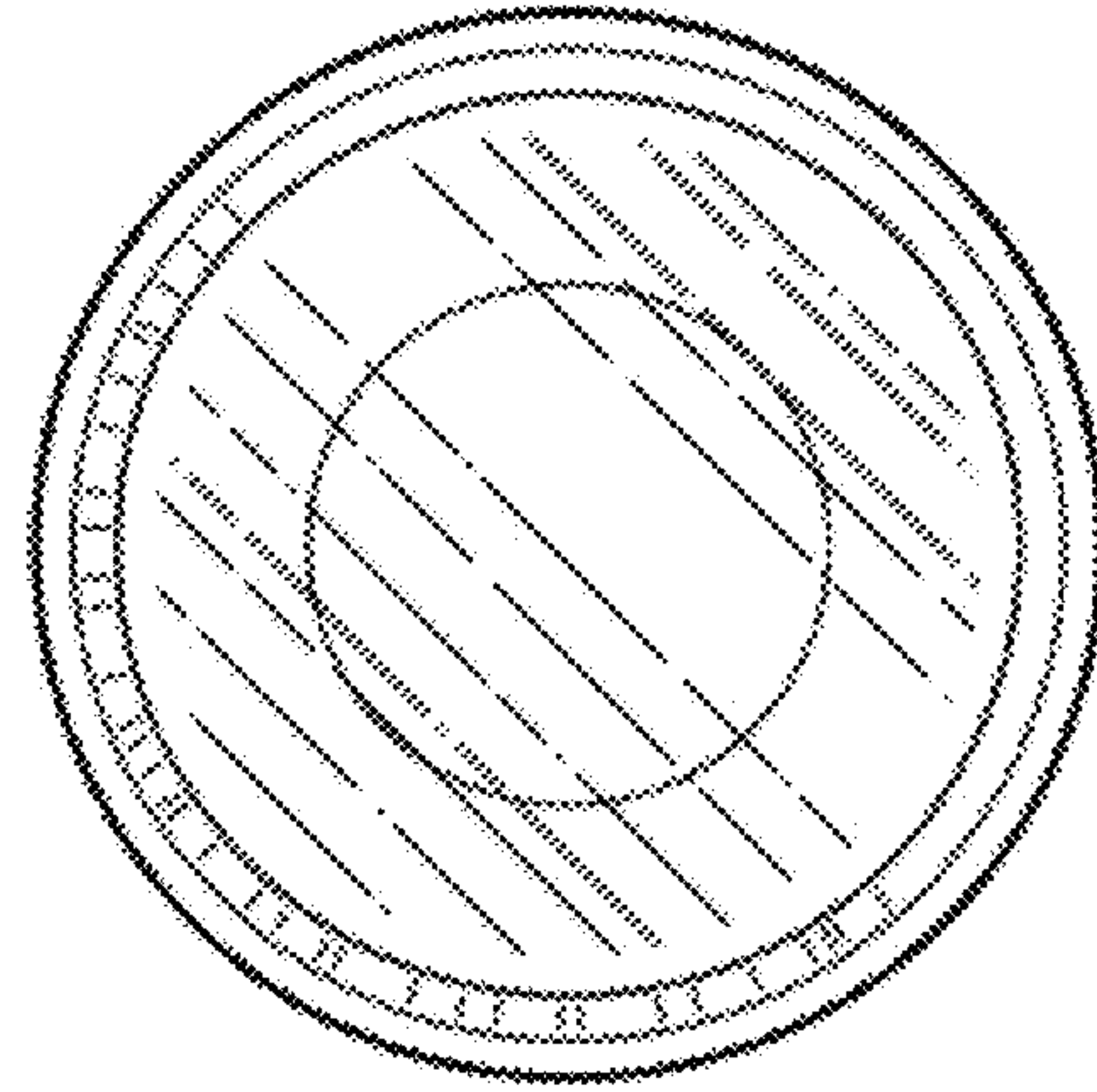

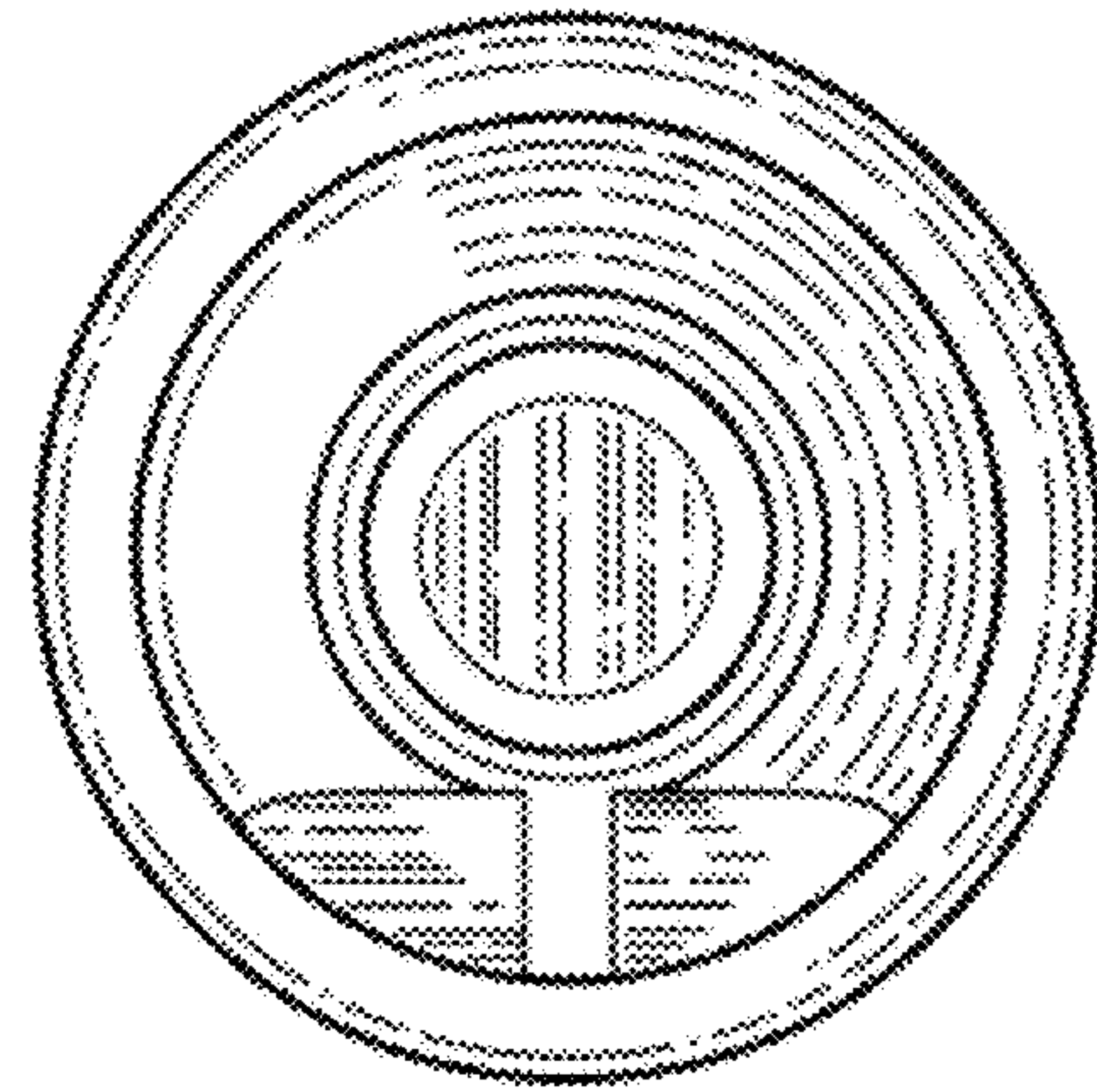
