(57) **CLAIM**

The ornamental design for the toboggan style hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of my design for a toboggan style hat.

FIG. 2 is a left side view thereof.

FIG. 3 is a right side view thereof.

FIG. 4 is a front view thereof.

FIG. 5 is a rear elevation view thereof.

FIG. 6 is a top perspective view thereof; and,

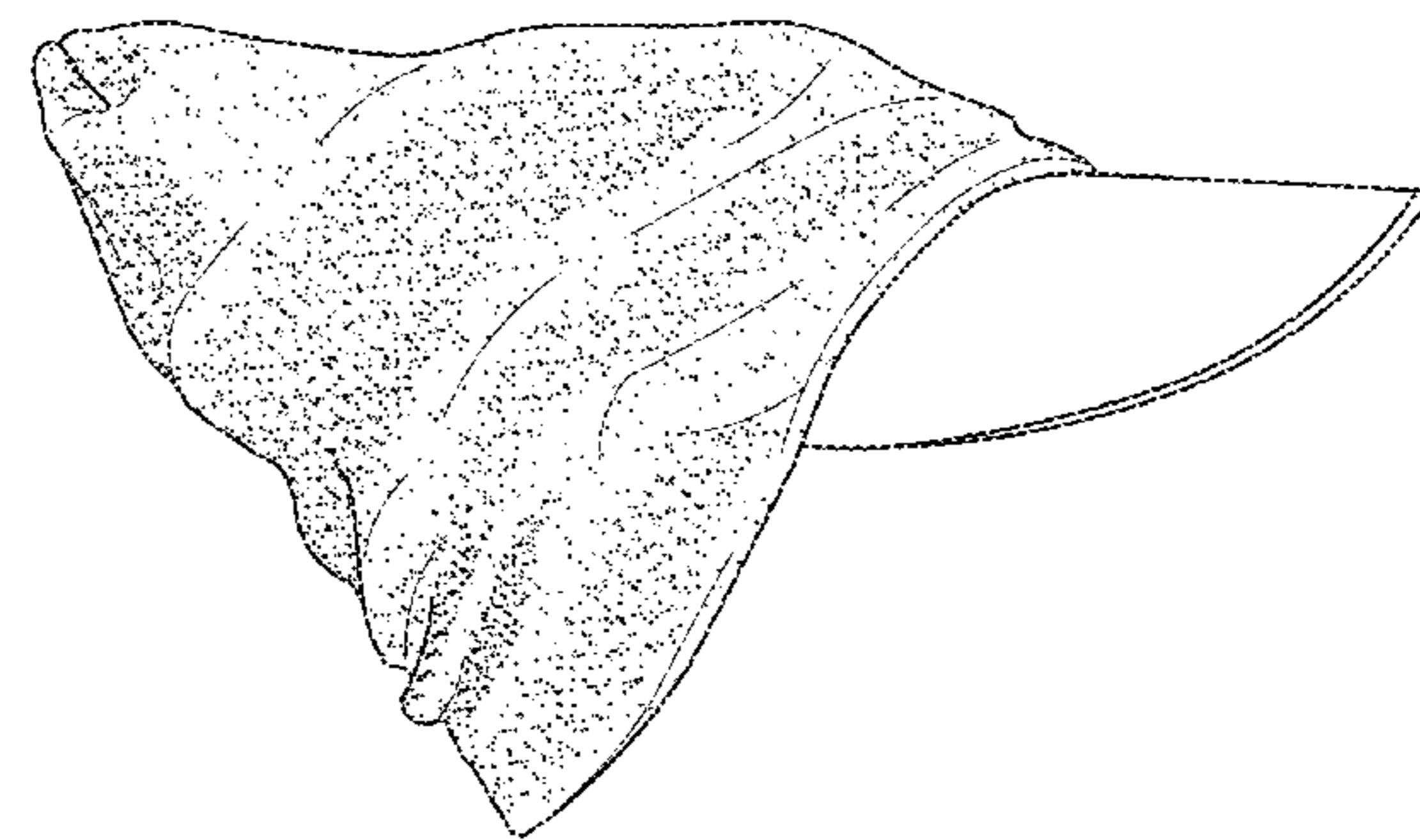
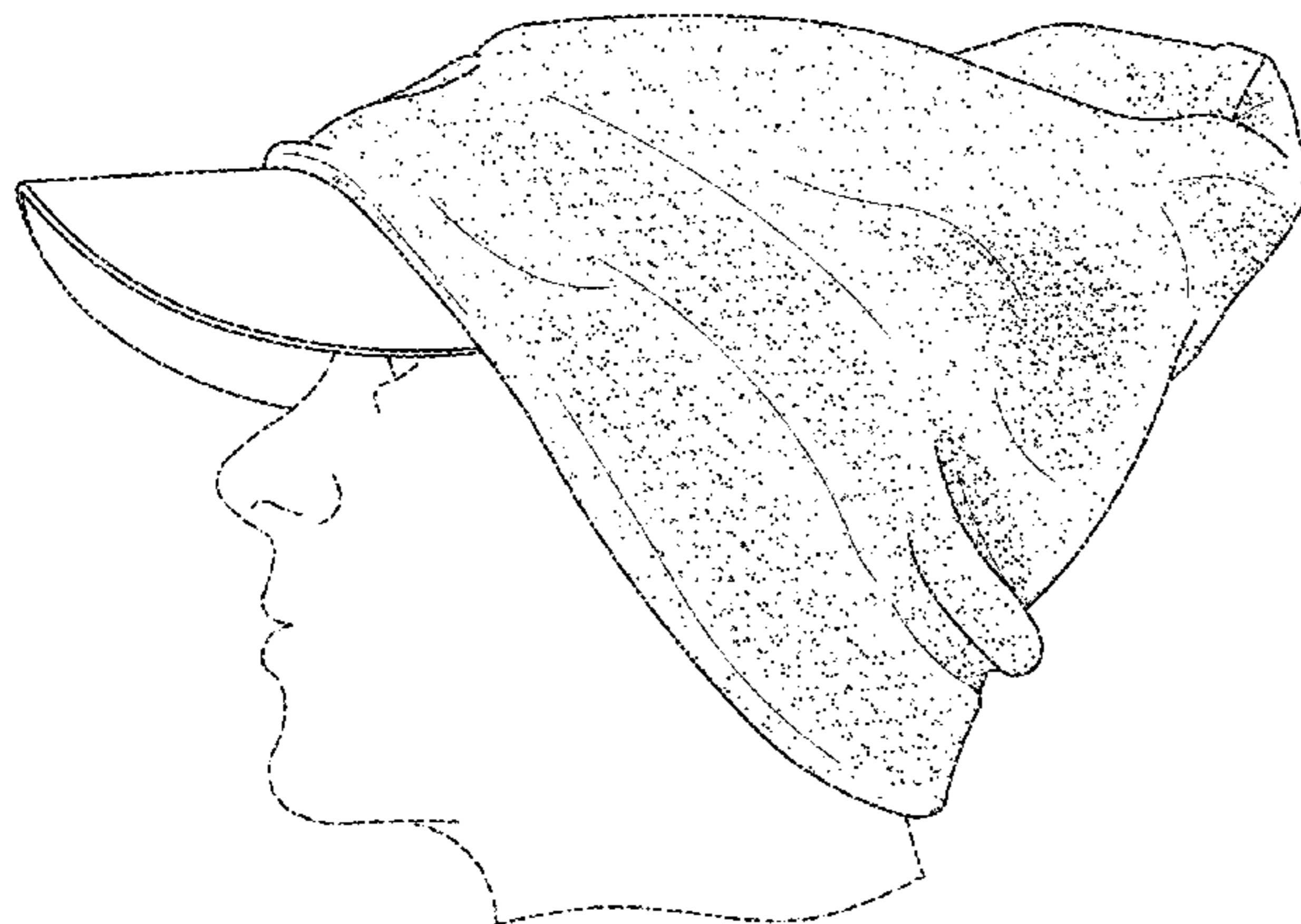
FIG. 7 is a bottom perspective view thereof.

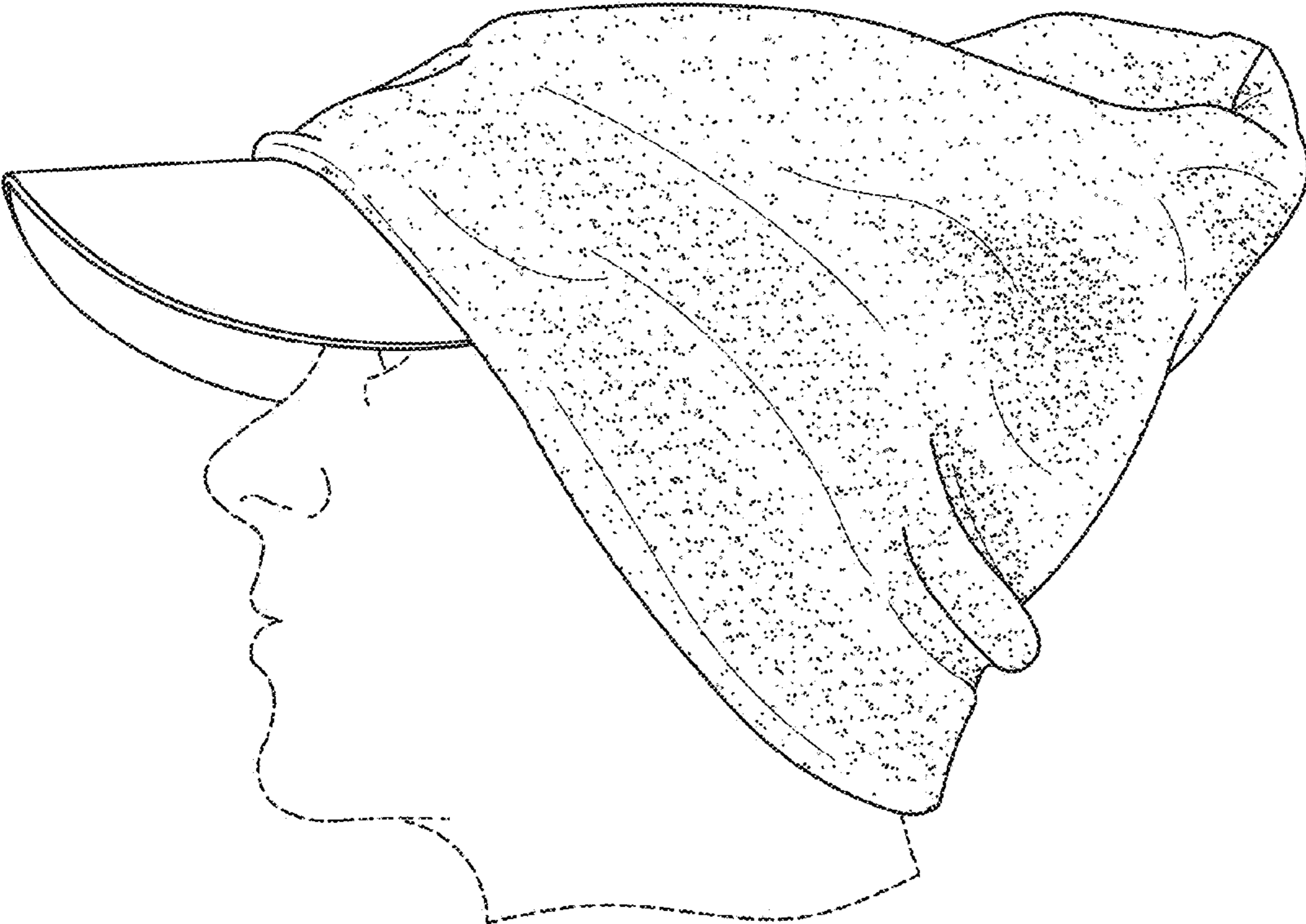

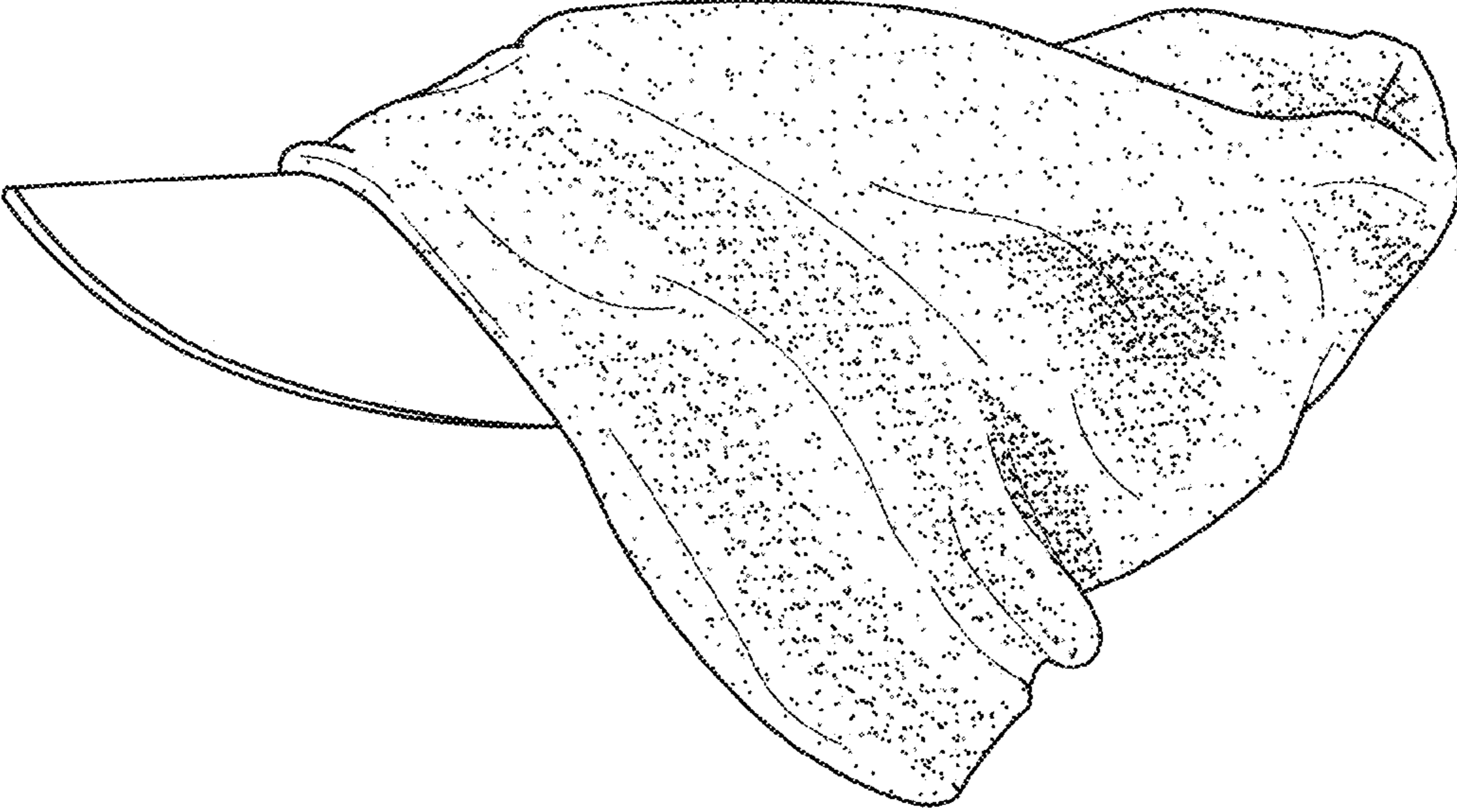

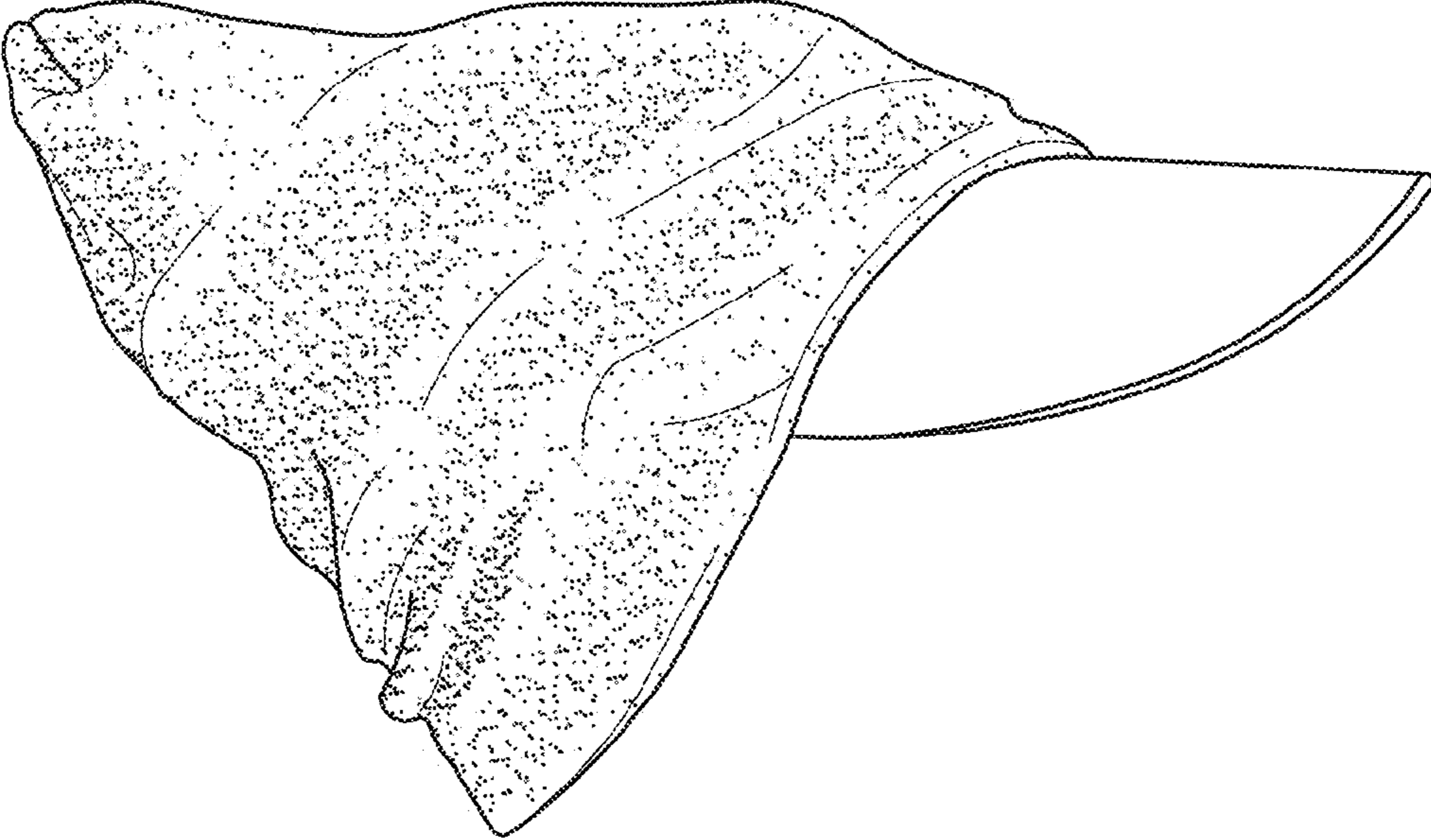

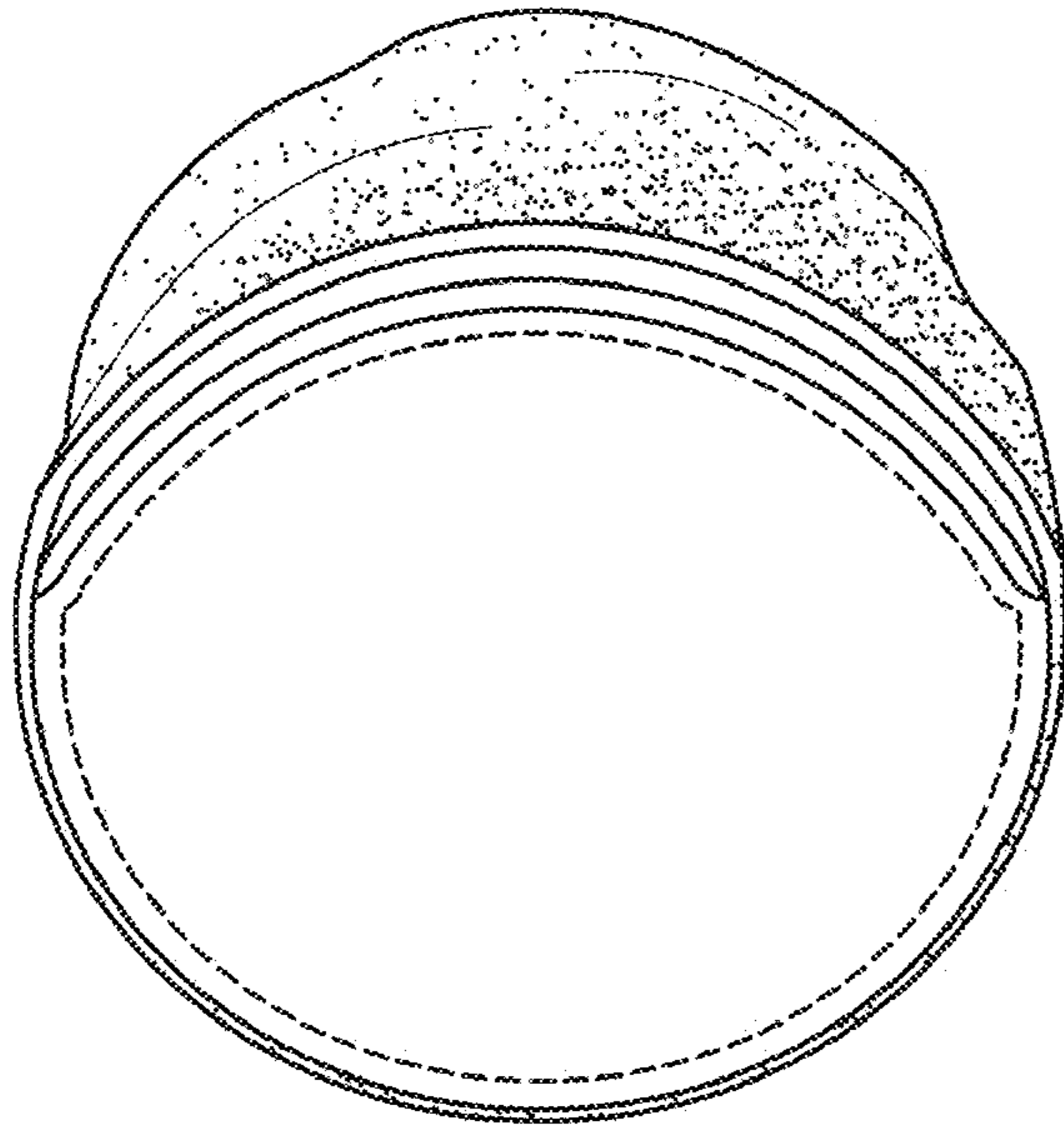

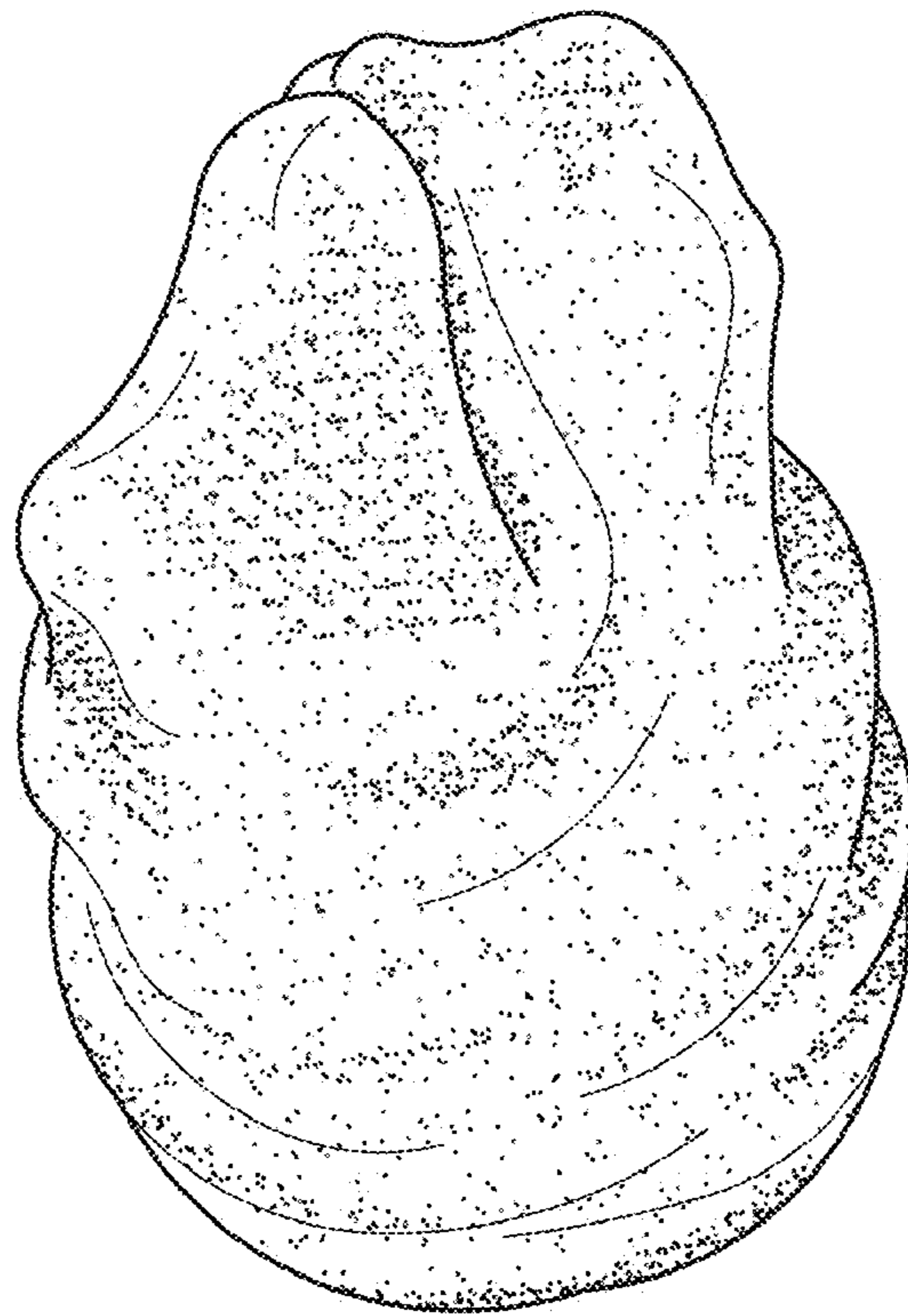

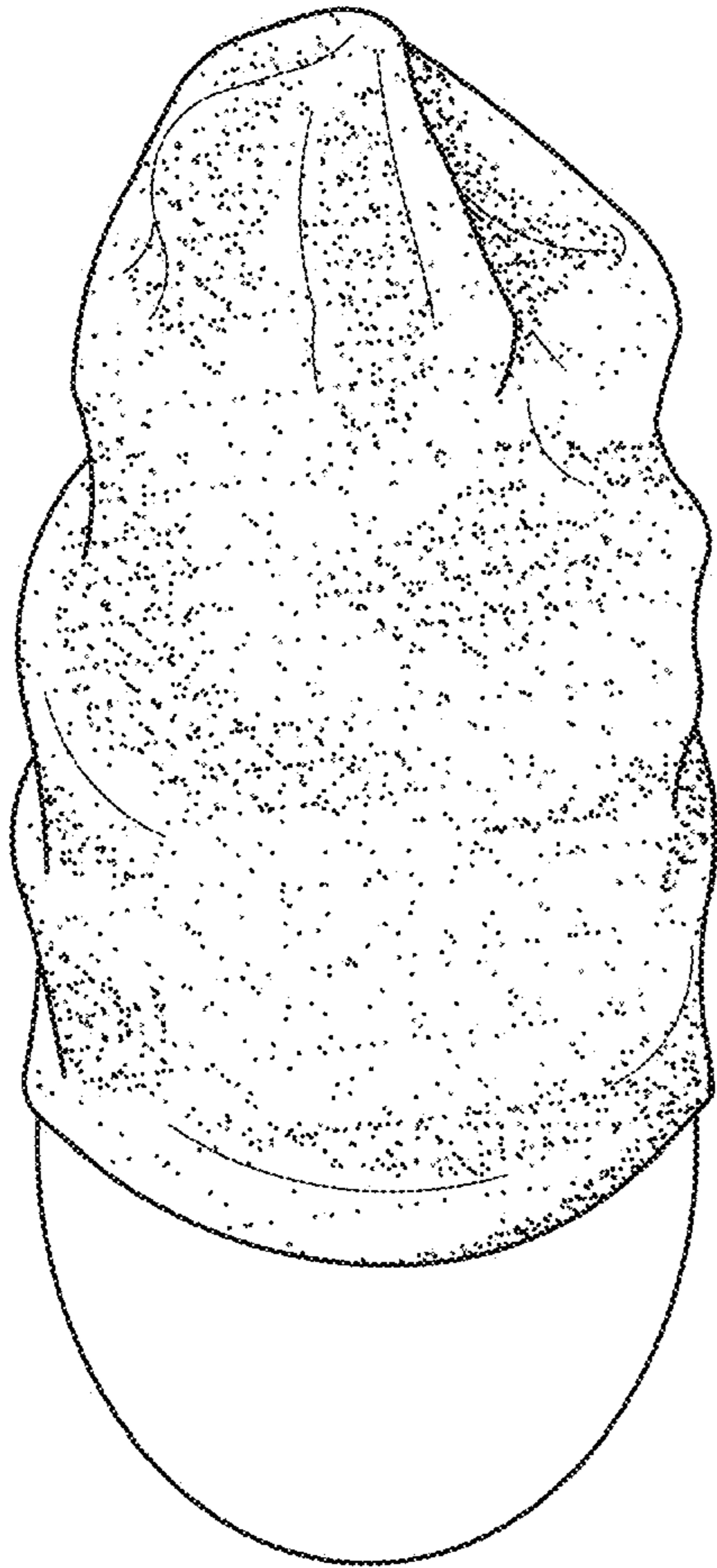

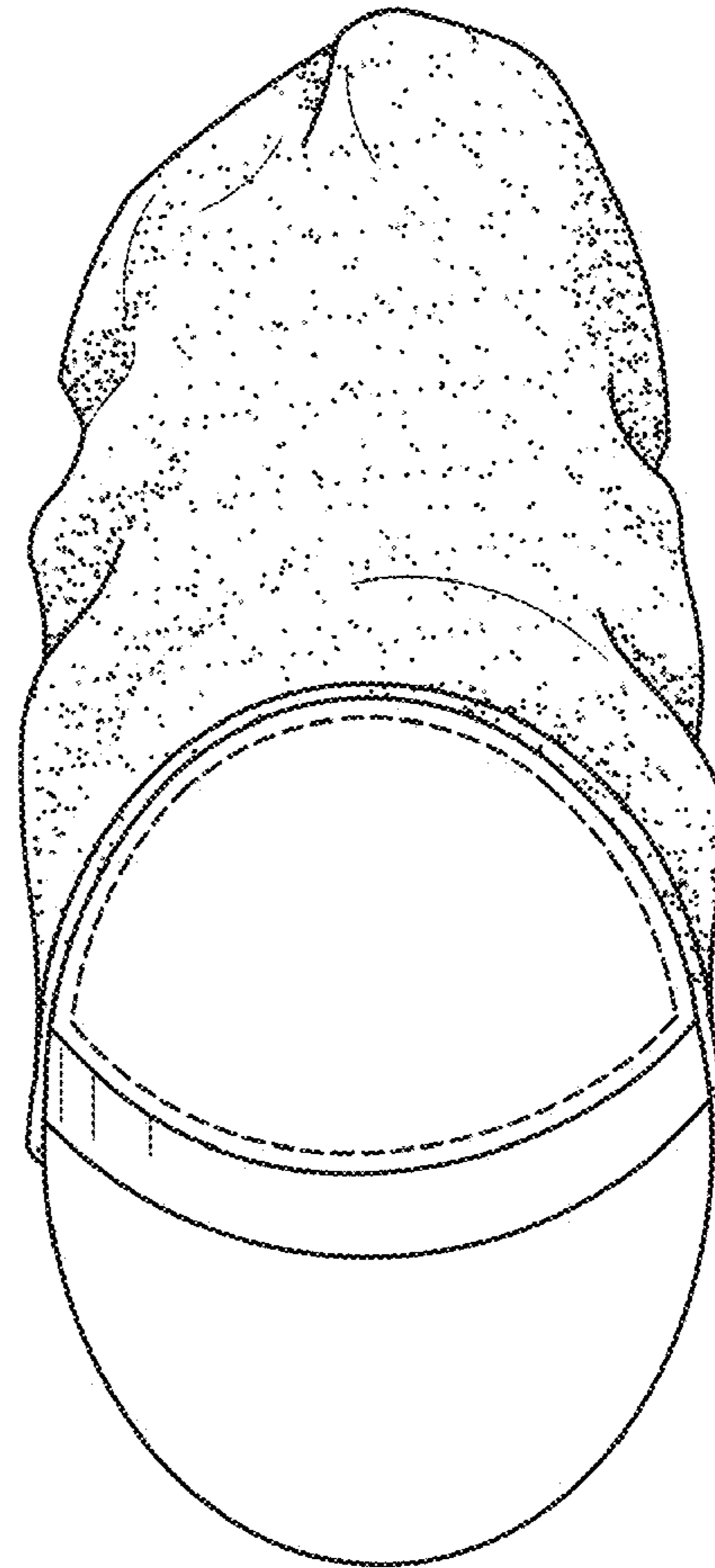
