FIG. 1 is a front perspective view of a shoe outsole showing my/our new design;

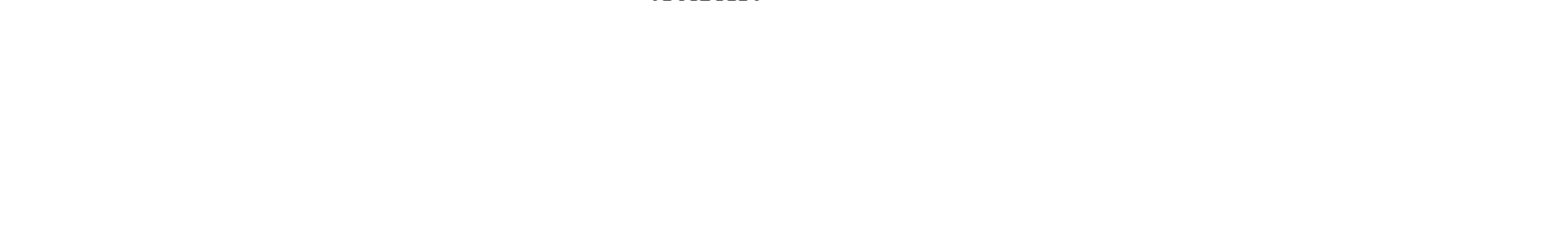
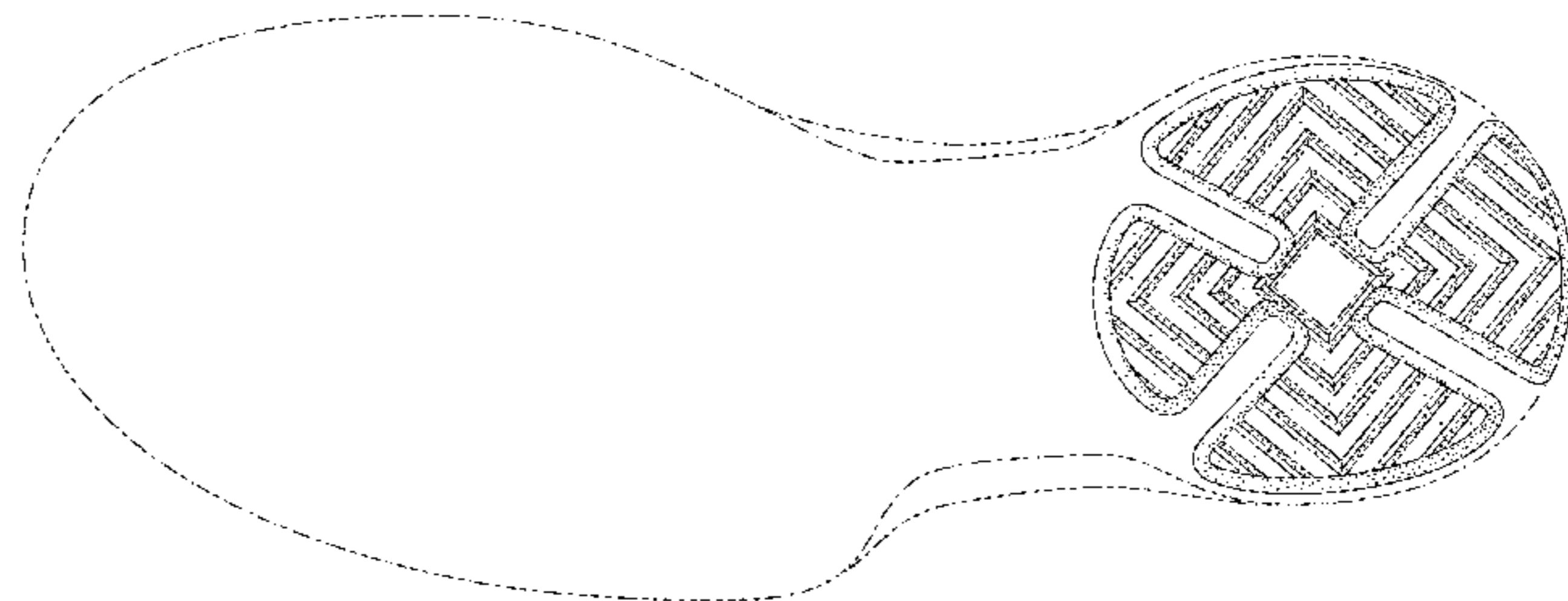
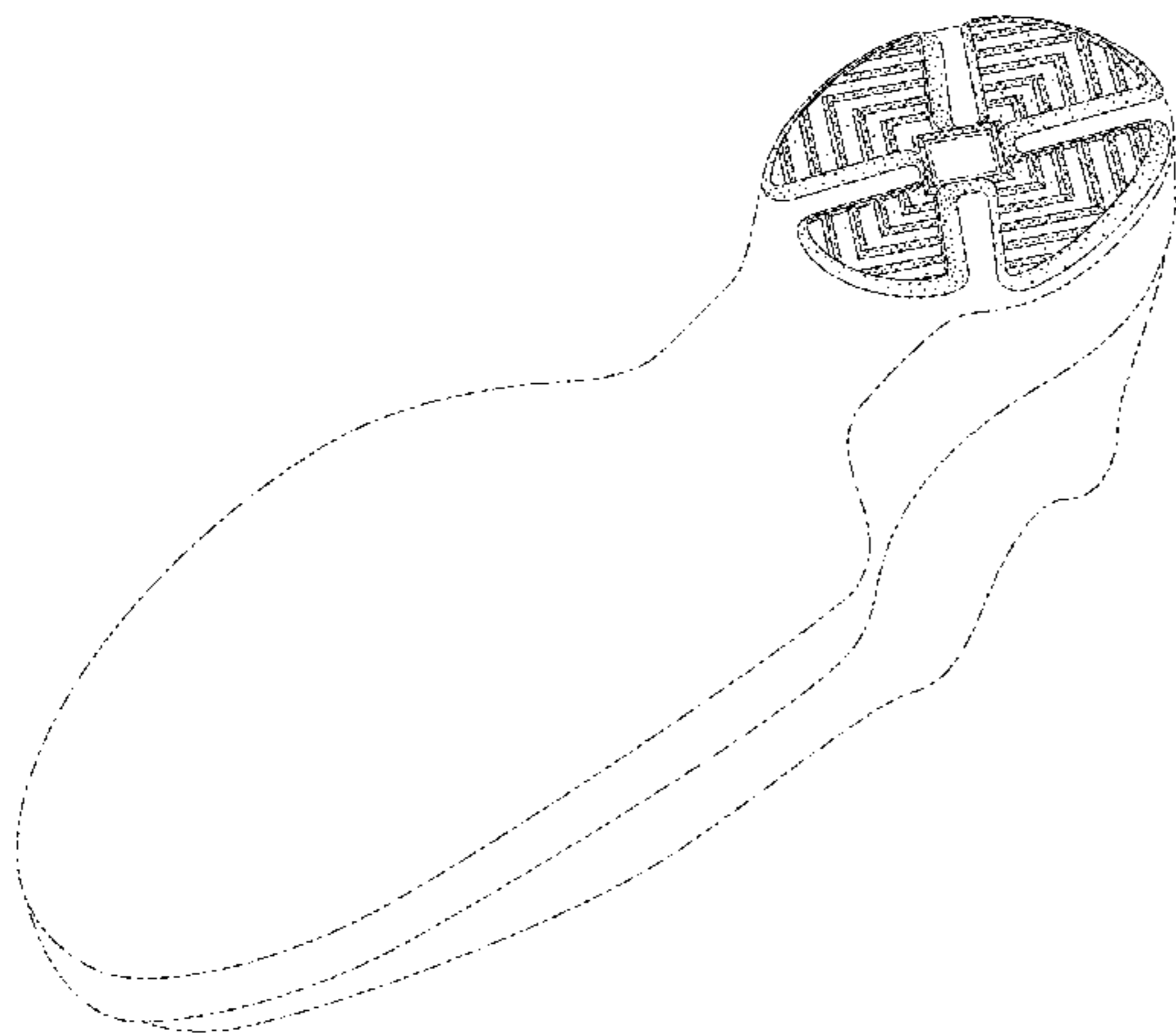
FIG. 2 is a plan view thereof; and,

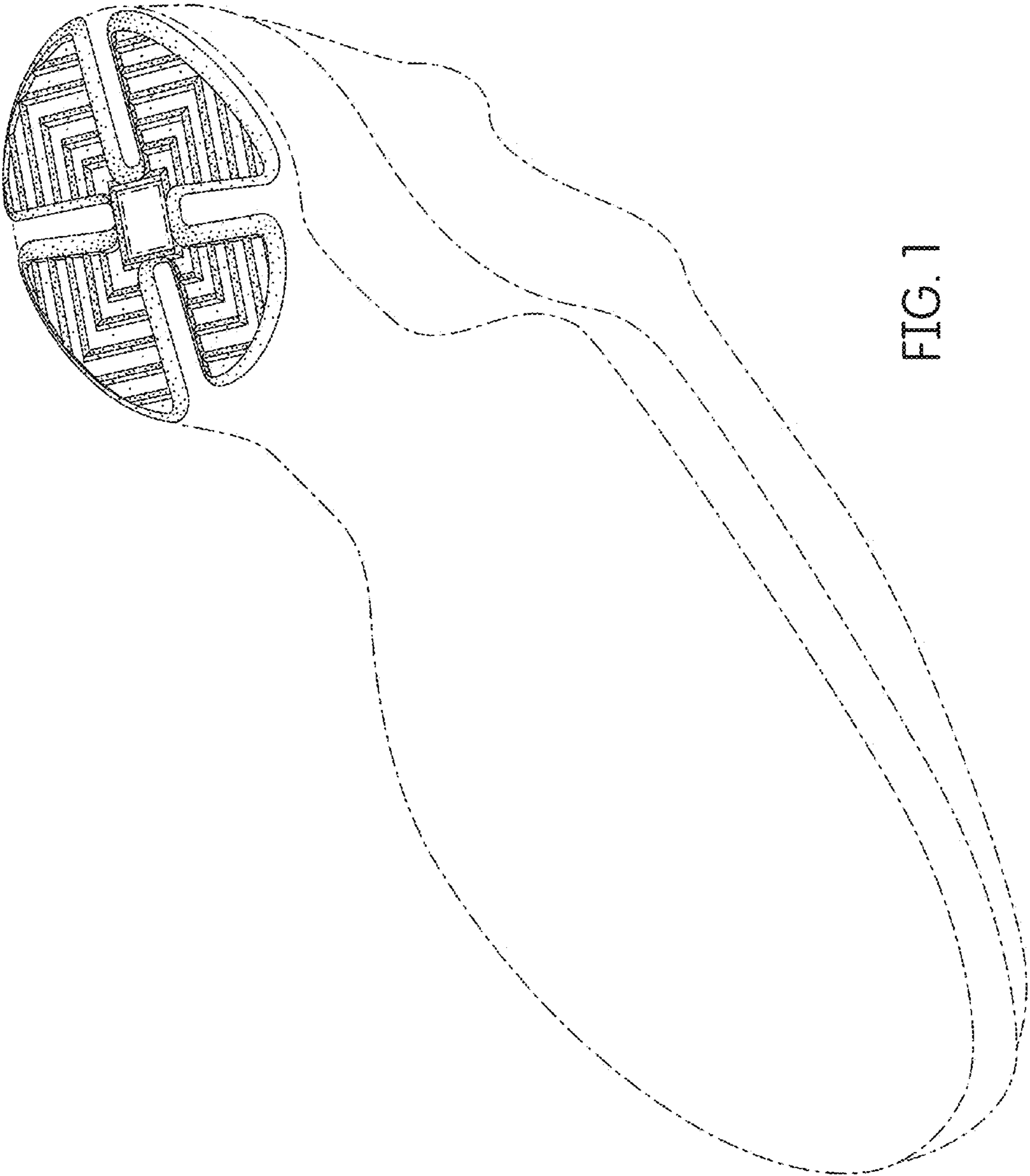

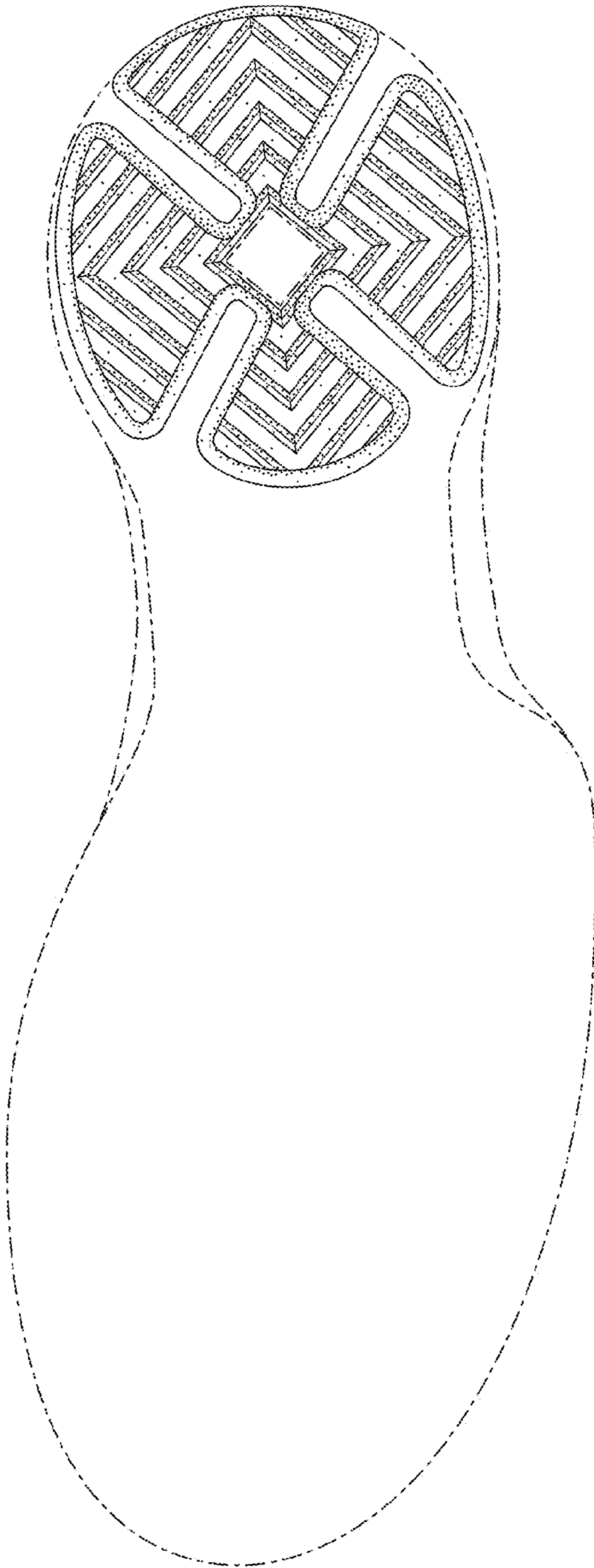

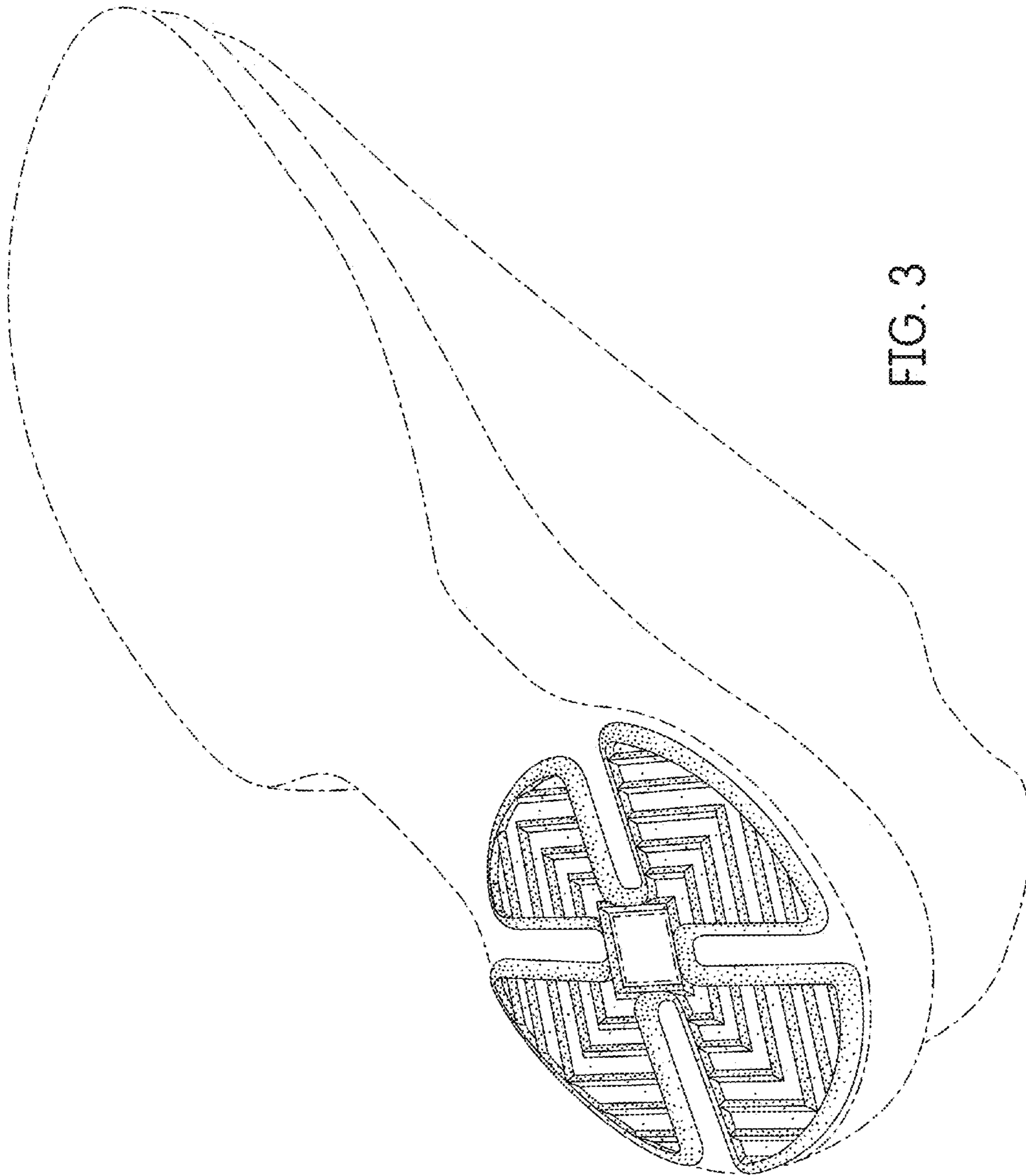
