(57) **CLAIM**

The ornamental design for an enclosure for a gun cleaning kit, as shown and described.

DESCRIPTION

FIG. 1 is a frontal isometric view of the preferred embodiment of my new enclosure for a gun cleaning kit; FIG. 2 is a rear isometric view thereof; FIG. 3 is a front plan view thereof; FIG. 4 is a rear plan view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

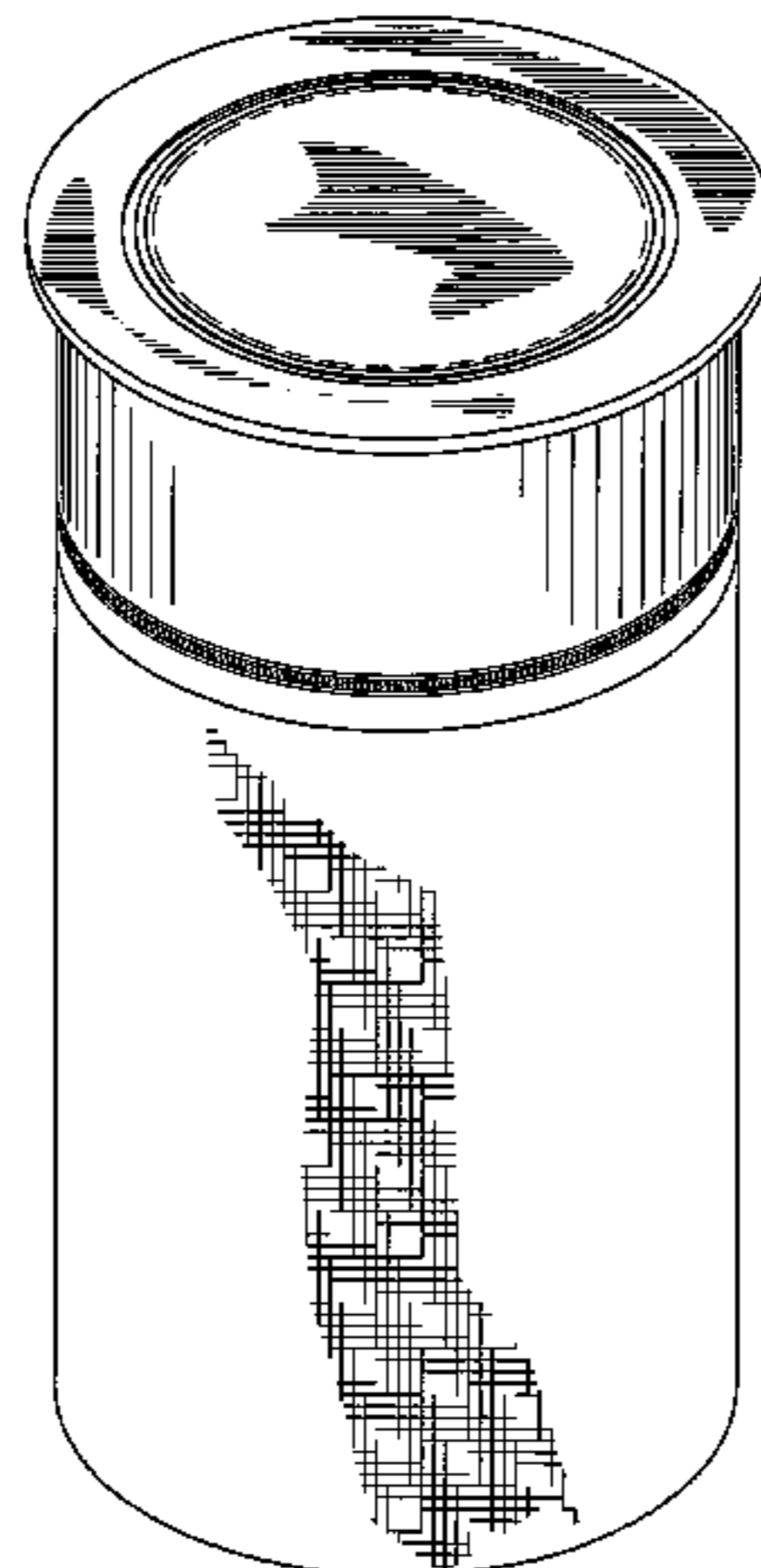

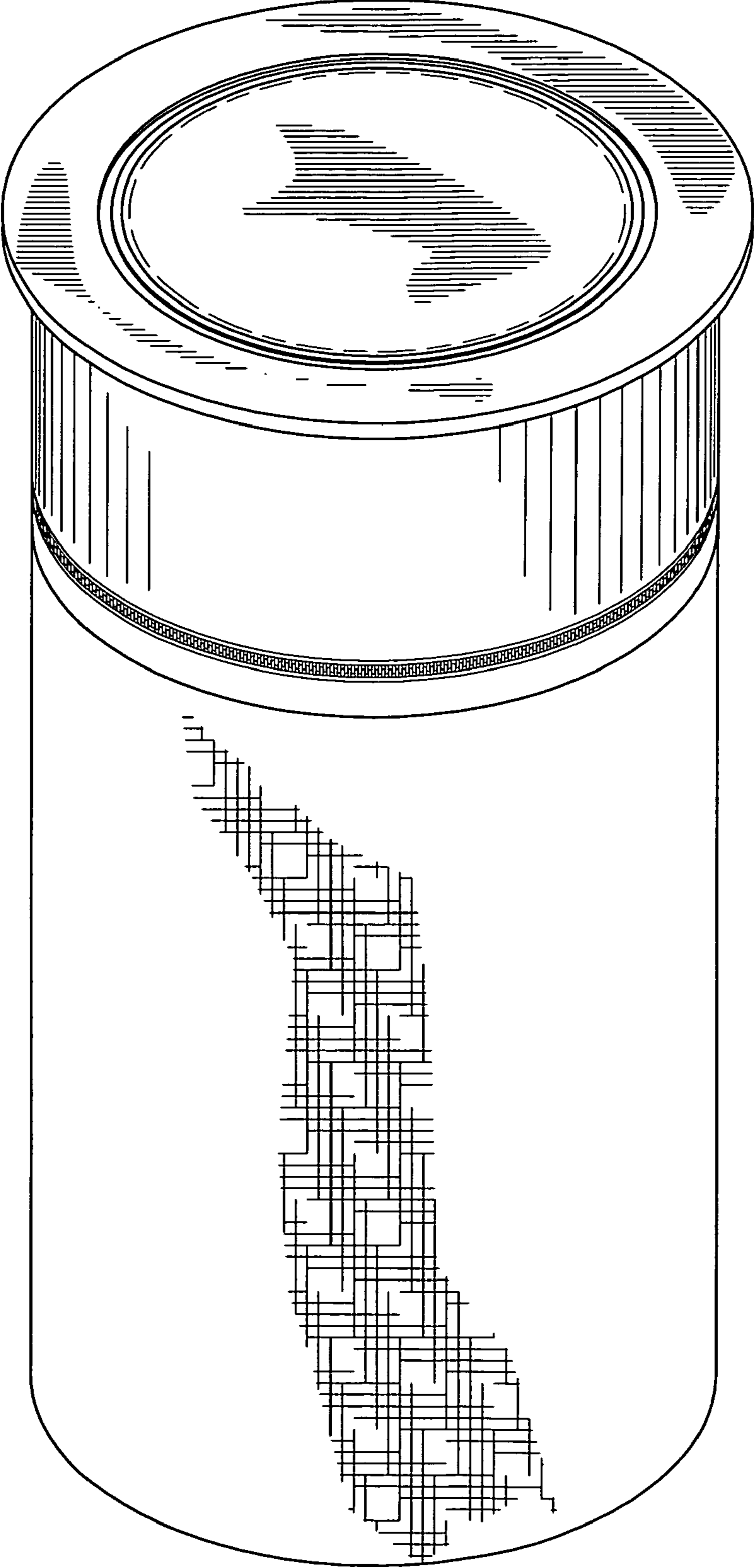

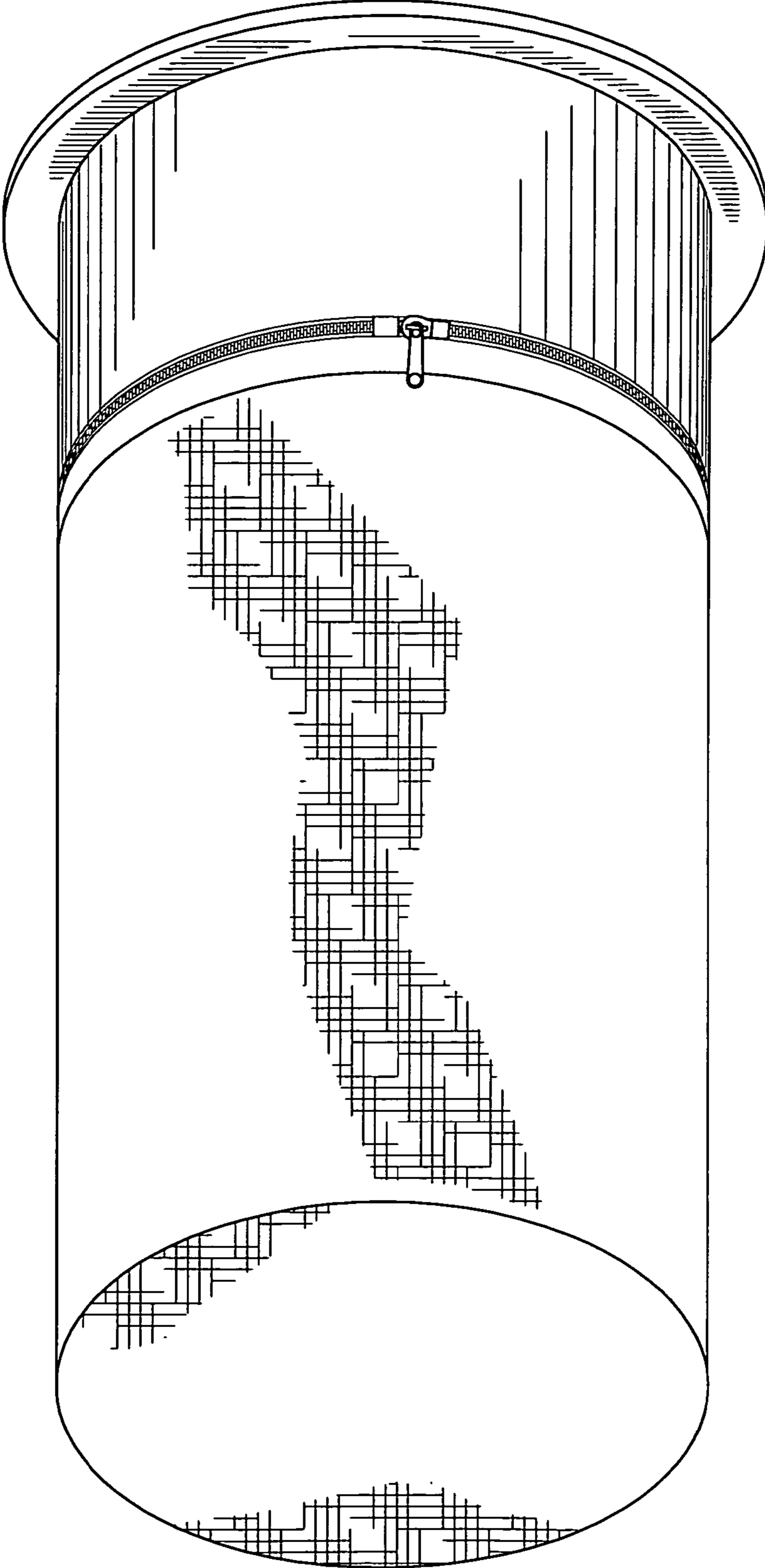

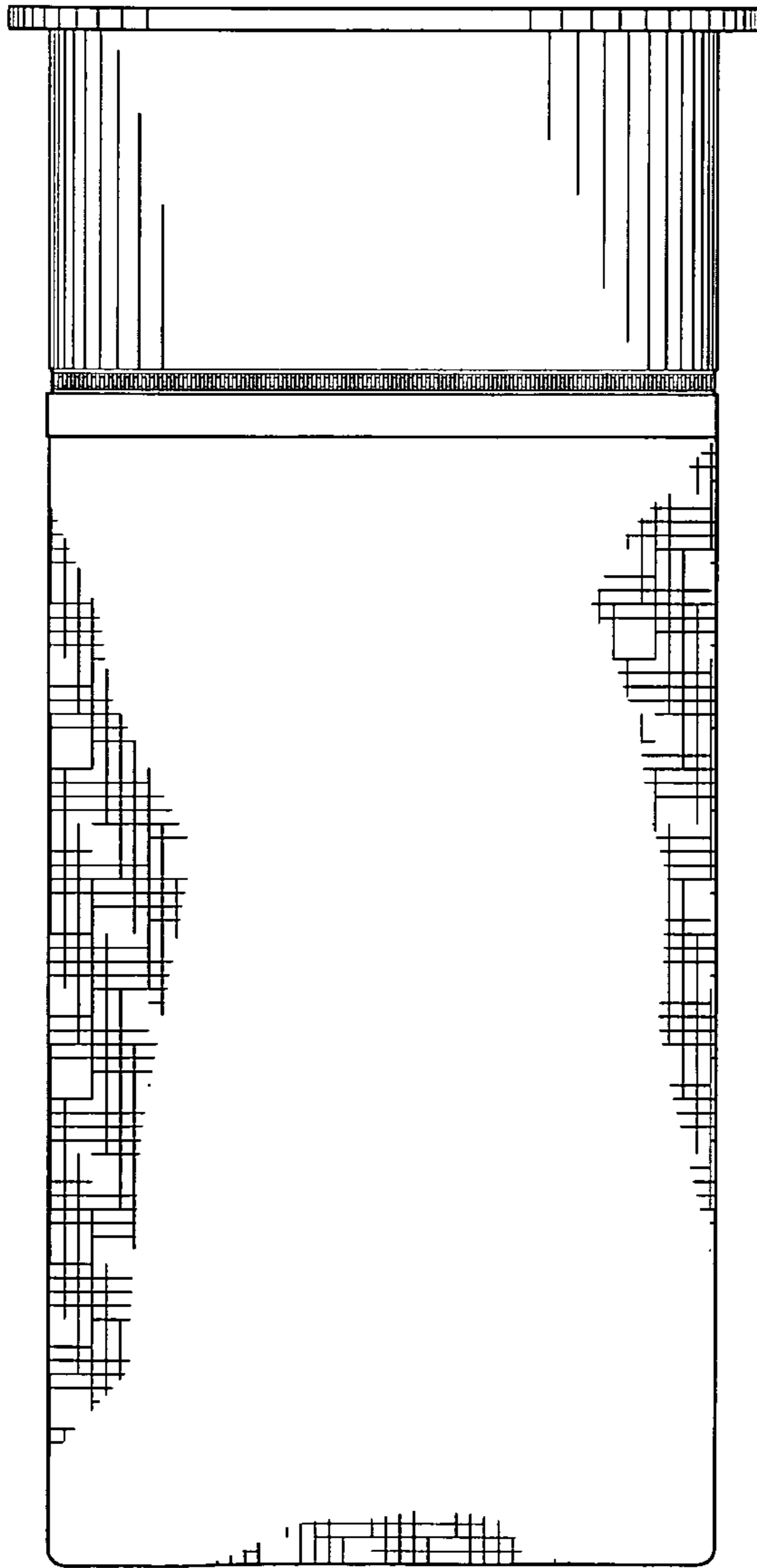

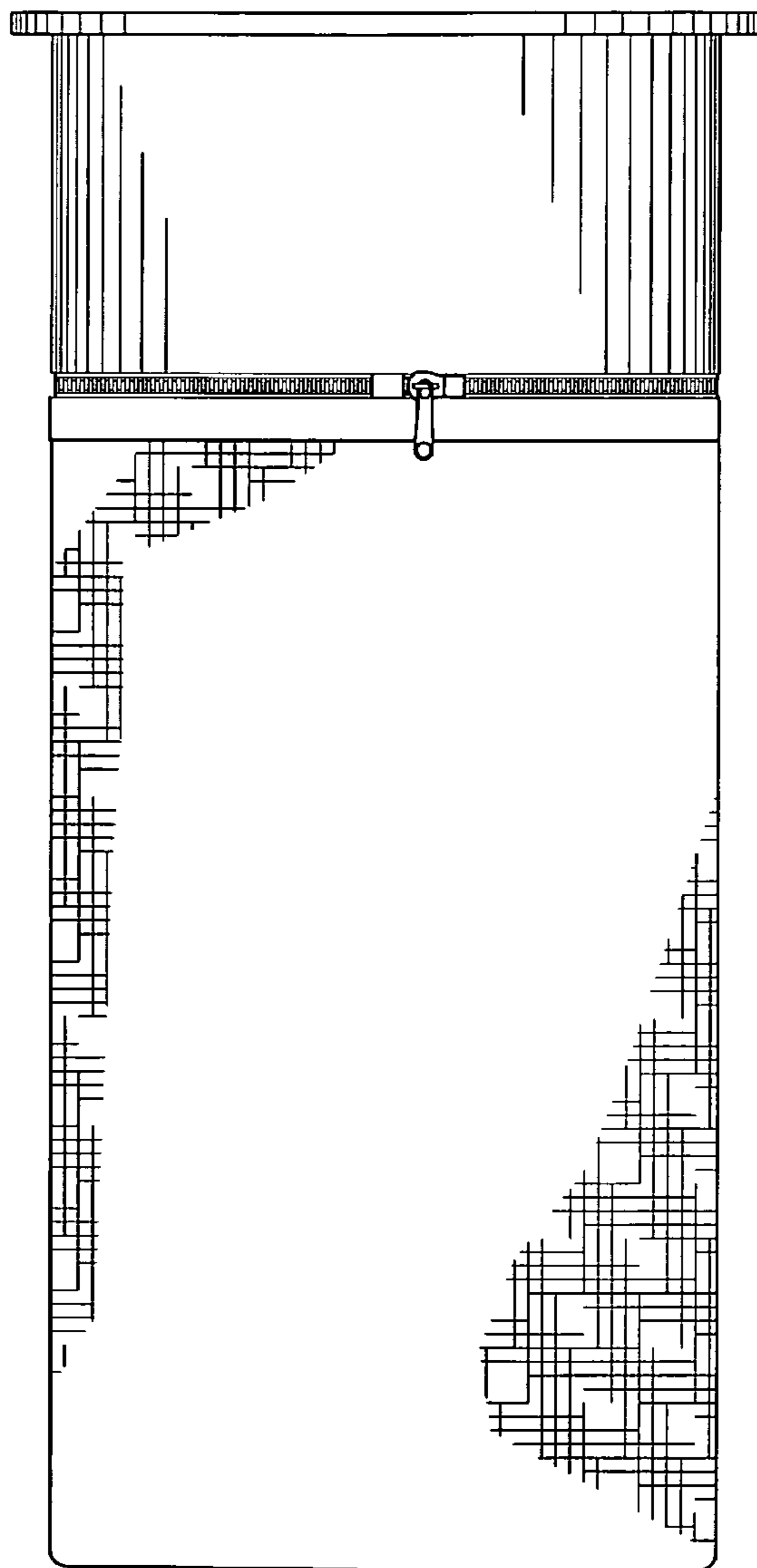

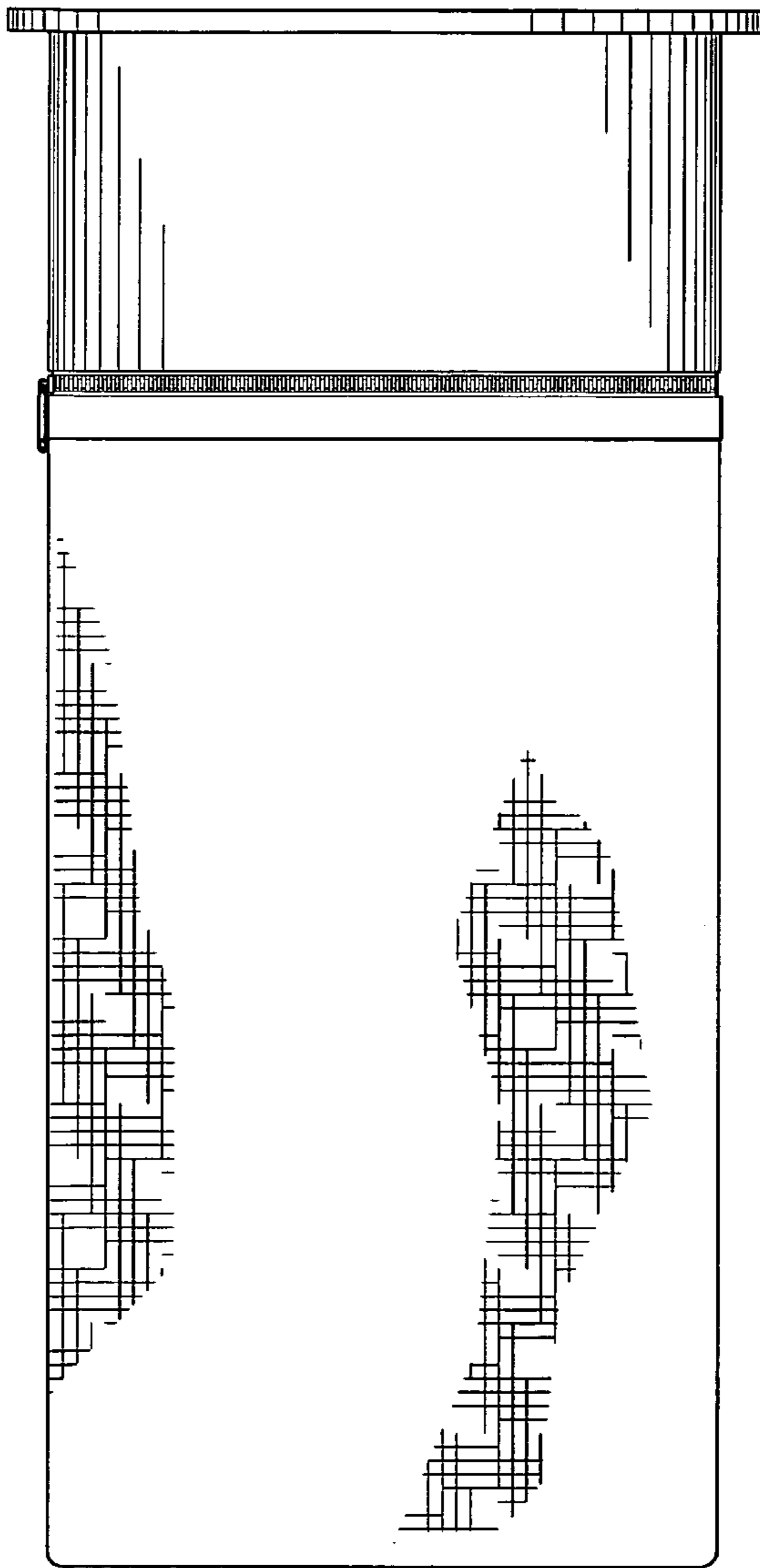

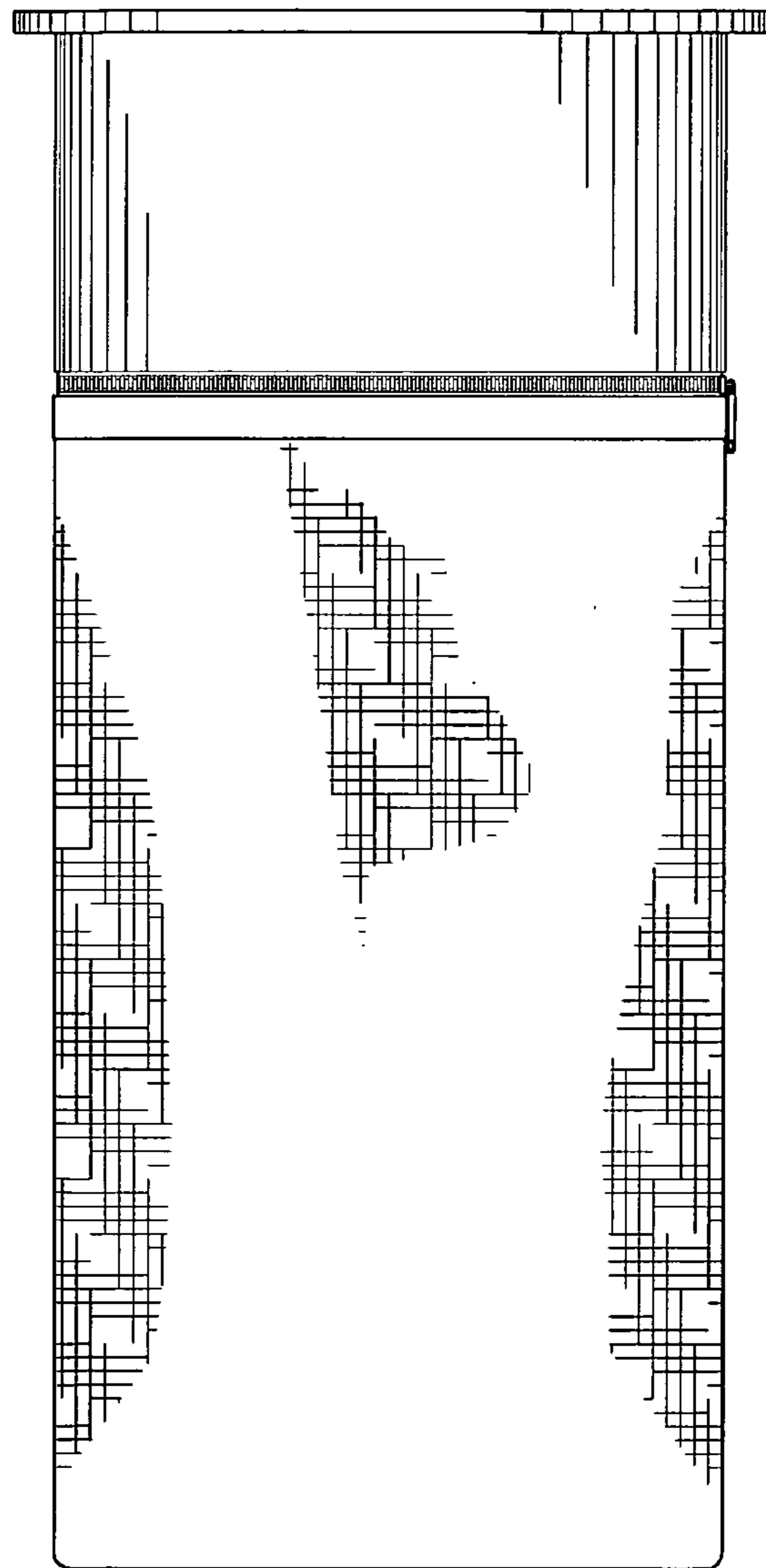

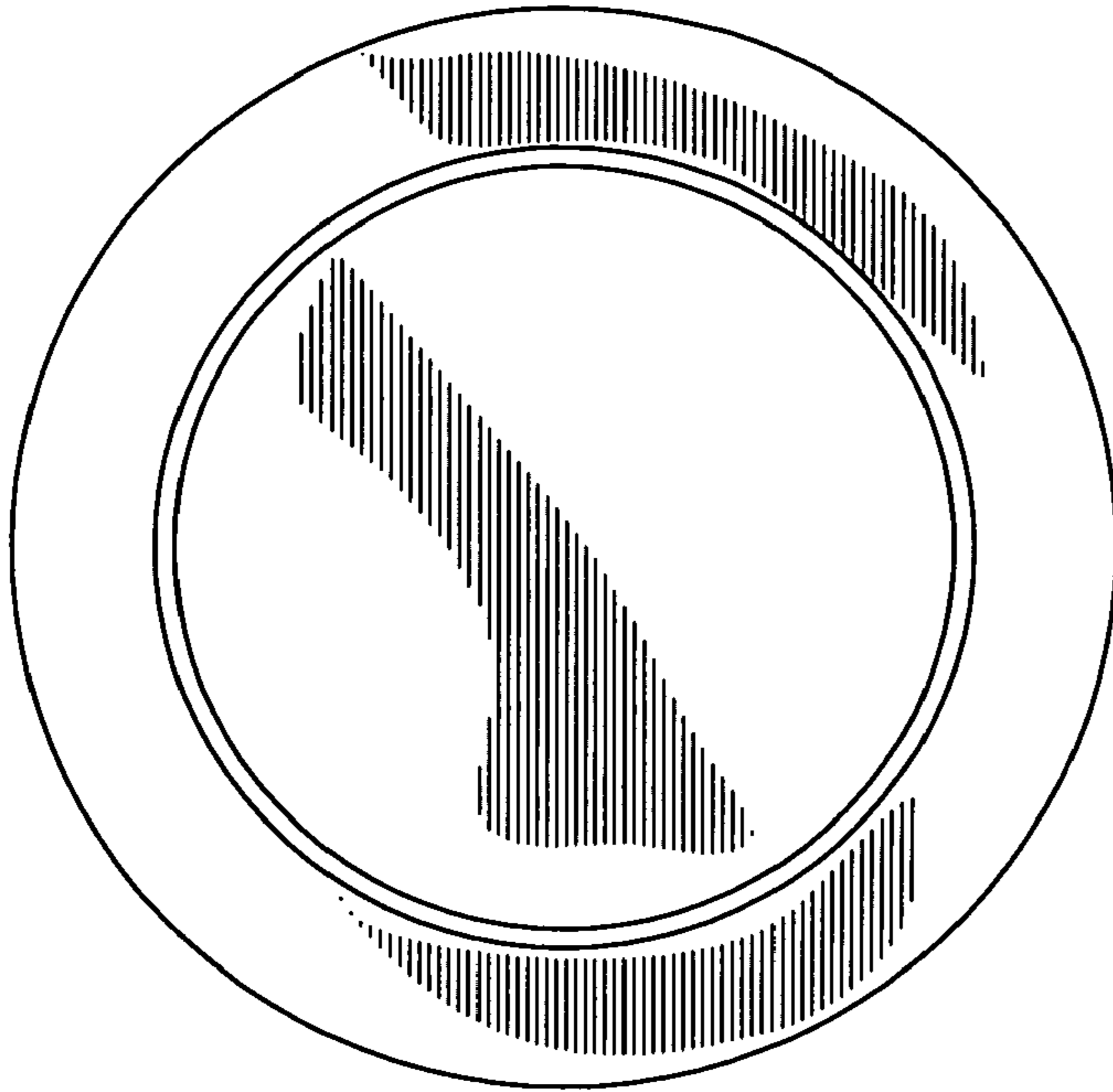
