The ornamental design for a seat, as shown and described.

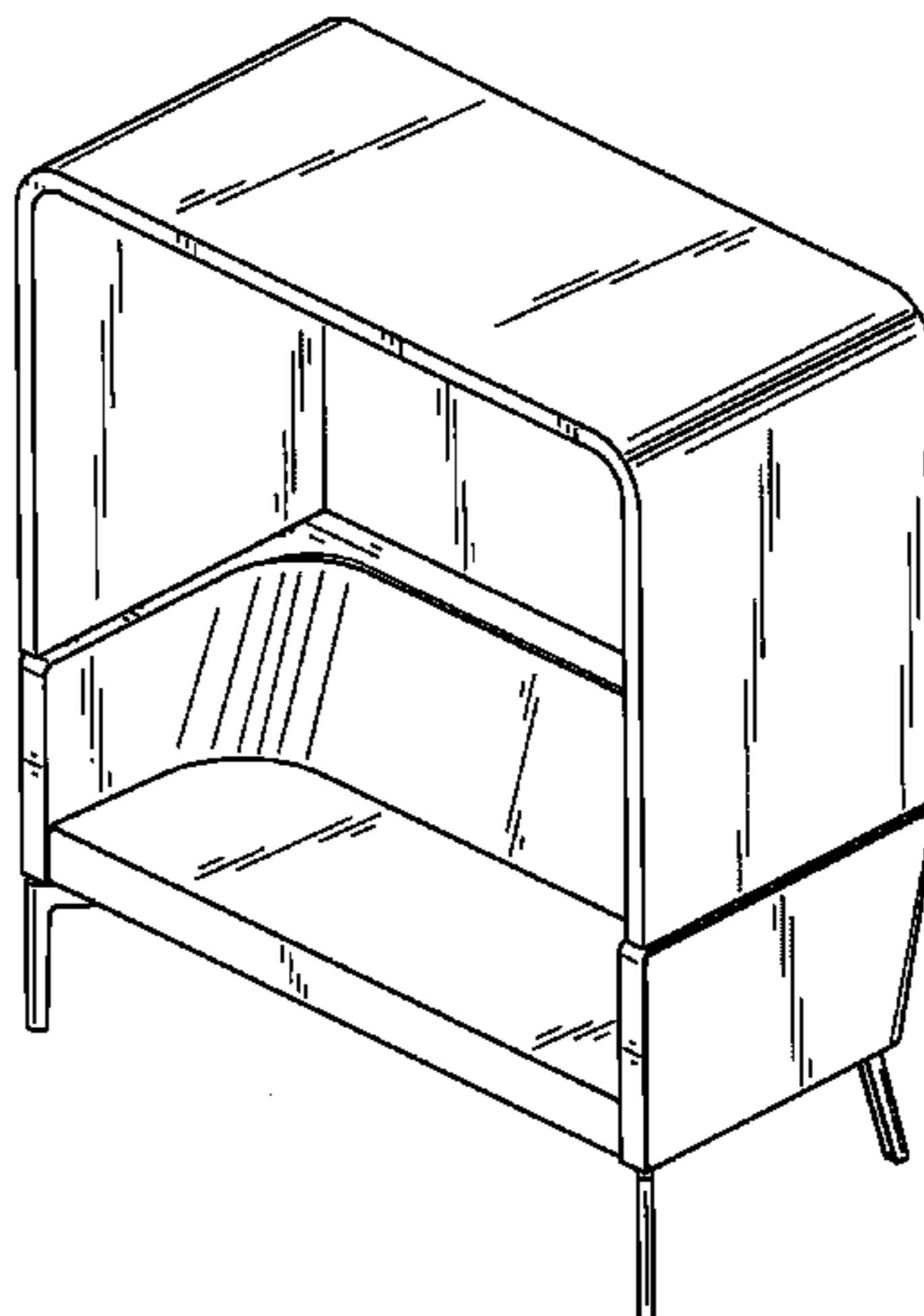
DESCRIPTION

FIG. 1 is a right, top, front perspective view of a seat according to our new design, the bottom thereof being unseen in use; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof, the left side elevational view thereof being a mirror image of the right side shown; FIG. 4 is a front elevational view thereof; and, FIG. 5 is a rear elevational view thereof.

The broken line representations in the figures are for the purpose of illustrating unclaimed environment. The broken lines are thus not part of the claim.

The nature of this product is seating furniture, for example a chair, lounge, couch and the like.

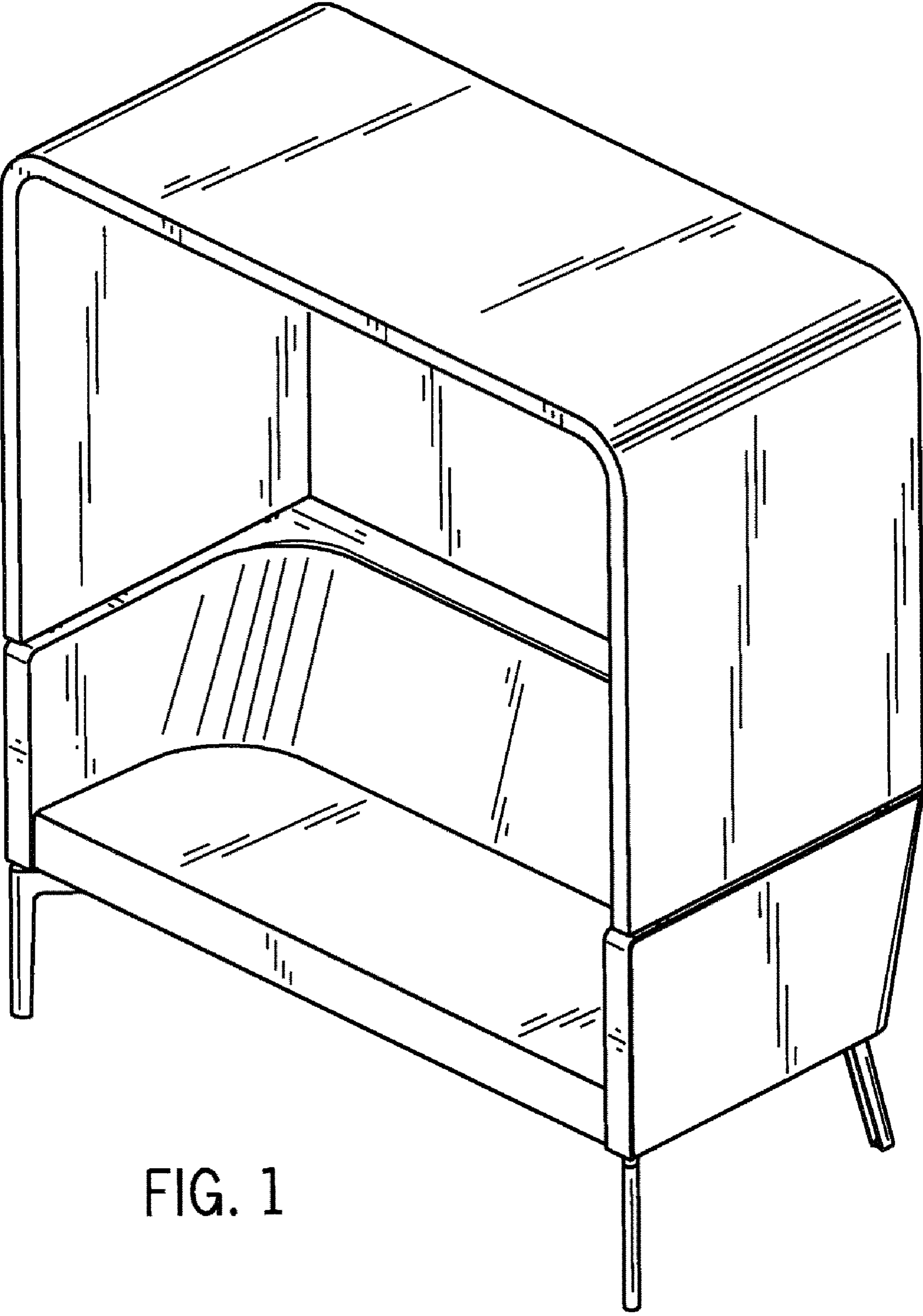

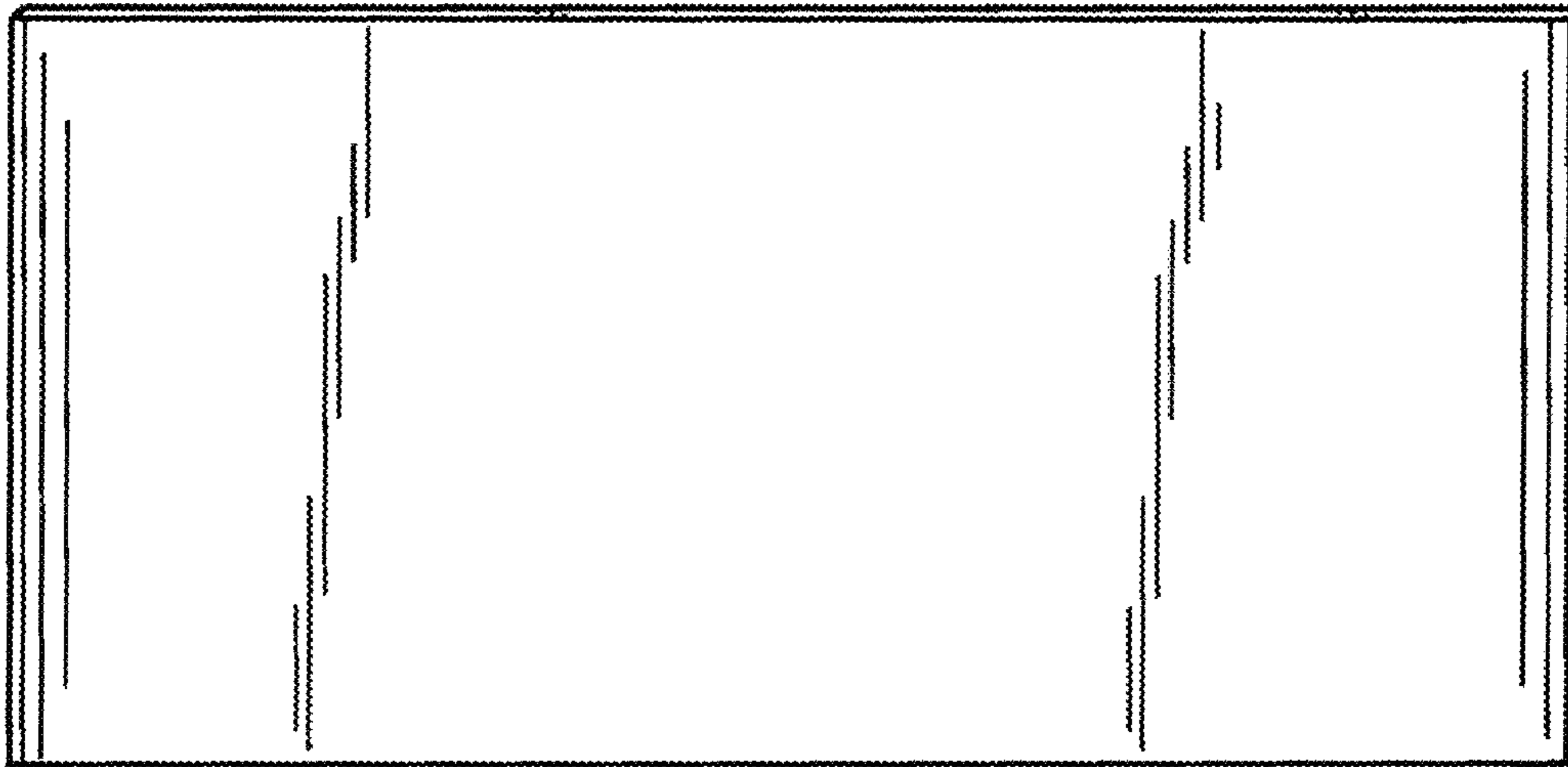

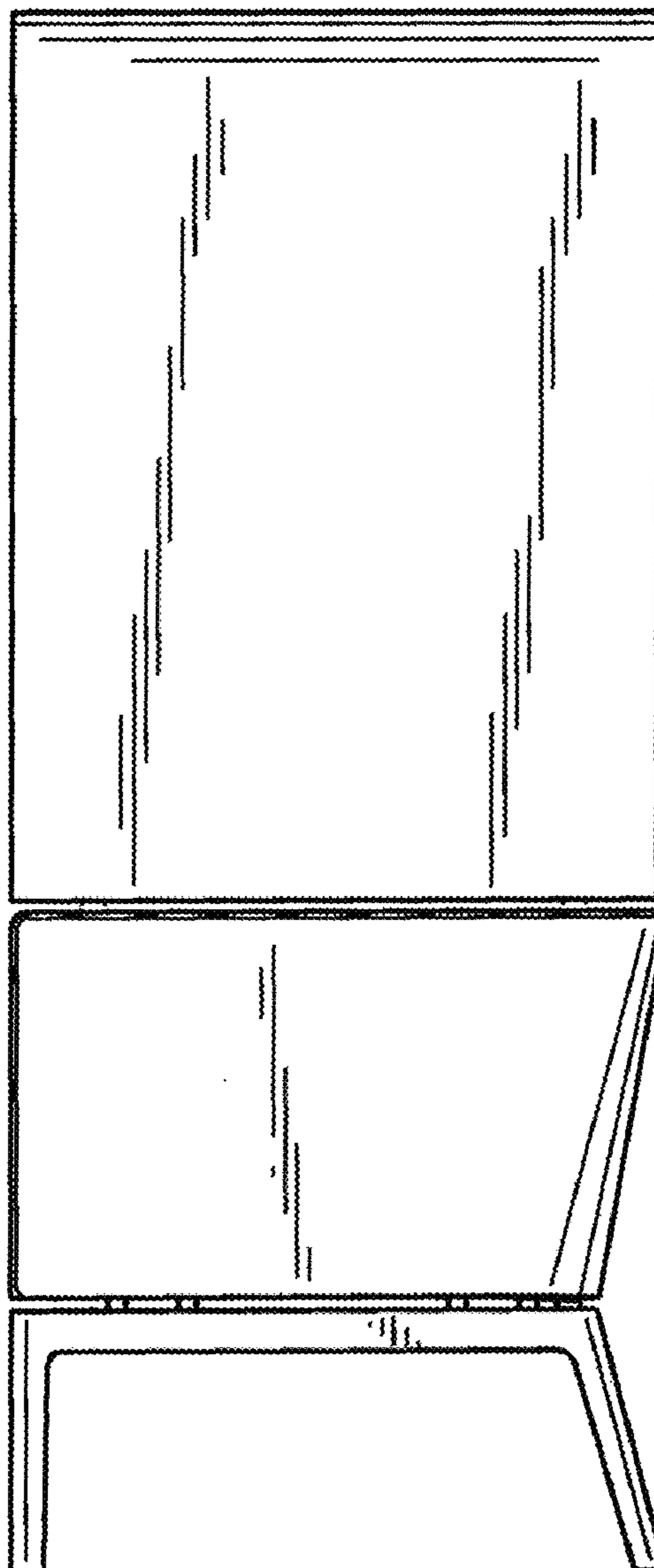

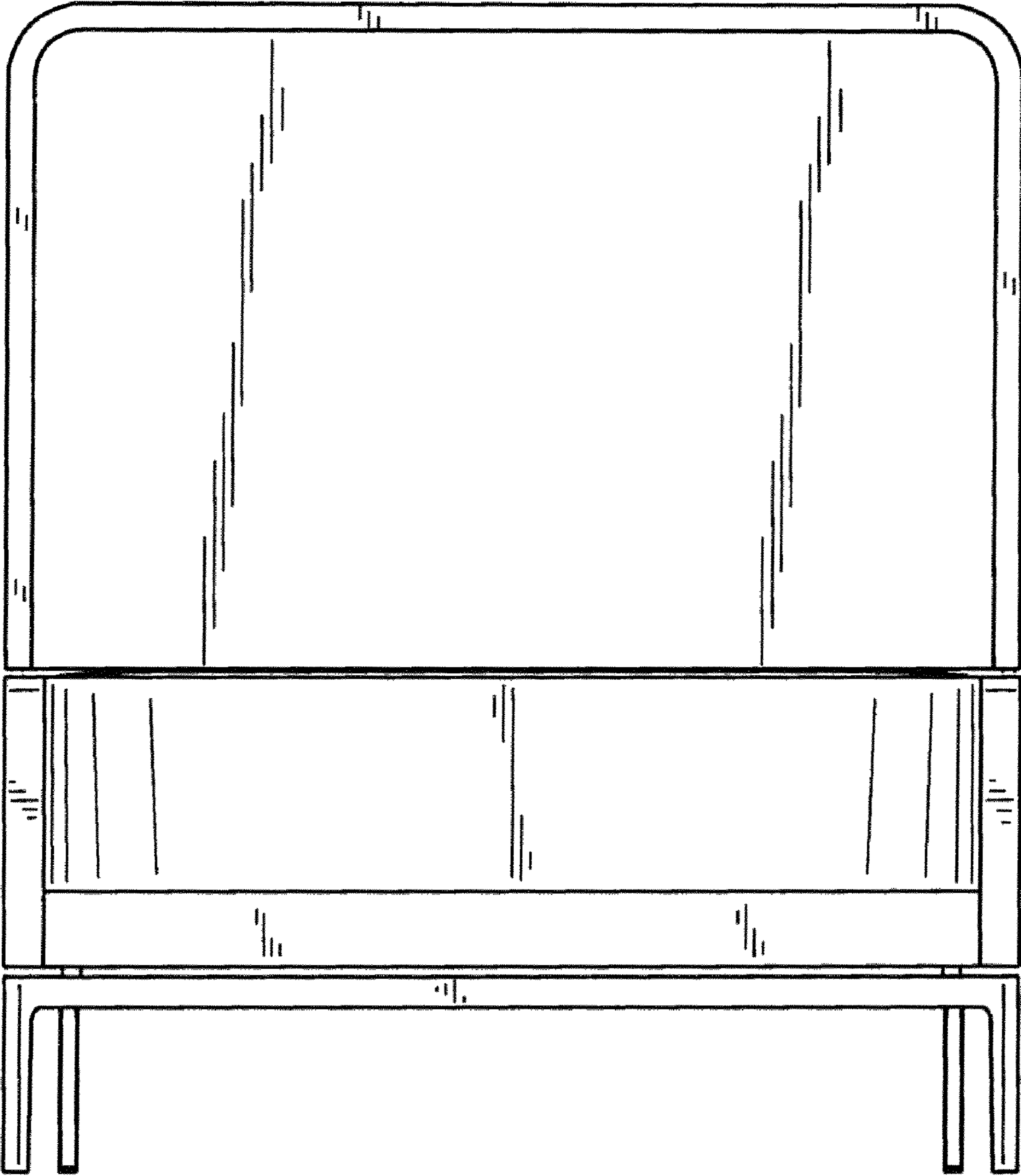

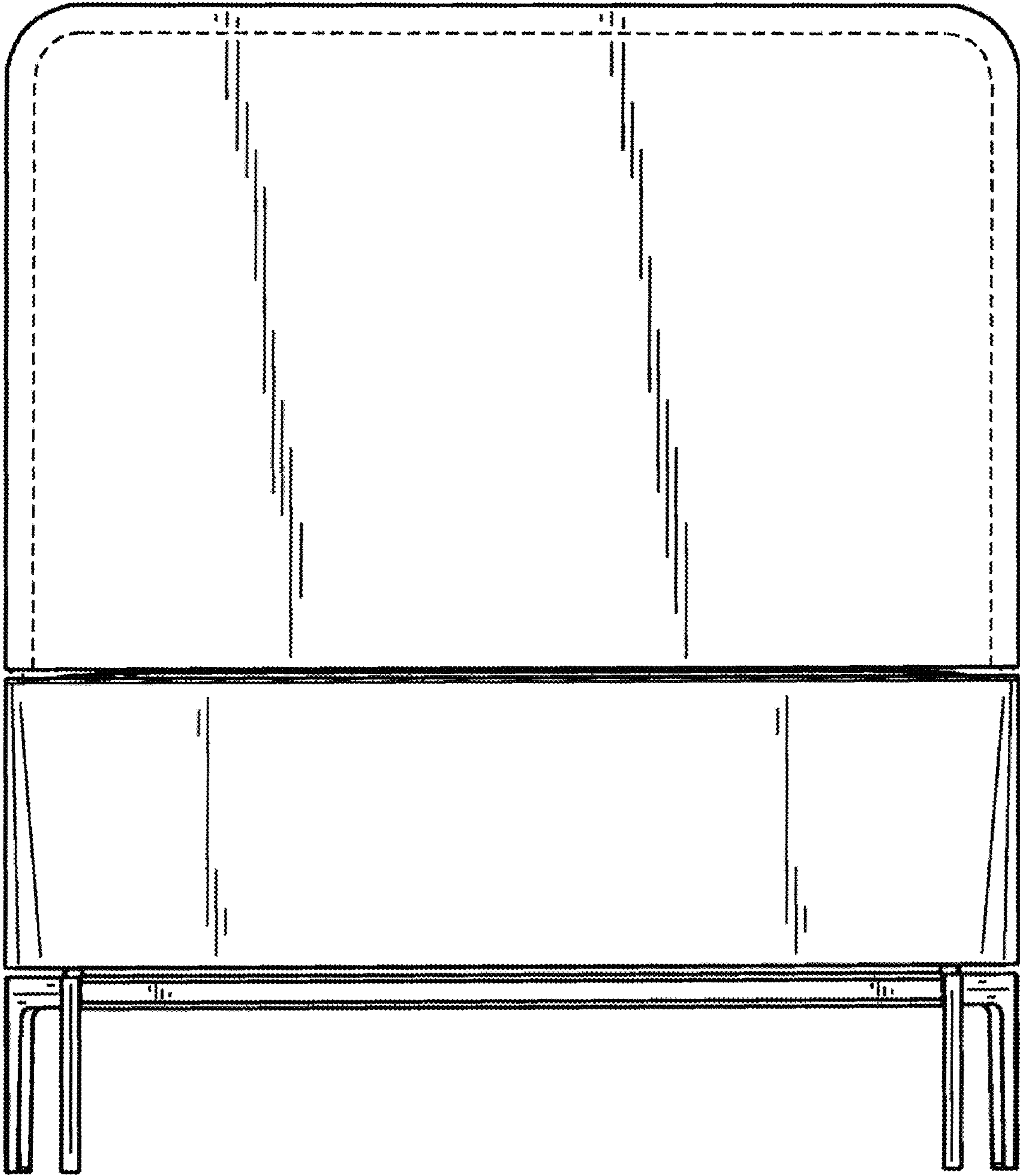
