(57) **CLAIM**

The ornamental design for a self-watering bucket insert for bucket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the top of a self-watering bucket insert, according to my new design, with broken lines forming no part thereof;

FIG. 2 is a perspective view from the top of the perforated plate portion of my design;

FIG. 3 is a perspective view from the top of the stanchion portion of my design;

FIG. 4 is top view of the self-watering bucket insert;

FIG. 5 is a bottom view of the self-watering bucket insert;

FIG. 6 is a side view of the self-watering bucket insert;

FIG. 7 is top view of the perforated plate portion;

FIG. 8 is a bottom view of the perforated plate portion;

FIG. 9 is a side view of the perforated plate portion;

FIG. 10 is top view of the stanchion portion;

FIG. 11 is a bottom view of the stanchion portion;

FIG. 12 is a side view of the stanchion portion;

FIG. 13 is a perspective view from the top of the self-watering bucket insert, with the oval area defined by broken lines including the connection between the perforated plate portion and the stanchion portion of my design; and,

FIG. 14 is an enlarged view of the oval area identified by broken lines in FIG. 13.

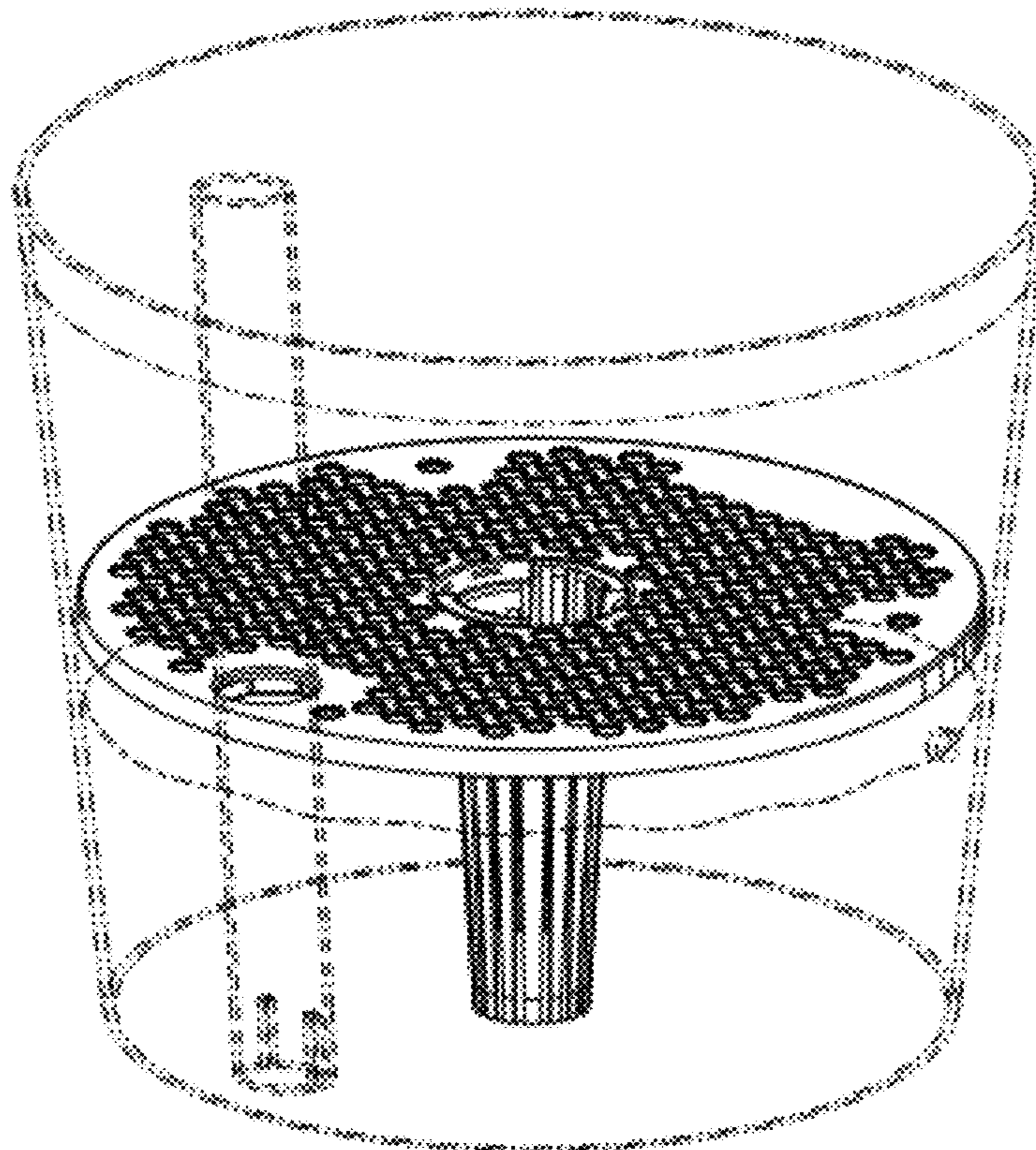

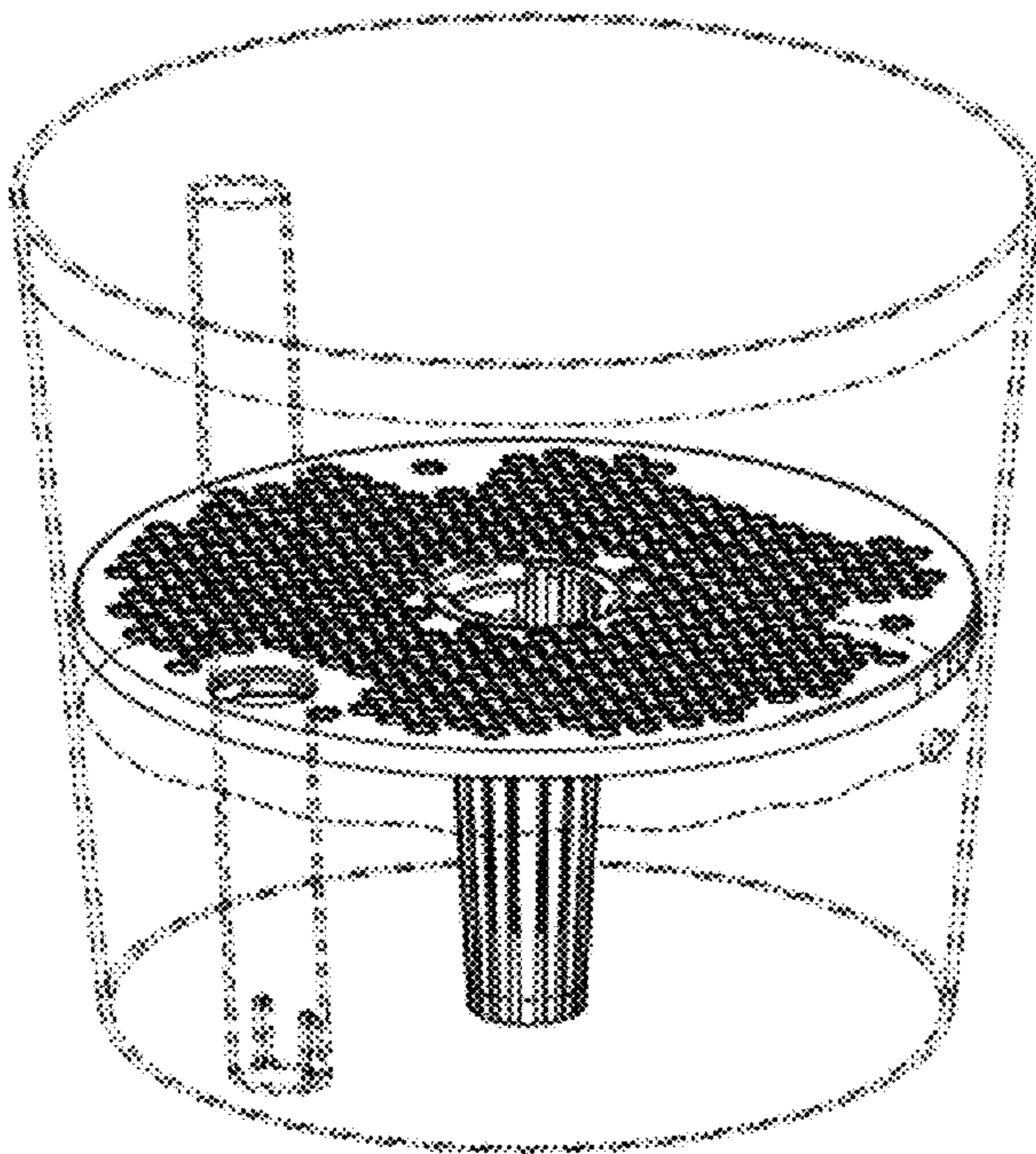

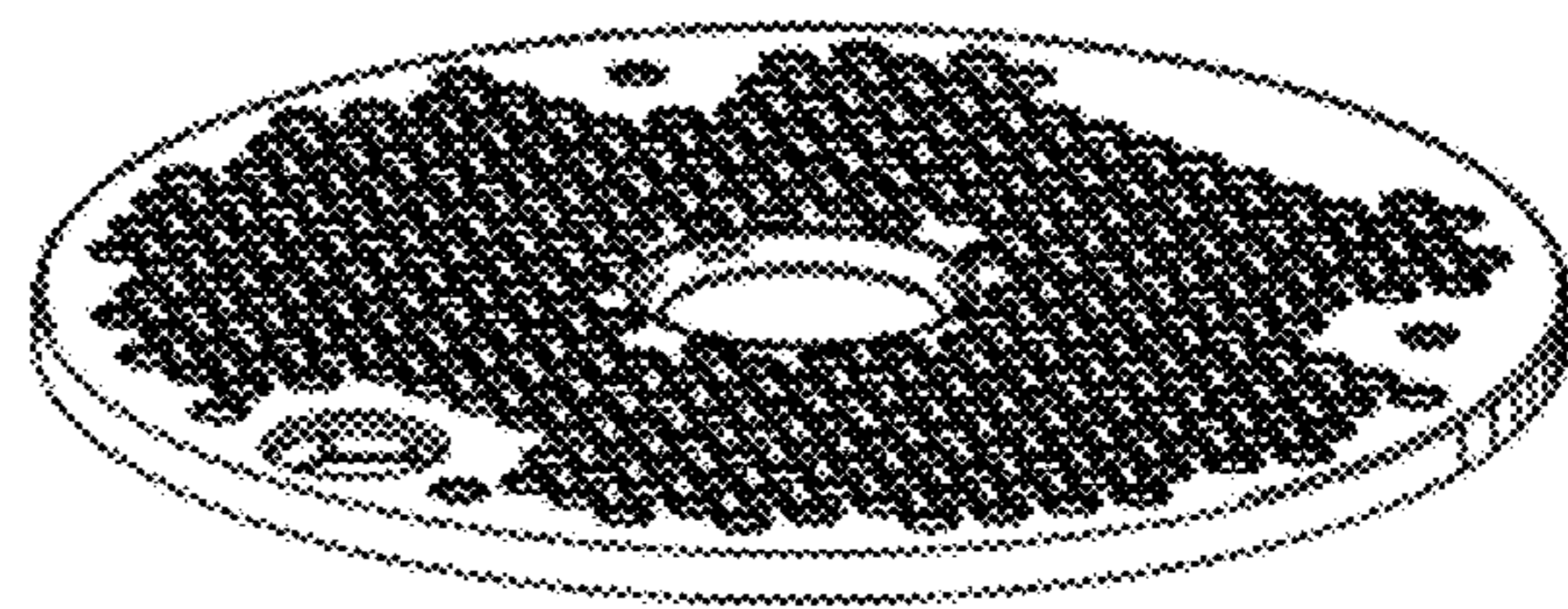

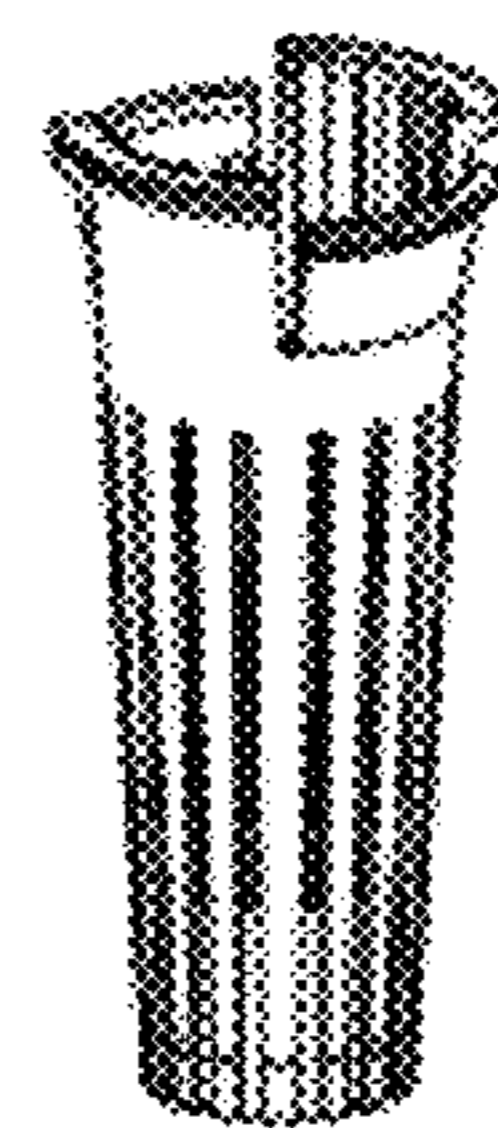

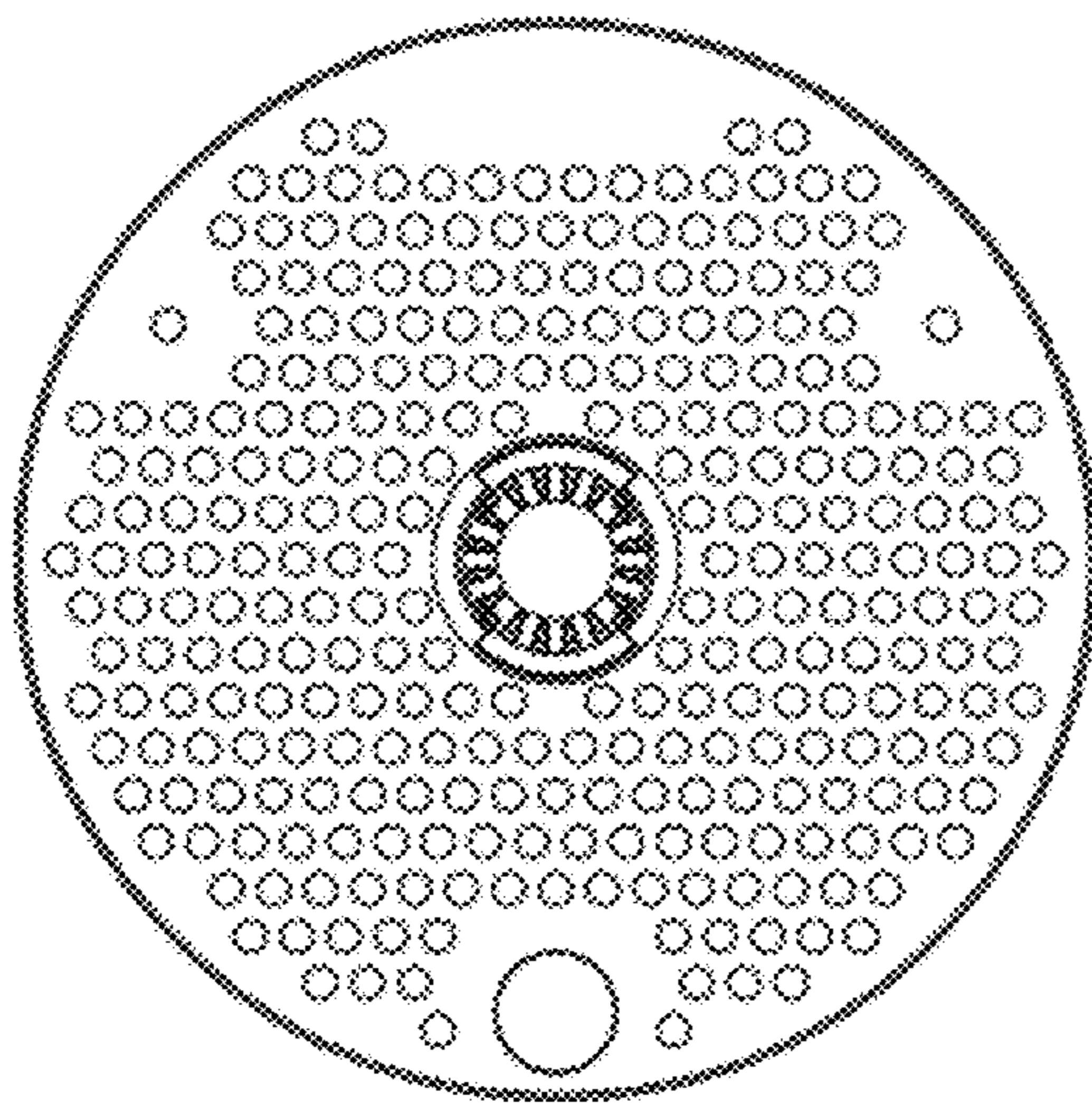

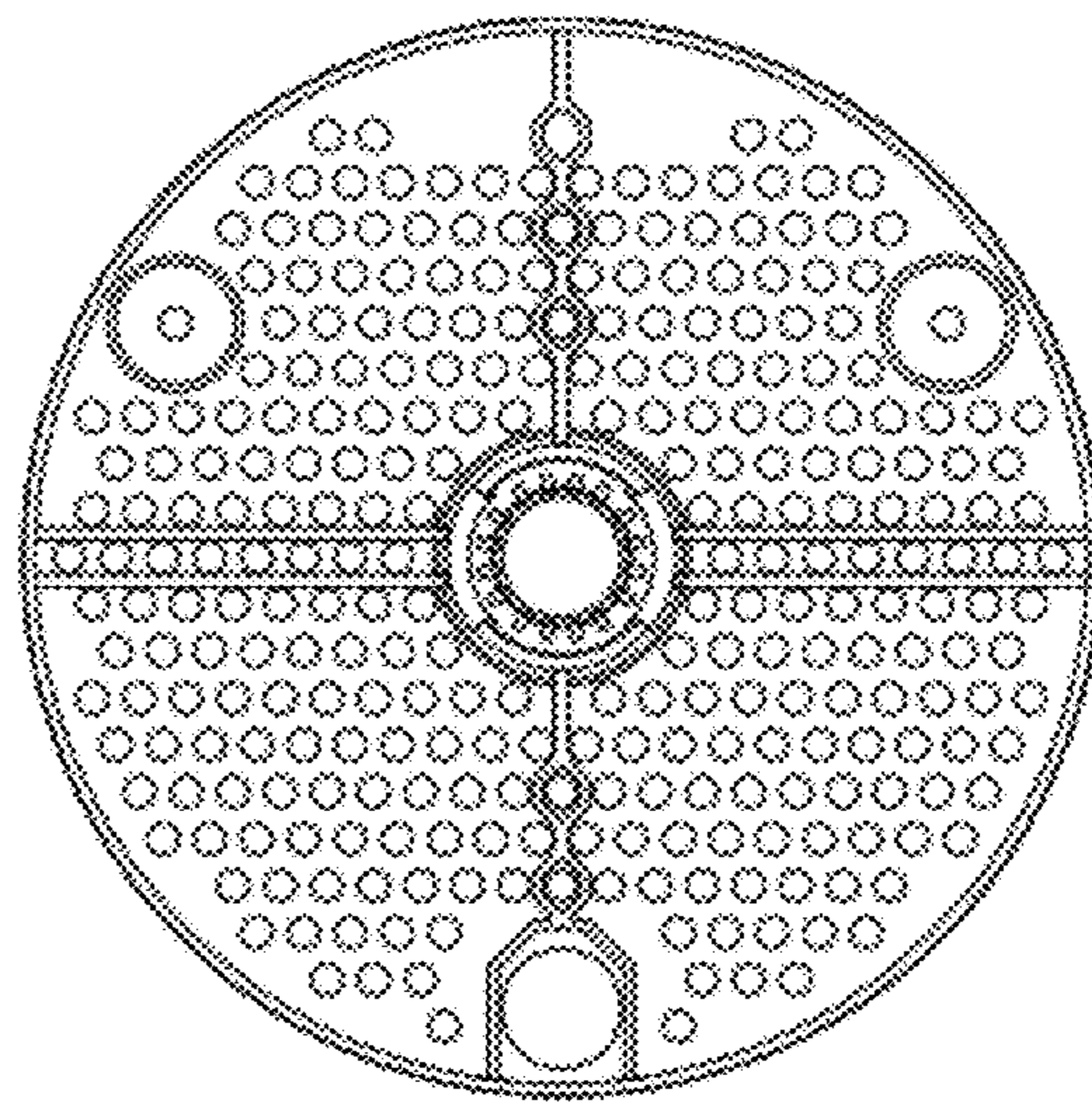

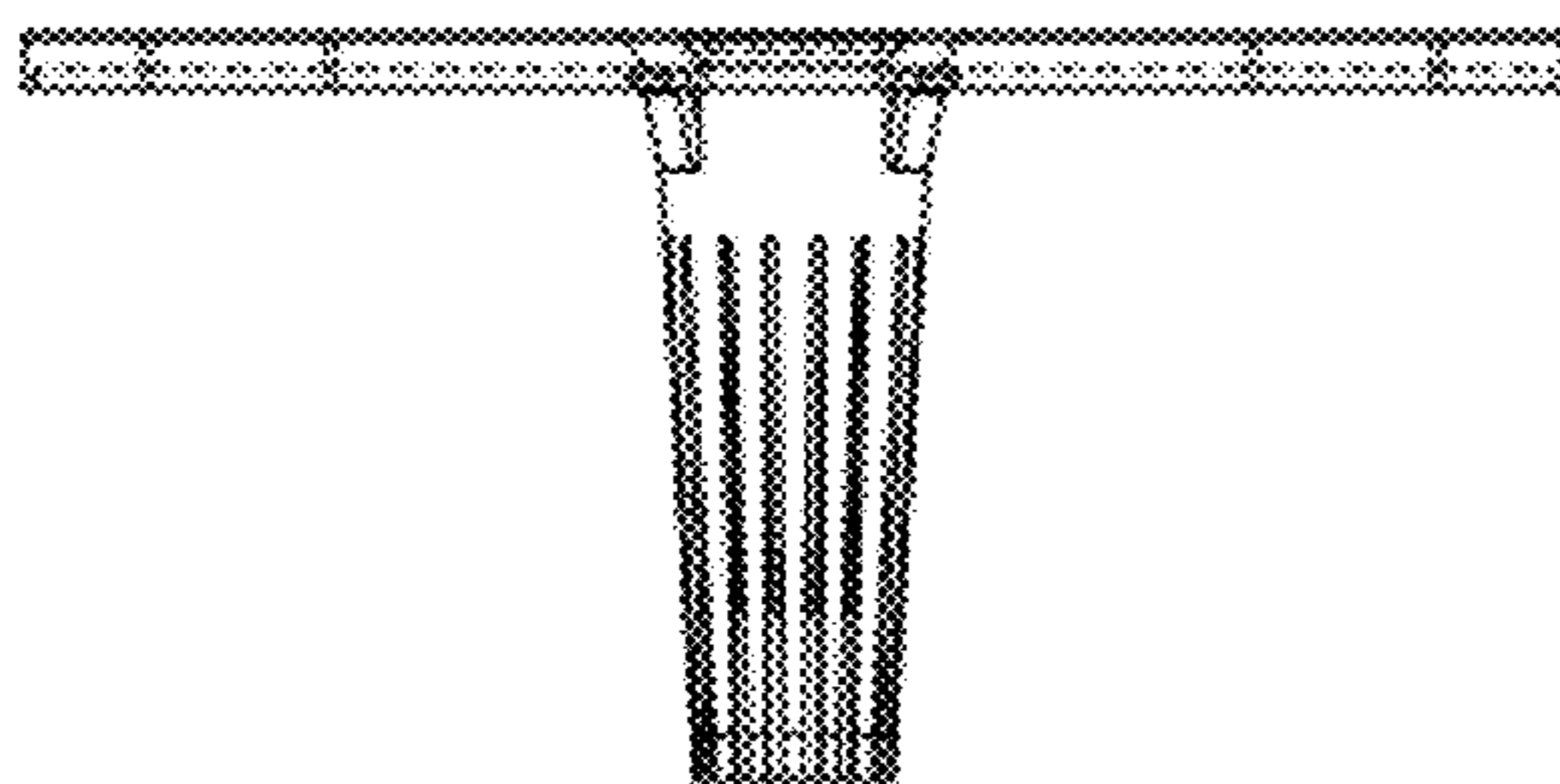

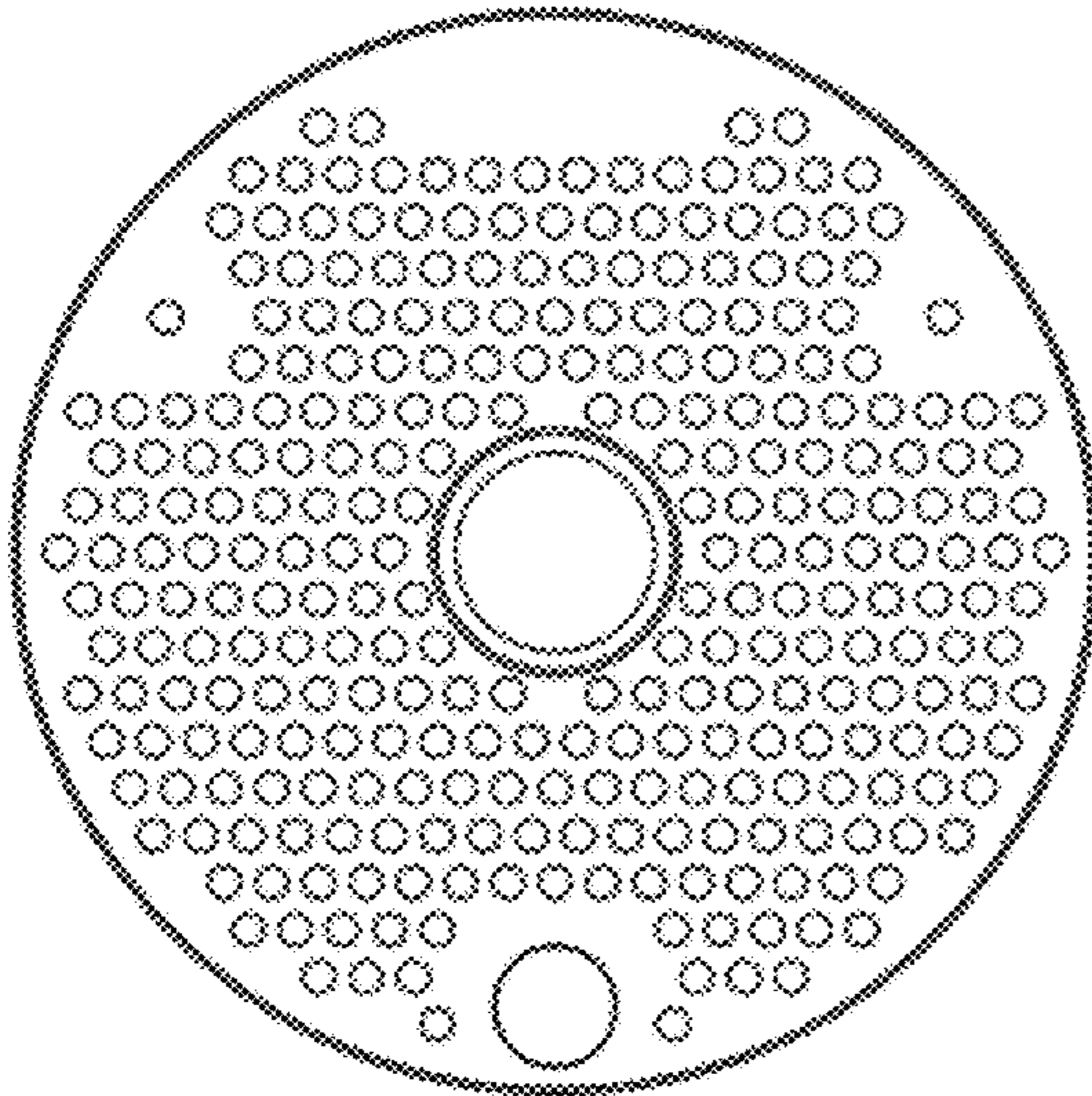

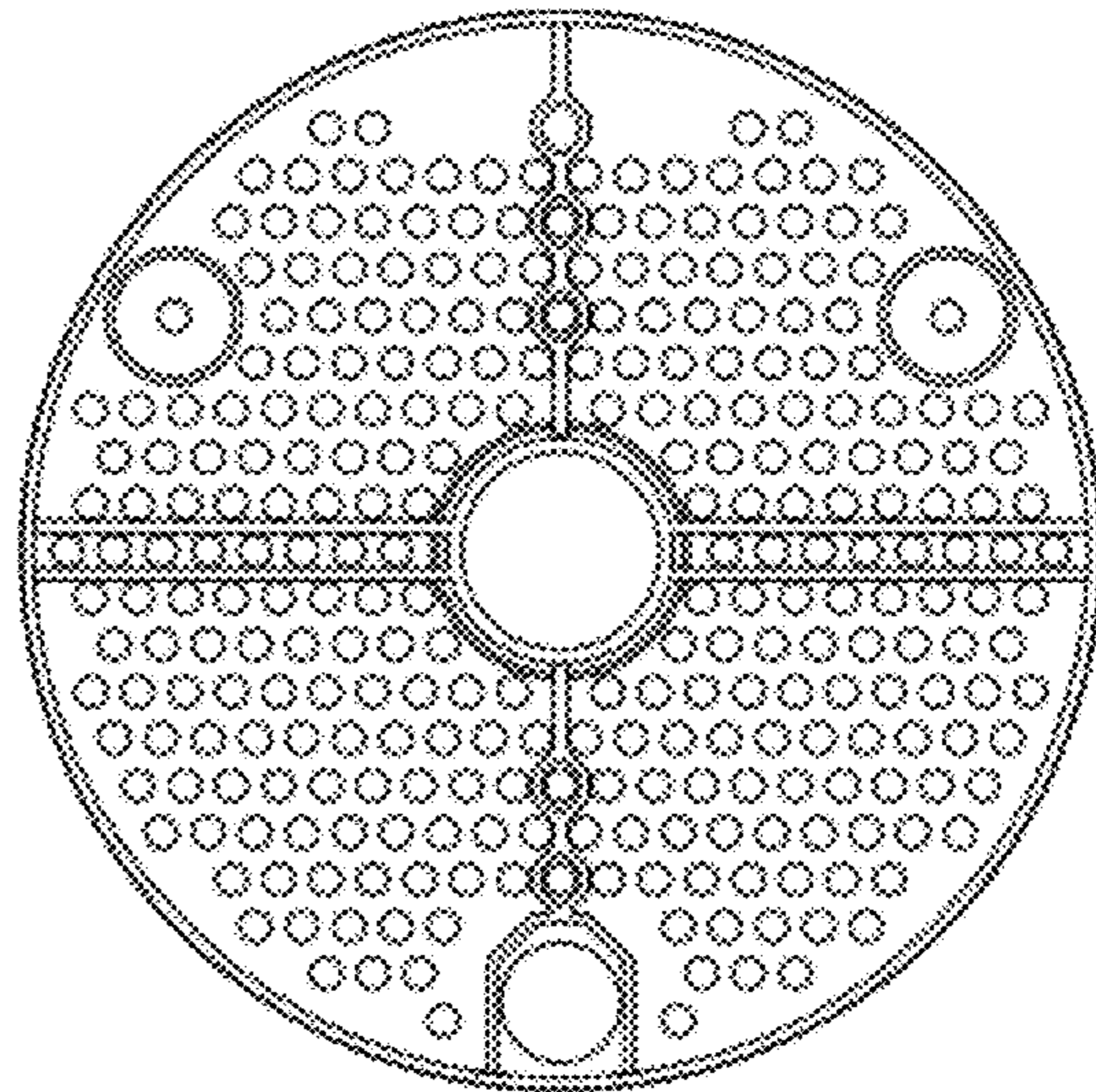

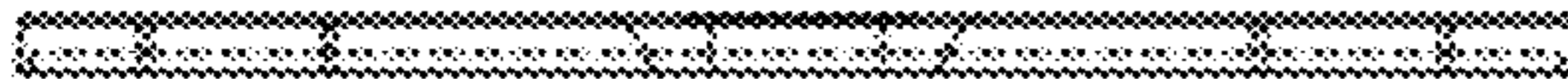

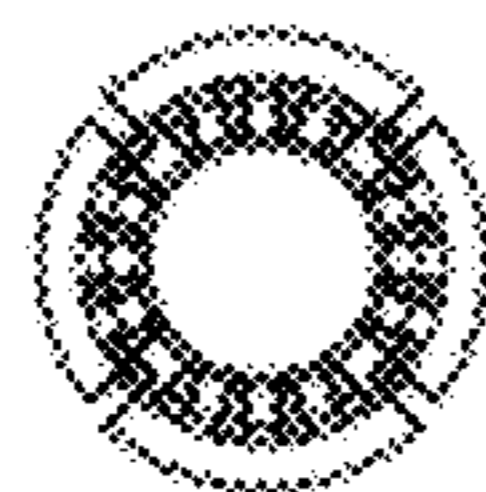

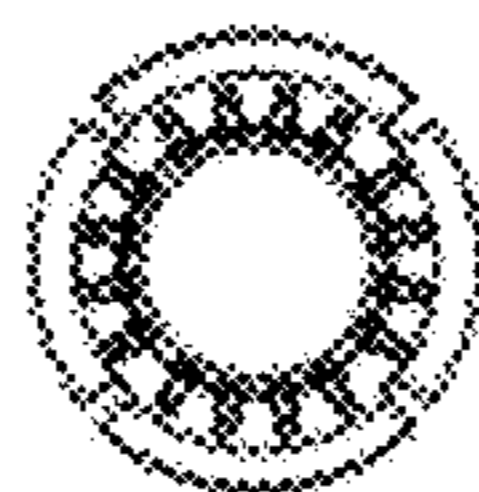

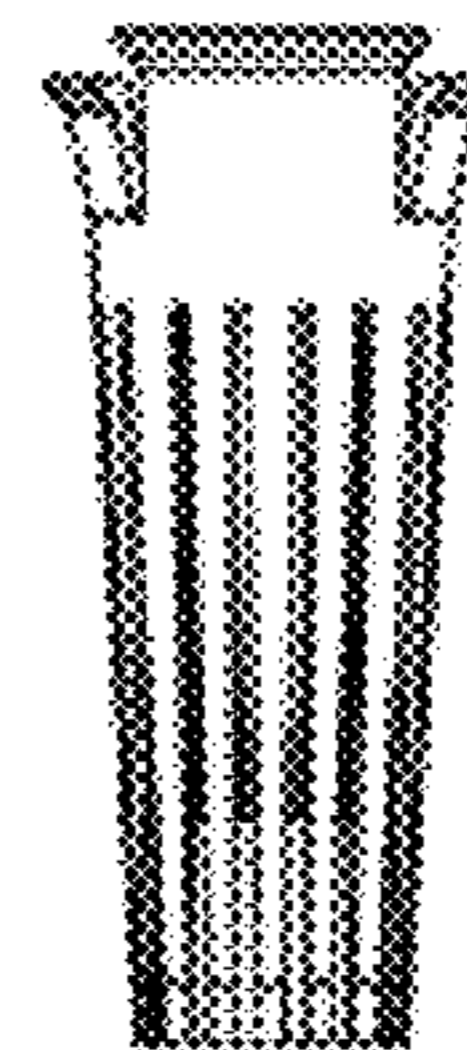

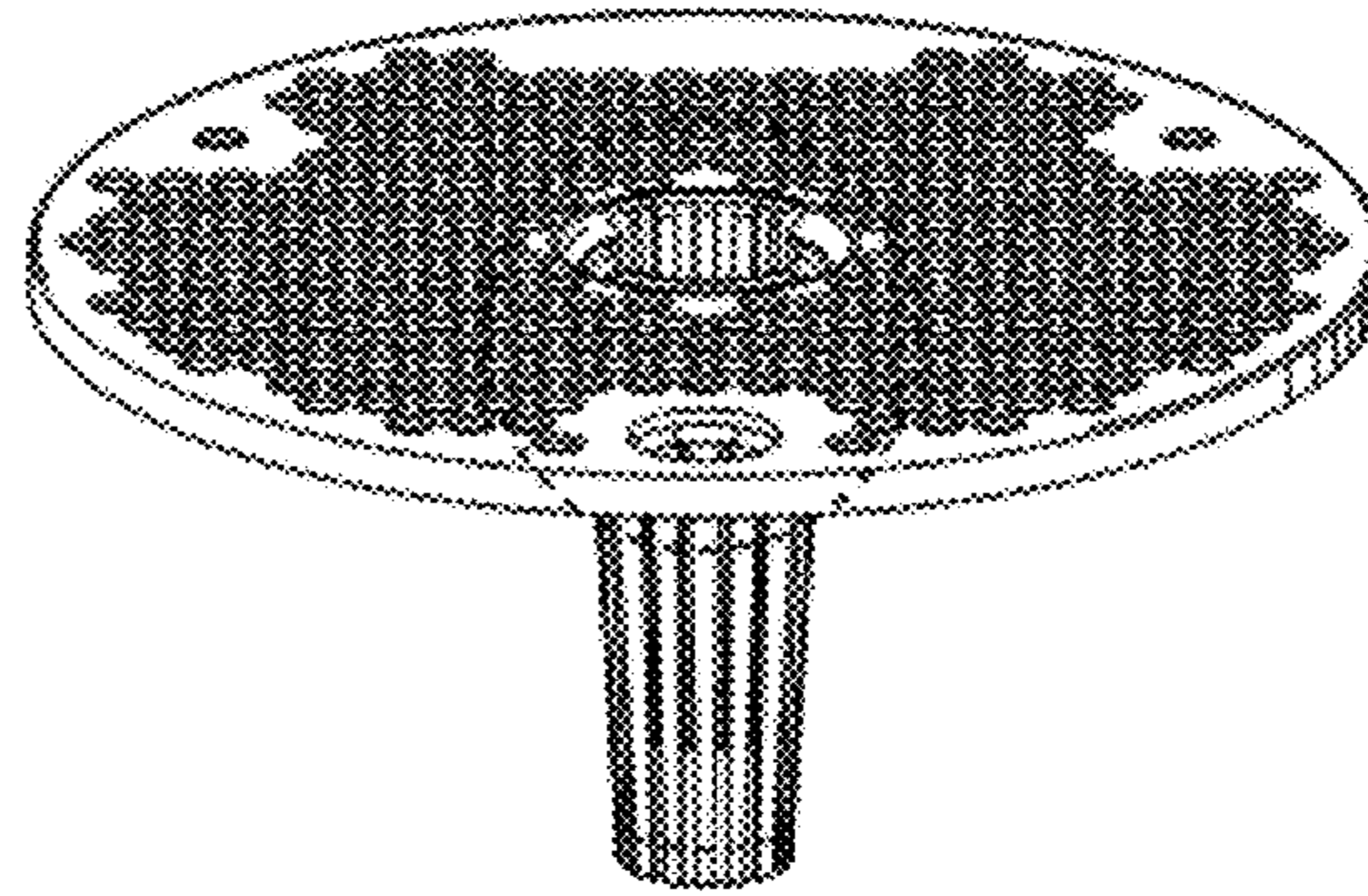
