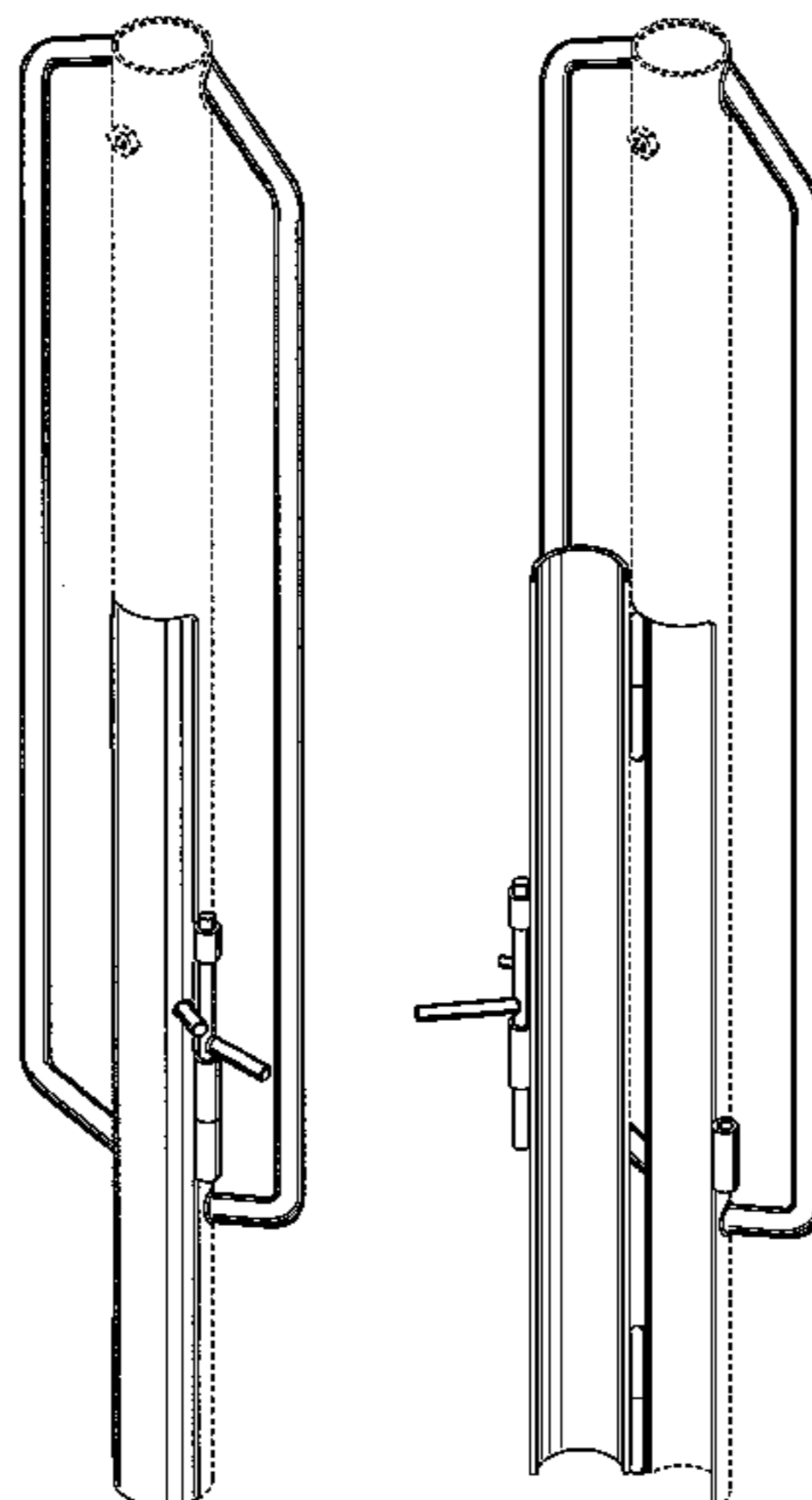
(57) **CLAIM**

The ornamental design for a post pounder, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a post pounder showing my new design with the door closed; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof; FIG. 8 is a front left perspective view of a post pounder showing my new design with the door opened; FIG. 9 is a front elevation view thereof; FIG. 10 is a back elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a top plan view thereof; and FIG. 14 is a bottom plan view thereof. The broken lines in the drawings illustrate portions of the post pounder that form no part of the claimed design.

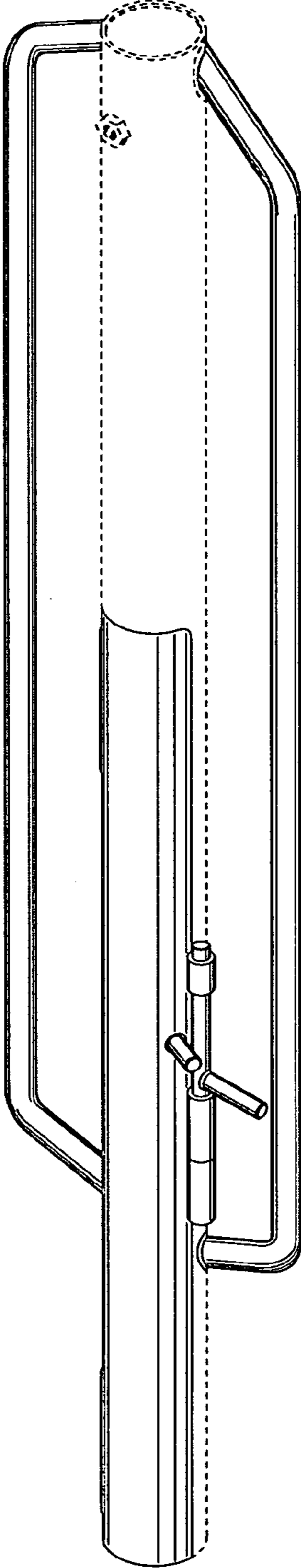

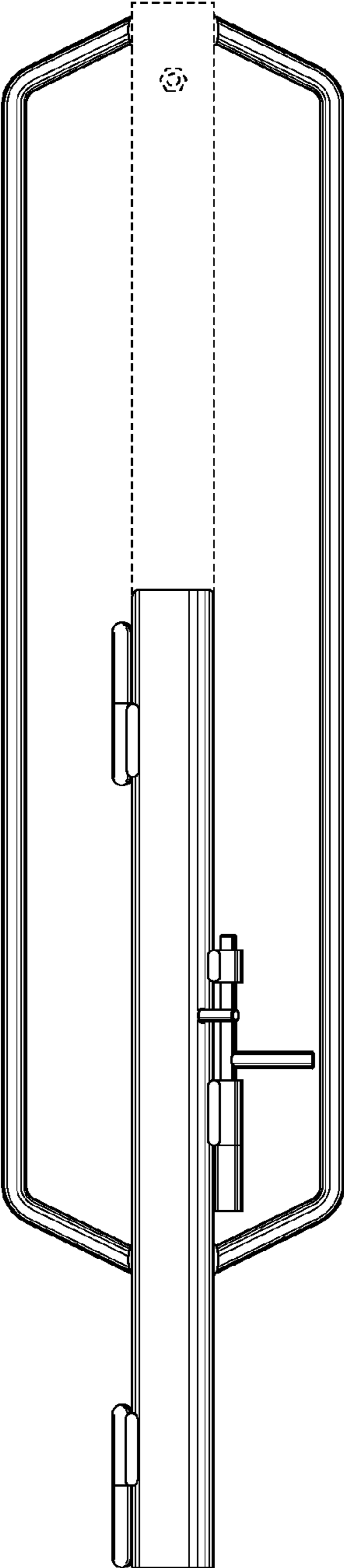

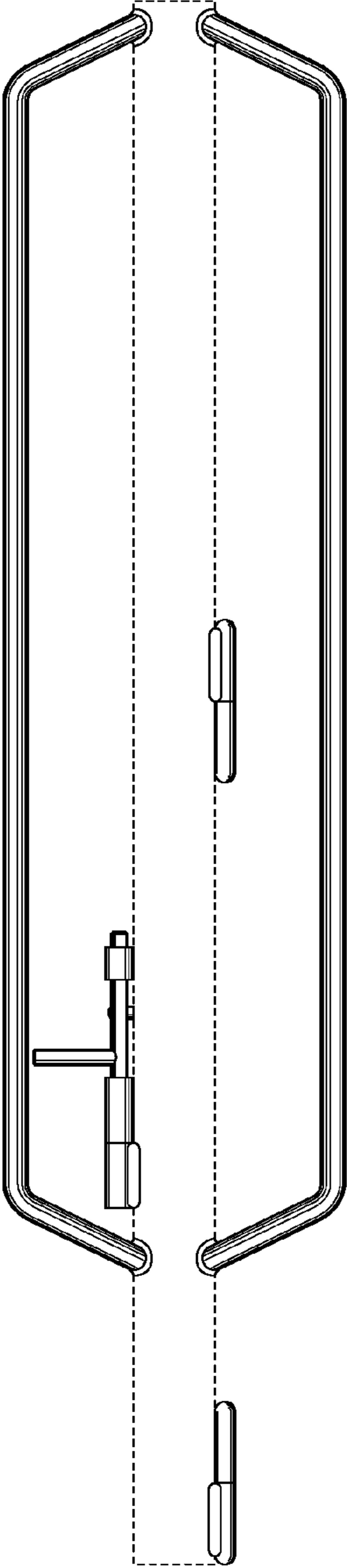

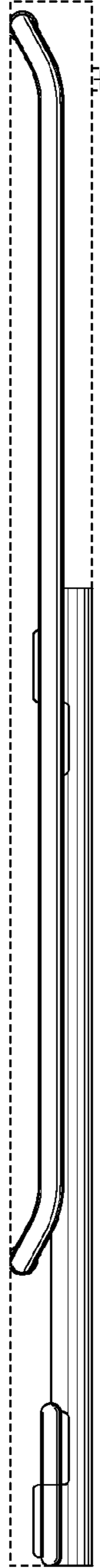

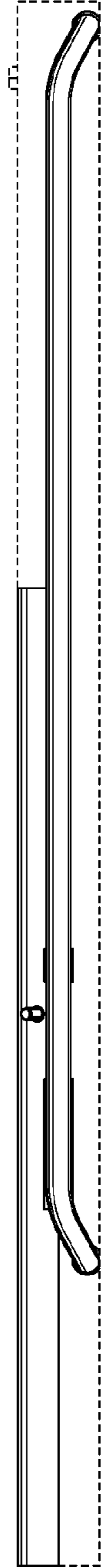

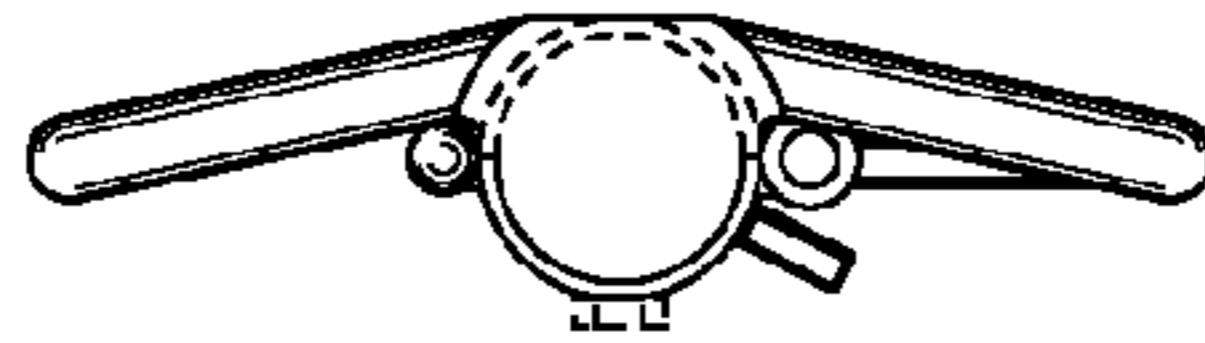

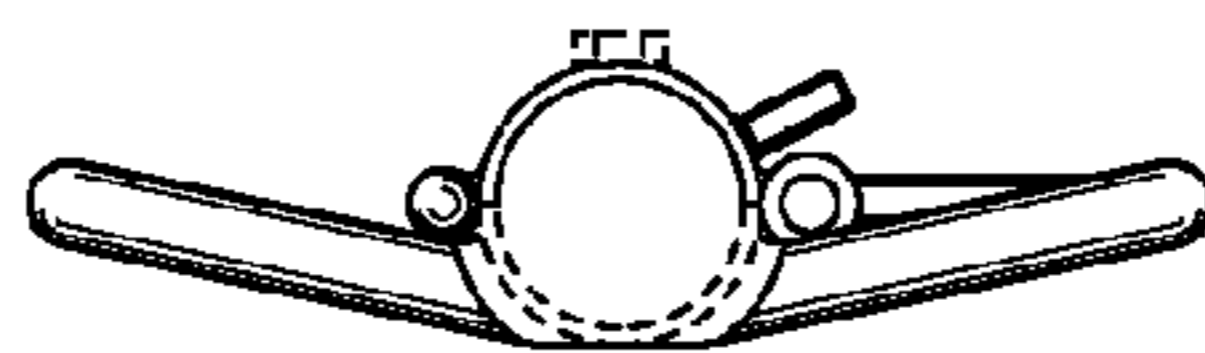

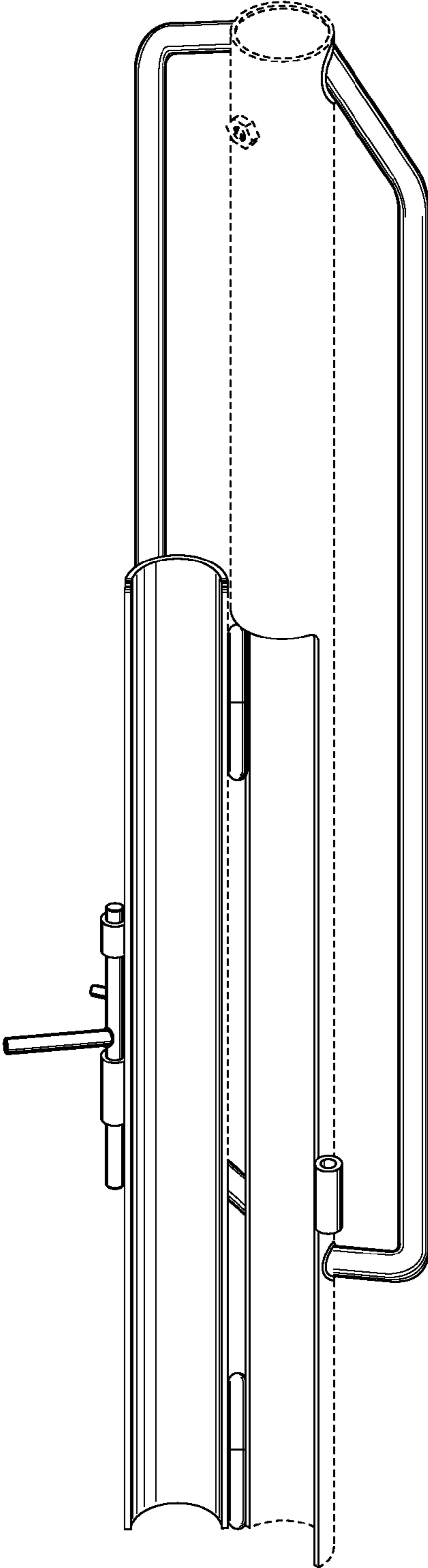

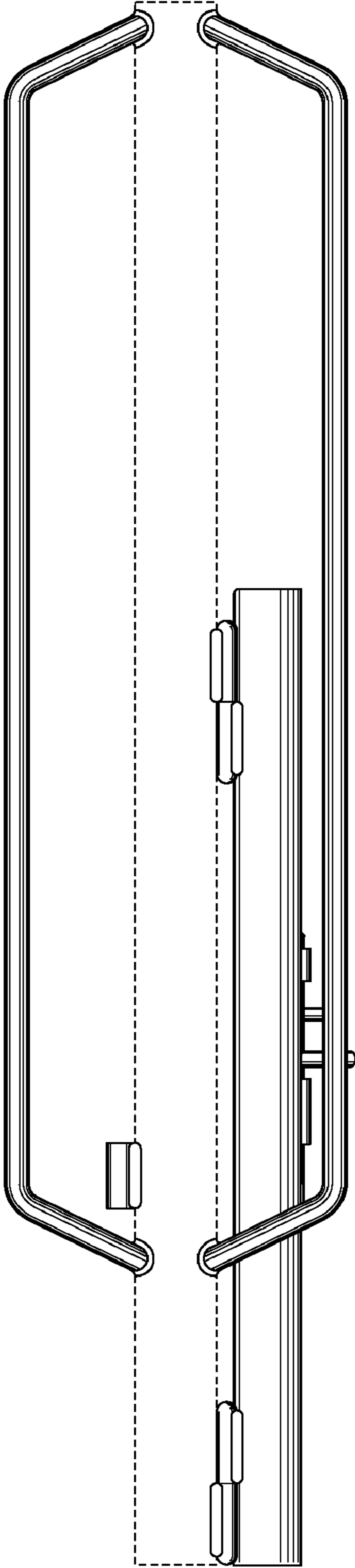

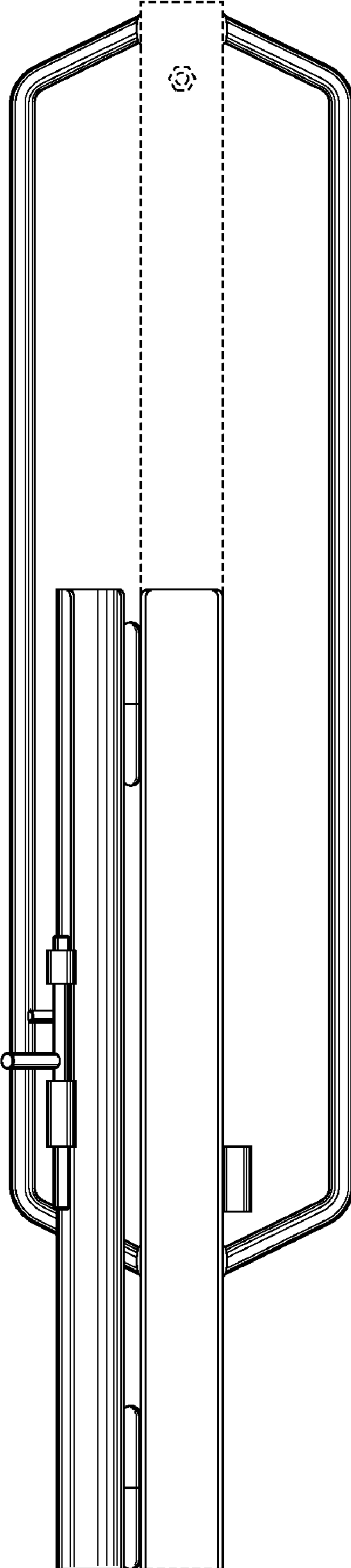

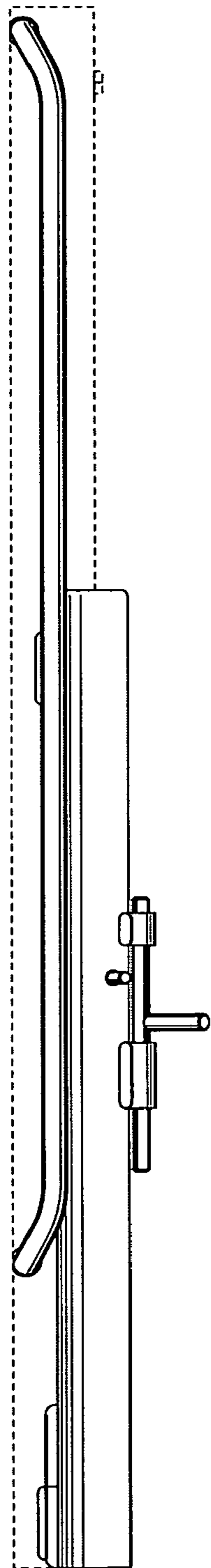

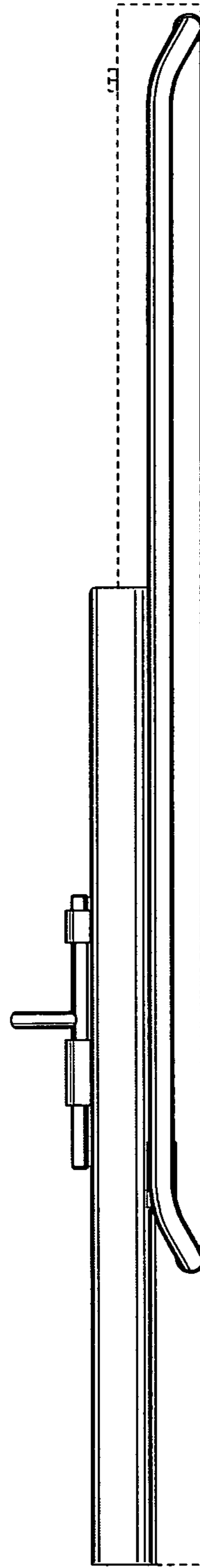

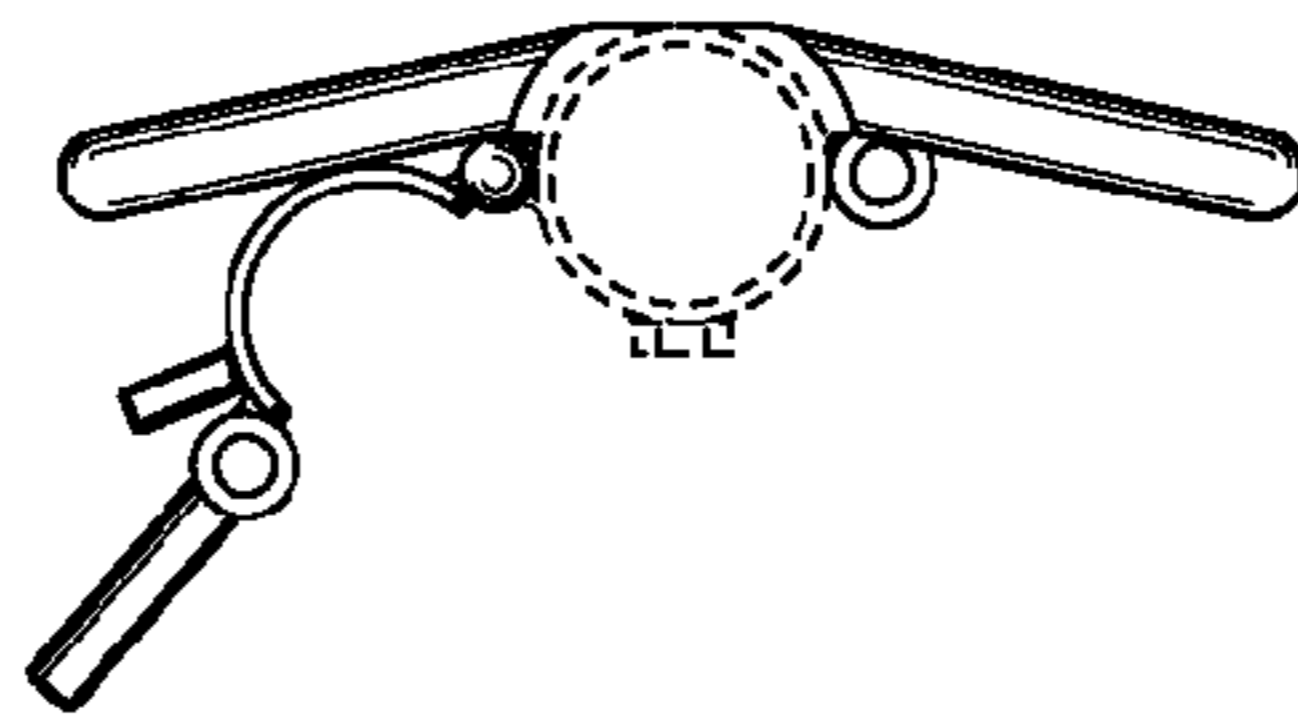

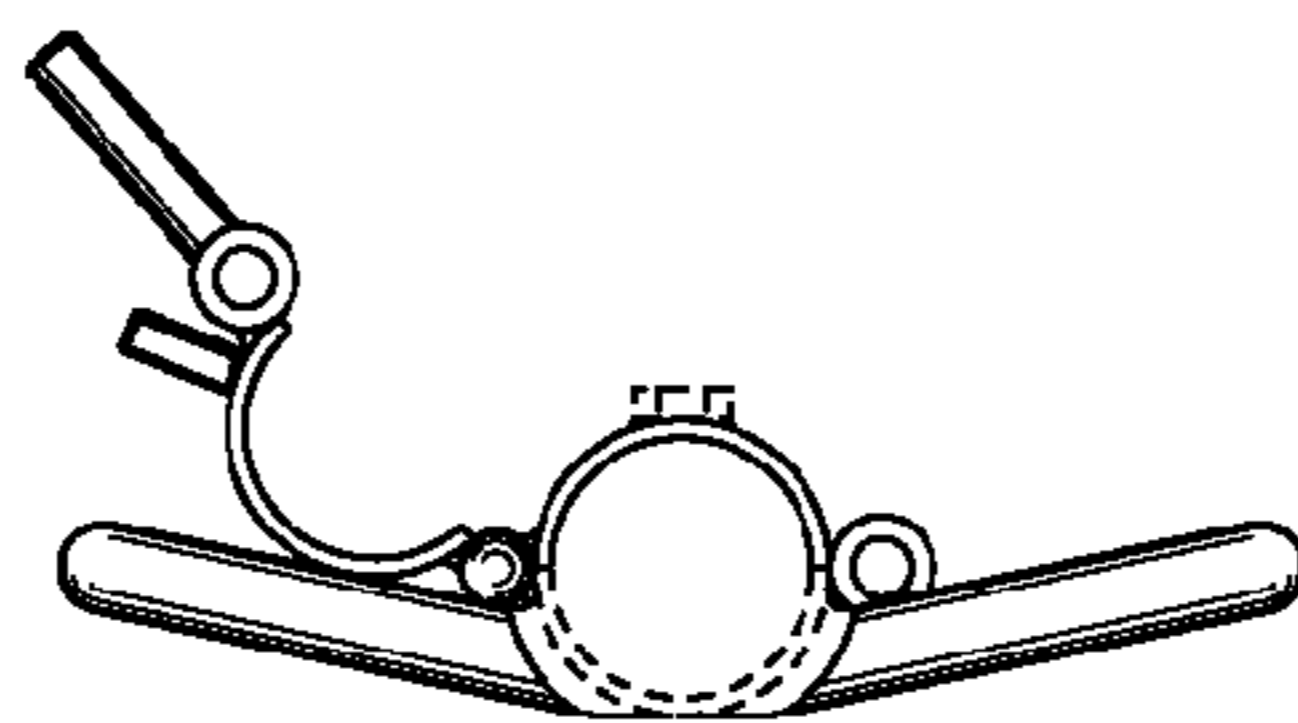
