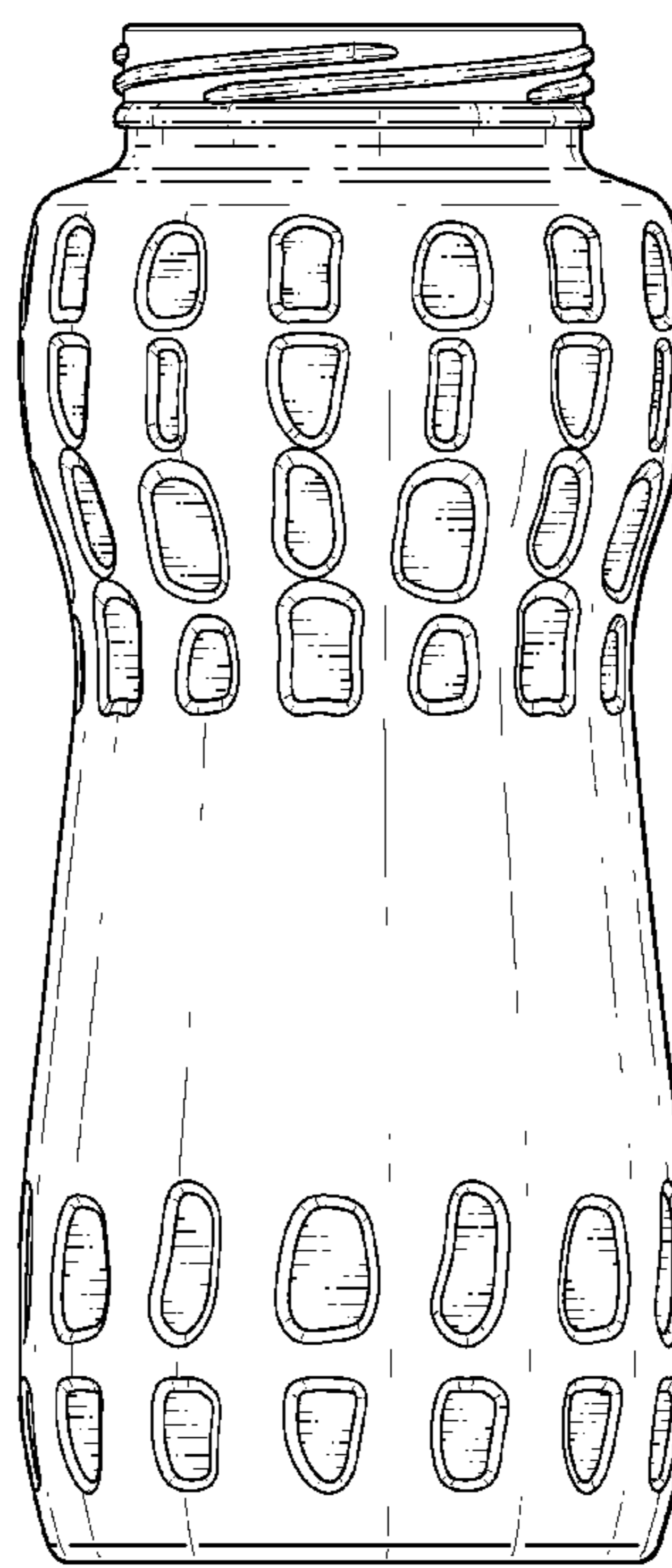
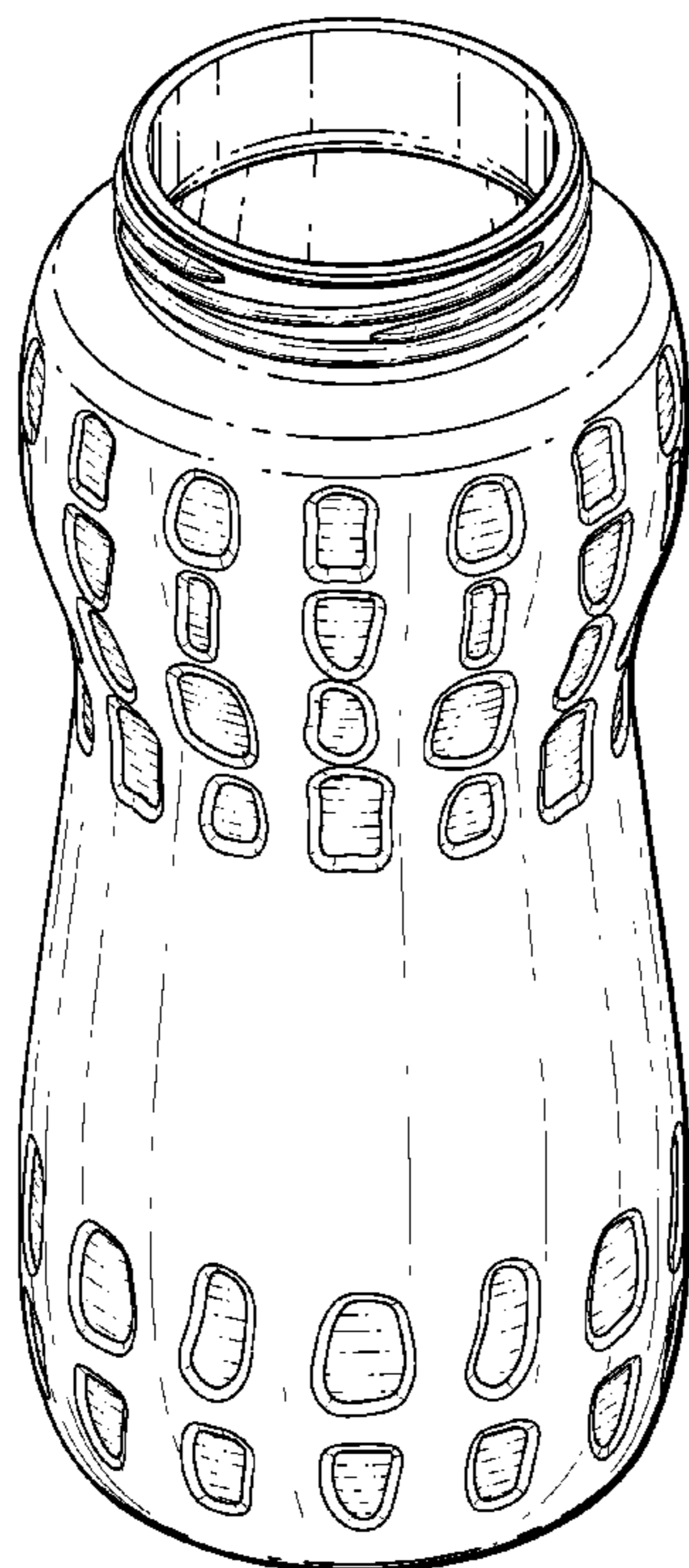
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a jar showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof; and,

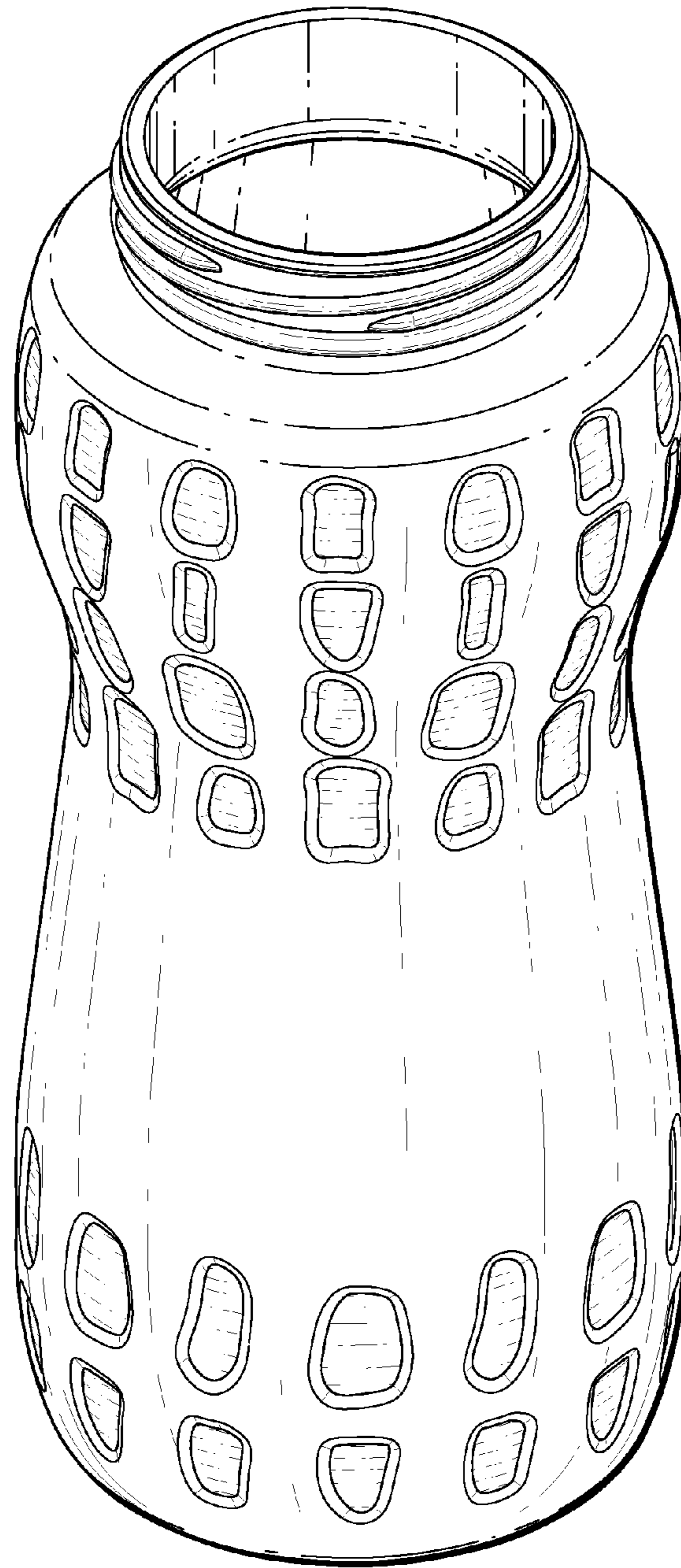

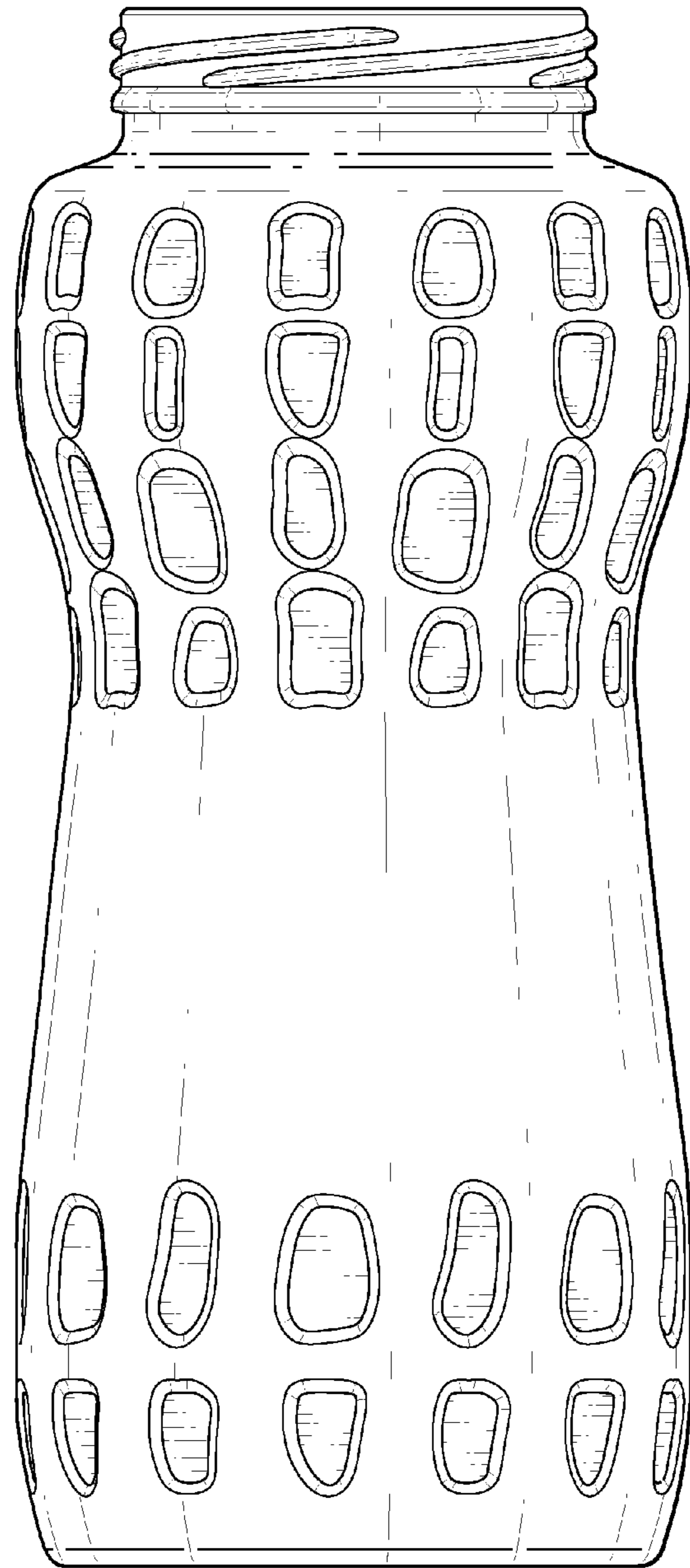

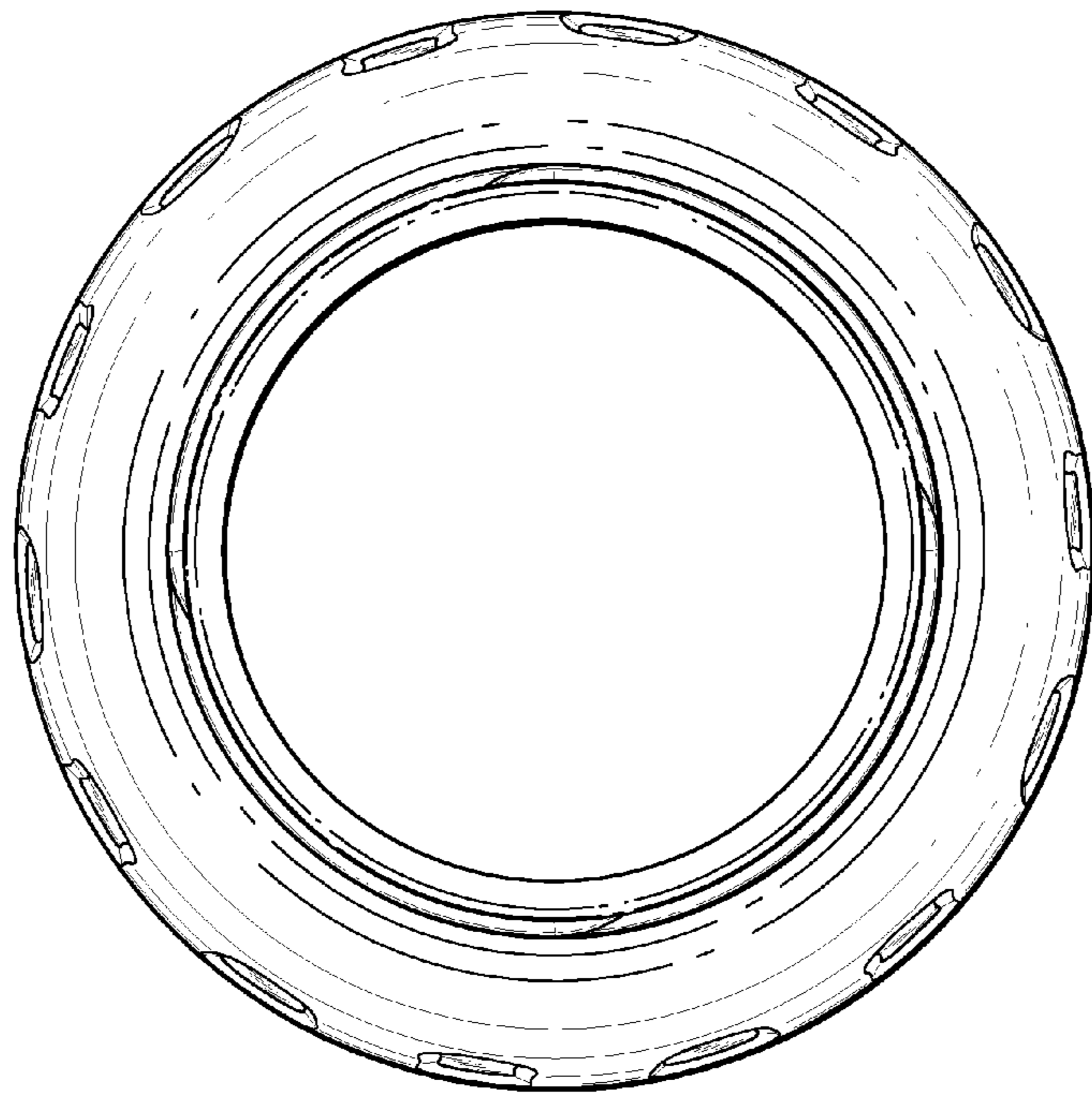

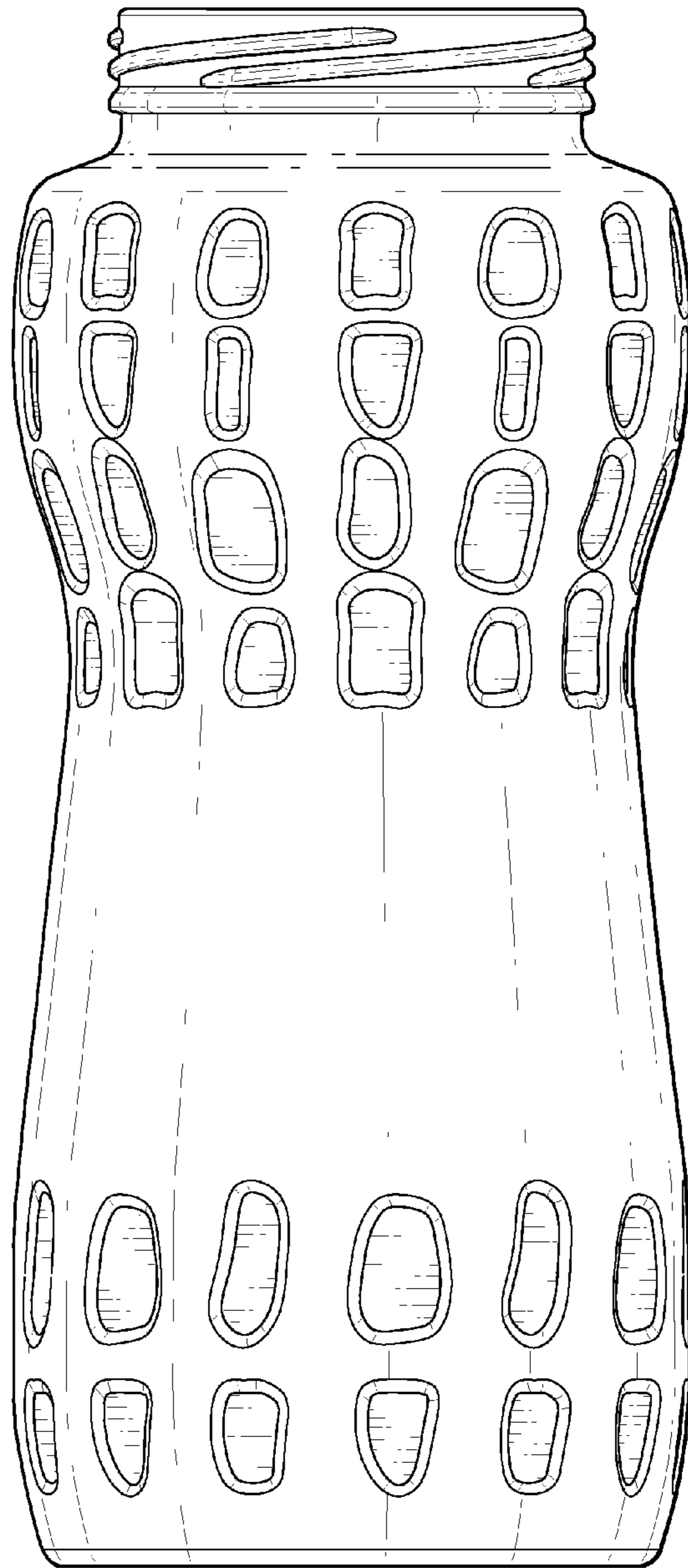

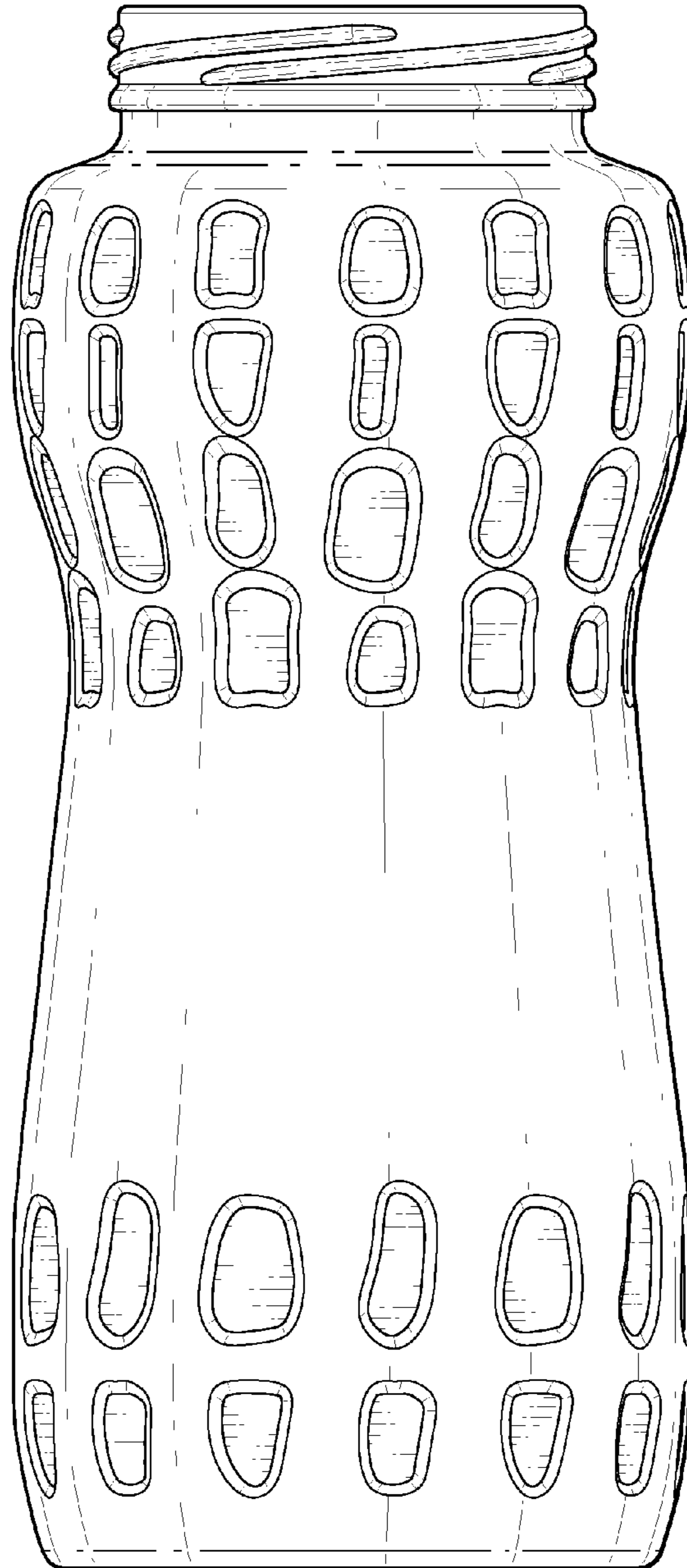

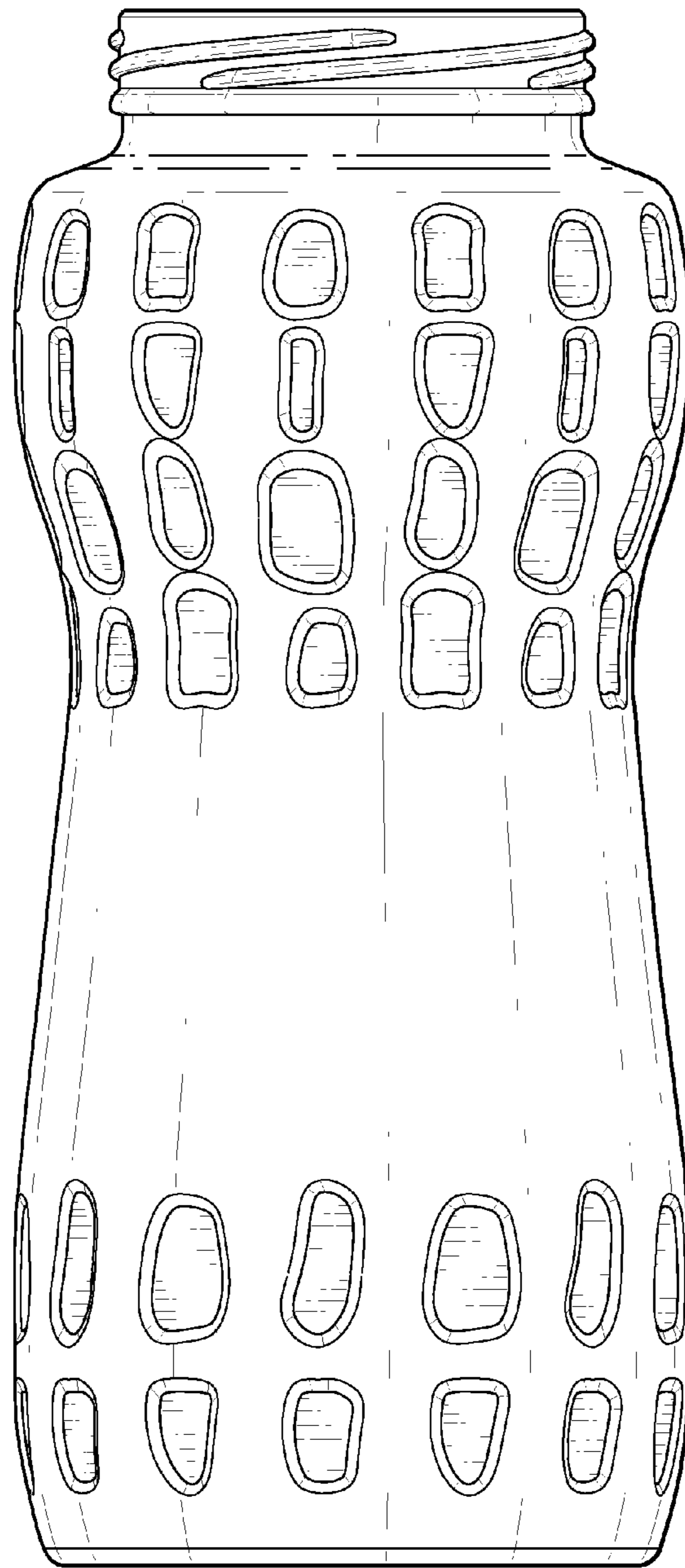
