(57) **CLAIM**

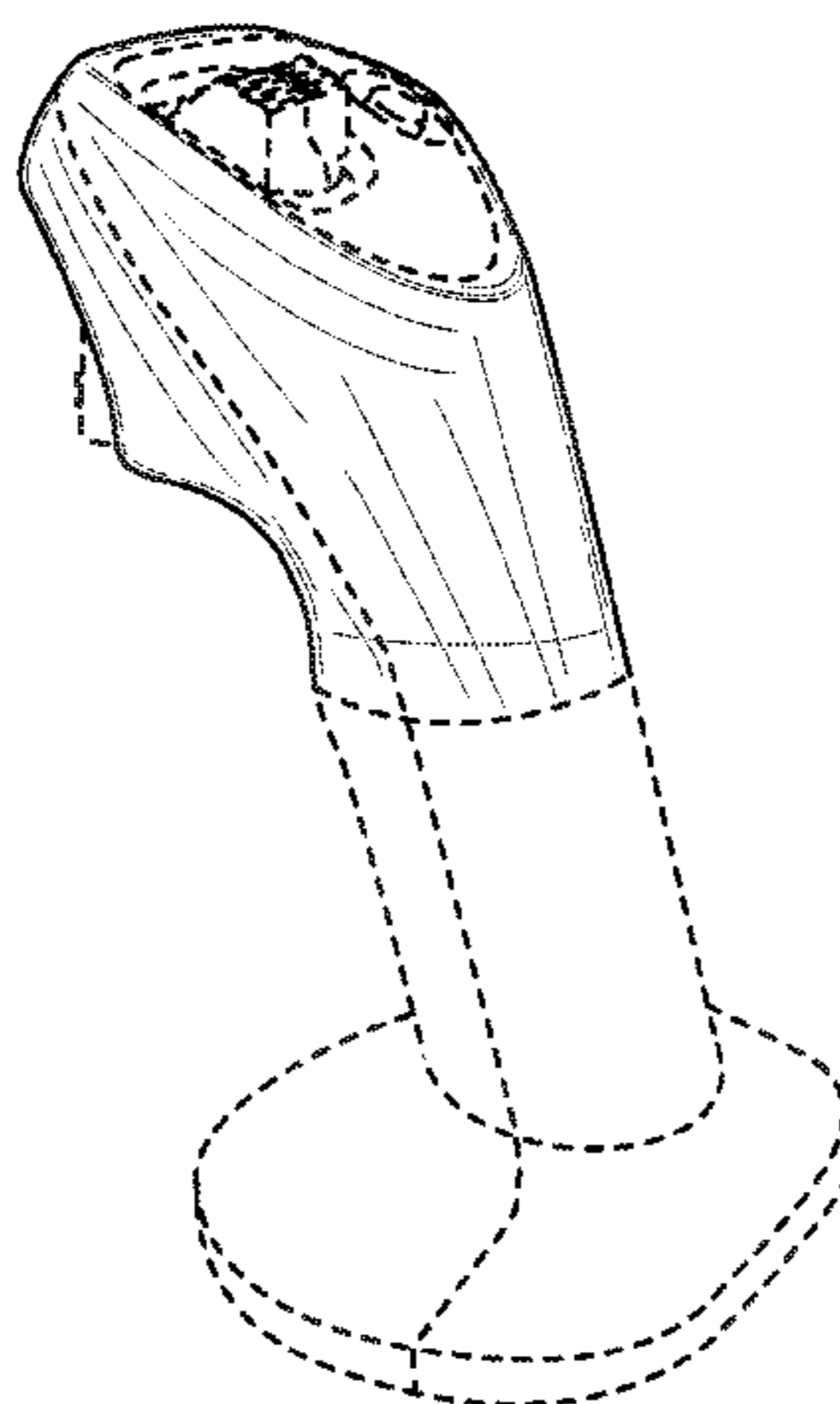
The ornamental design for a controller, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective, rear view of a first embodiment of a controller according to my design;  
FIG. 2 is a front view of the controller of FIG. 1;  
FIG. 3 is a rear view of the controller of FIG. 1;  
FIG. 4 is a left side view of the controller of FIG. 1;  
FIG. 5 is a right side view of the controller of FIG. 1;  
FIG. 6 is a top view of the controller of FIG. 1; and,  
FIG. 7 is a bottom view of the controller of FIG. 1.

Broken lines are included in various figures of the drawings to denote aspects of the controller that form no part of the claimed design and to delimit the unclaimed boundaries of various surfaces that form part of the claimed design. 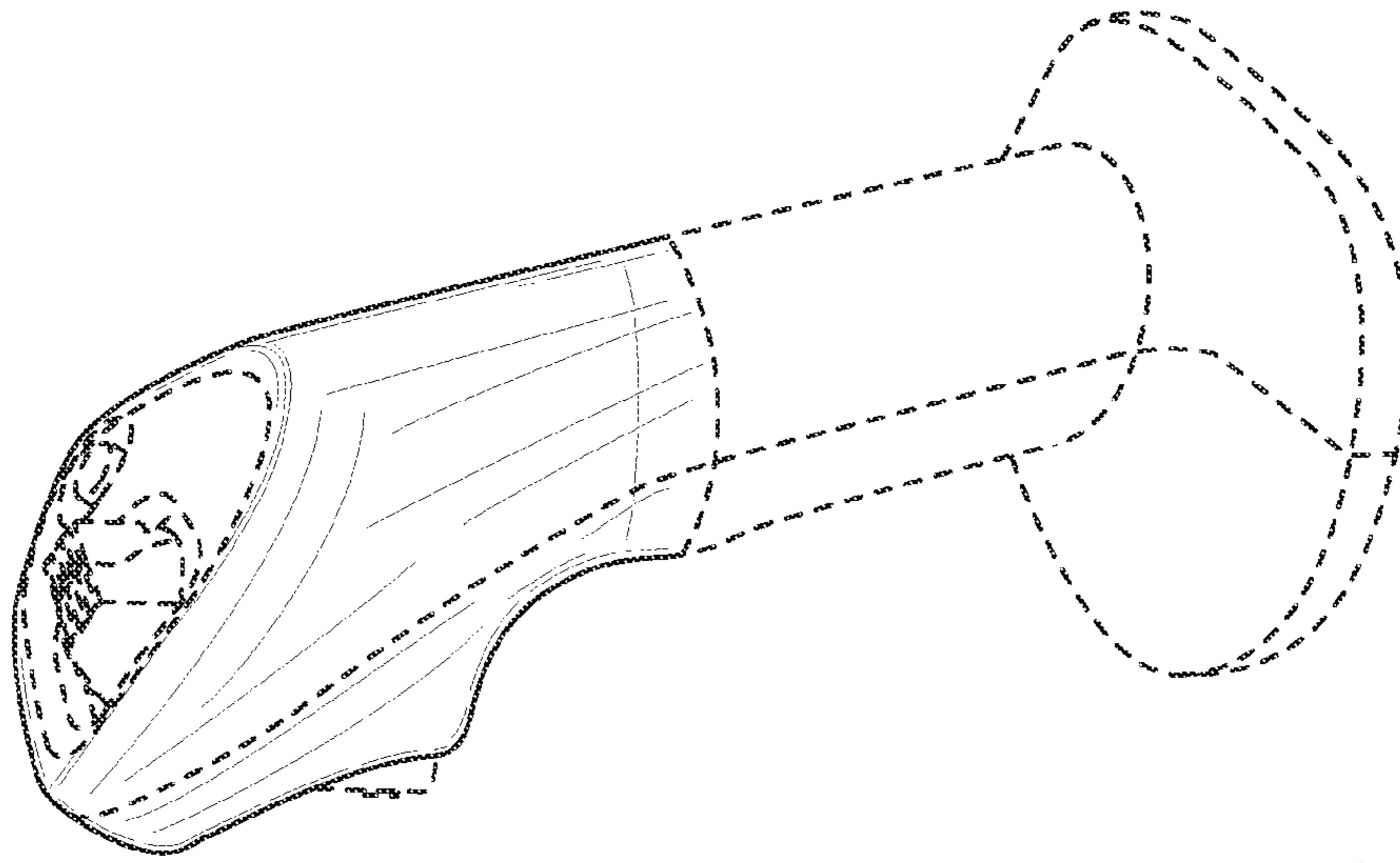

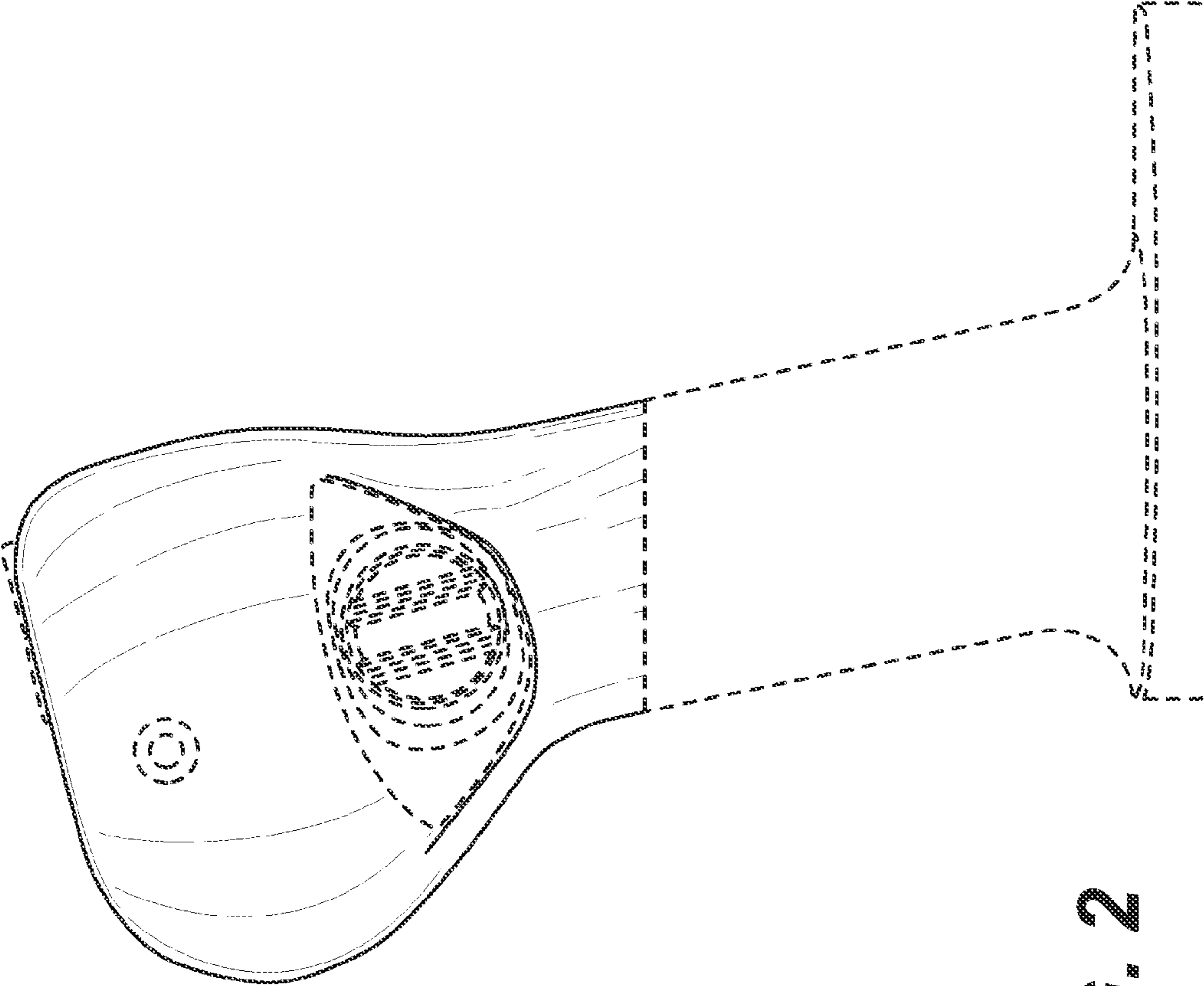

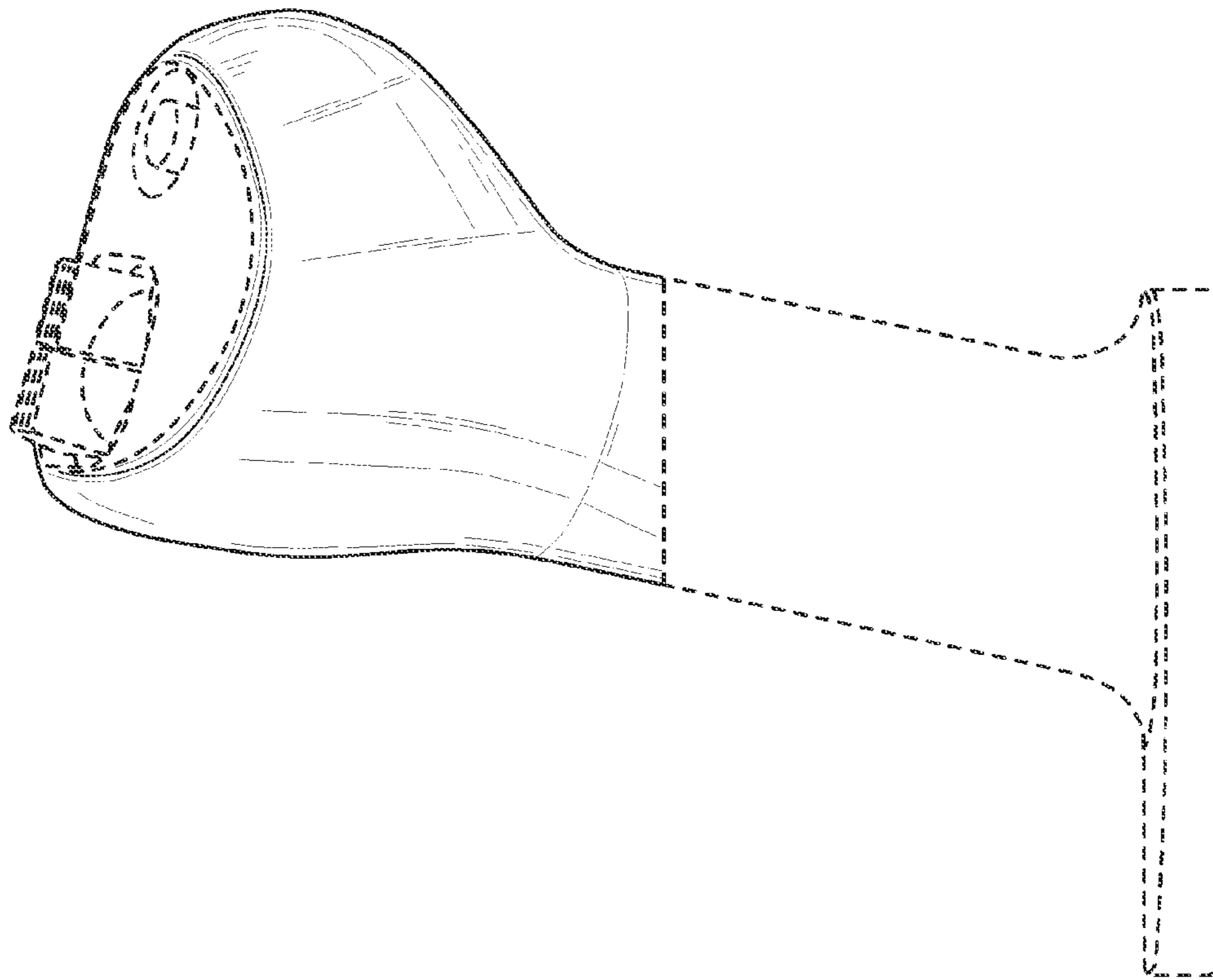

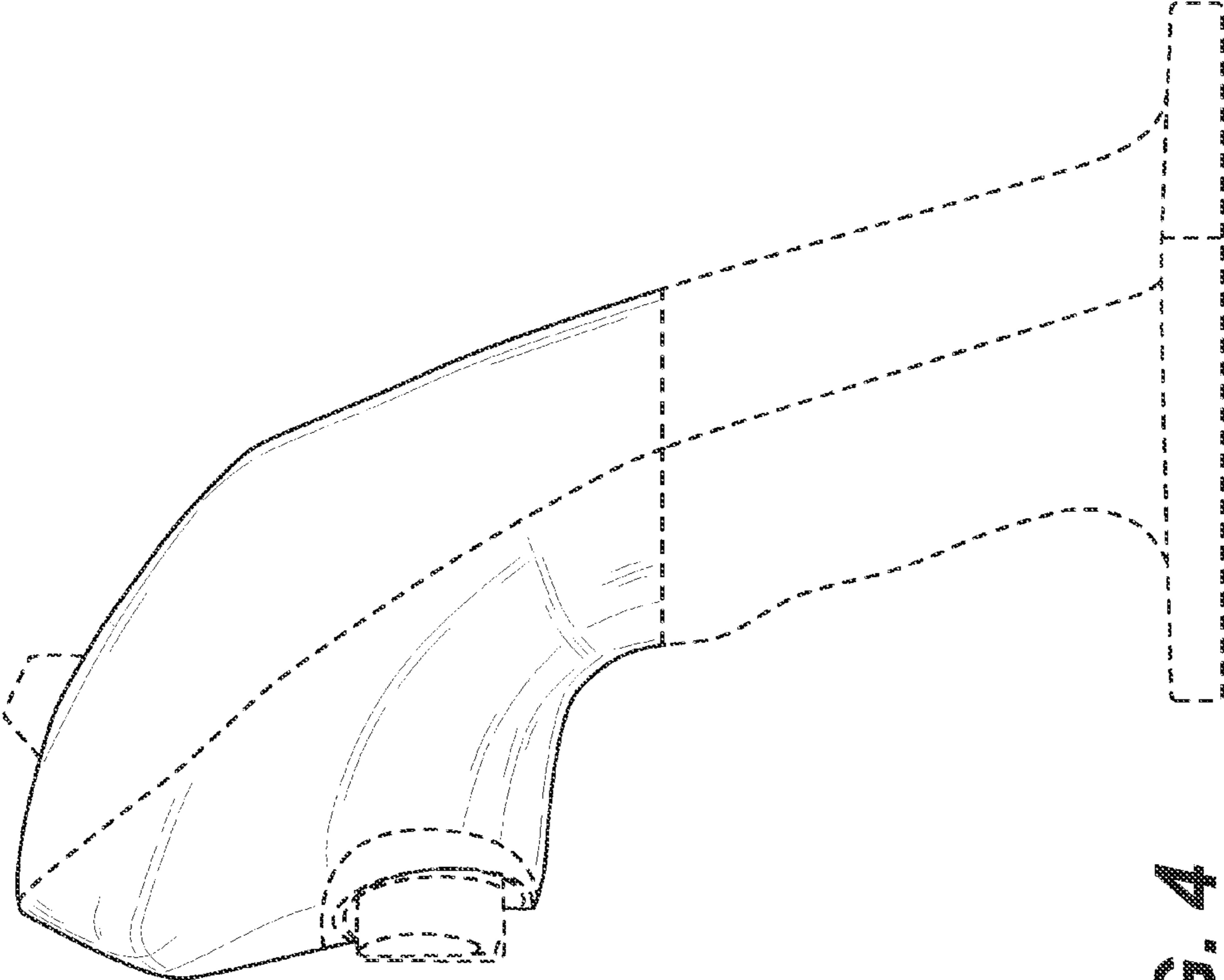

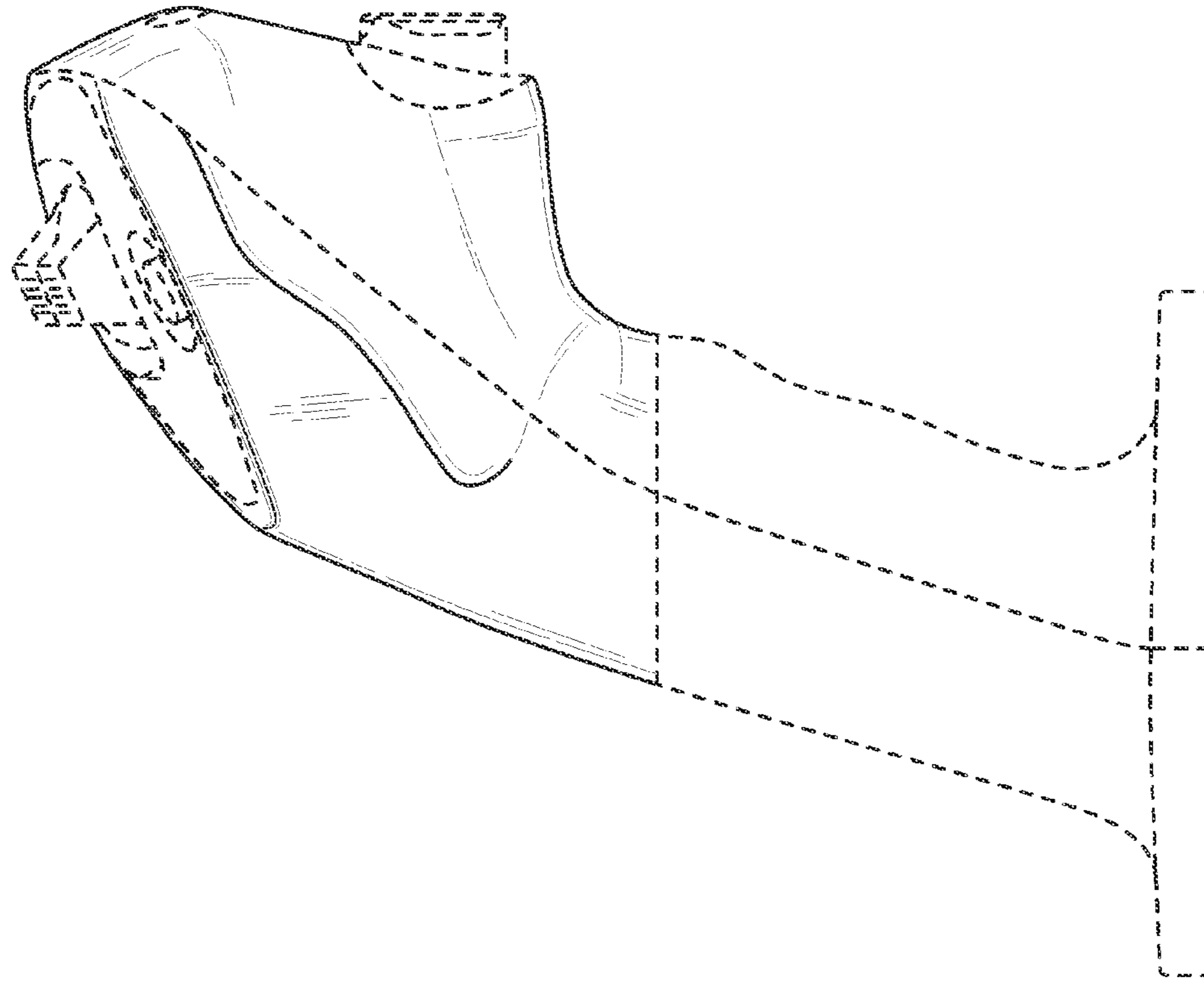

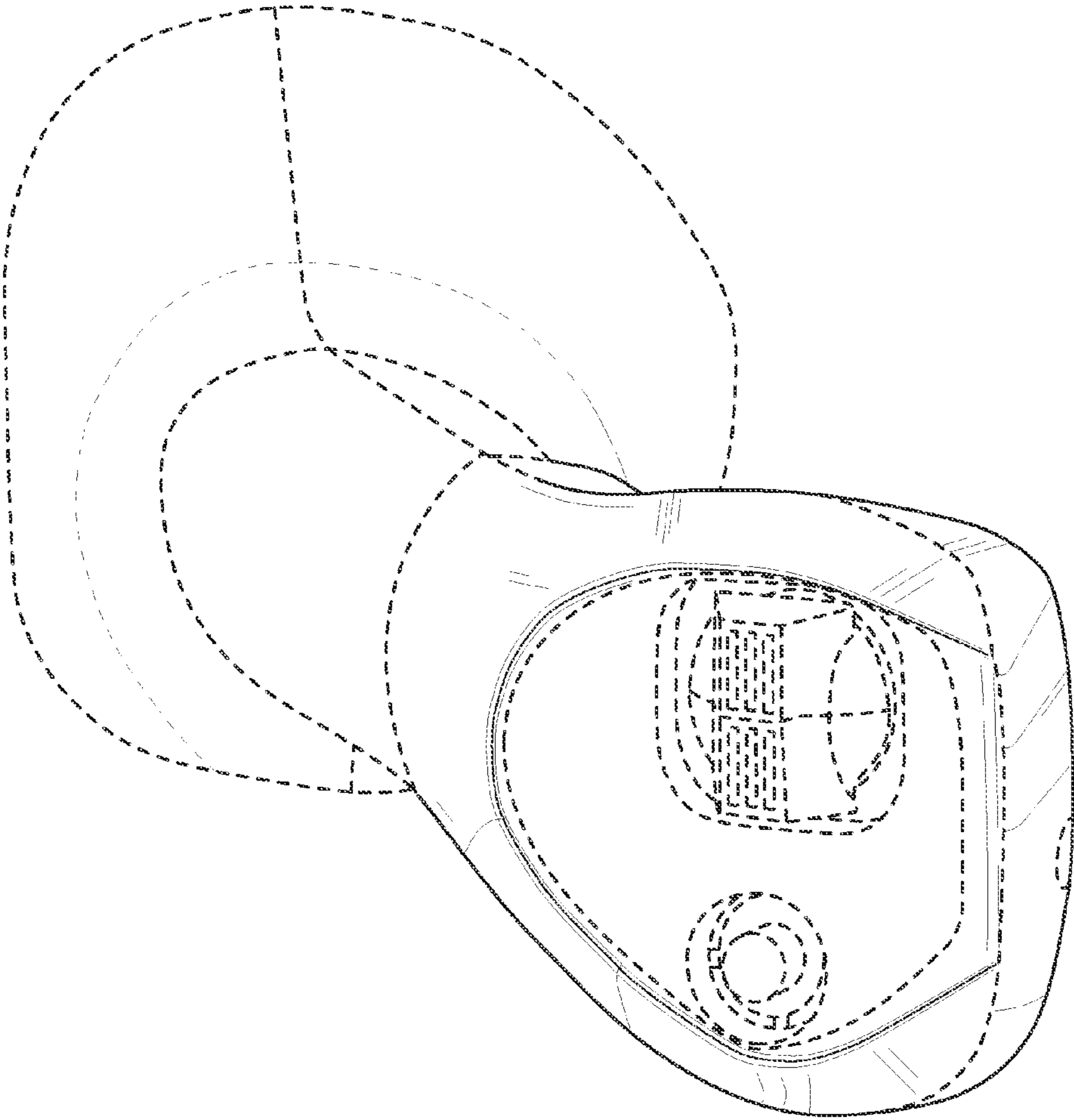

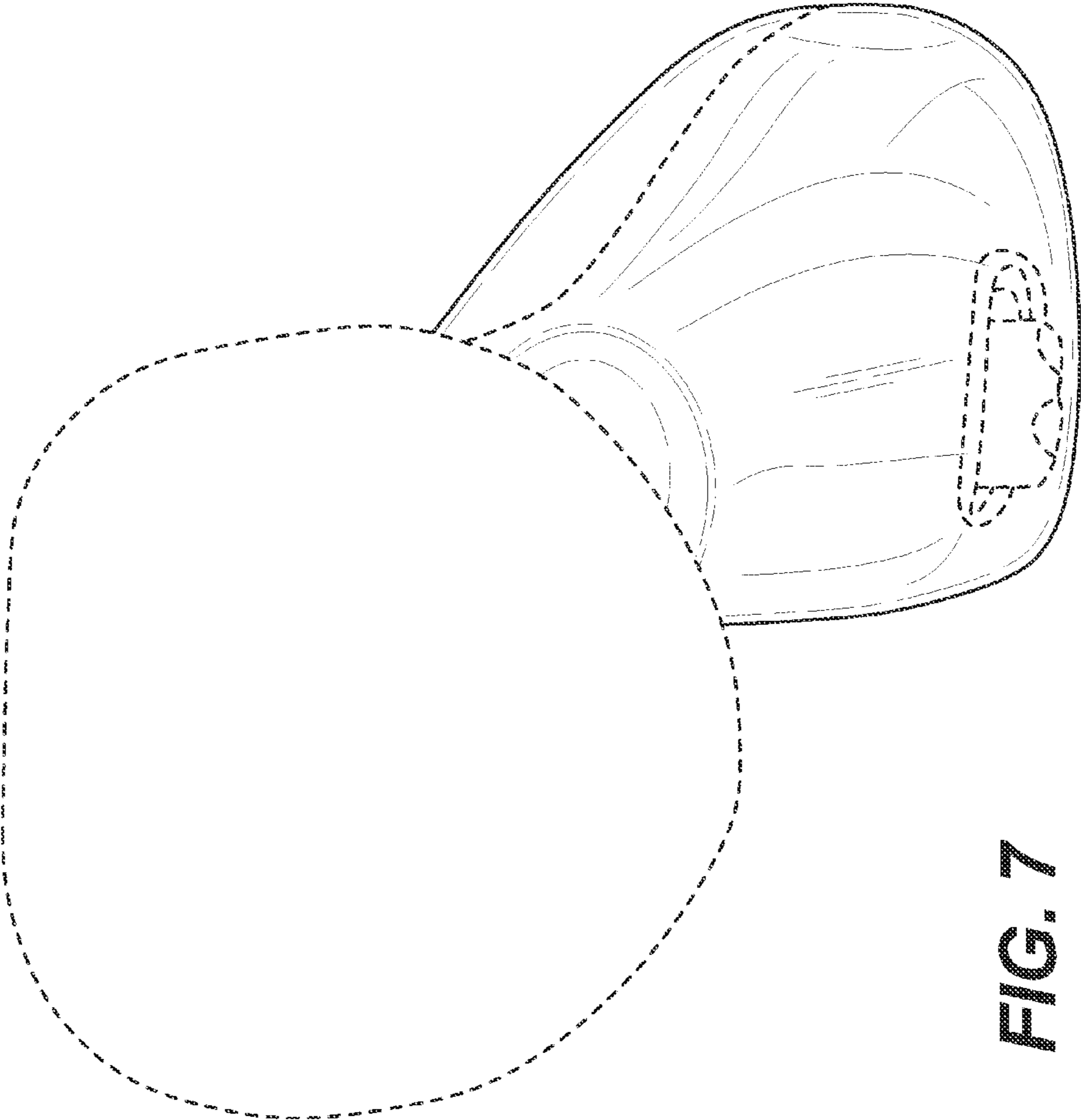
