I claim the ornamental design for an inverter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an inverter showing my new design;

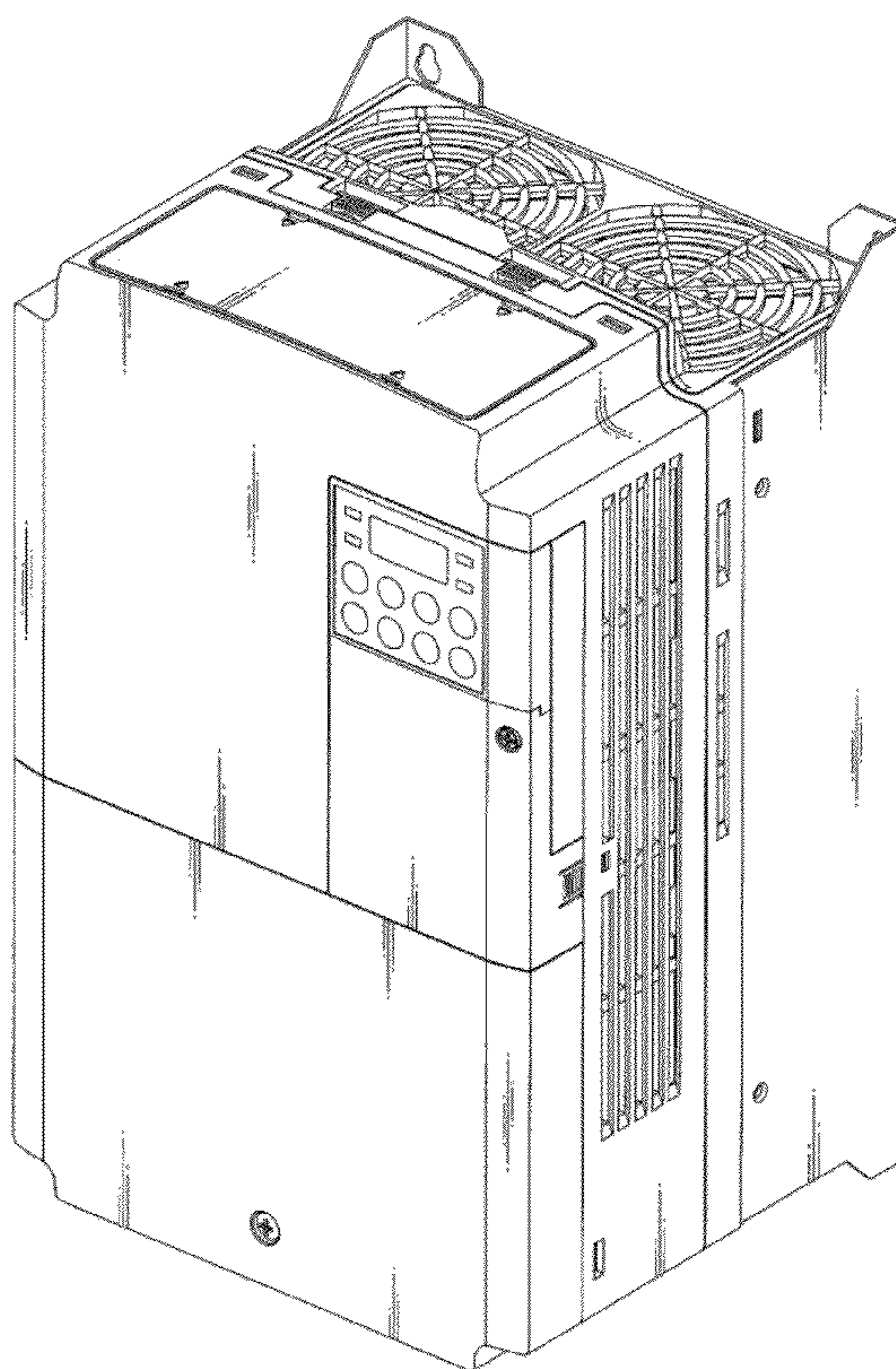

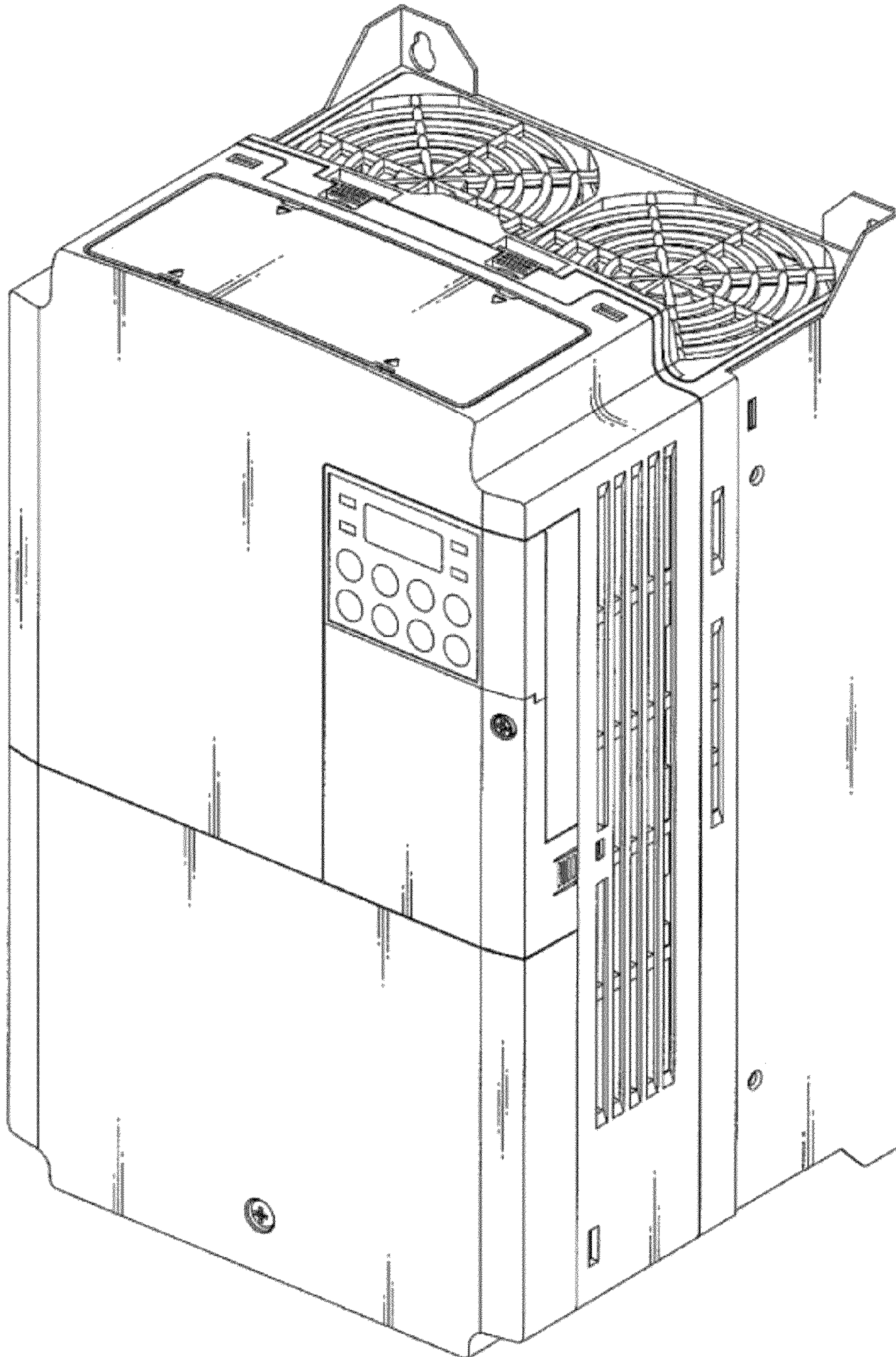

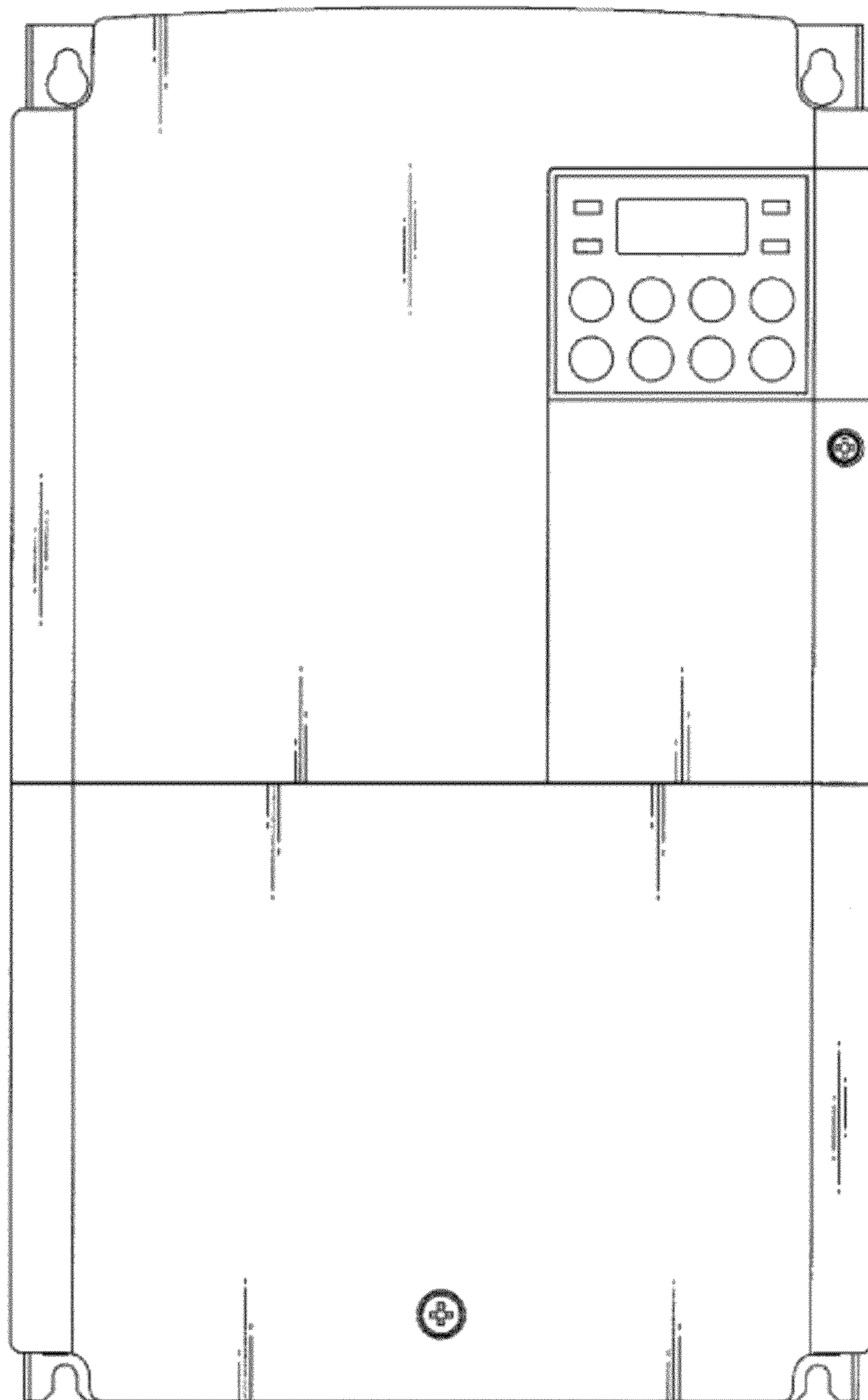

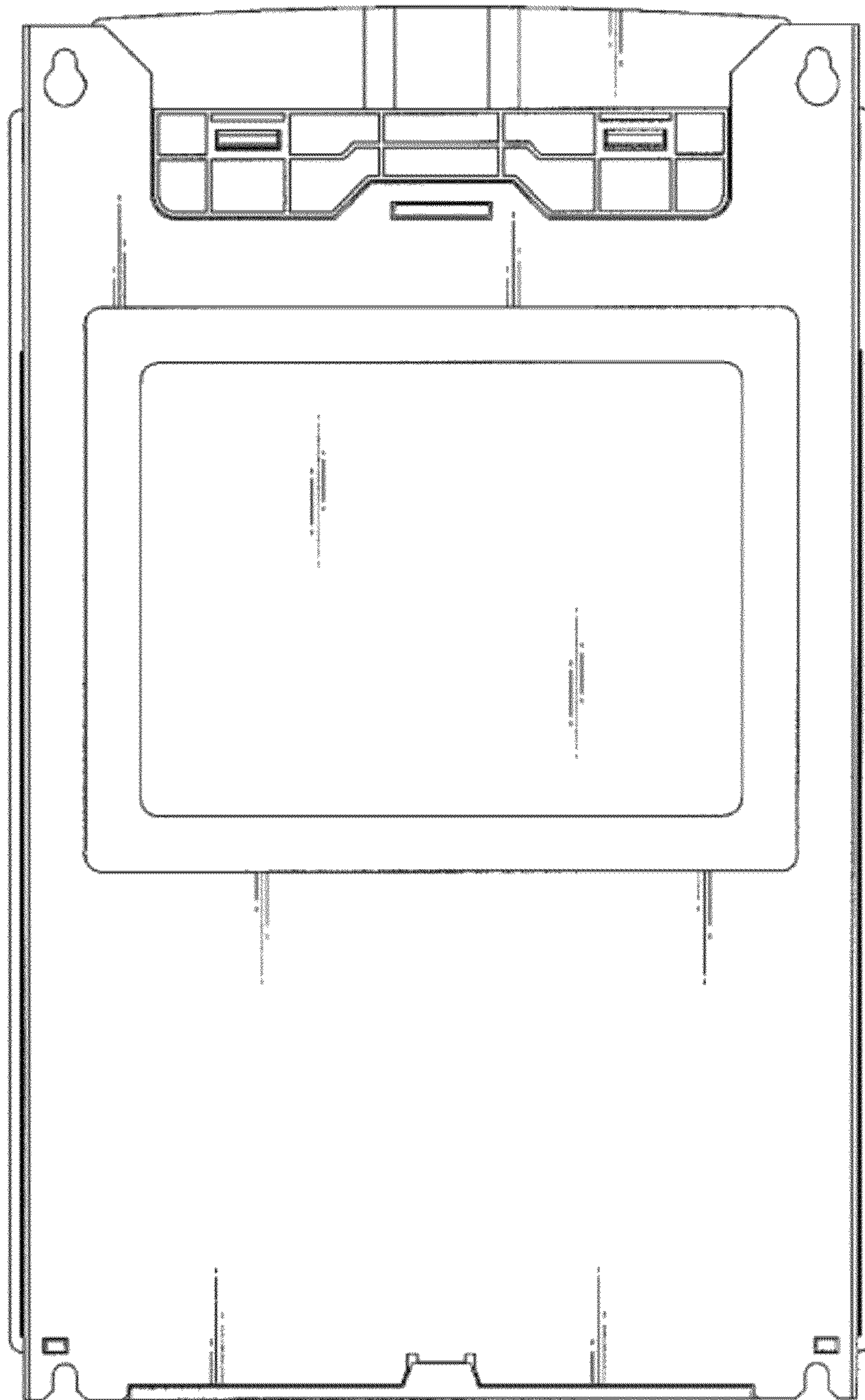

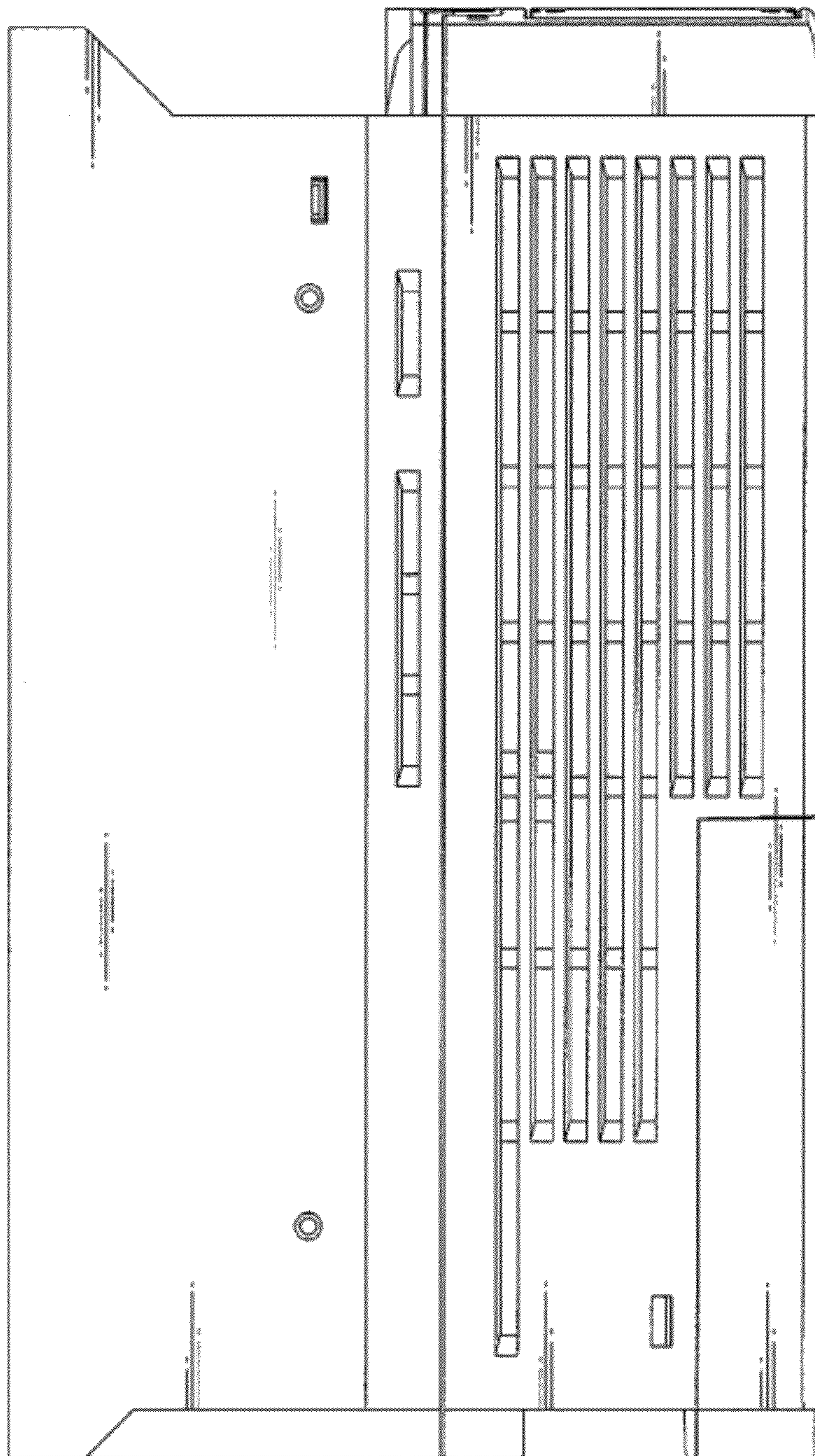

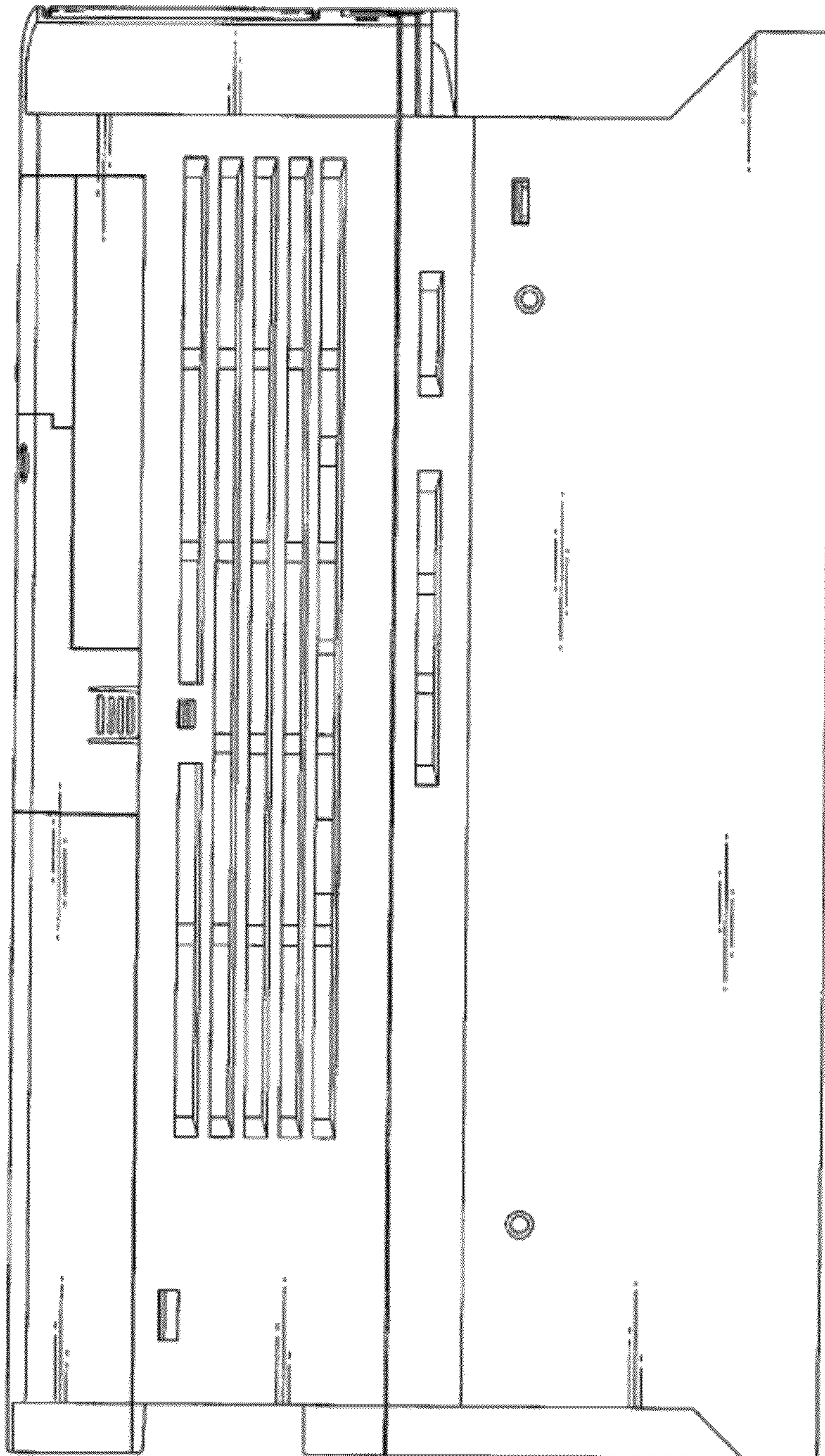

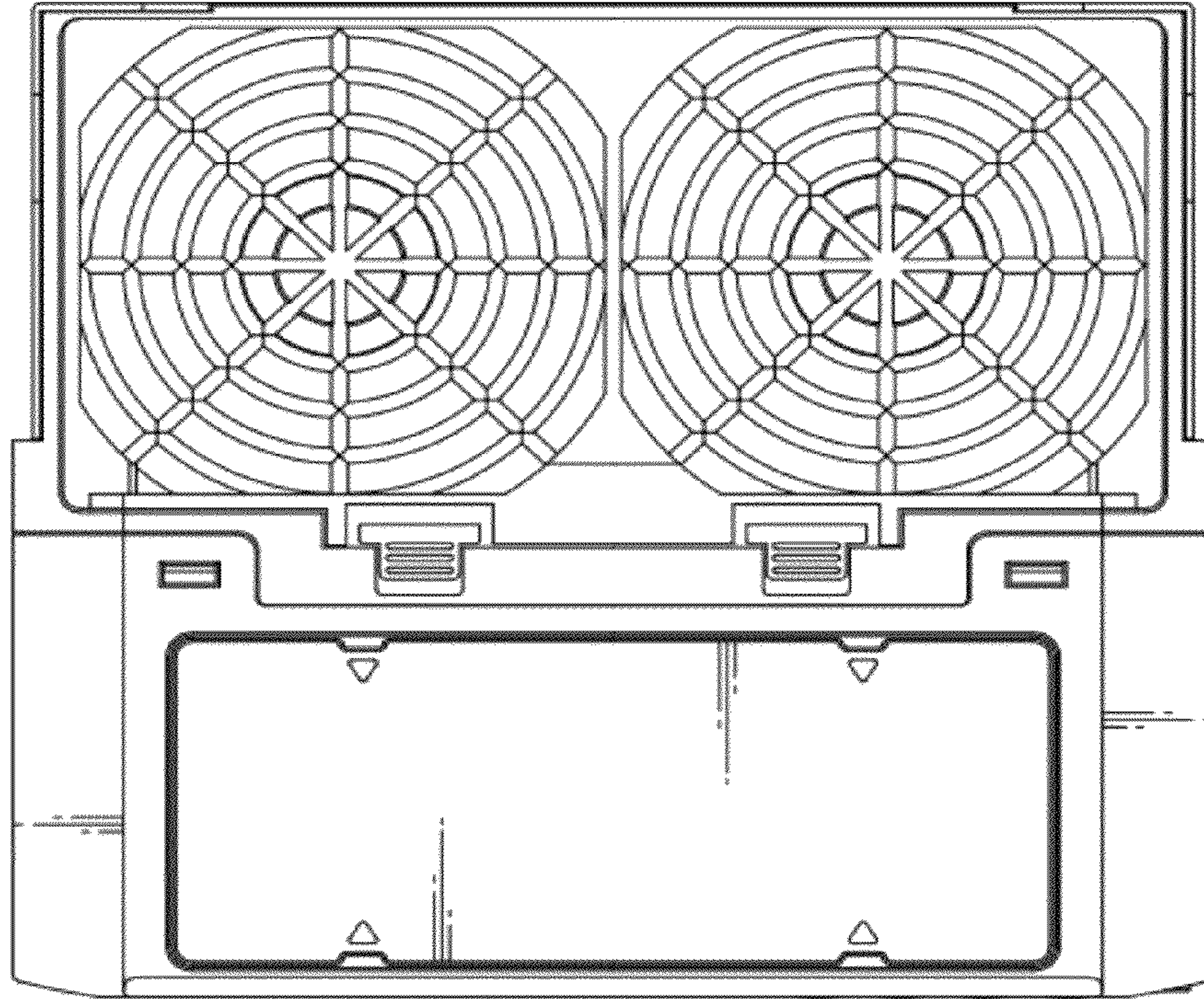
