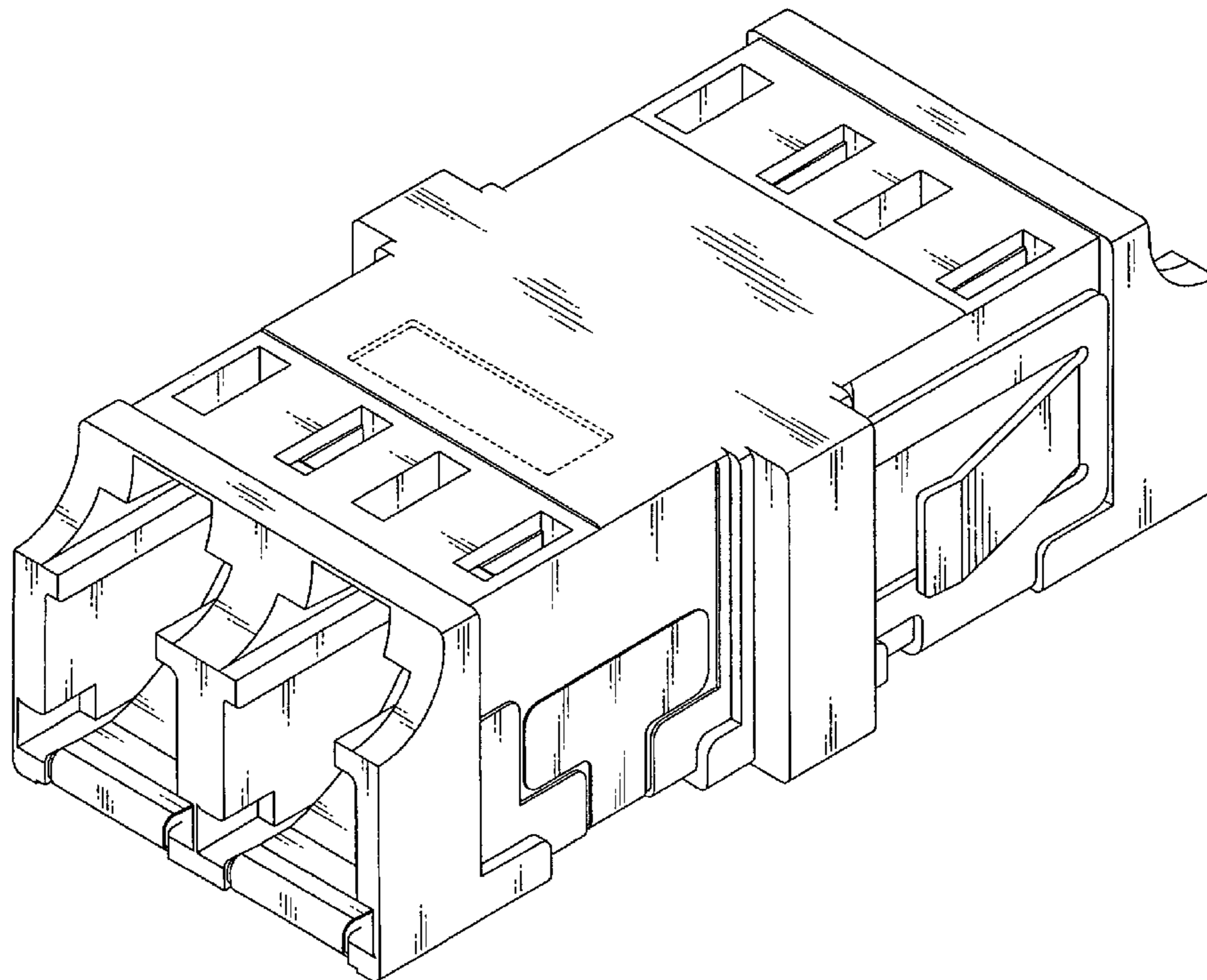
(57) **CLAIM**

The ornamental design for an optical fiber adaptor with shutter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of front, top plan and right side of an optical fiber adaptor with shutter showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a cross sectional view at 8-8 shown in FIG. 4 thereof. The line portion in the figure drawings is included for the purpose of illustrating environment and forms no part of the claimed design.

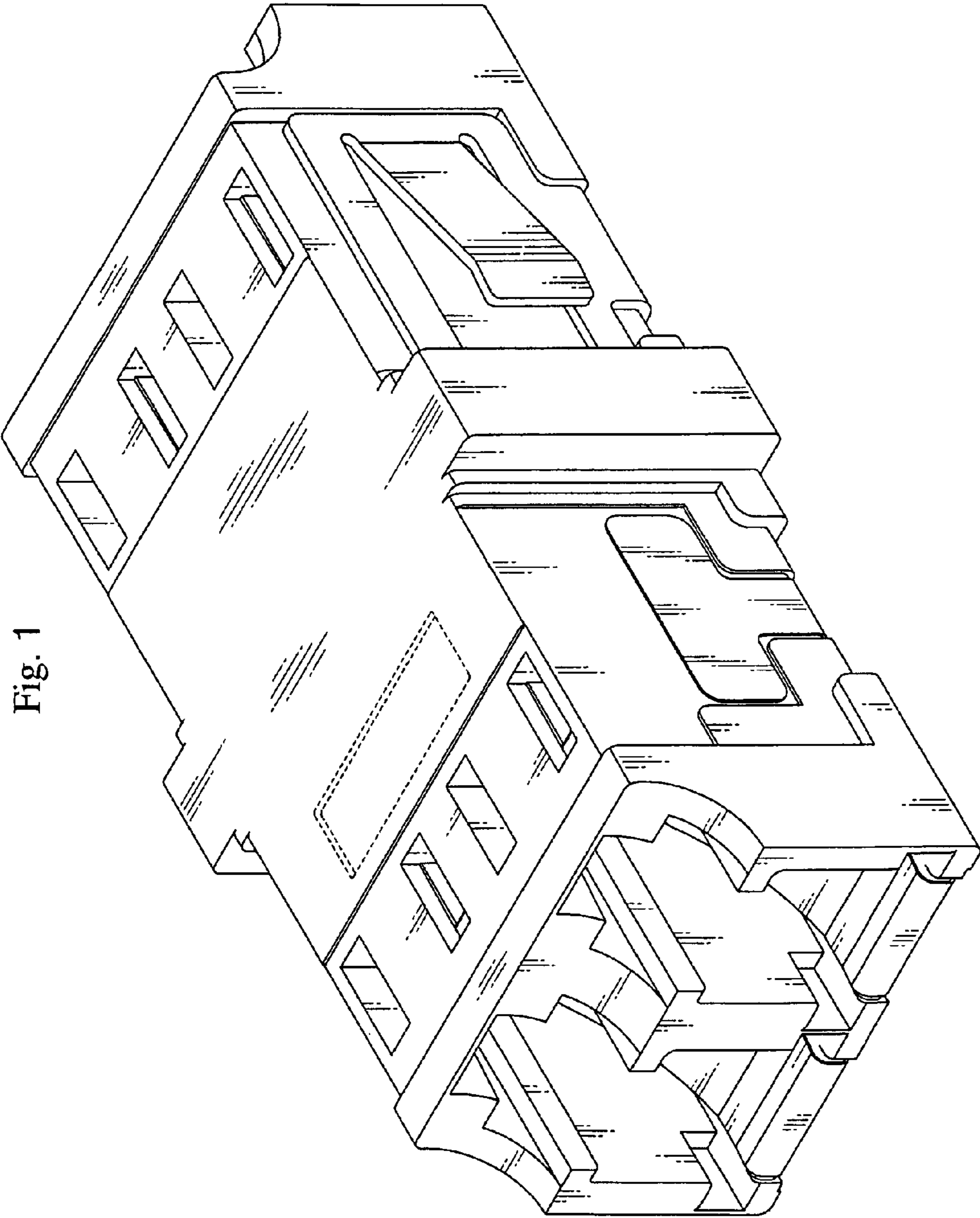

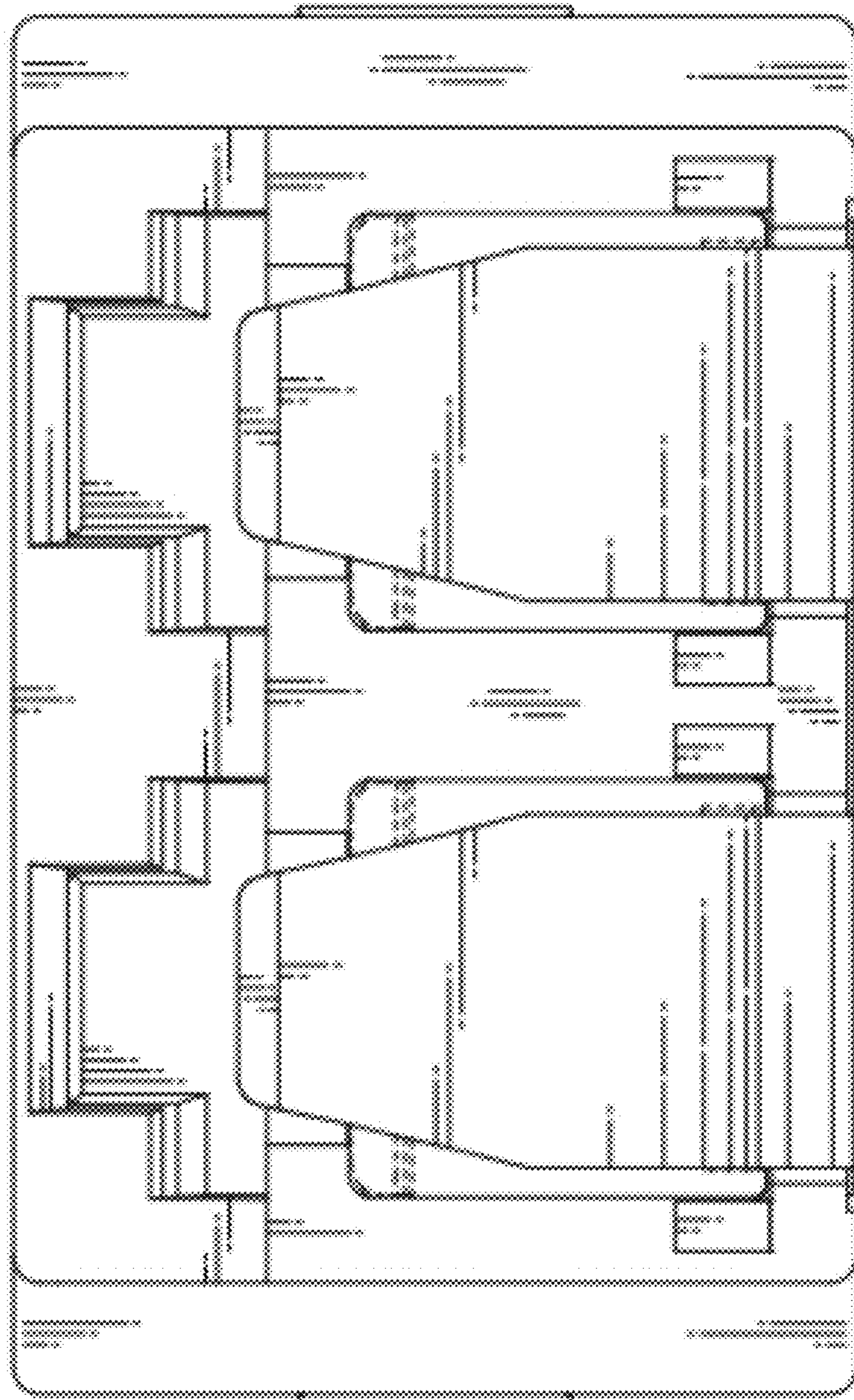

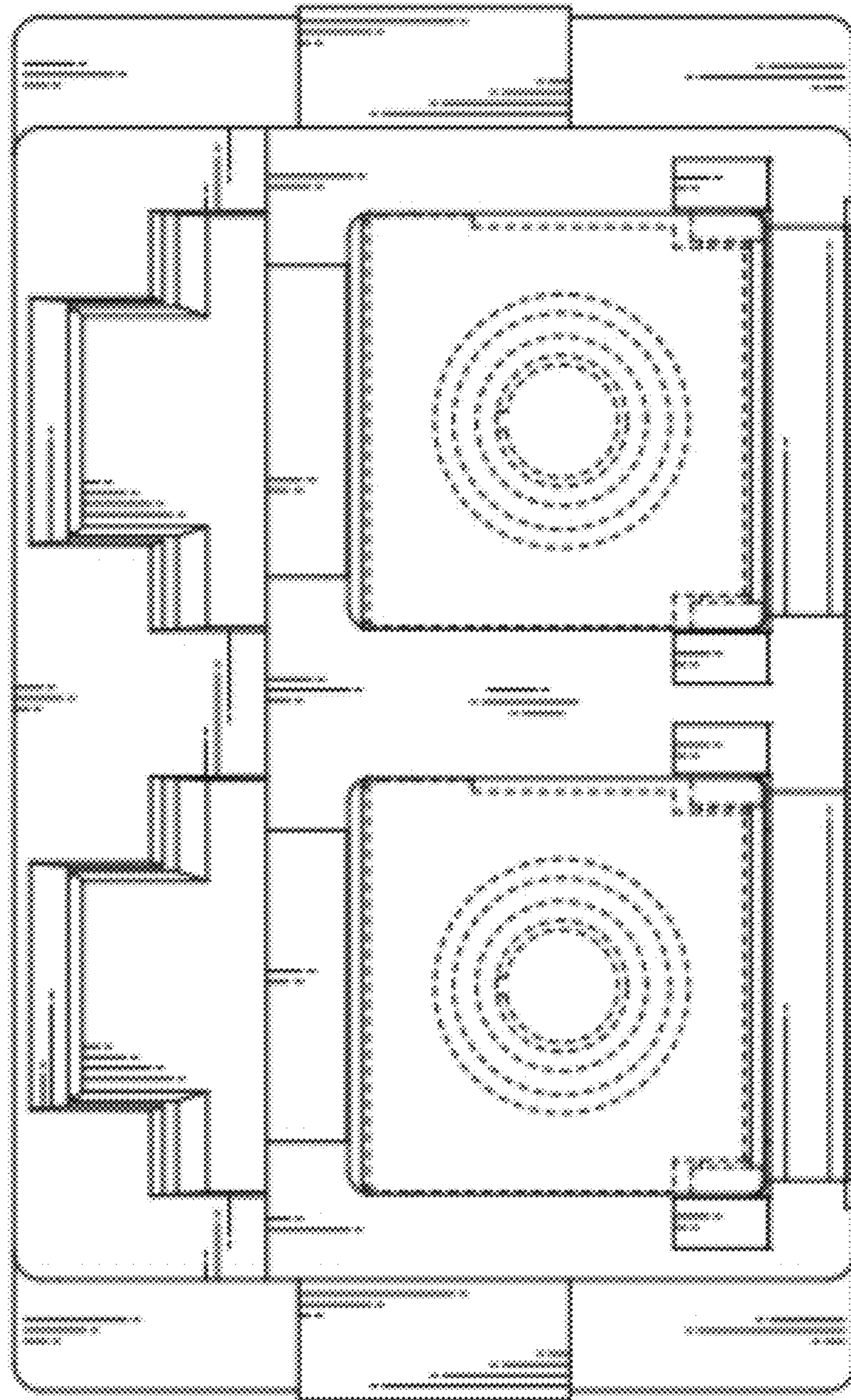

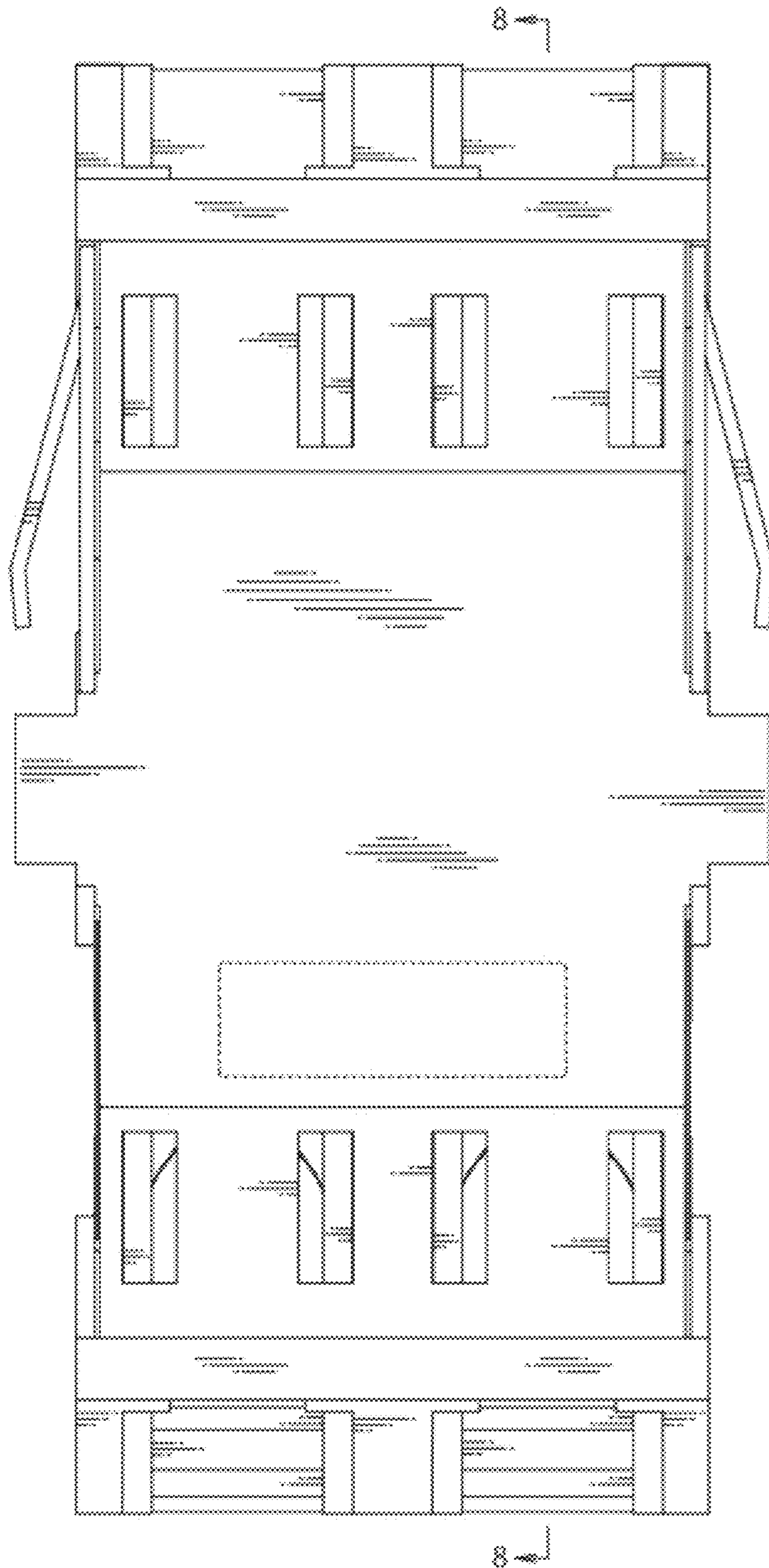

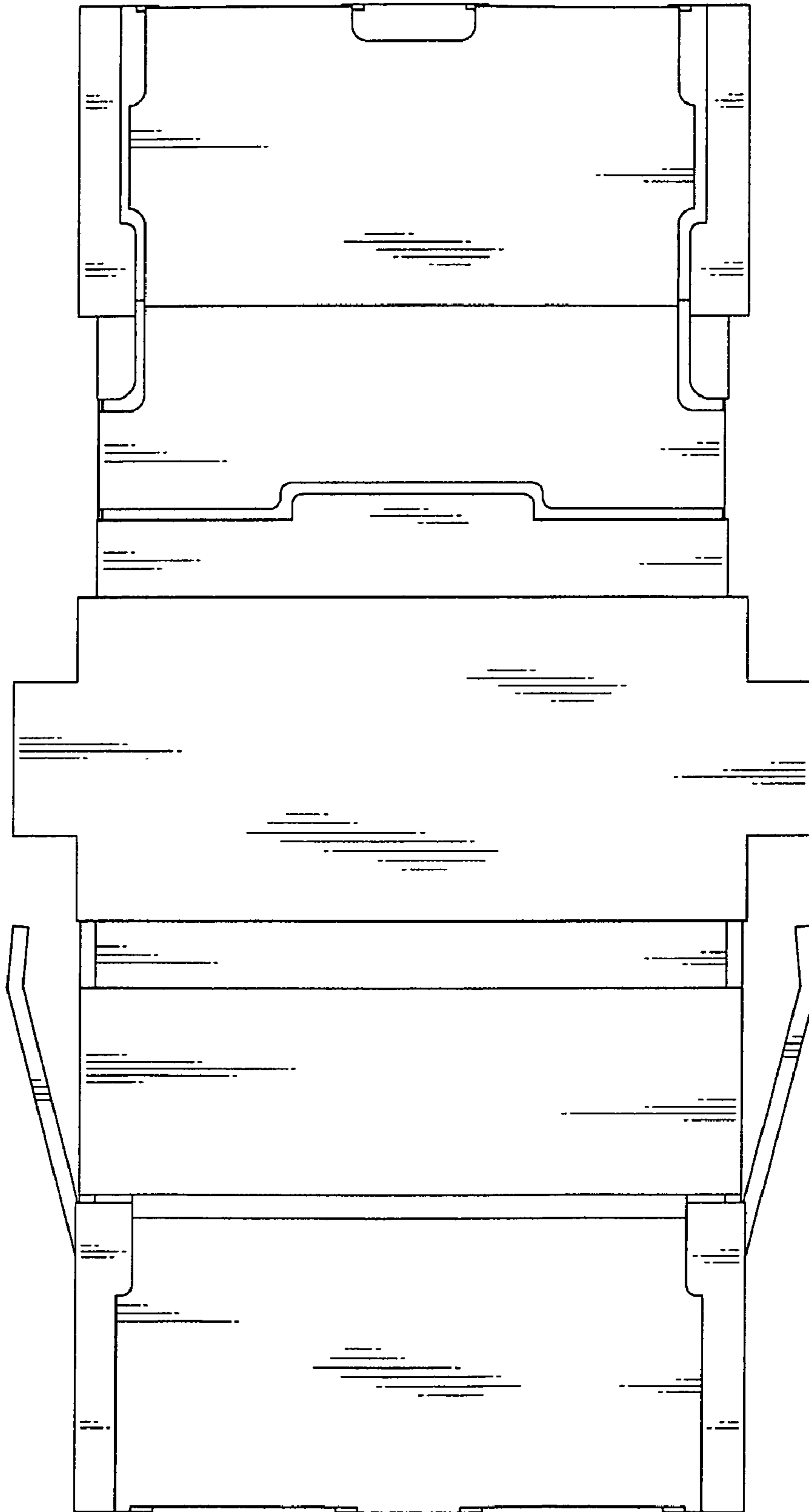

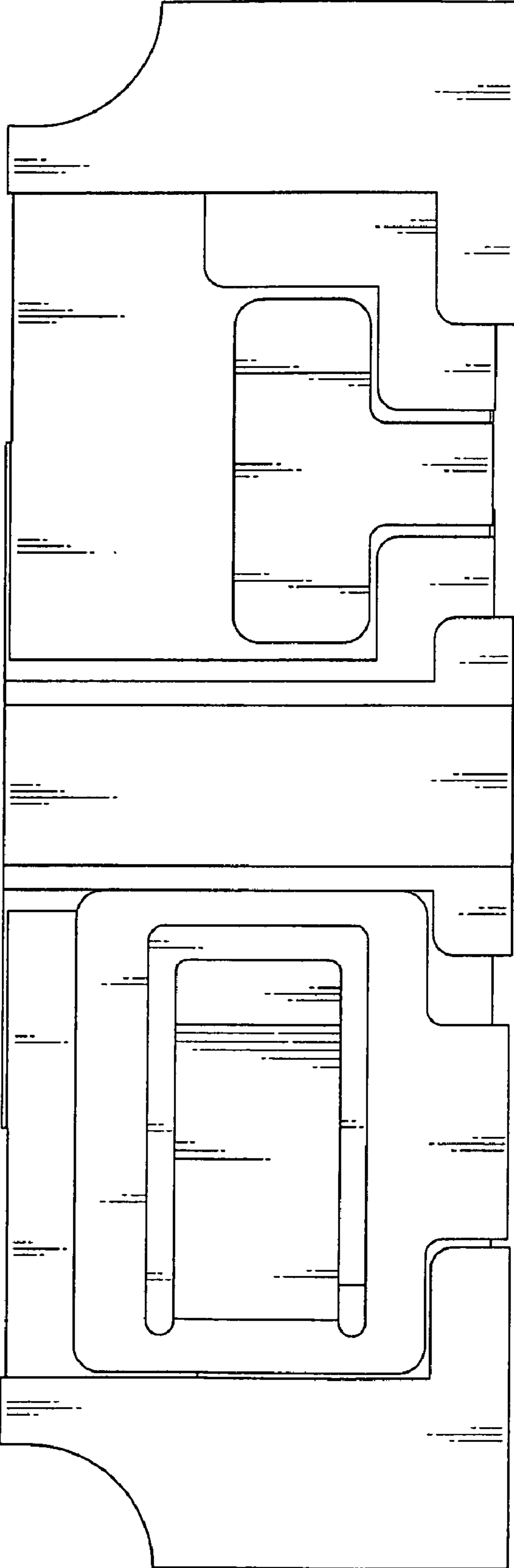

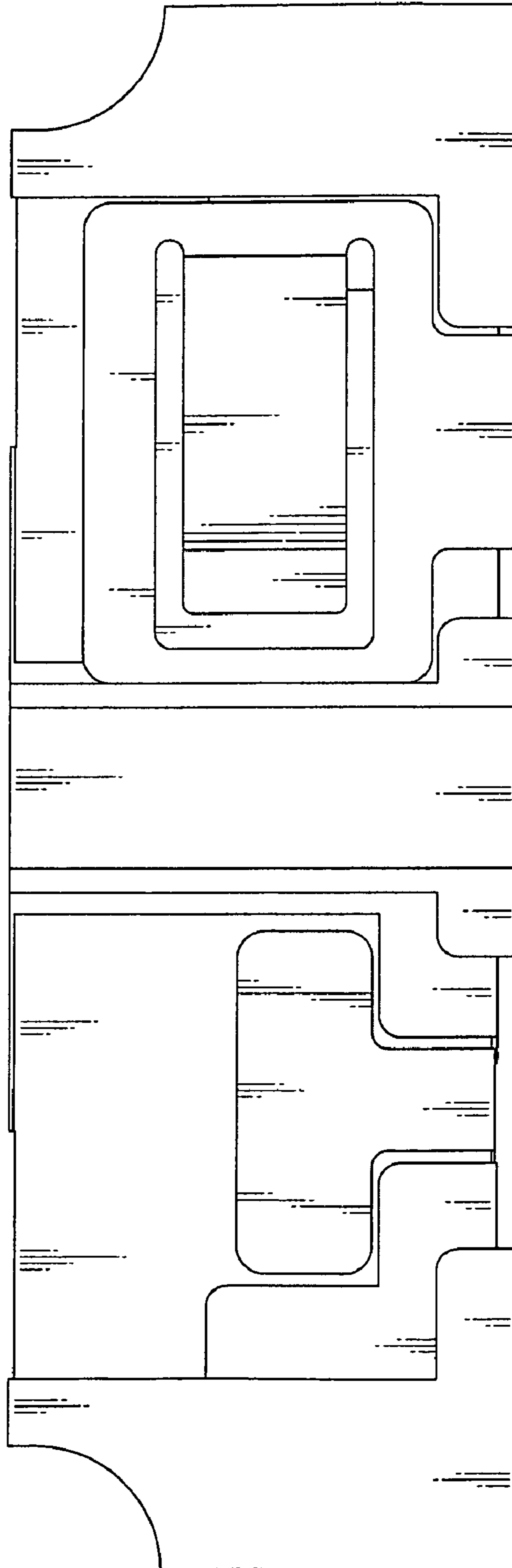
