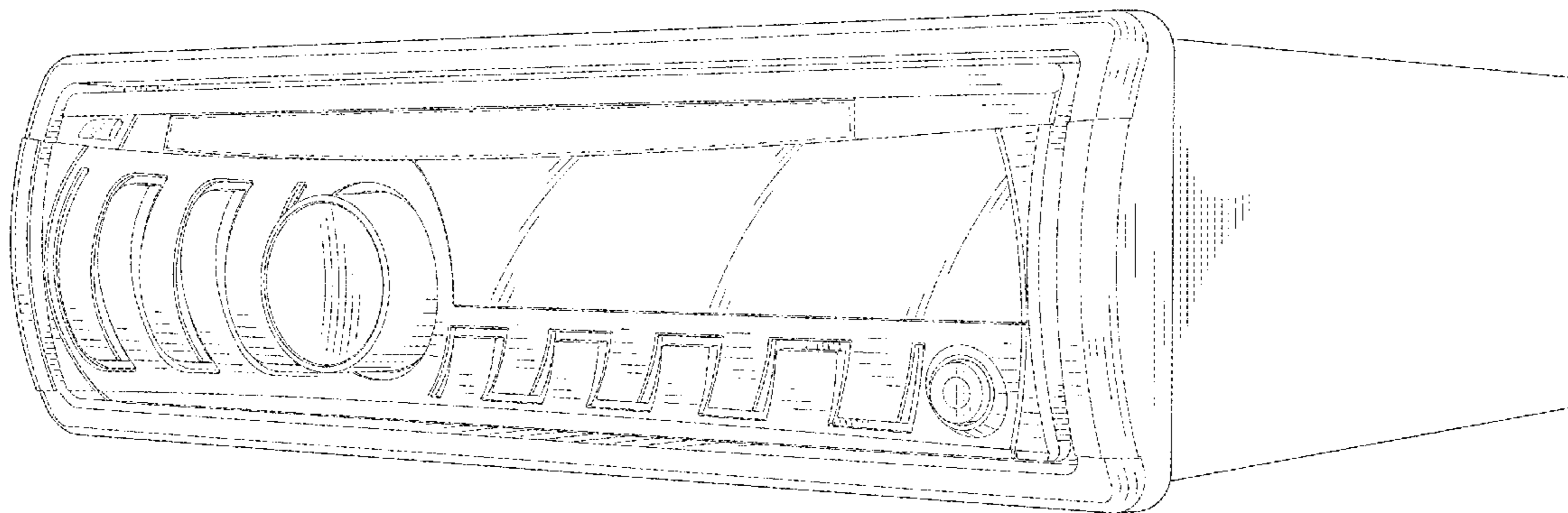
The ornamental design for an audio head unit, as shown and described.

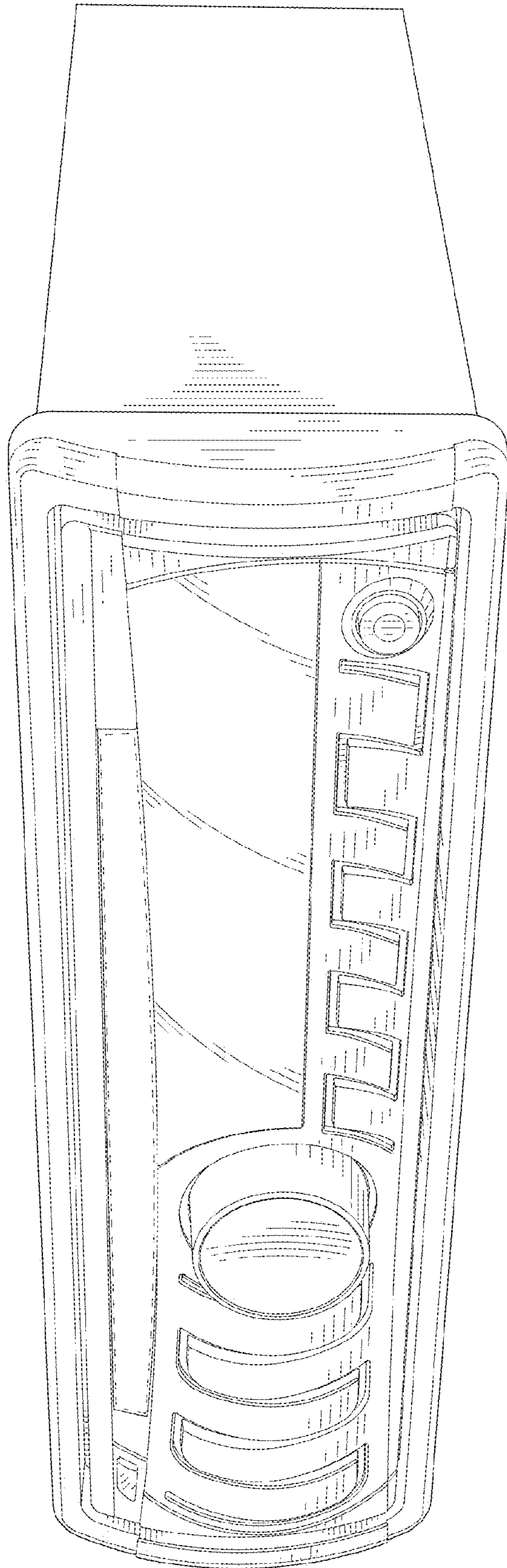

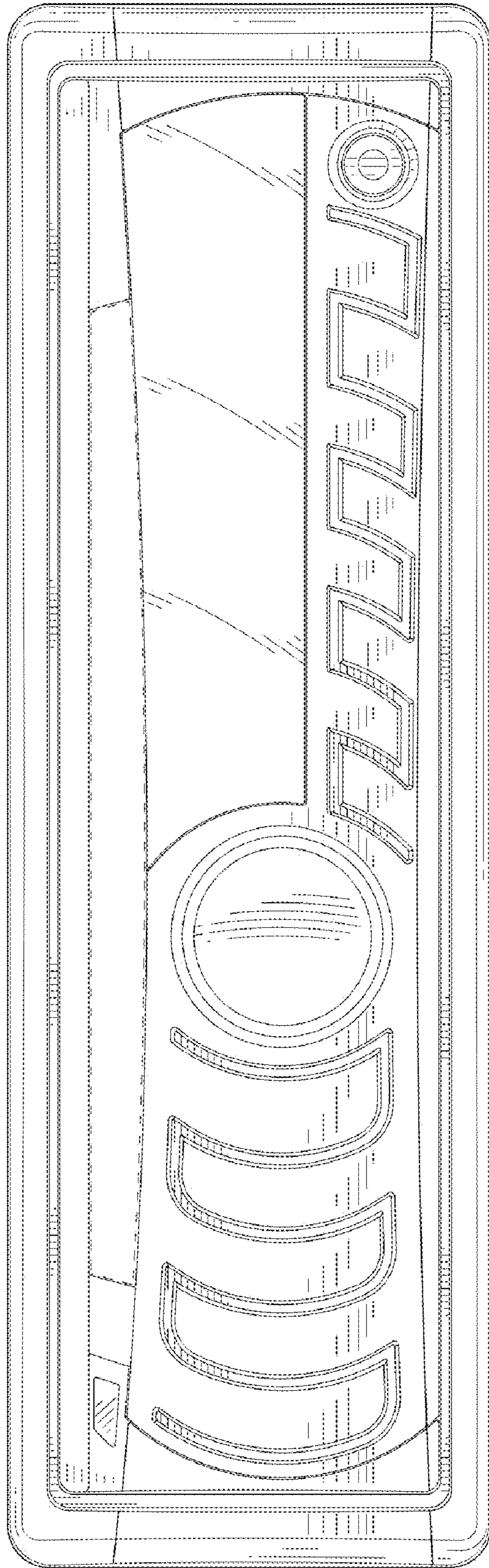

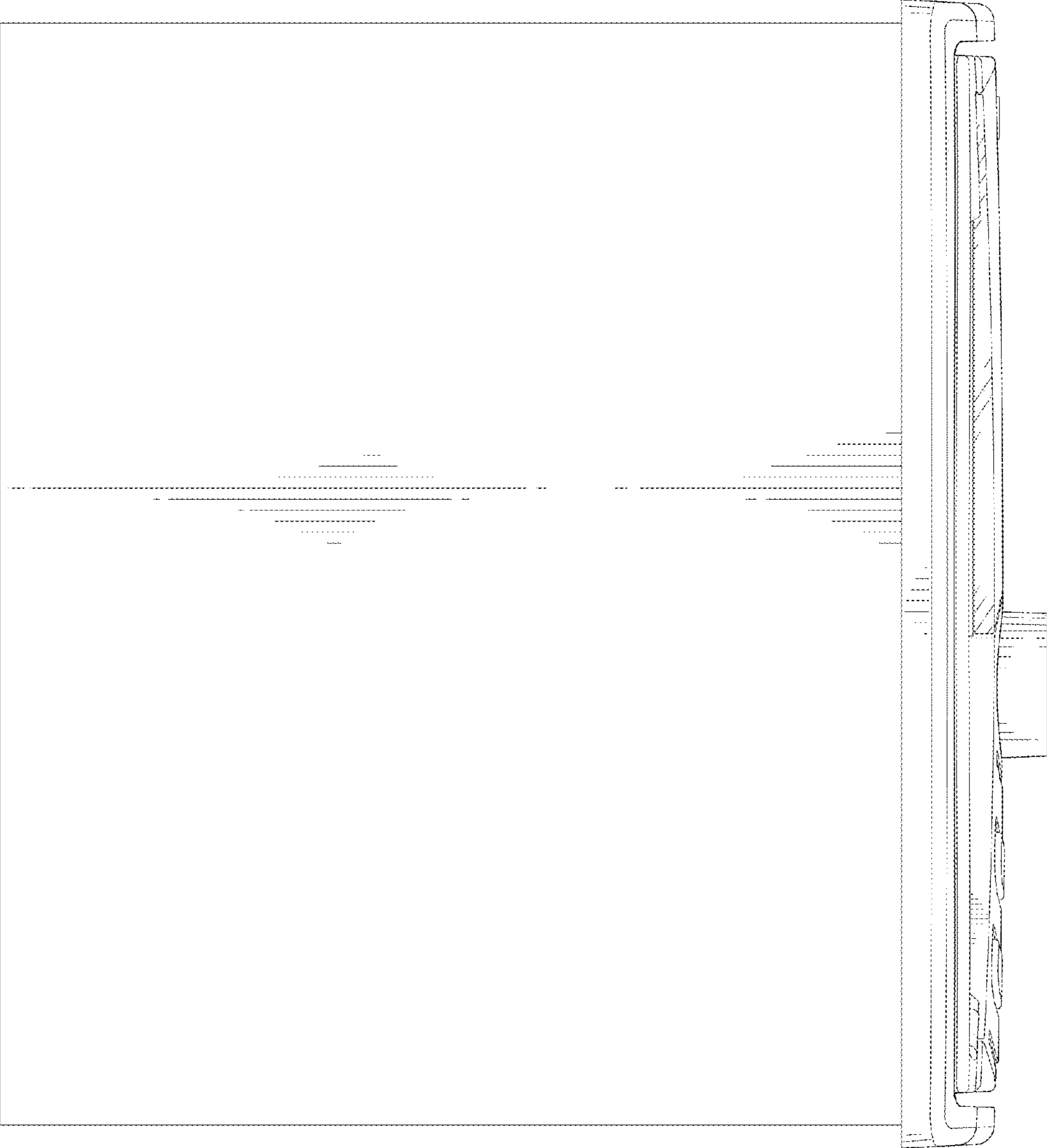

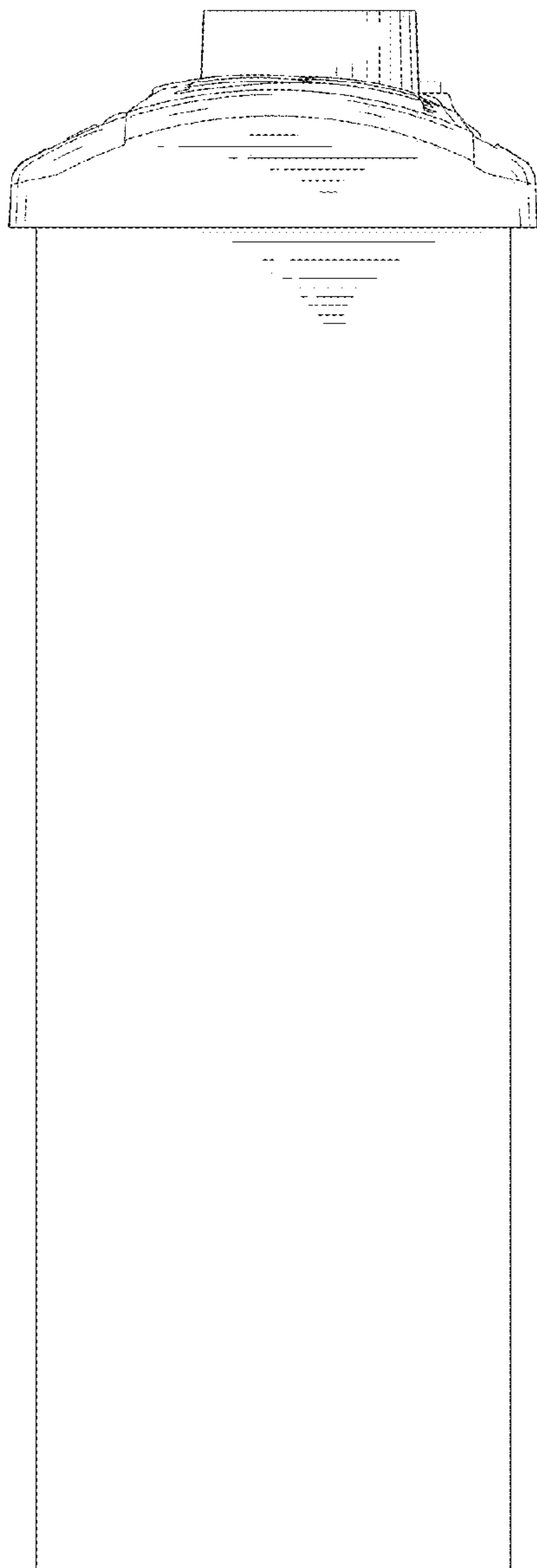

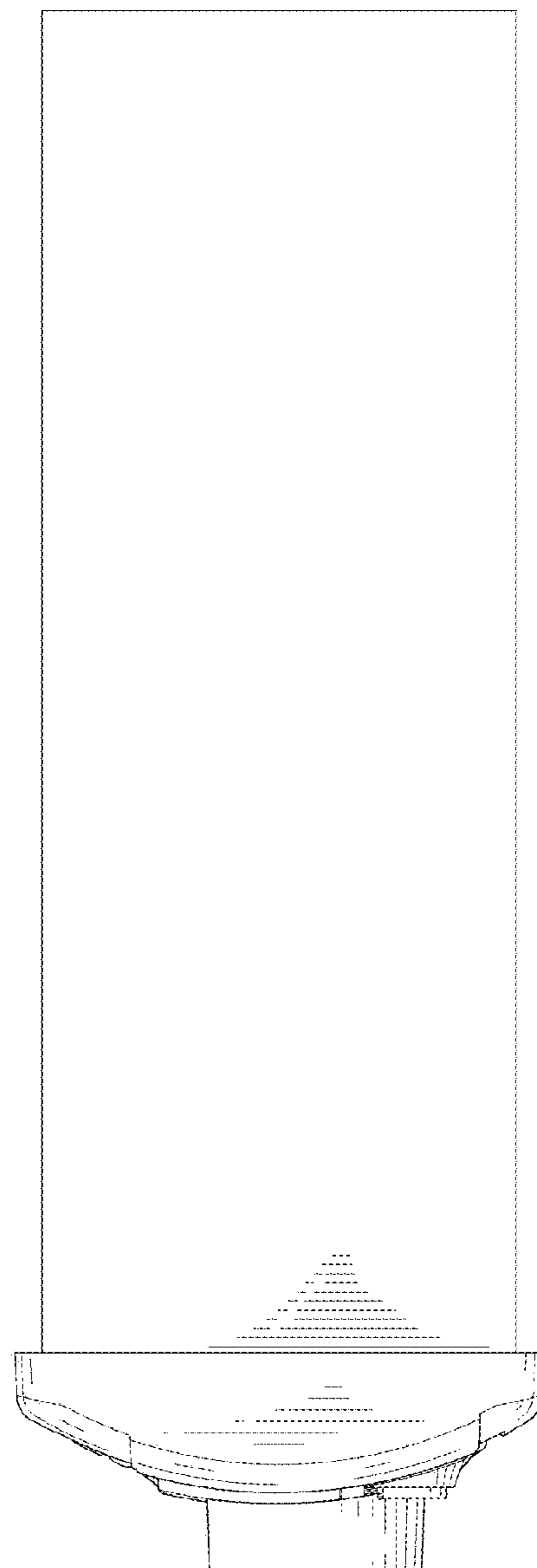

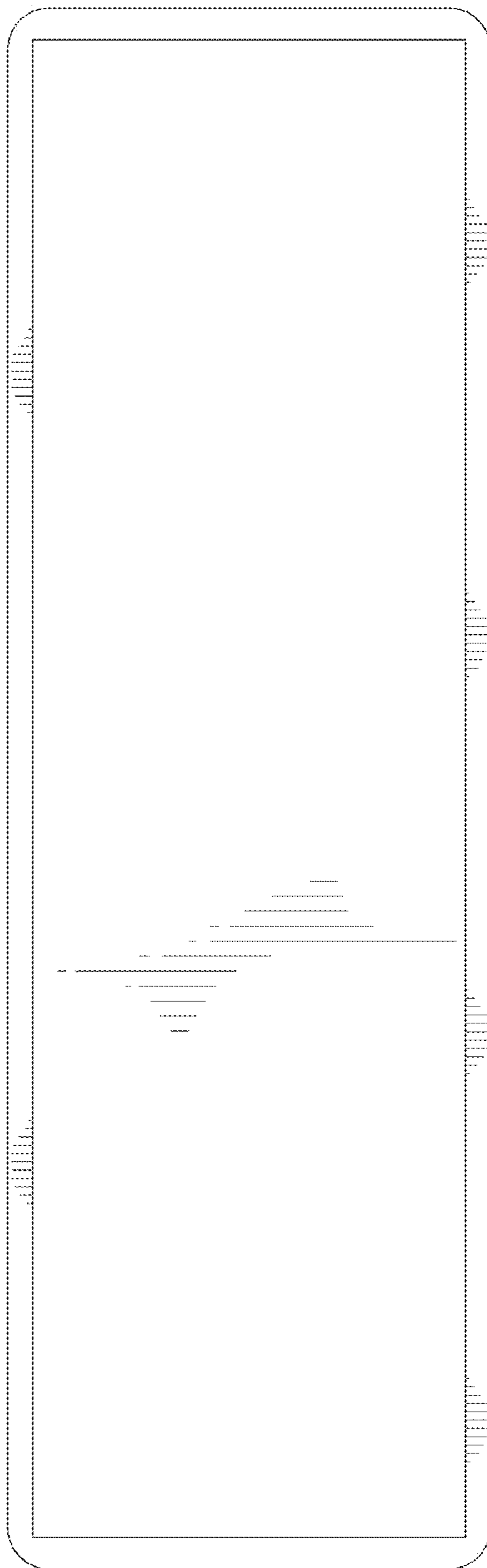

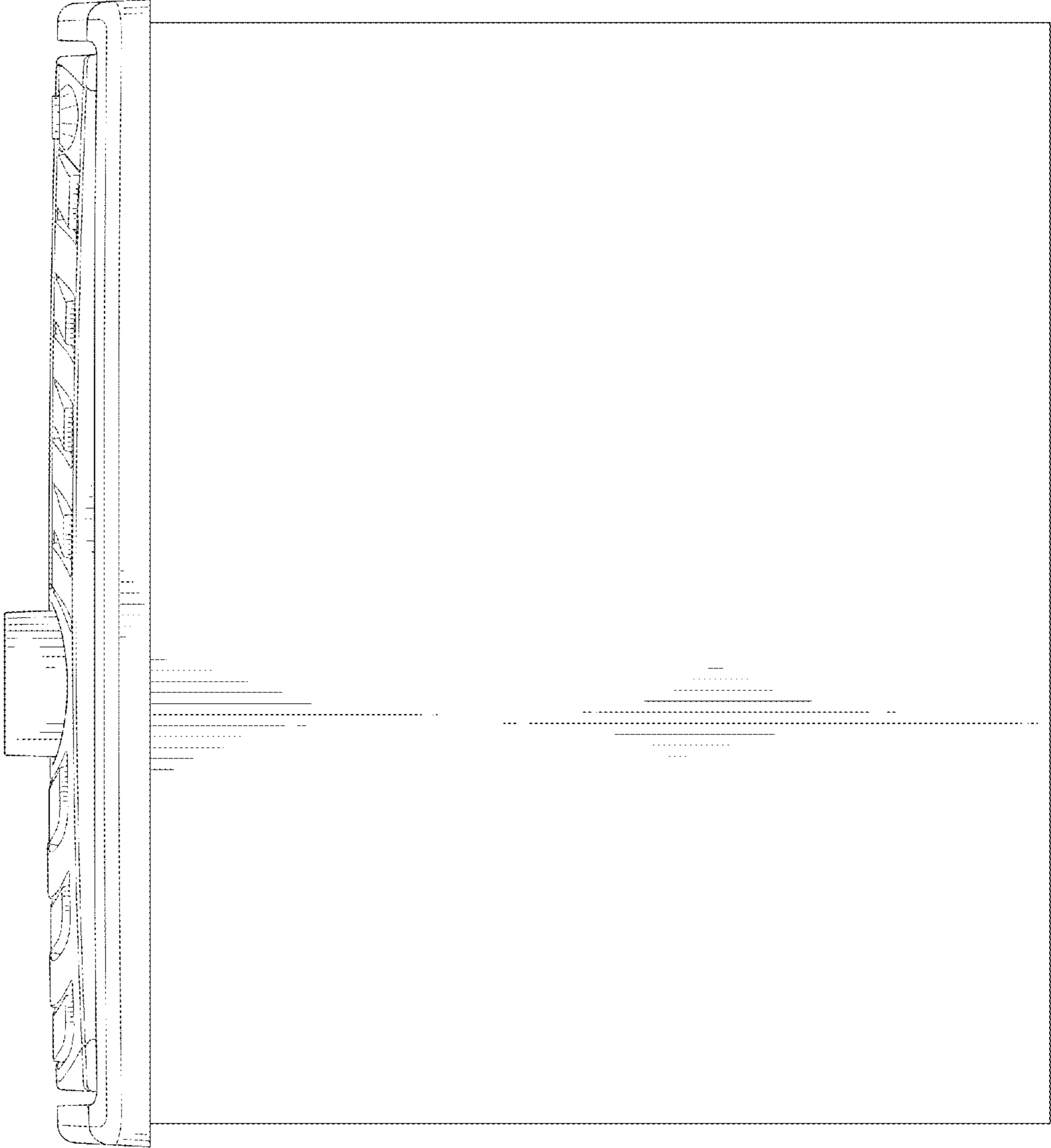
