(57) **CLAIM**

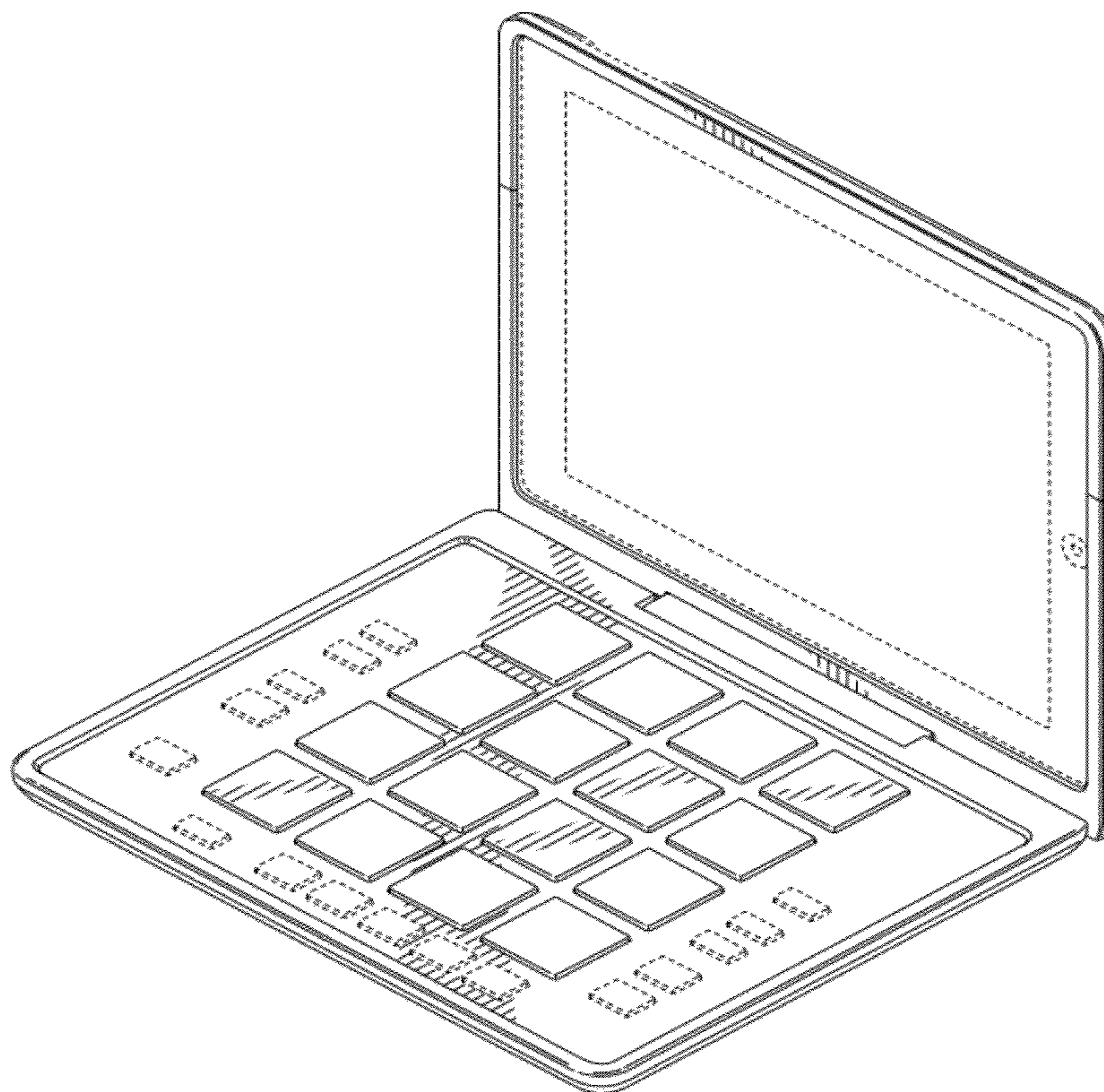
The ornamental design for a case for a tablet computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a case for a tablet computer with the case propped open showing my new design;  
FIG. 2 is a front elevation view thereof;

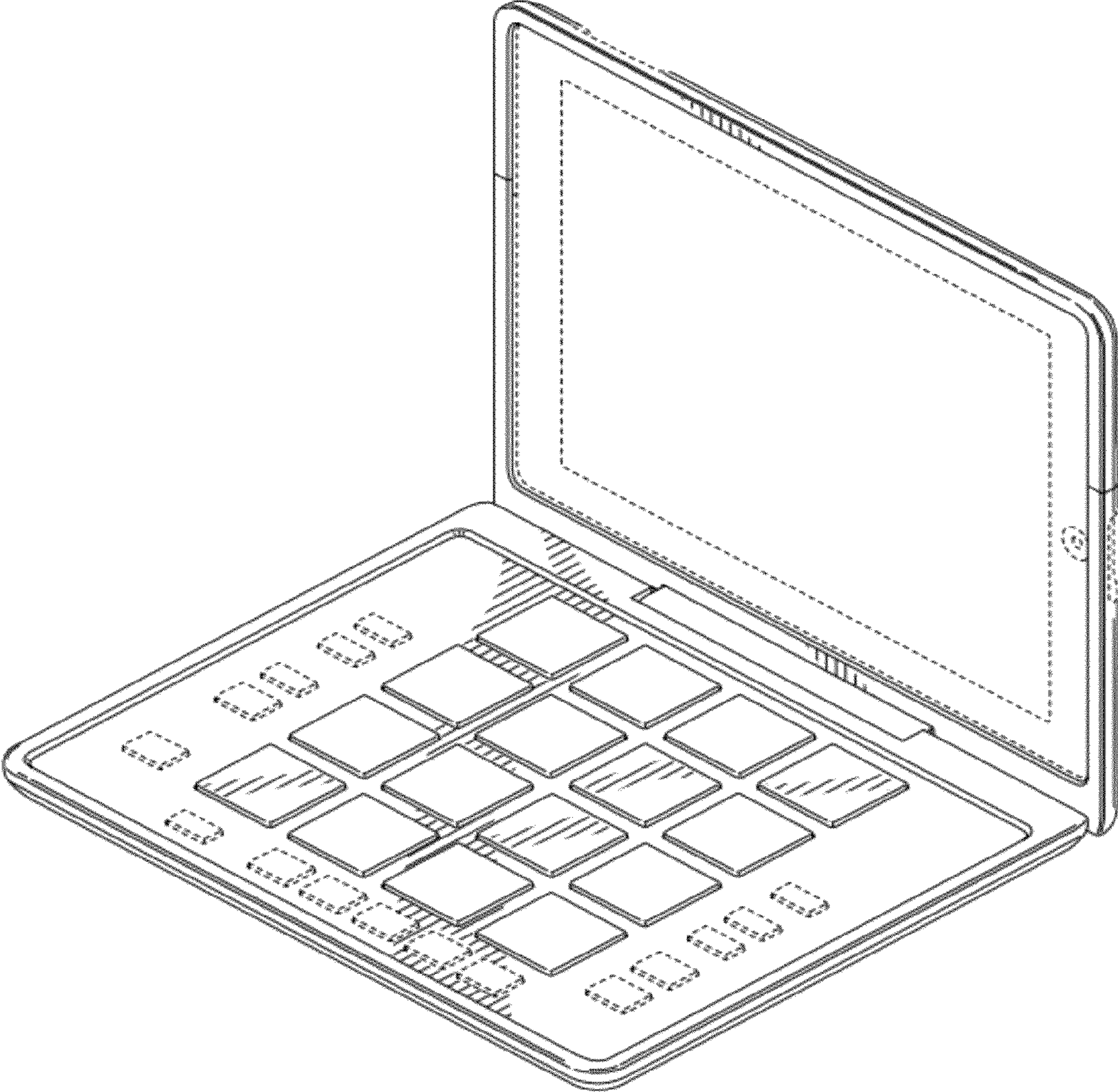

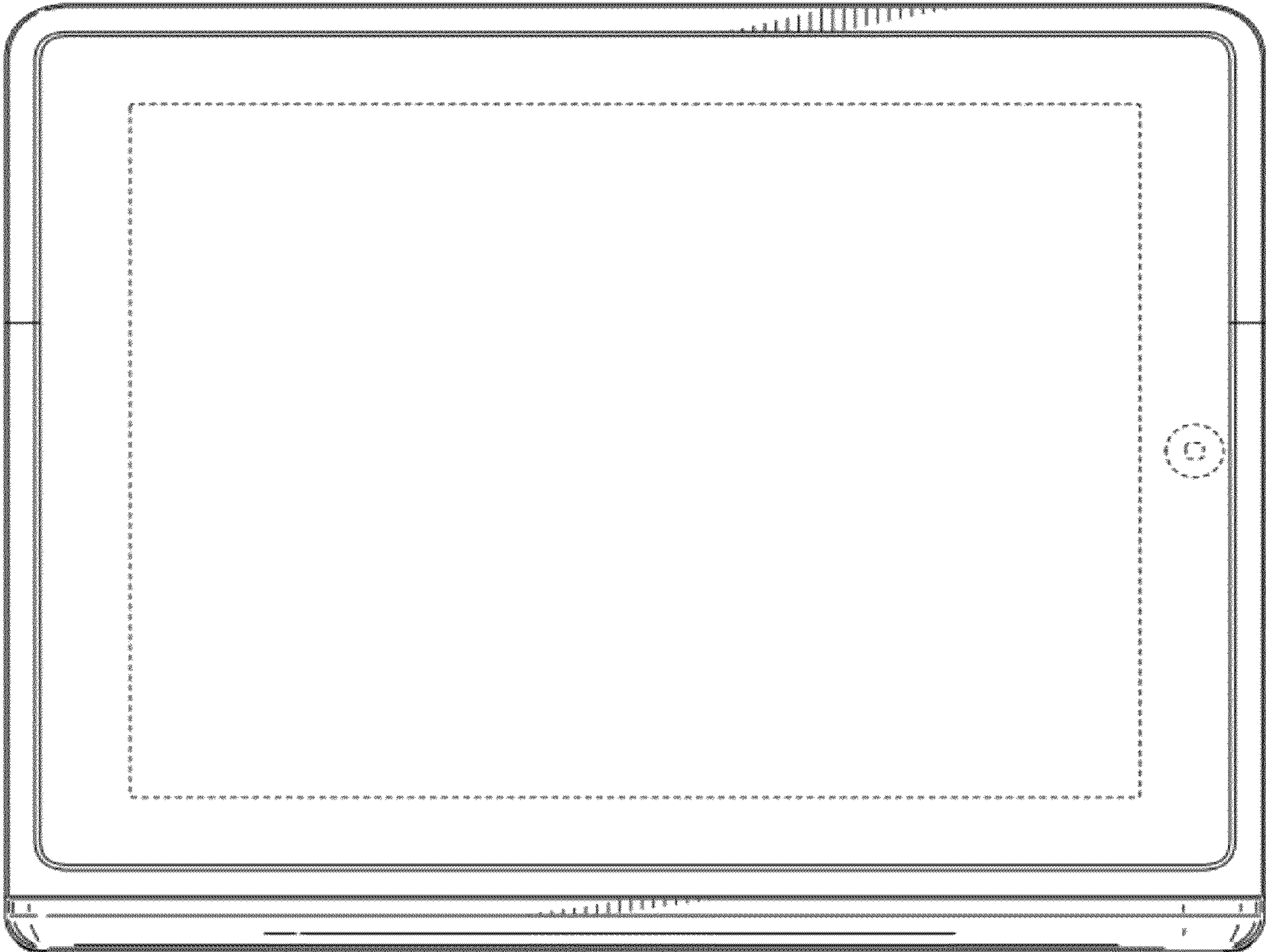

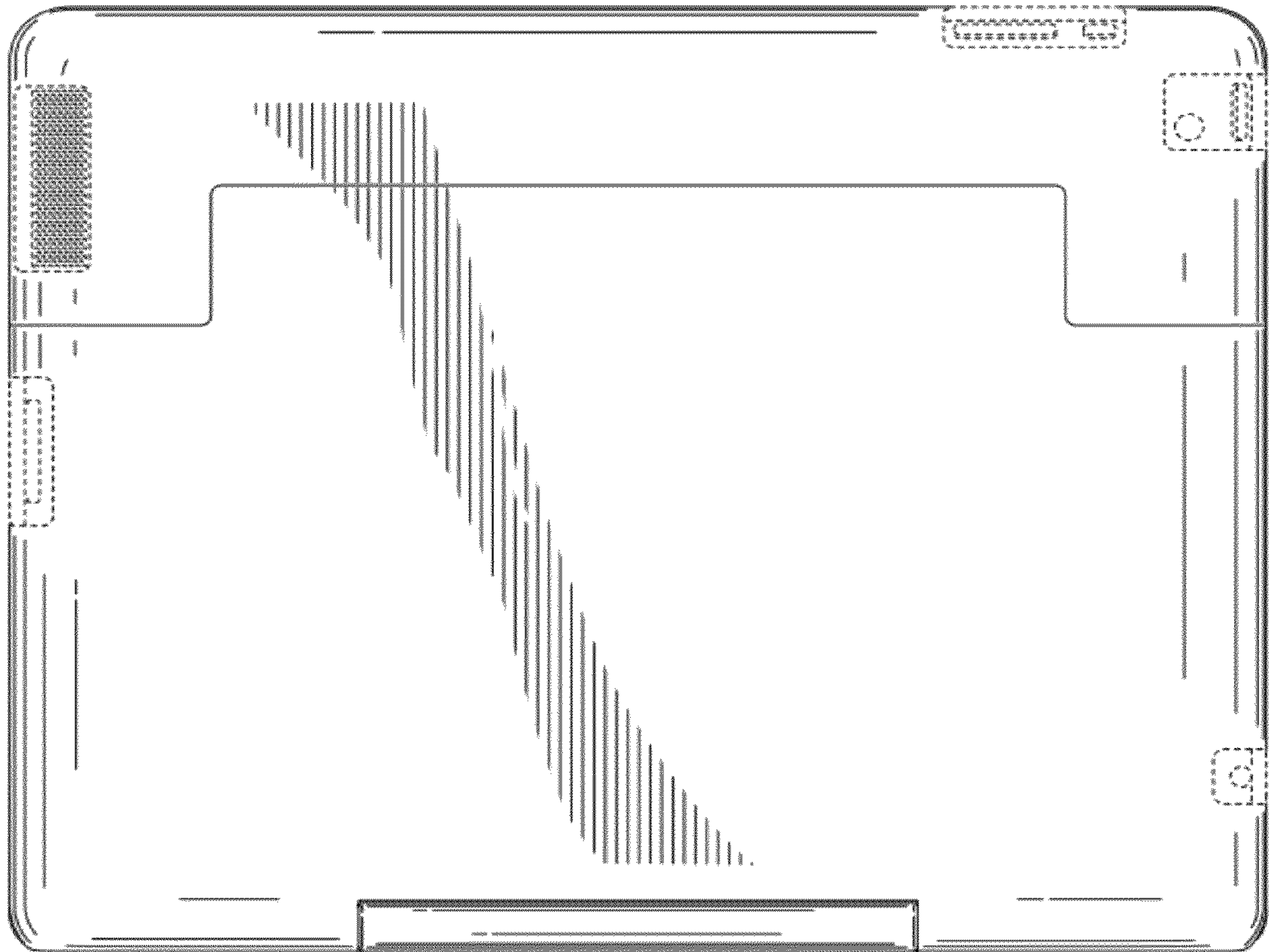

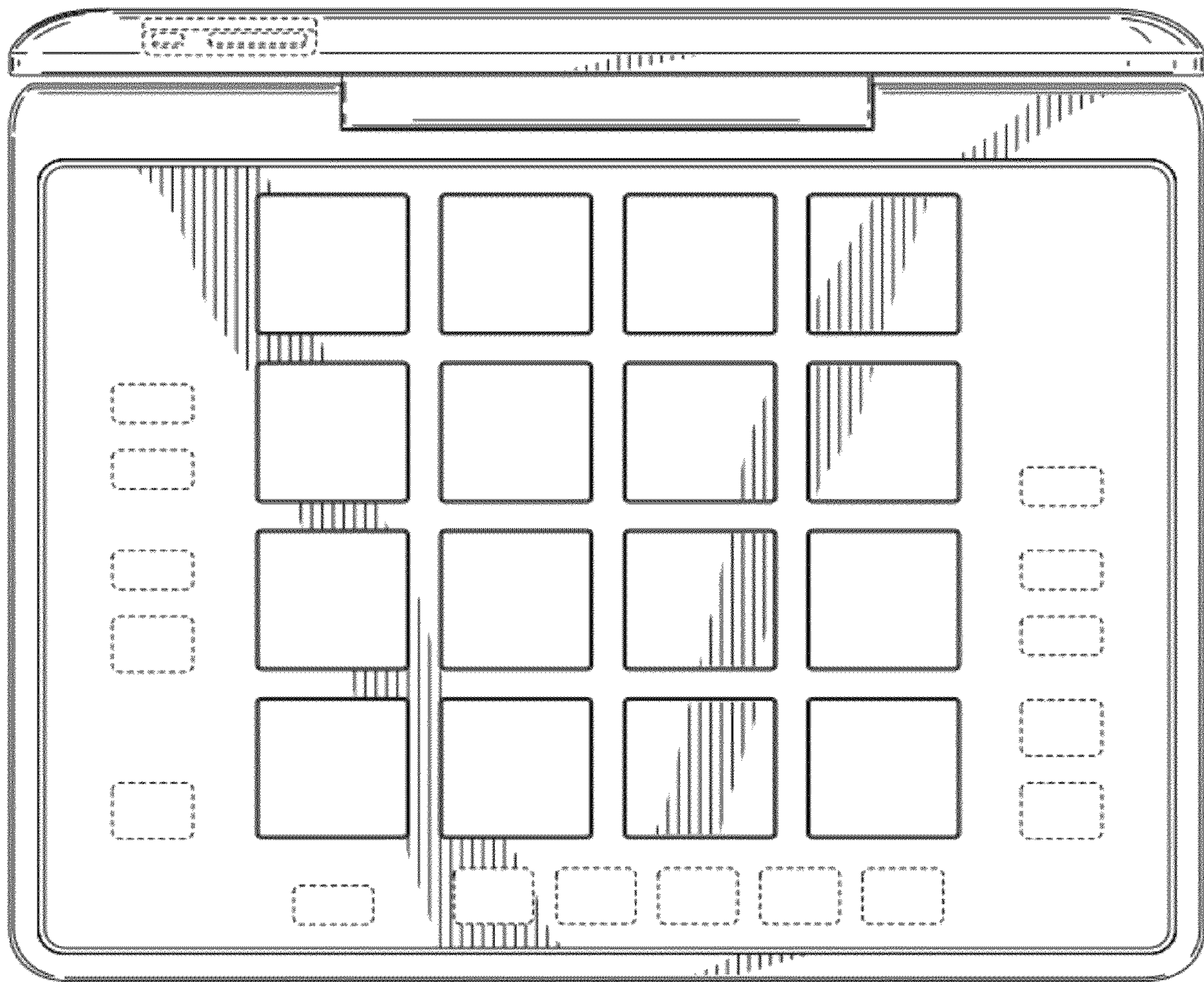

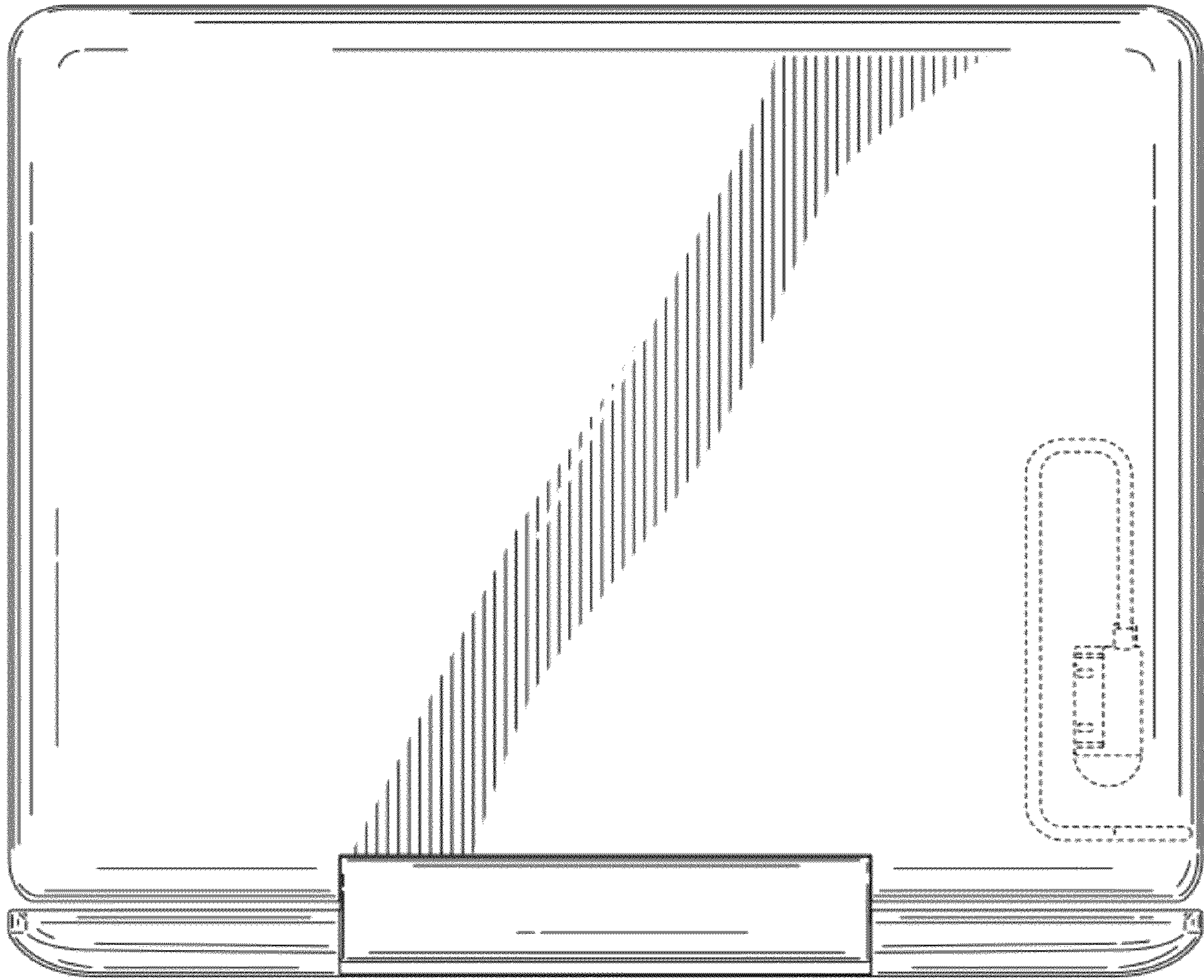
