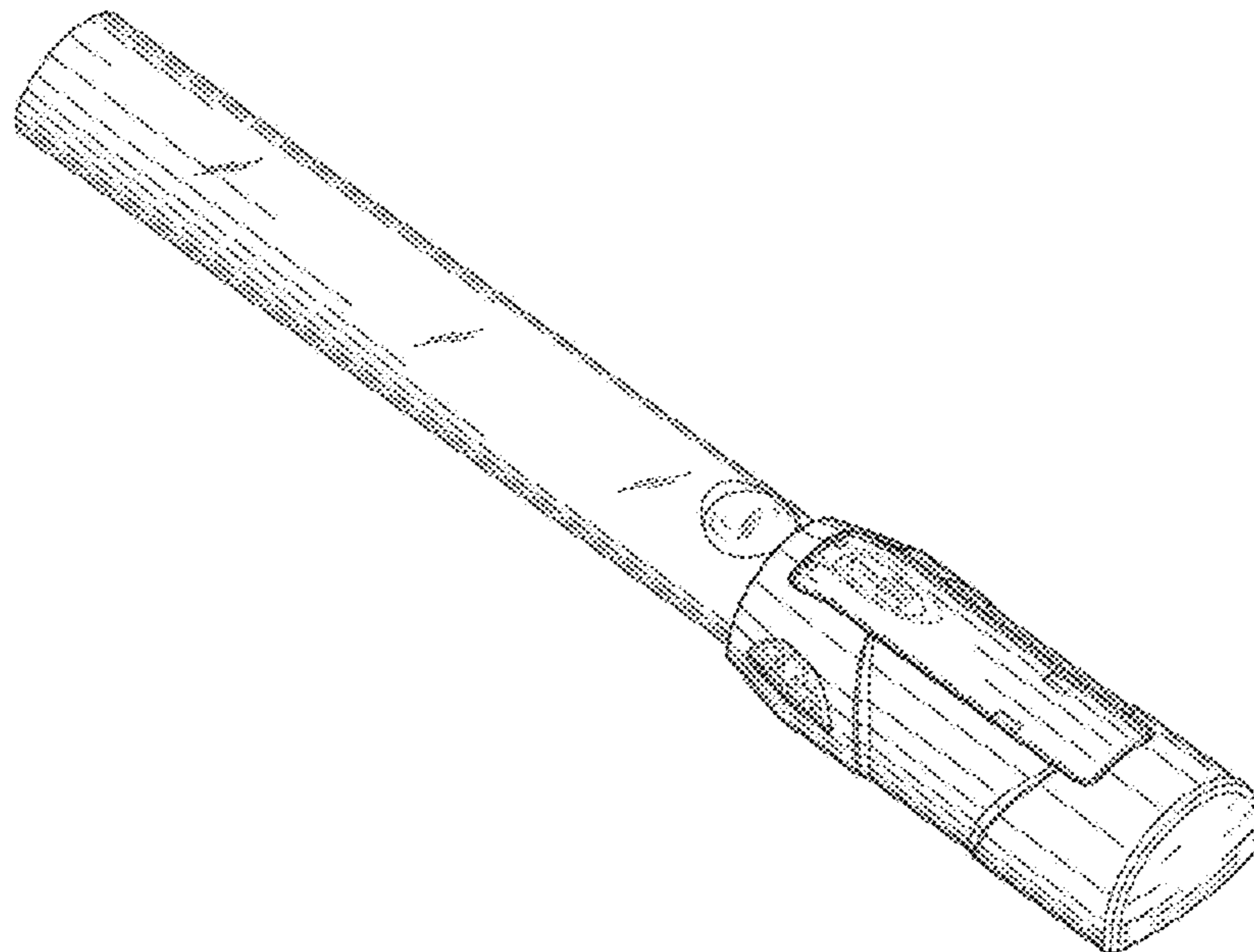
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a magnifier showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a first end elevational view thereof; and,

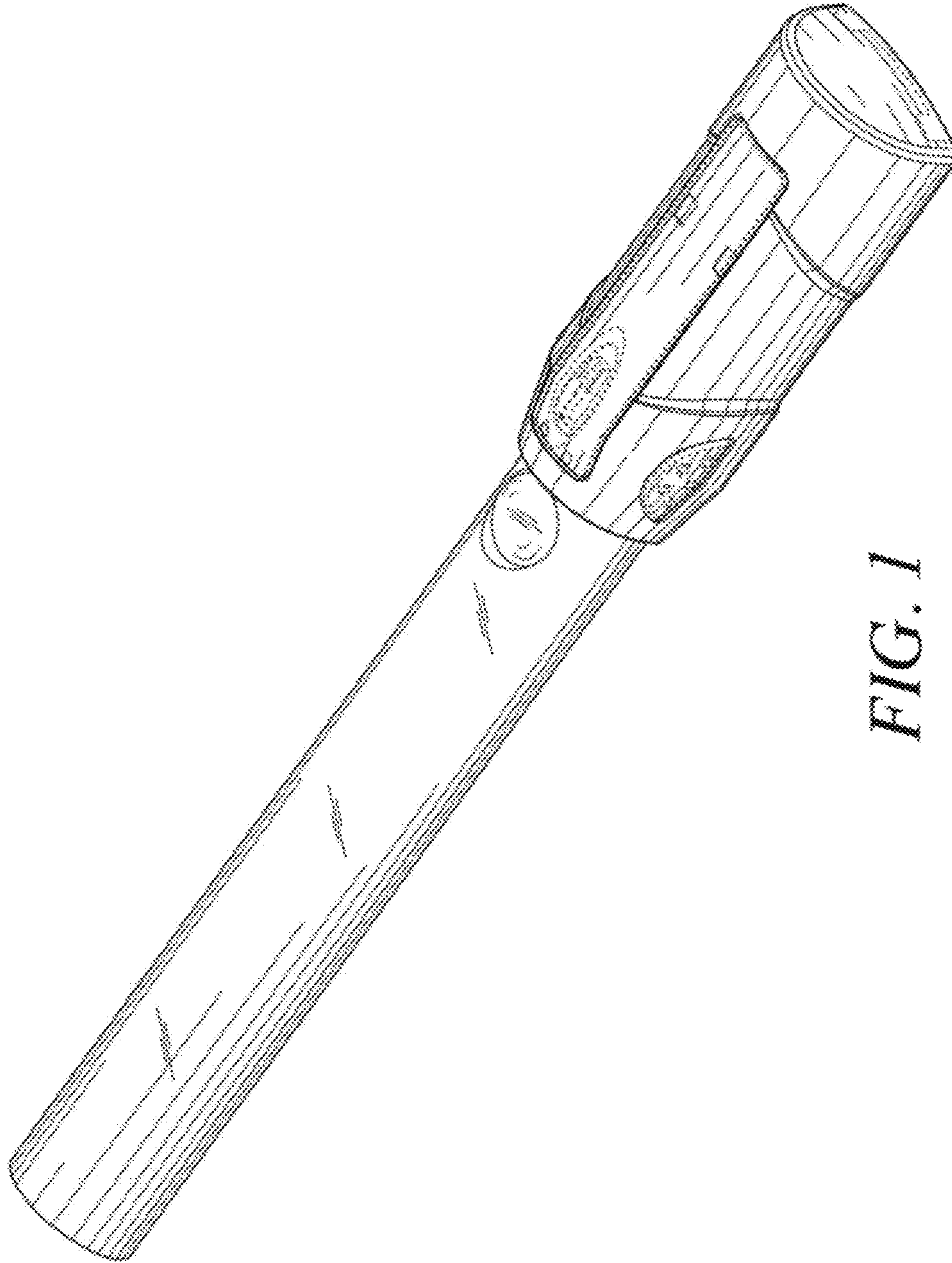

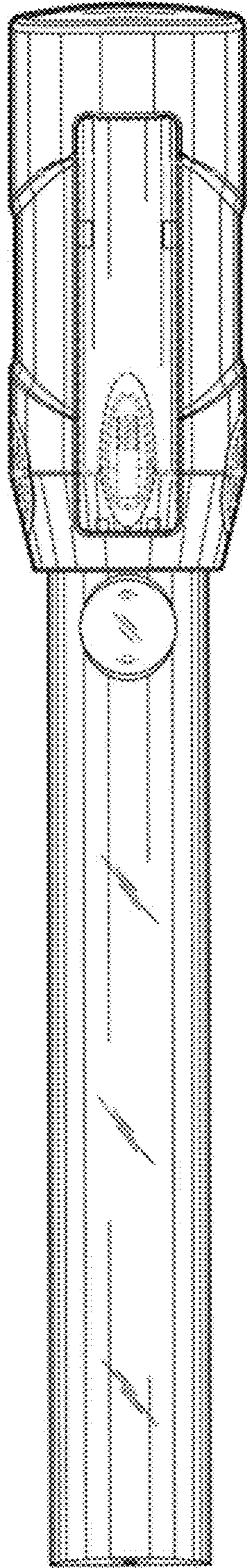

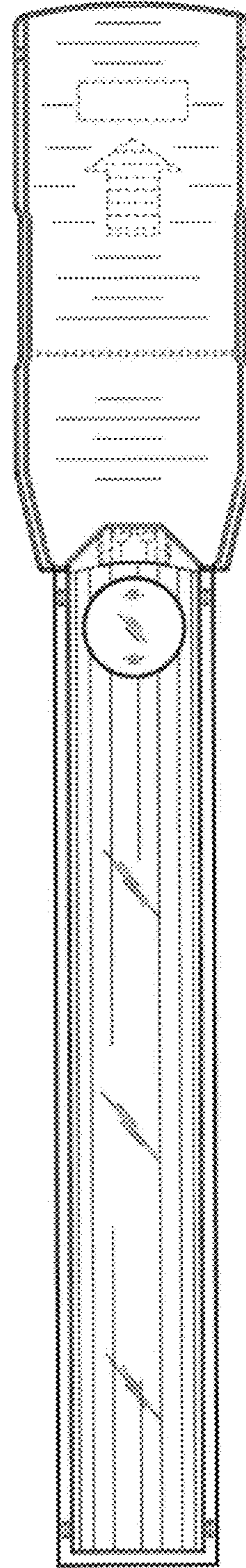

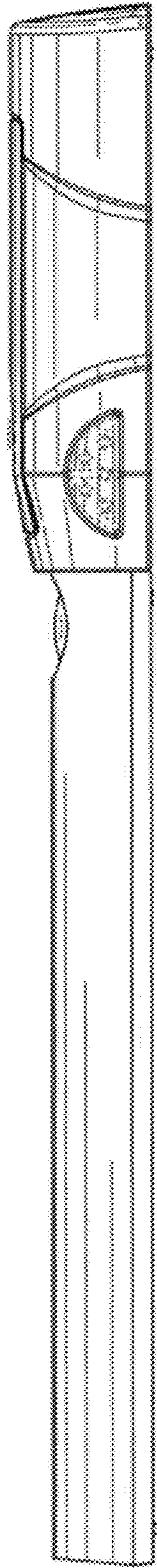

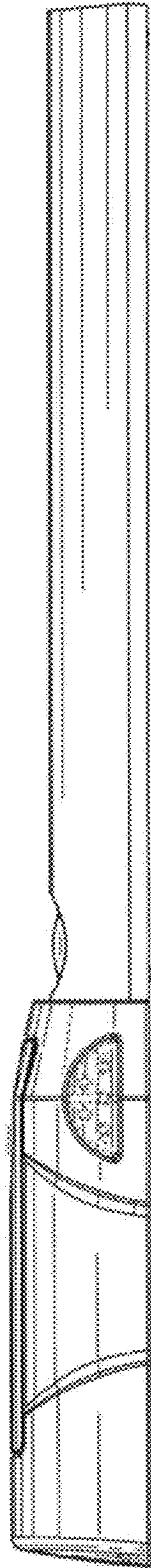

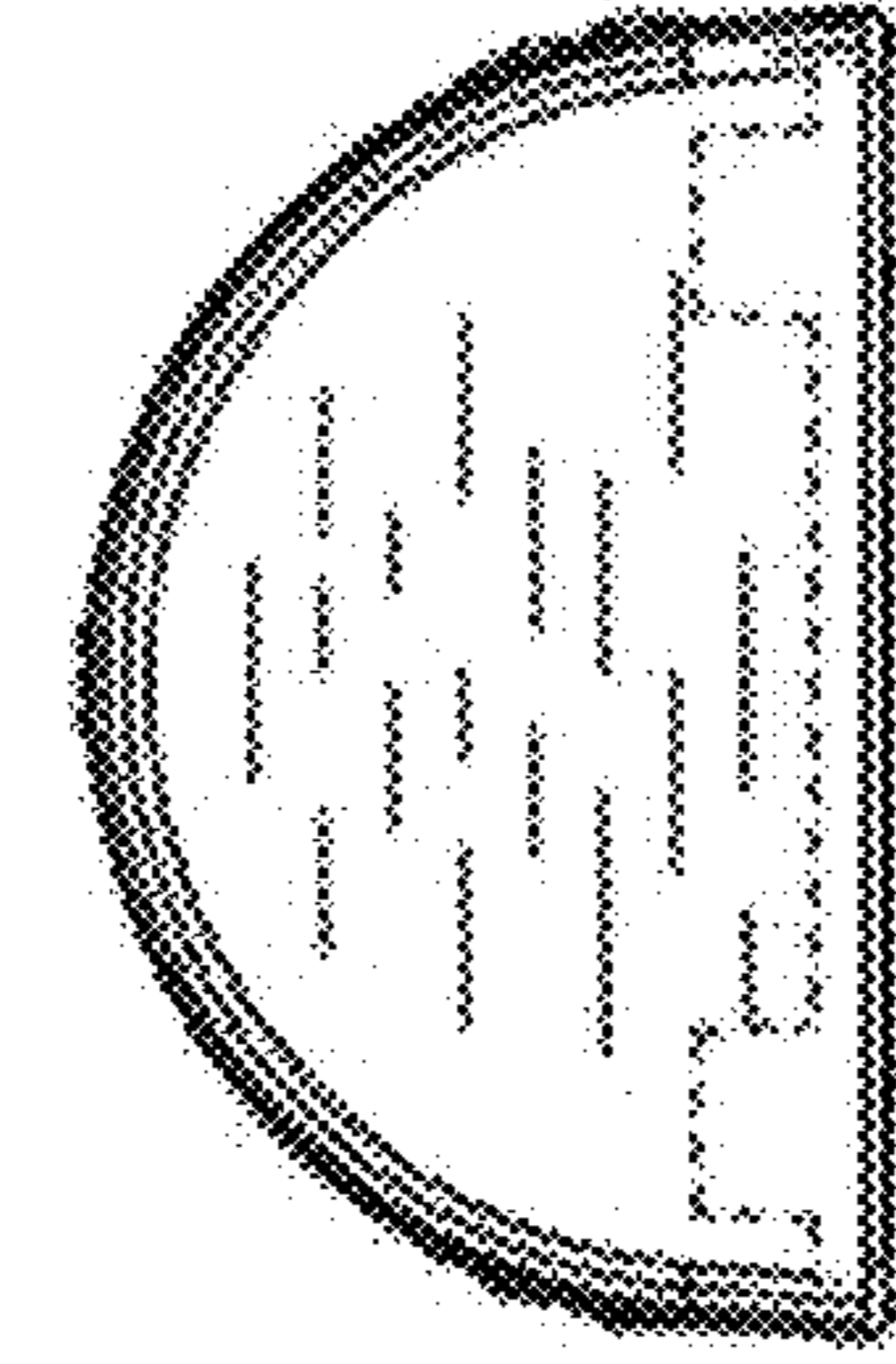

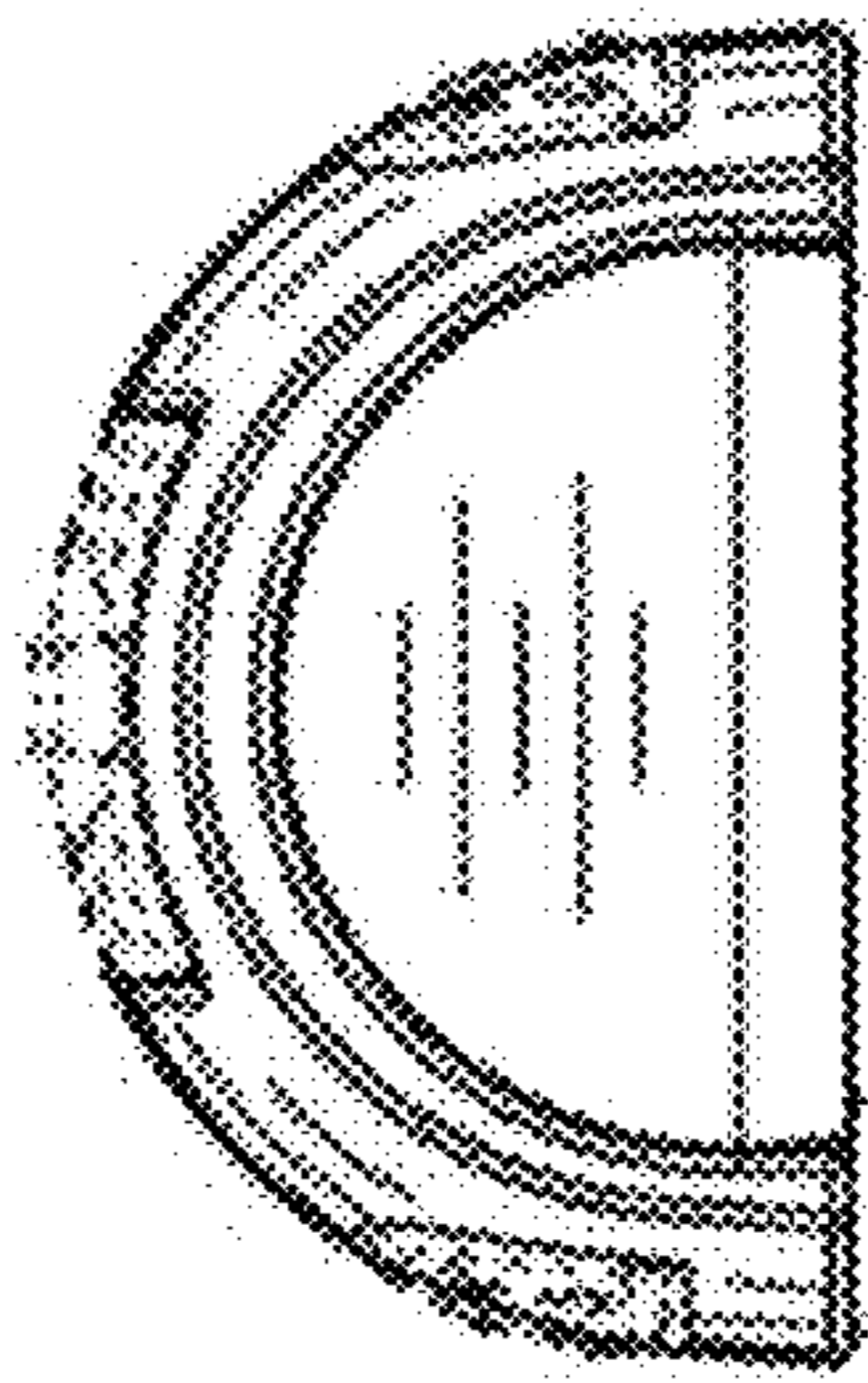
