(57) **CLAIM**

The ornamental design for a lubricated diaper, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a lubricated diaper, showing my new design, with the transparent sheet partially pulled back;

FIG. 2 is a top plan view thereof, but with the transparent sheet not pulled back;

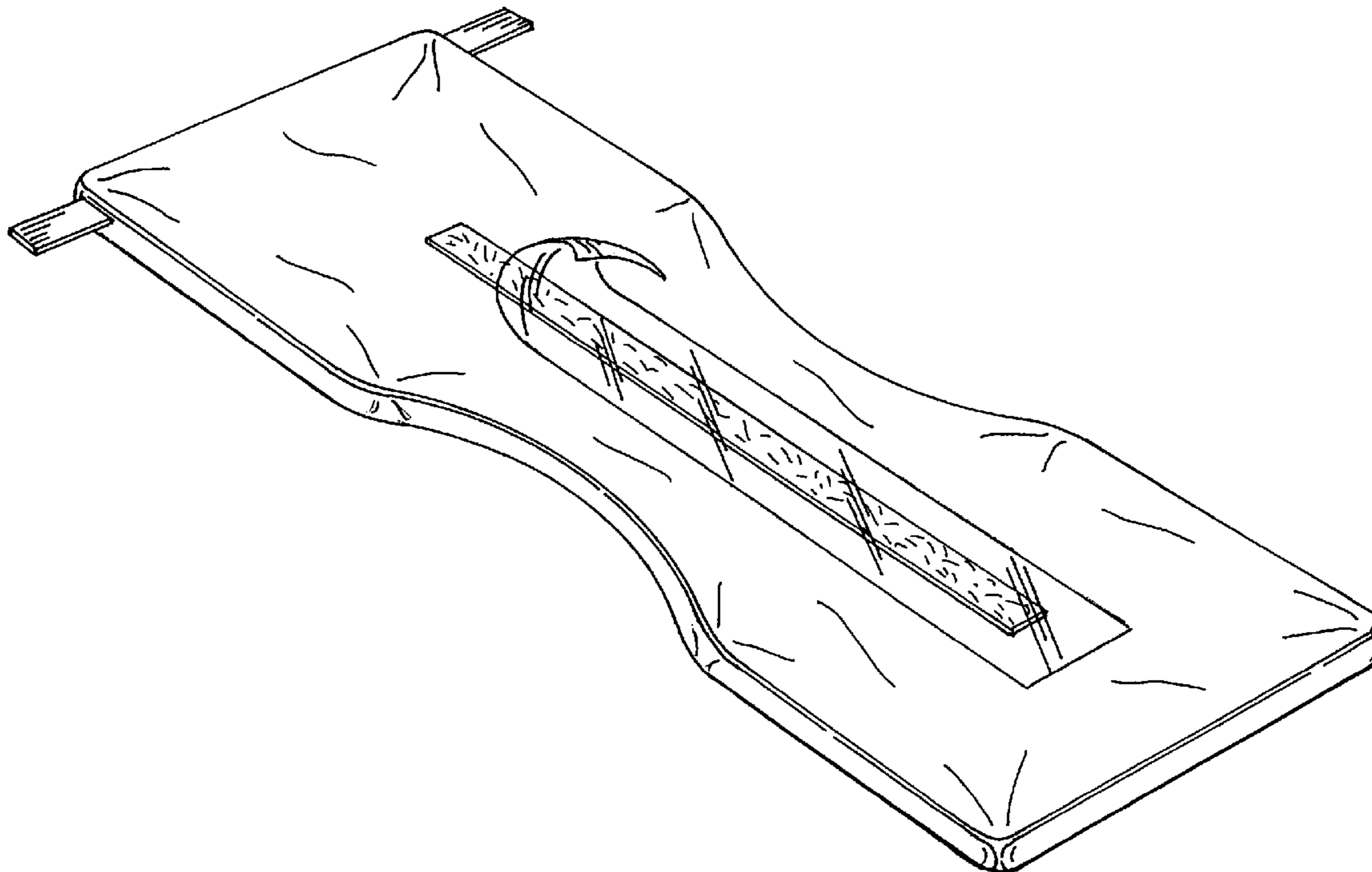
FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof; and,

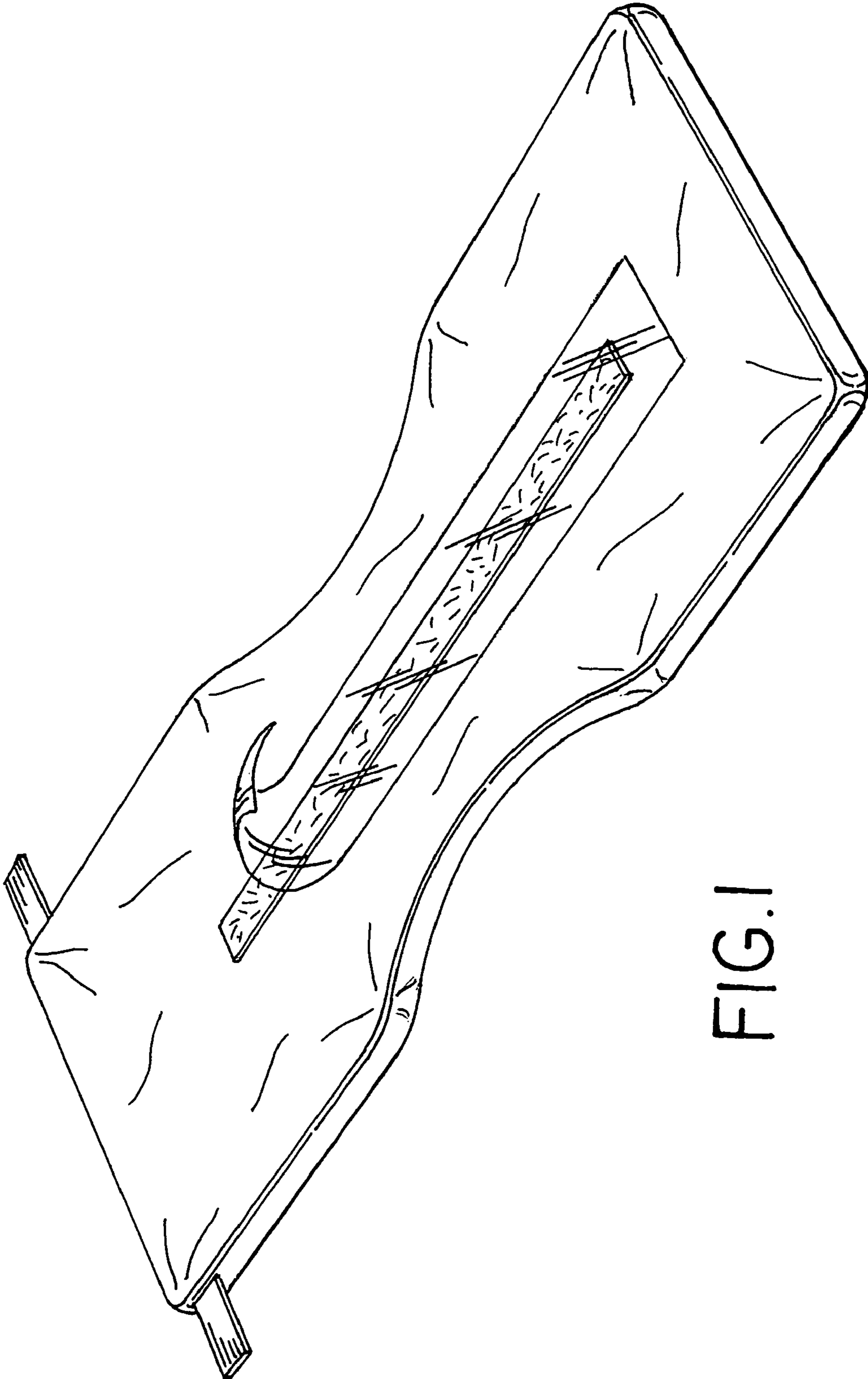

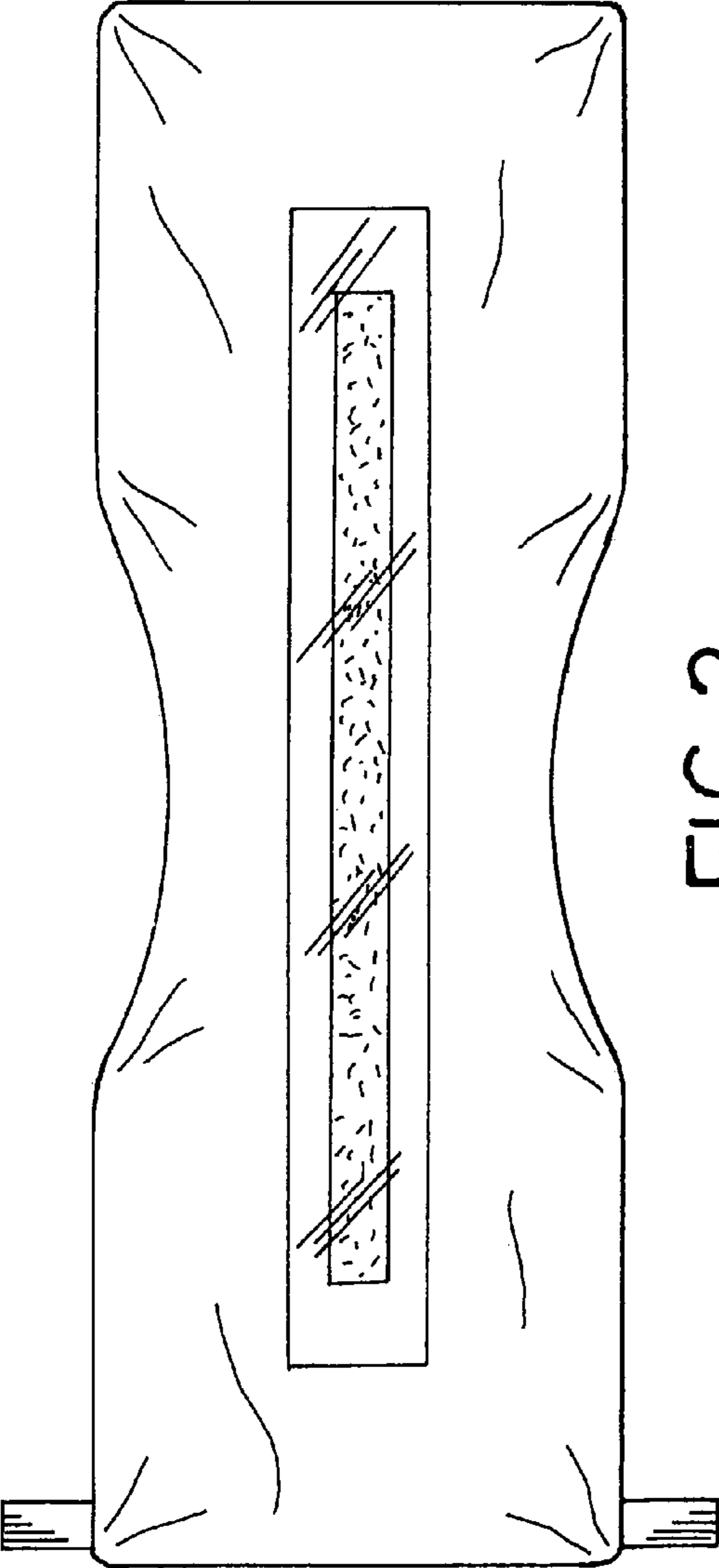

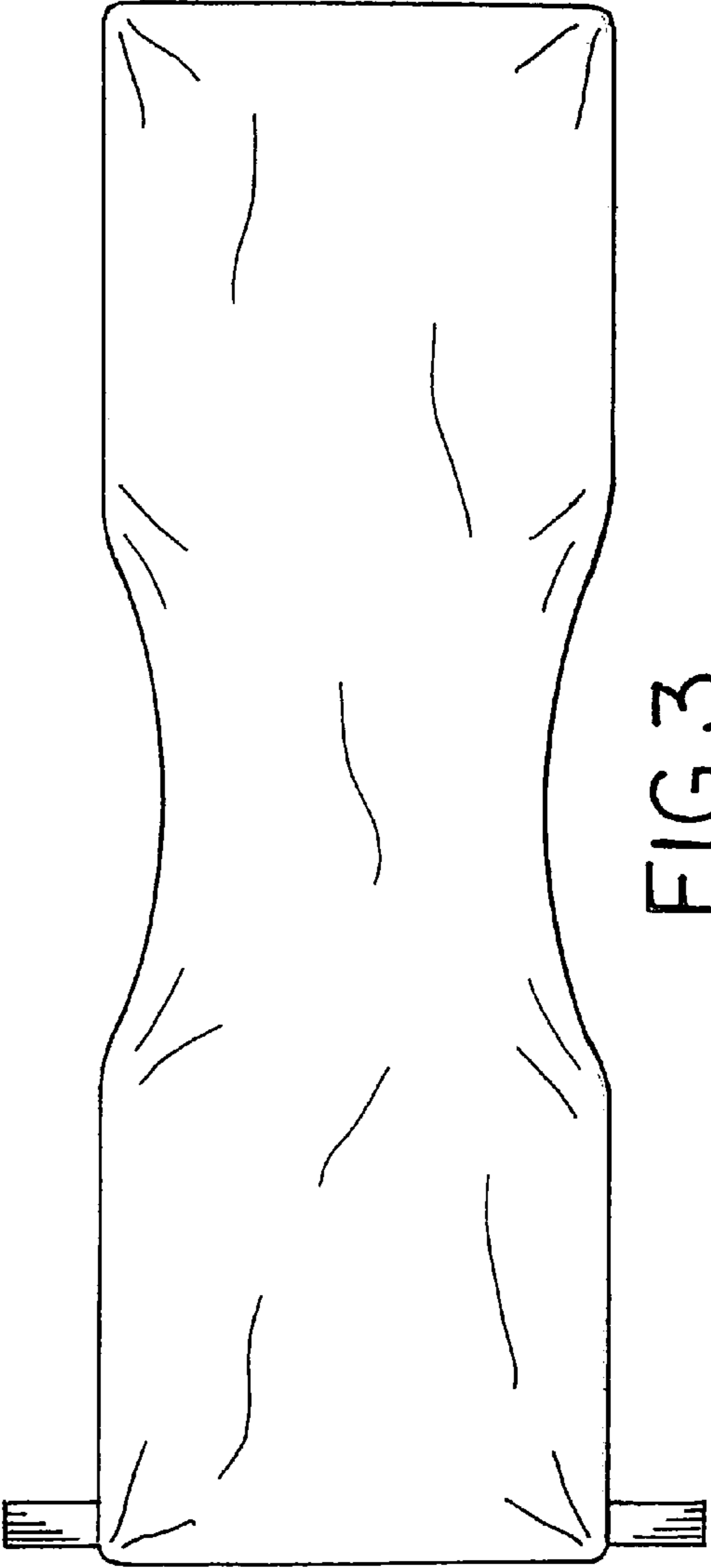
