(57) **CLAIM**

The ornamental design for a visor interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a visor interface in a flat, unused state;

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof.

FIG. 6 is a bottom view thereof.

FIG. 7 is a perspective view of the visor interface shown in a curved, used condition;

FIG. 8 is a perspective view thereof, wherein the visor frame and helmet are illustrated in broken lines;

FIG. 9 is a front view of the visor interface of FIG. 1 in a used condition;

FIG. 10 is a rear view thereof;

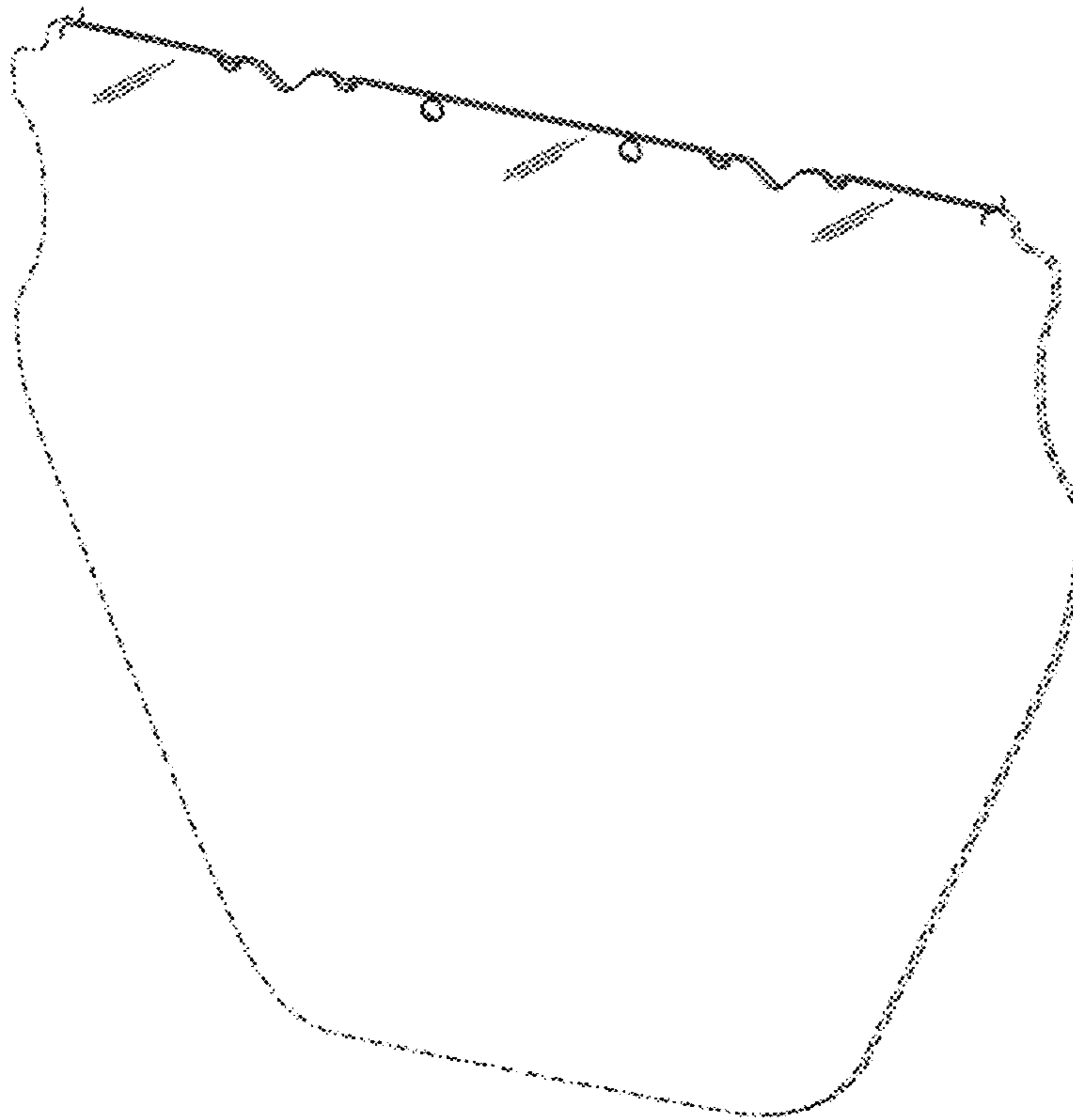
FIG. 11 is a side view thereof, the opposite side view is identical;

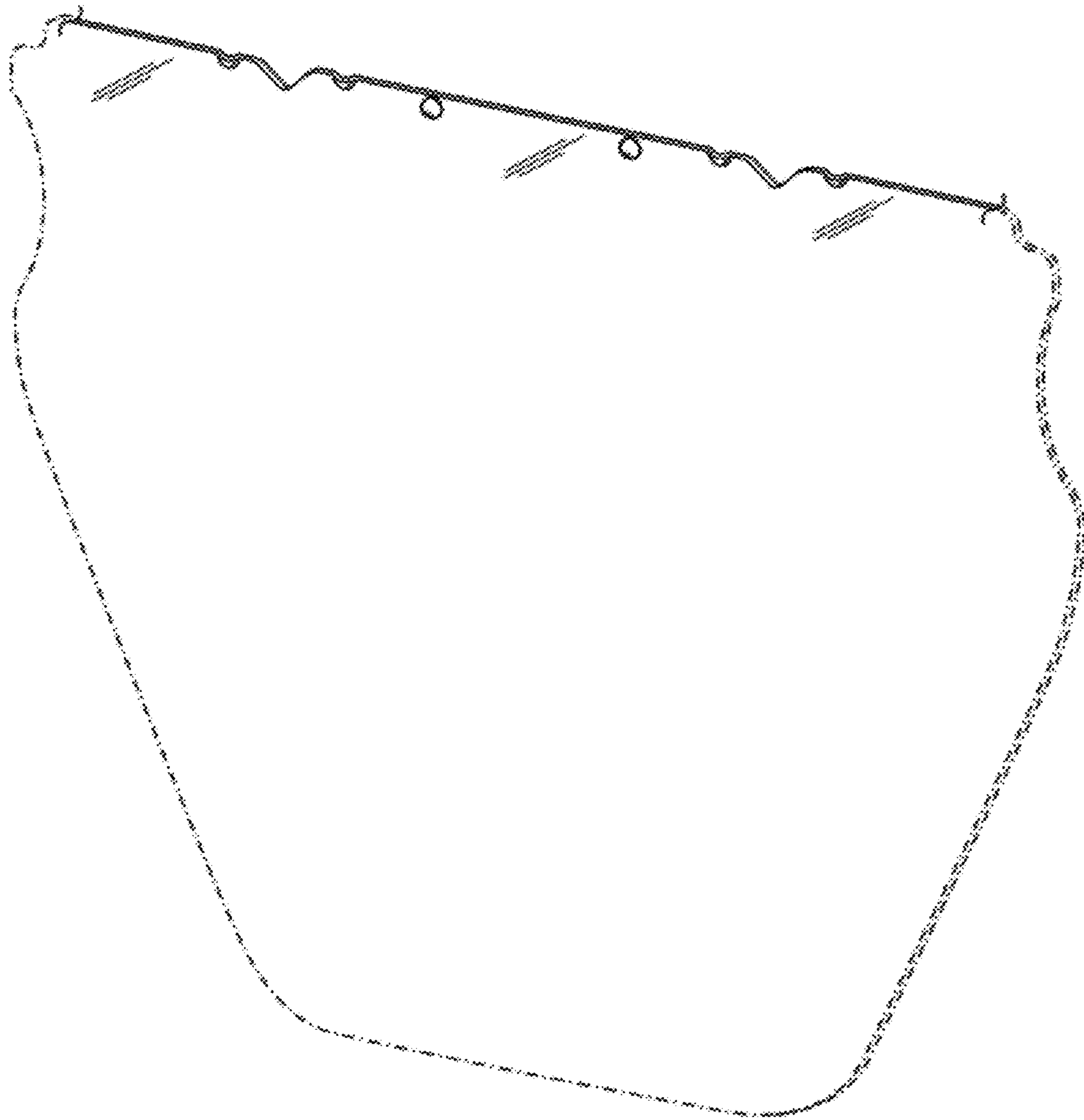

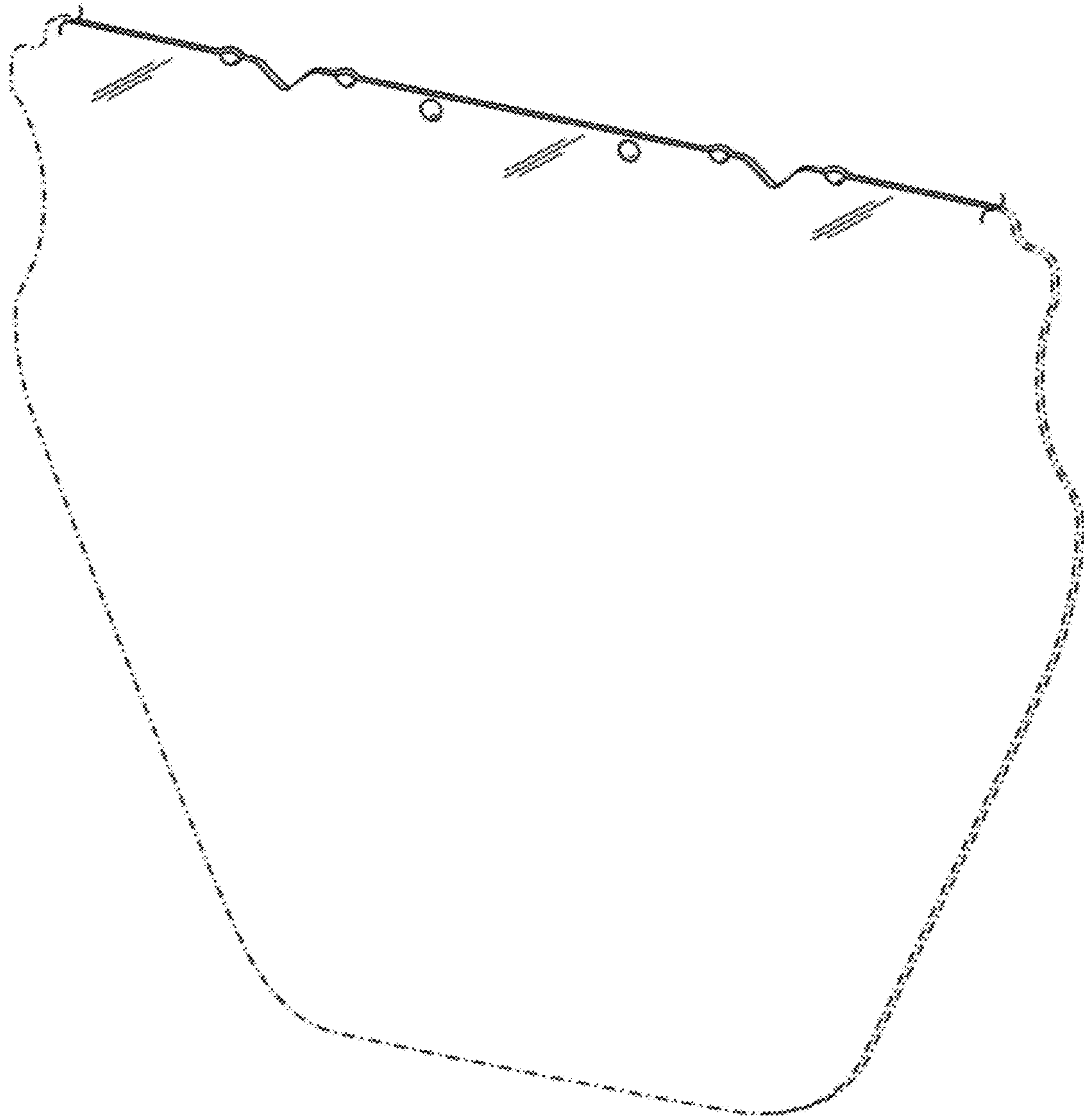

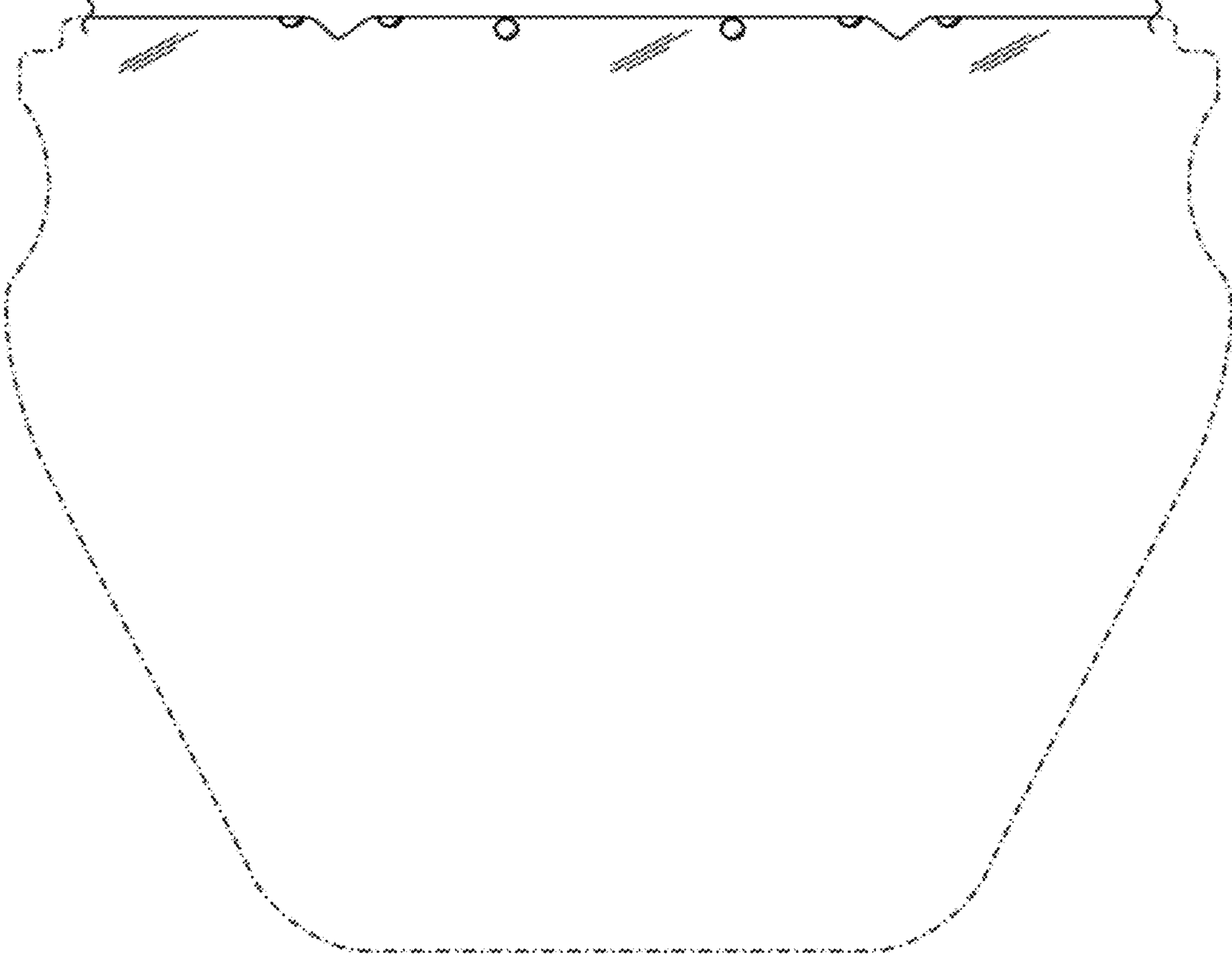

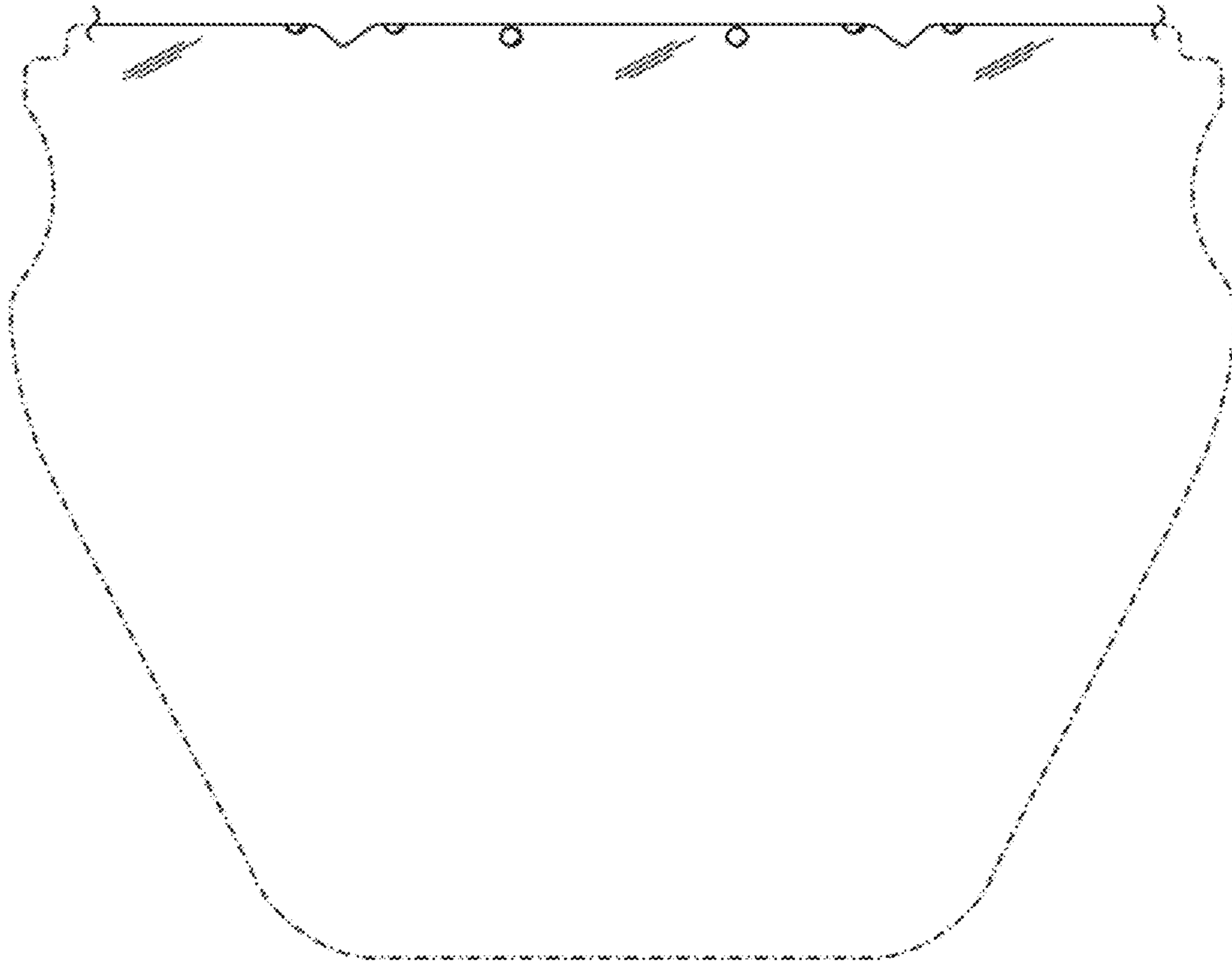

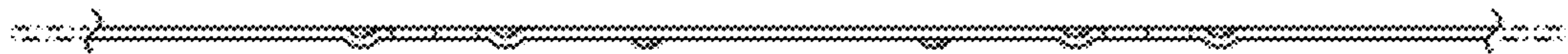

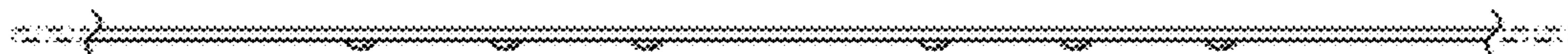

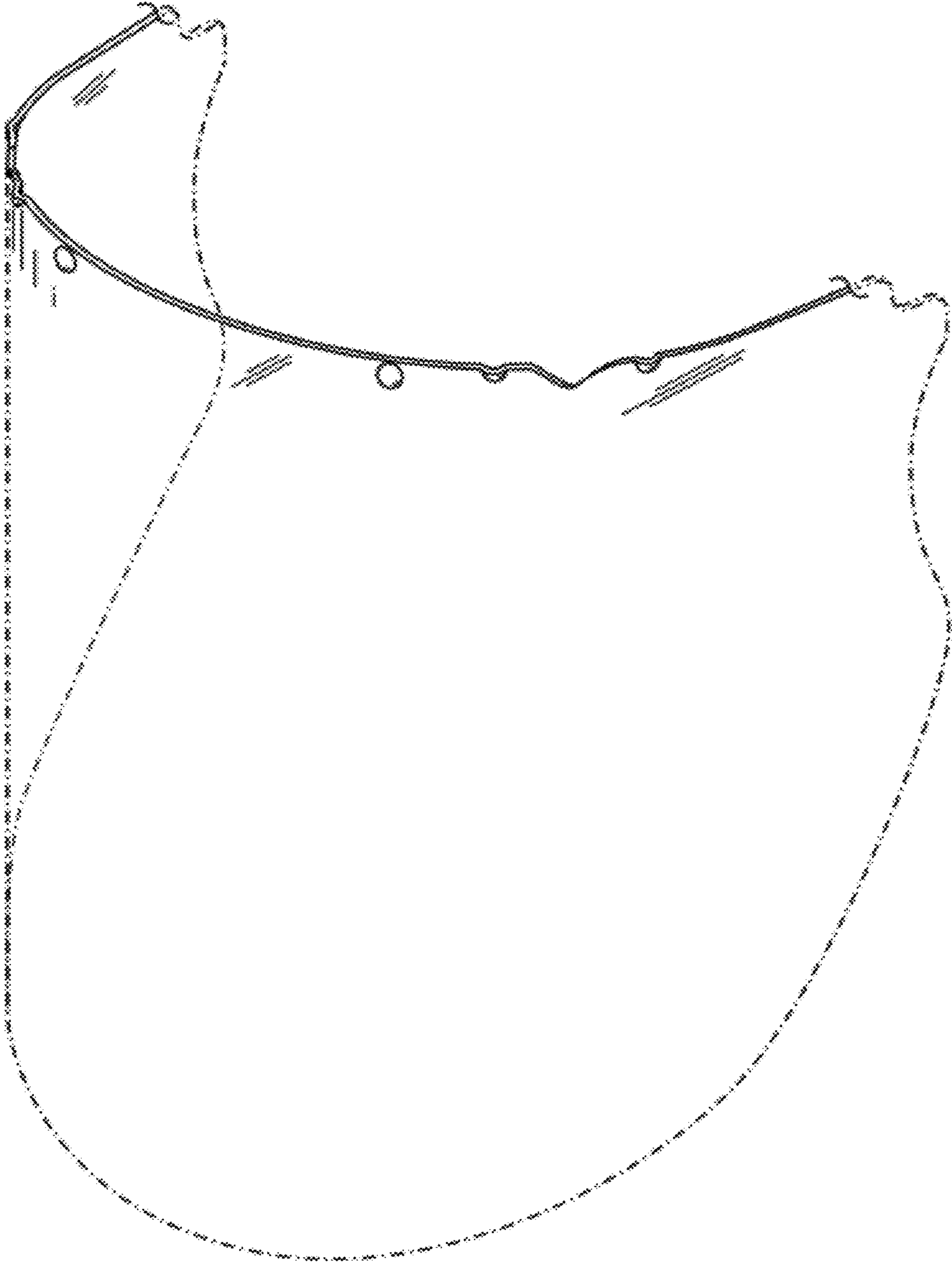

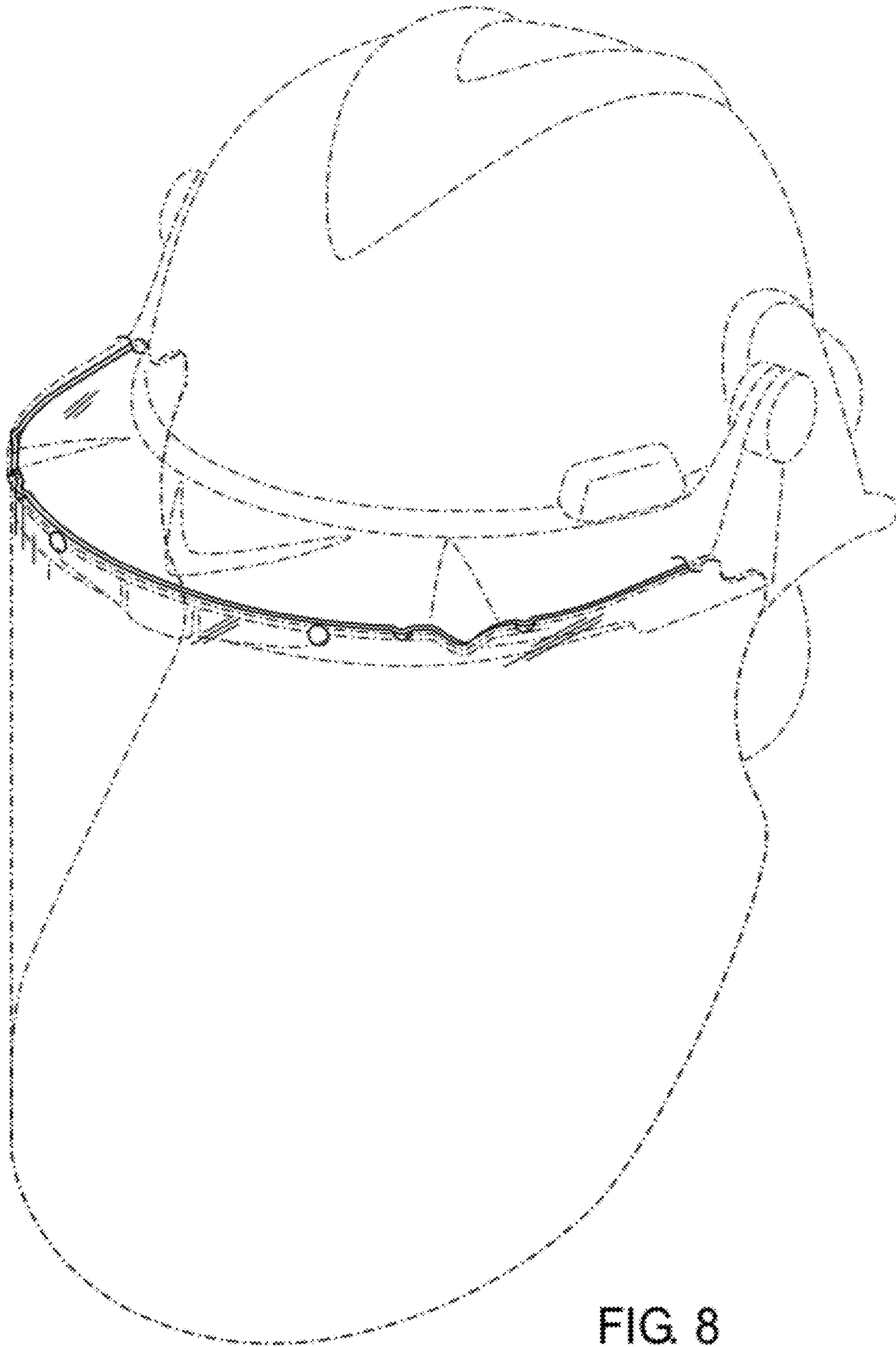

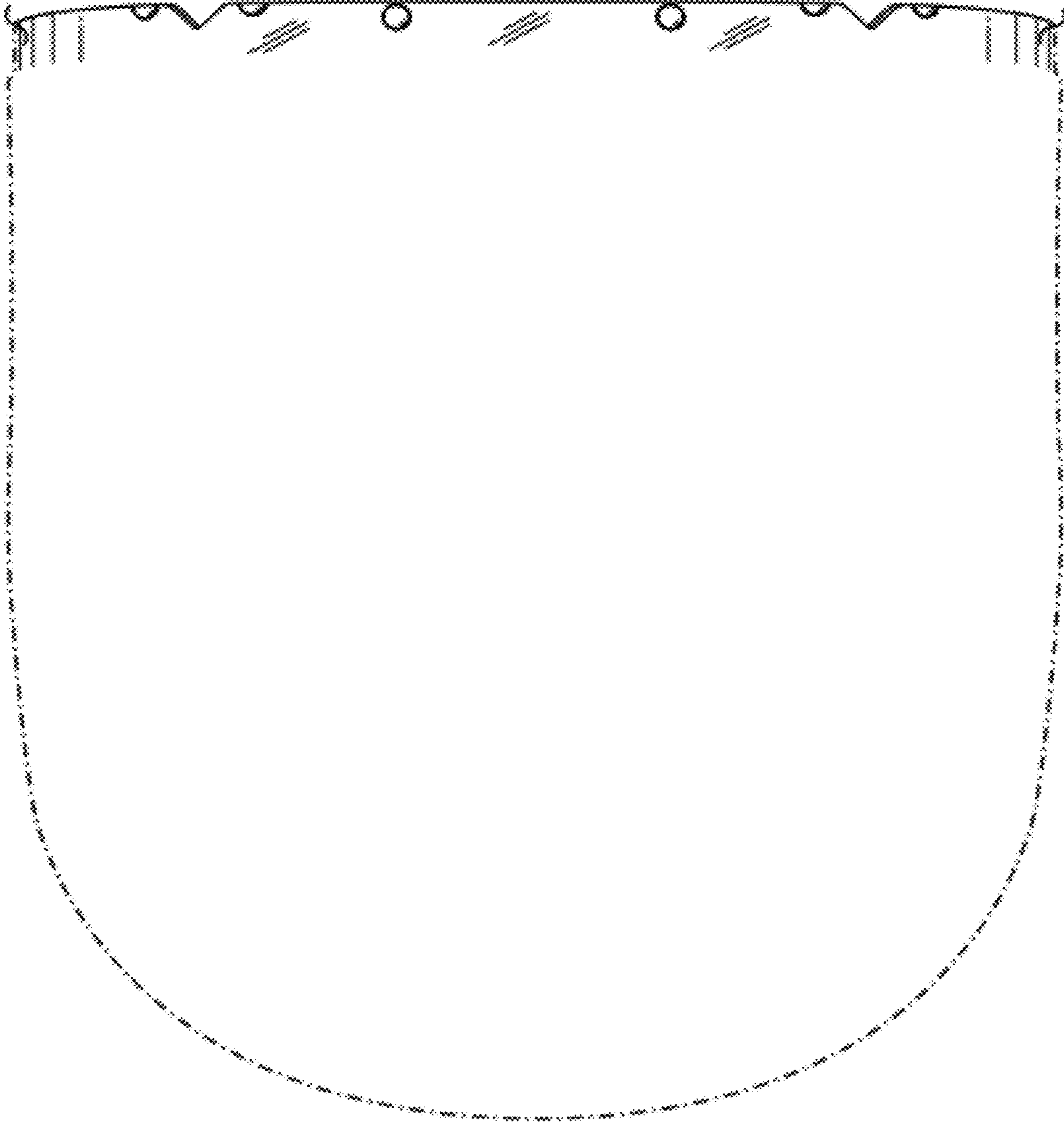

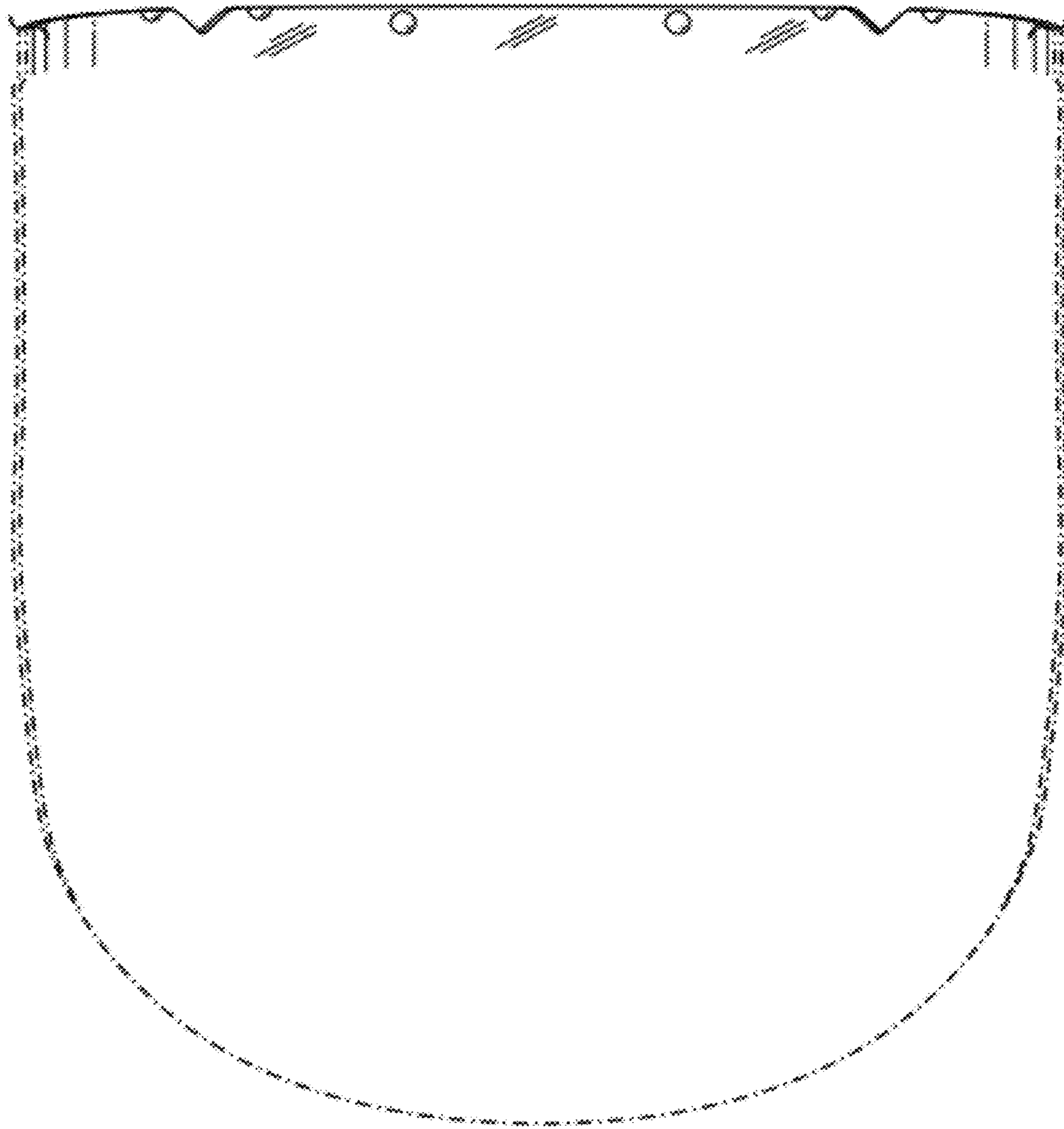

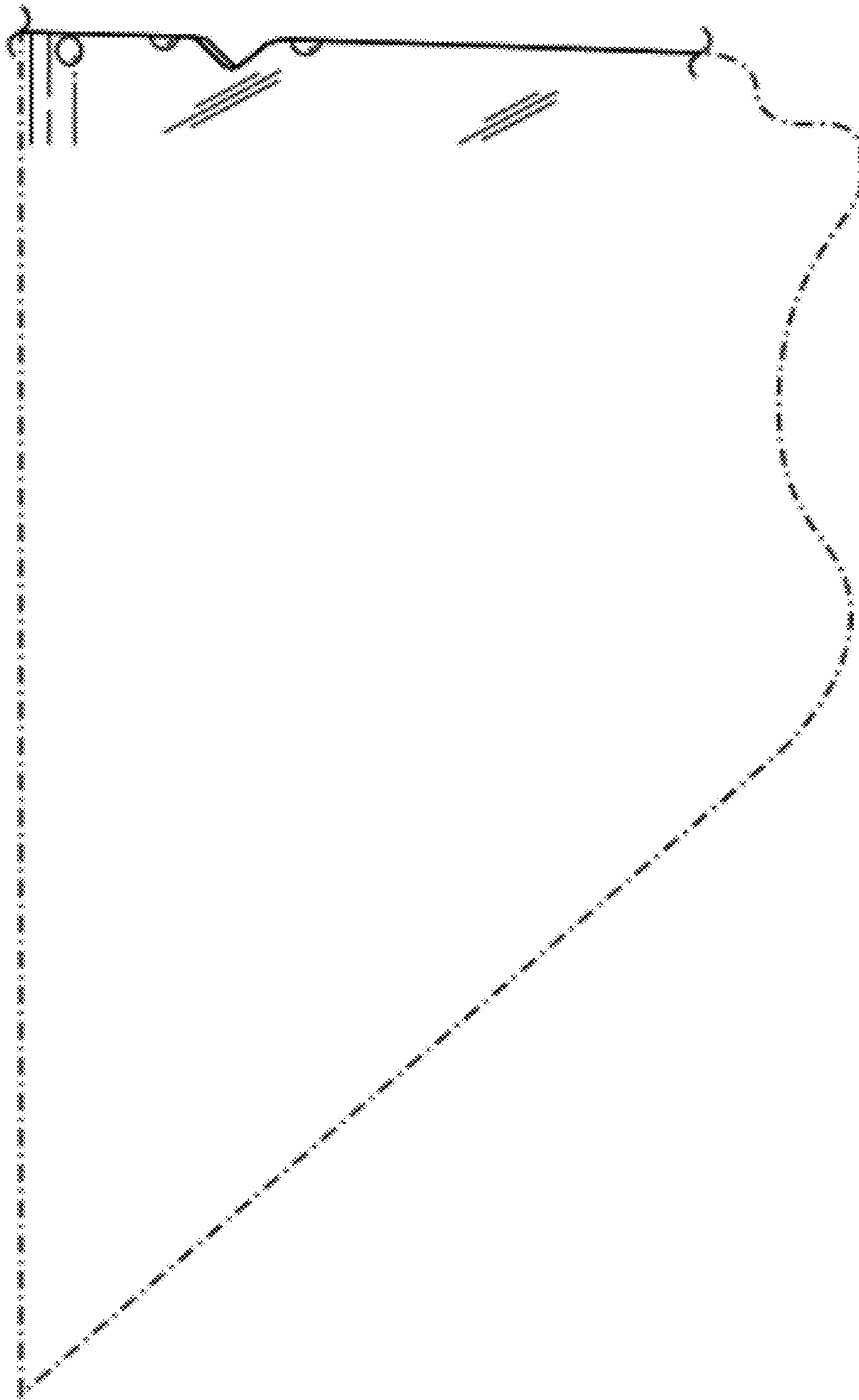

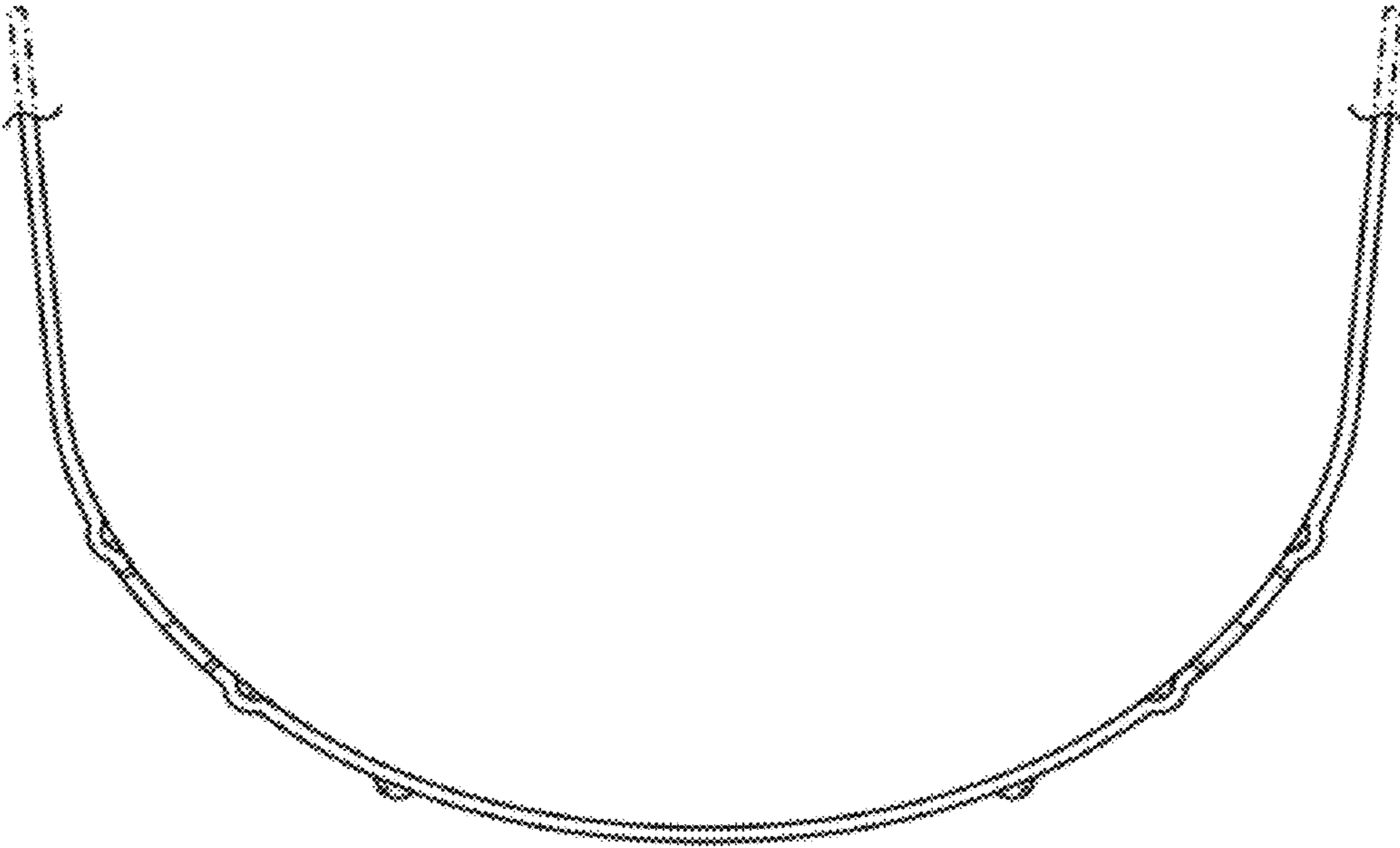

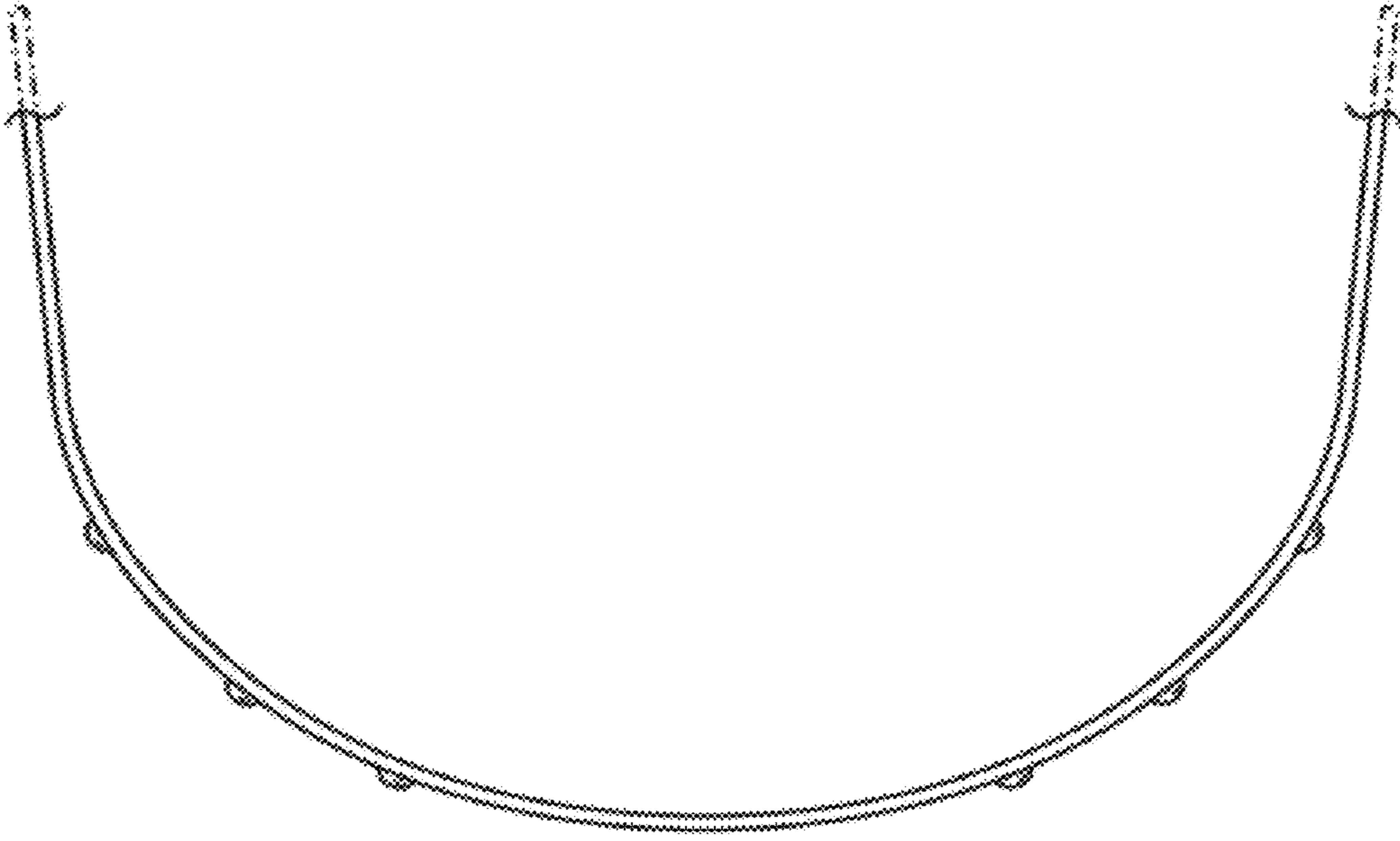
