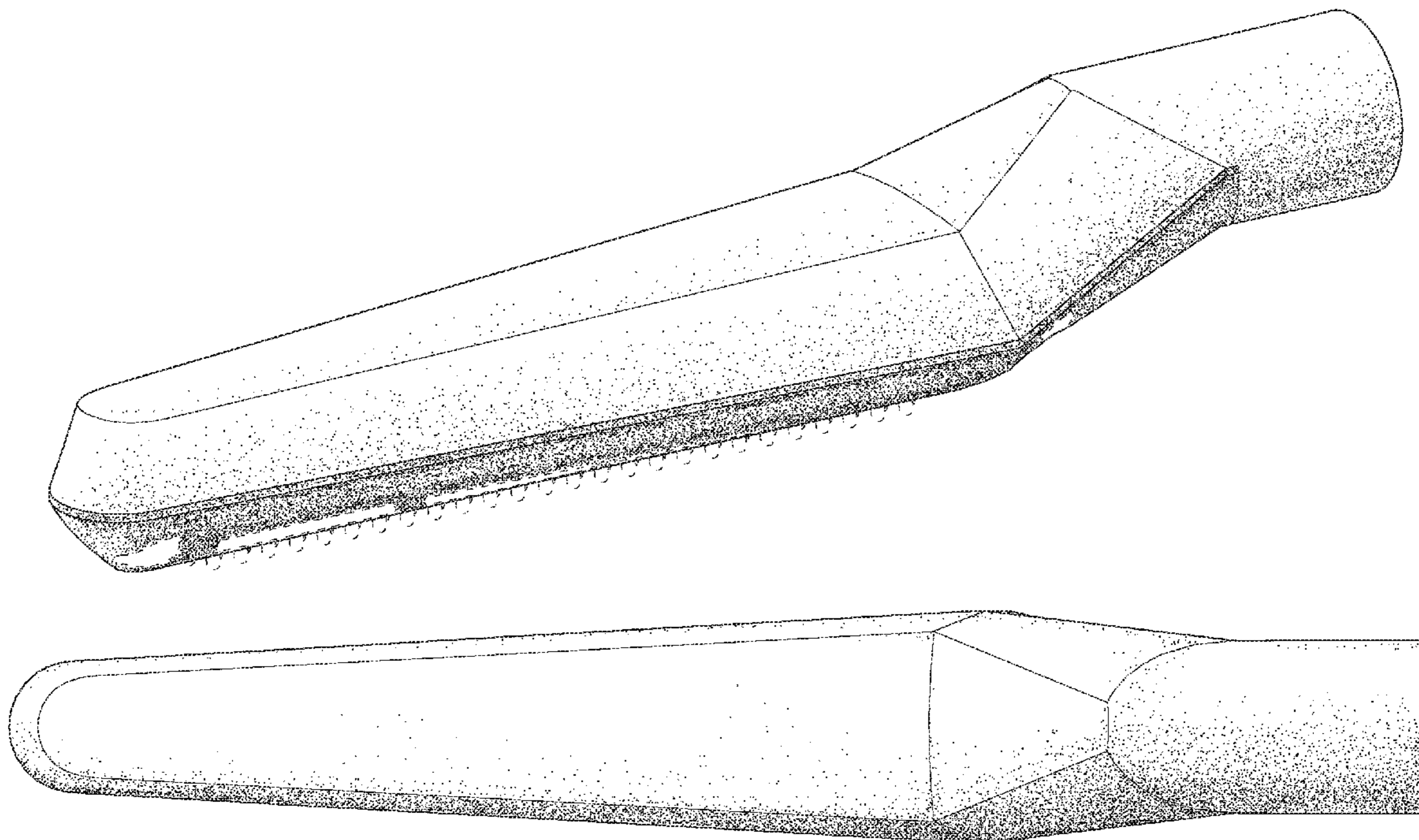
(57) **CLAIM**

The ornamental design for a vacuum accessory pet hair tool, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vacuum accessory pet hair tool which embodies our design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof, the right side view thereof being a mirror image of the left side view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof. Portions of the vacuum accessory pet hair tool shown in broken lines form no part of the claimed design.

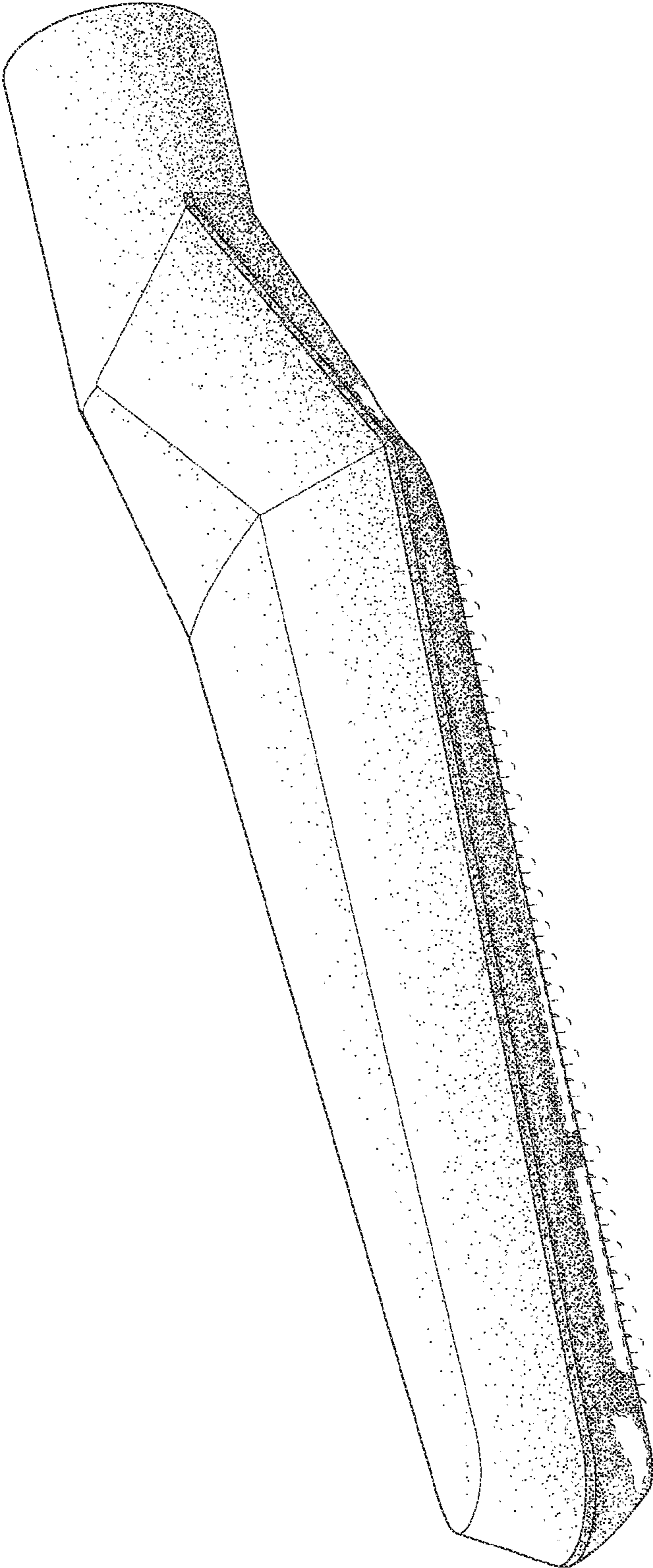

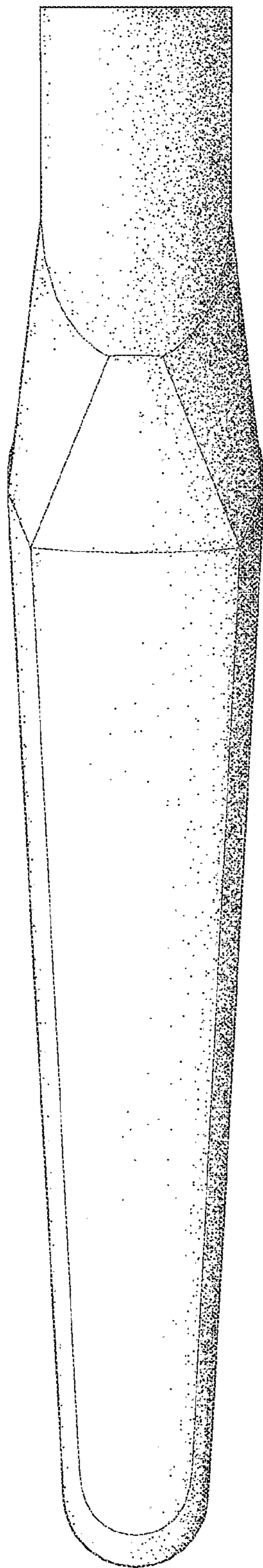

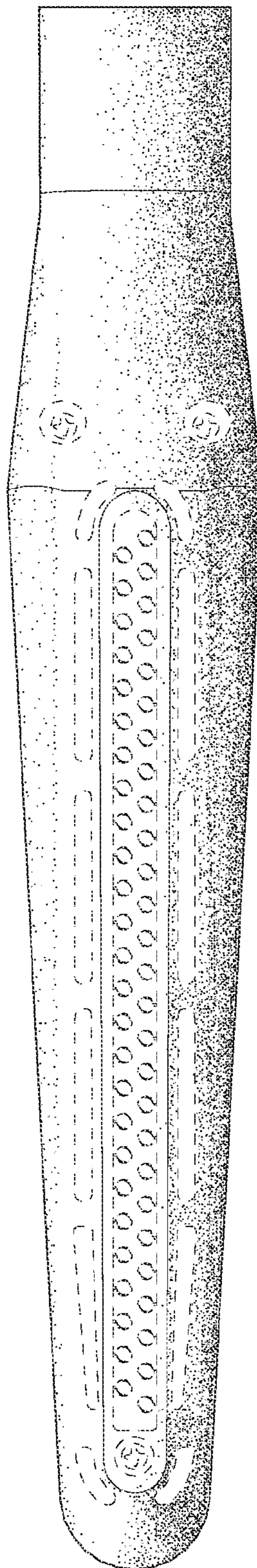

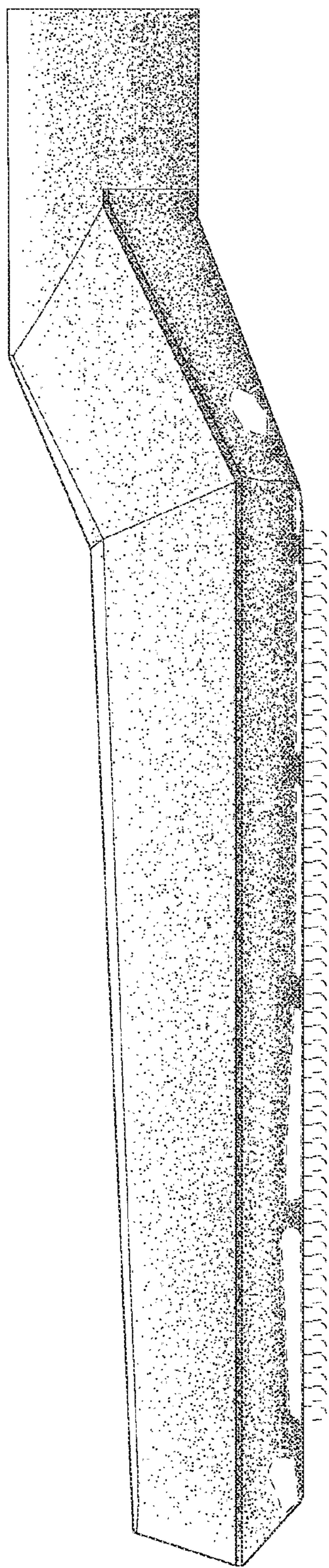

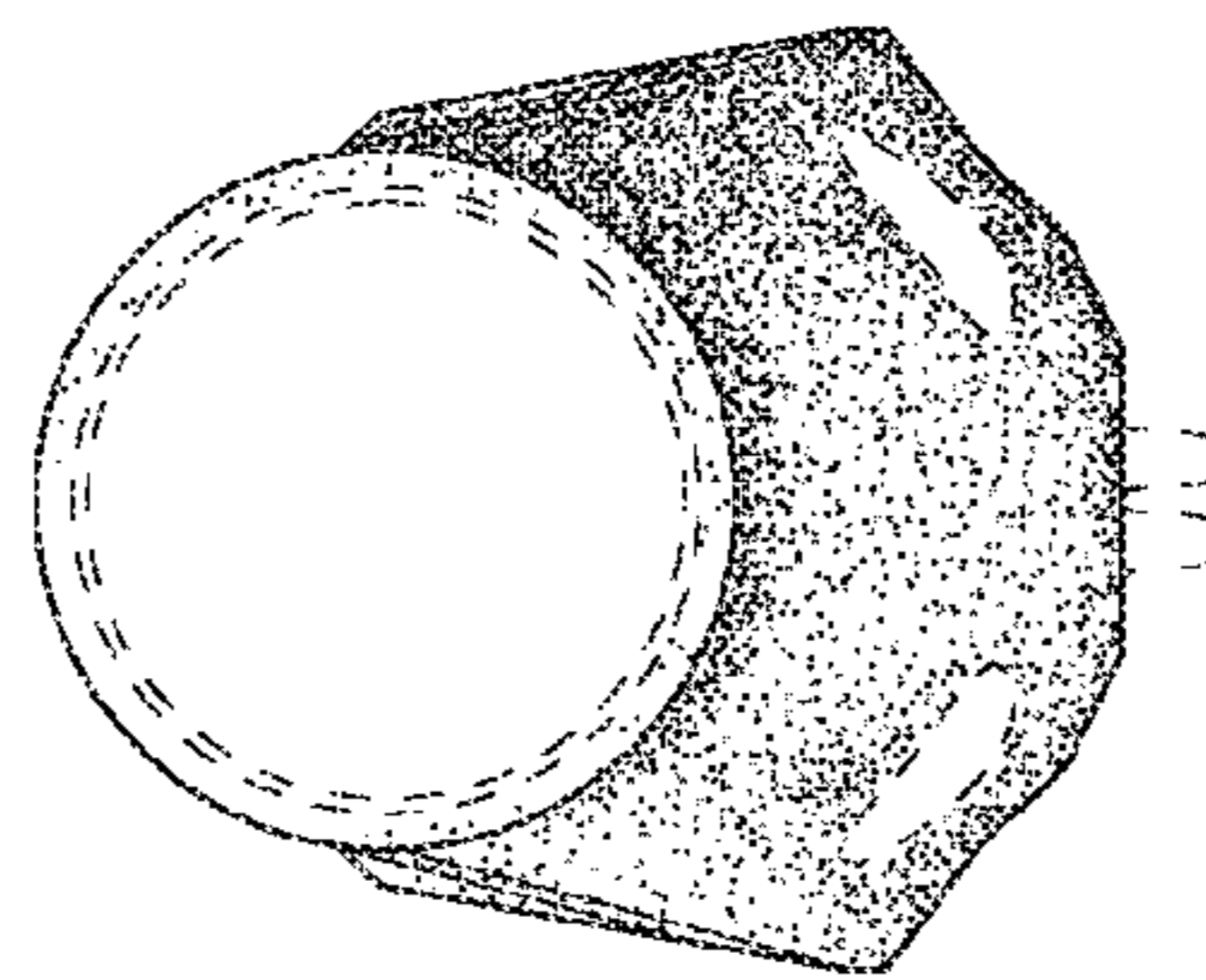

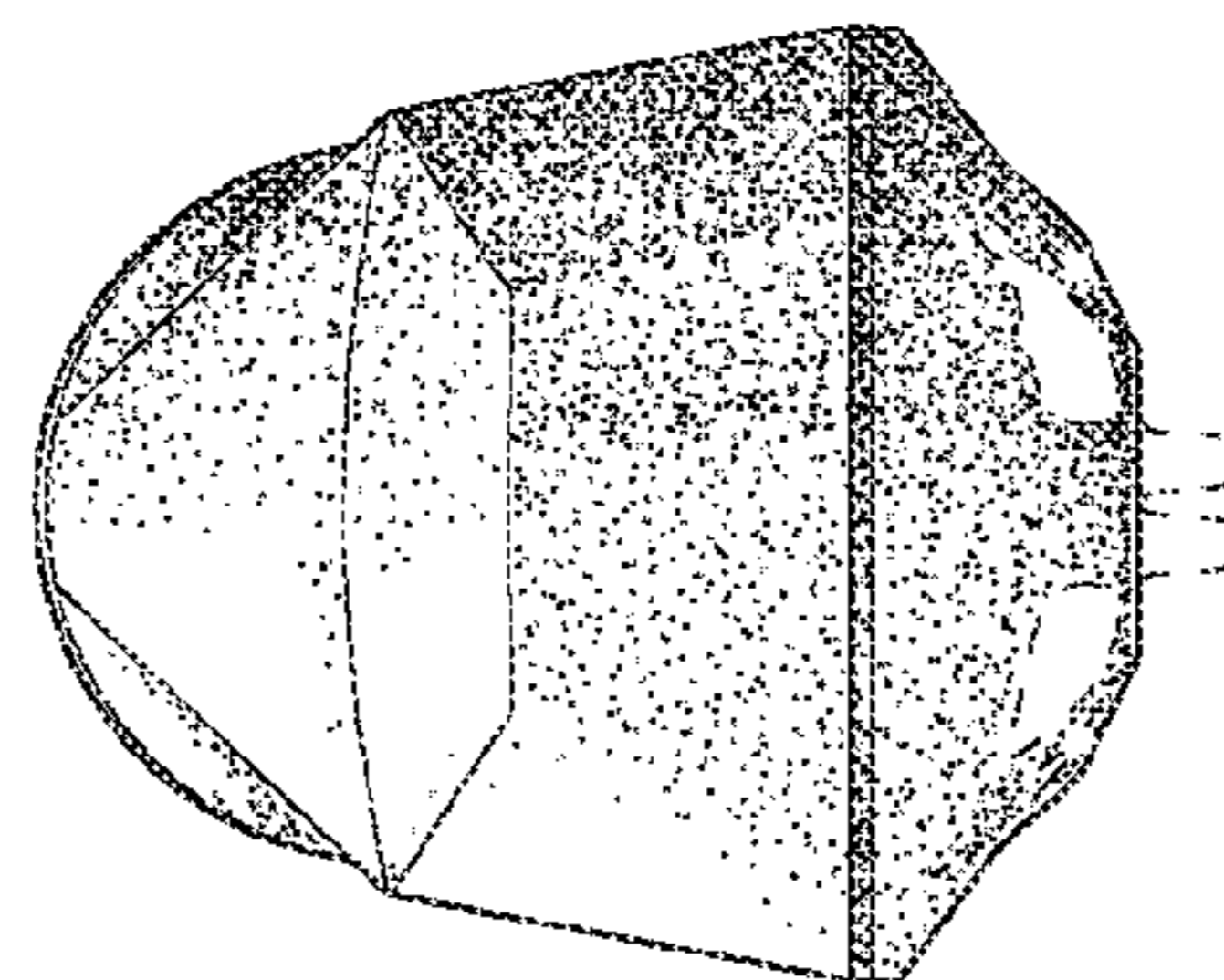
