The ornamental design for a washing machine, as shown and described.

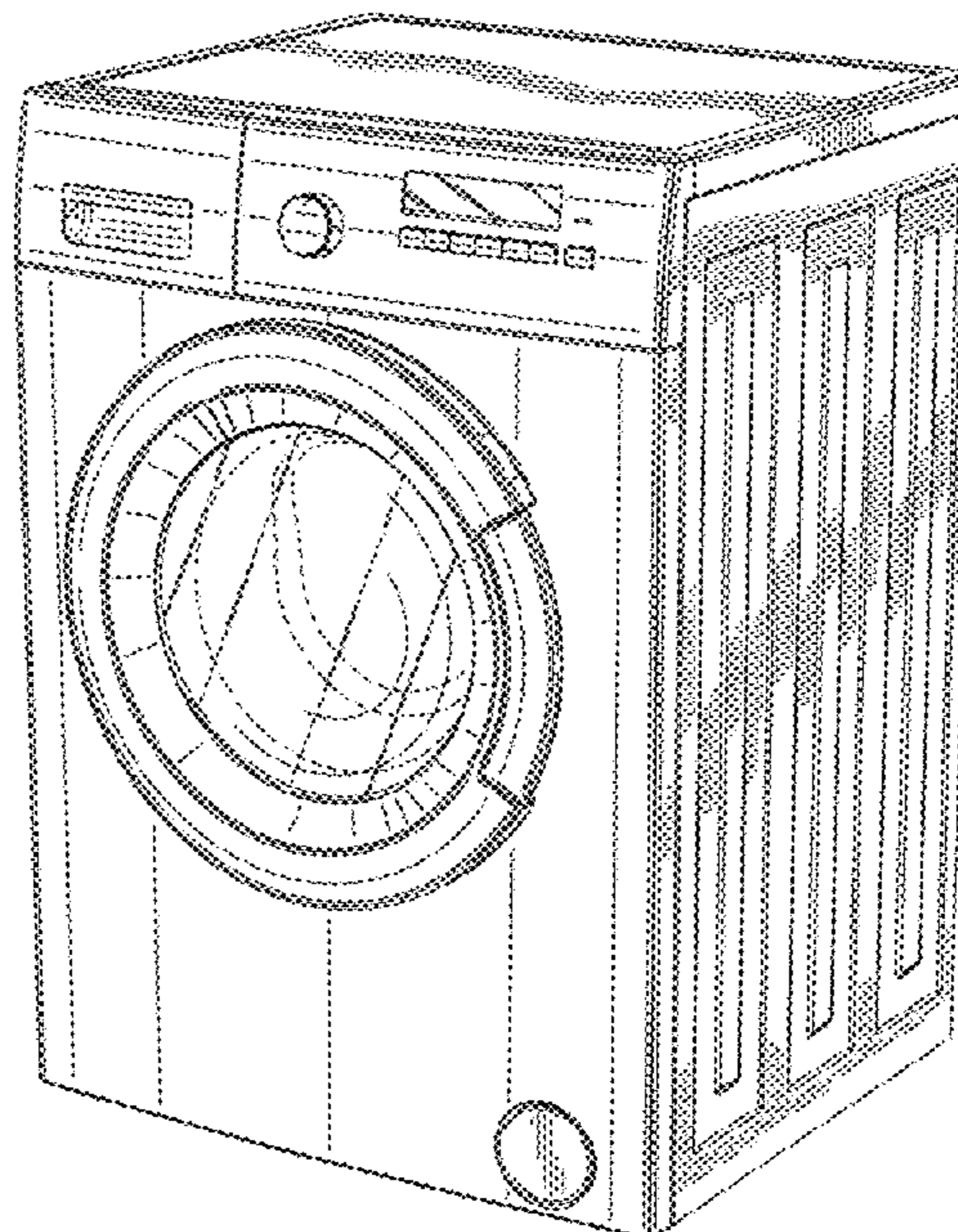
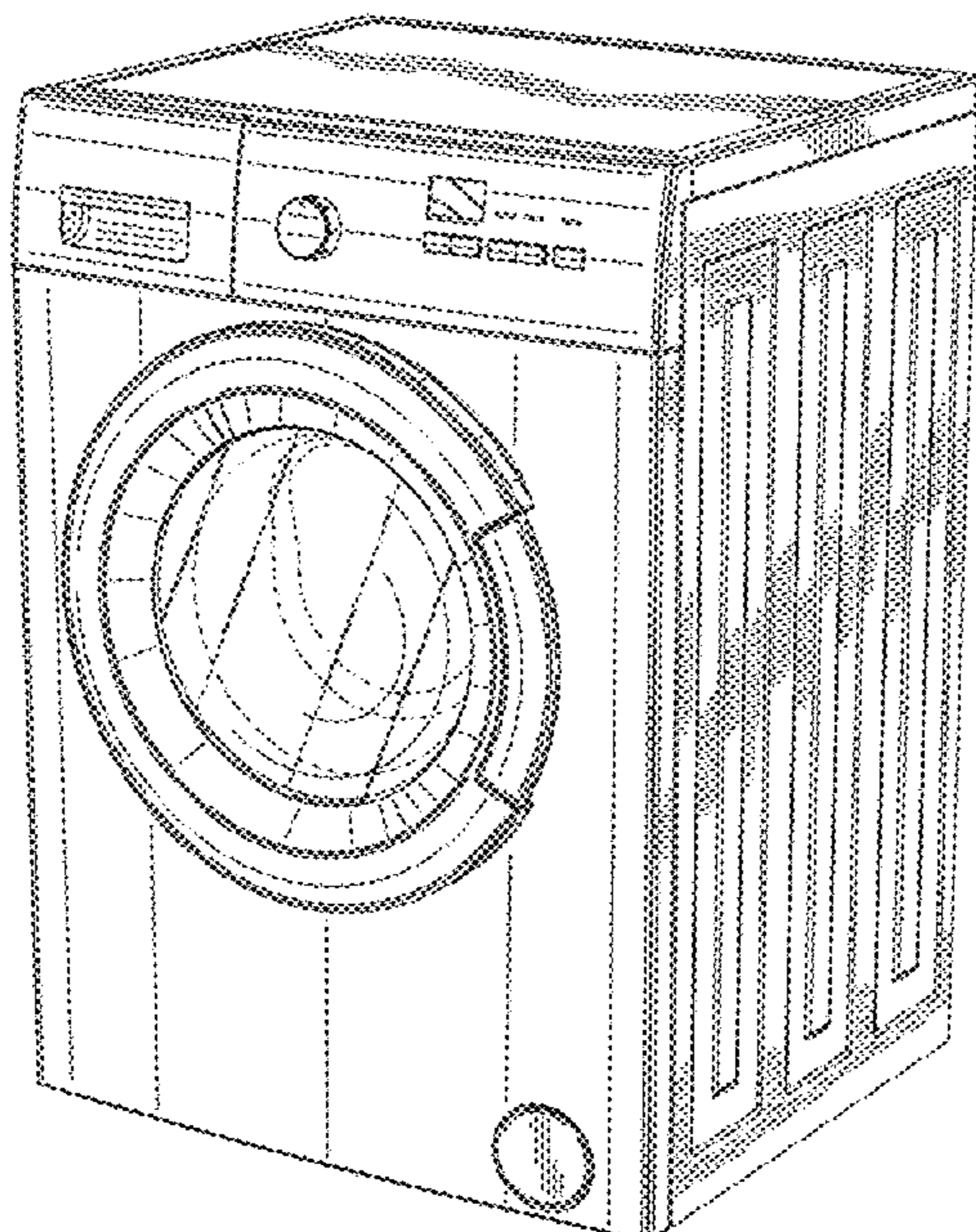
DESCRIPTION

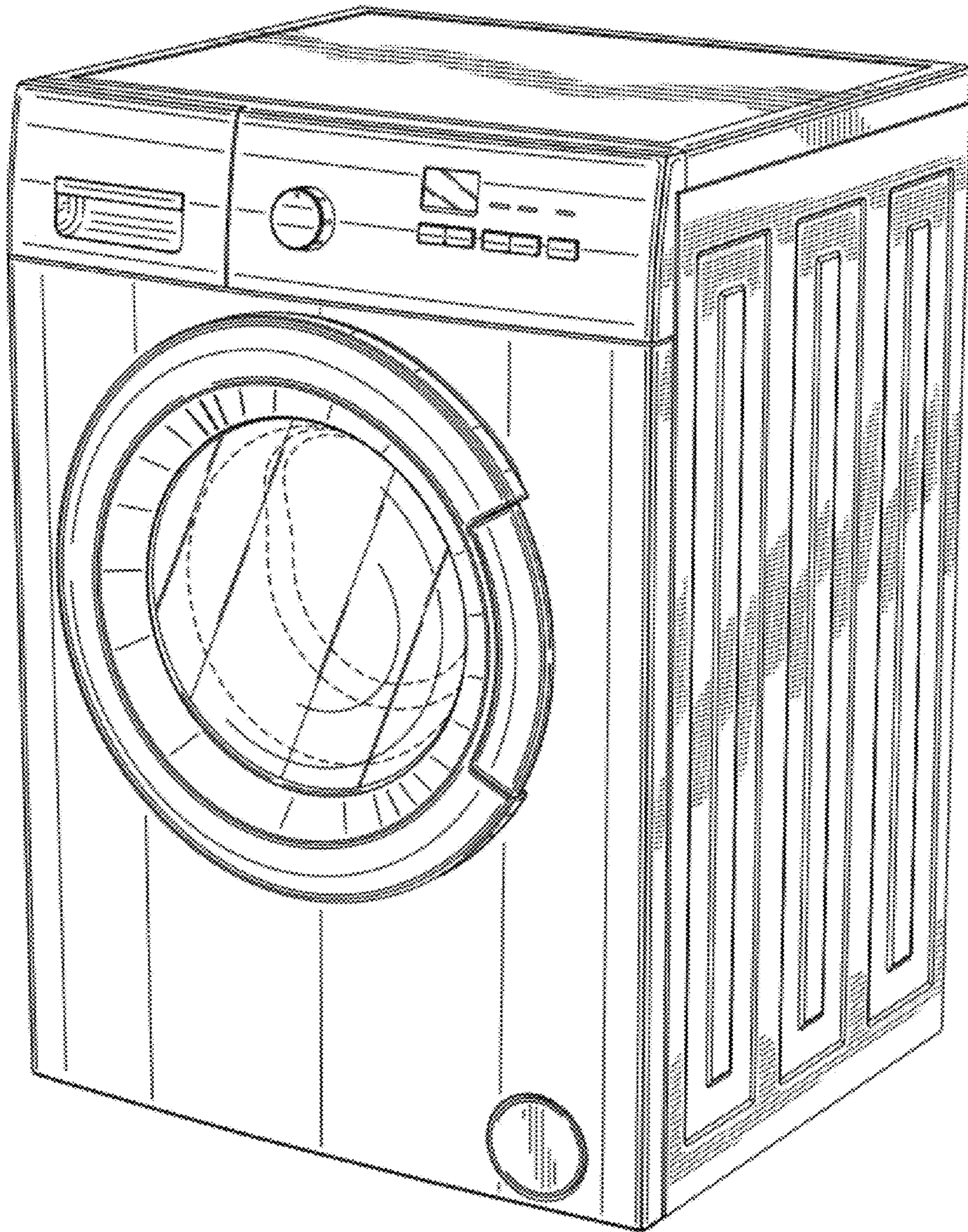

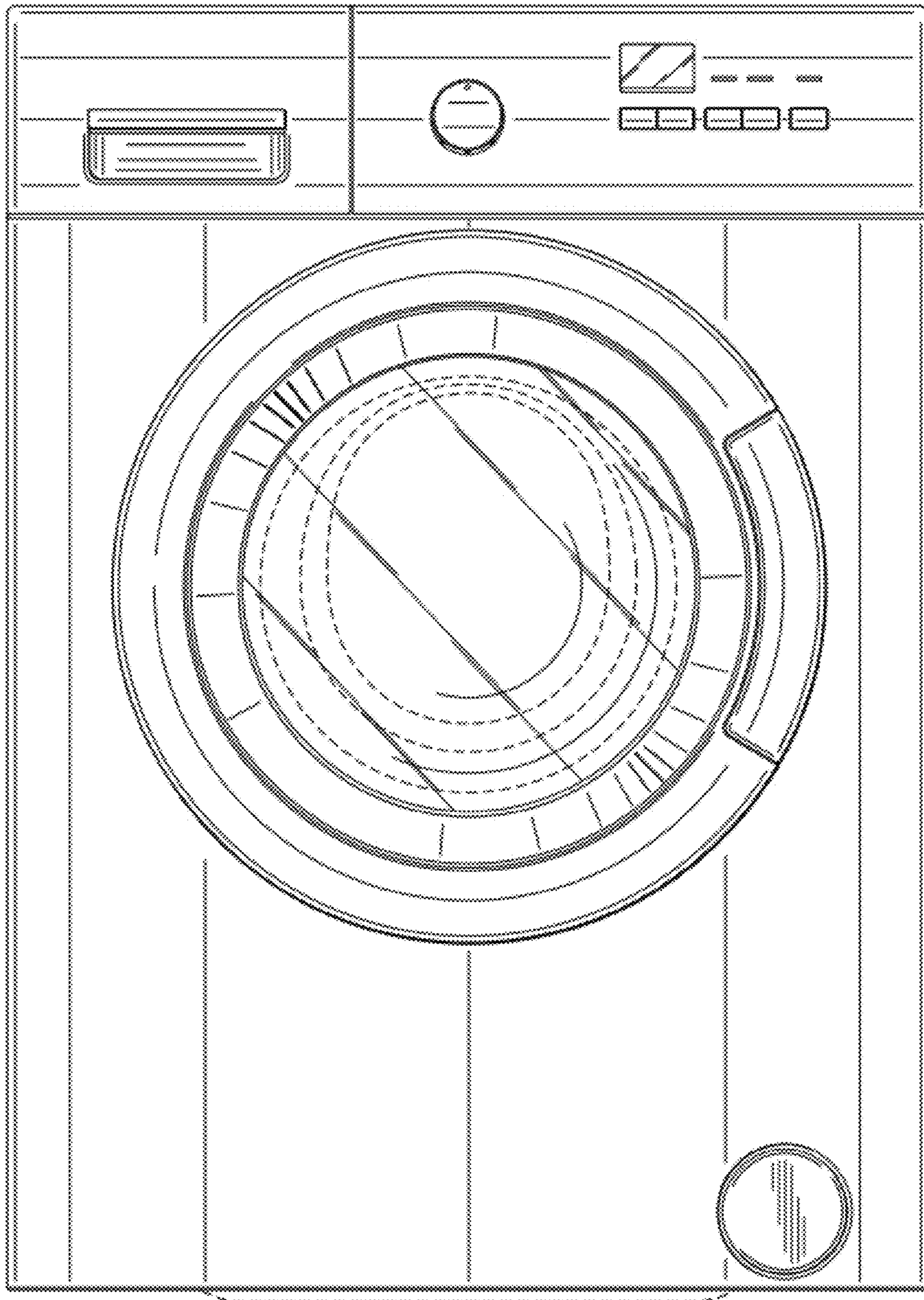

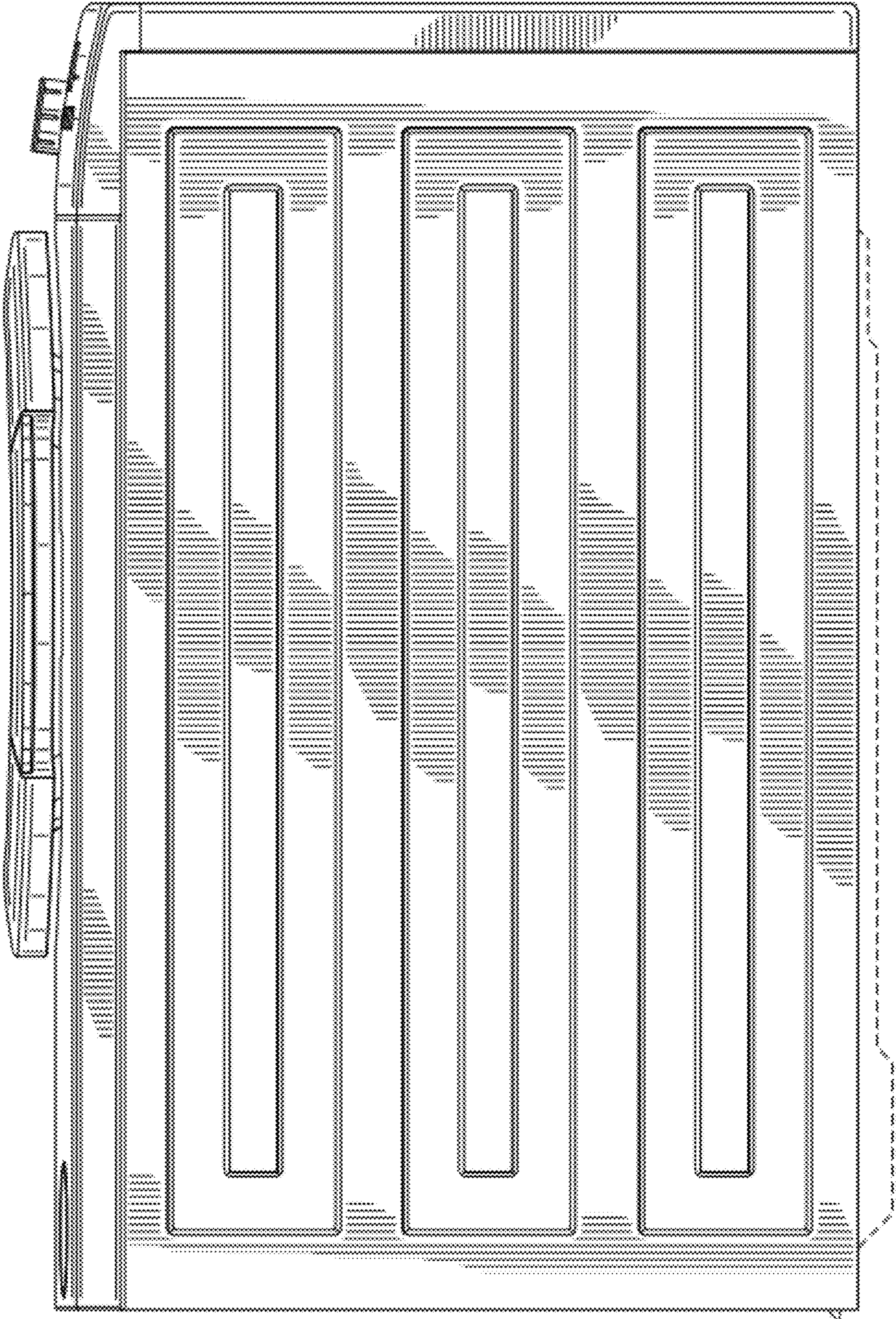

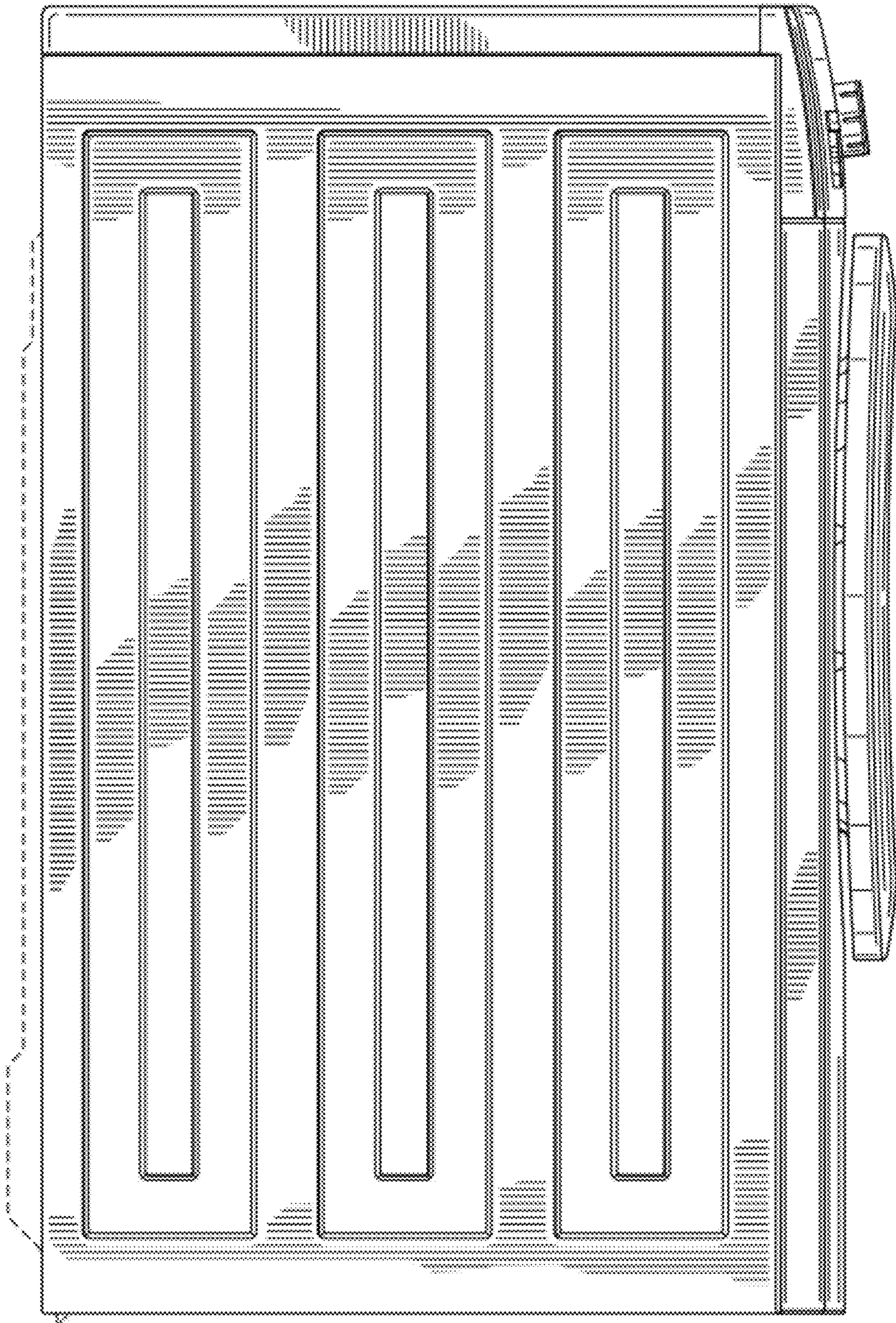

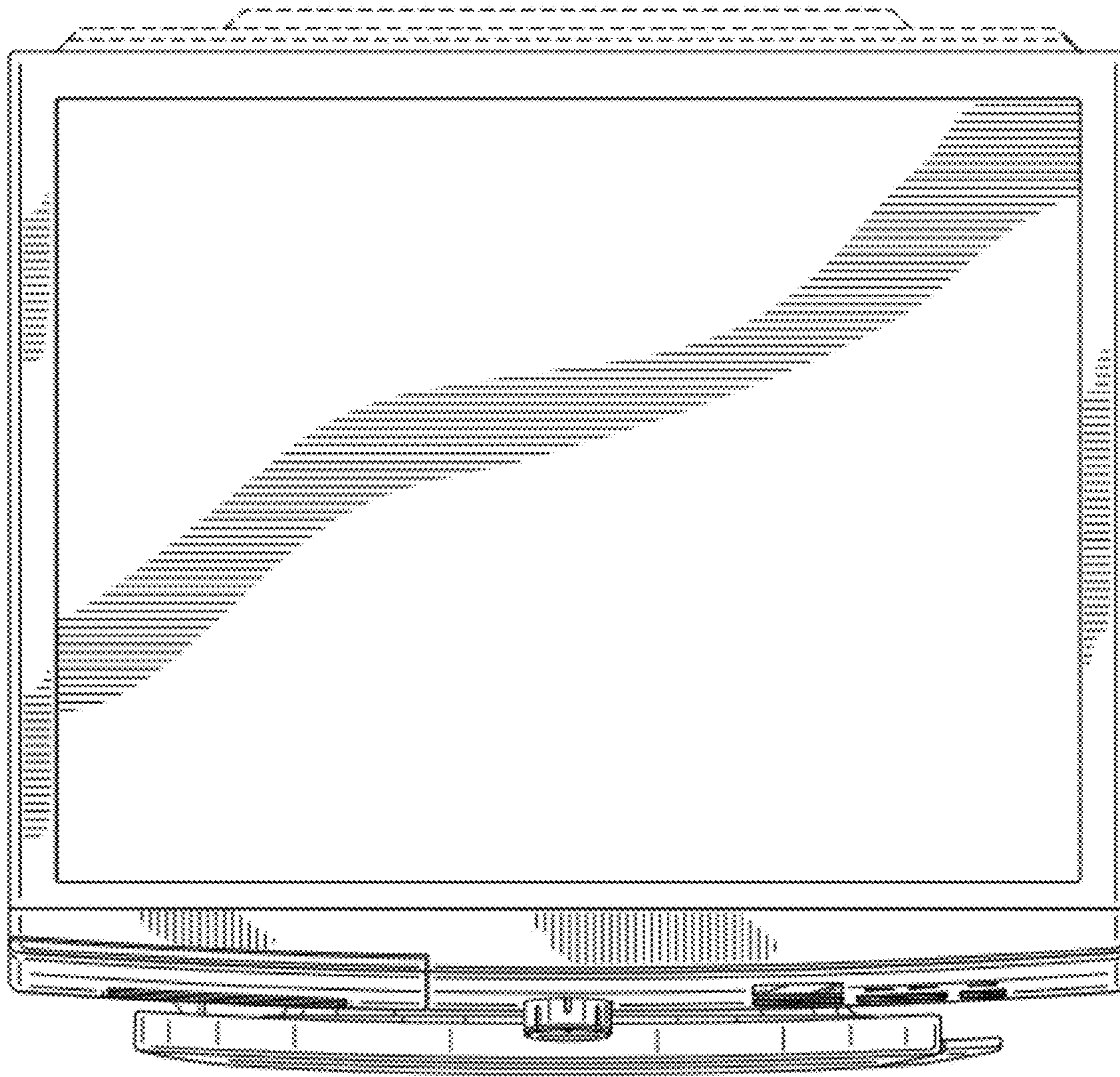

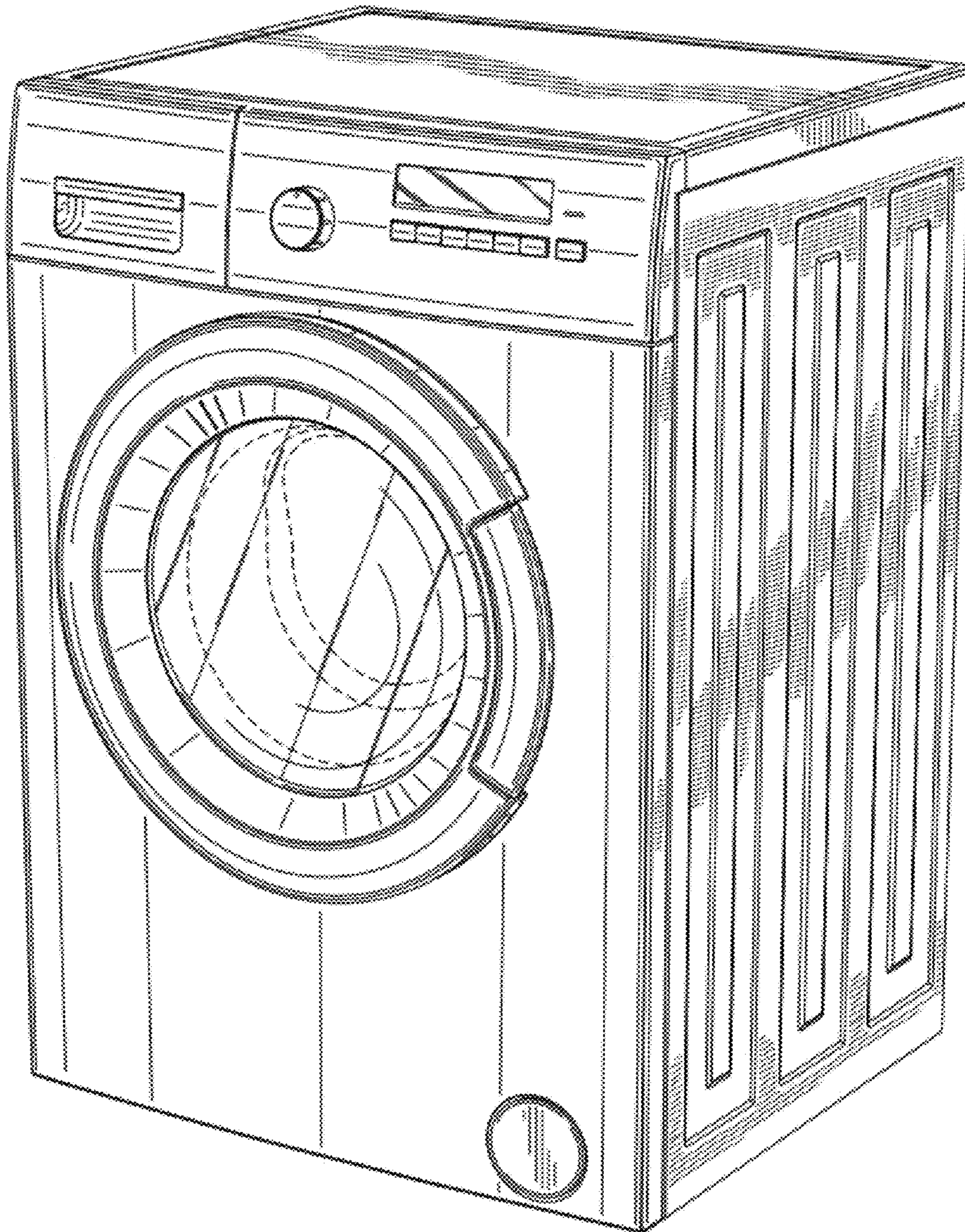

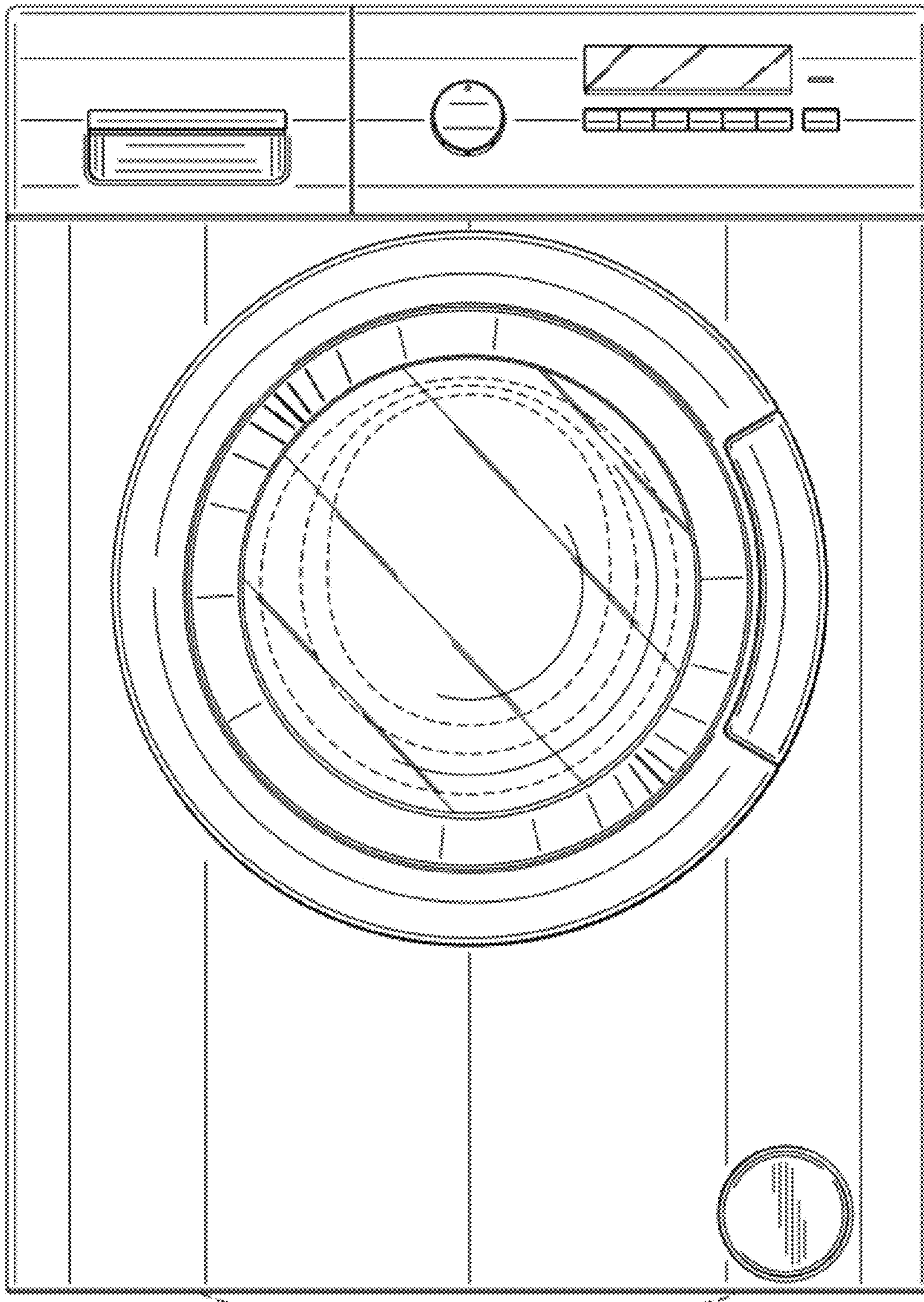

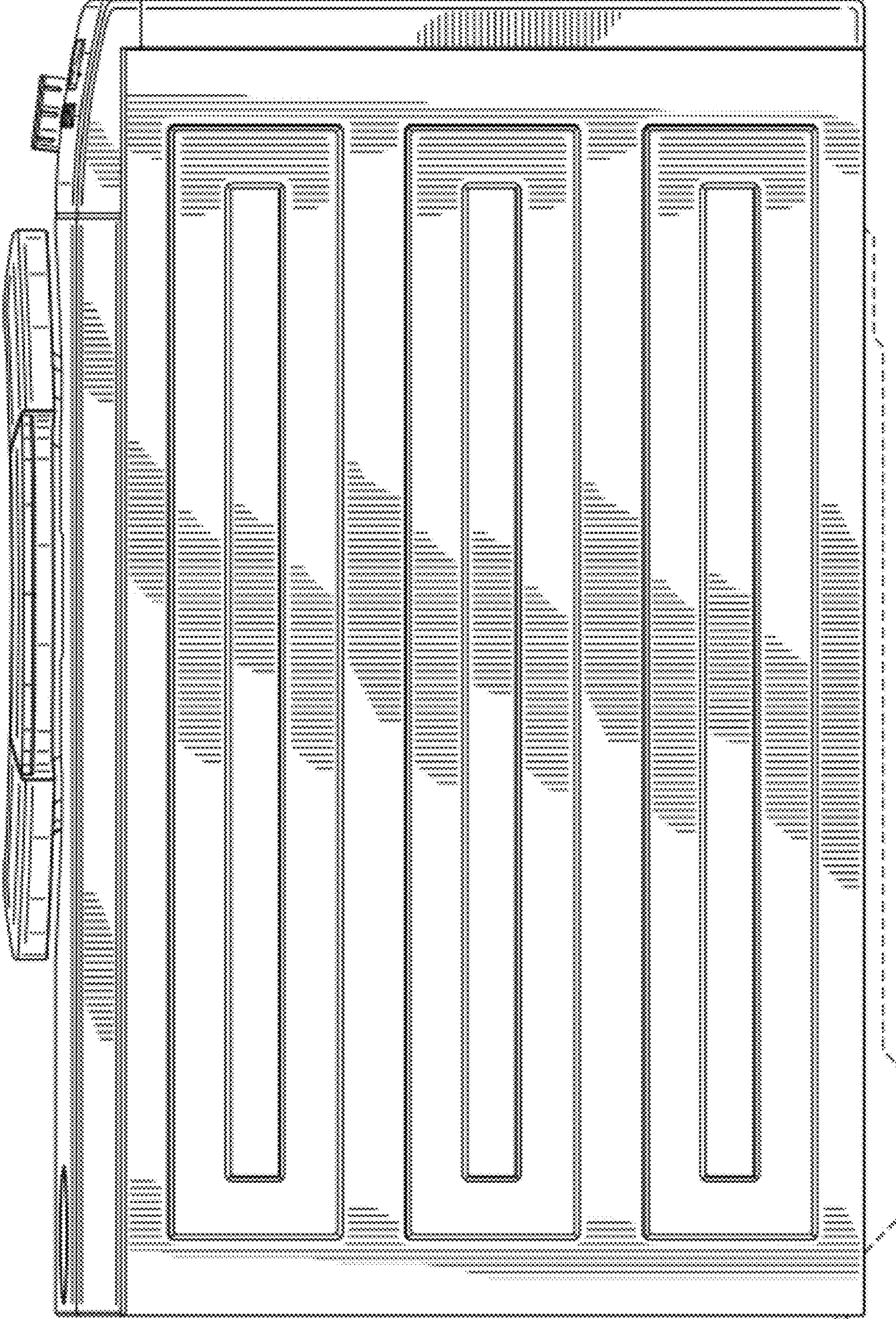

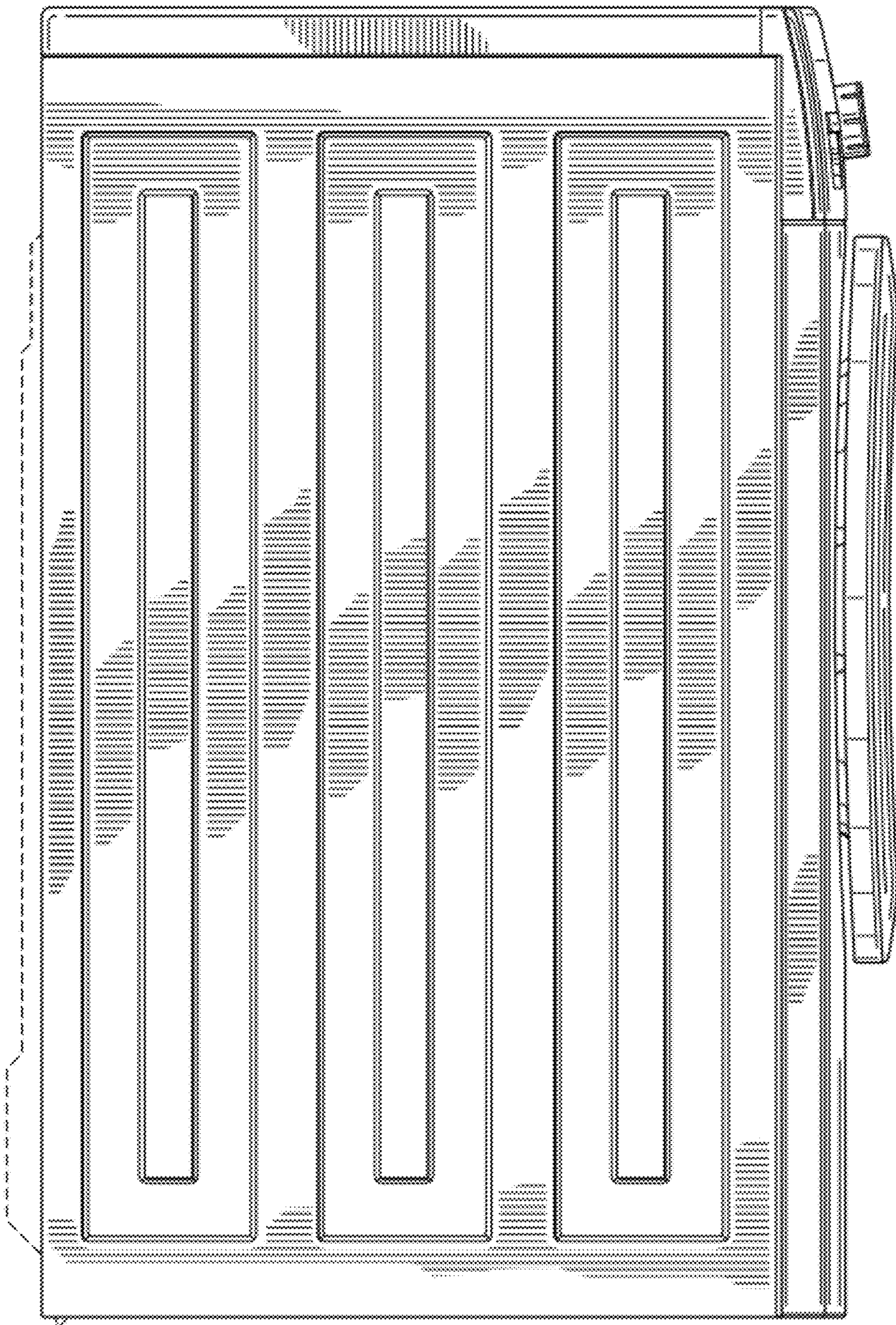

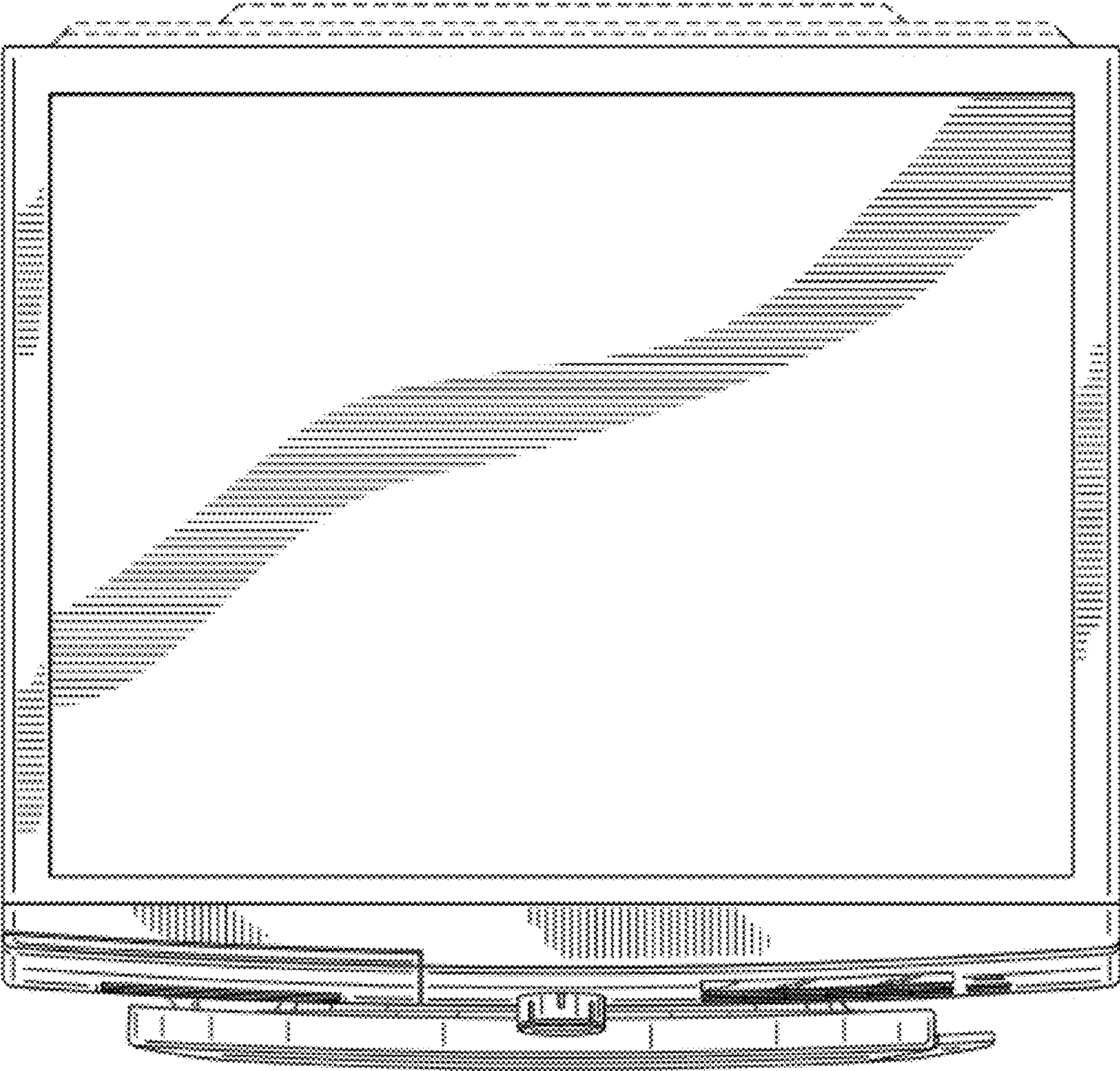
