(57) **CLAIM**

I claim the ornamental design for a neck pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a neck pillow, illustrated in an unfastened configuration with the pillow in a deflated configuration.

FIG. 2 is a top plan view of FIG. 1;

FIG. 3 is a left-side elevational view of FIG. 1;

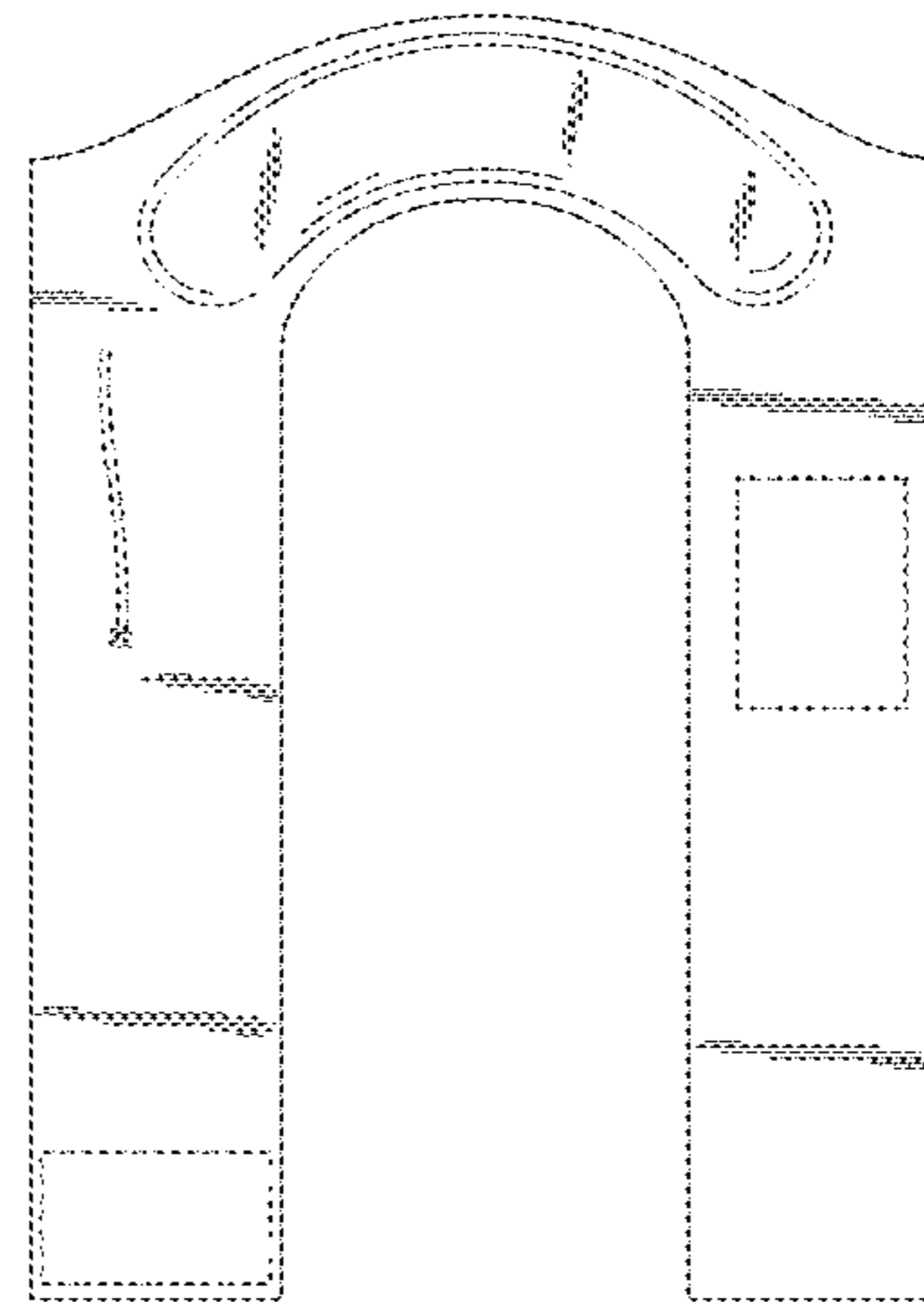
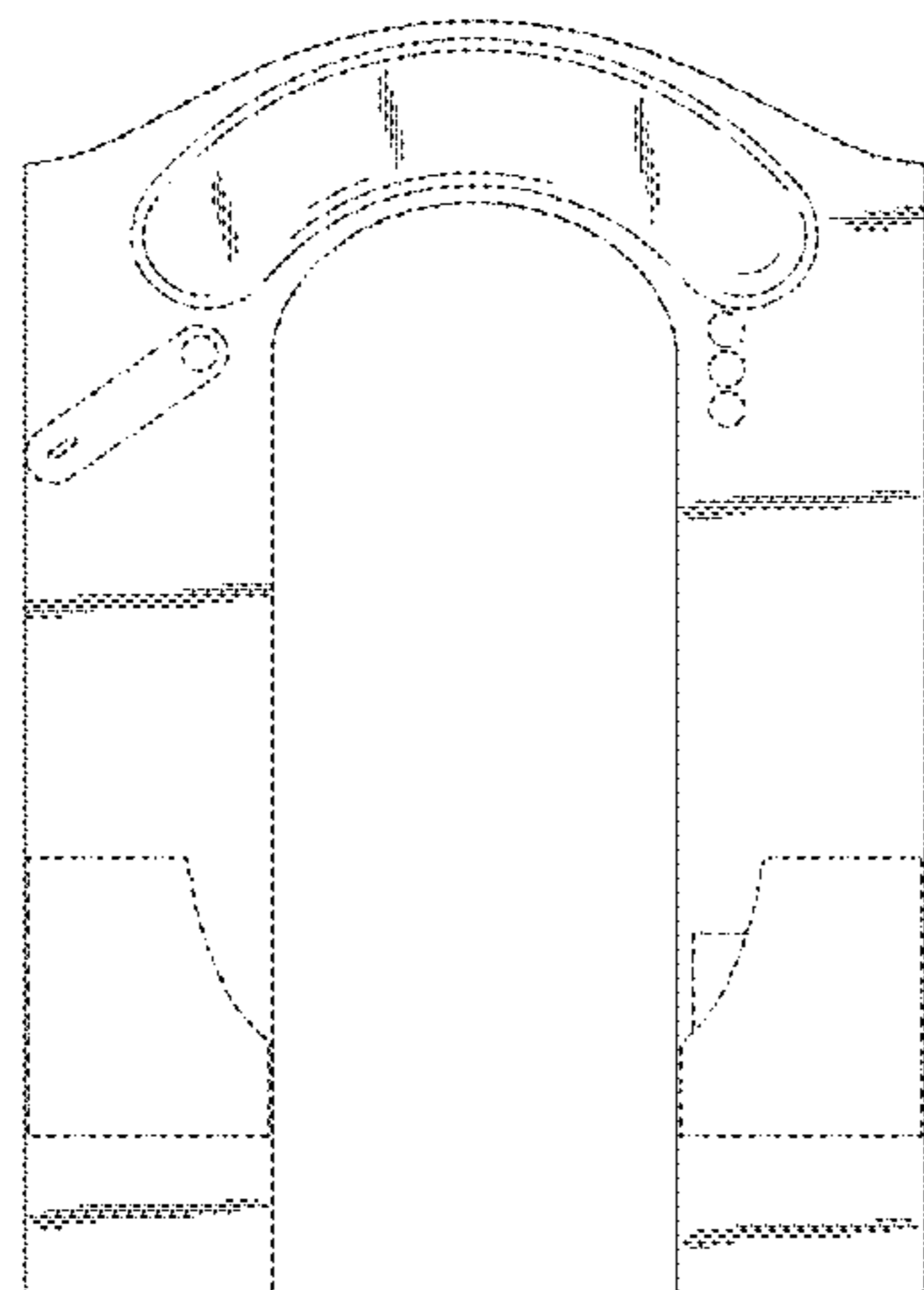
FIG. 4 is a rear elevational view of FIG. 1;

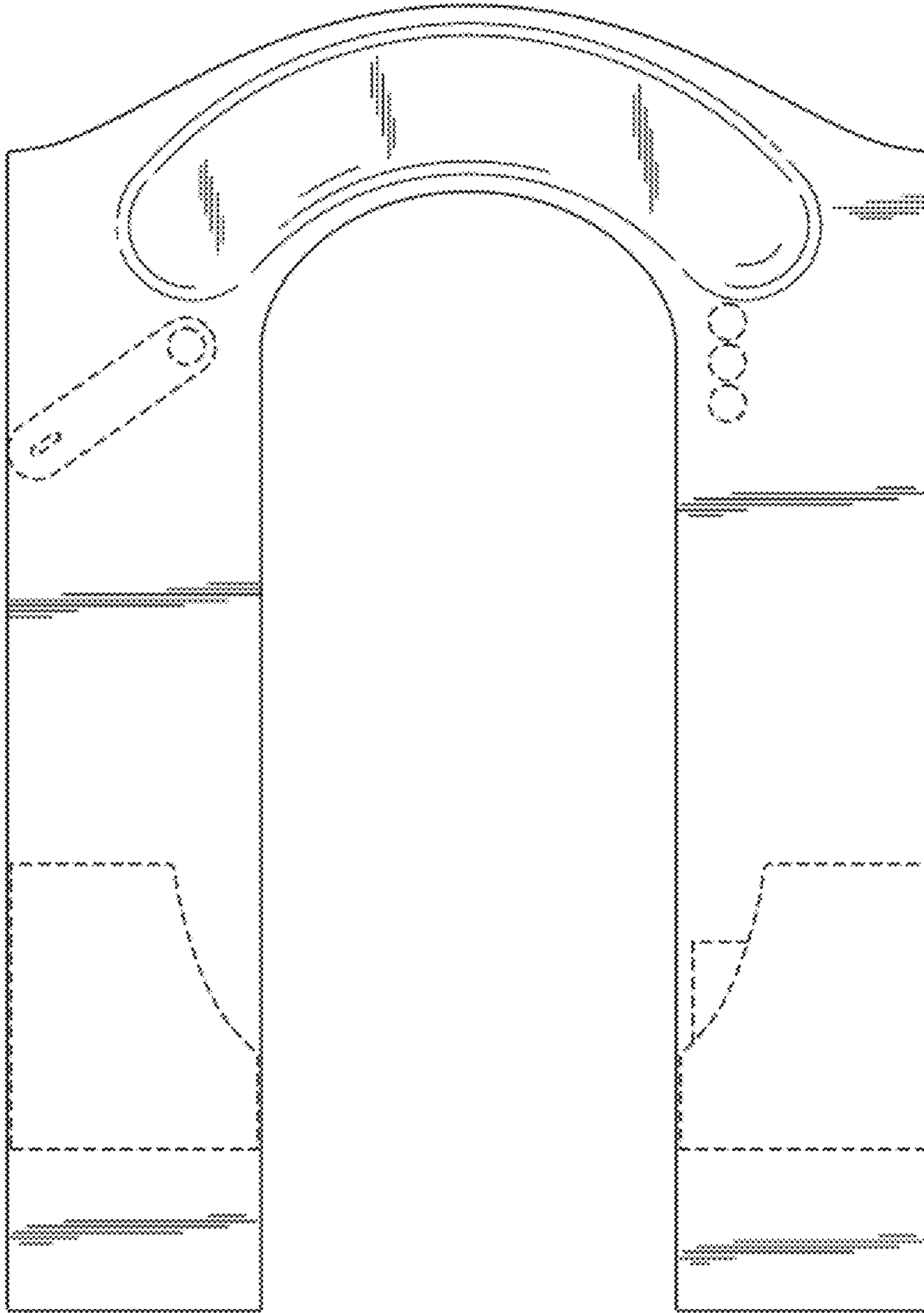

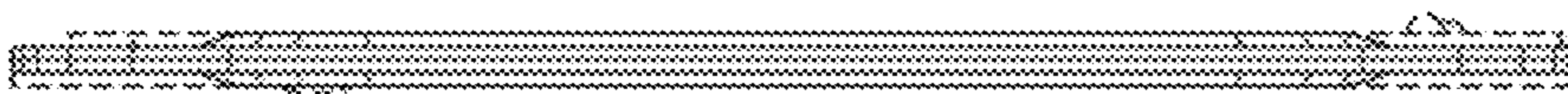

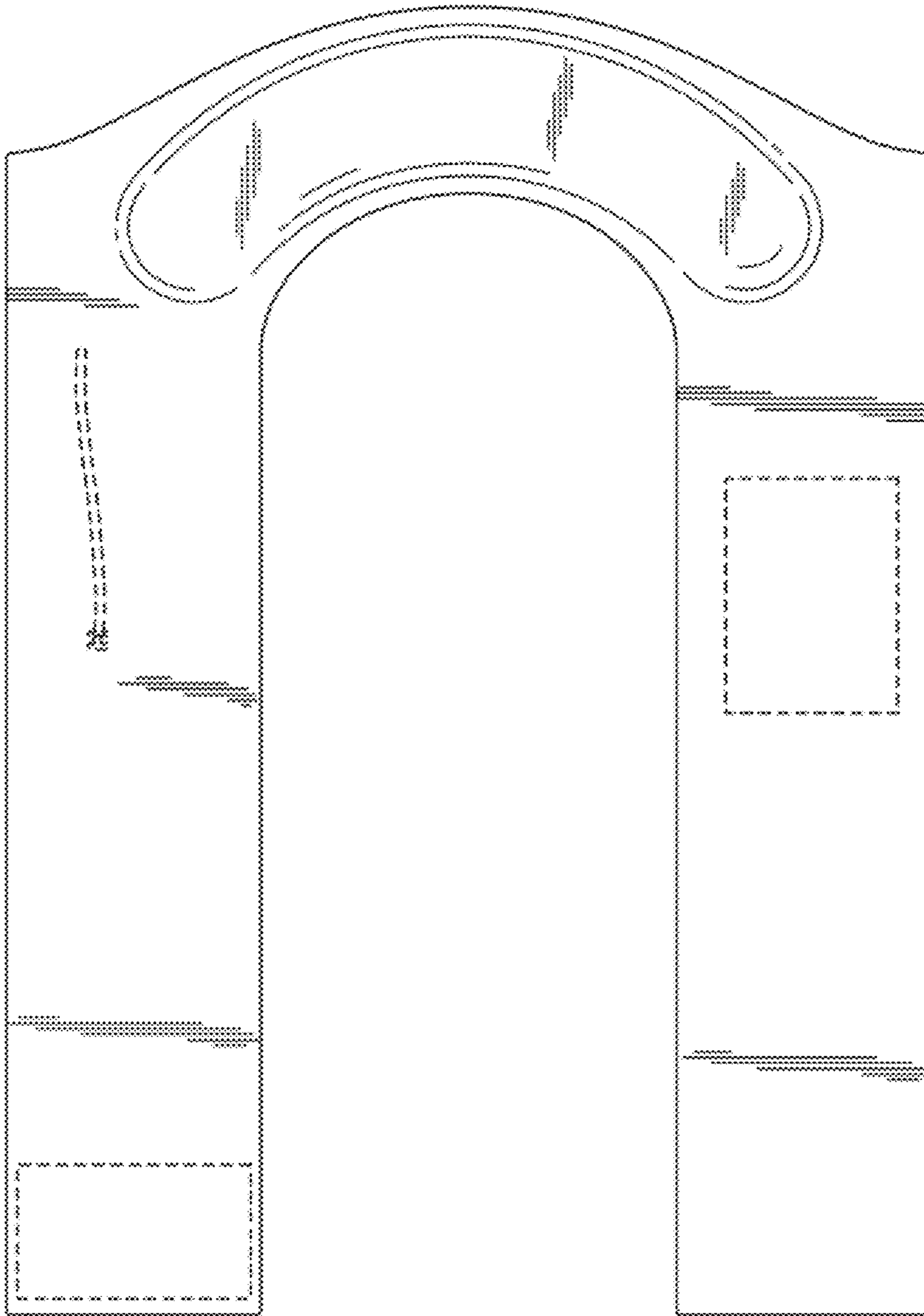
