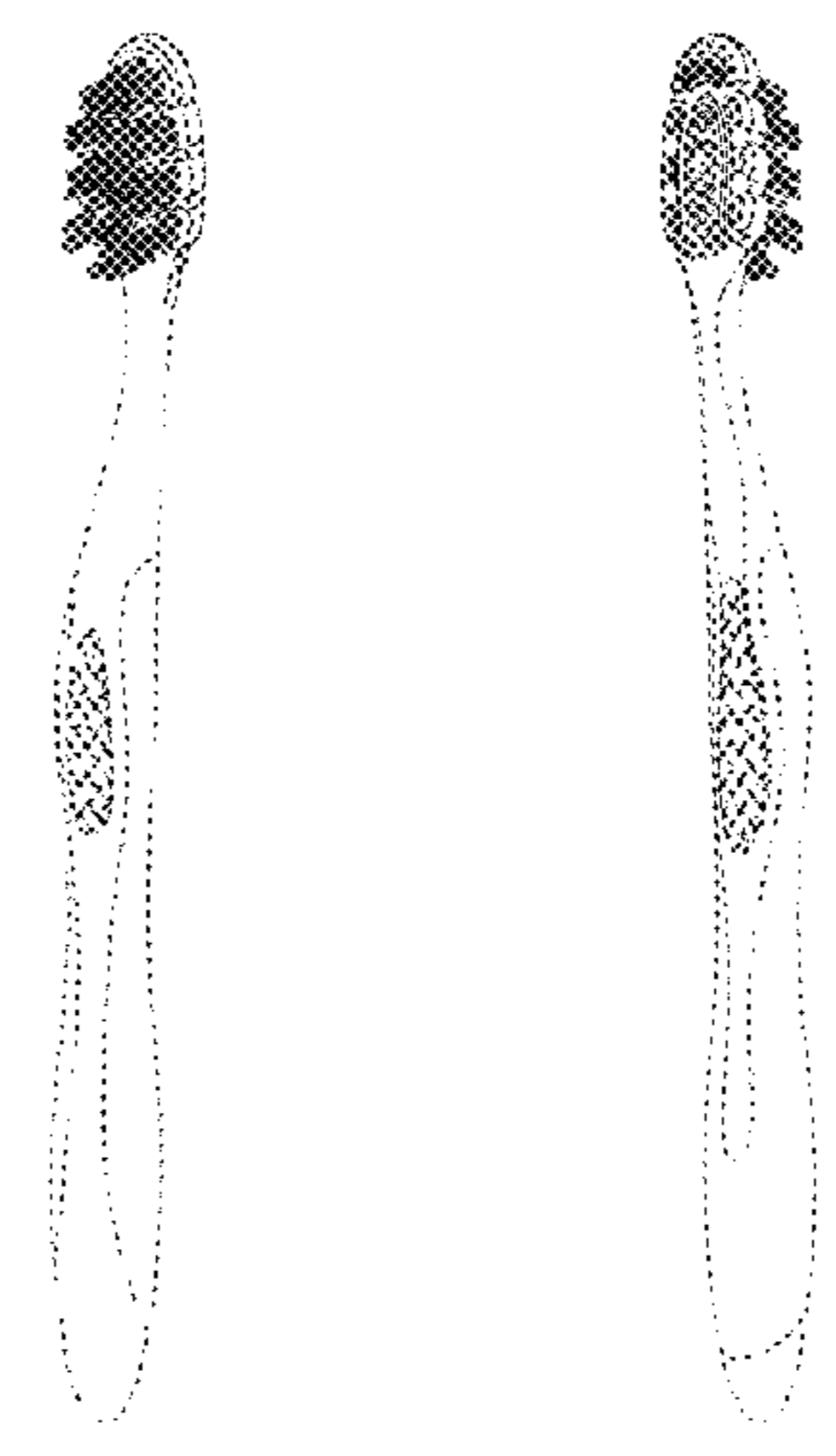

The ornamental design for an oral care implement, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of an oral care implement according to the new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.
The broken lines showing the handle portion of the oral care implement form no part of the claimed design.

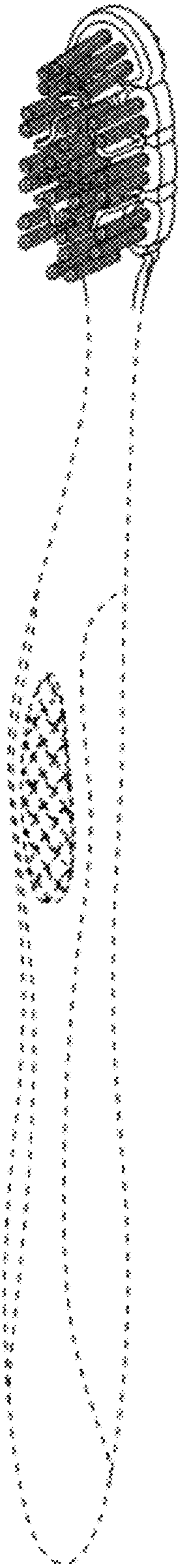

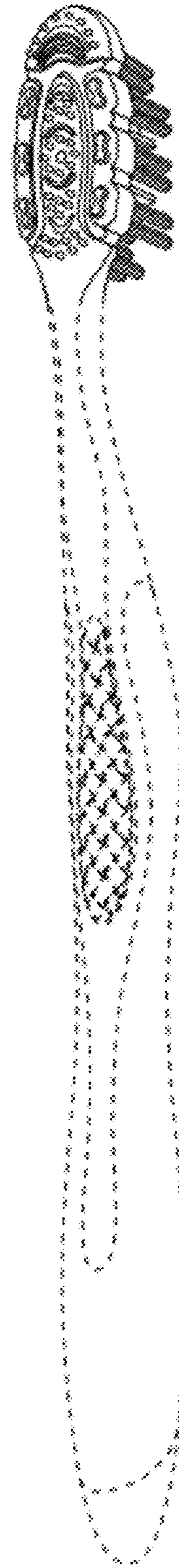

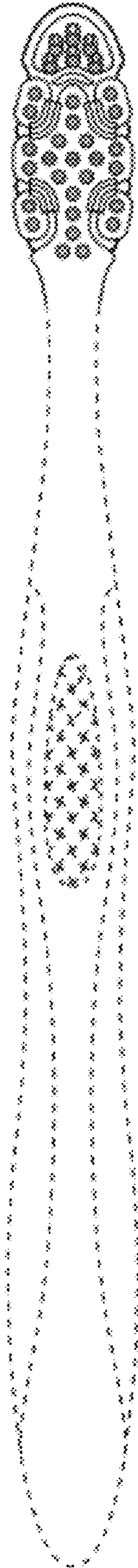

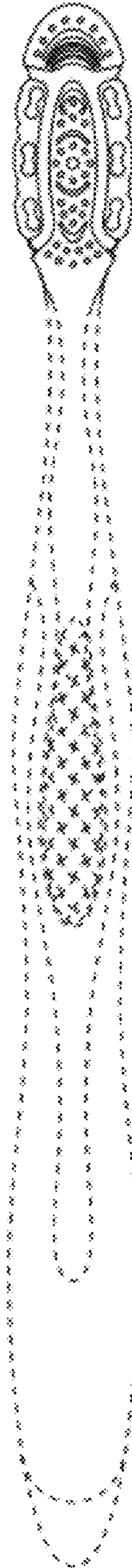

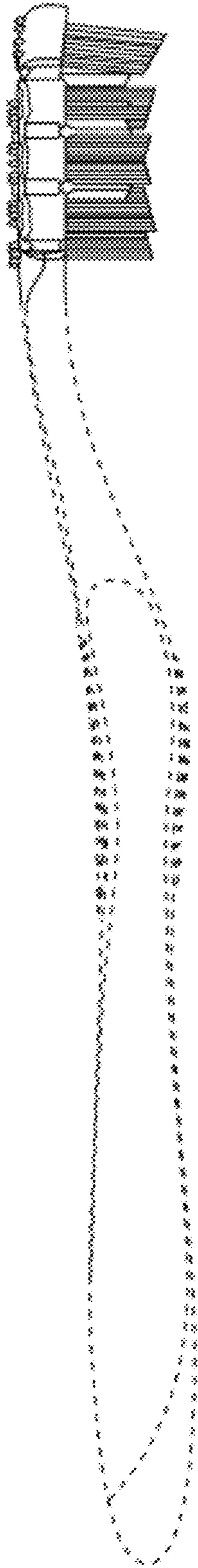

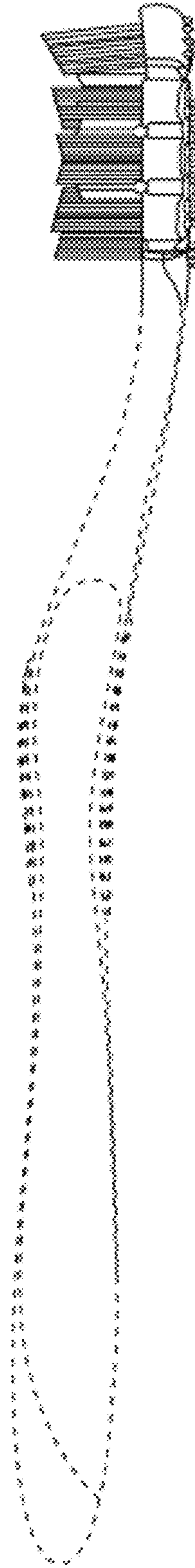

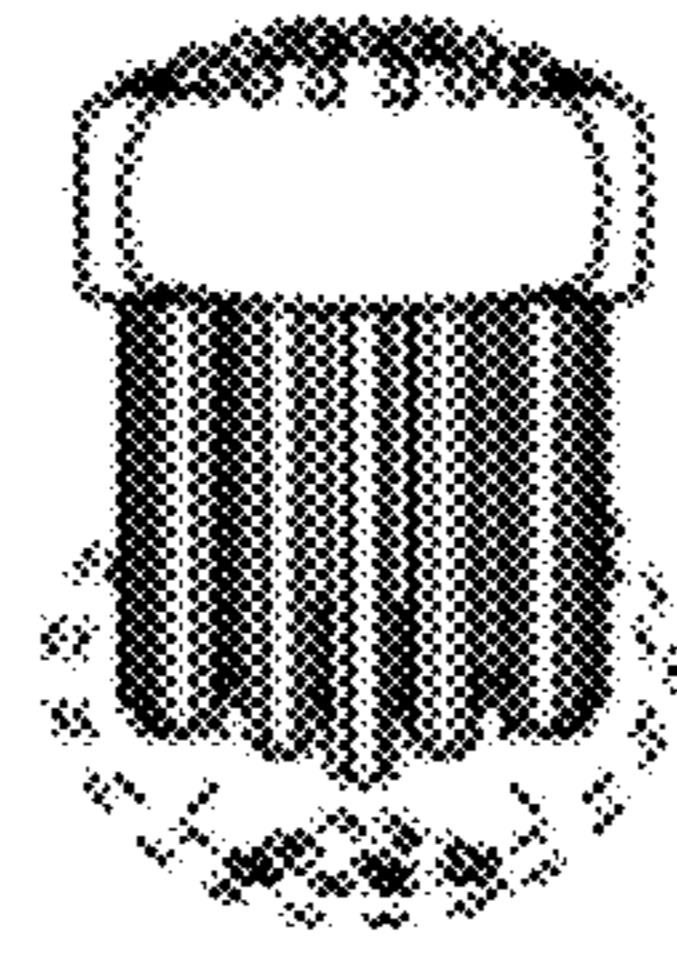
