DESCRIPTION

FIG. 4 is a front elevation of the multiple crock buffet server shown in FIGS. 1-3;

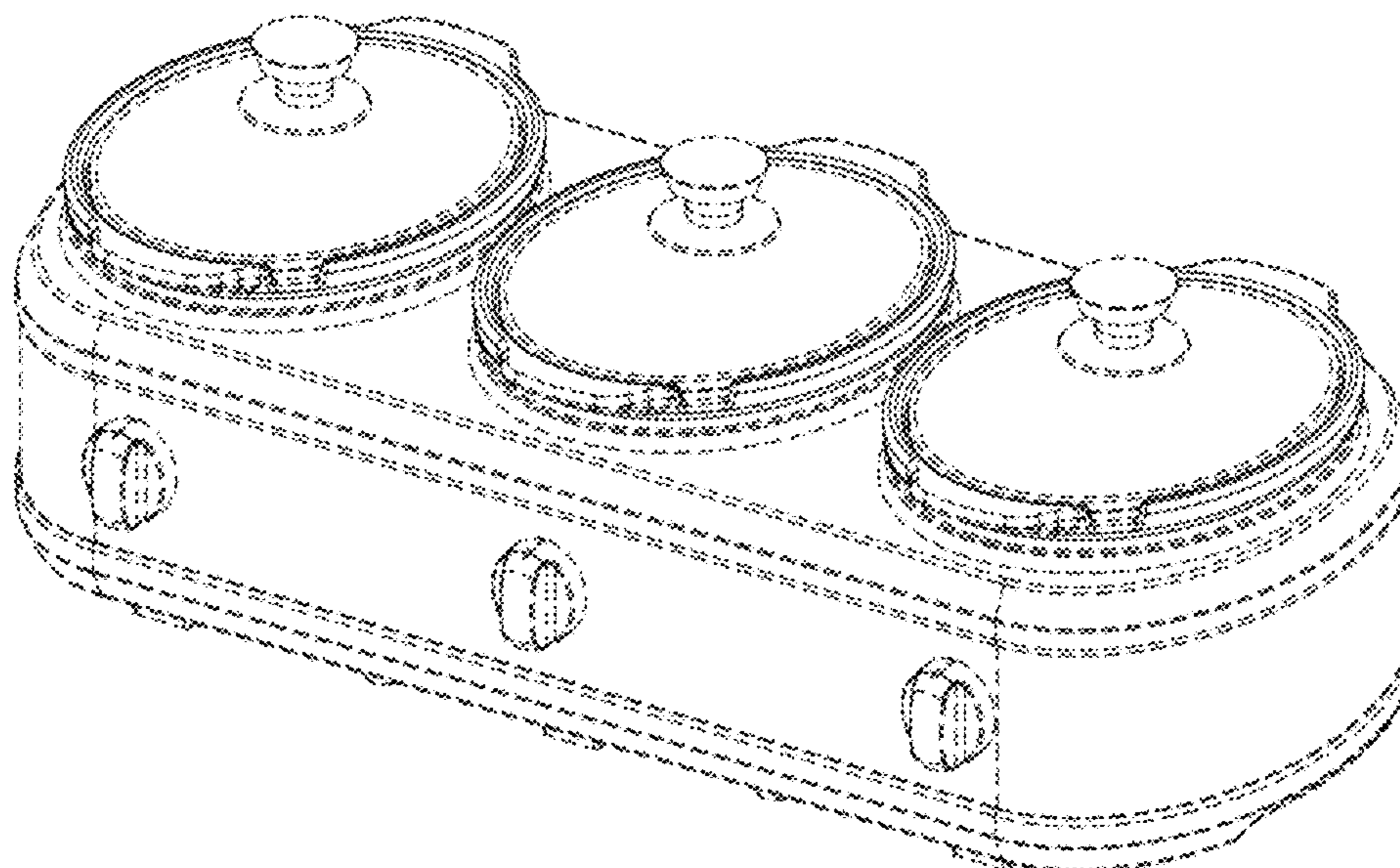
FIG. 5 is a right side elevation of the multiple crock buffet server shown in FIGS. 1-4;

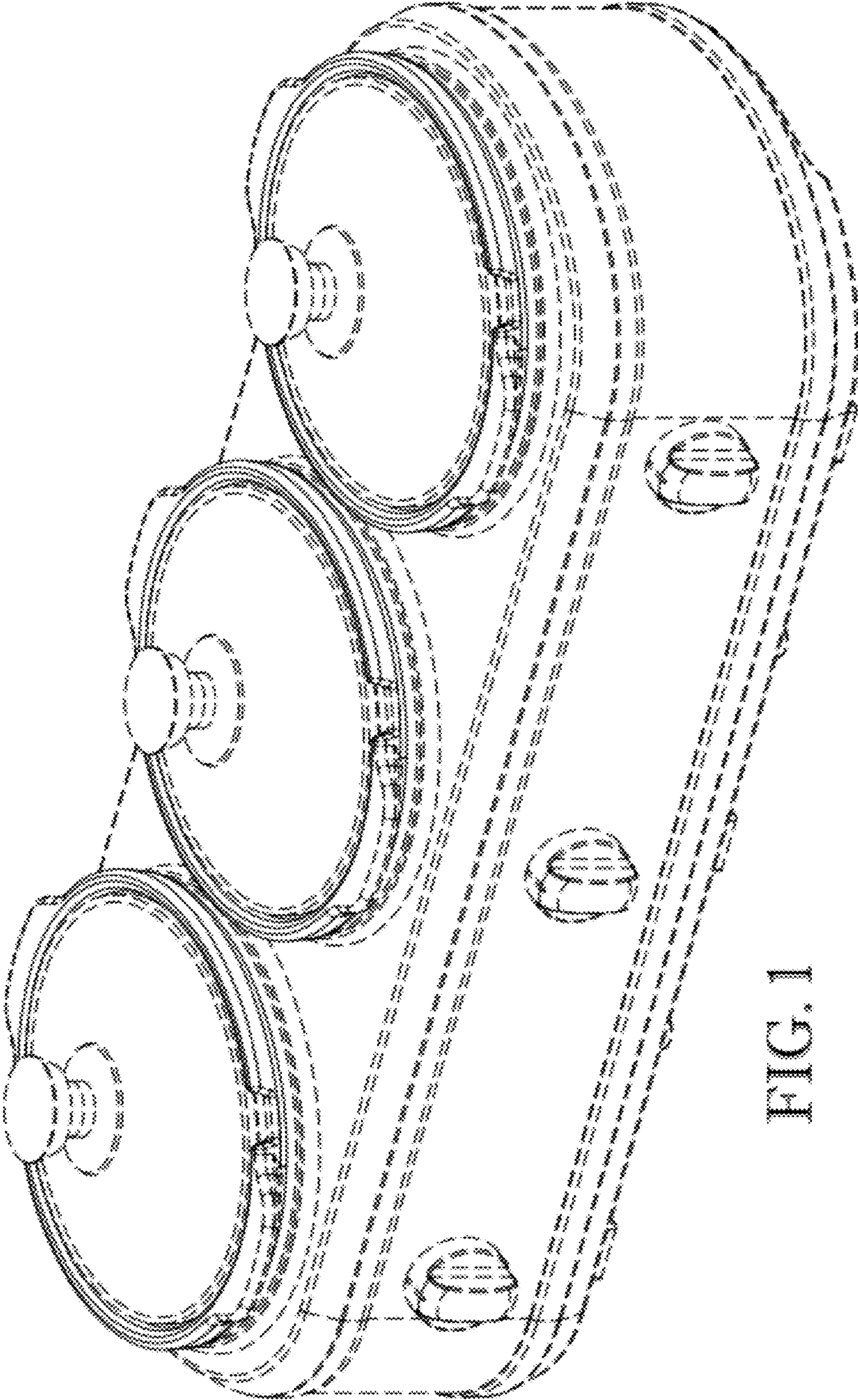

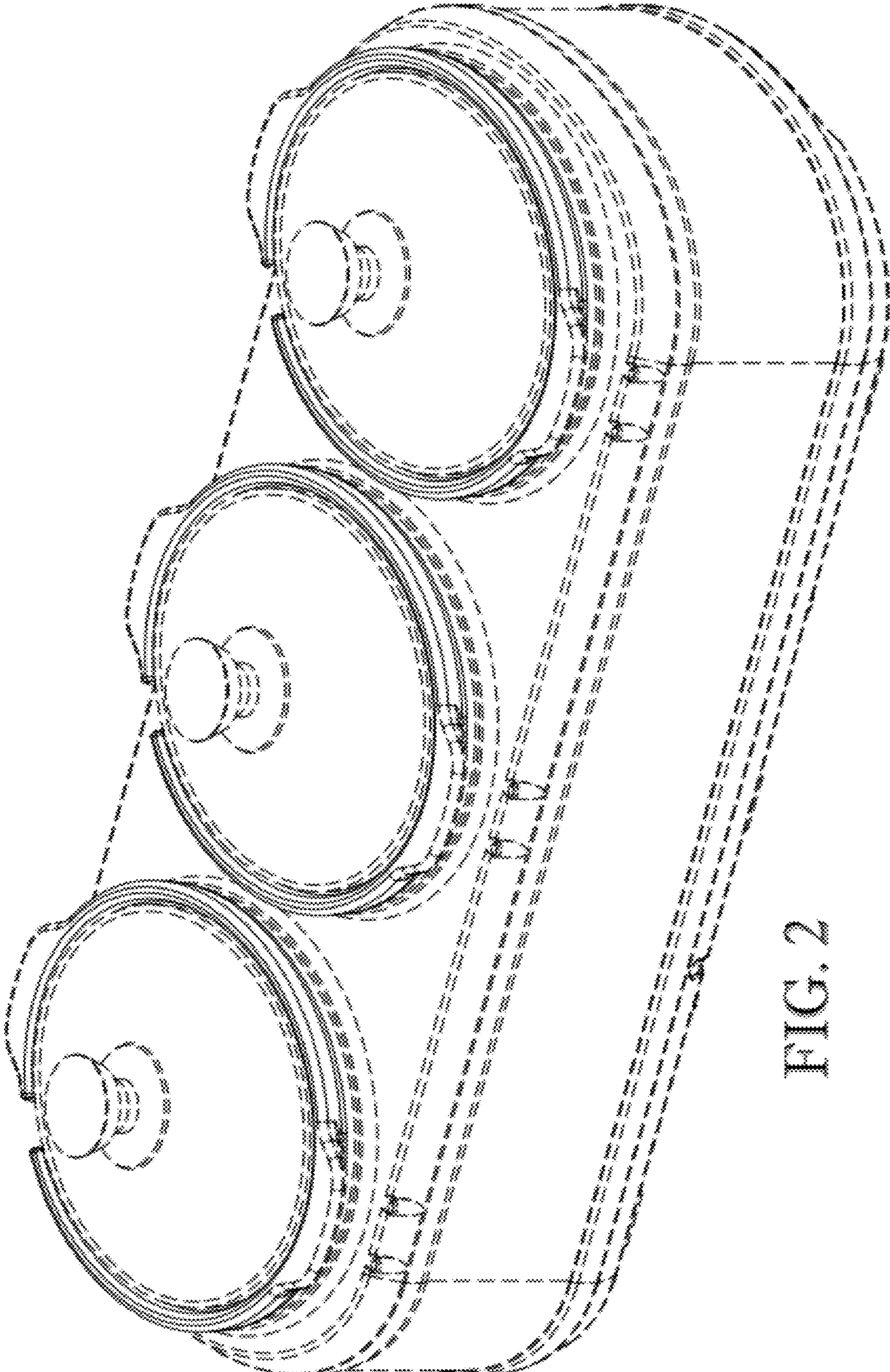

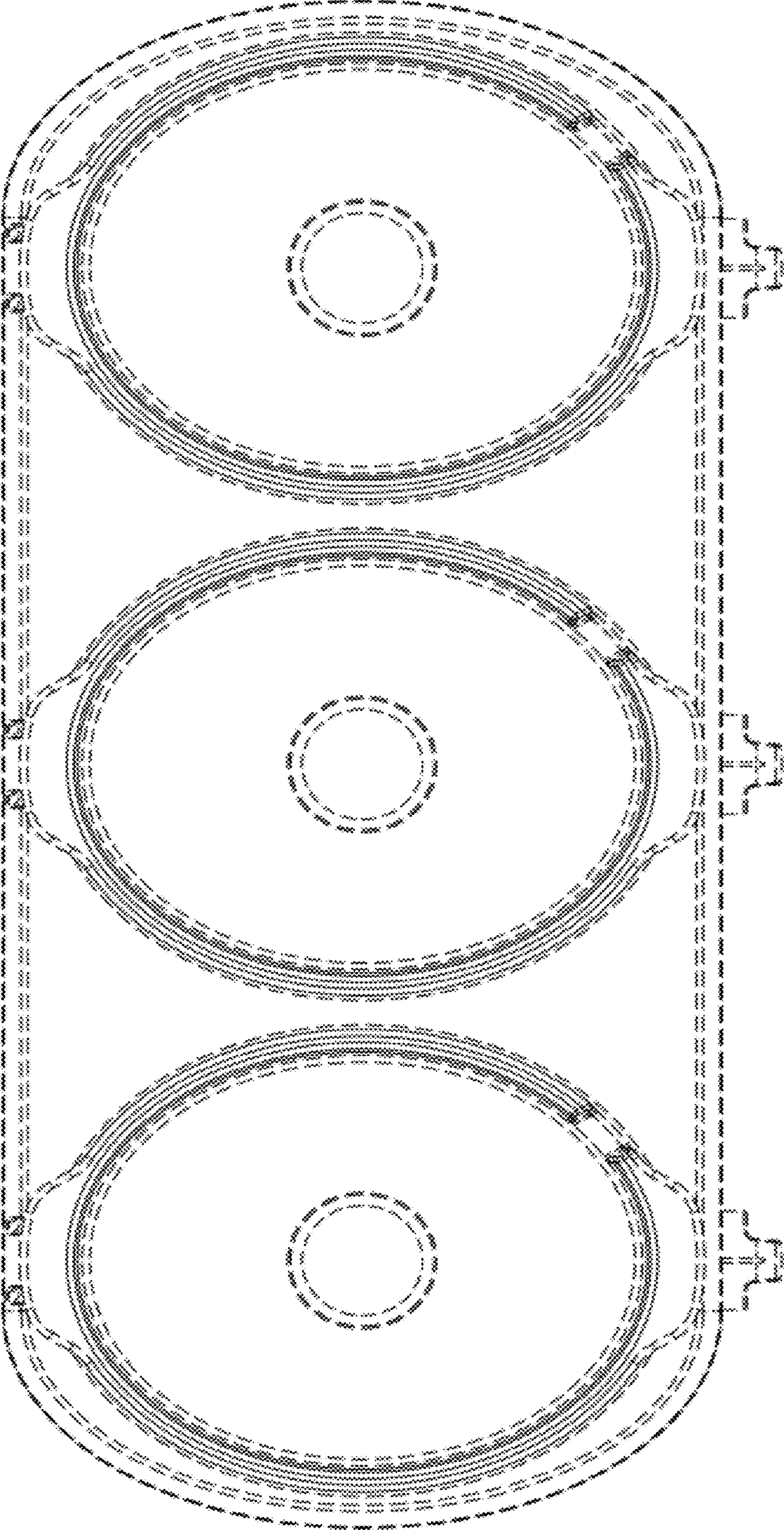

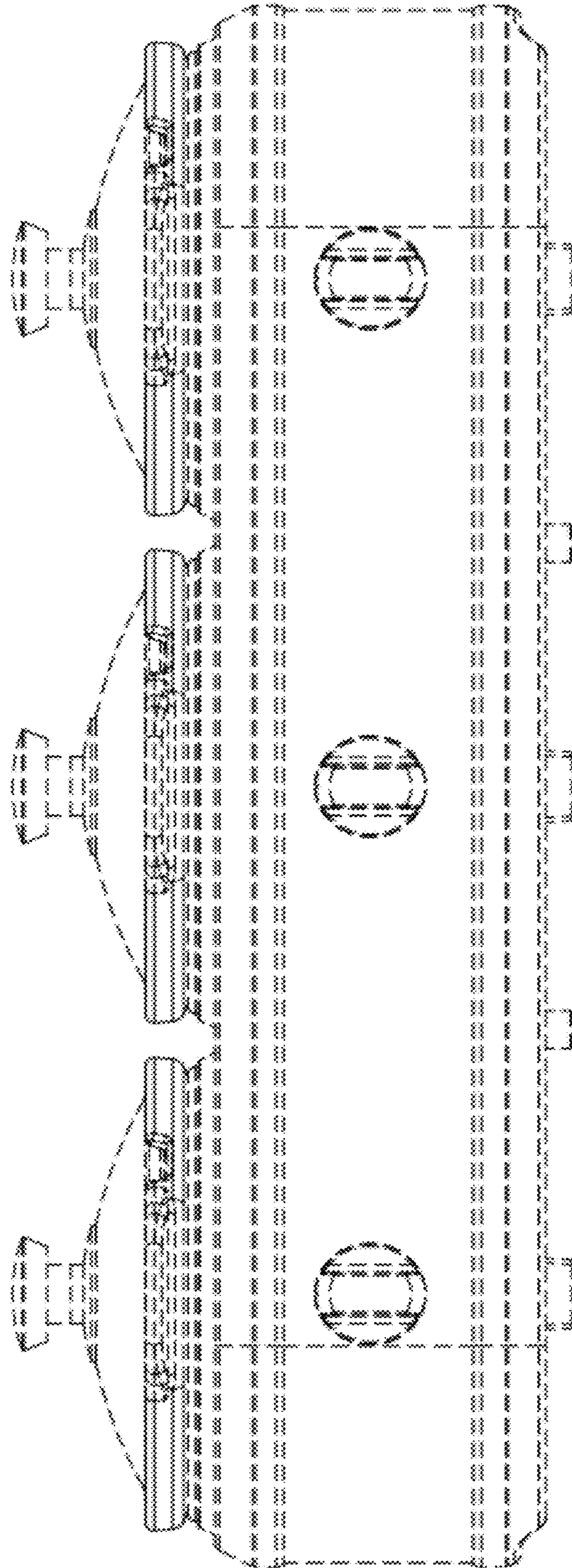

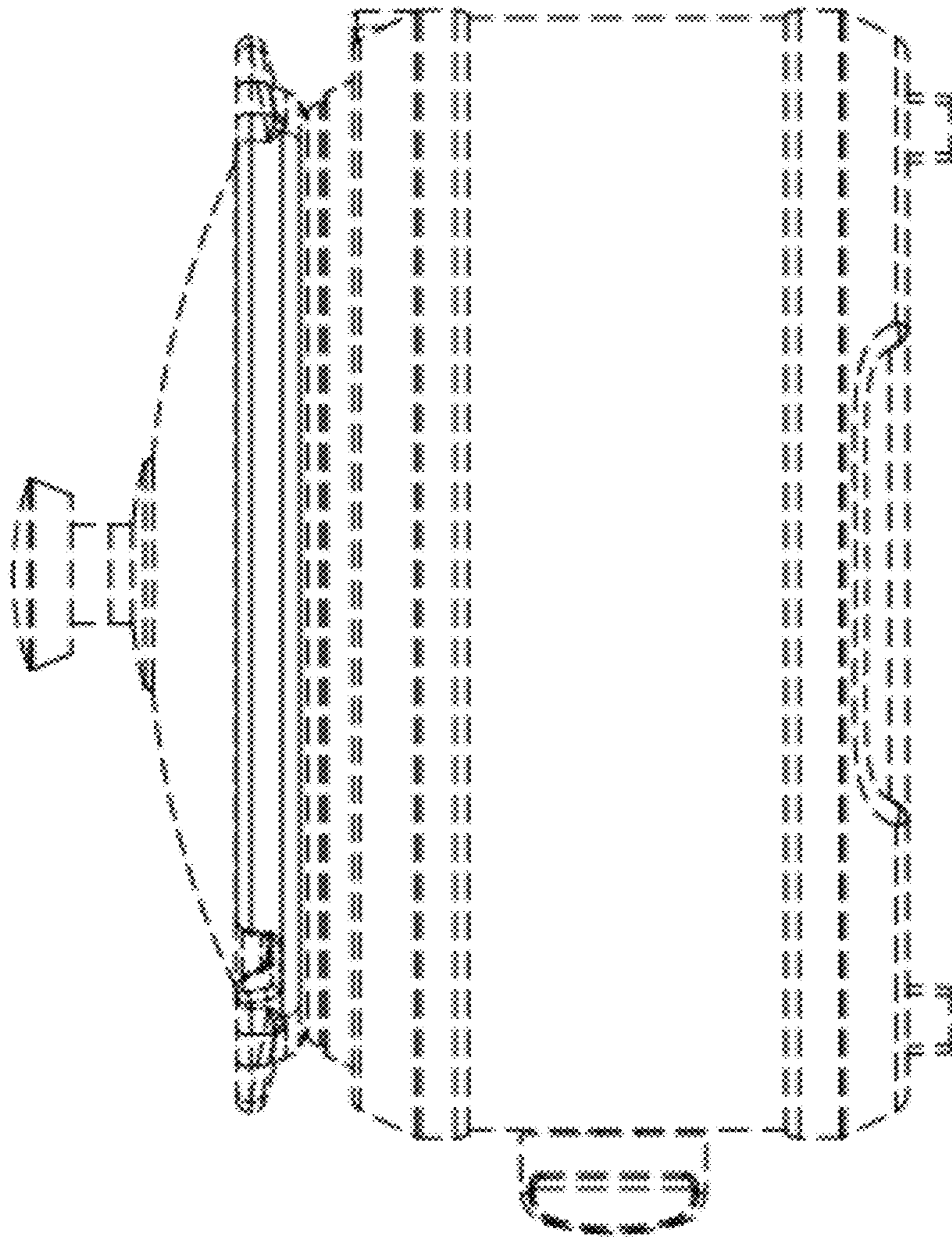

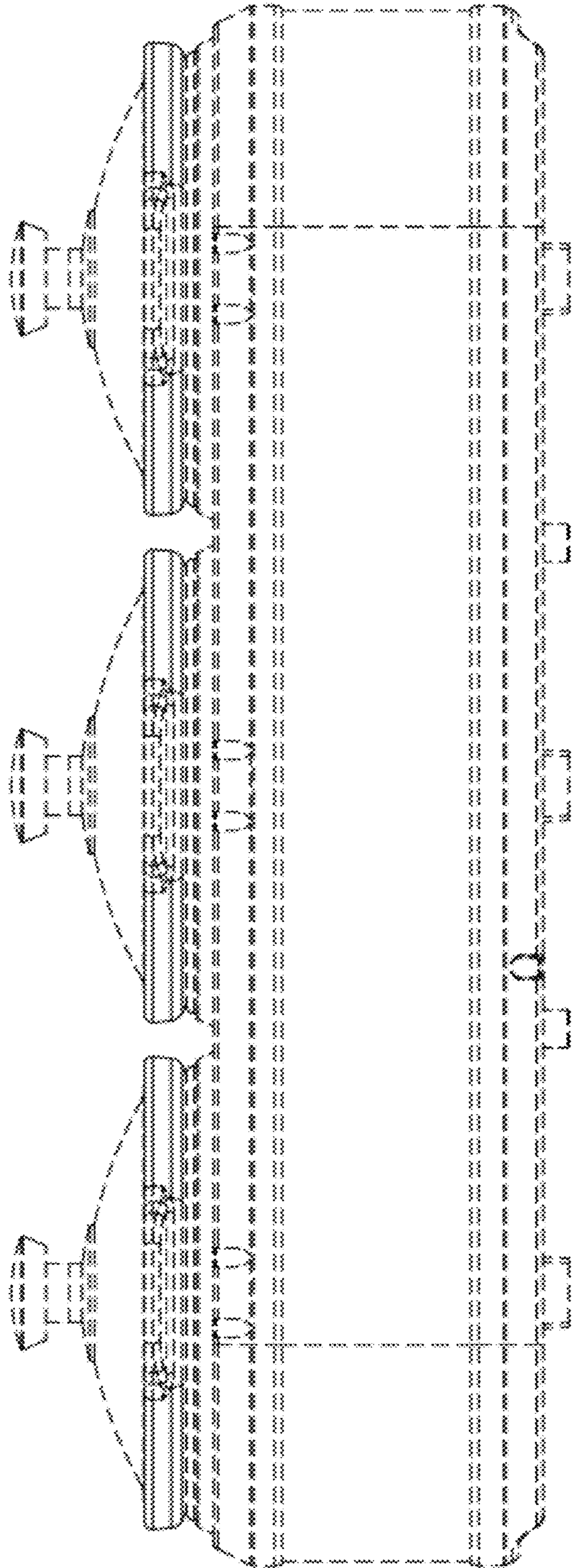

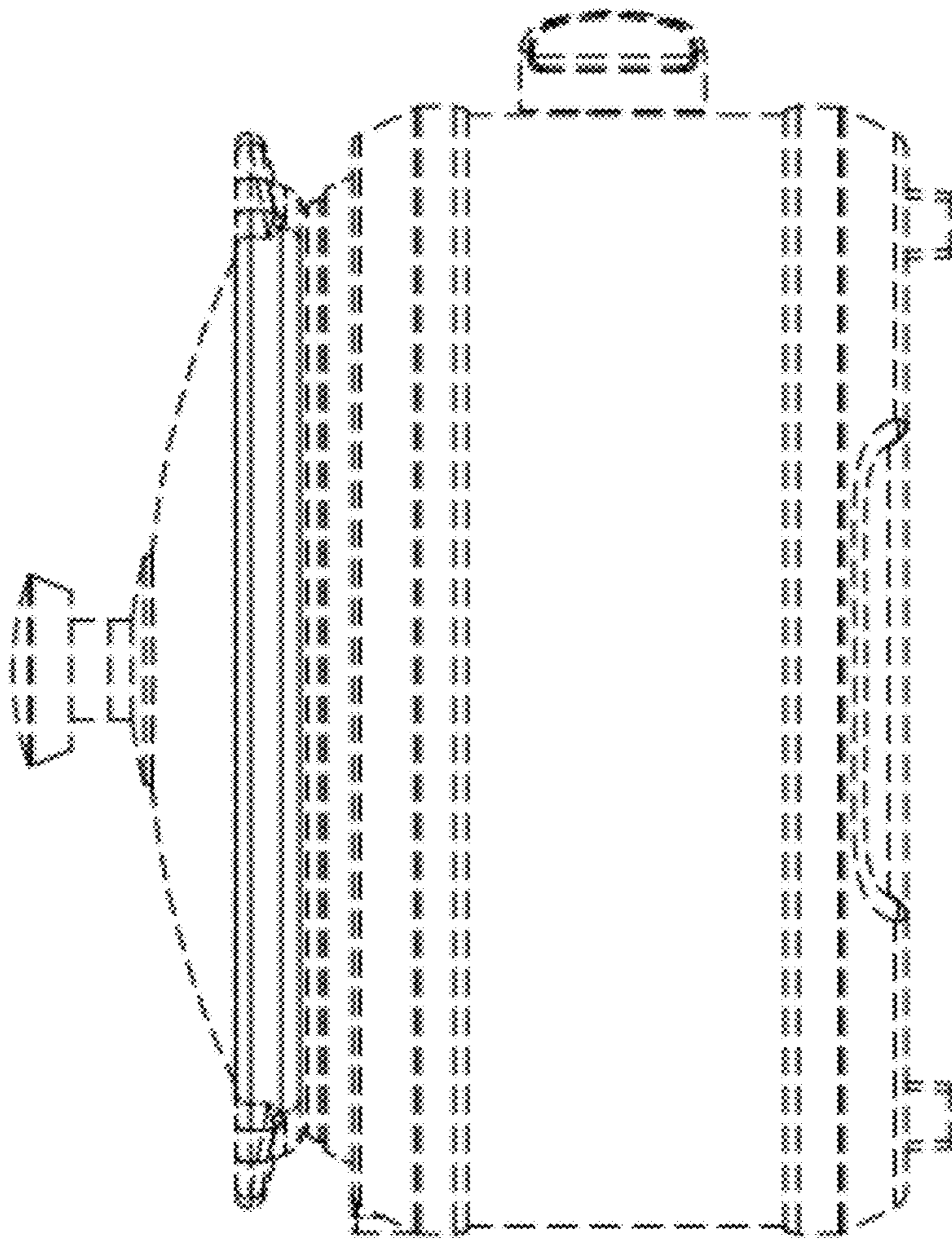

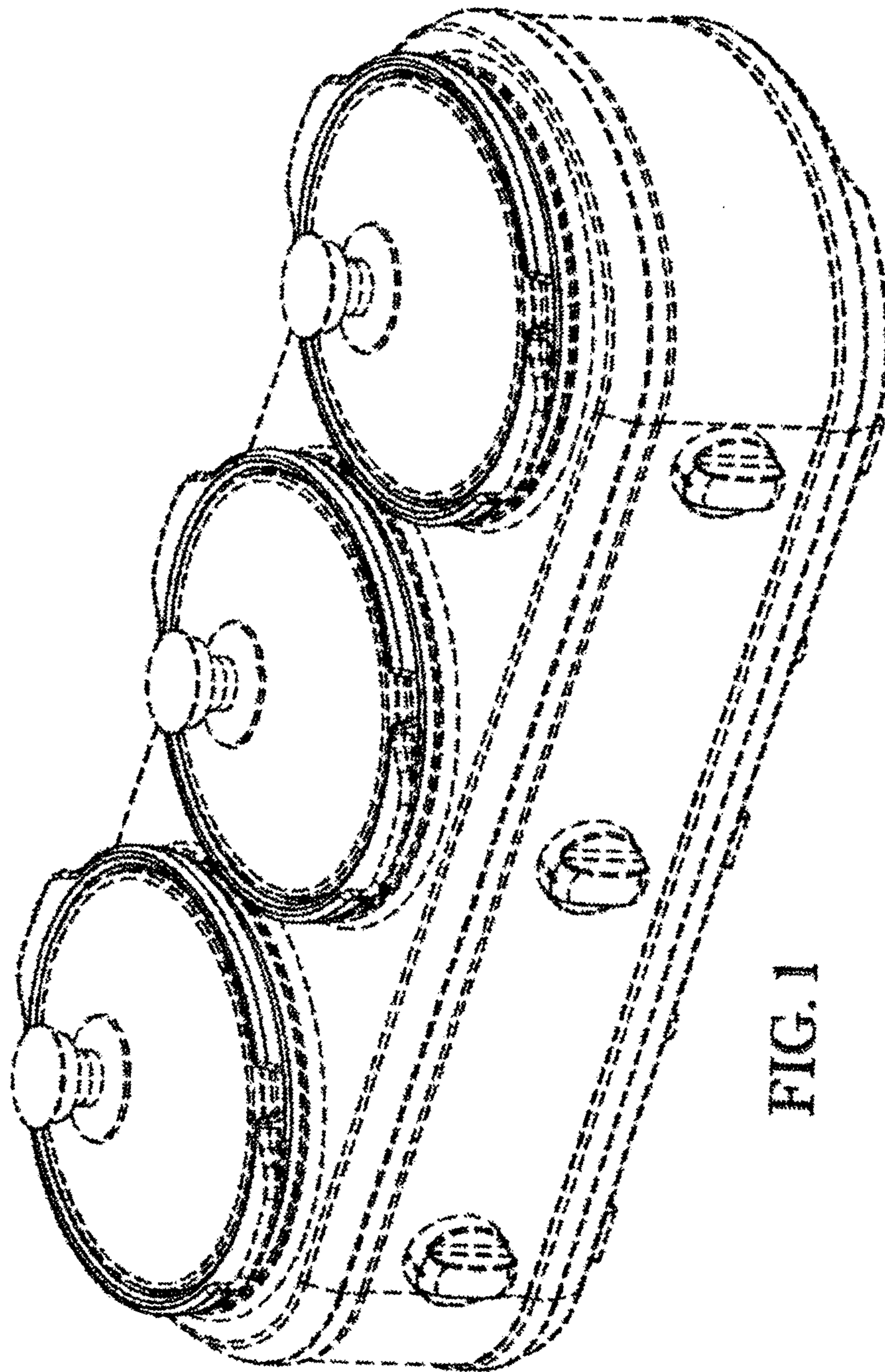

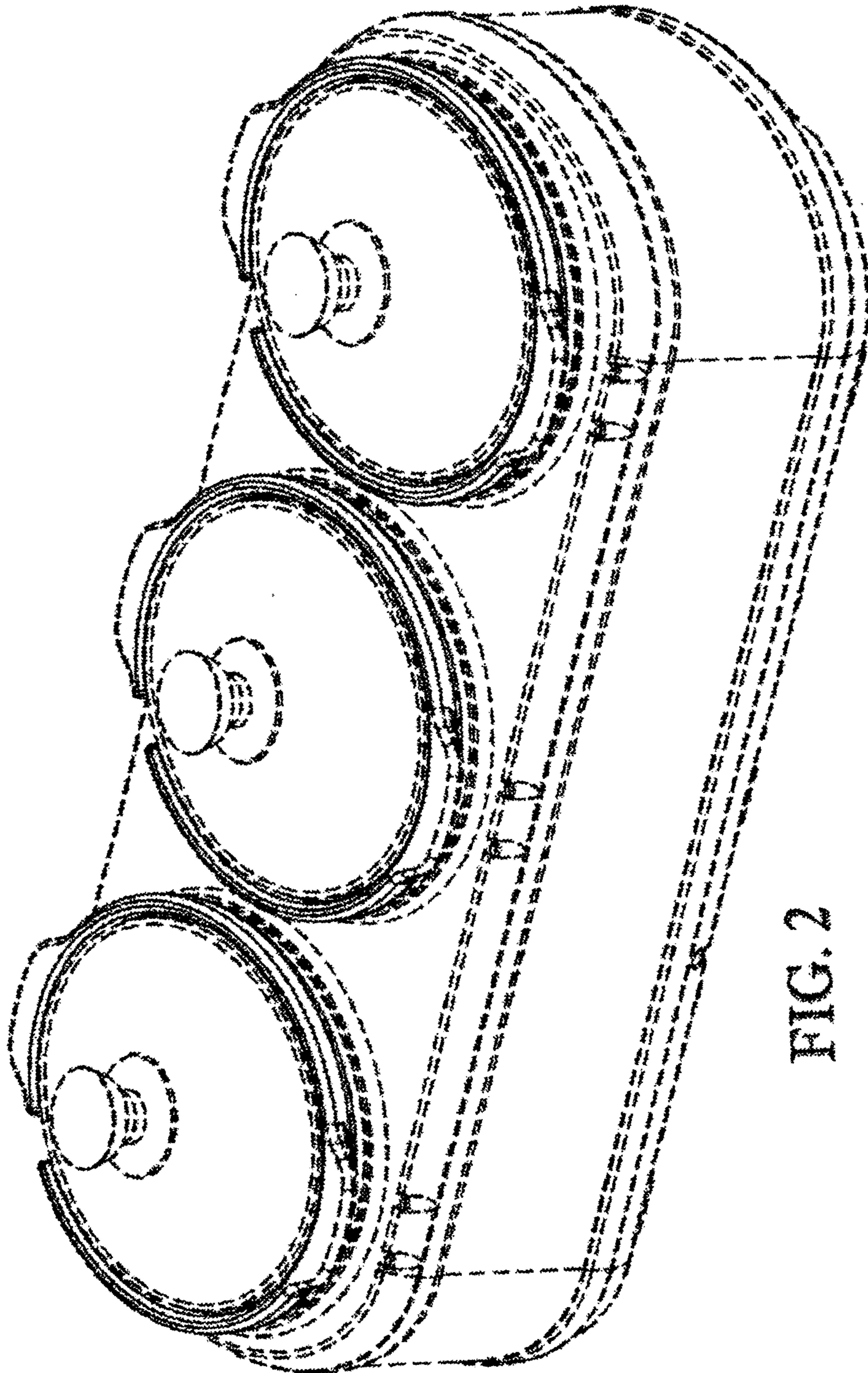

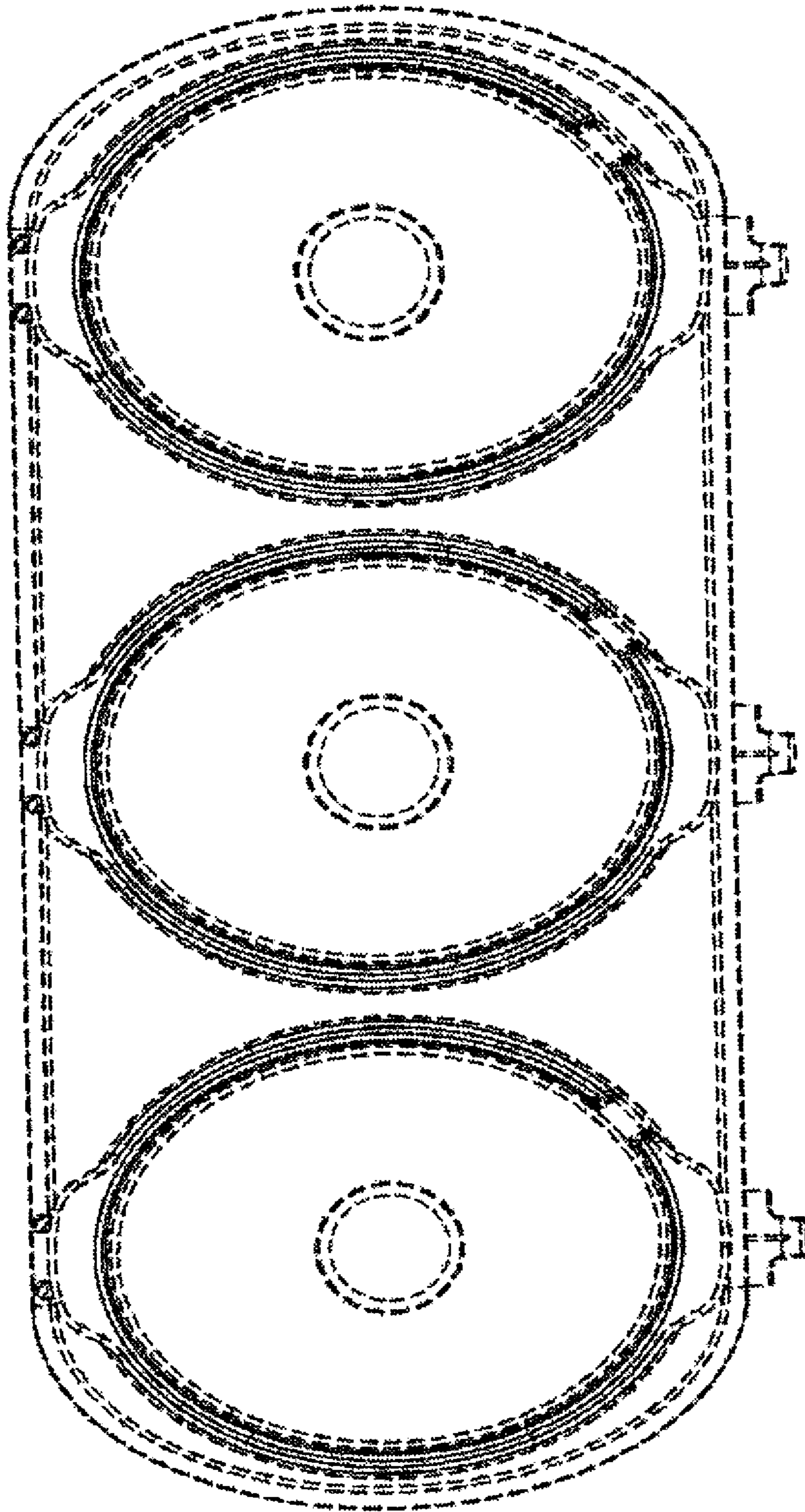

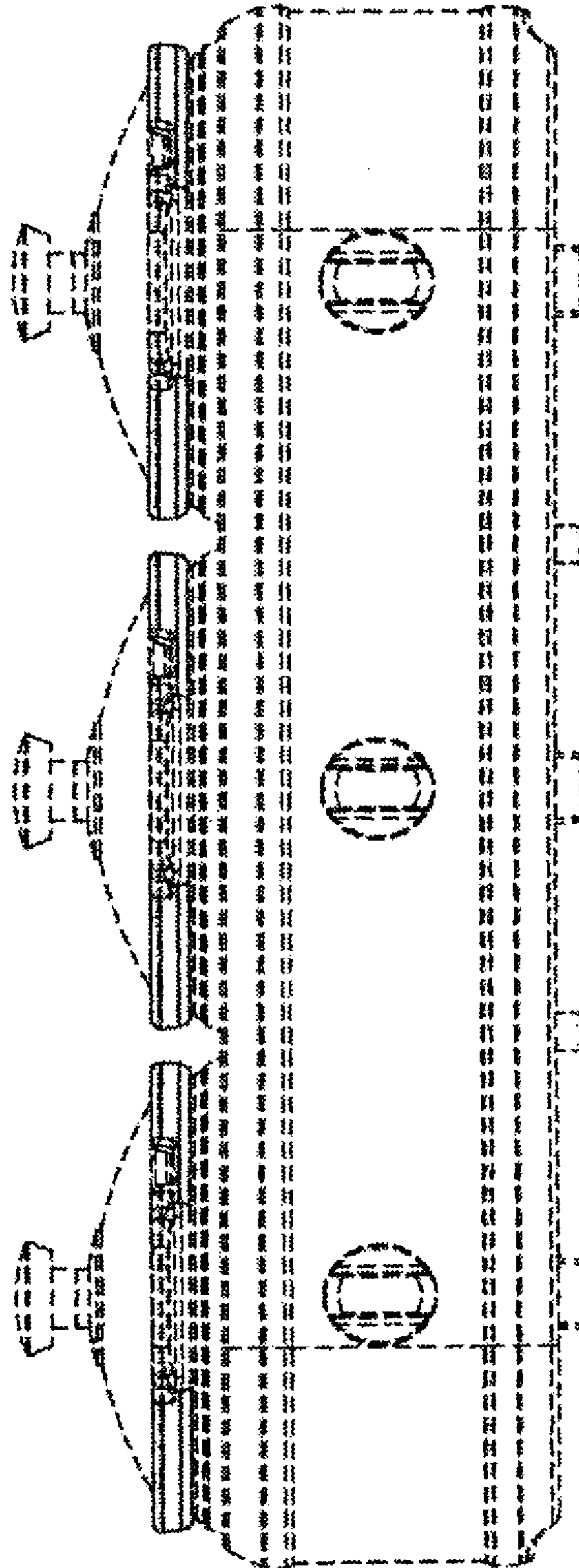

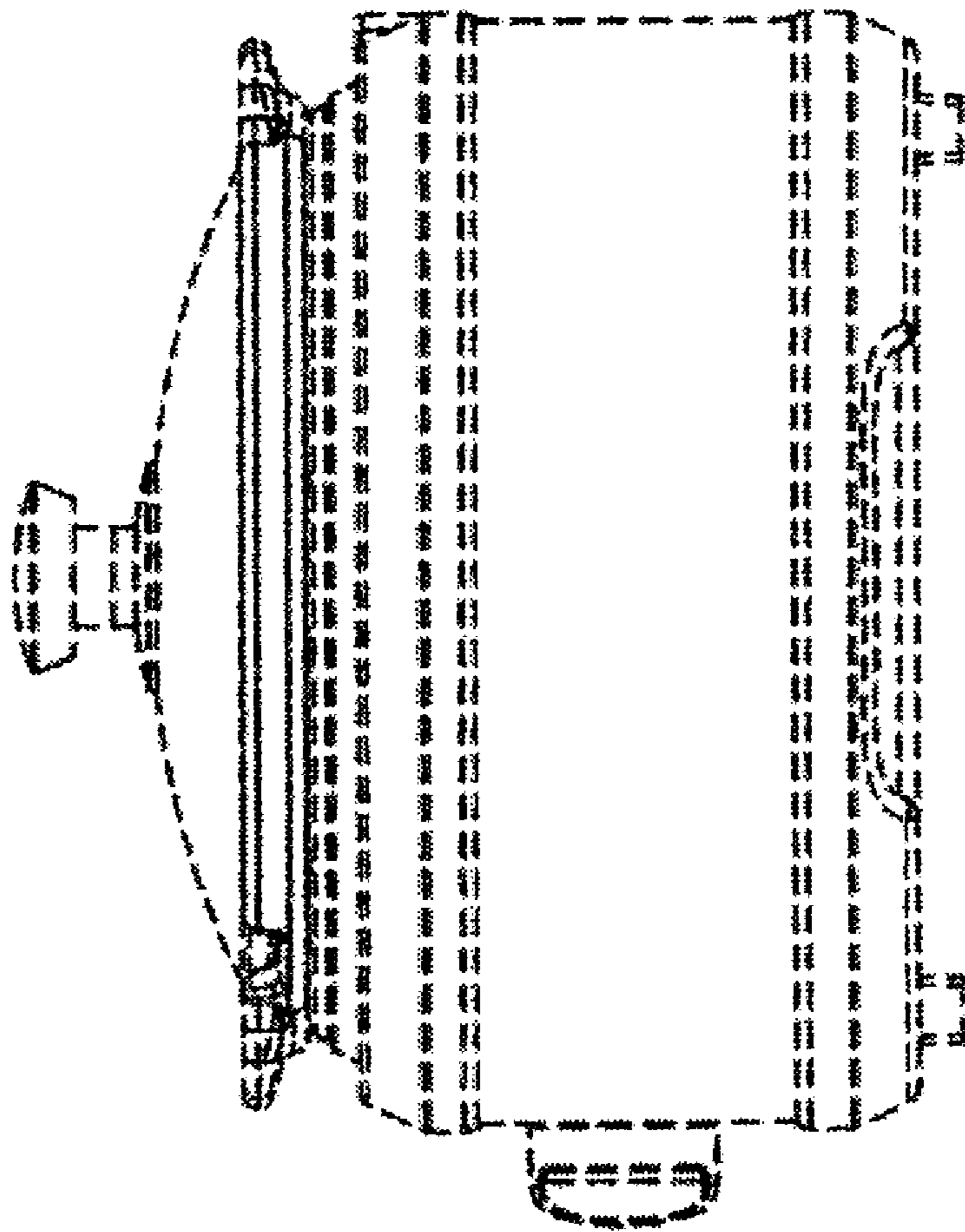

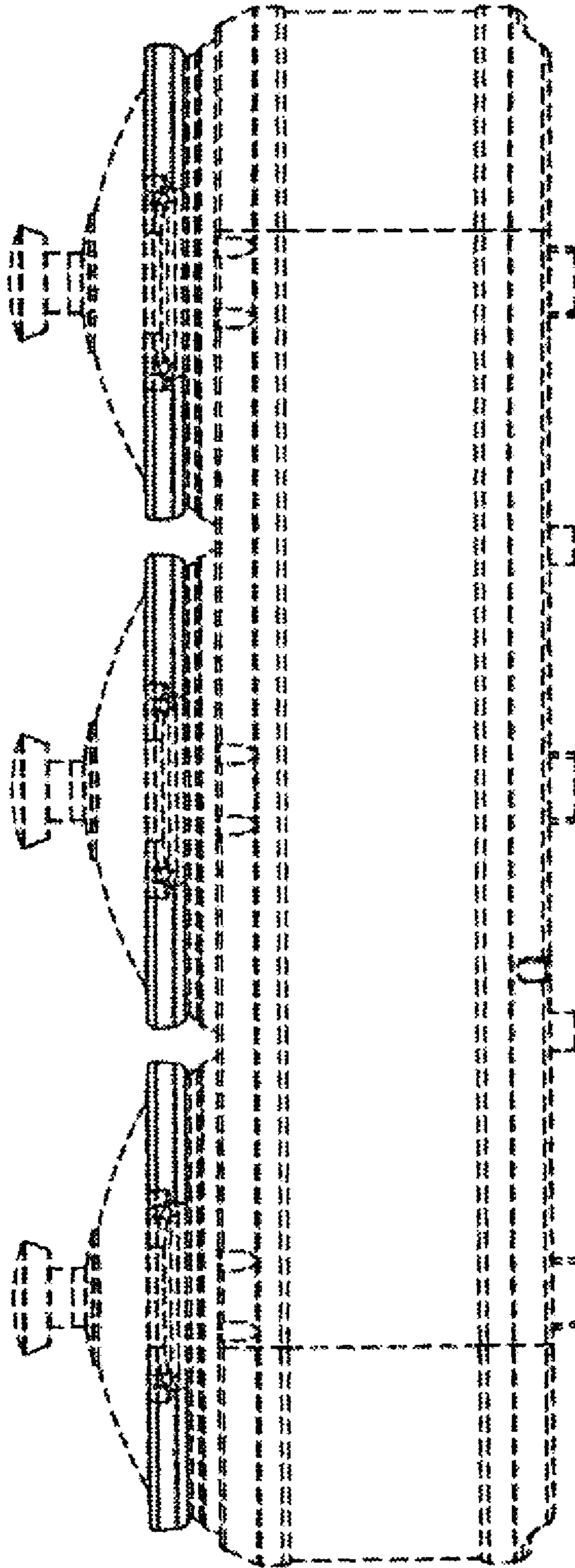

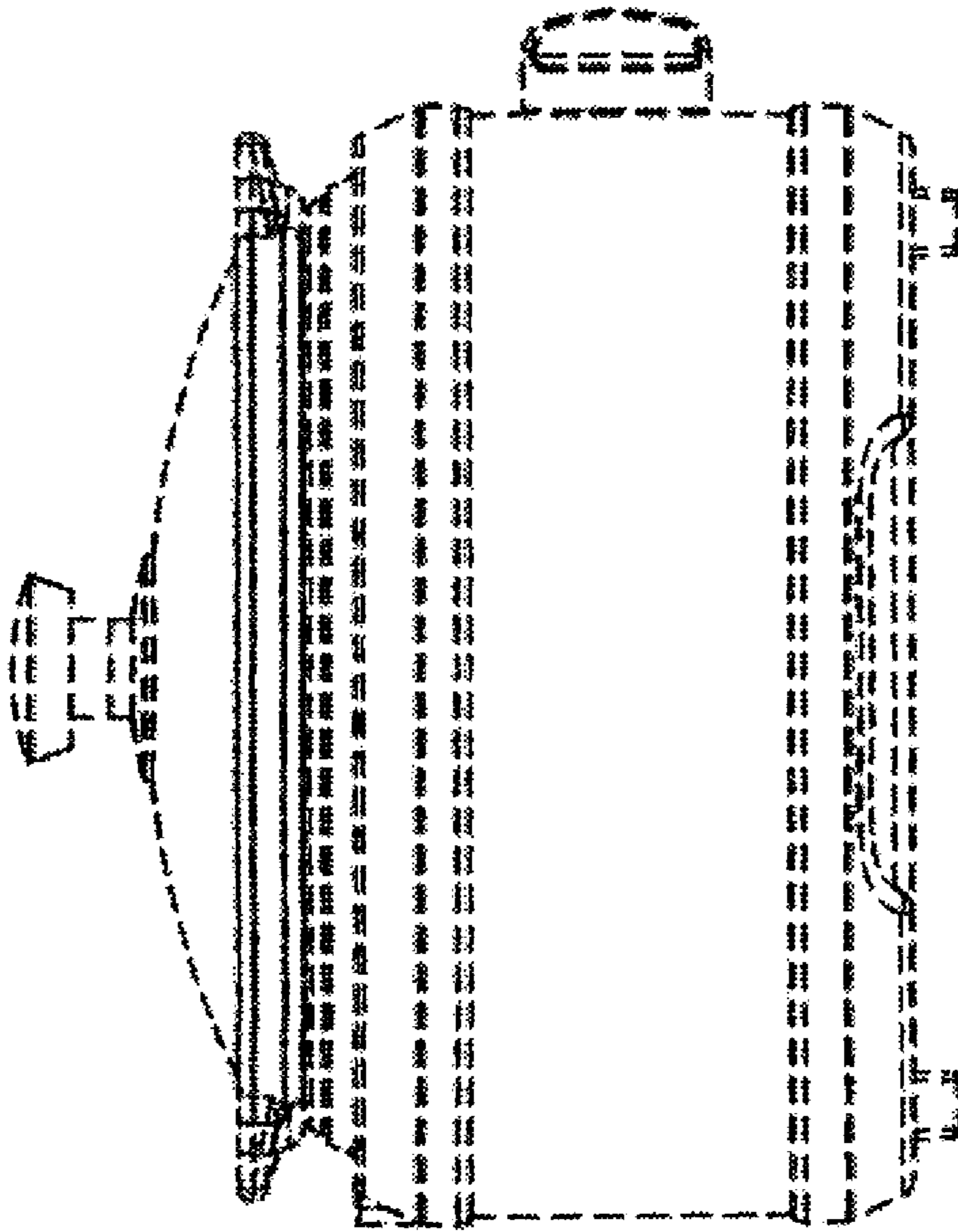
