(57) **CLAIM**

The ornamental design for disposable cutlery, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of handle of disposable cutlery with the broken lines therein for background purposes only and not a portion of the claim;

FIG. 16 is a side elevational view of the design shown in FIG. 14;

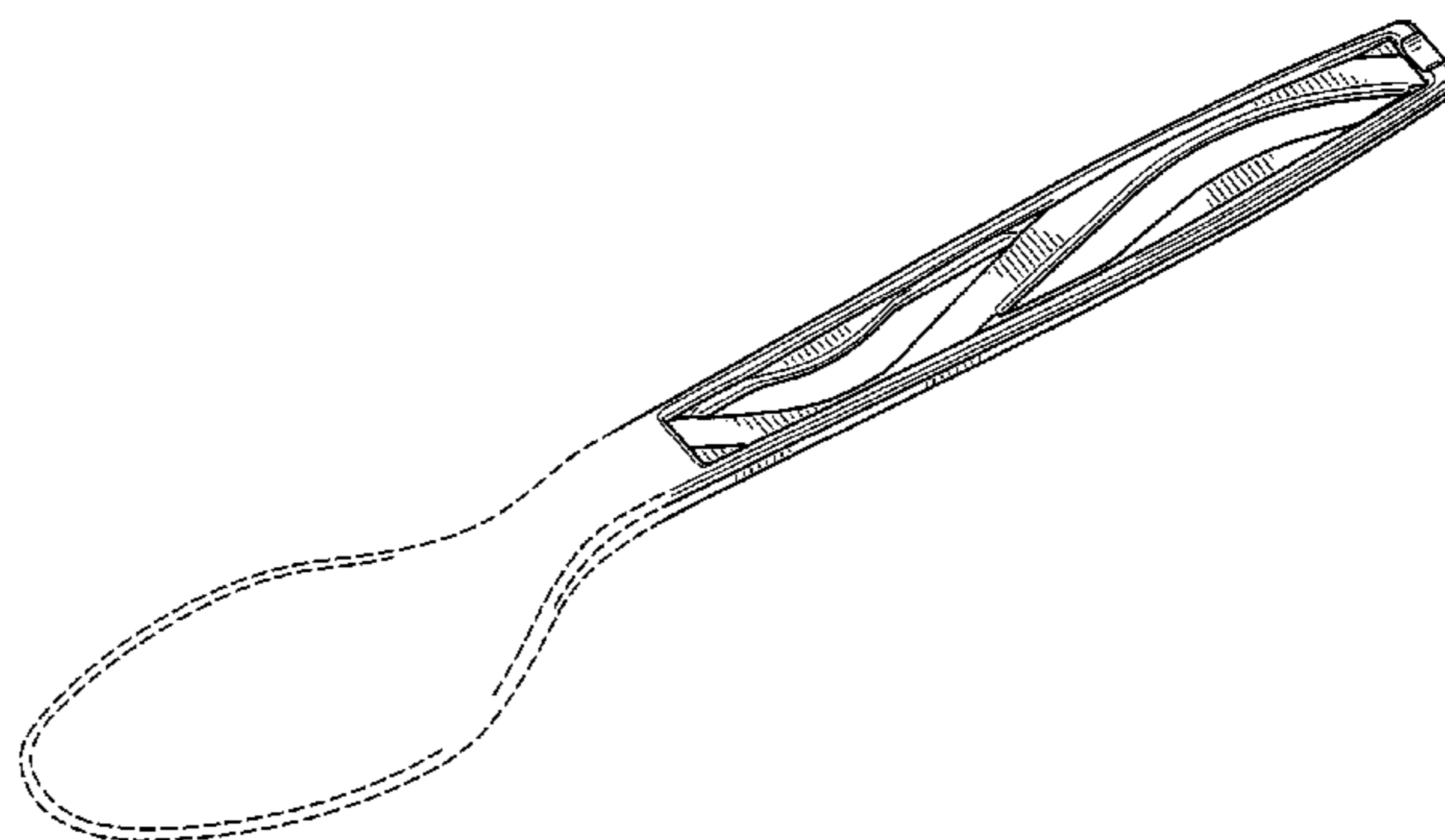
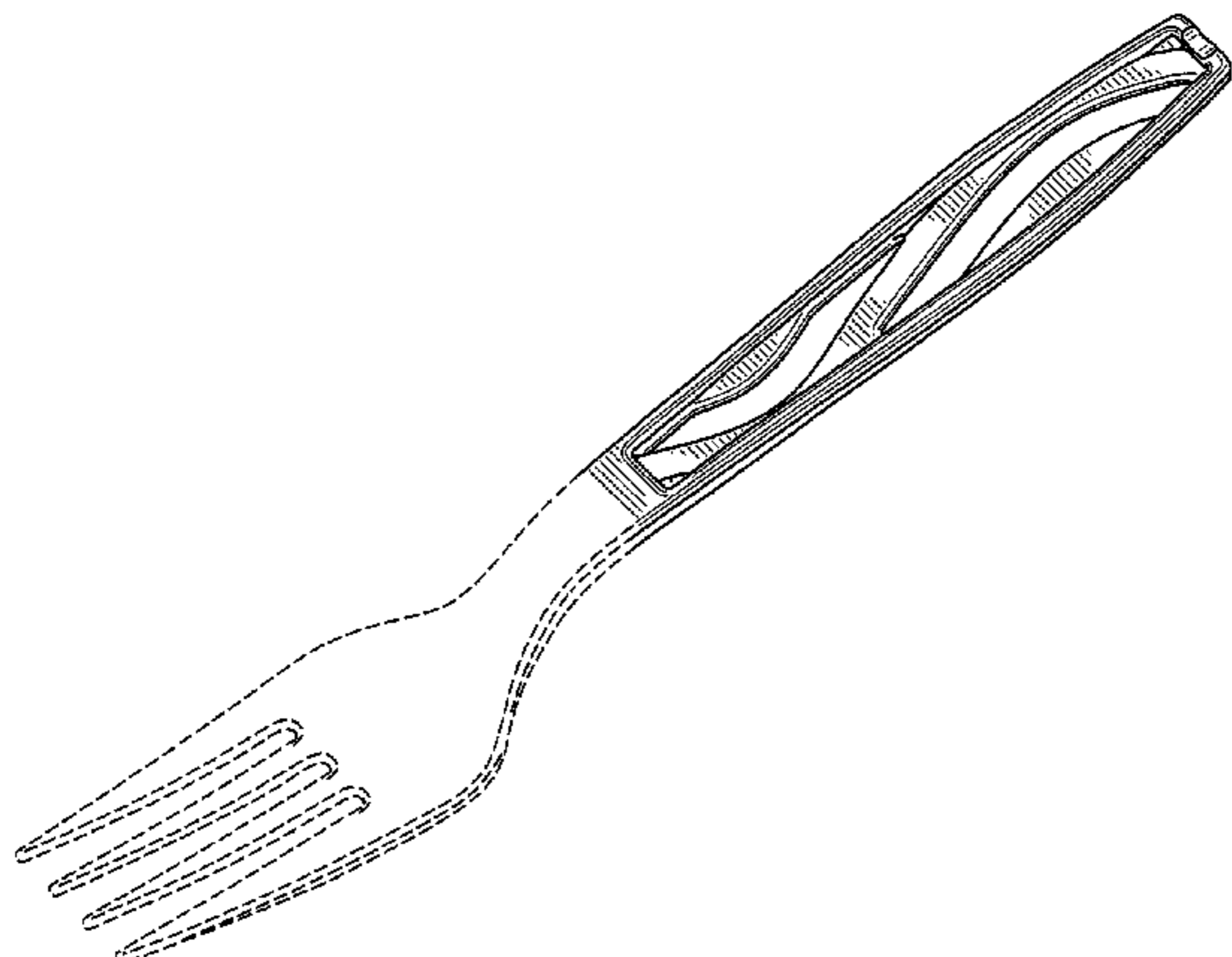
FIG. 17 is a side elevational view of the design shown in FIG. 15;

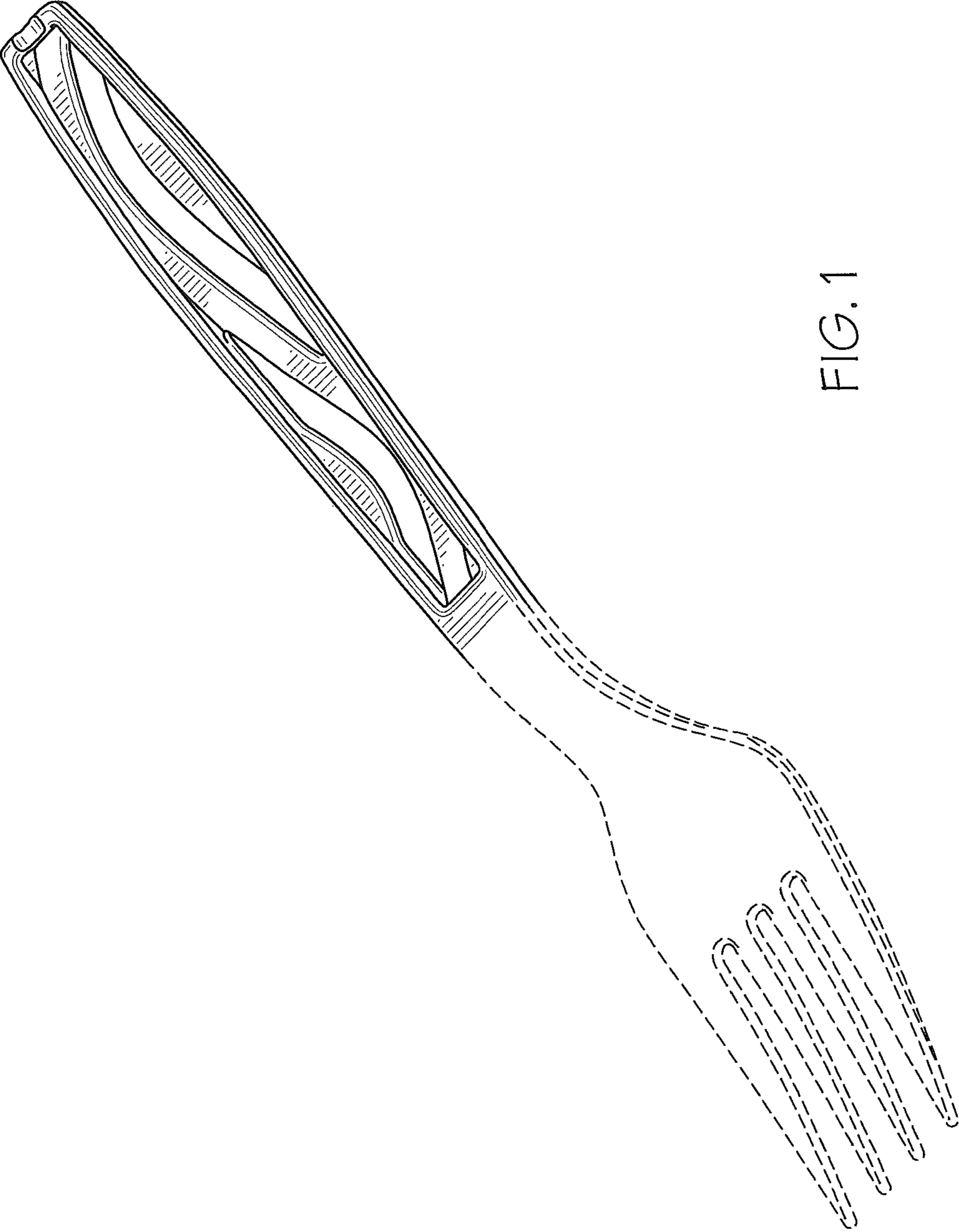

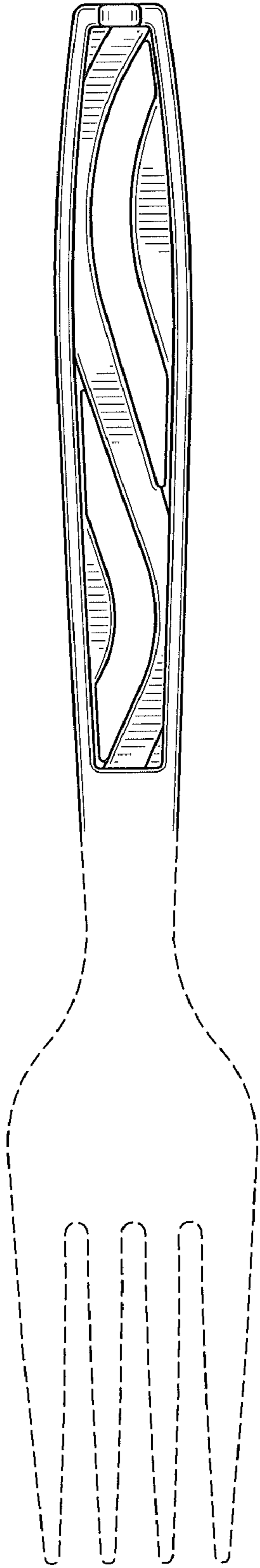

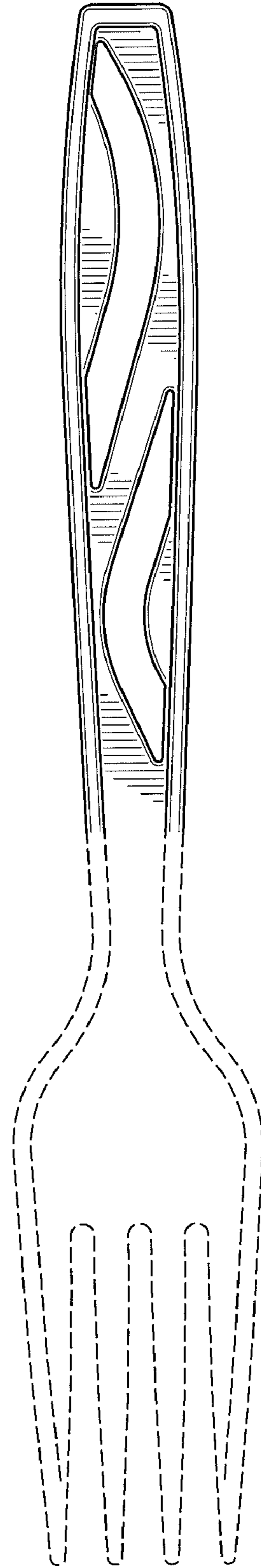

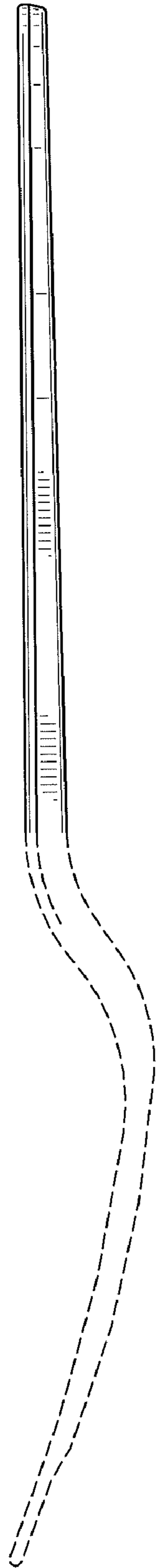

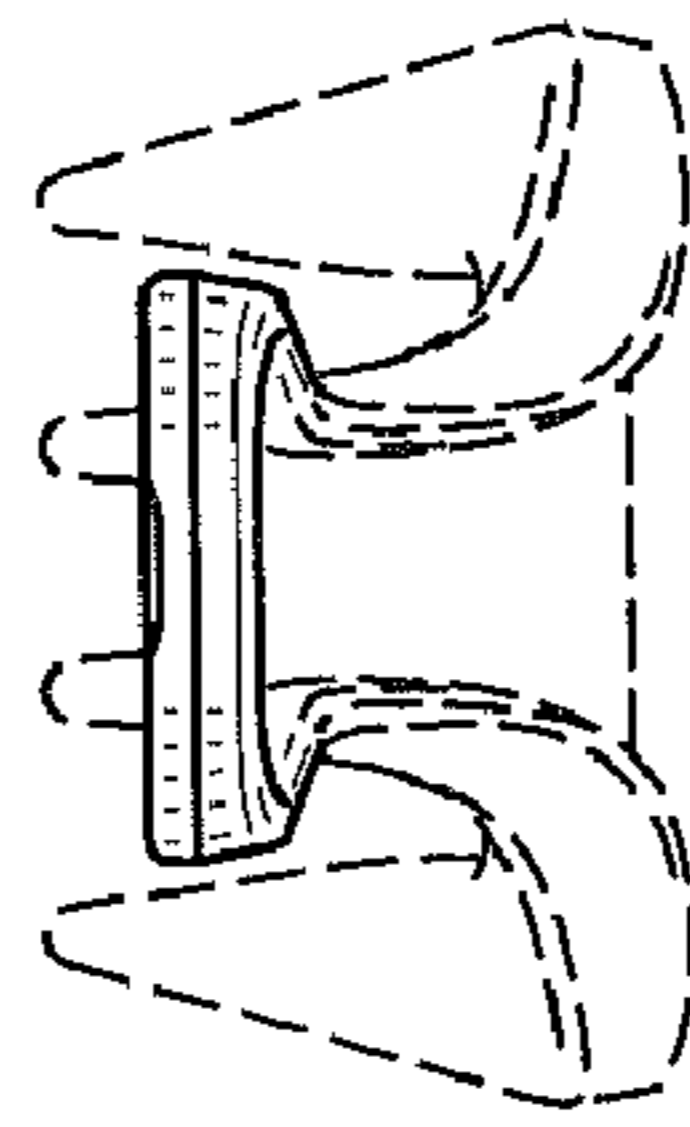

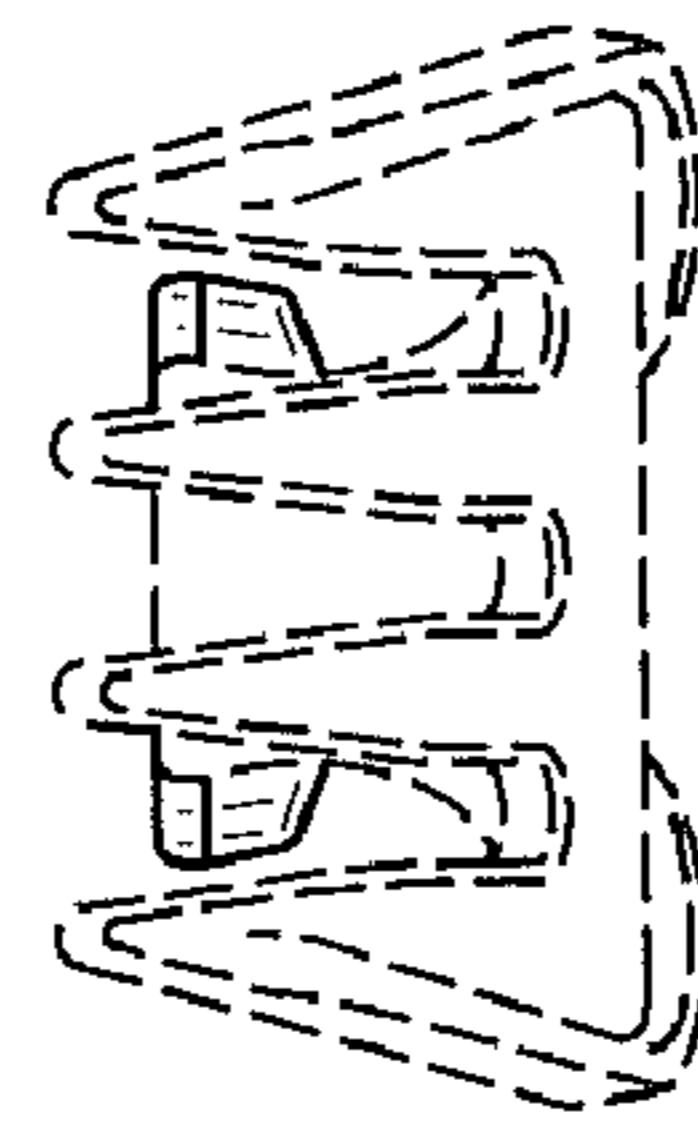

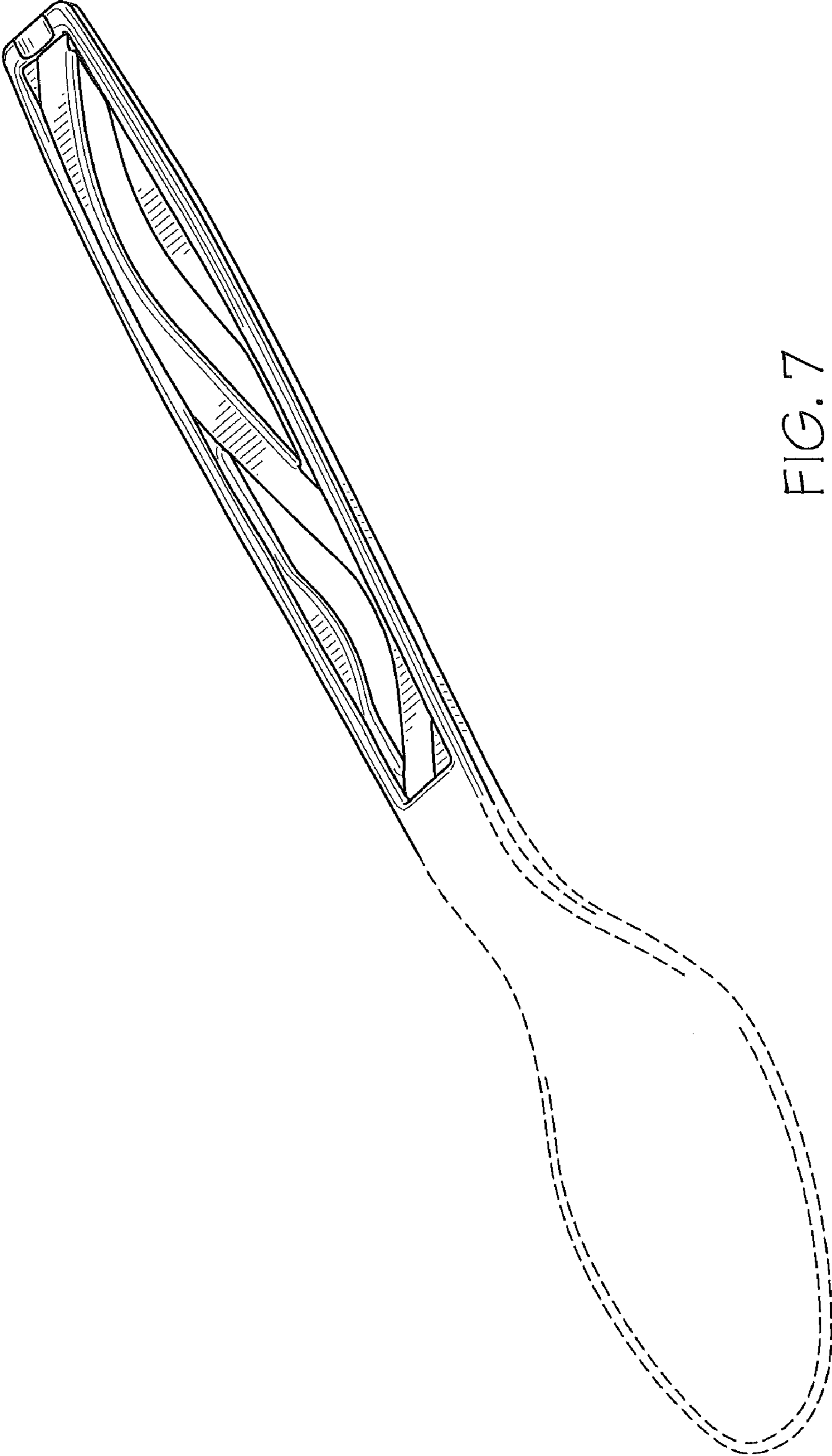

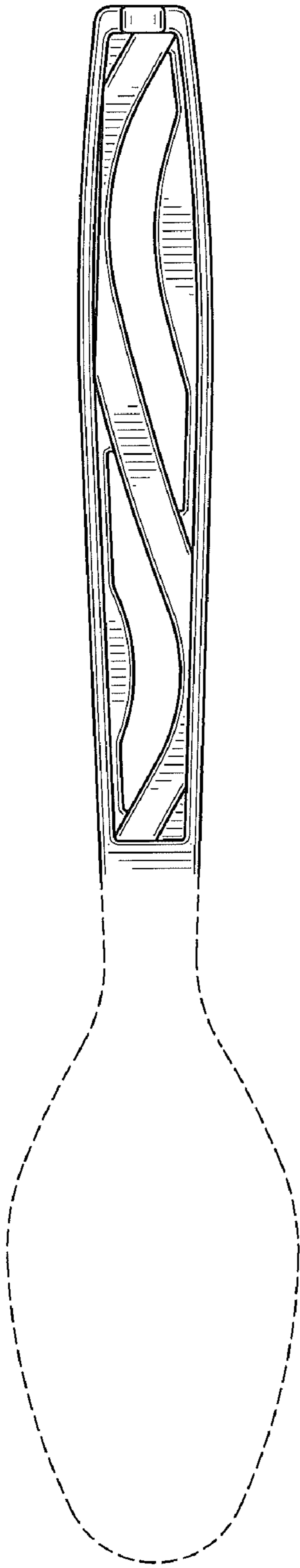

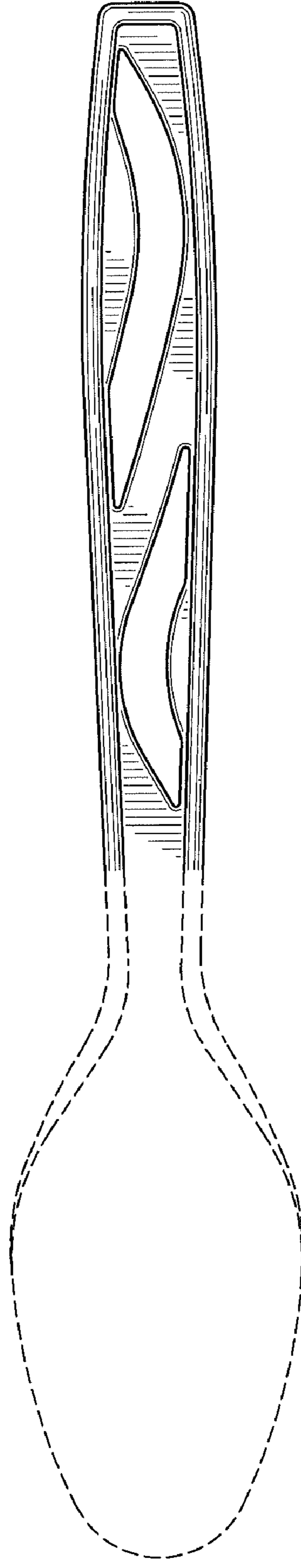

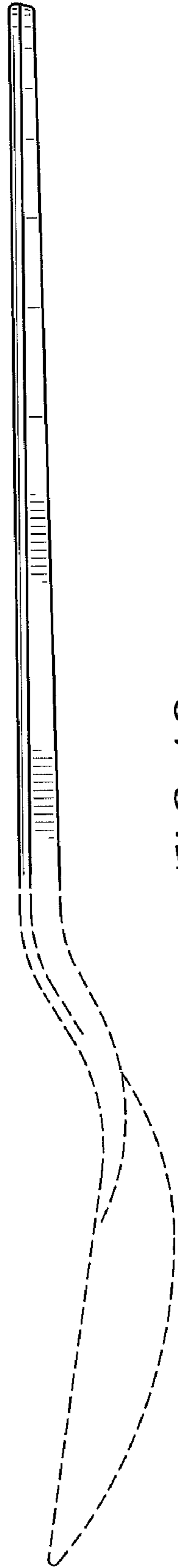

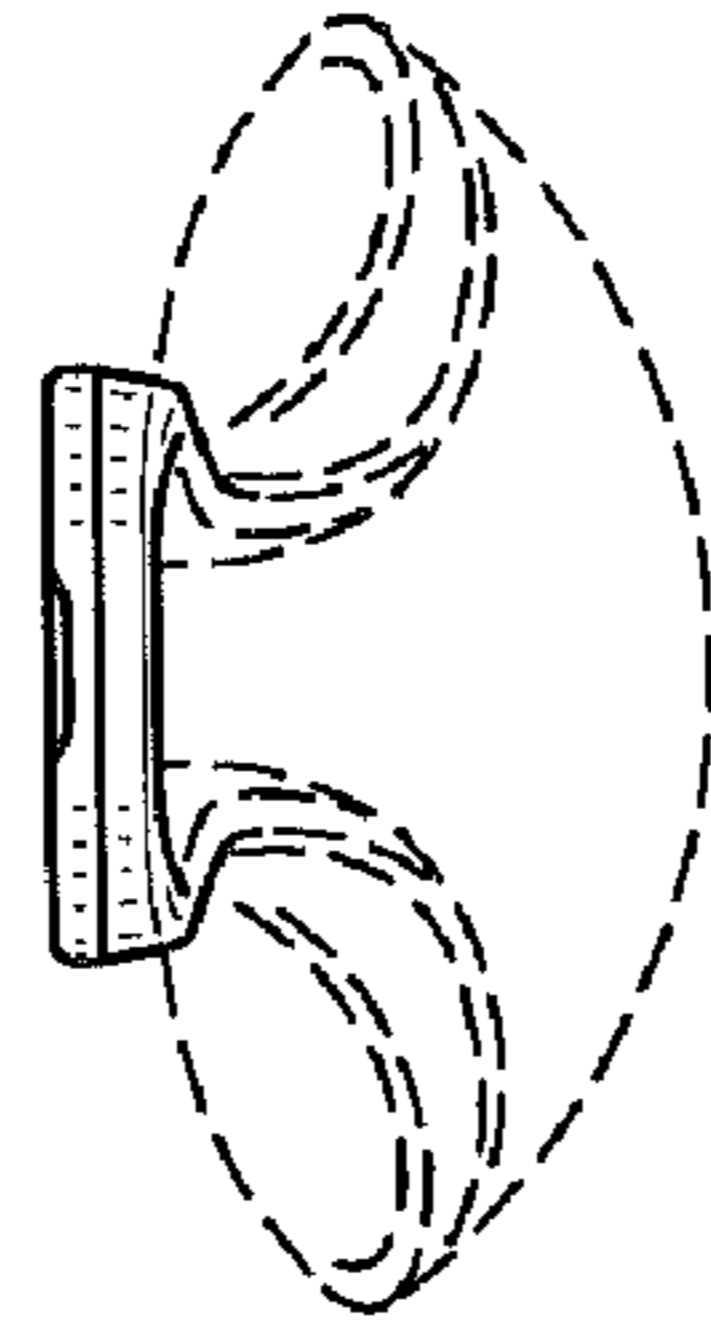

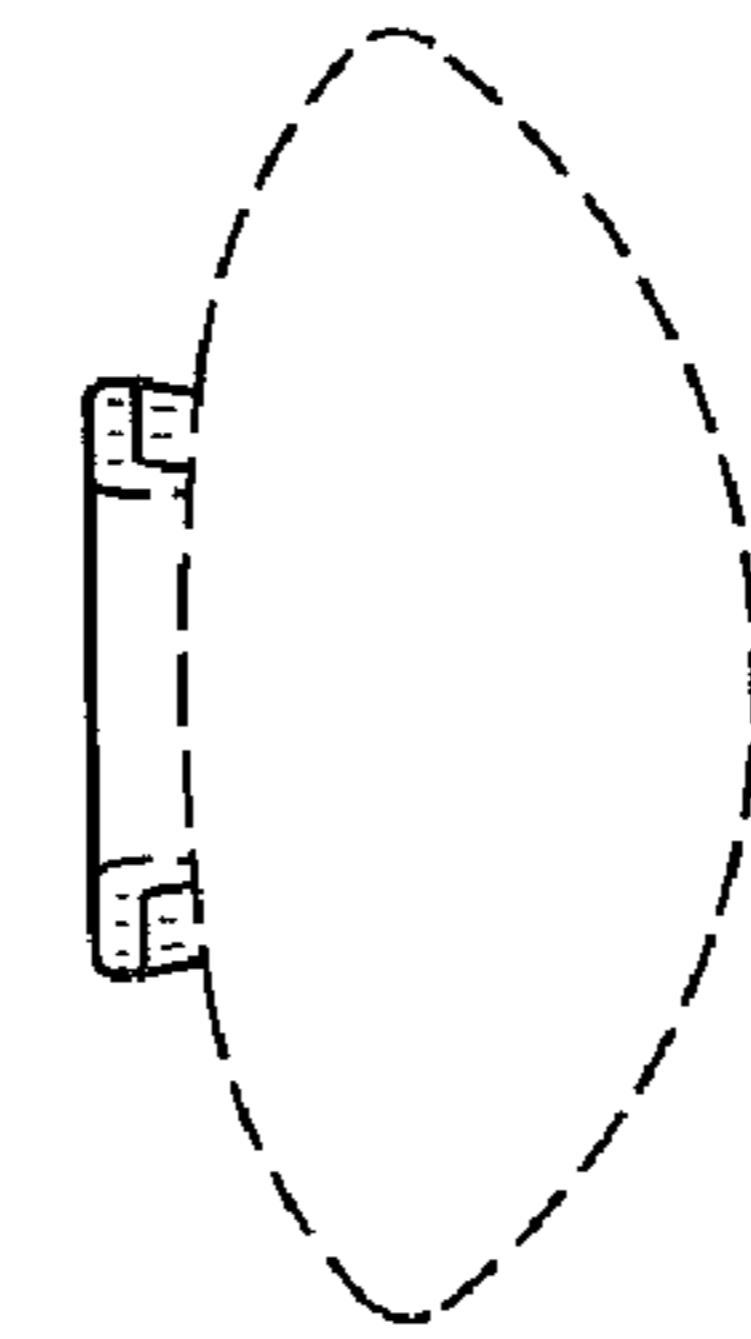

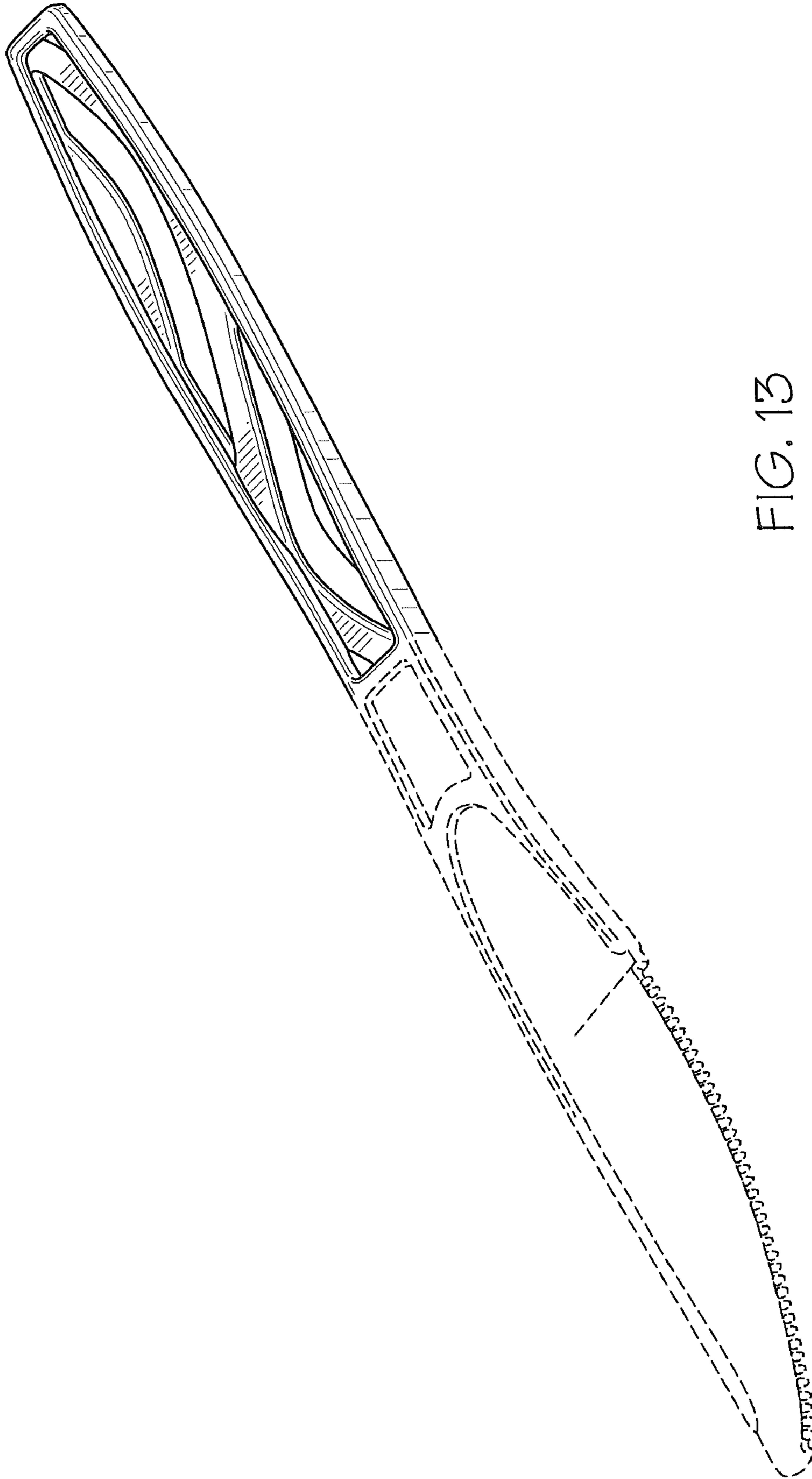

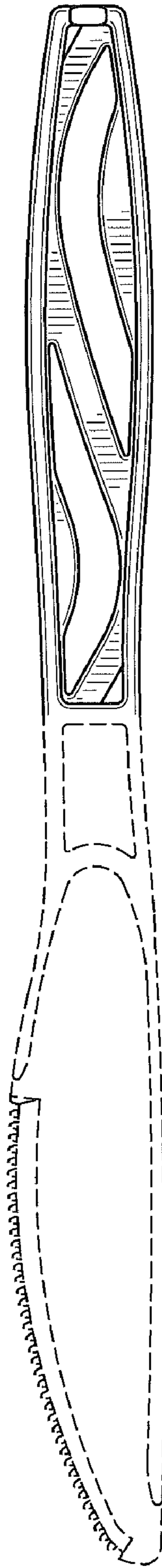

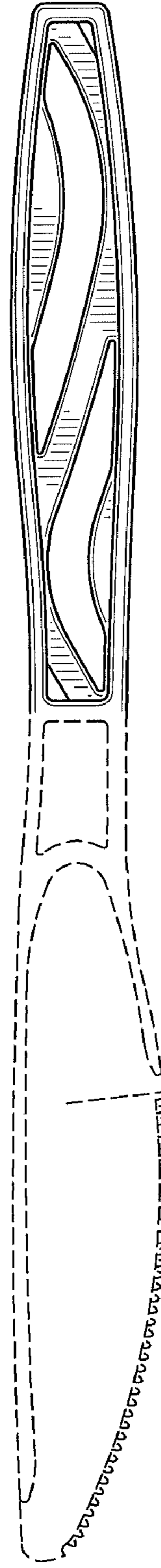

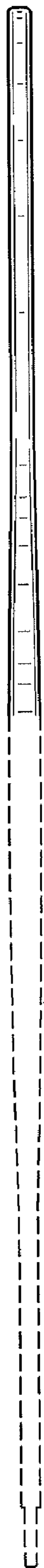

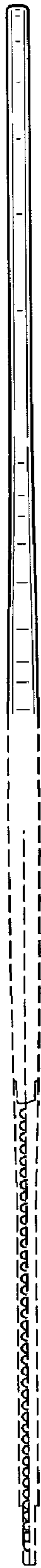
