(57) **CLAIM**

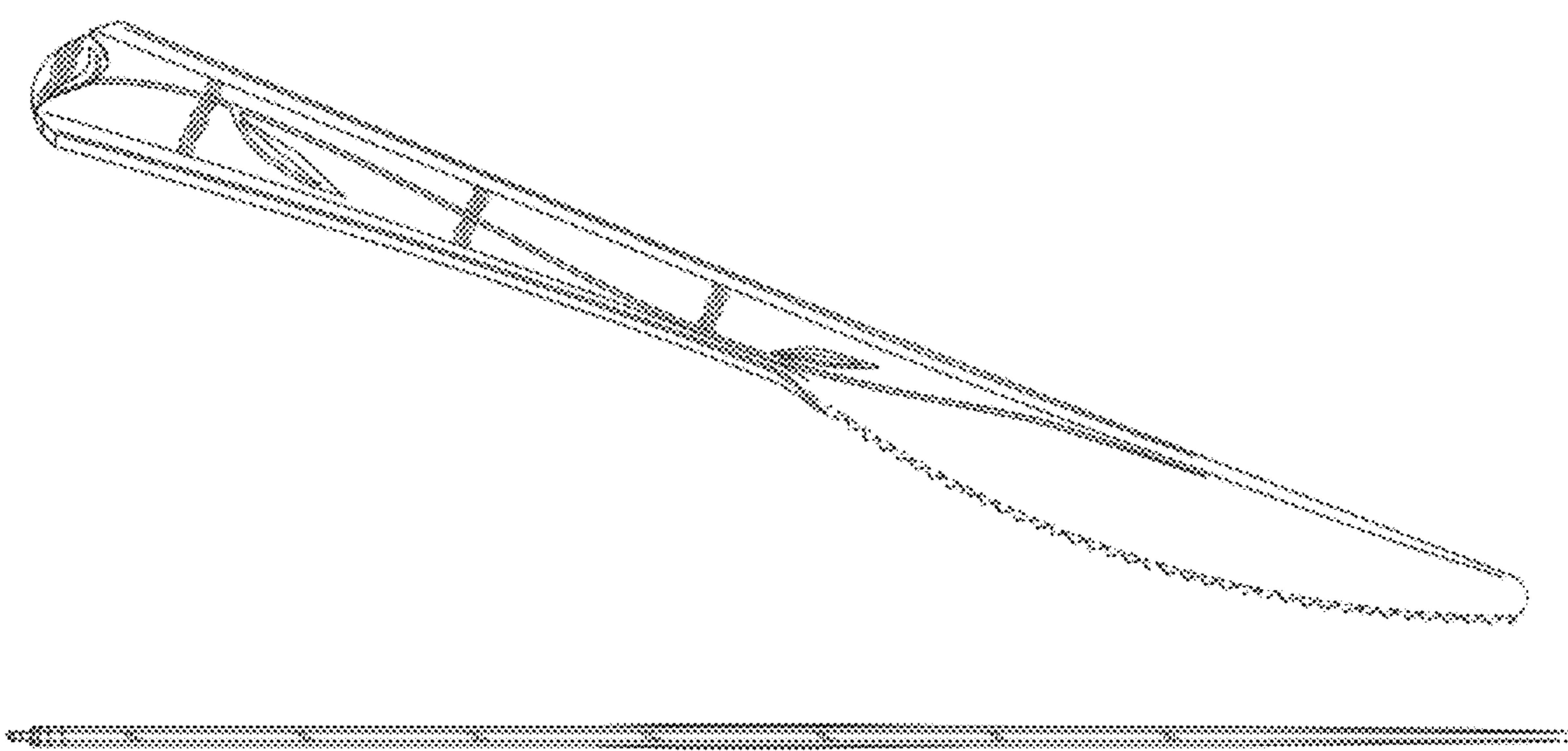
The ornamental design for a disposable plastic knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, right side elevation view of a disposable plastic knife, showing my new design;  
 FIG. 2 is a right side elevation view thereof, where the left side elevation view is a mirror image of the right side elevation view;  
 FIG. 3 is a rear view thereof;

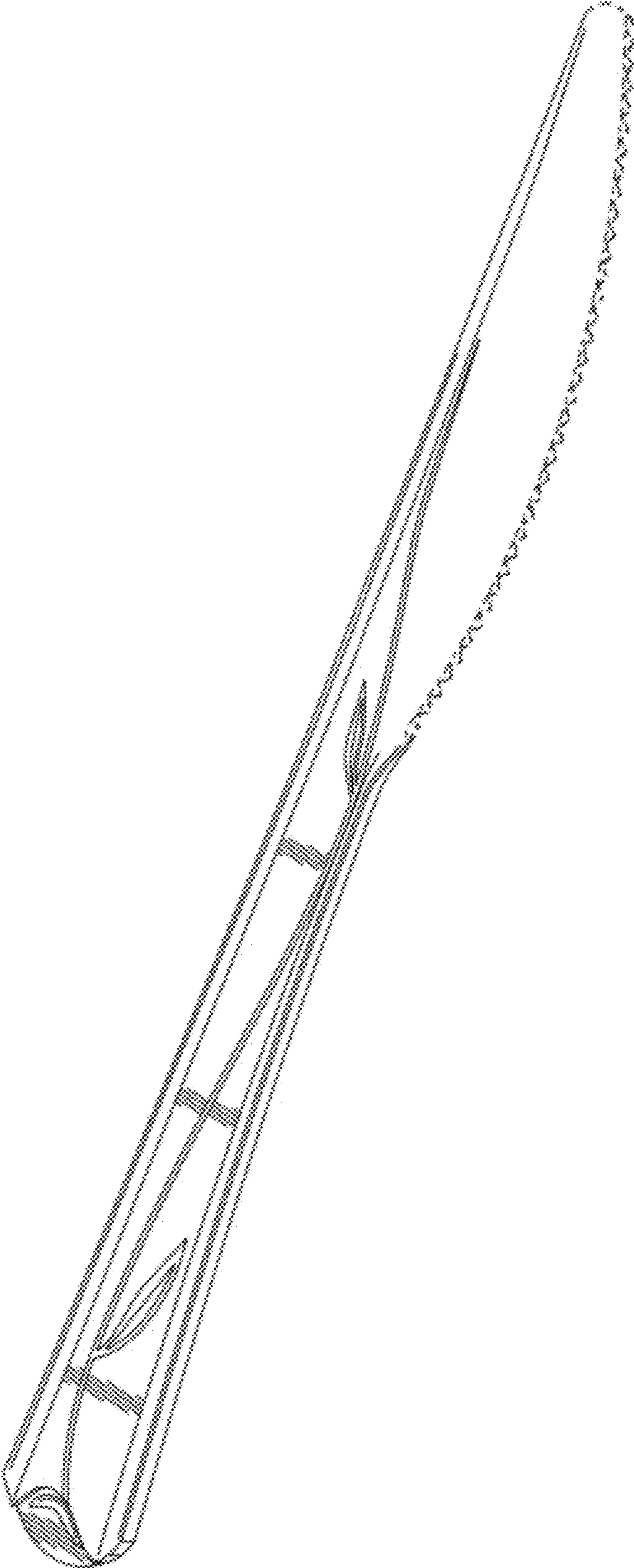

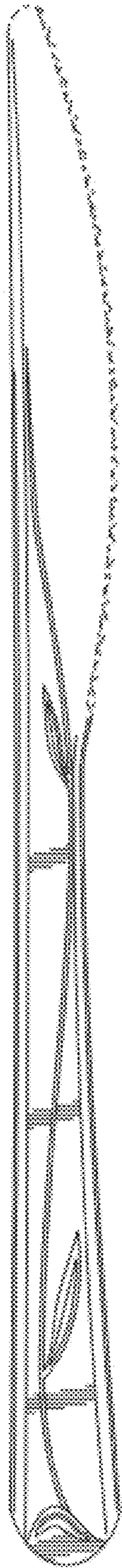
