The ornamental design for a disposable plastic fork, as shown and described.

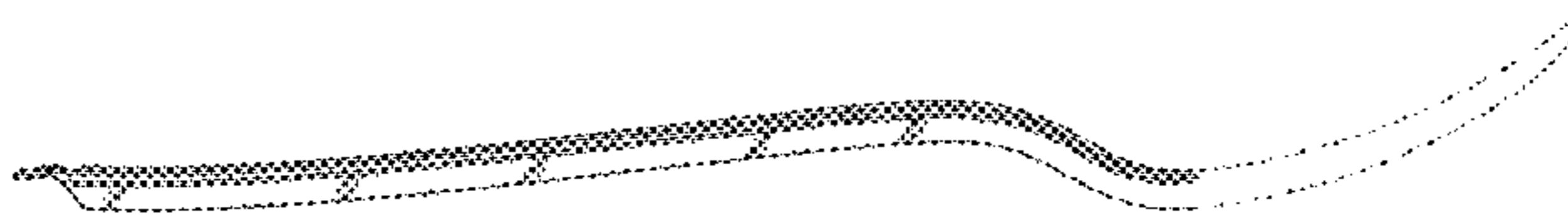
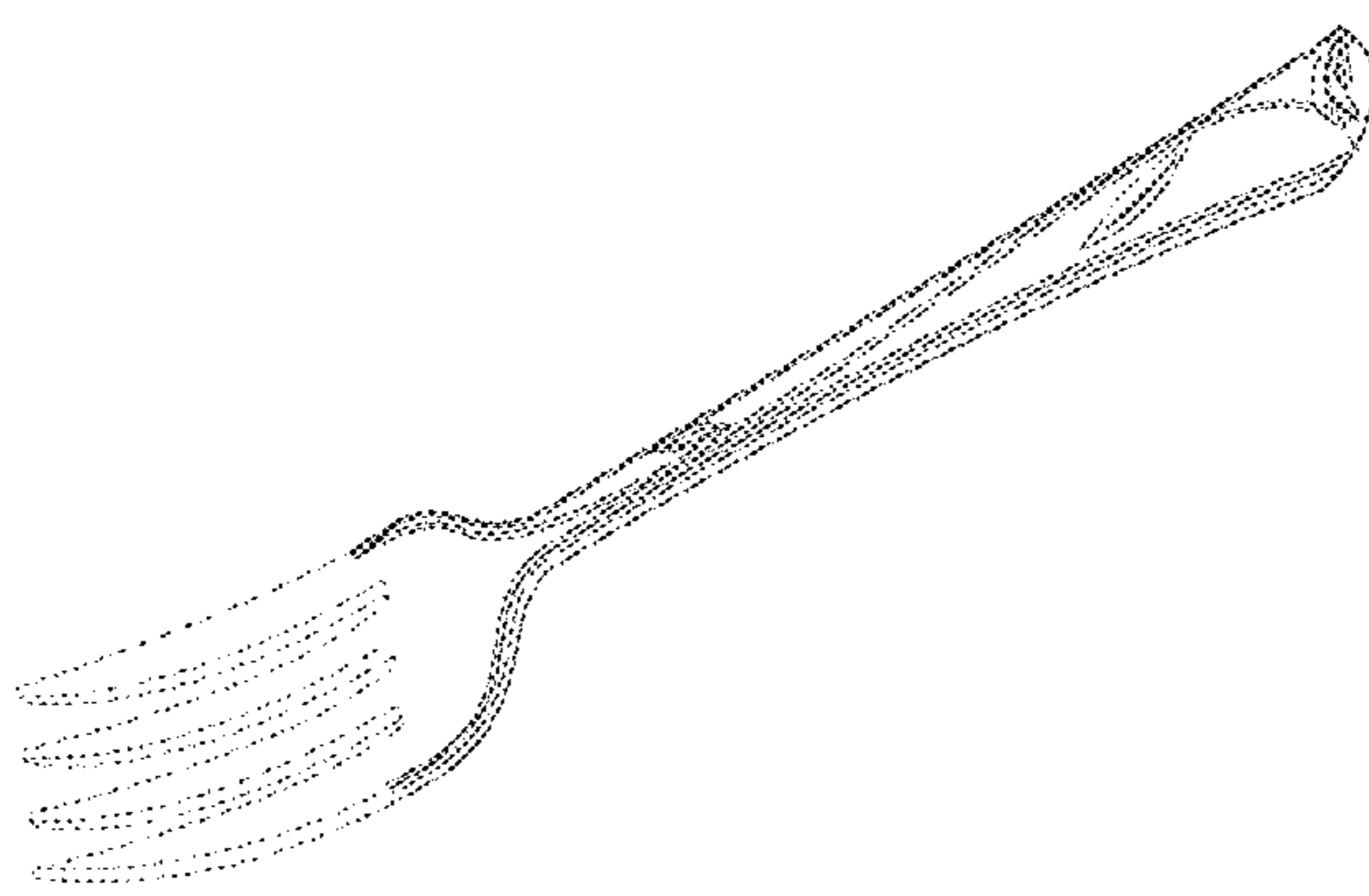
DESCRIPTION

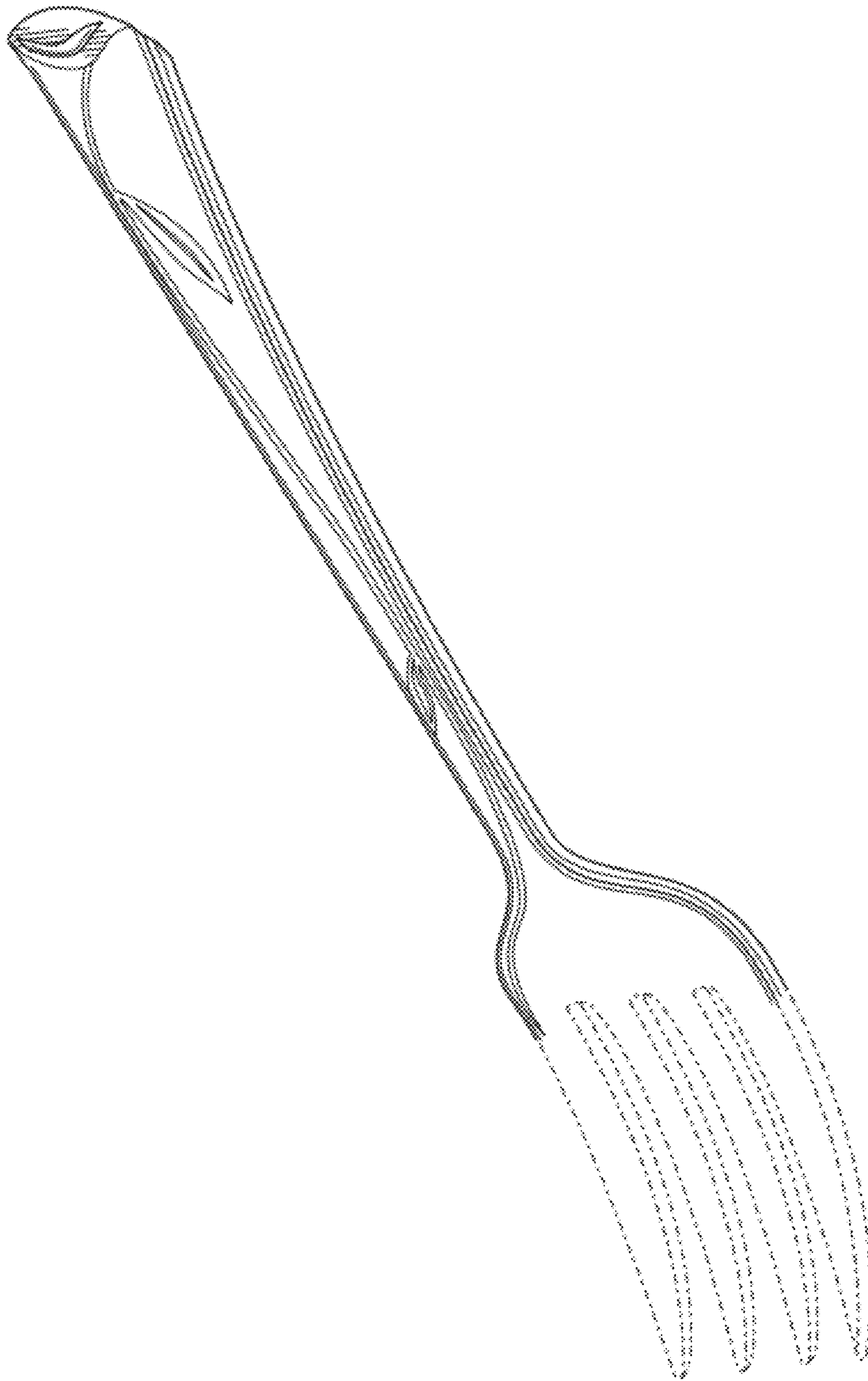

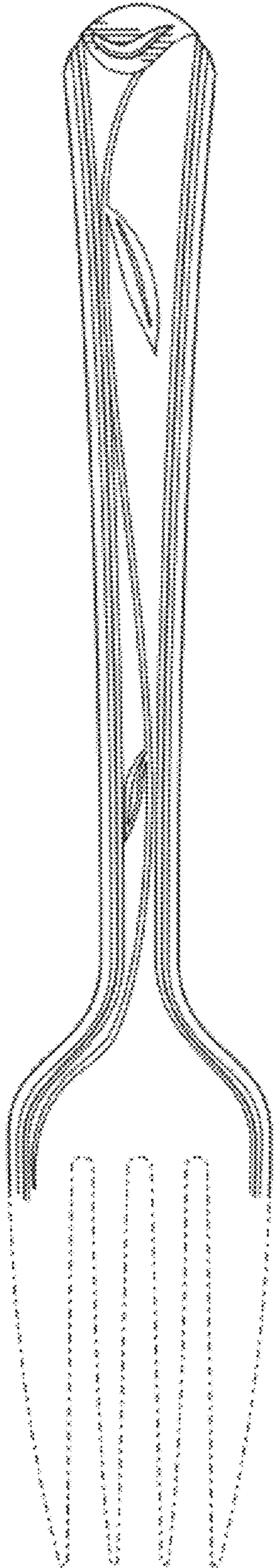

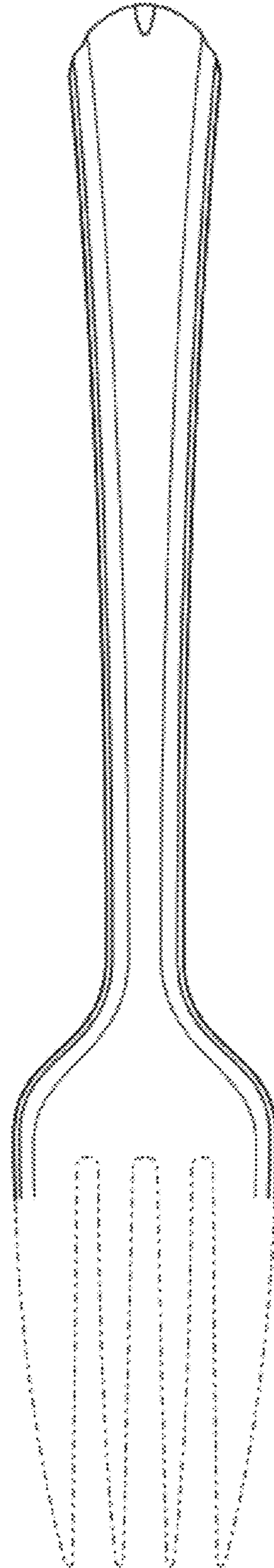

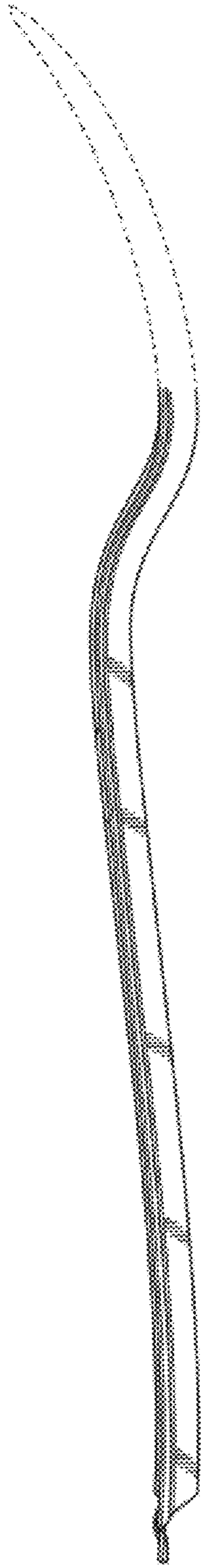

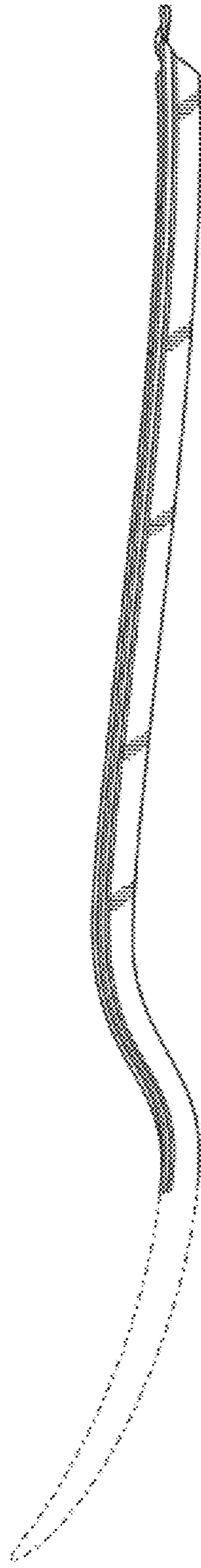

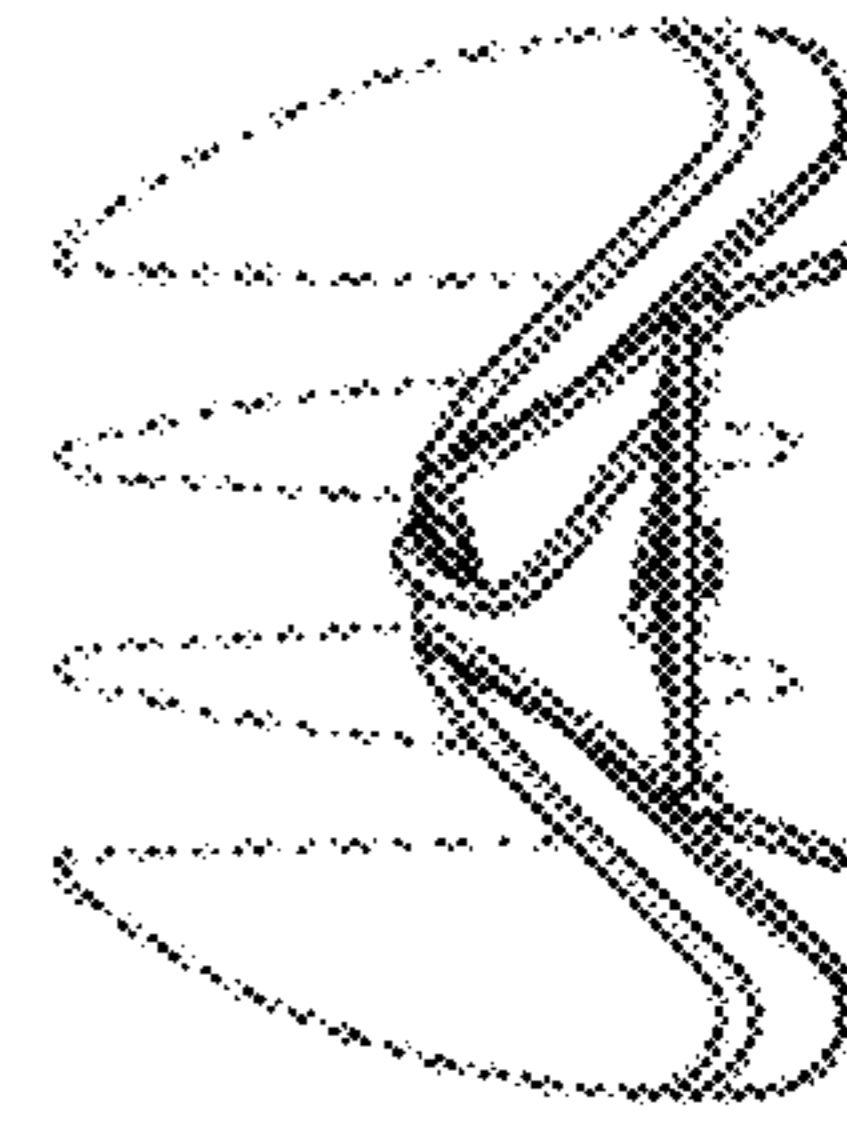
