DESCRIPTION

FIG. 1 is a top view of the new design for a fruit cutter, the bottom view being symmetrical;

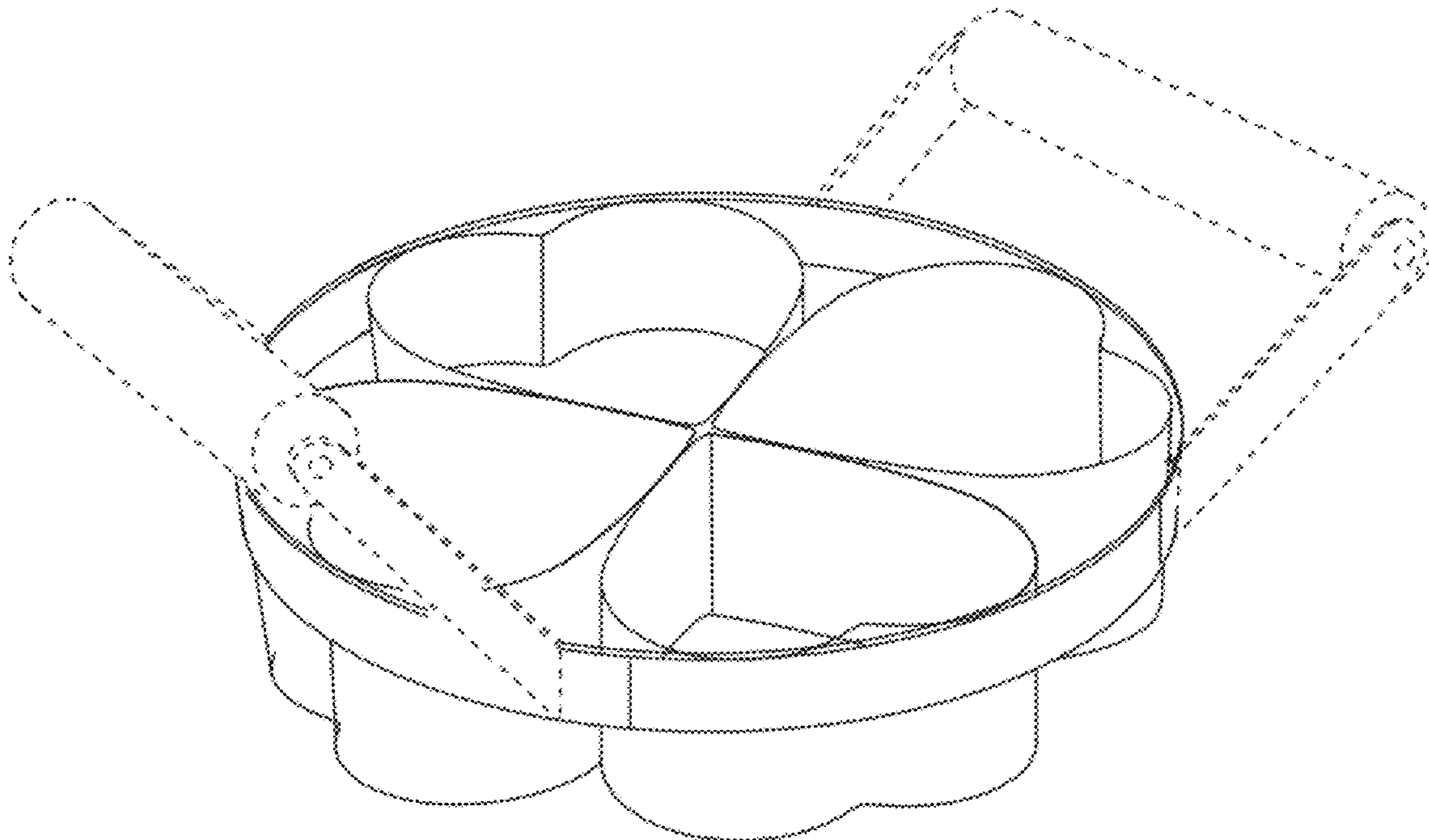
FIG. 2 is a right view thereof, the left view being symmetrical;

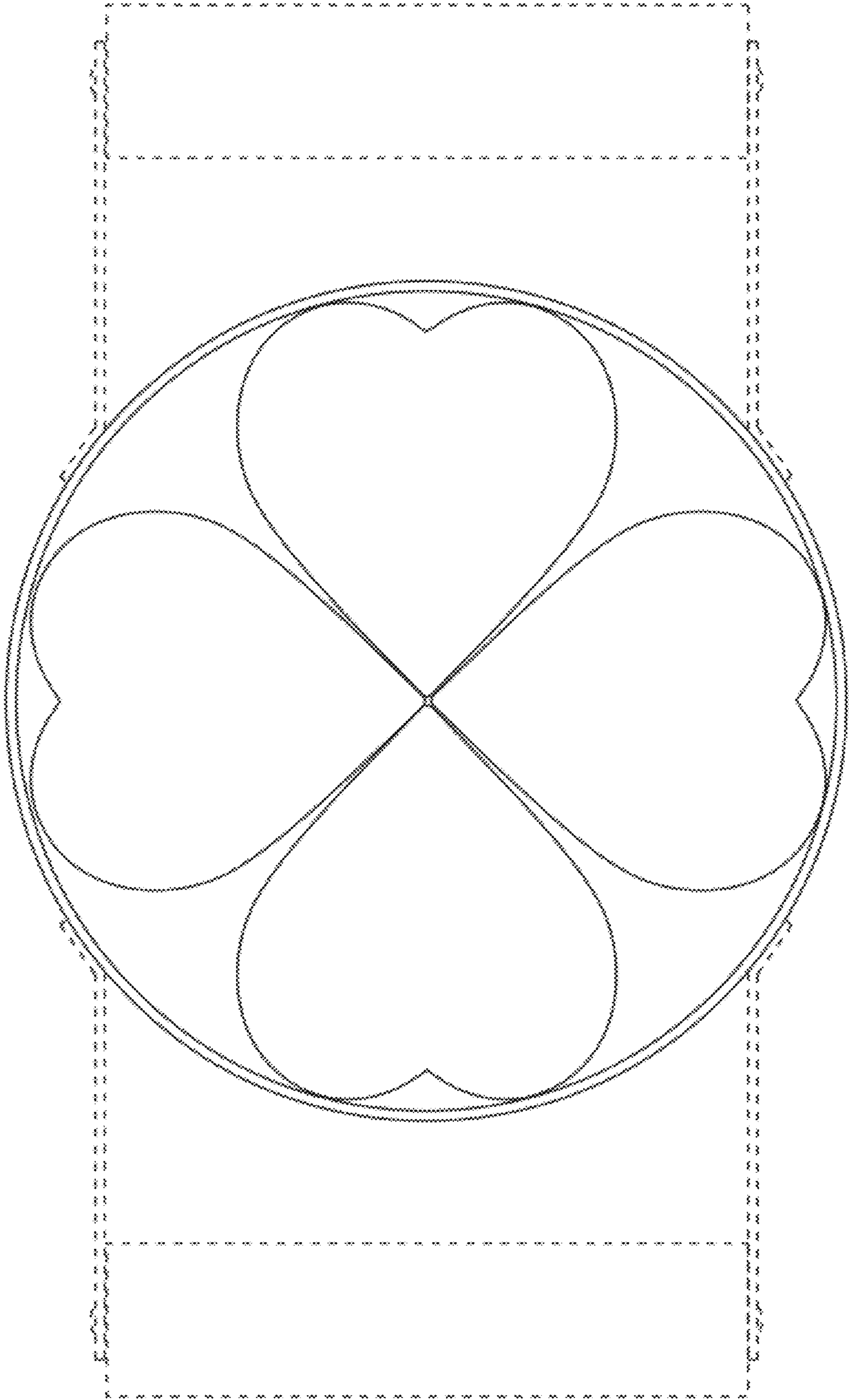

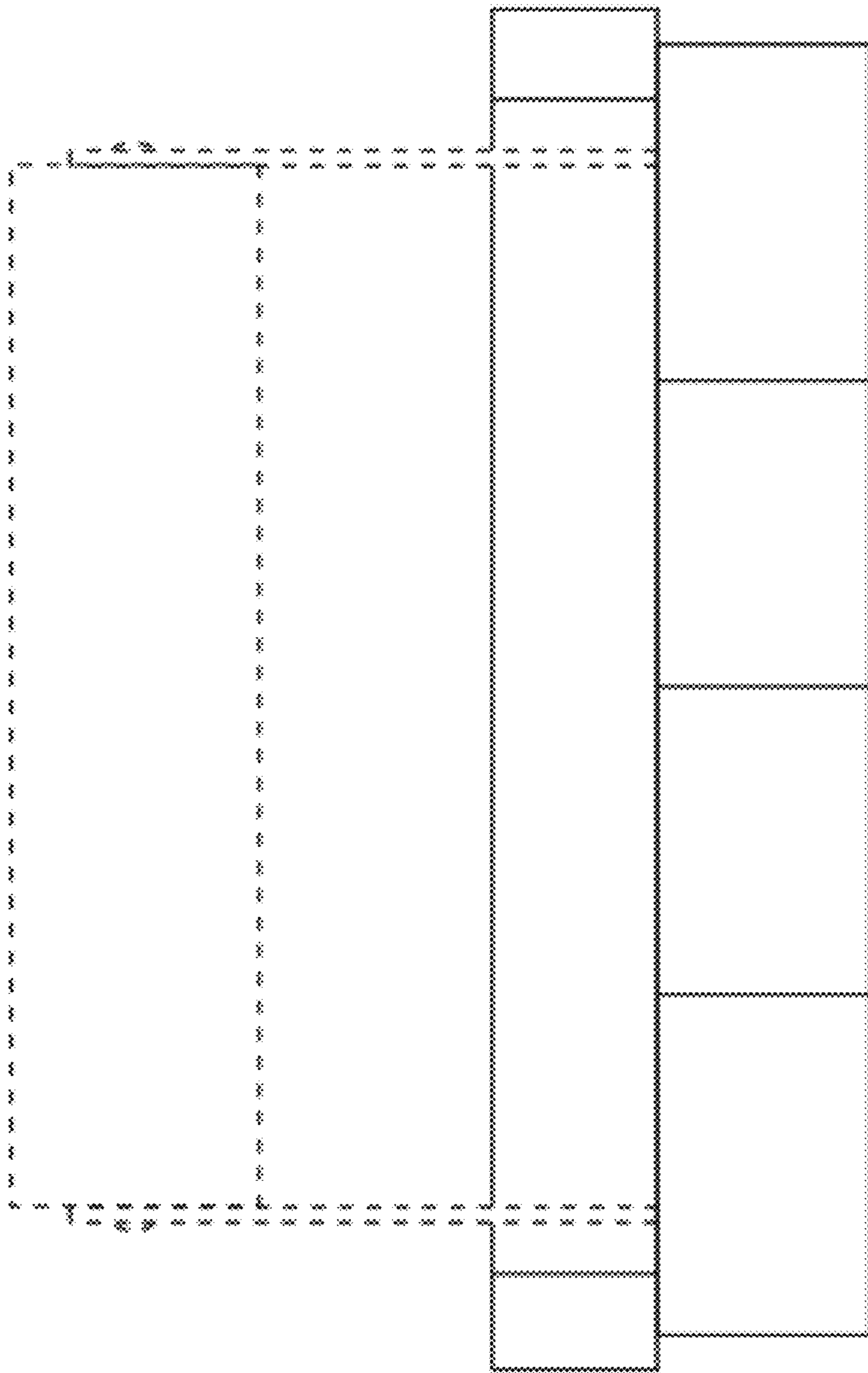

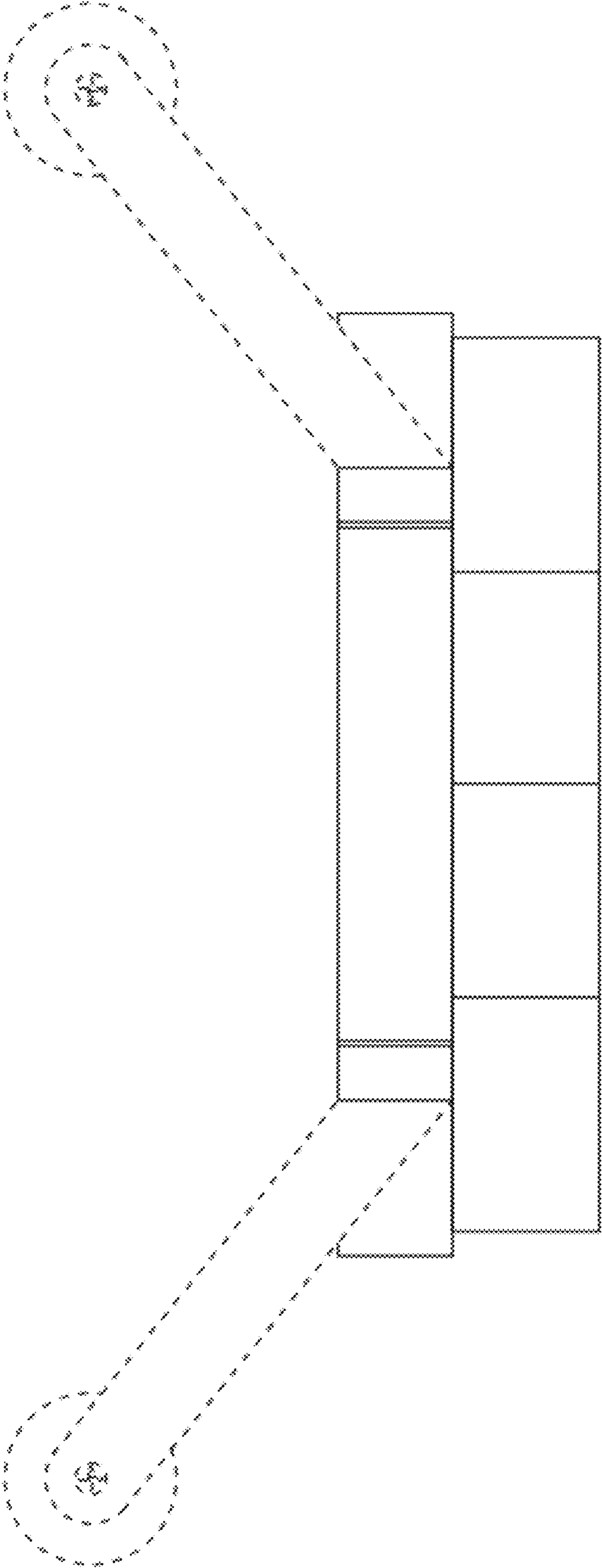

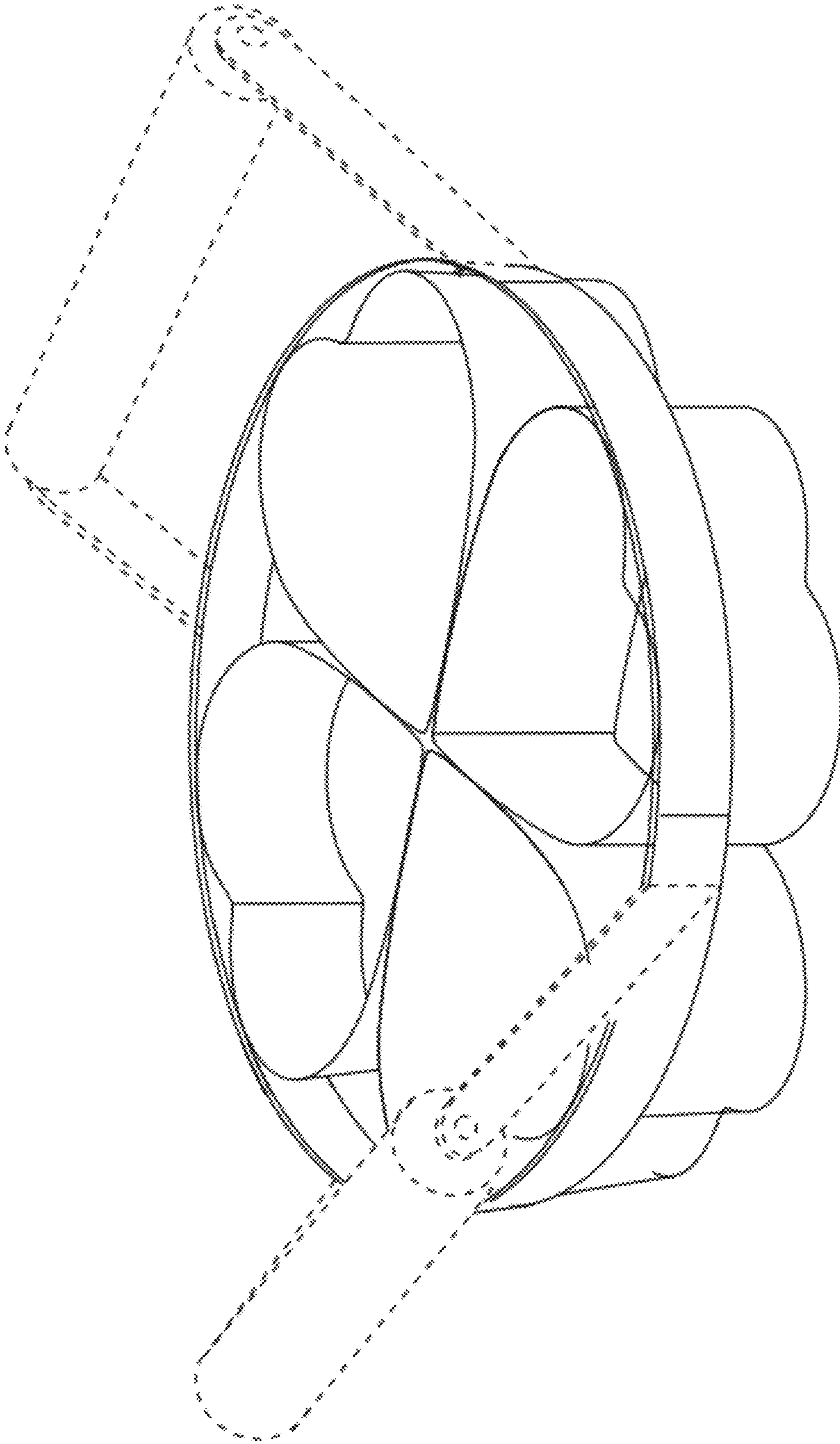
