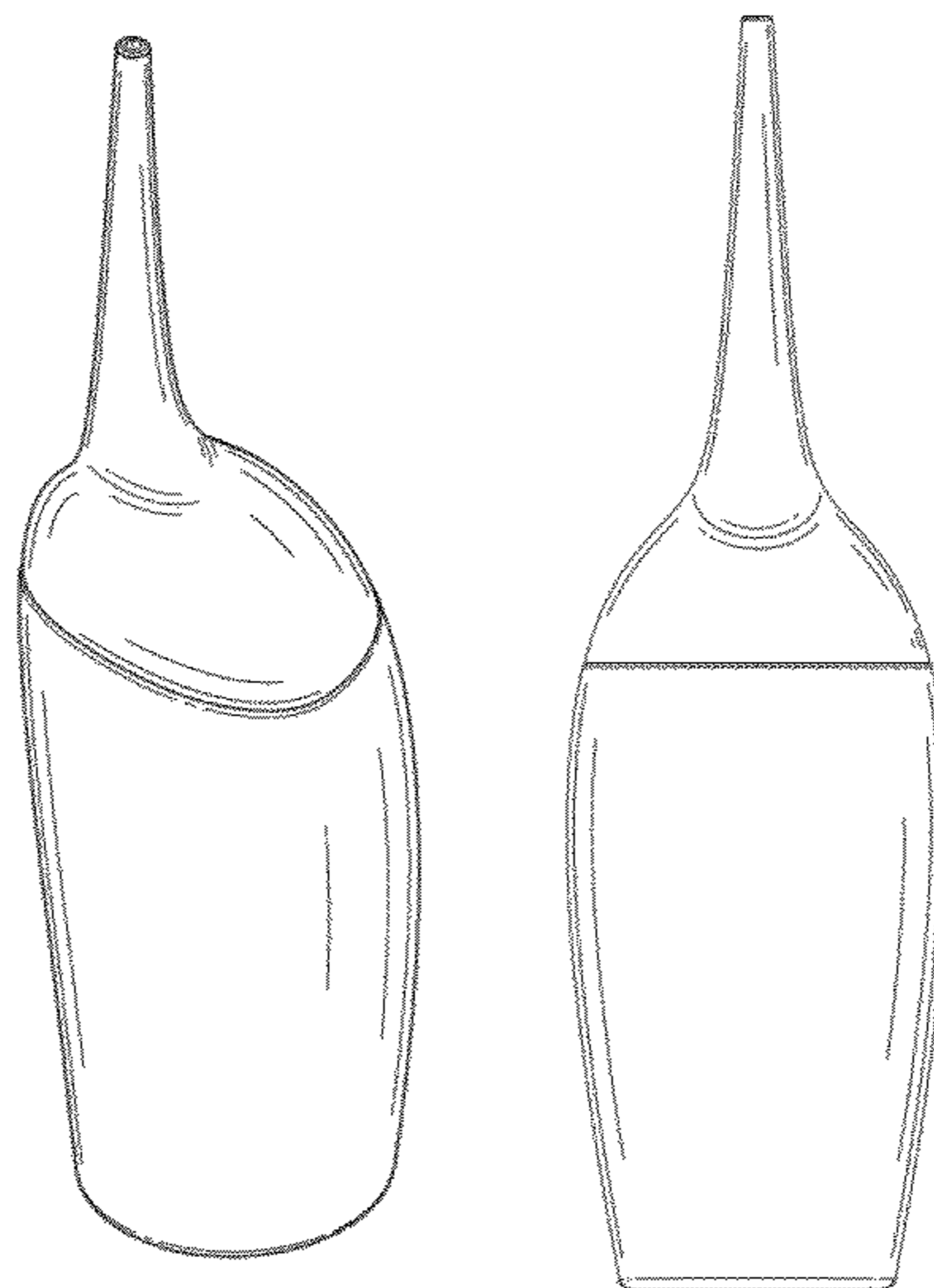
(57) **CLAIM**

The ornamental design for an applicator bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an applicator bottle;  
 FIG. 2 is a front elevational view of the applicator bottle of FIG. 1;  
 FIG. 3 is a rear elevational view of the applicator bottle of FIG. 1;  
 FIG. 4 is a left side elevational view of the applicator bottle of FIG. 1, the right side being a mirror image thereof;  
 FIG. 5 is a top plan view of the applicator bottle of FIG. 1; and,  
 FIG. 6 is a bottle elevational view of the applicator bottle of FIG. 1.

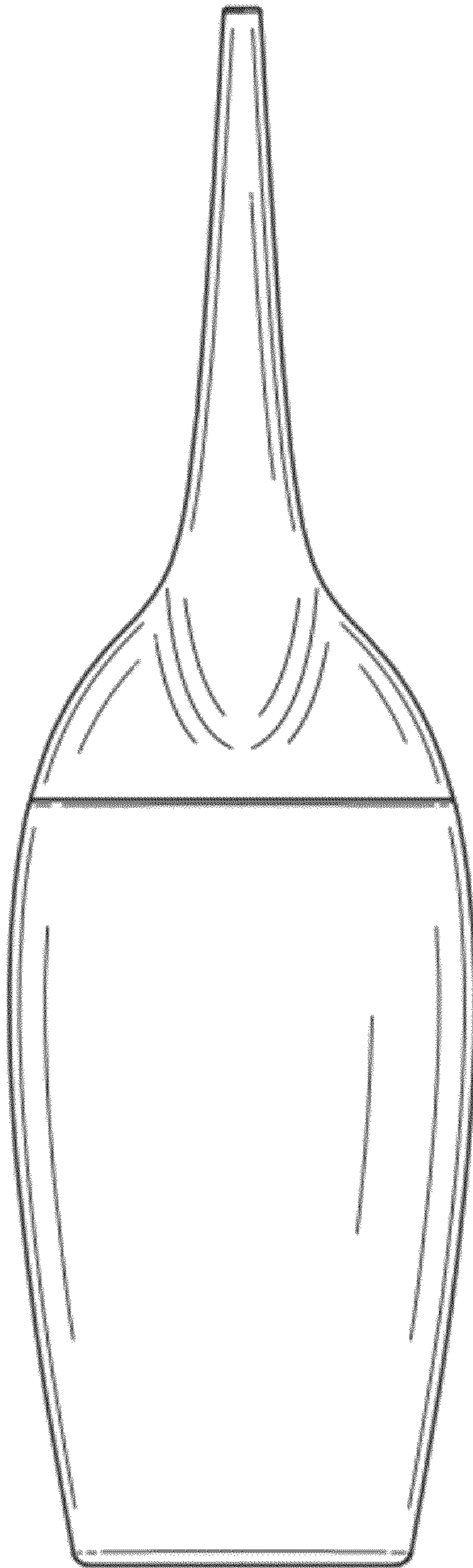
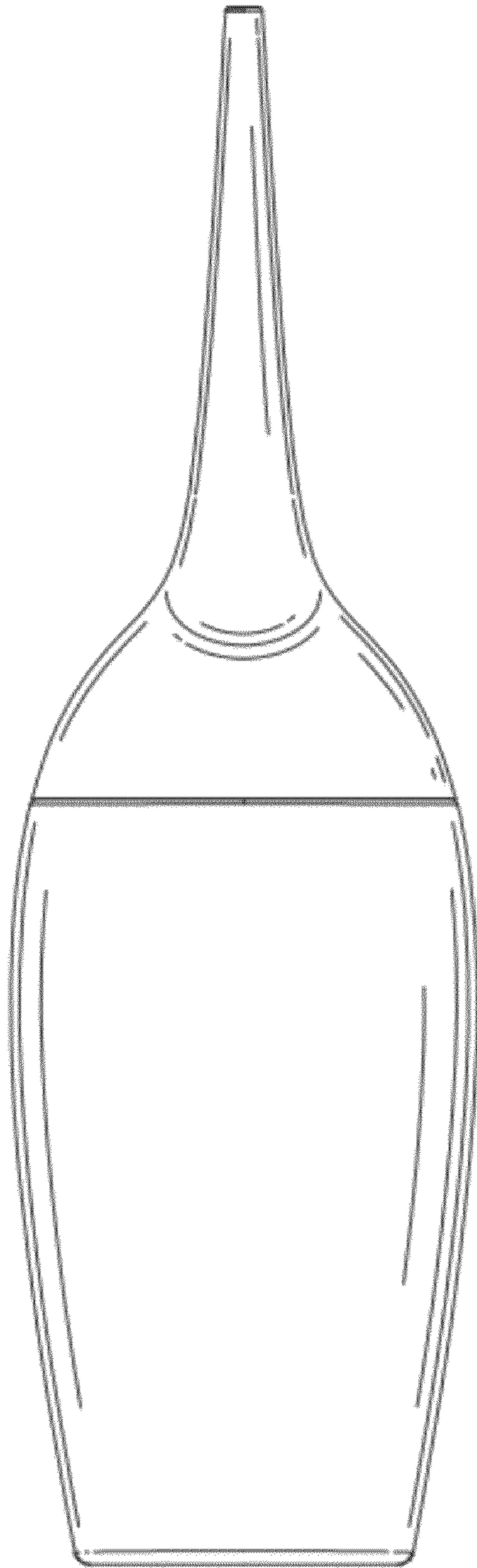
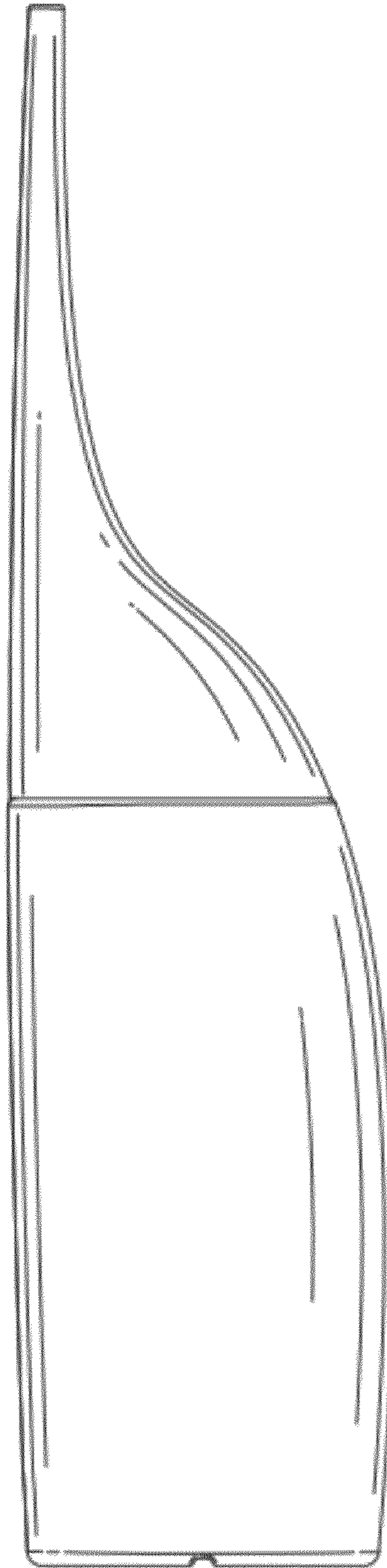


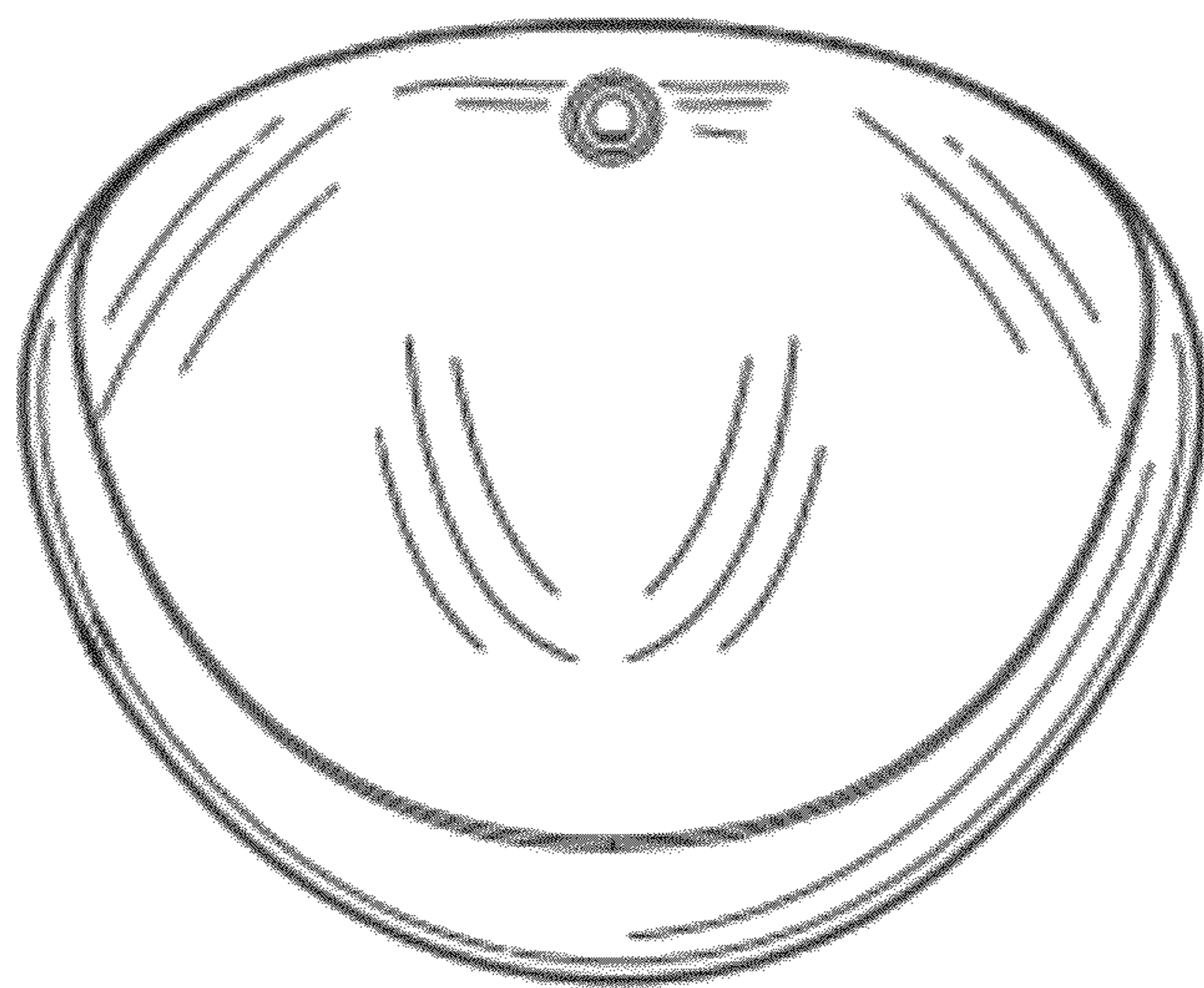

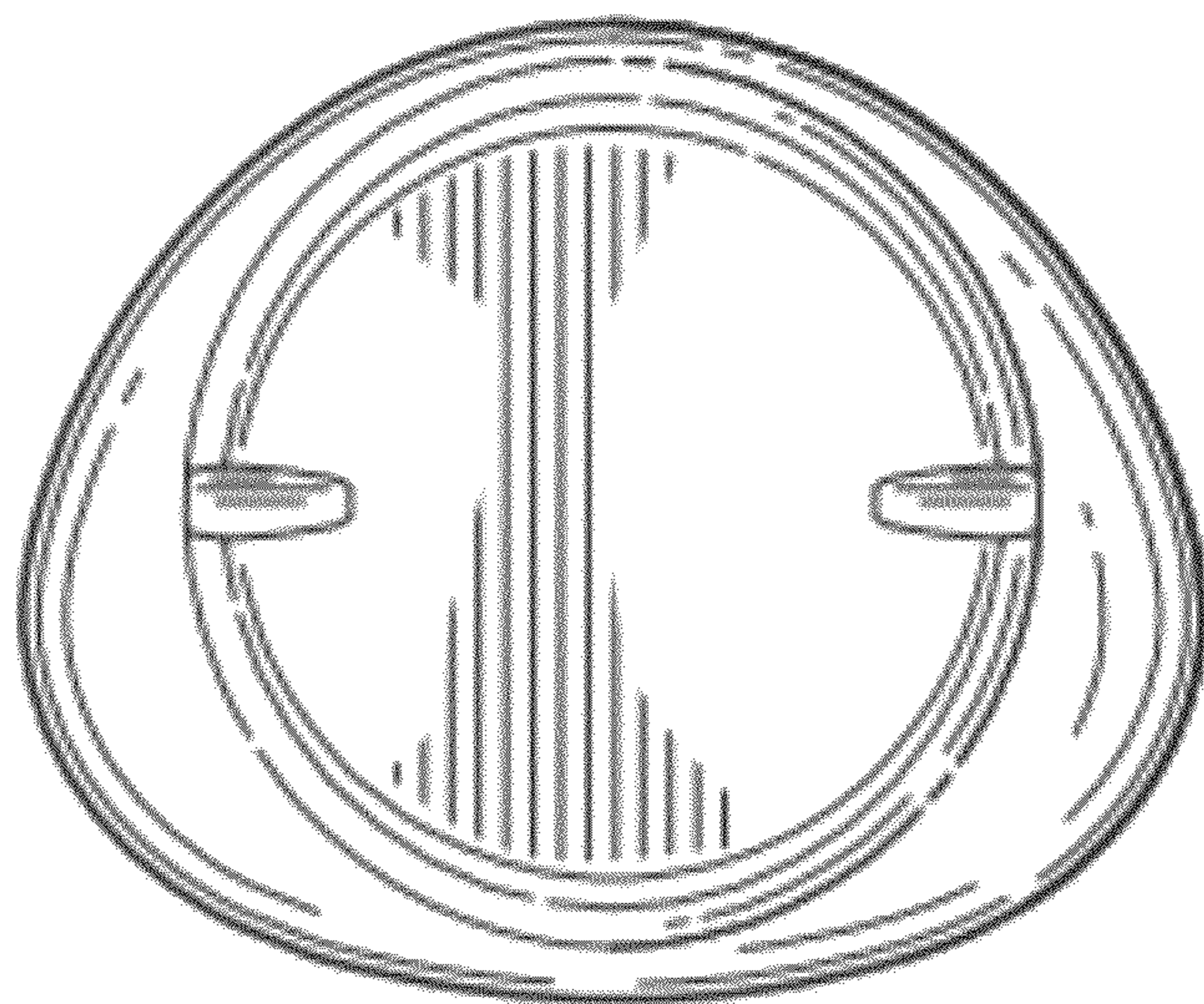
