**DESCRIPTION**

FIG. 1 is a perspective view of a wrist watch case with band showing my new design;

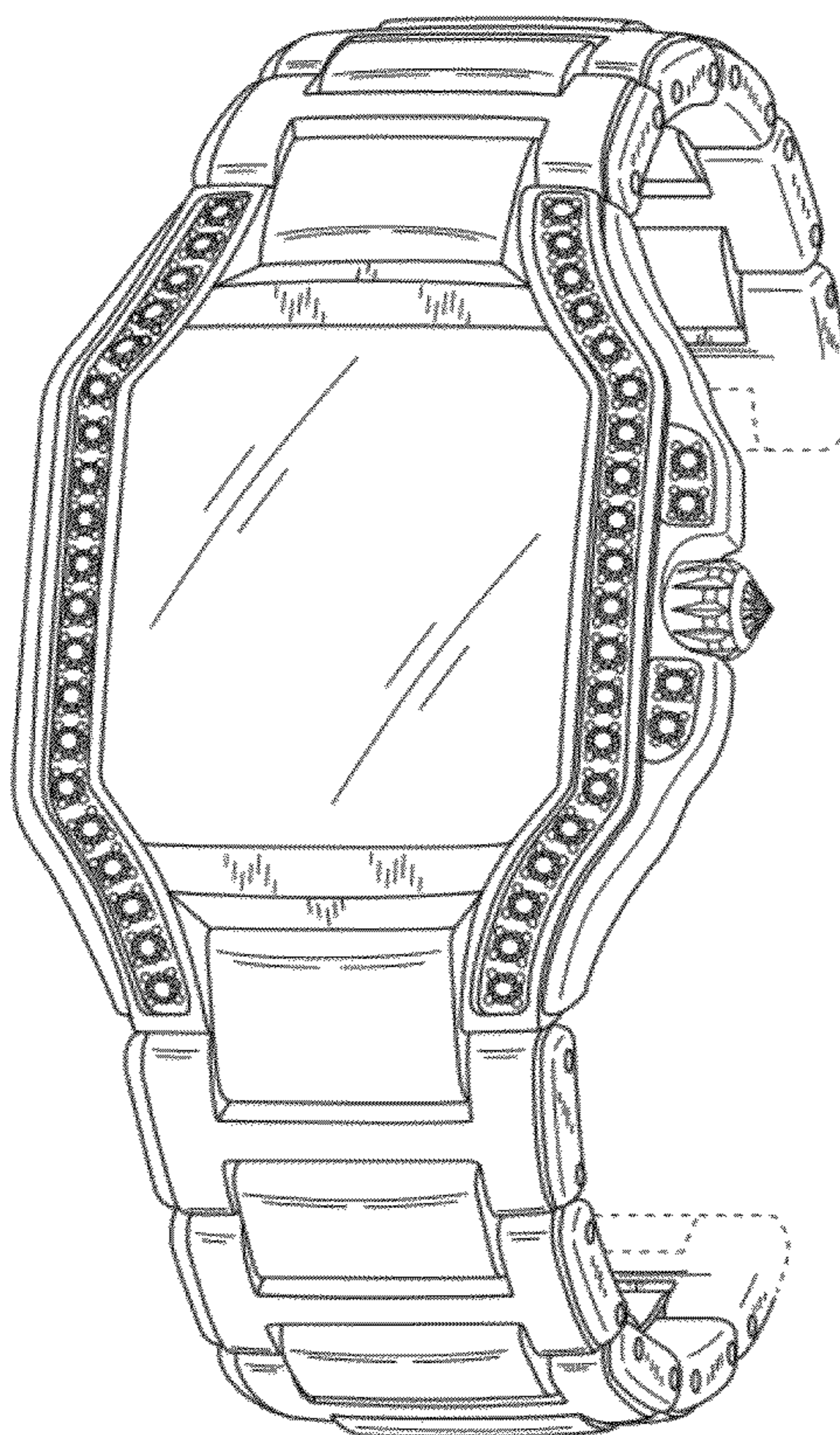

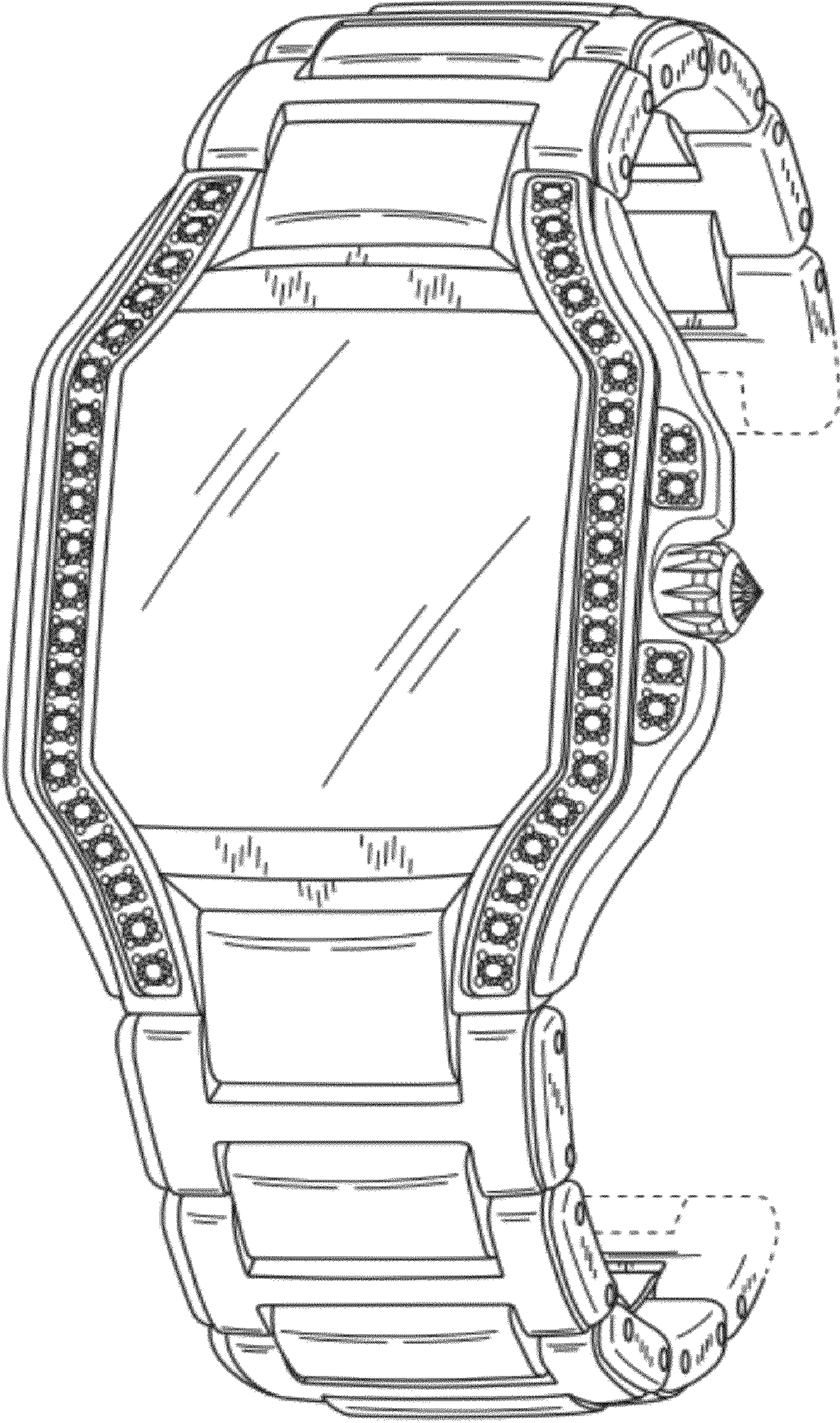

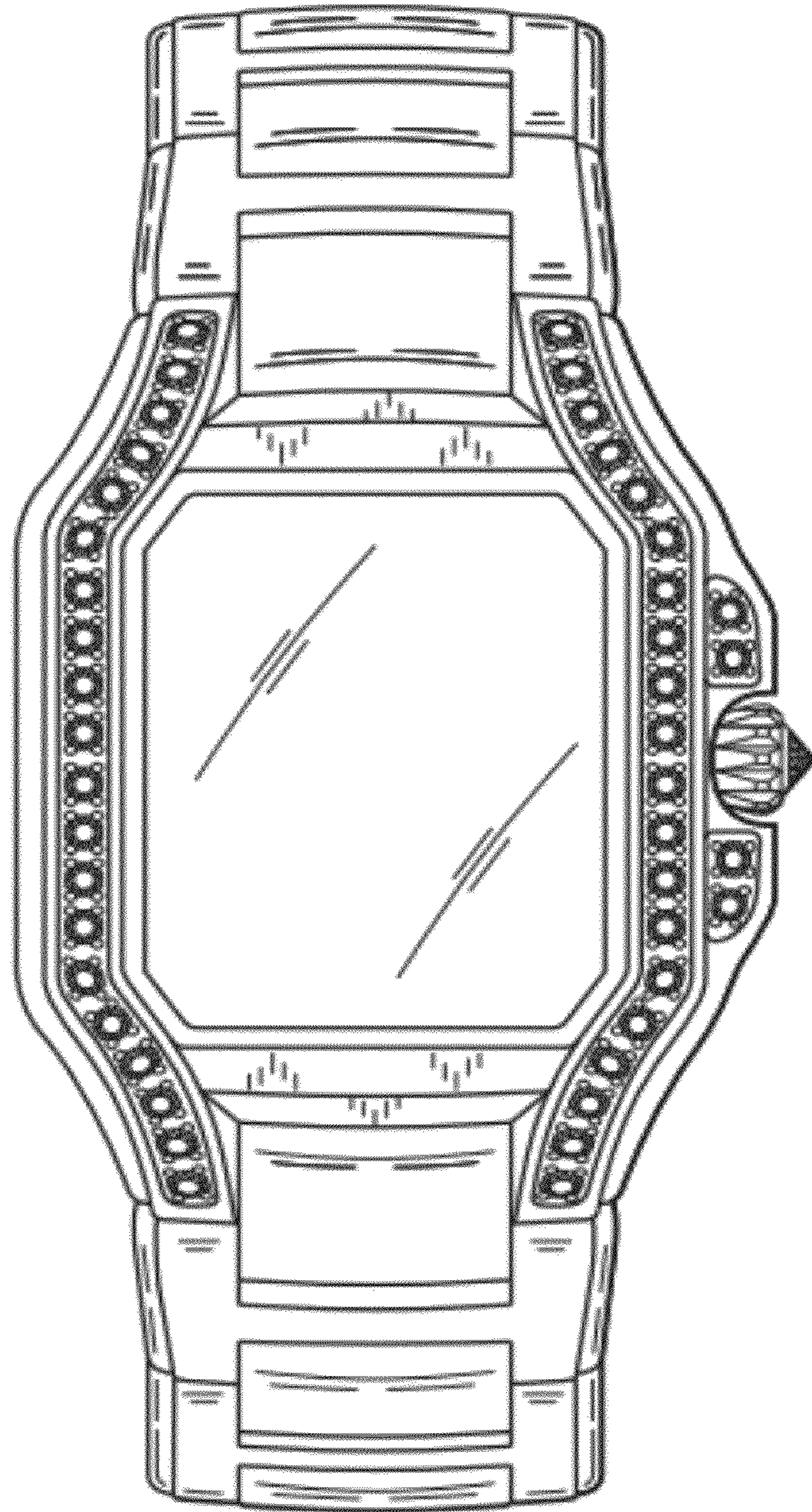

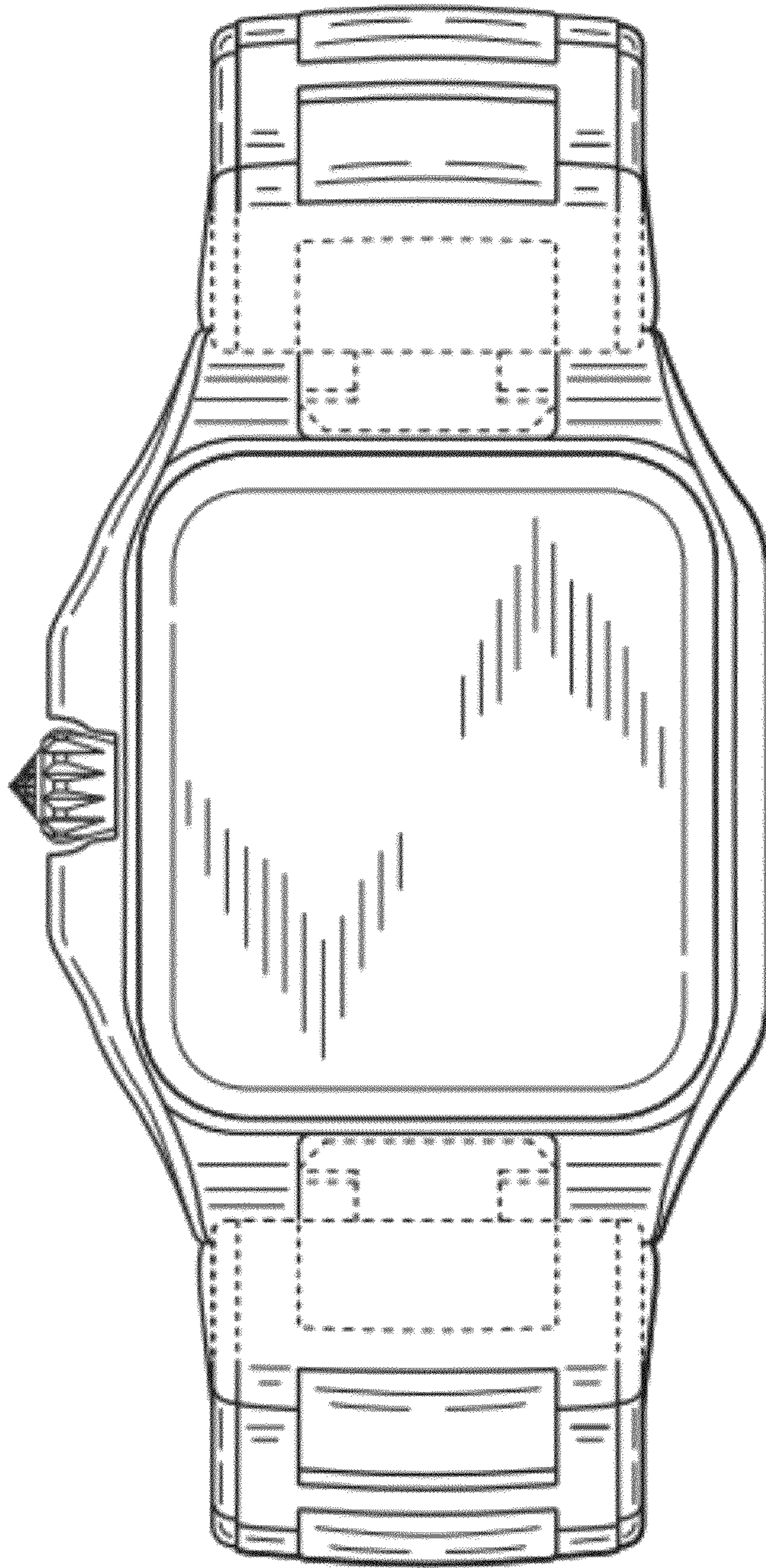

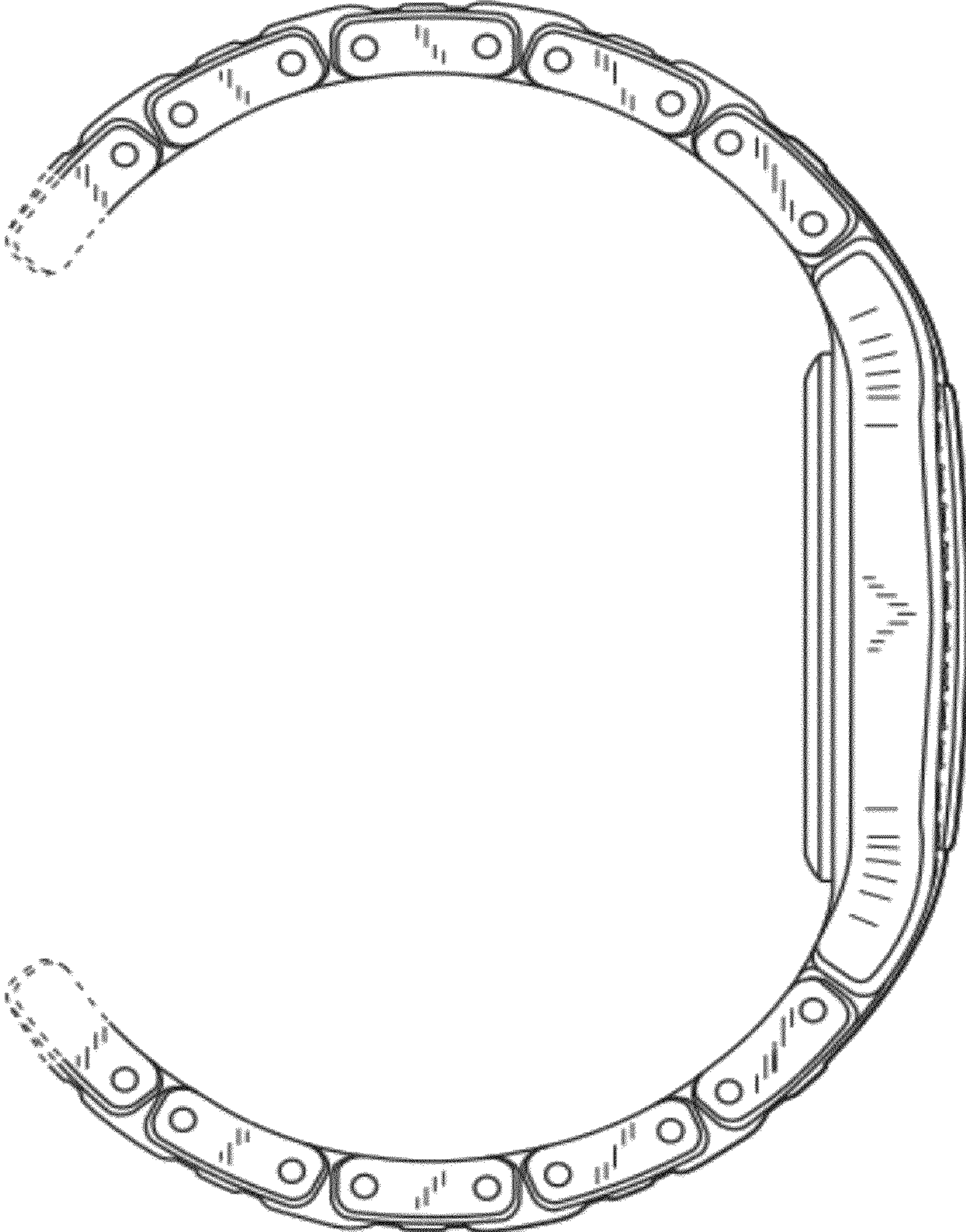

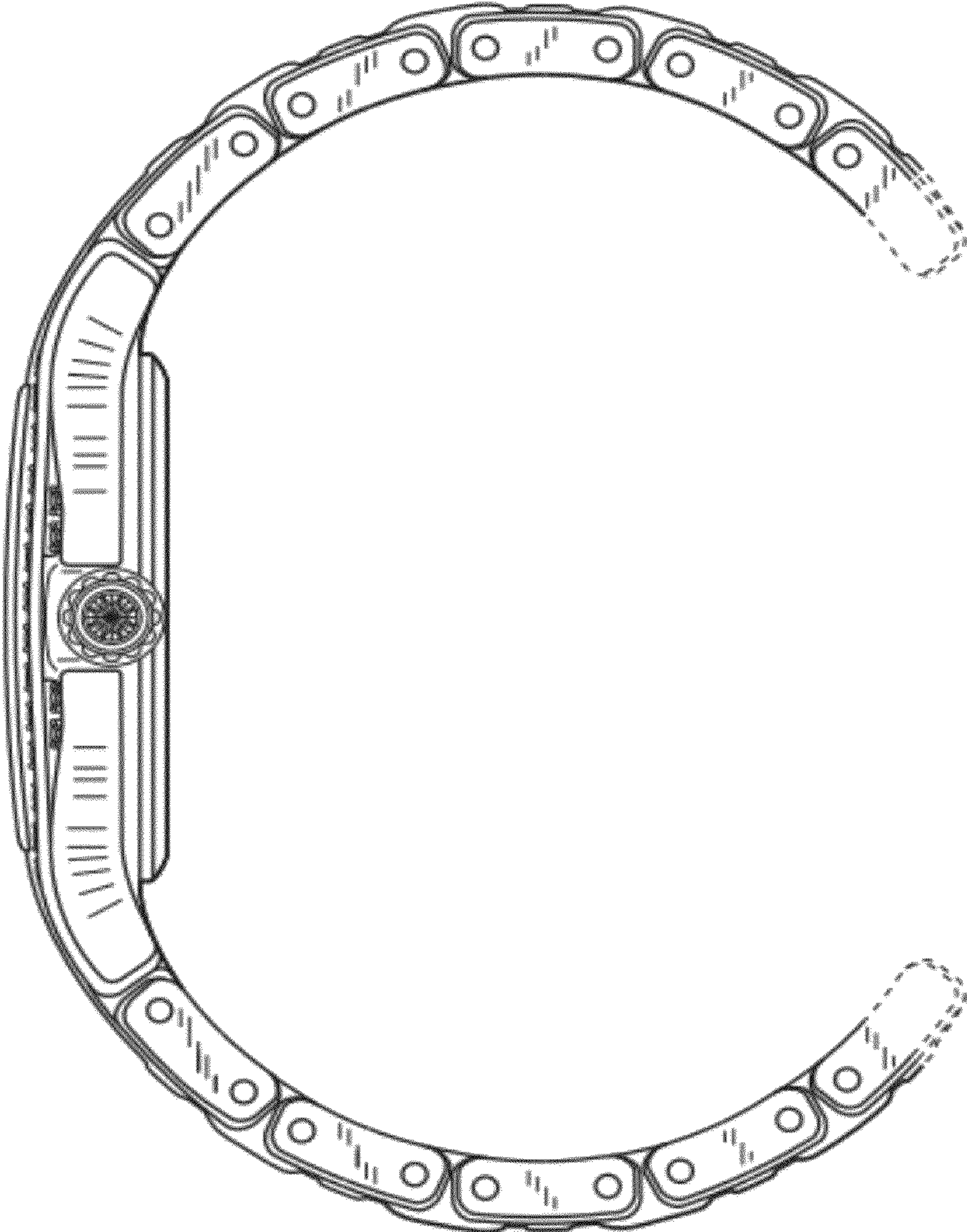

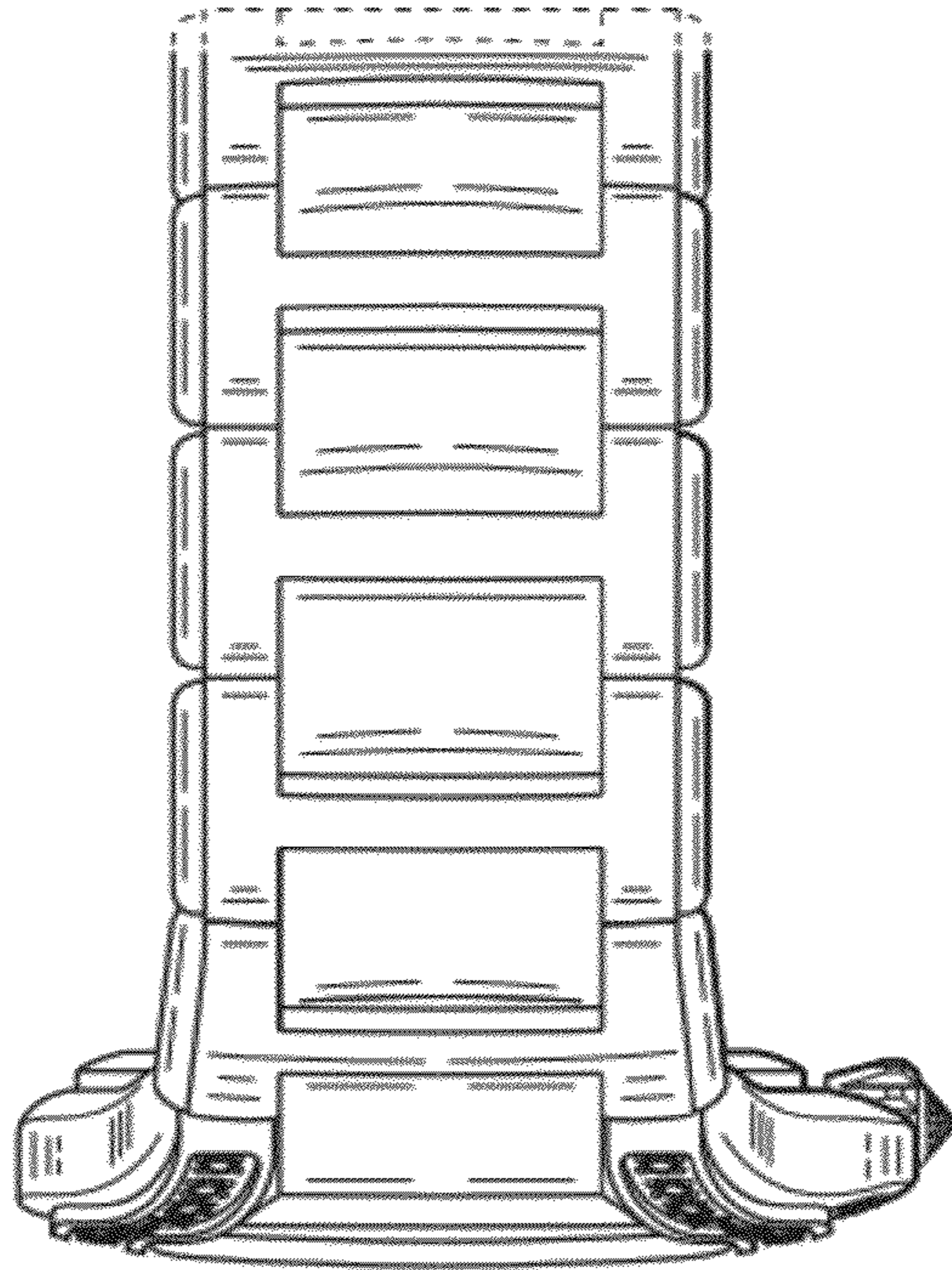
