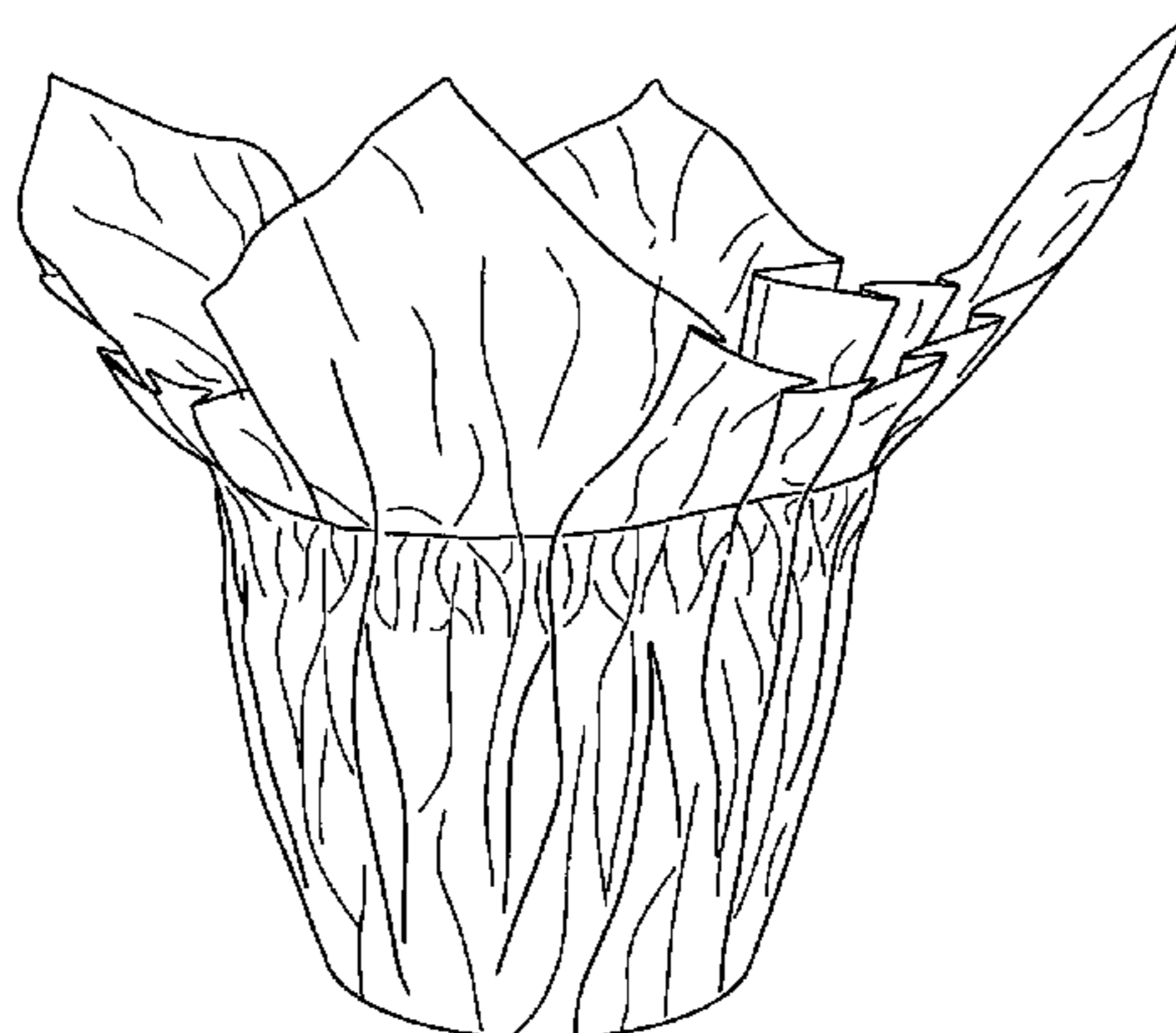
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a flower pot cover showing our new design.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a side elevational view thereof.
FIG. 5 is an elevational view of a side opposite that shown in FIG. 4.

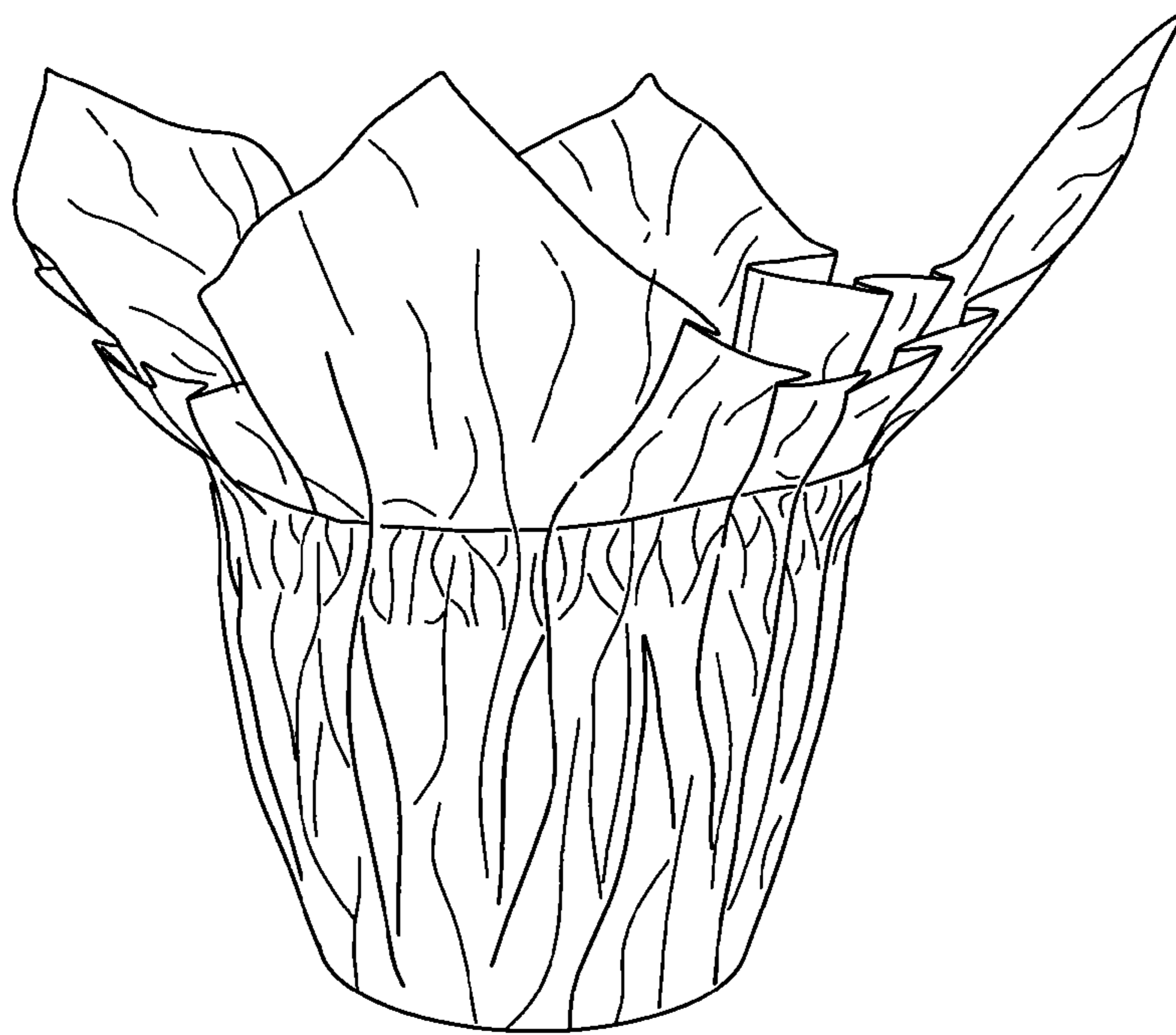

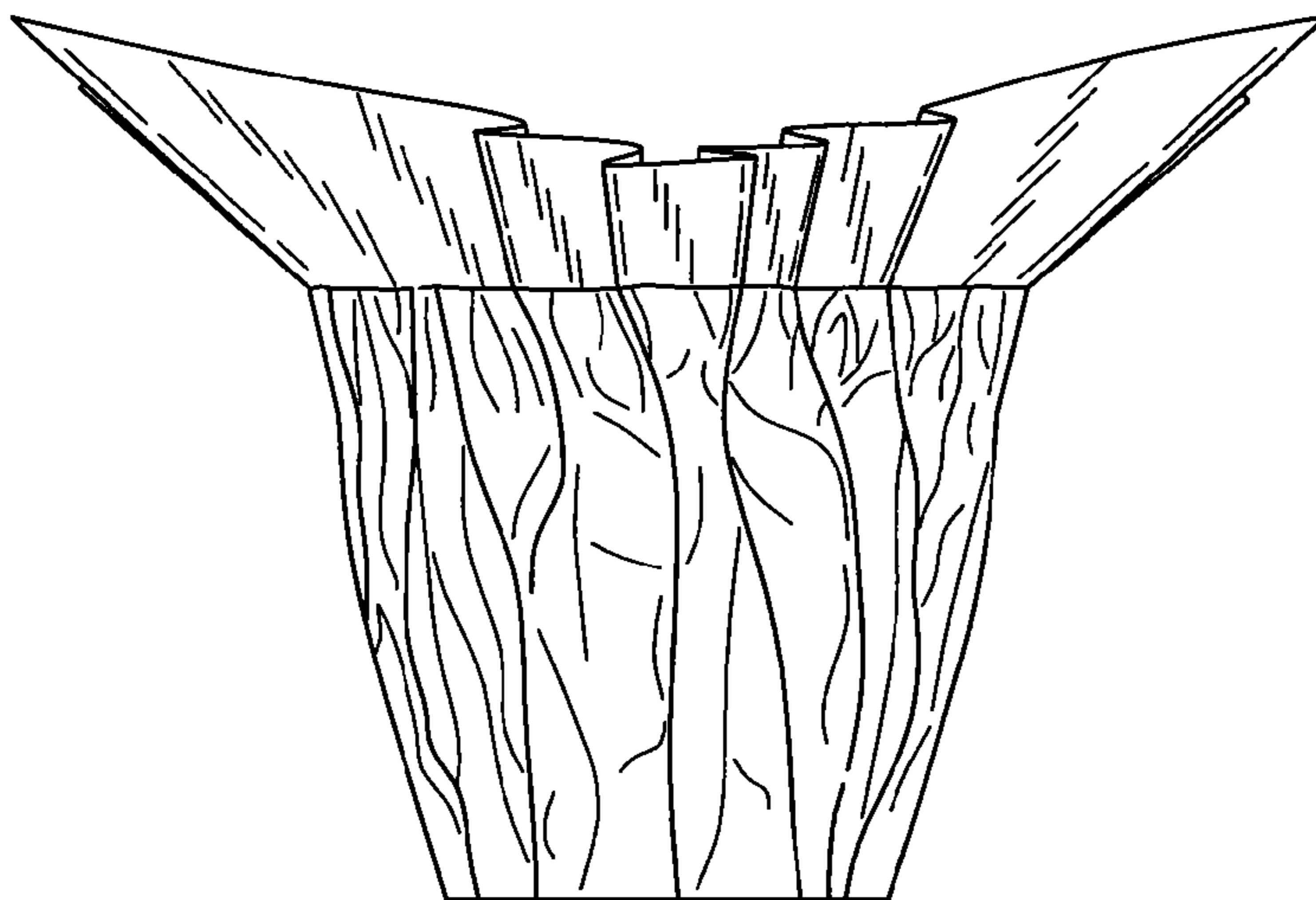

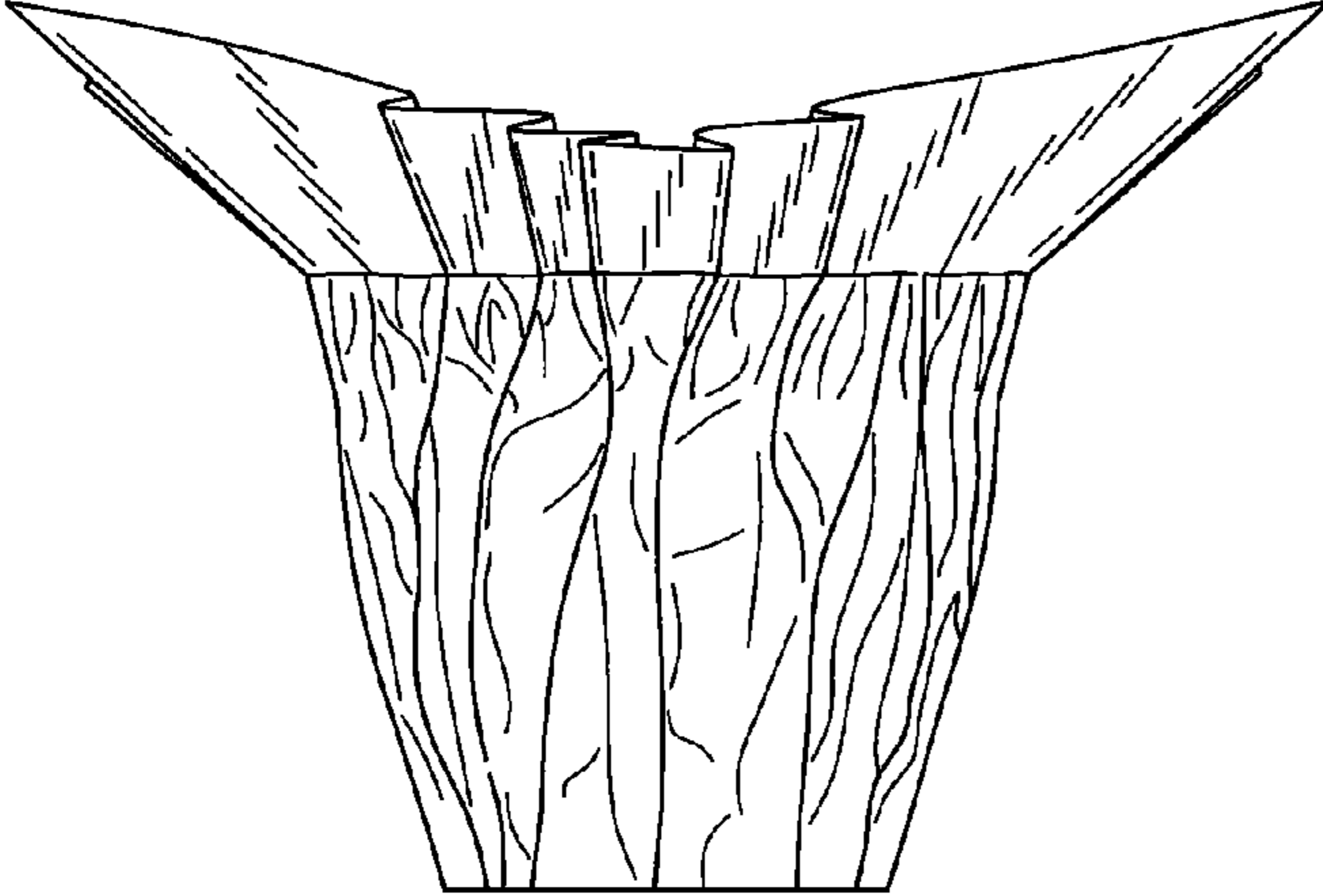

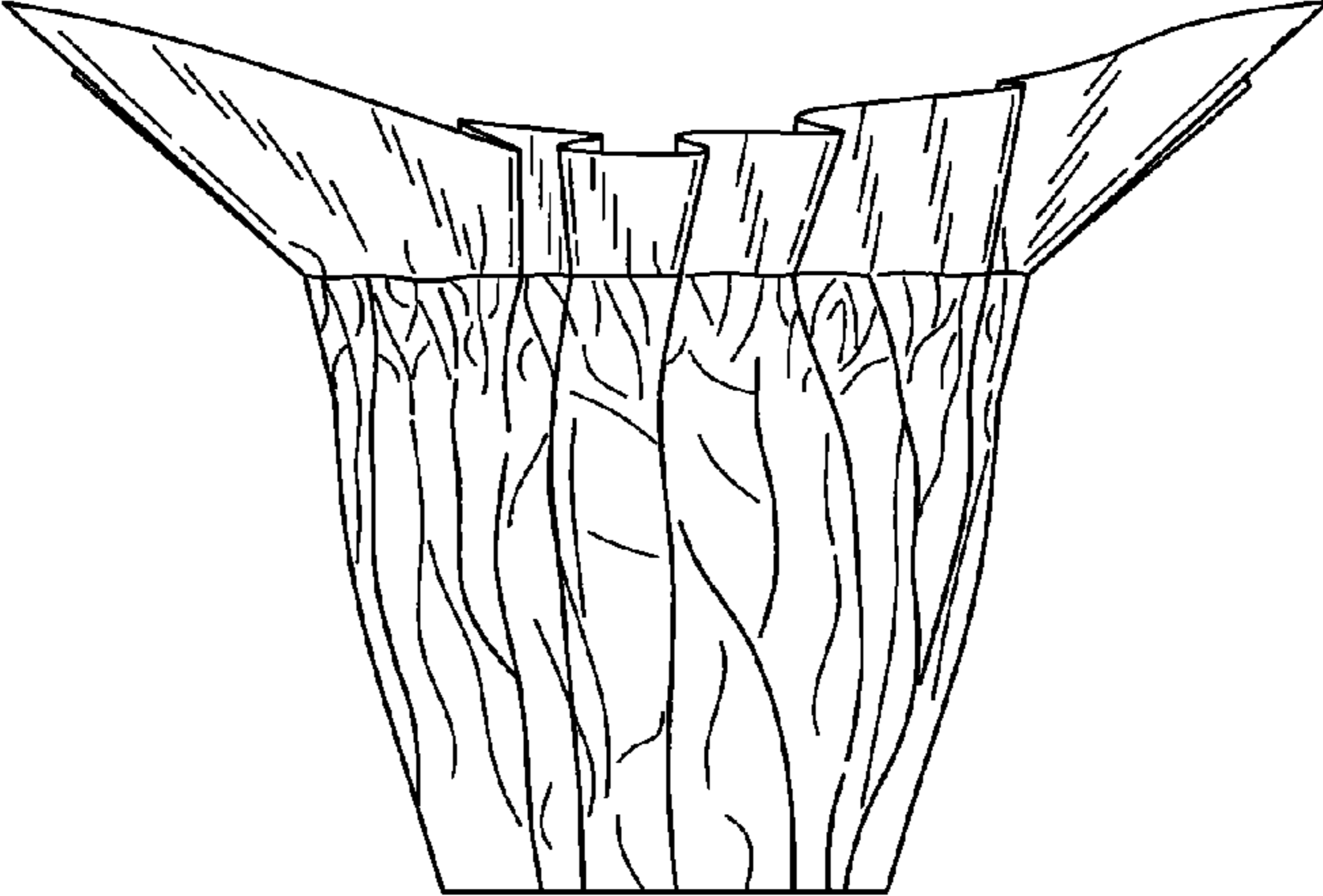

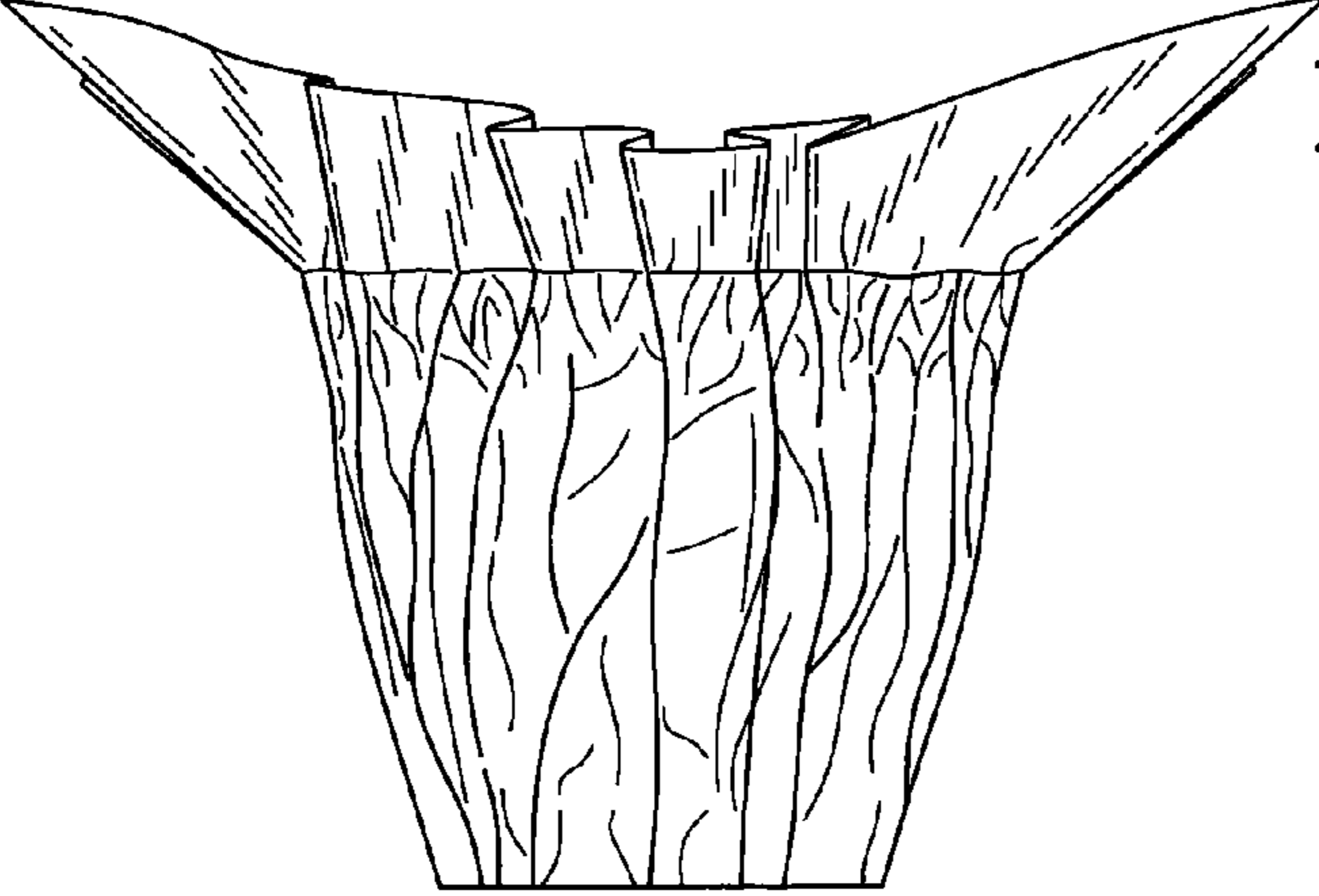

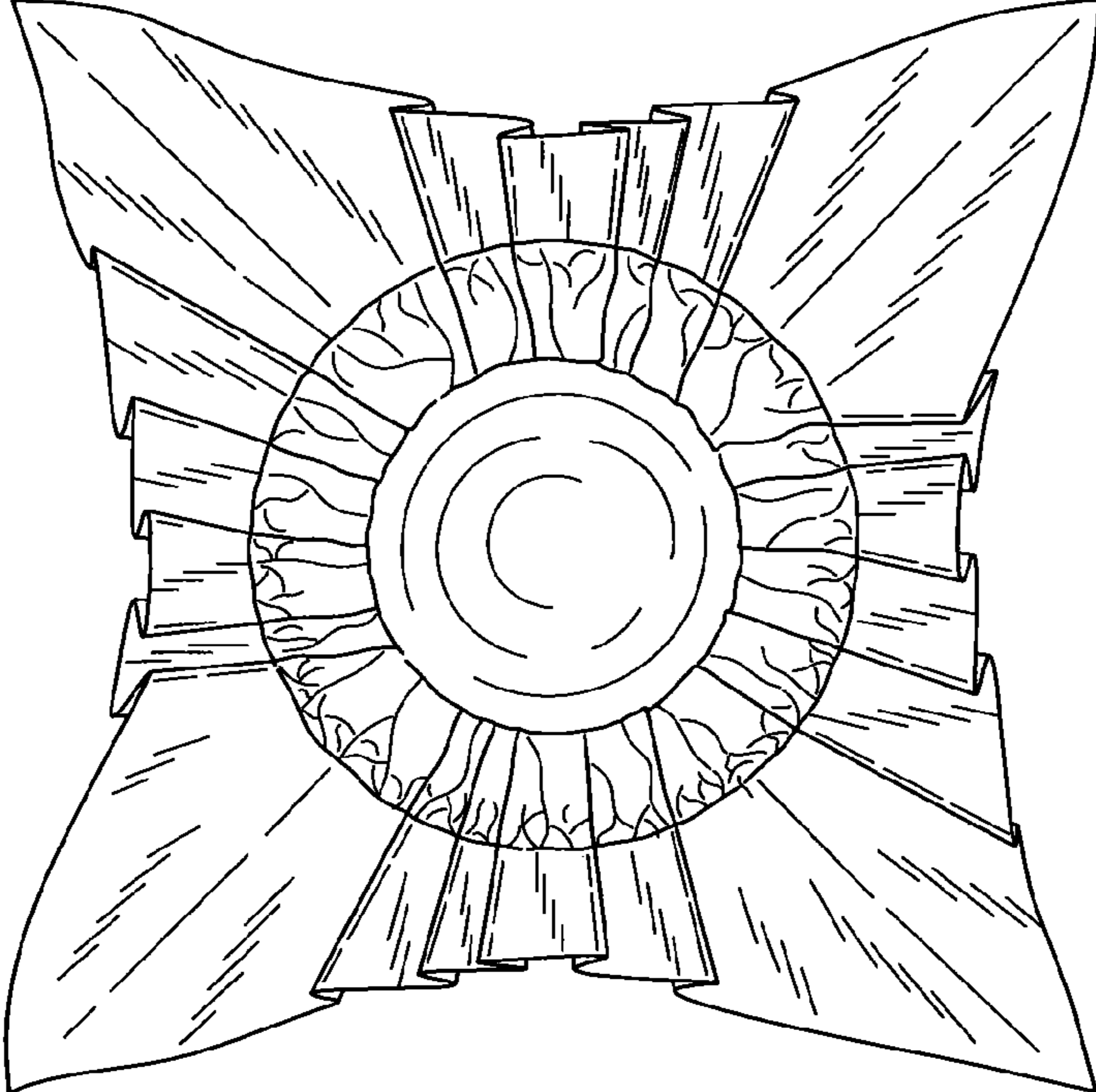

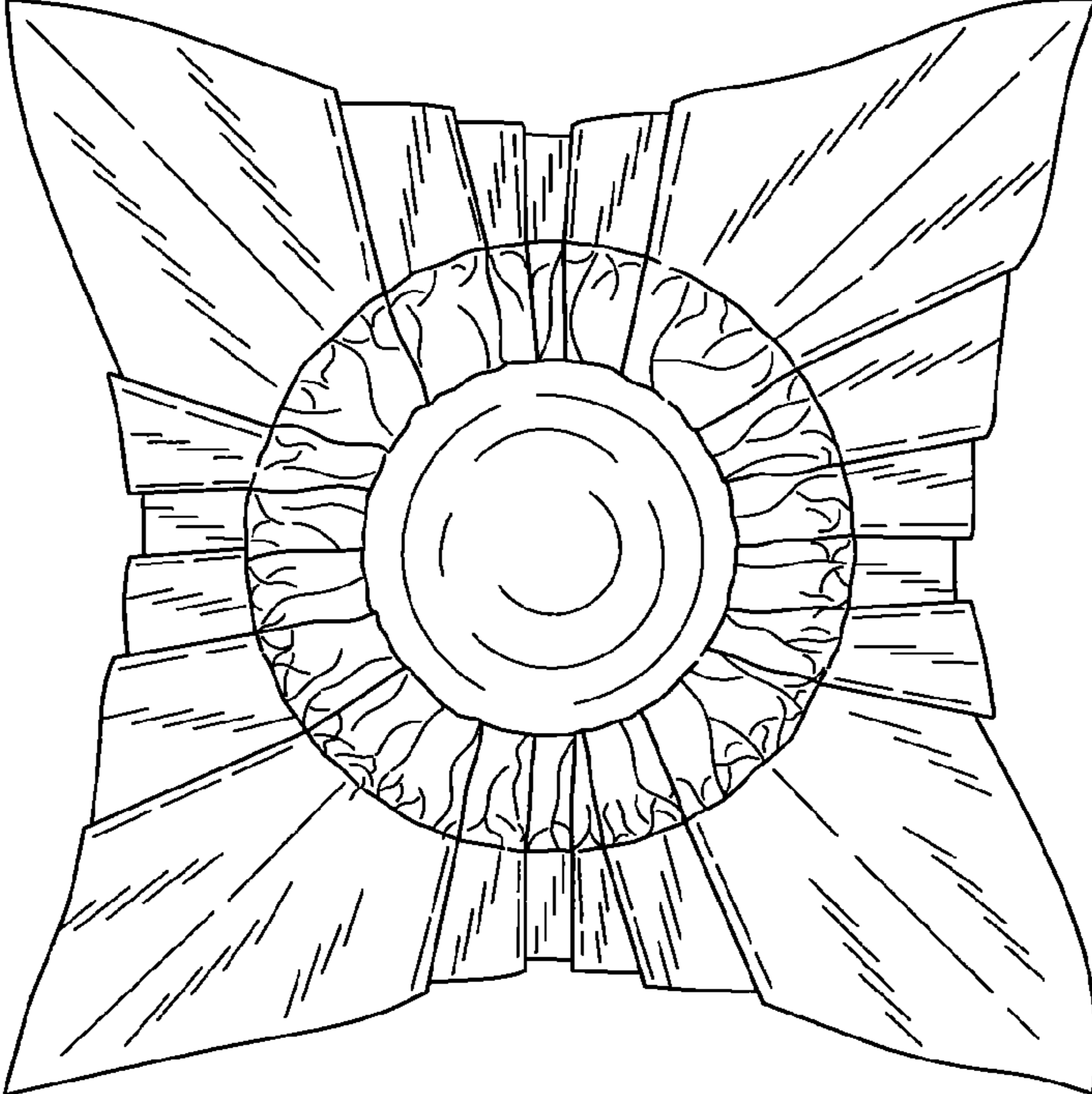
