The ornamental design for a mobile communication terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portable multimedia terminal;

FIG. 2 is a front view of the portable multimedia terminal of FIG. 1;

FIG. 3 is a rear view of the portable multimedia terminal of FIG. 1;

FIG. 4 is a left-side view of the portable multimedia terminal of FIG. 1;

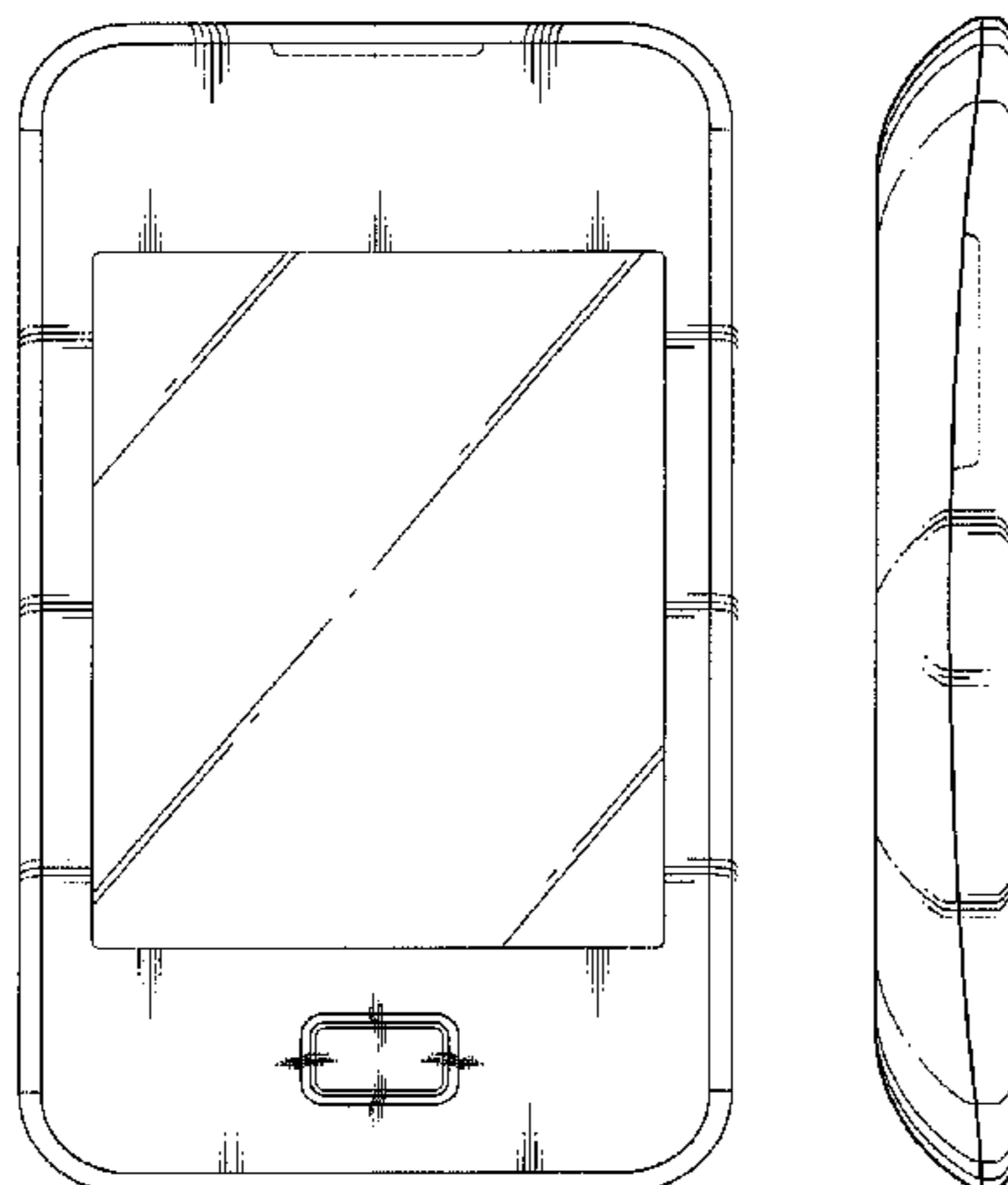
FIG. 5 is a right-side view of the portable multimedia terminal of FIG. 1;

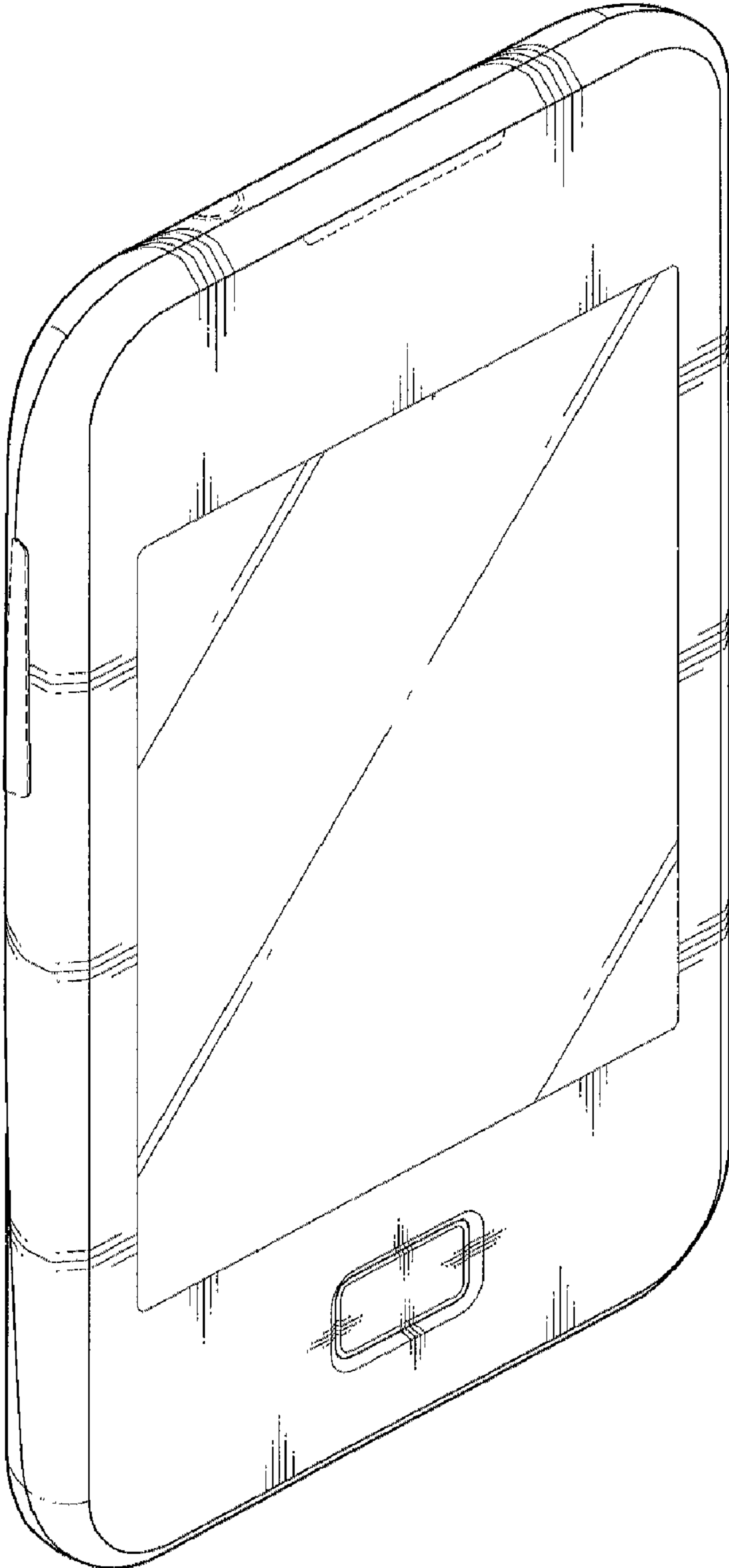

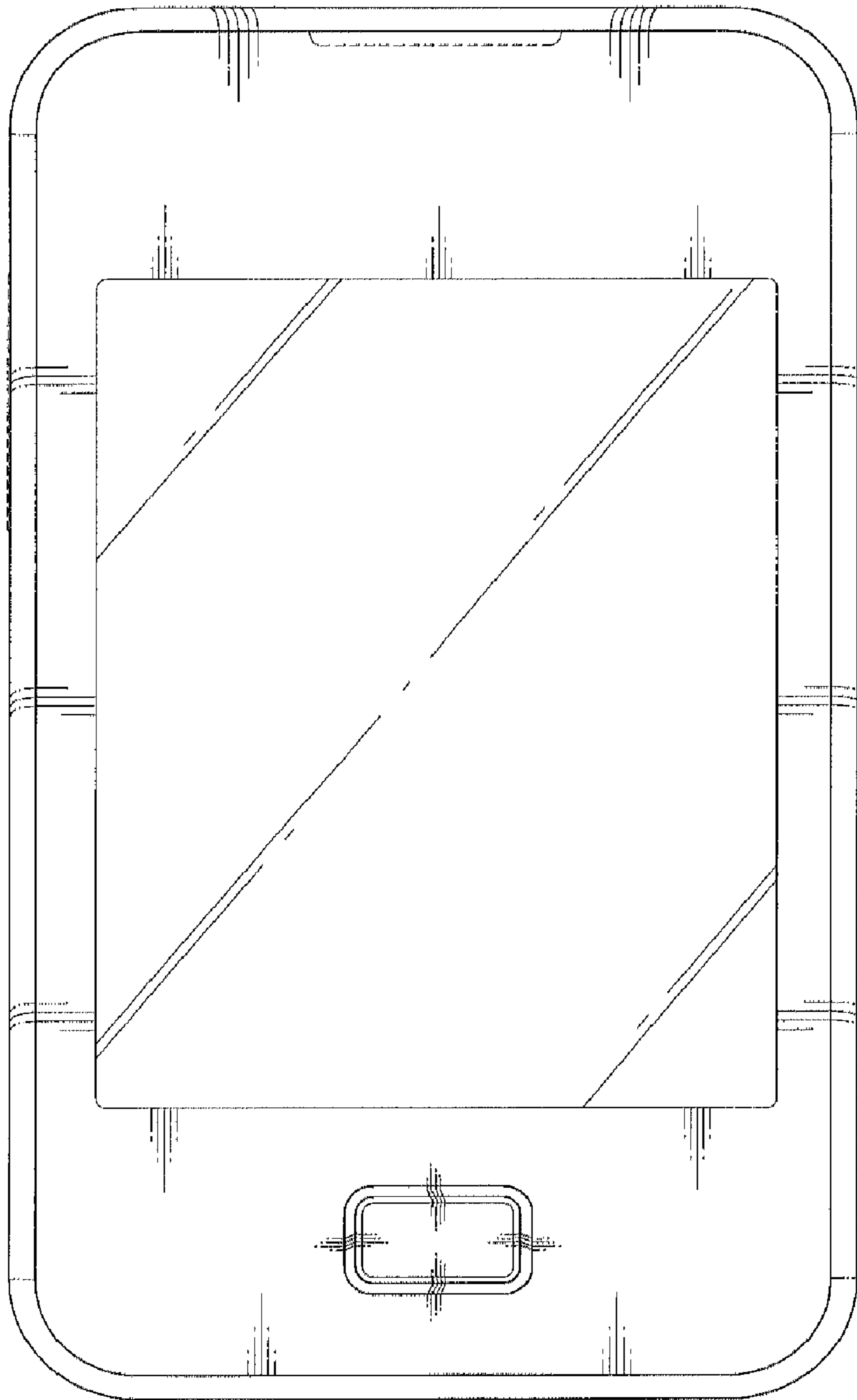

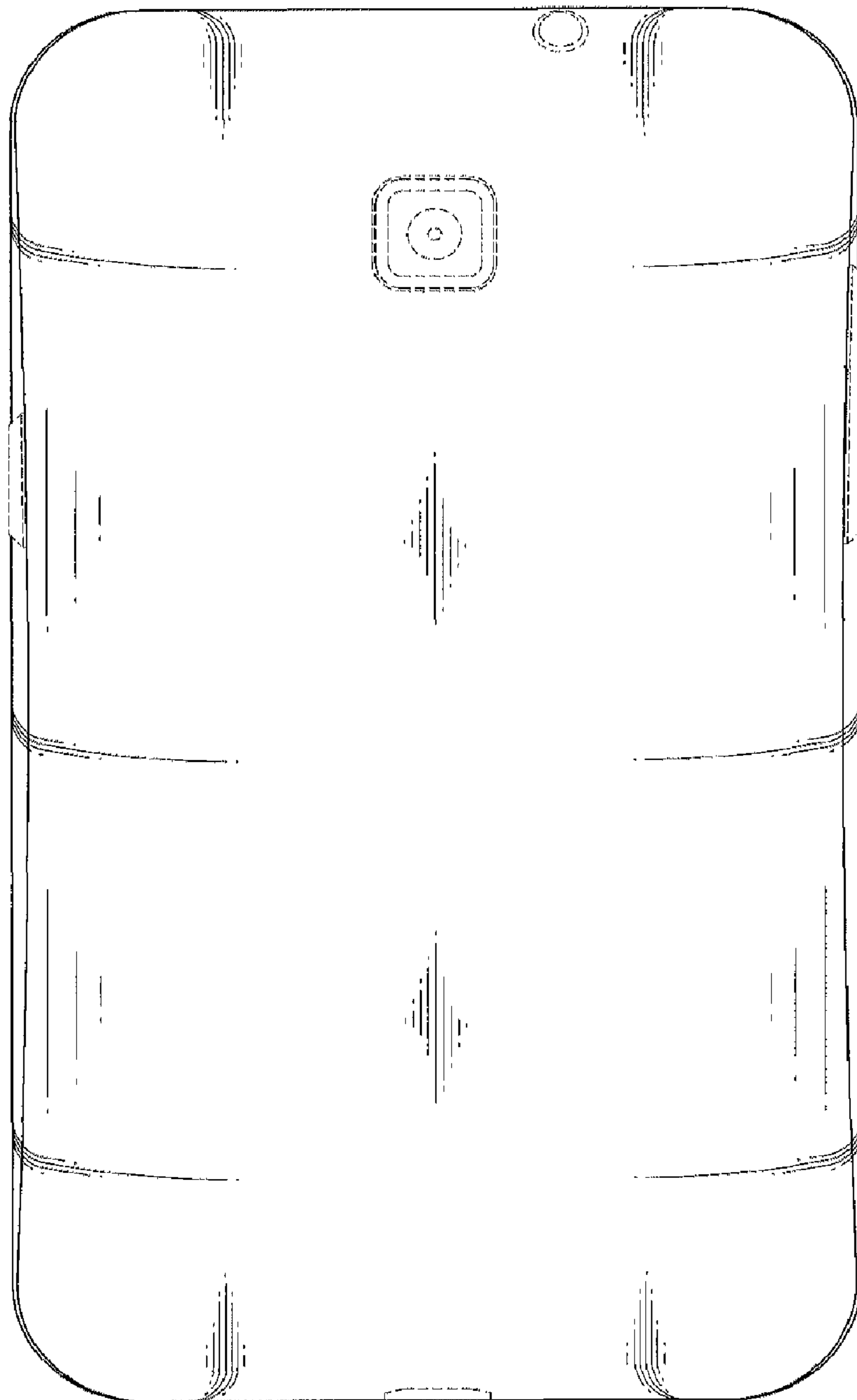

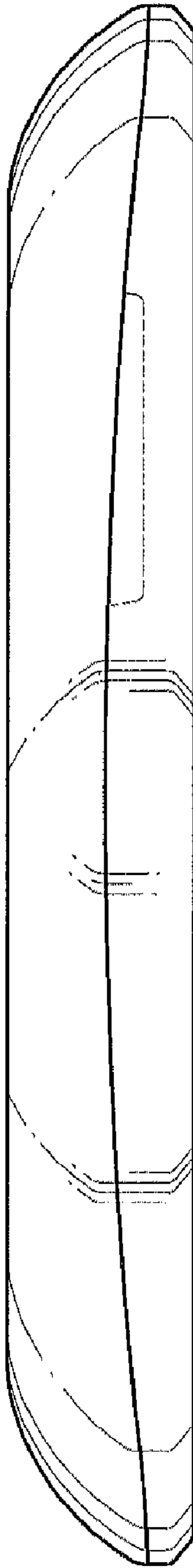

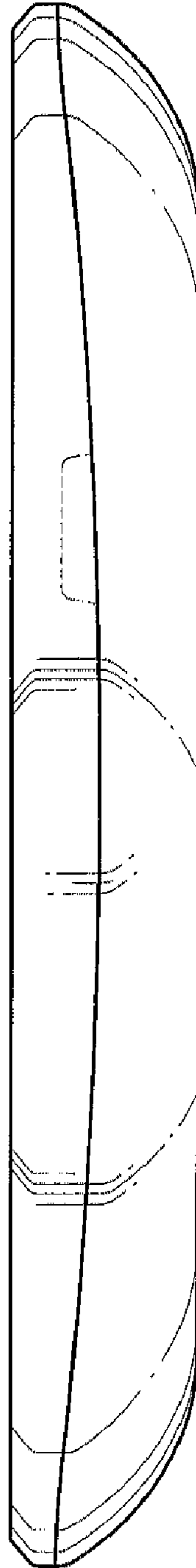
