FIG. 4 is a right view of the support platform of FIG. 1.

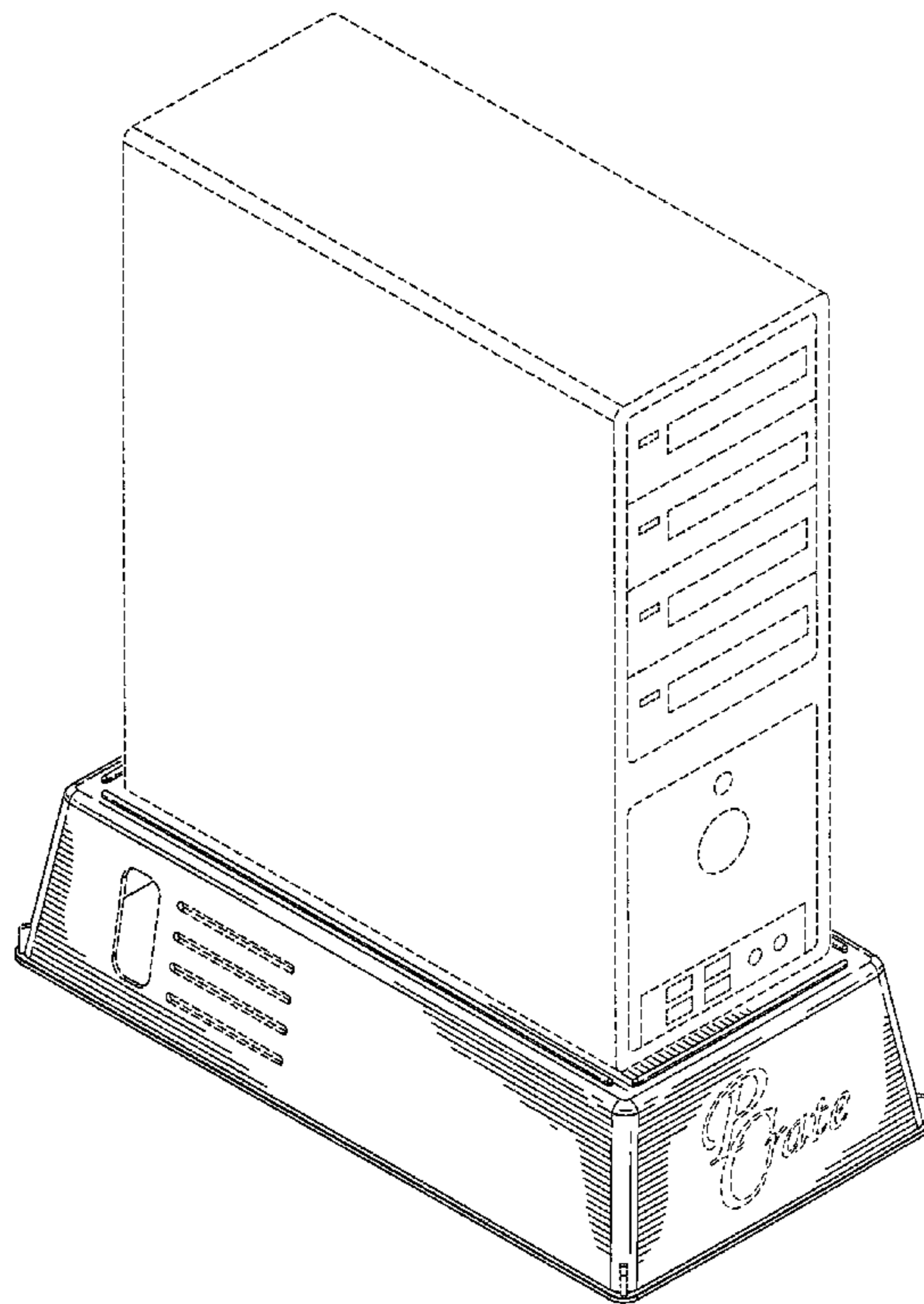
FIG. 5 is a left view of the support platform of FIG. 1.

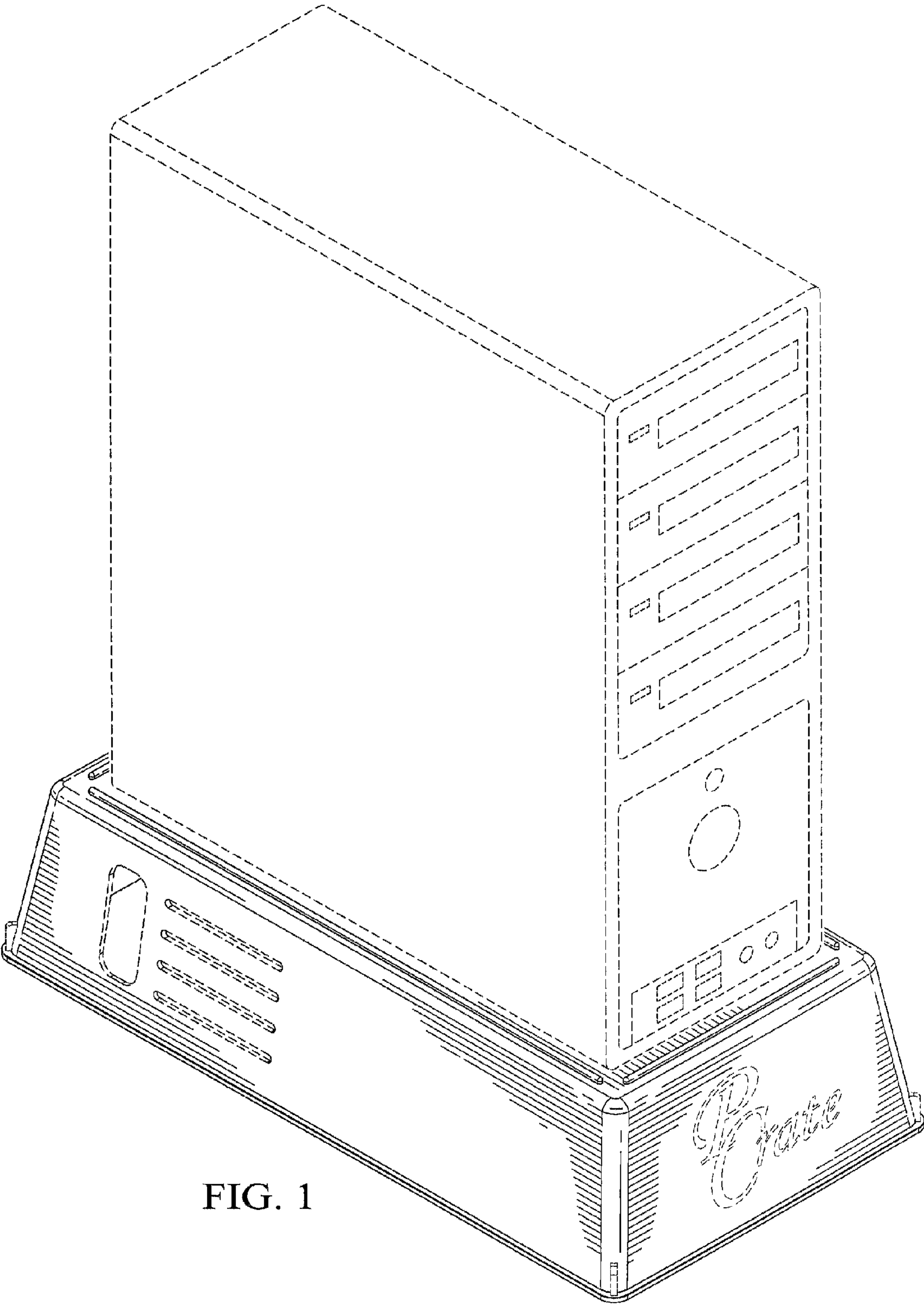

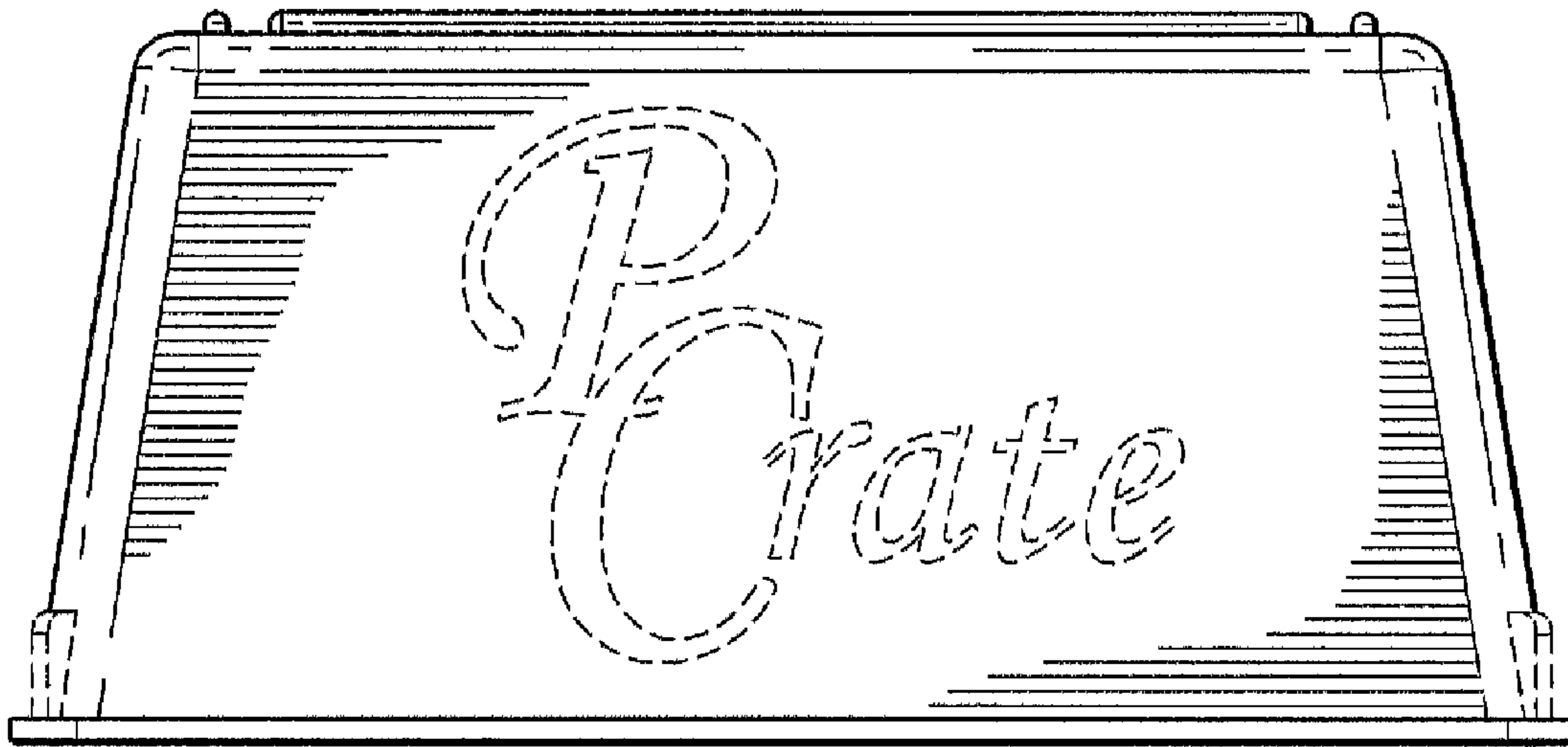

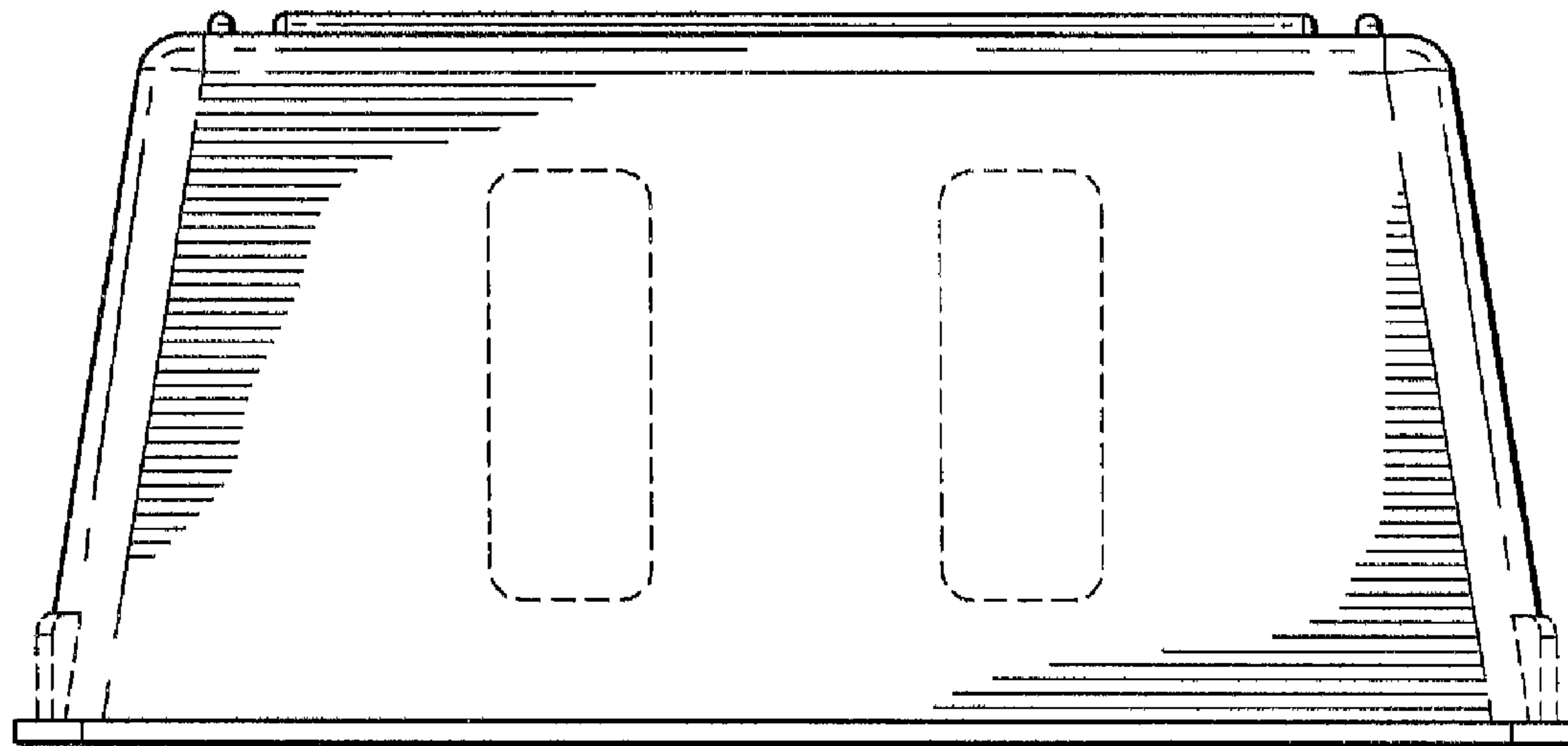

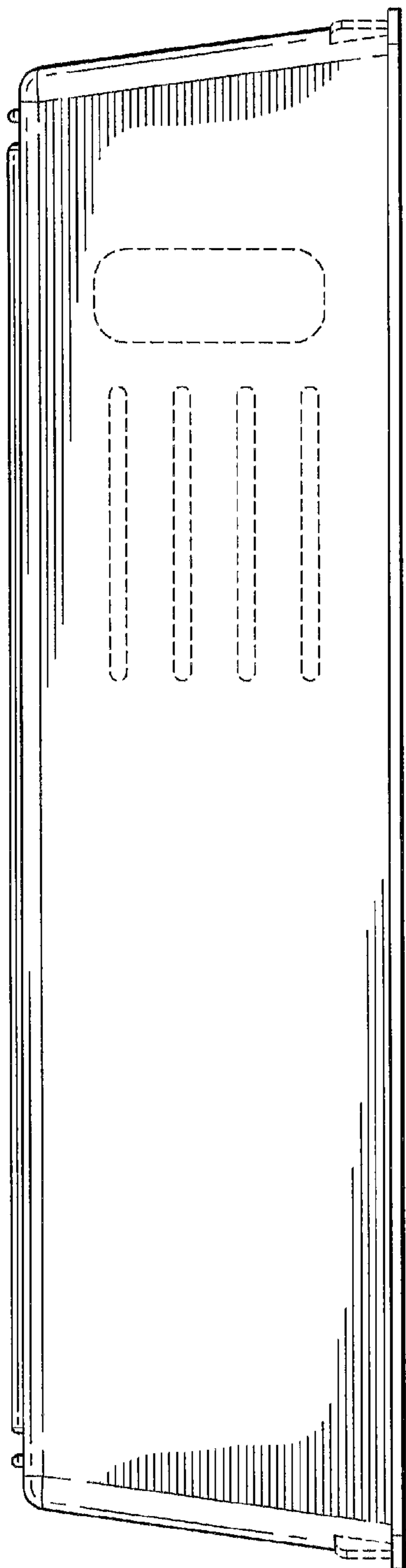

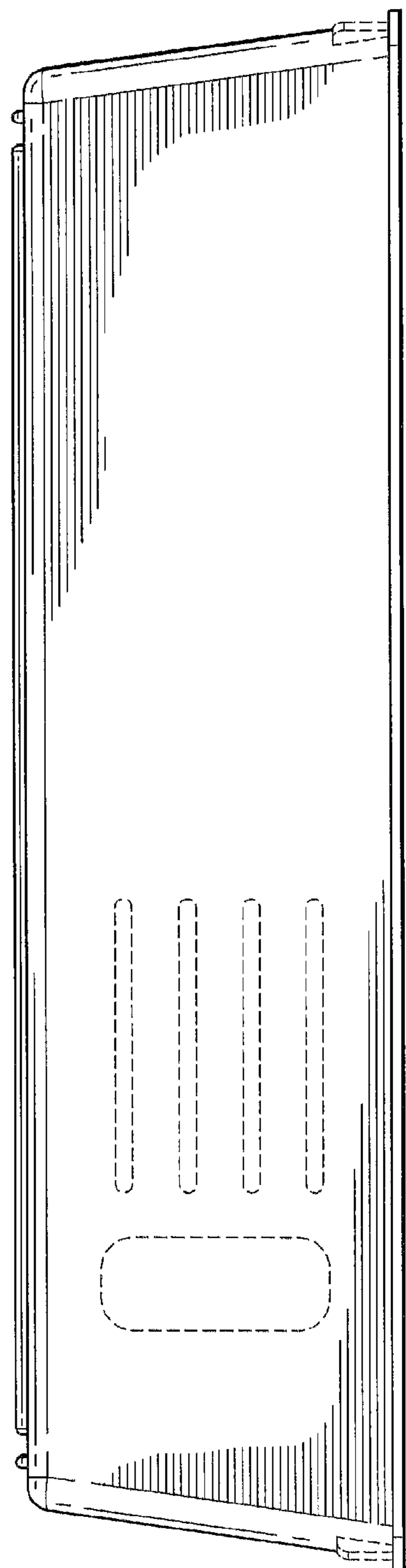

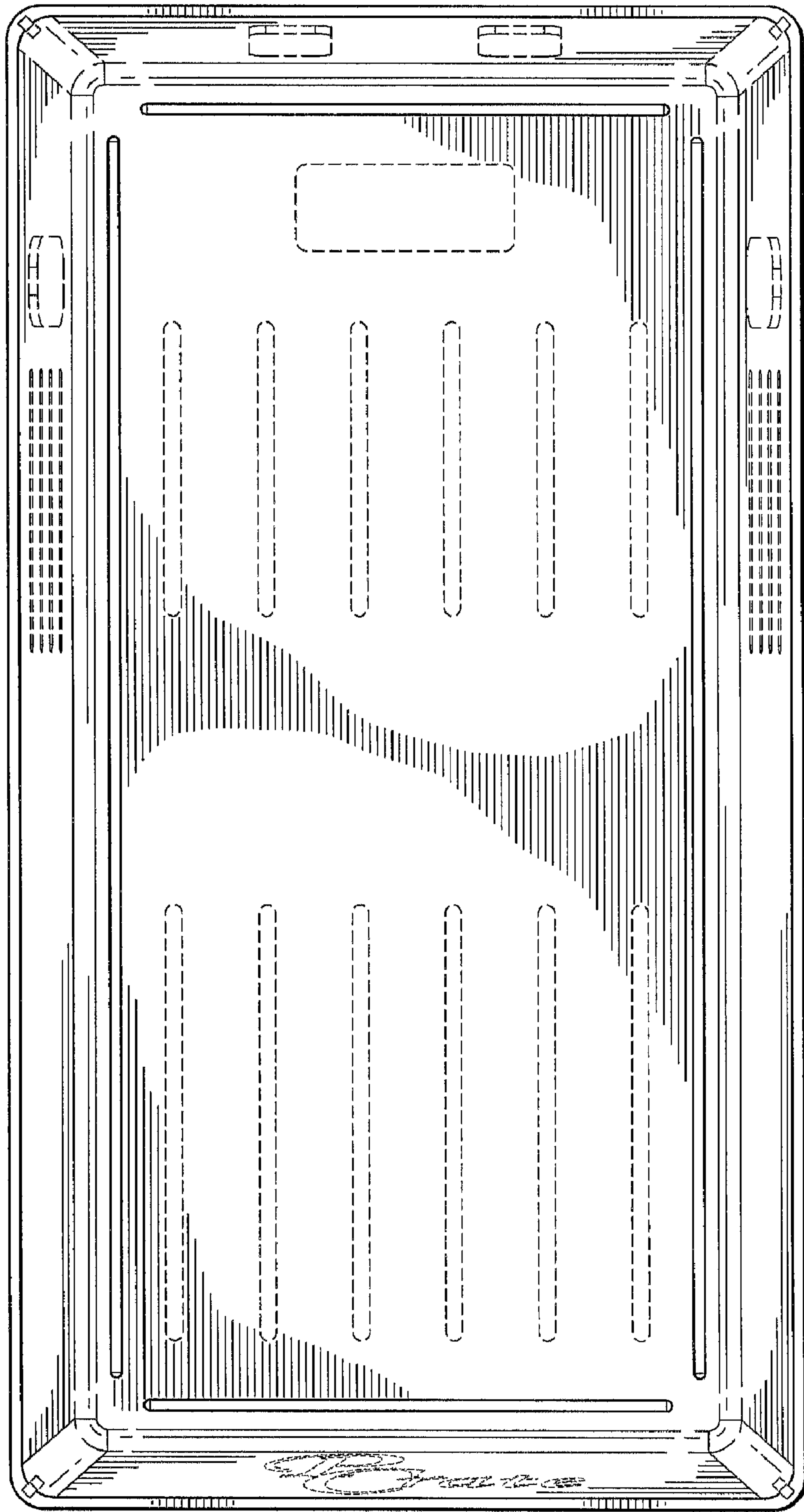

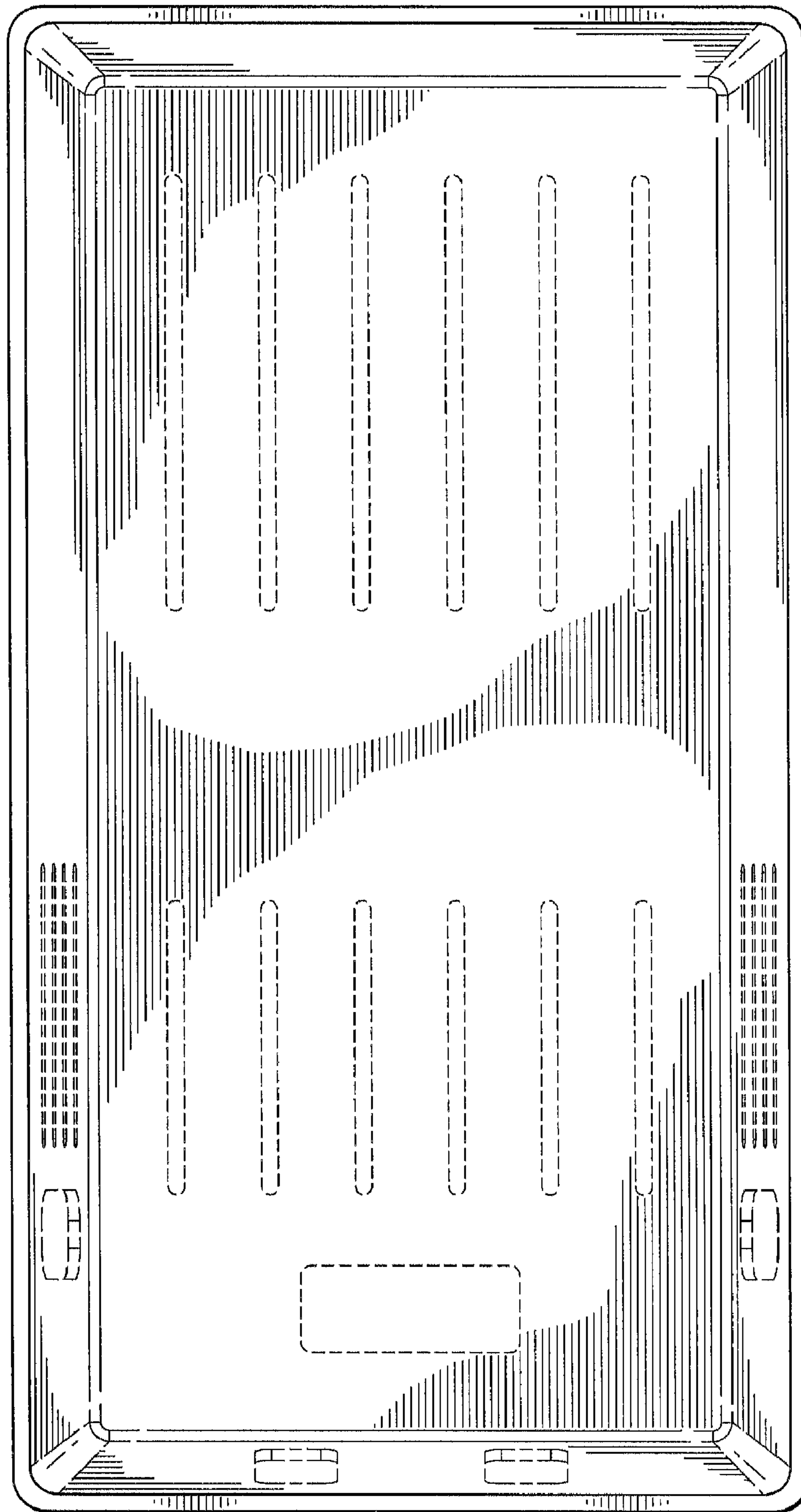
