FIG. 4 is a top plan view of the clip of FIG. 1;

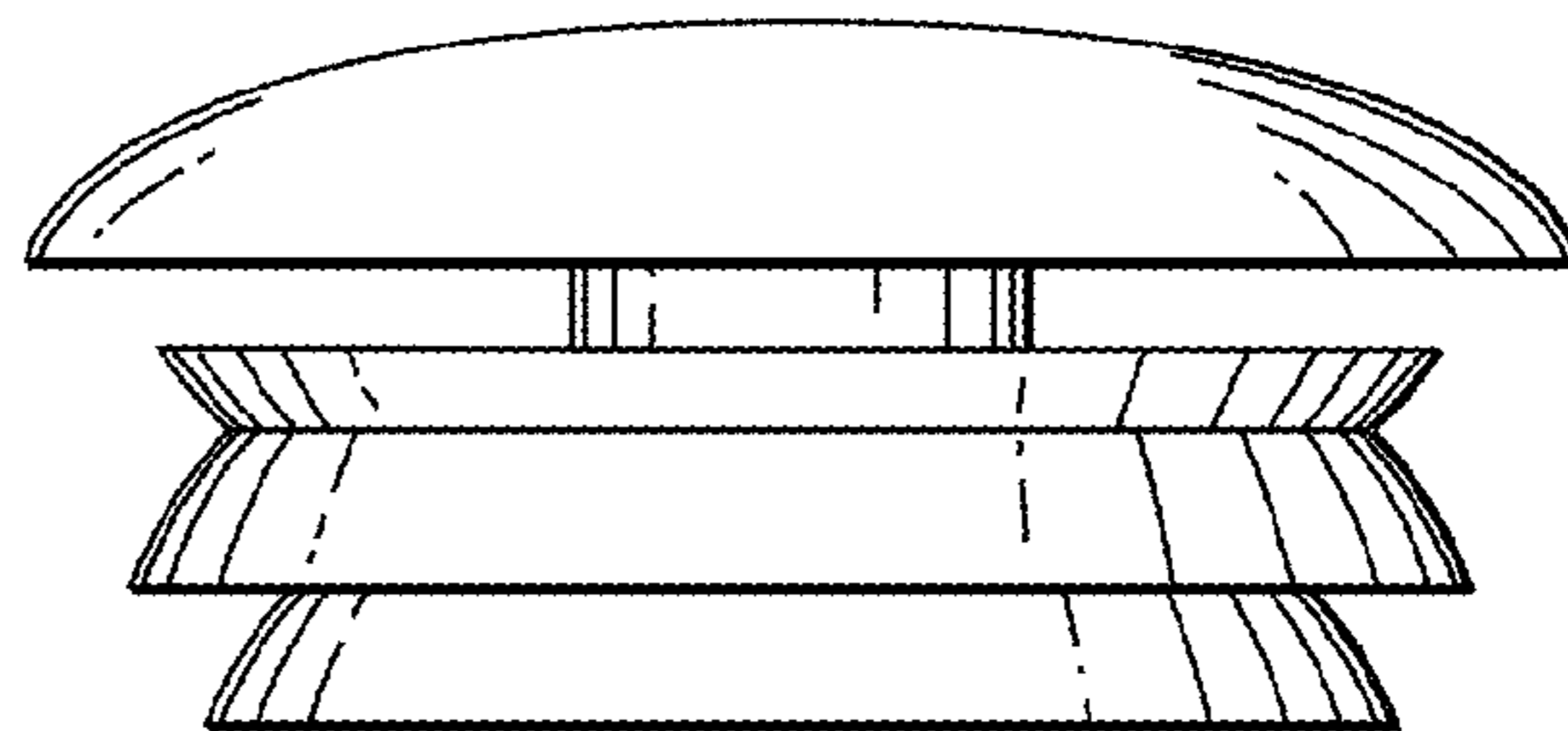
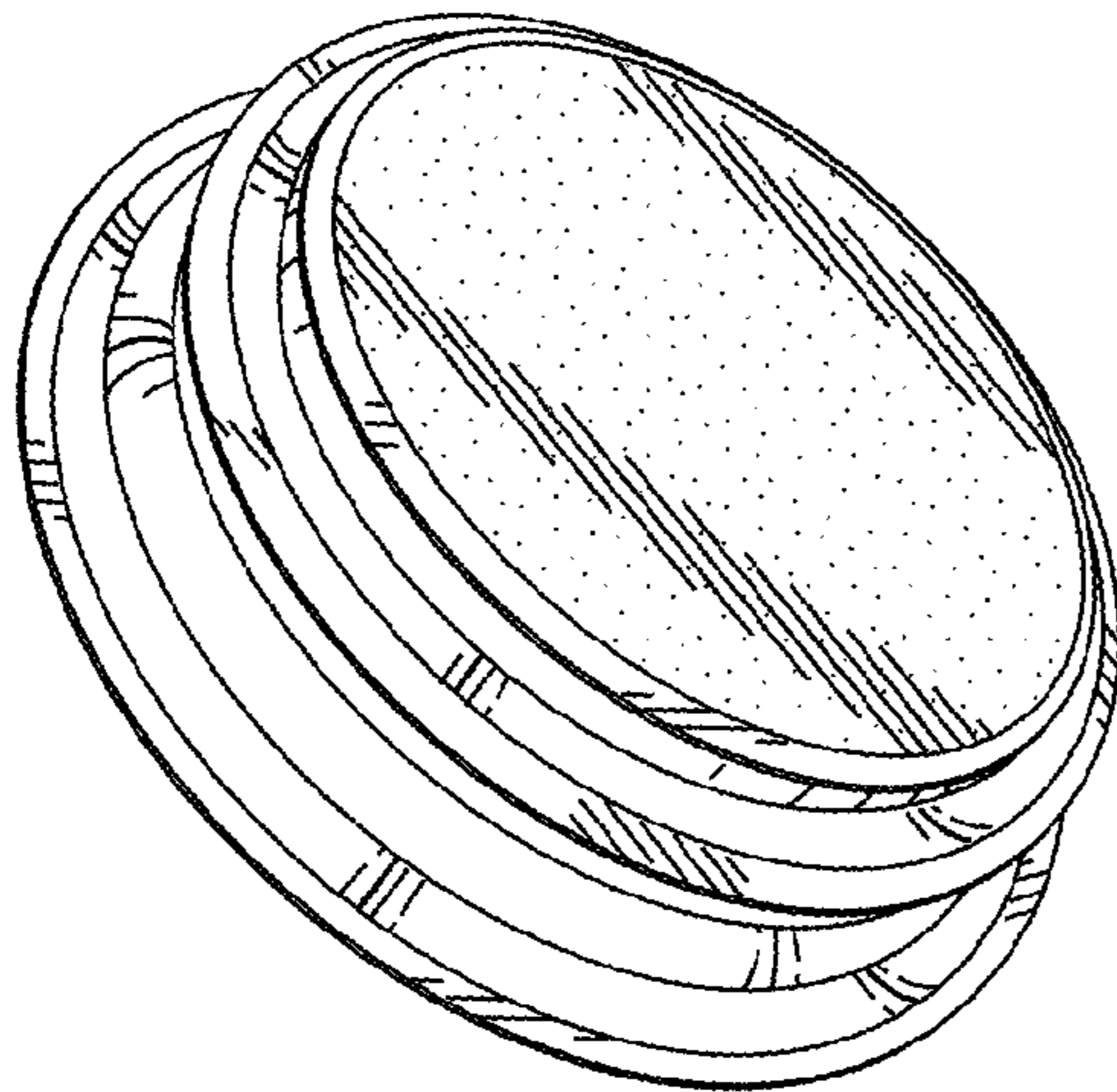
FIG. 5 is a right-side elevation view of the clip of FIG. 1;

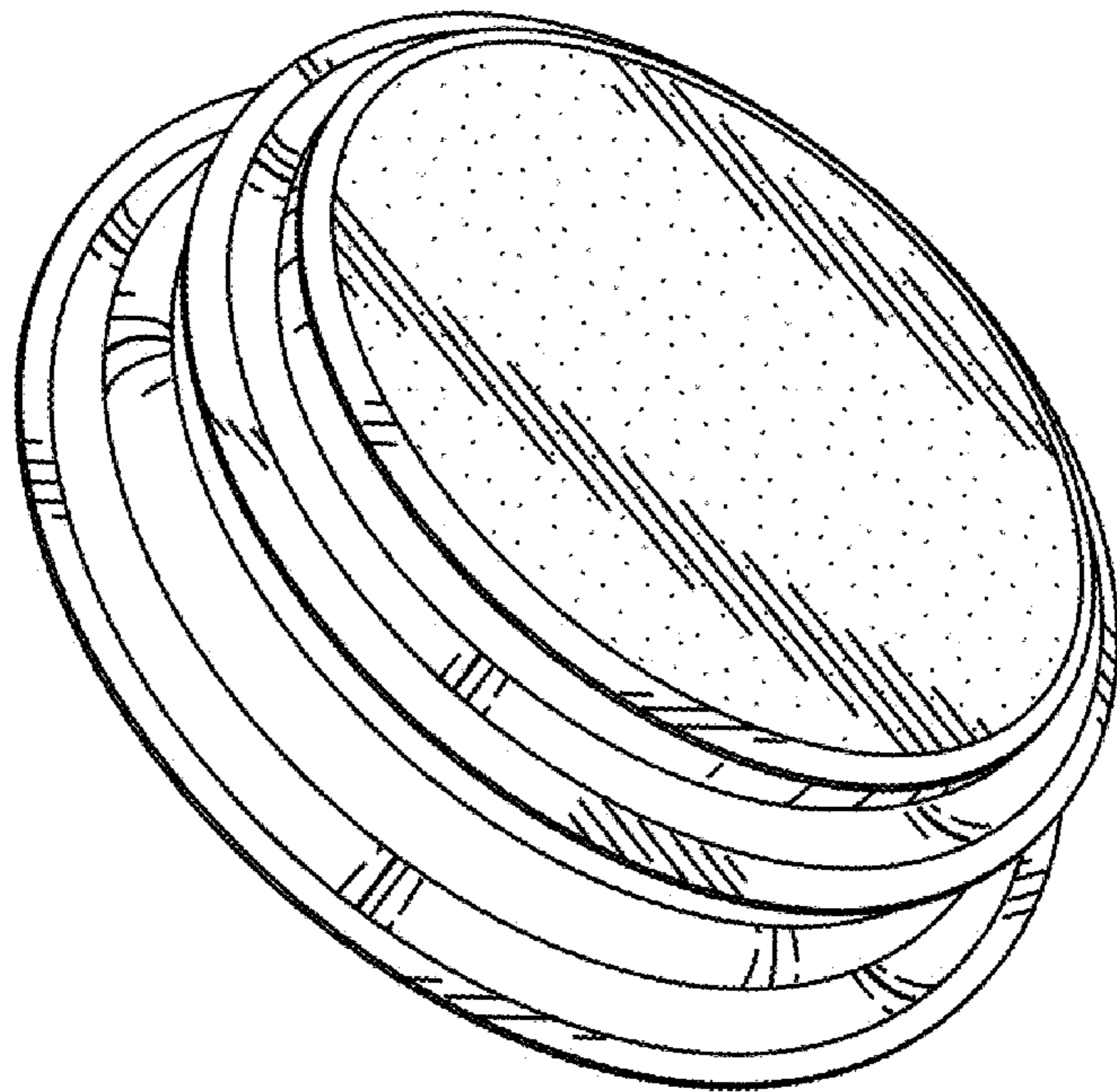

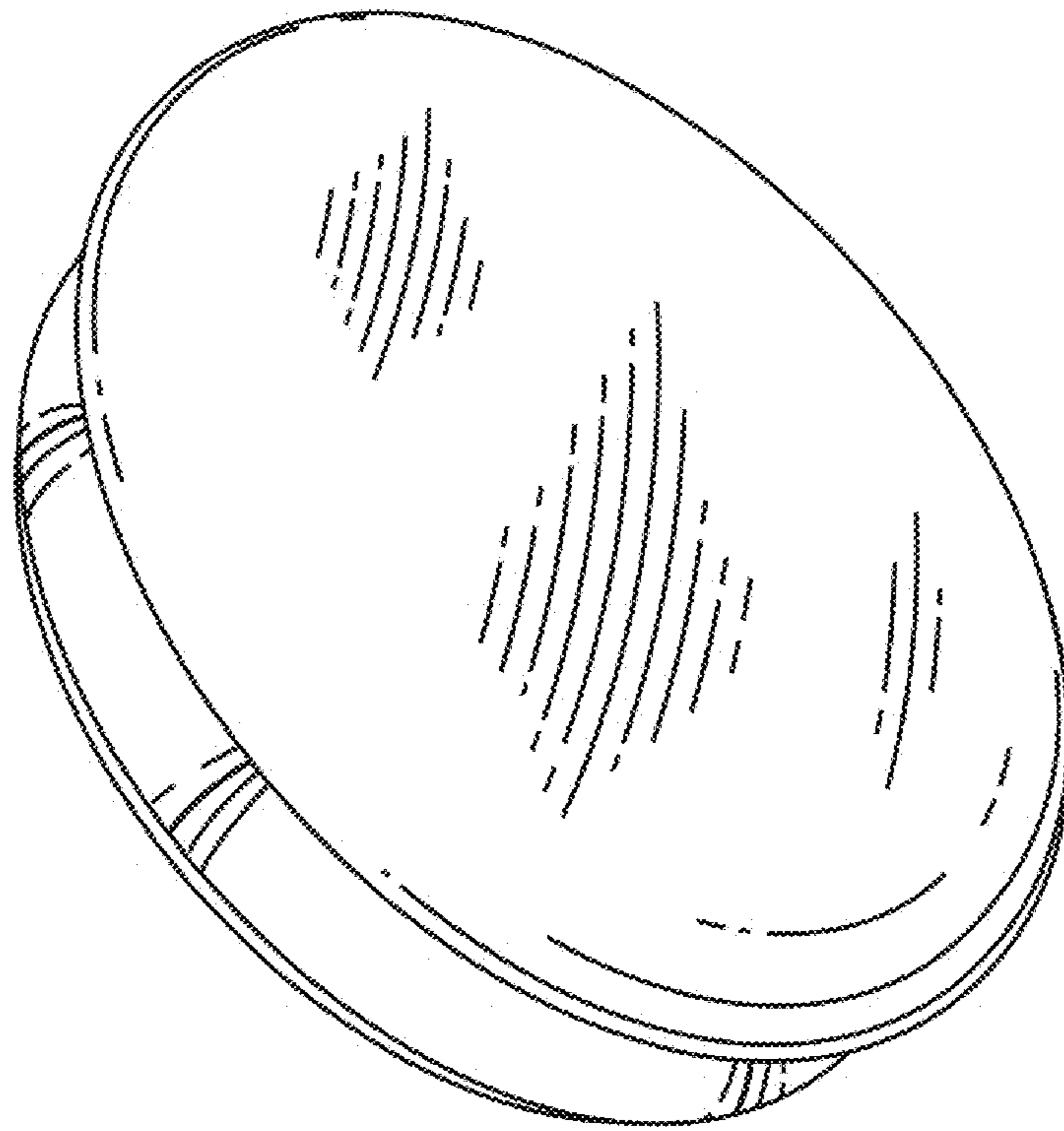

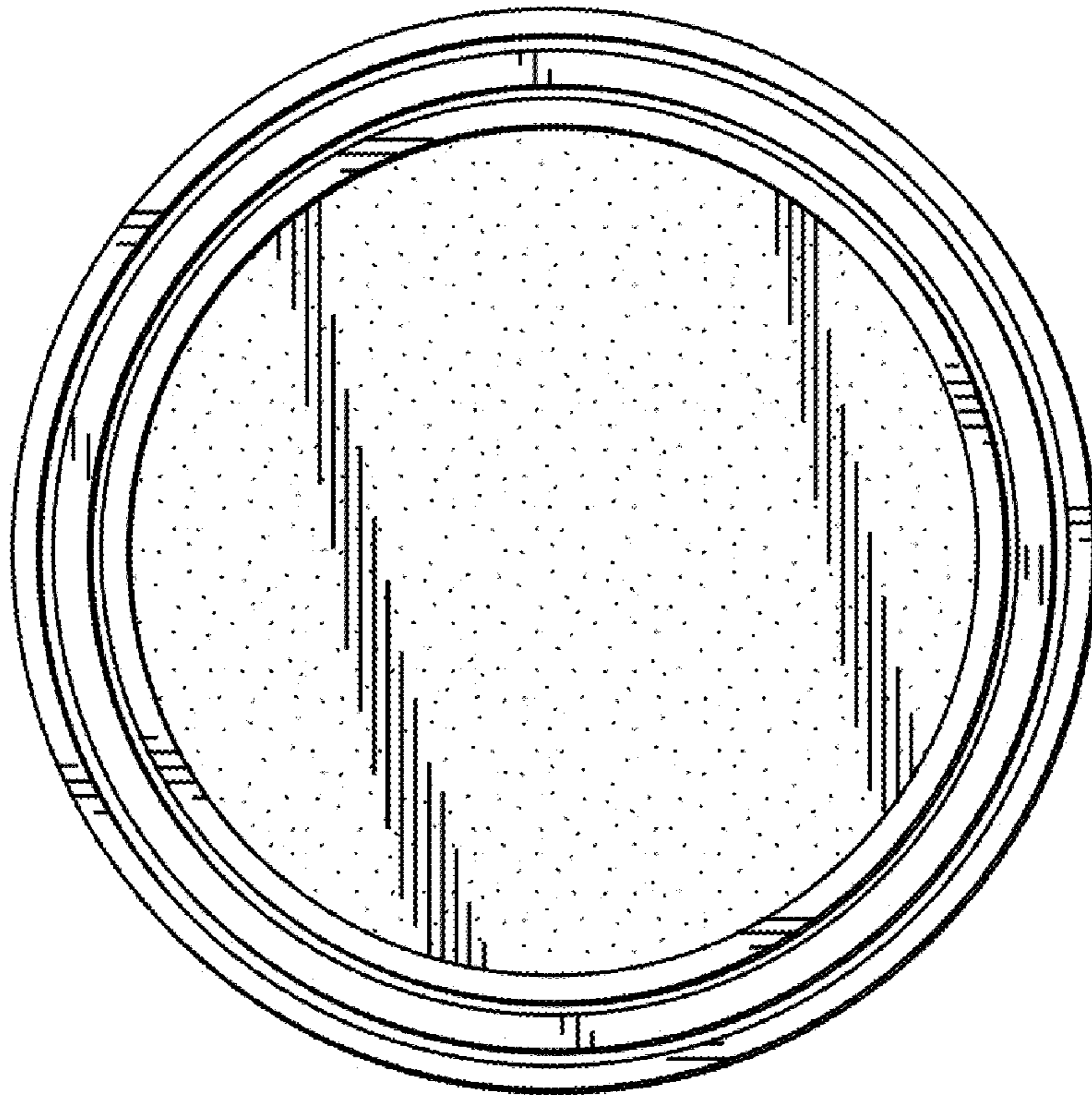

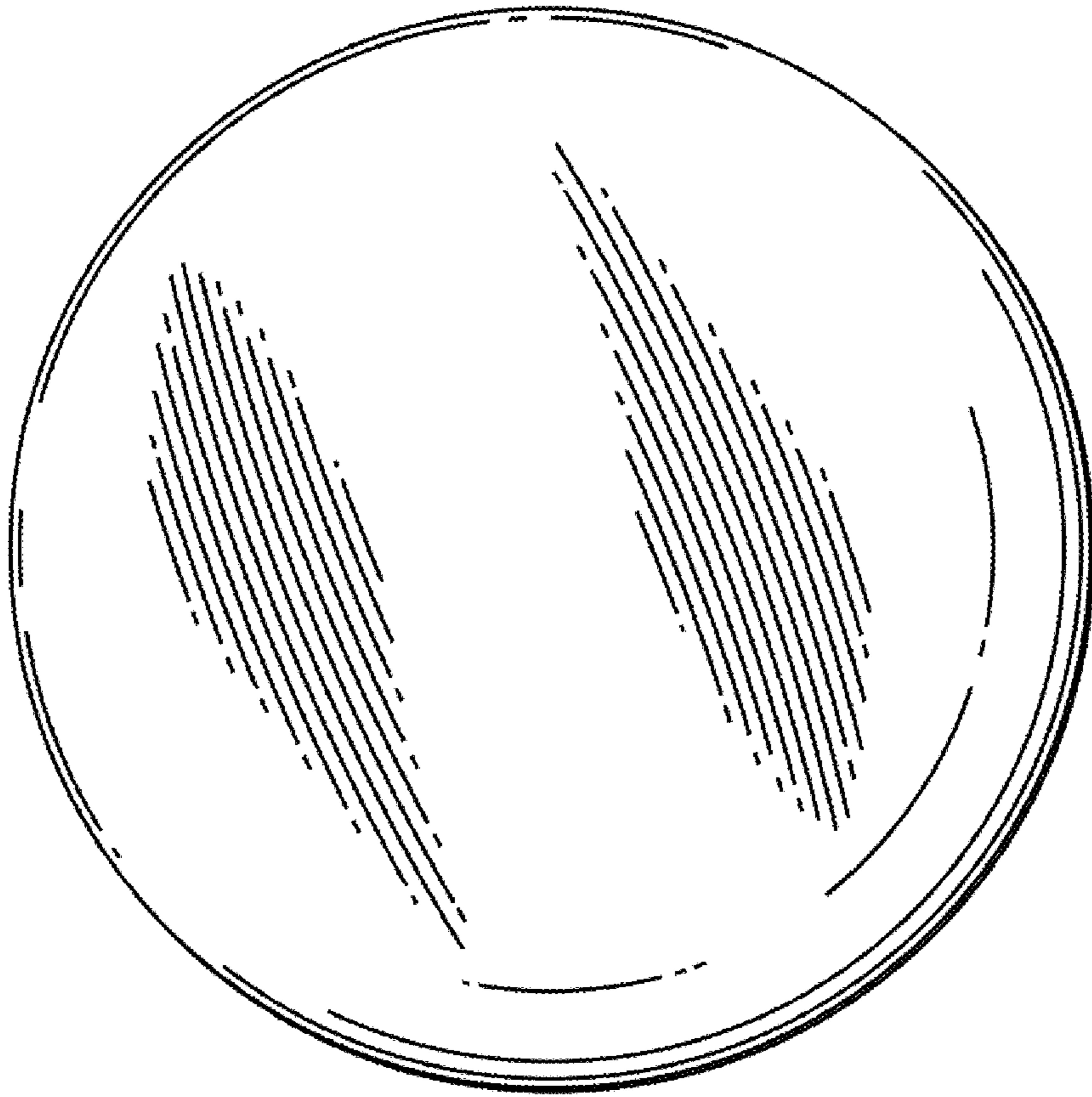

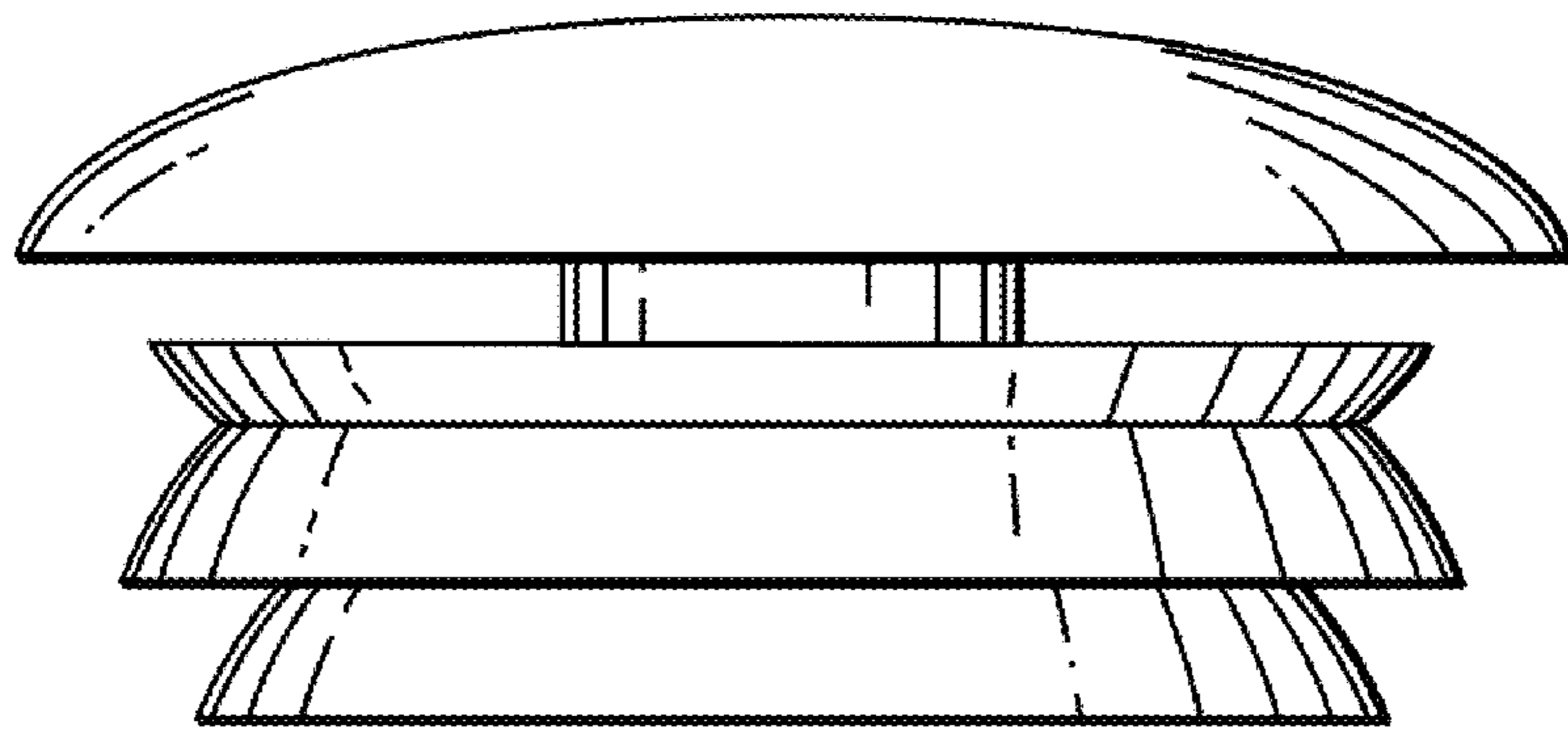

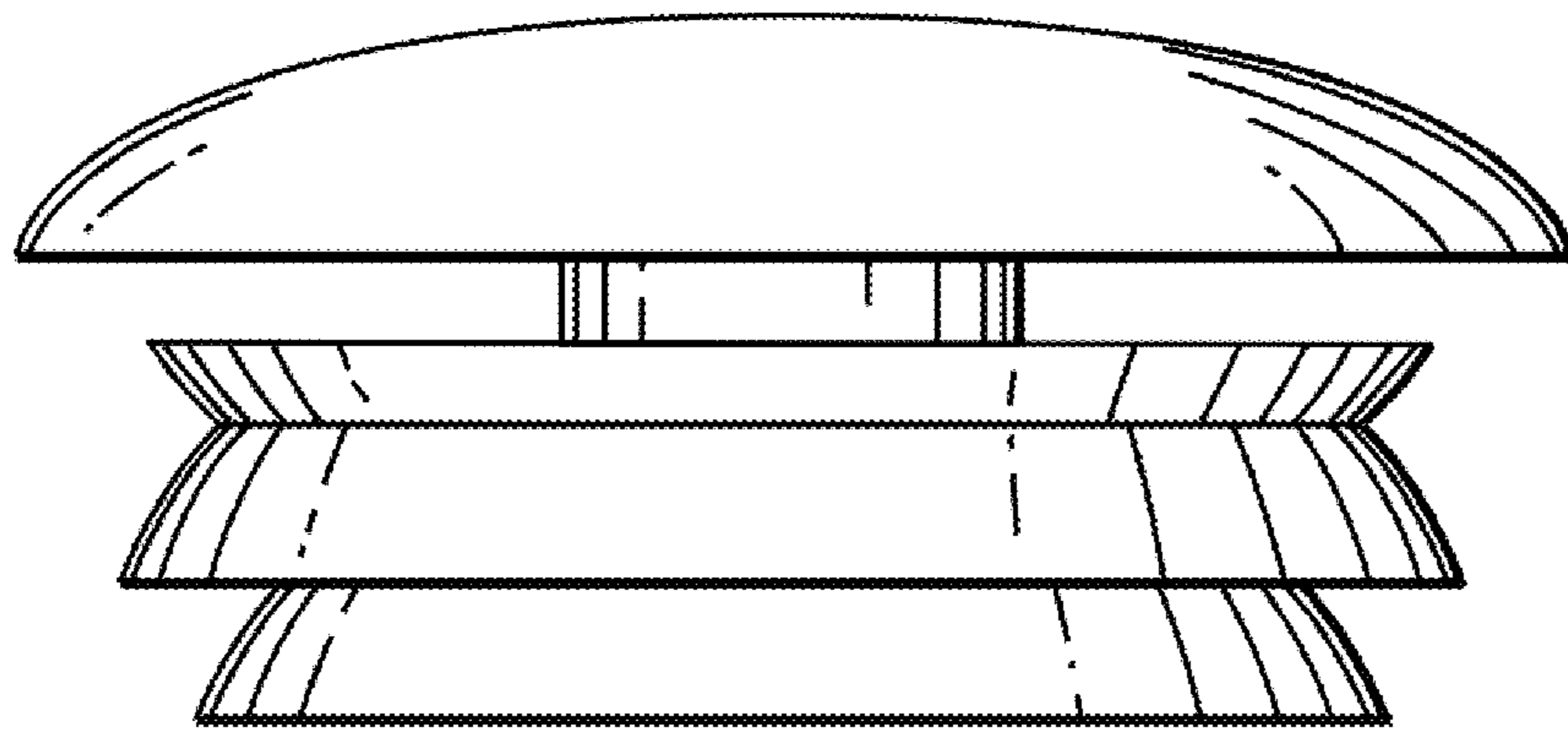

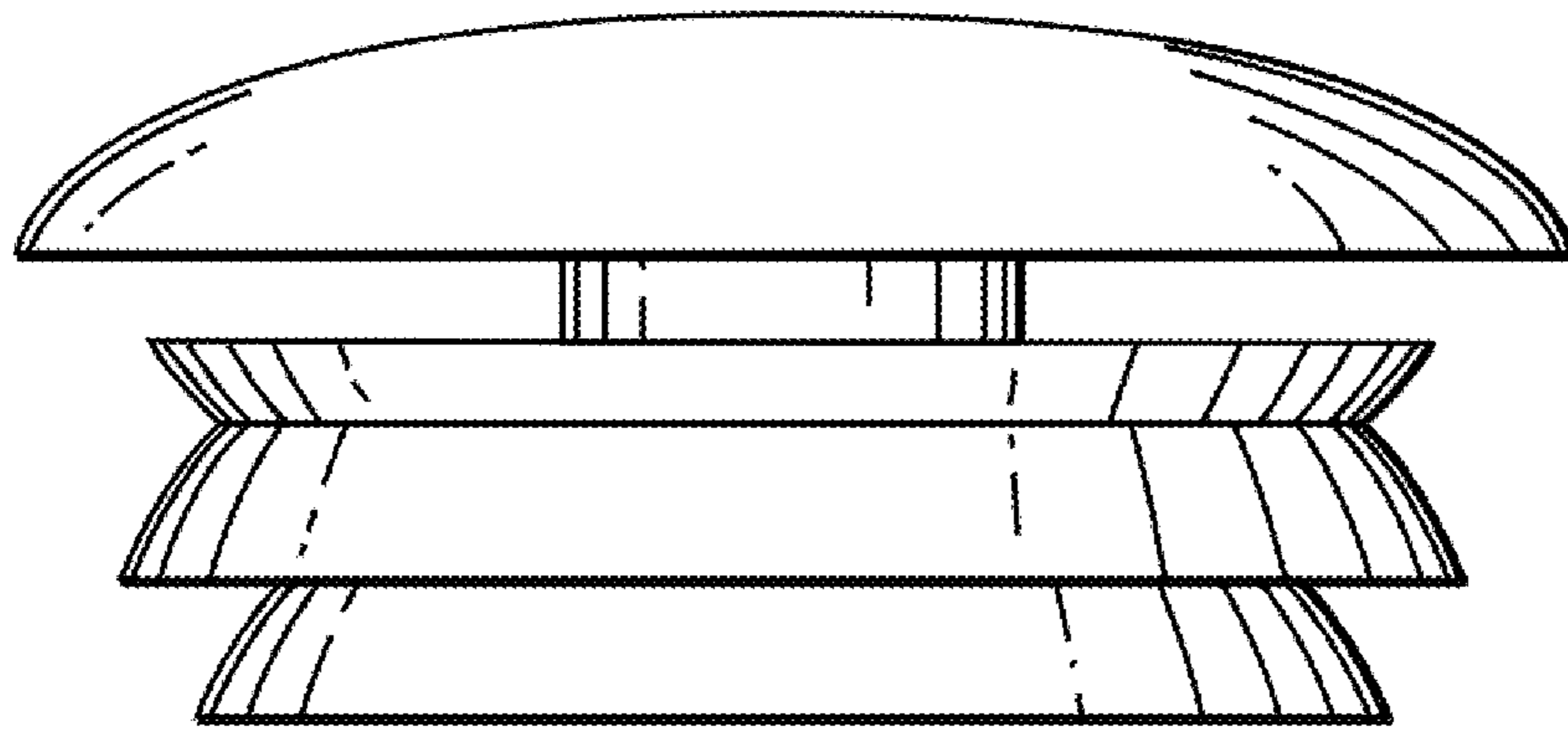

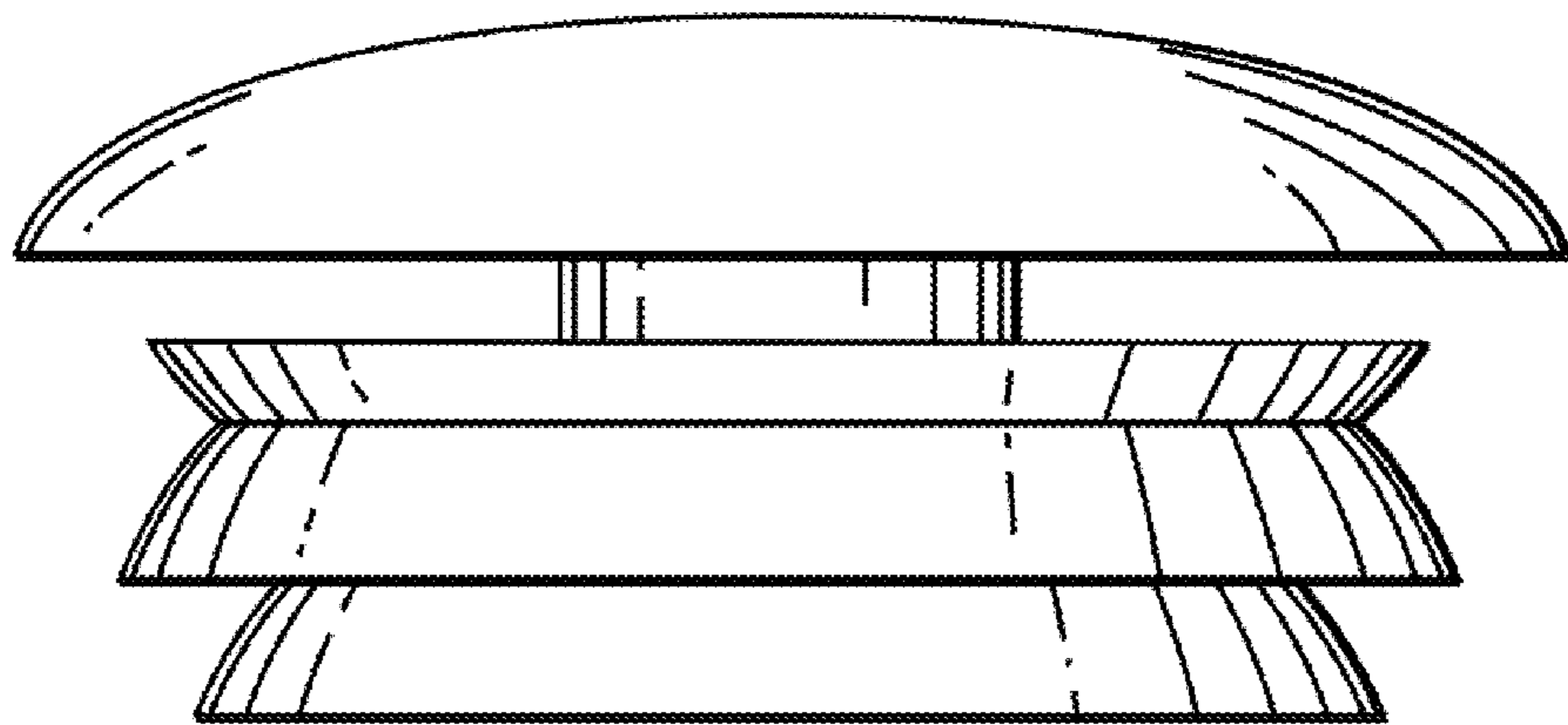
