(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of the claimed design;

FIG. 3 is a left-side elevation view of the claimed design of FIG. 1;

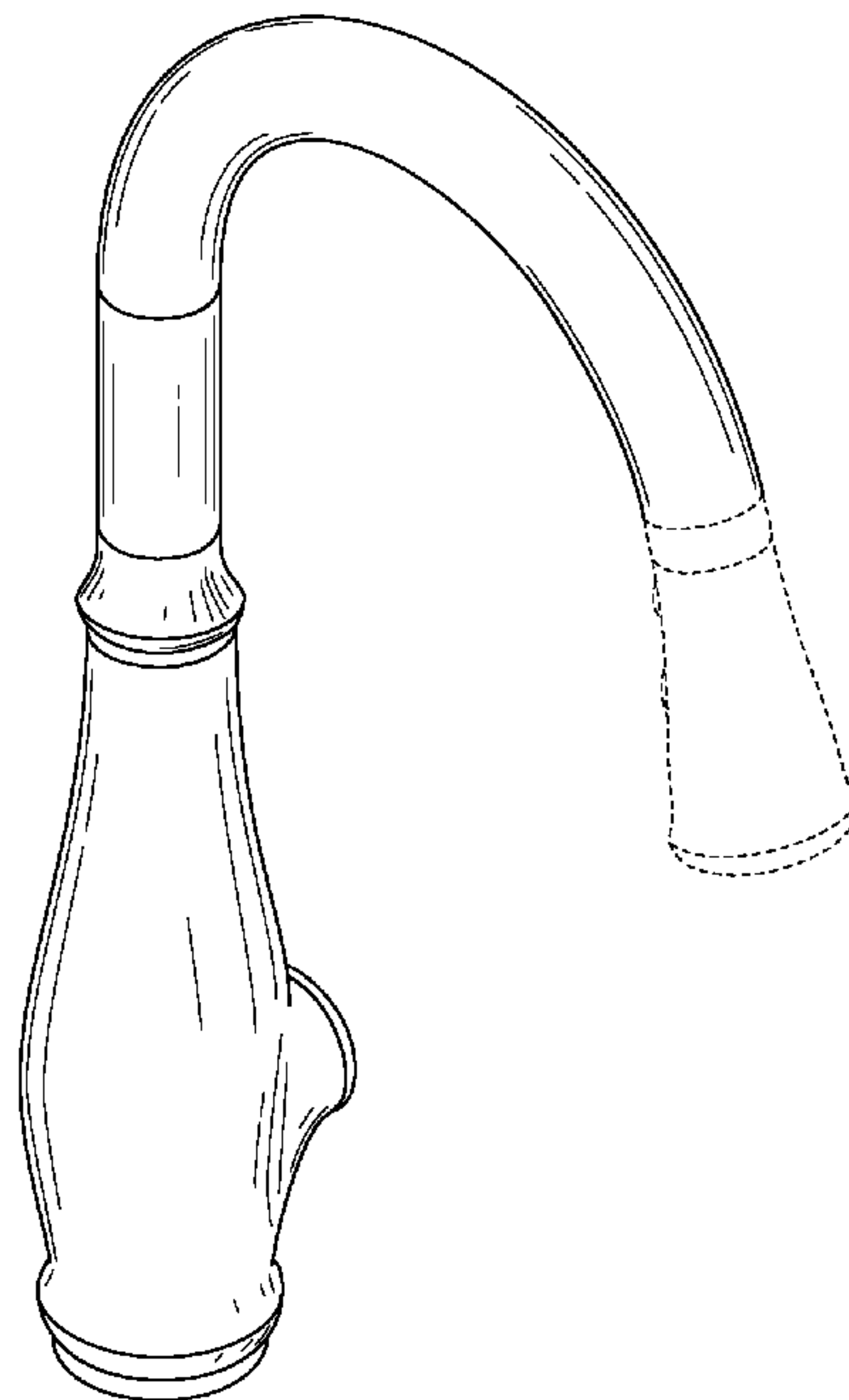
FIG. 4 is a front elevation view of the claimed design of FIG. 1;

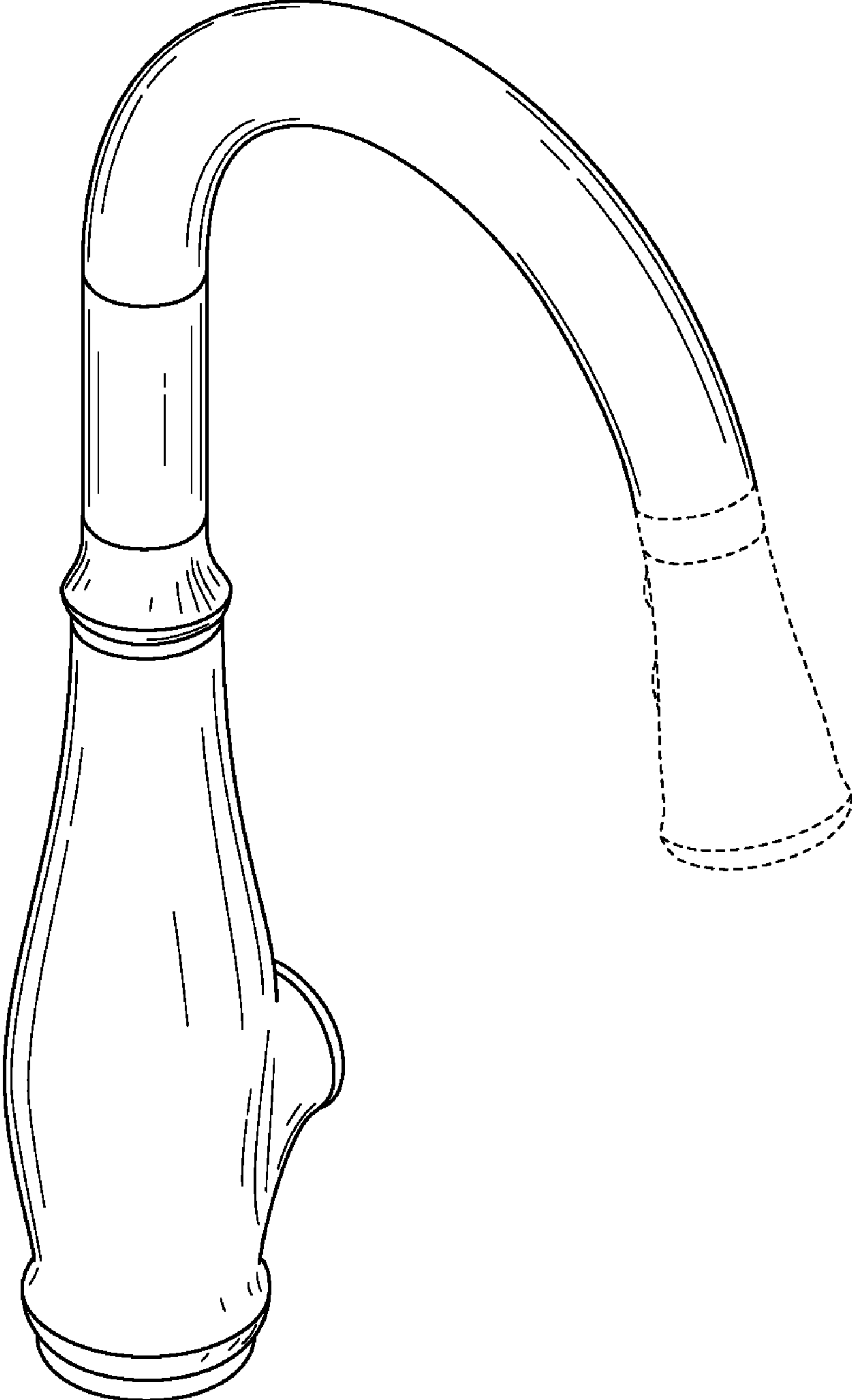

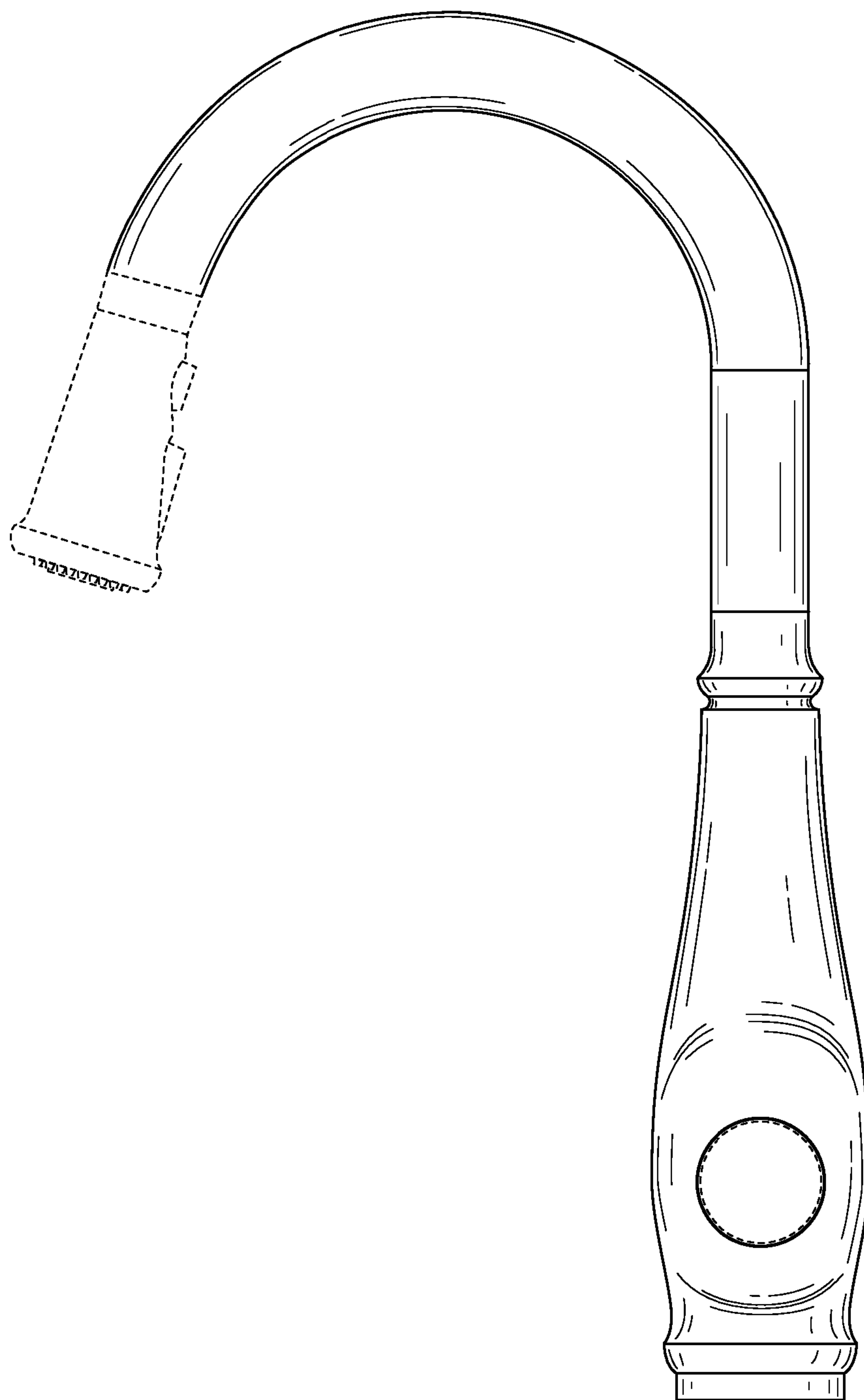

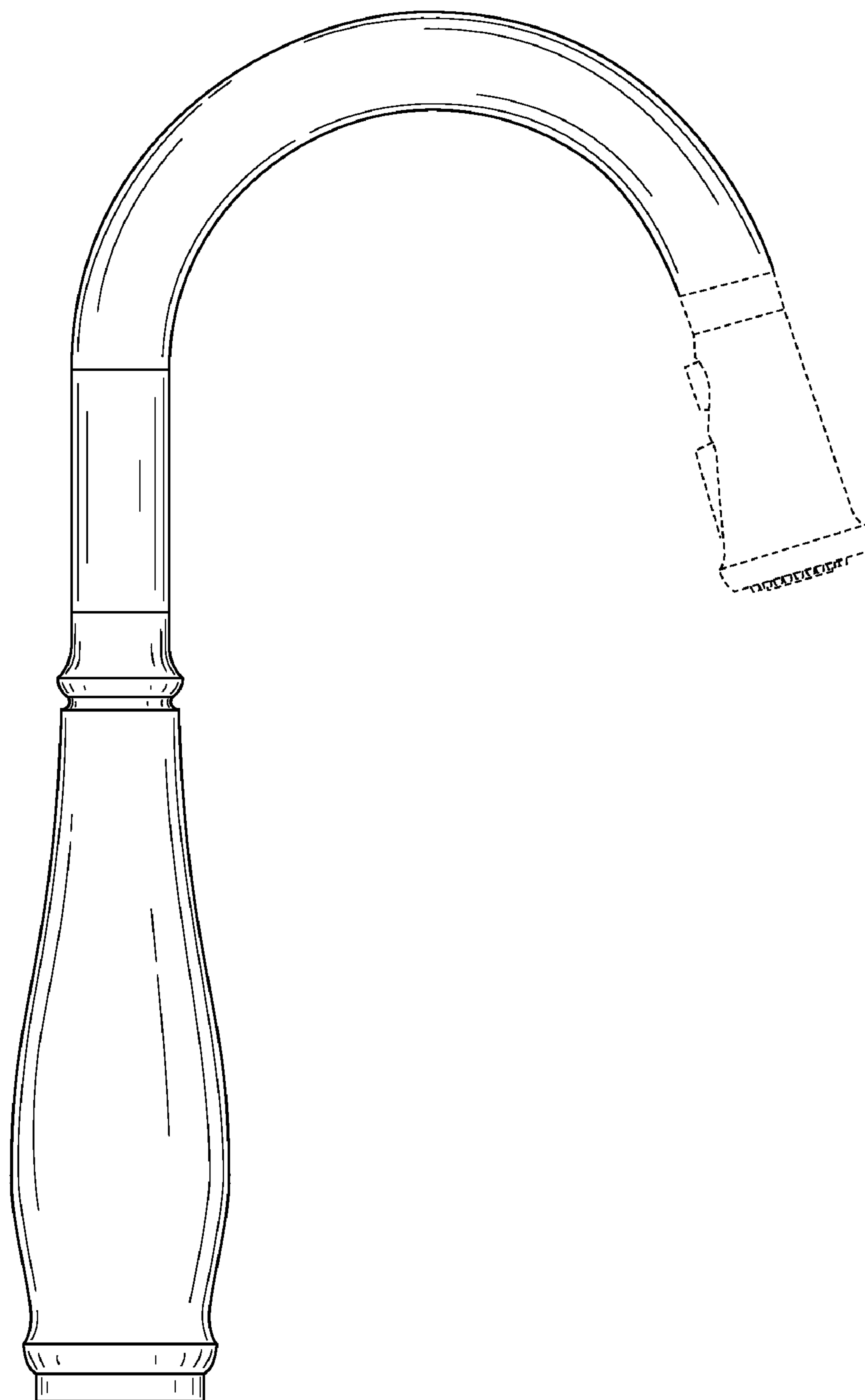

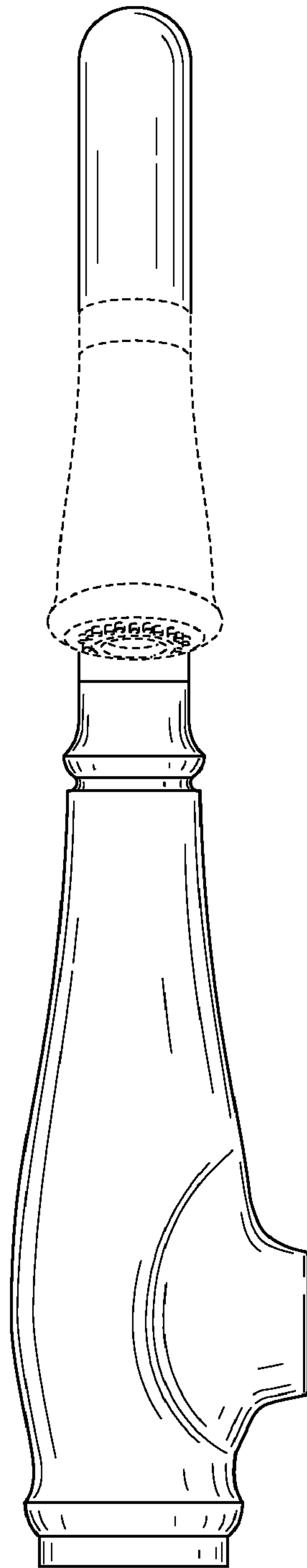

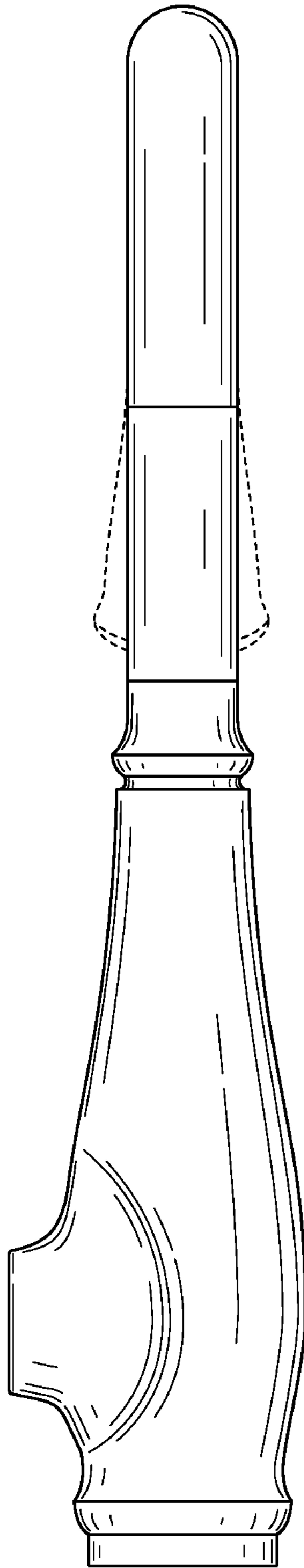

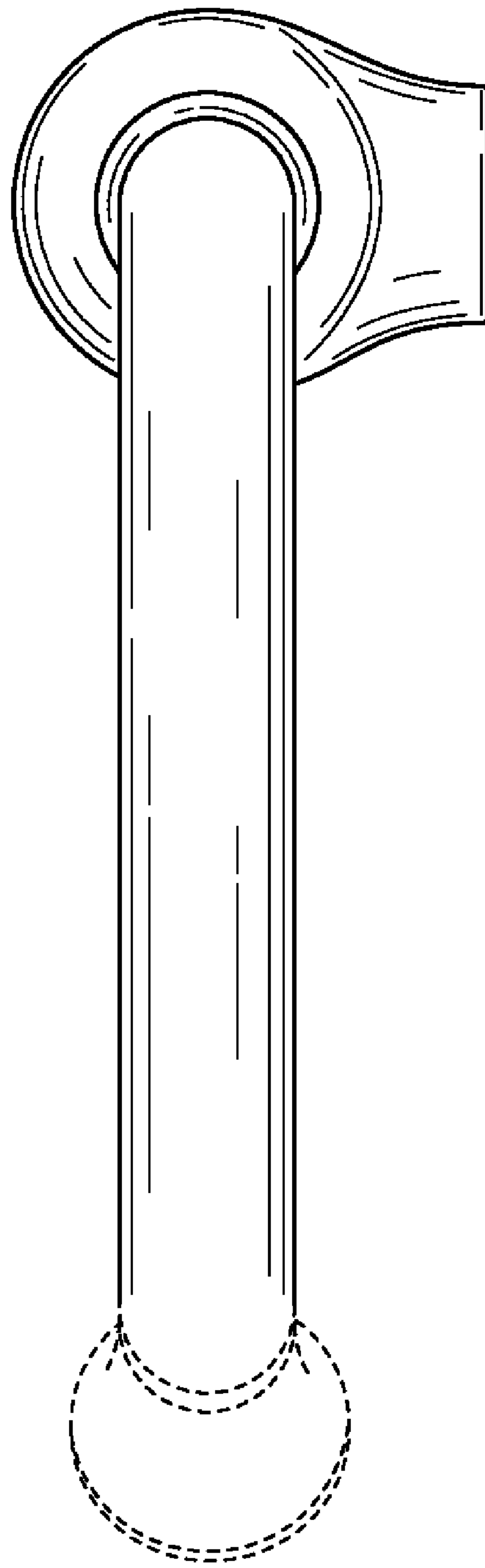

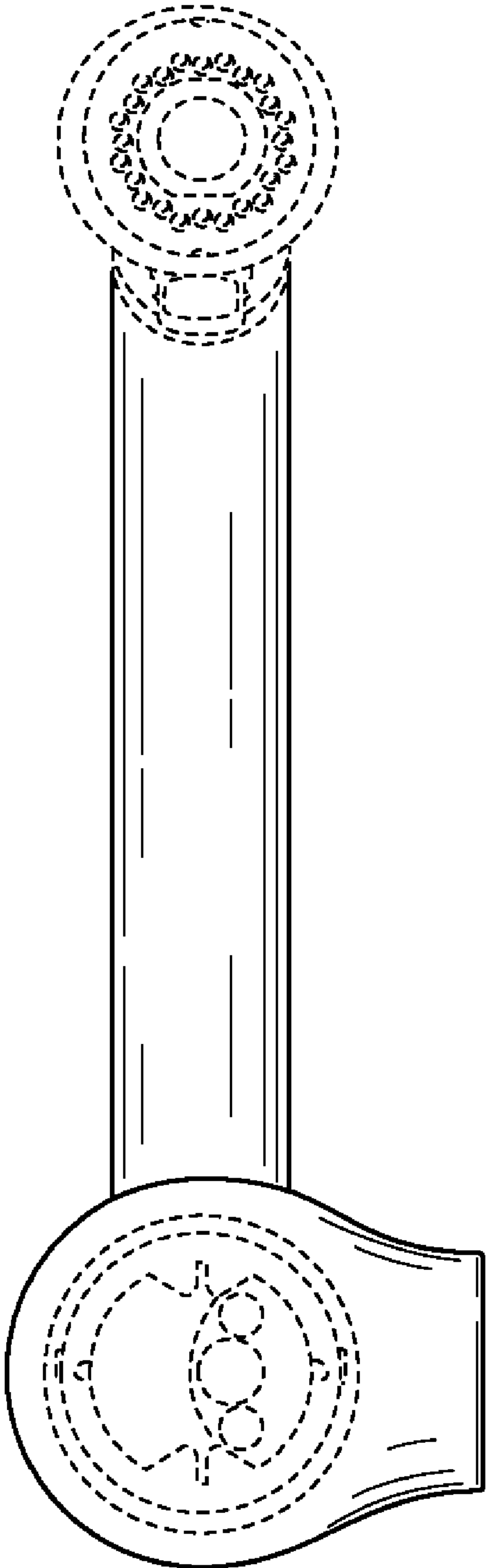
