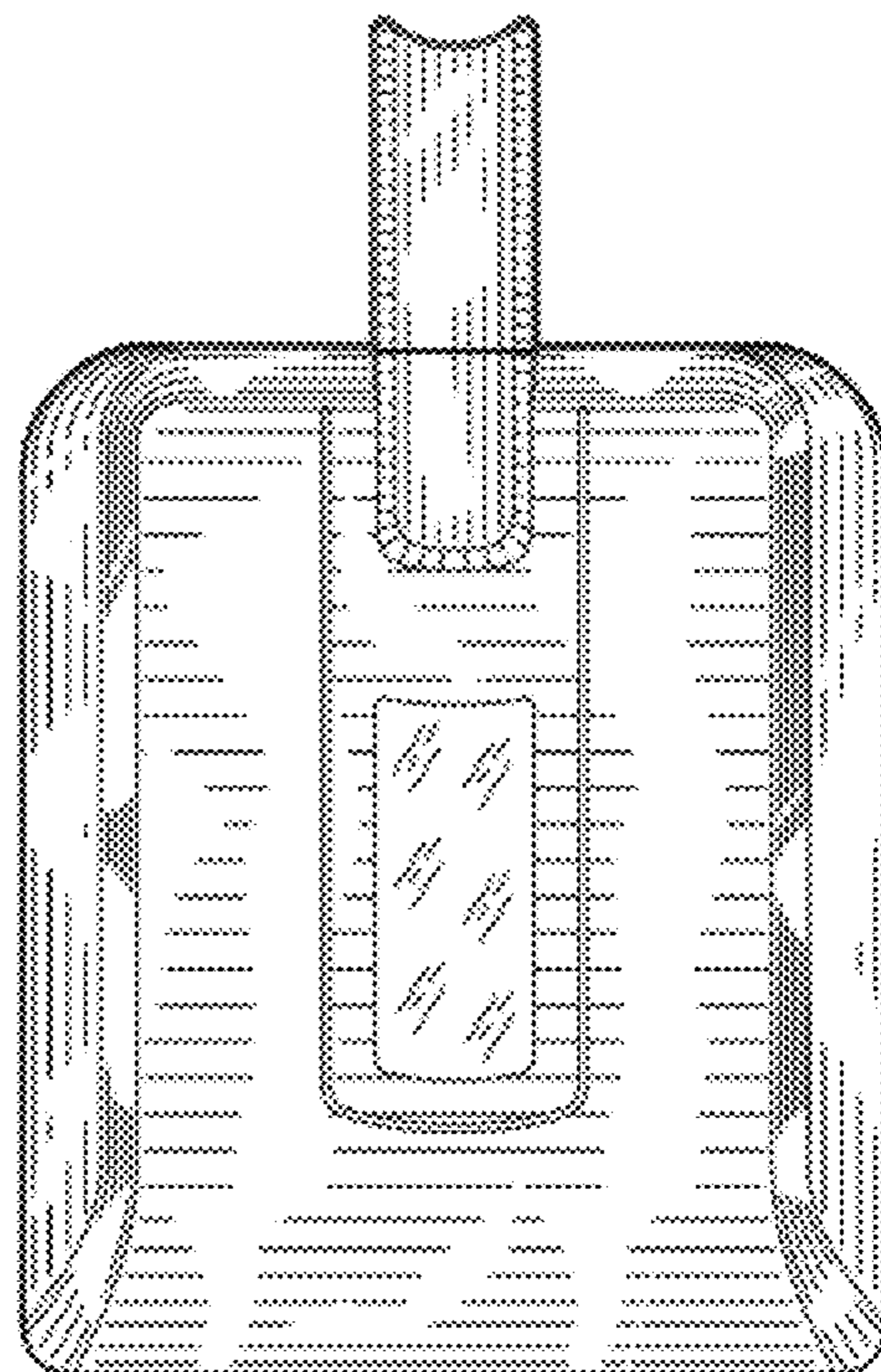
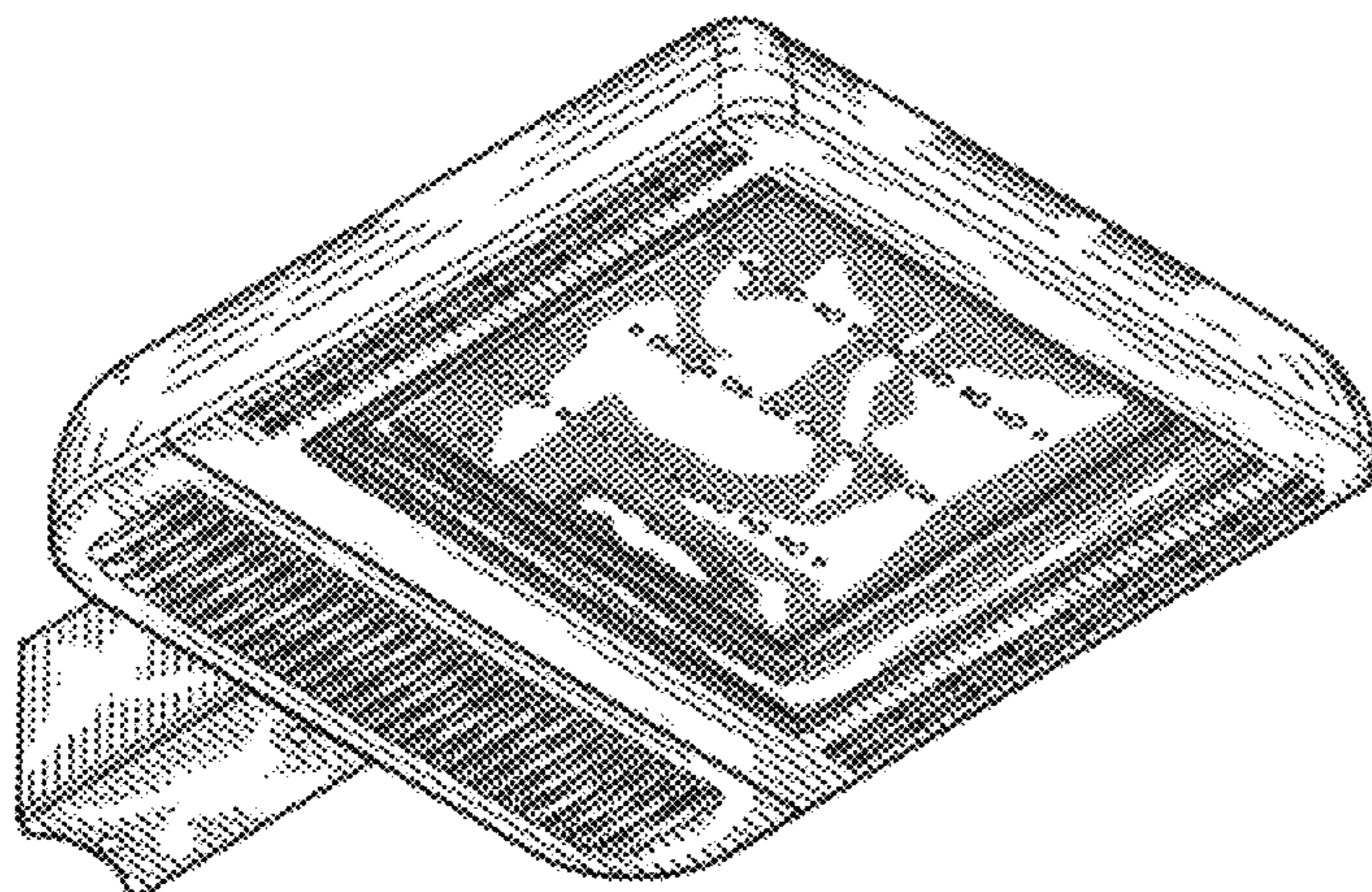
The ornamental design for a luminaire for road lighting, as shown and described.

DESCRIPTION

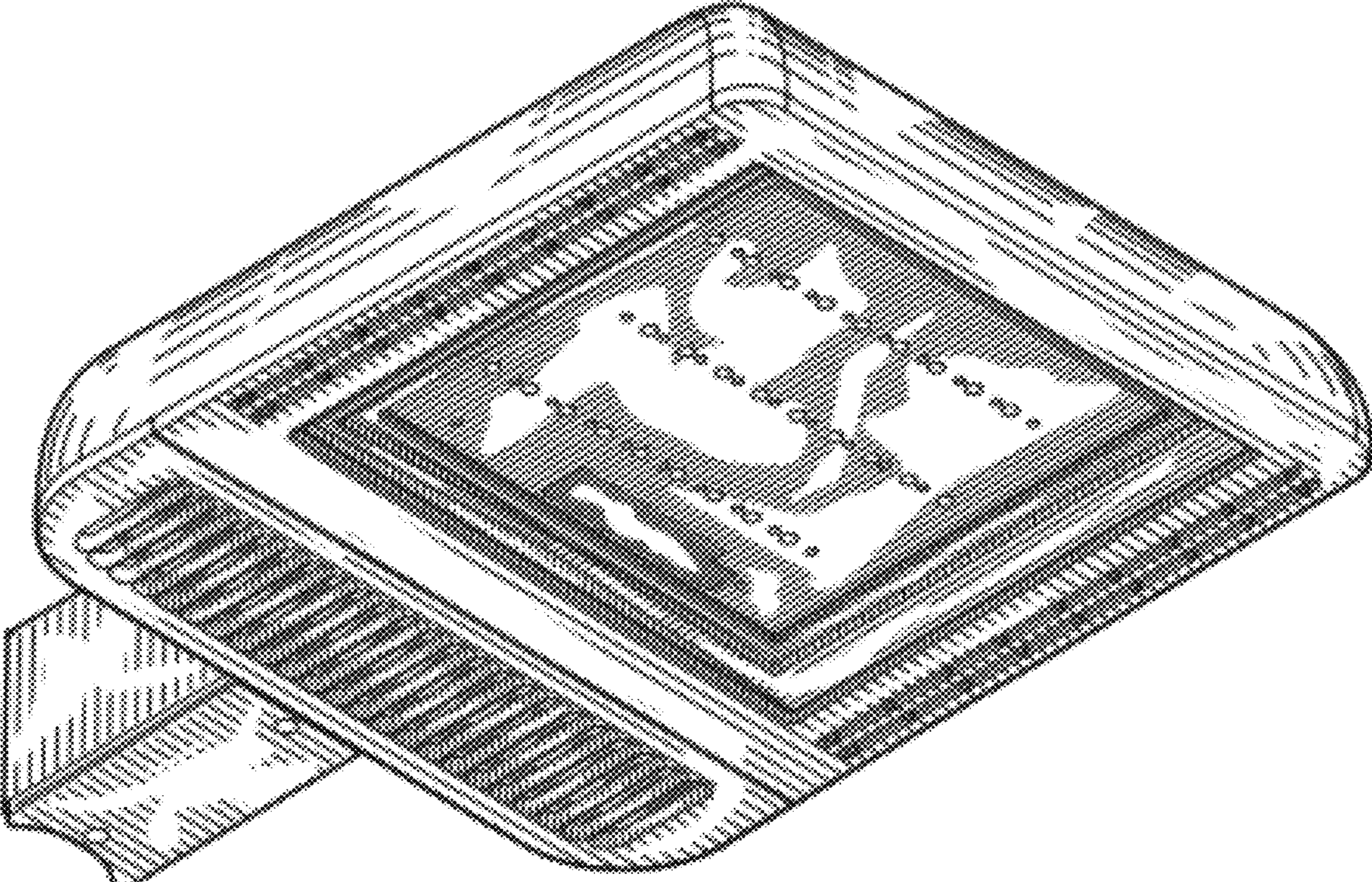

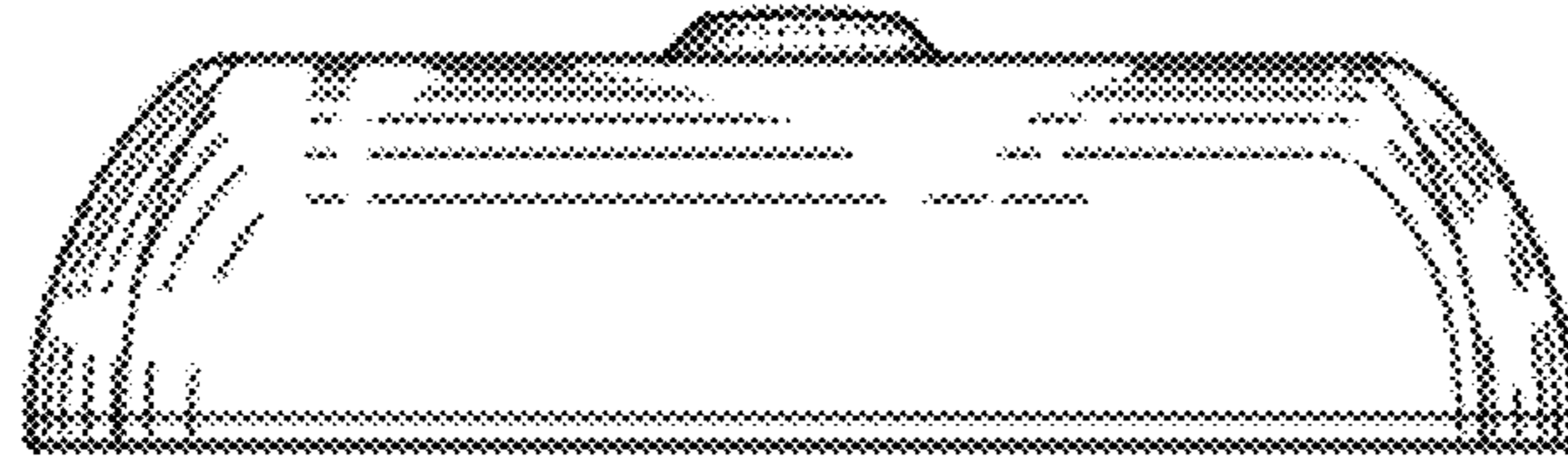

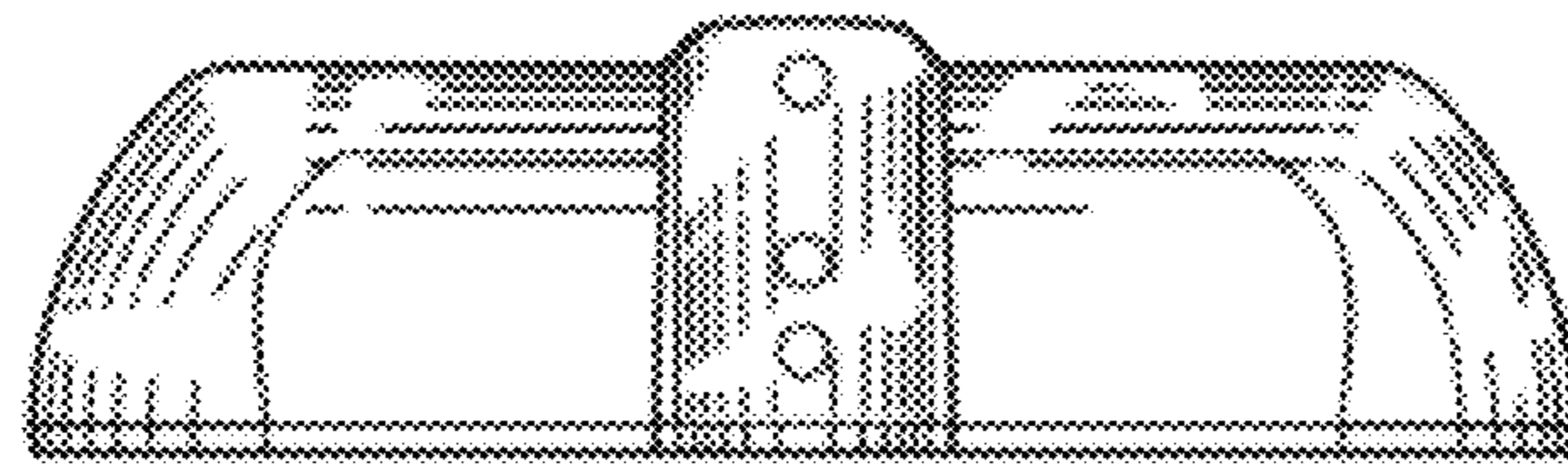

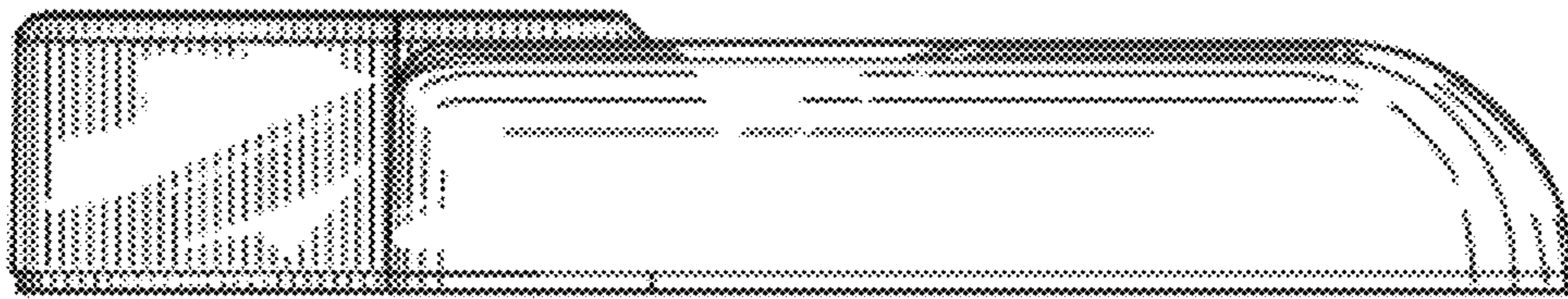

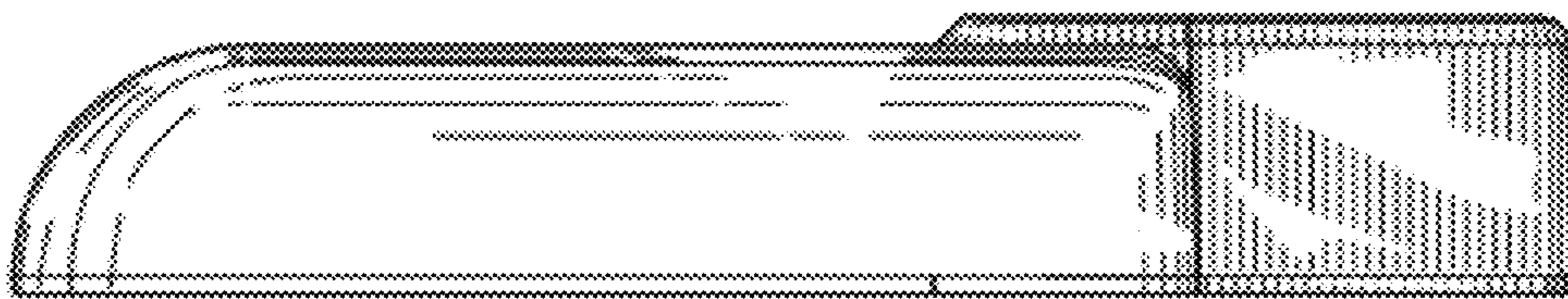

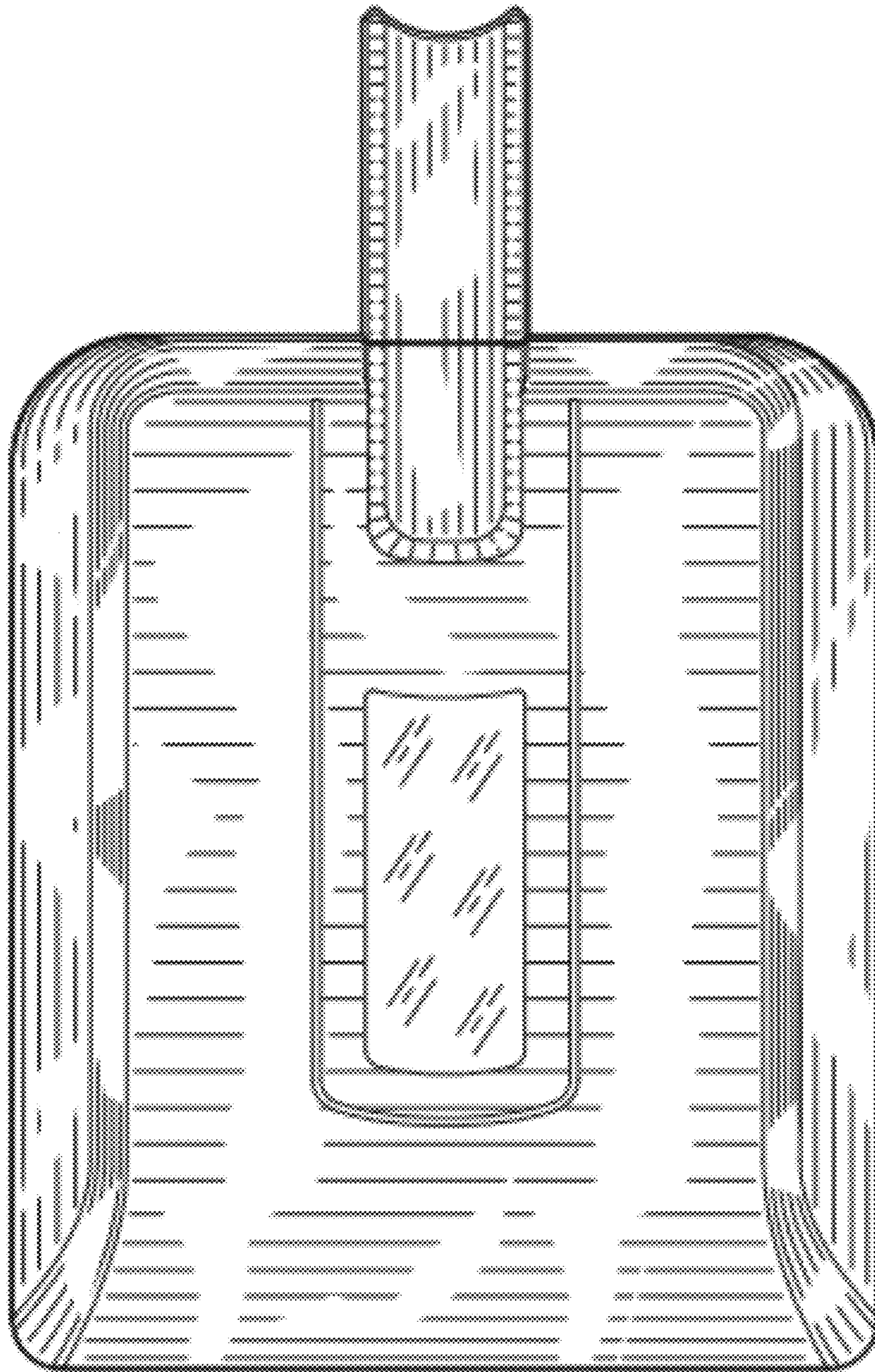

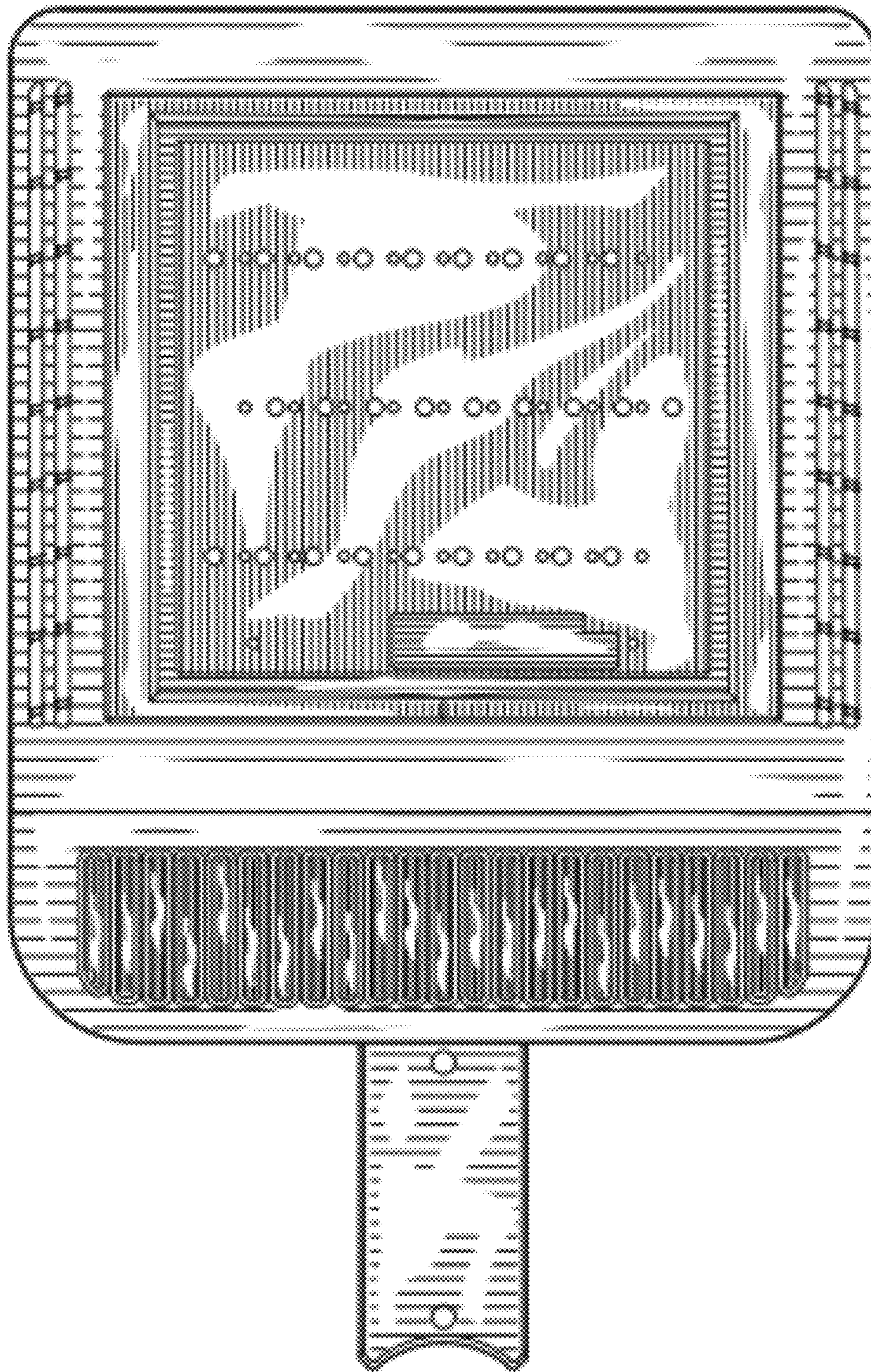
