(57) **CLAIM**

The ornamental design for a triple candle wick, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a triple candle wick showing our new design.

FIG. 2 is a front view thereof, the back view being a mirror image thereof.

FIG. 3 is a side view thereof, the opposite side view being a mirror image thereof.

FIG. 4 is a top view thereof.

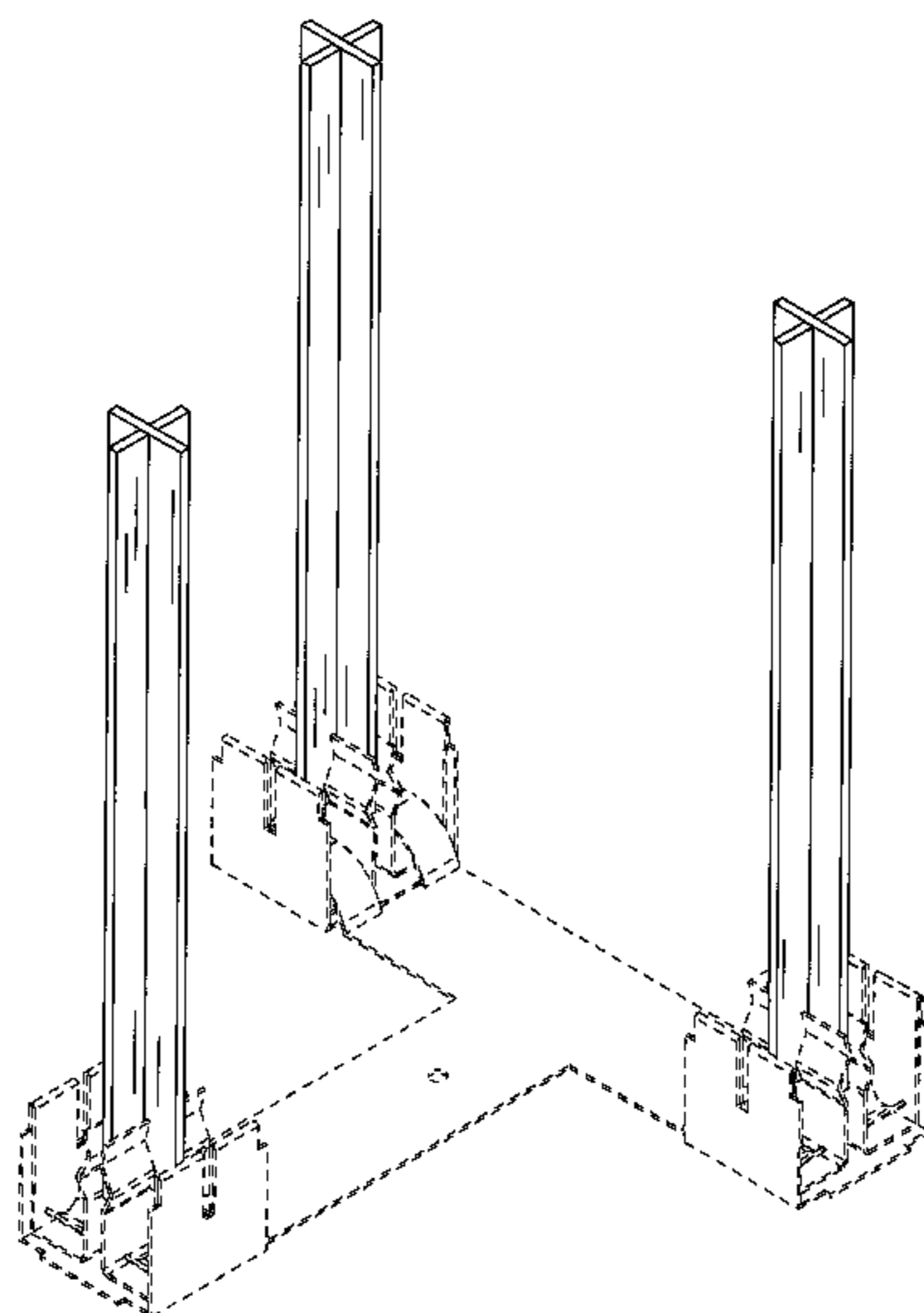
FIG. 5 is a perspective view of the candle wick of FIGS. 1-4 shown as a component of a wax candle.

FIG. 6 is a side view of the view shown in FIG. 5, shown with the wax removed, the opposite side view being a mirror image thereof; and,

FIG. 7 is a top view of the view shown in FIG. 5, shown with the wax removed.

The broken lines in the drawings are included for purposes of illustrating portions of the environment used with the candle wick that form no part of the claimed design.

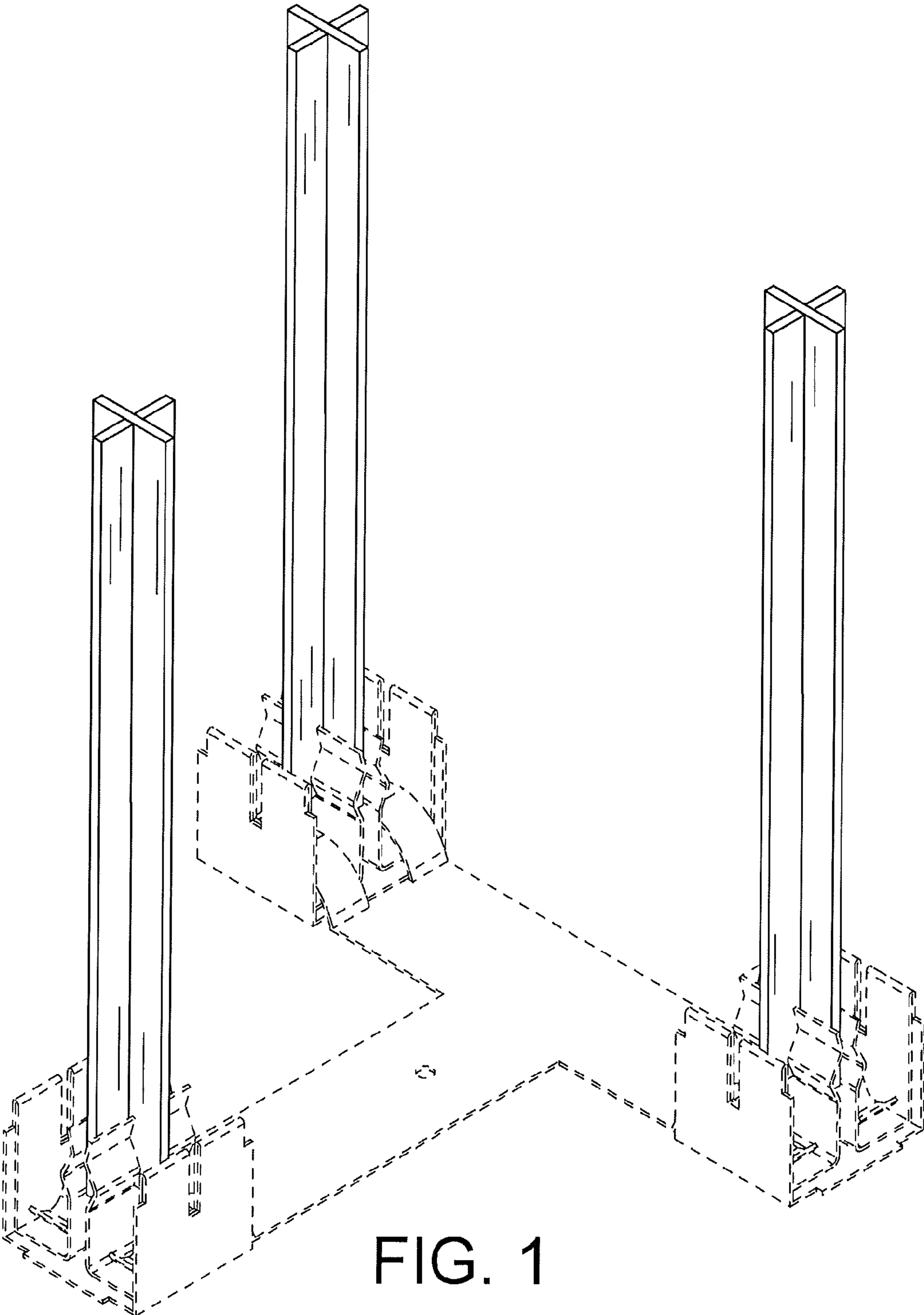

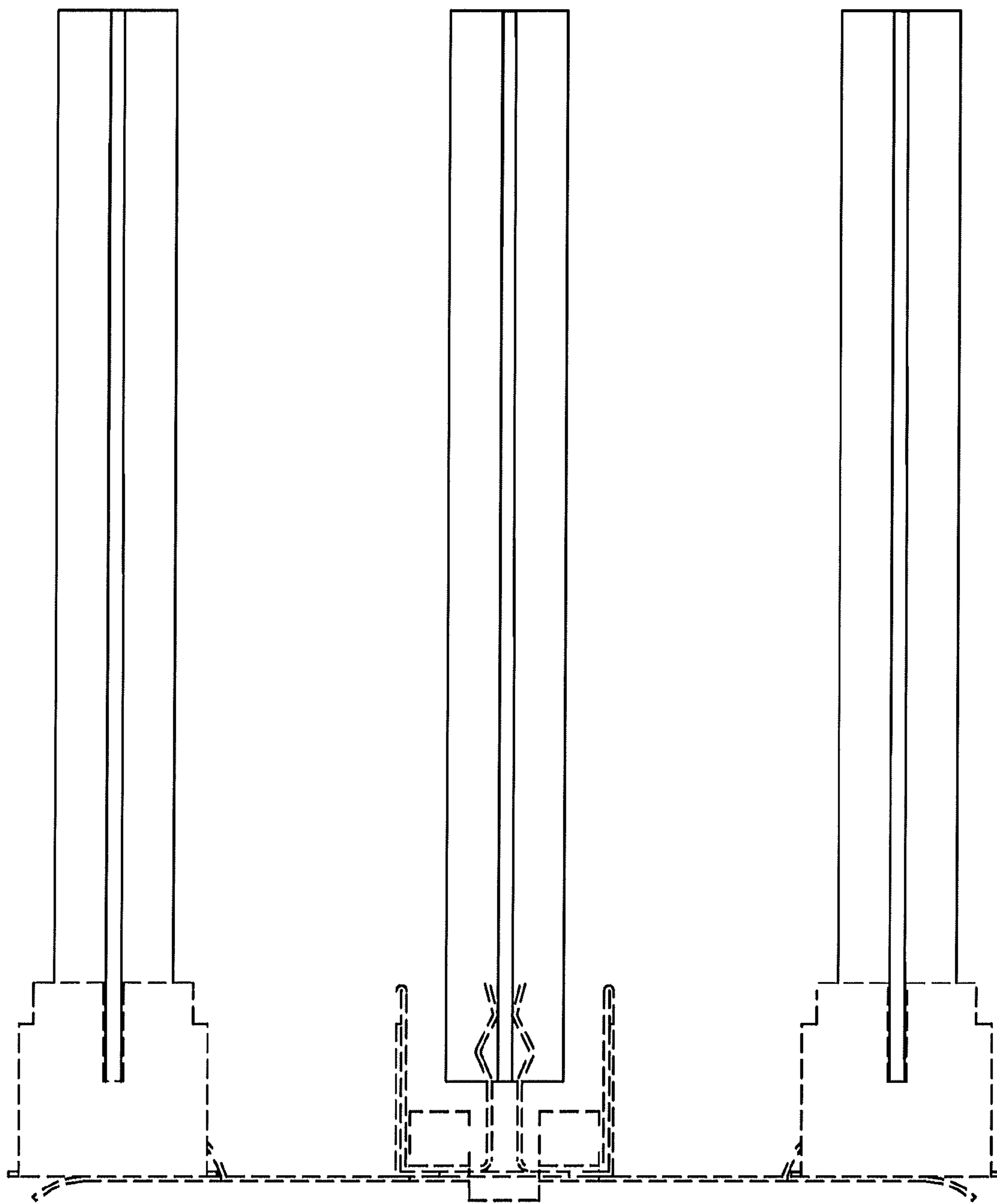

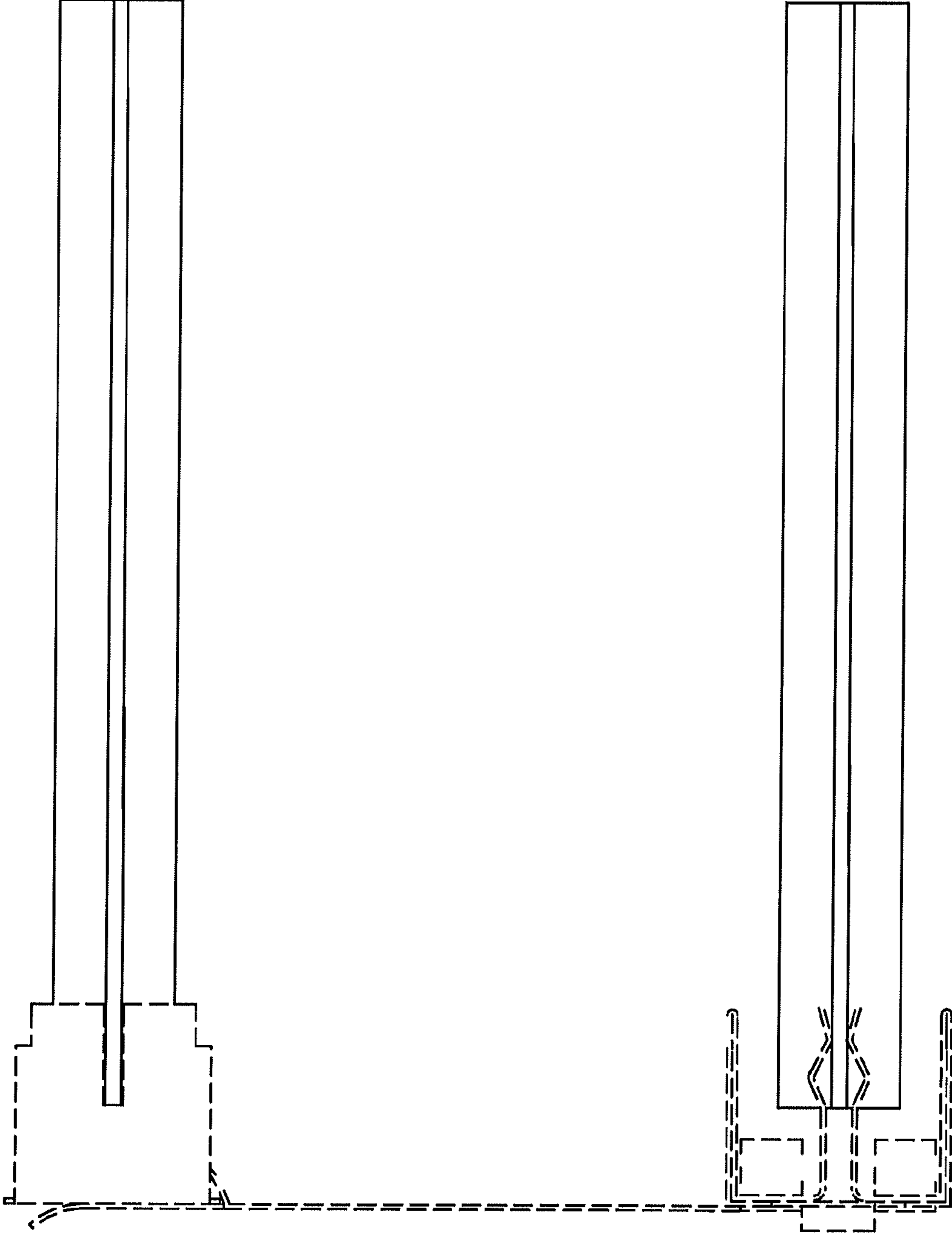

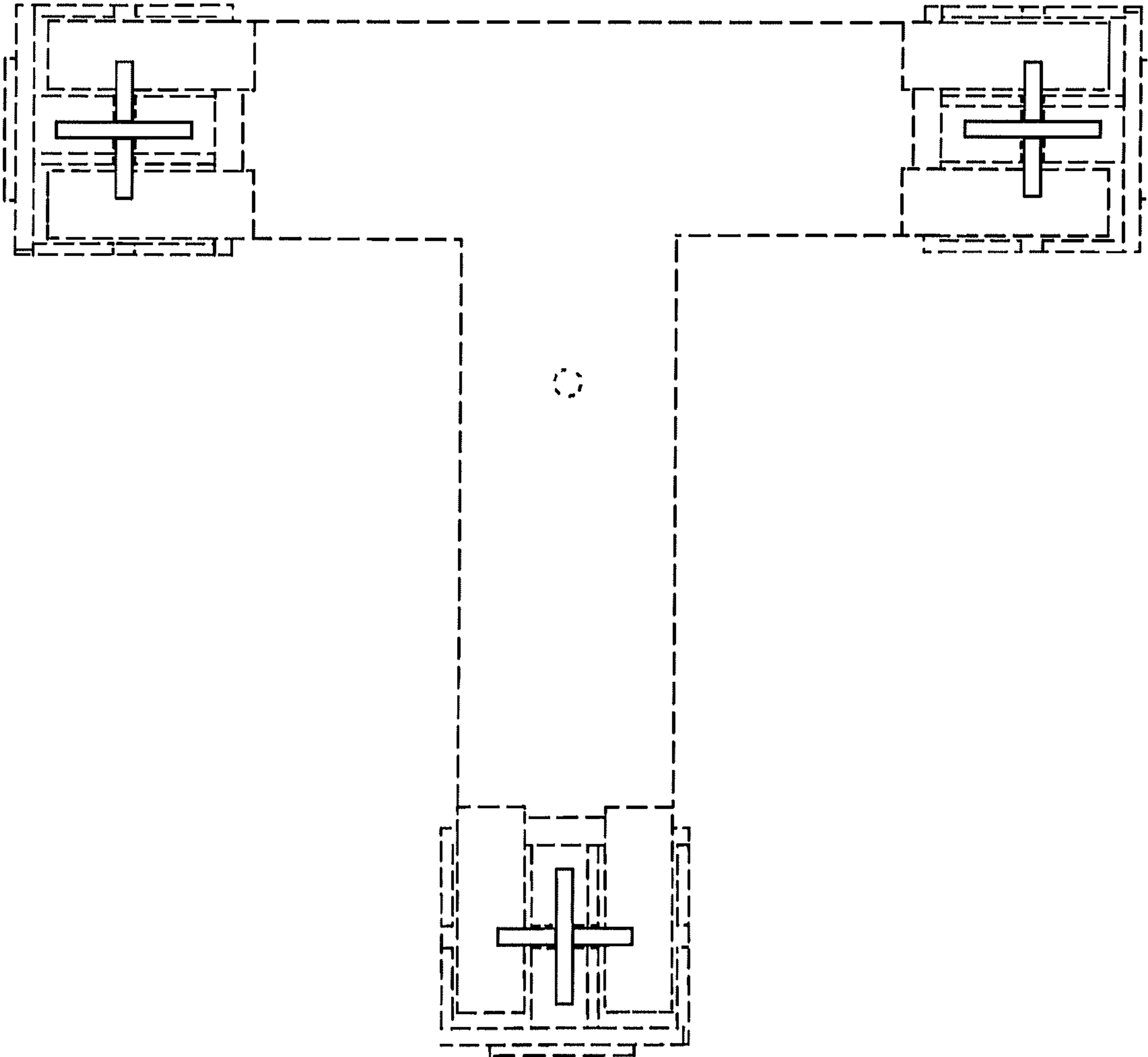

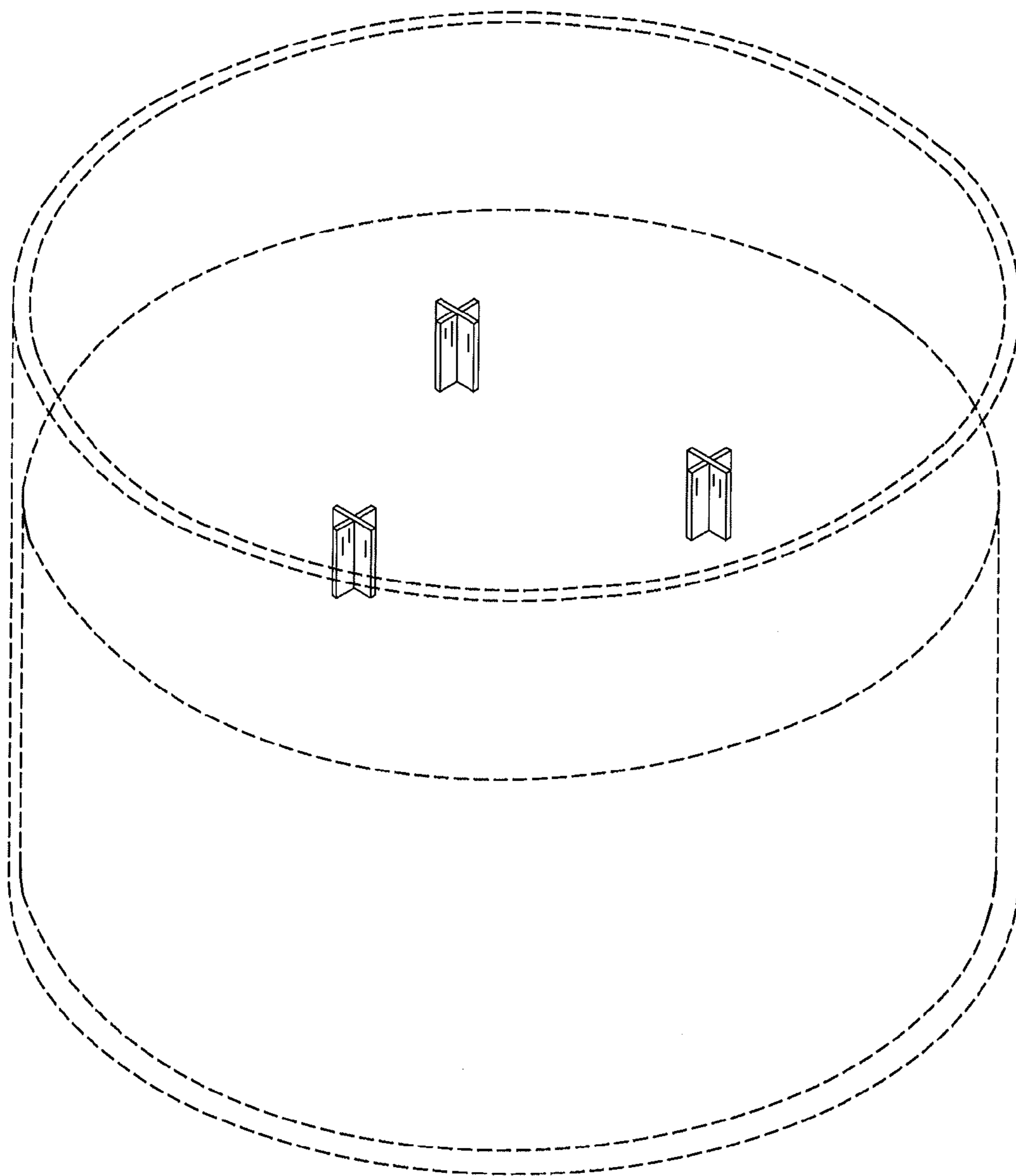

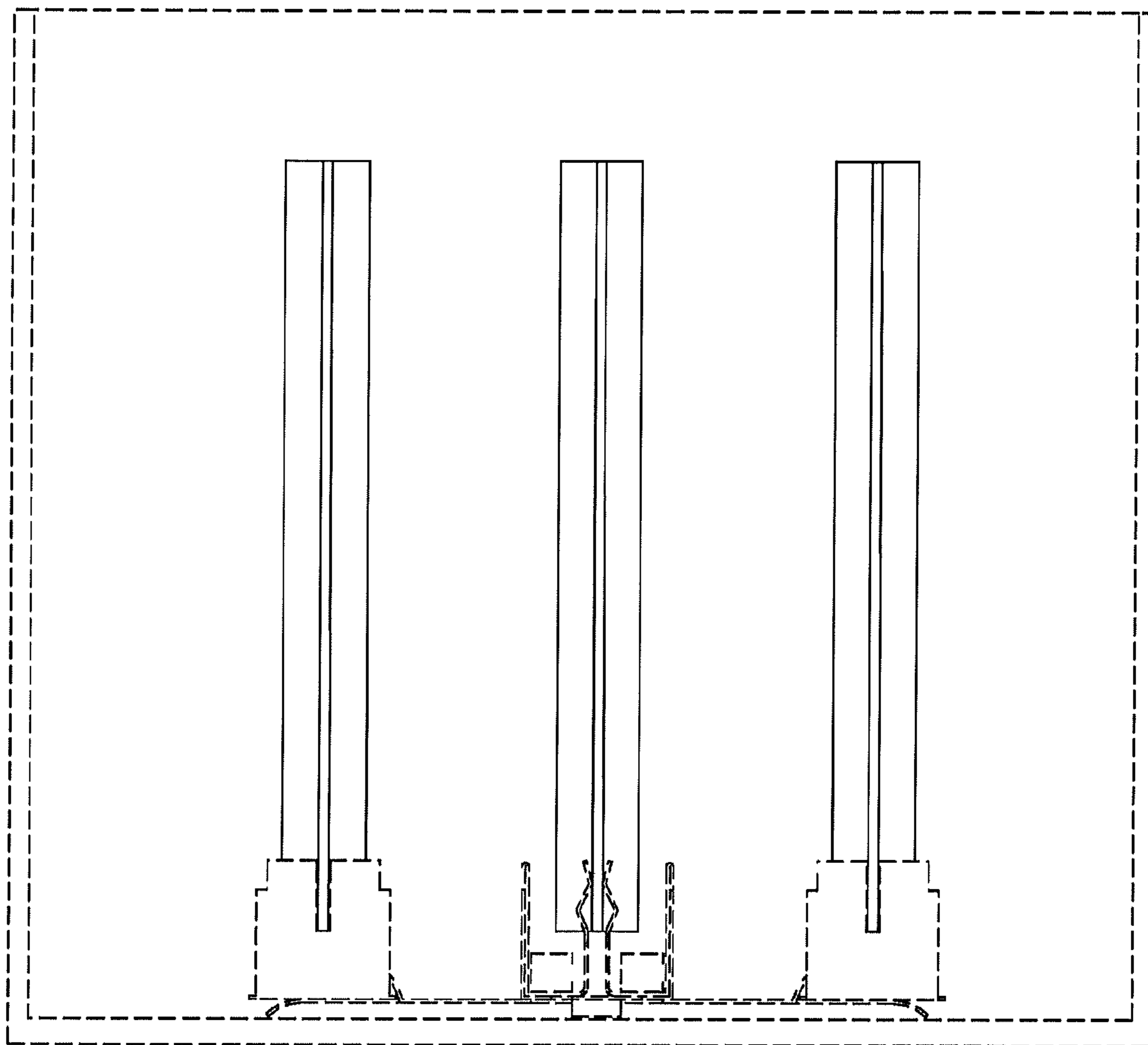

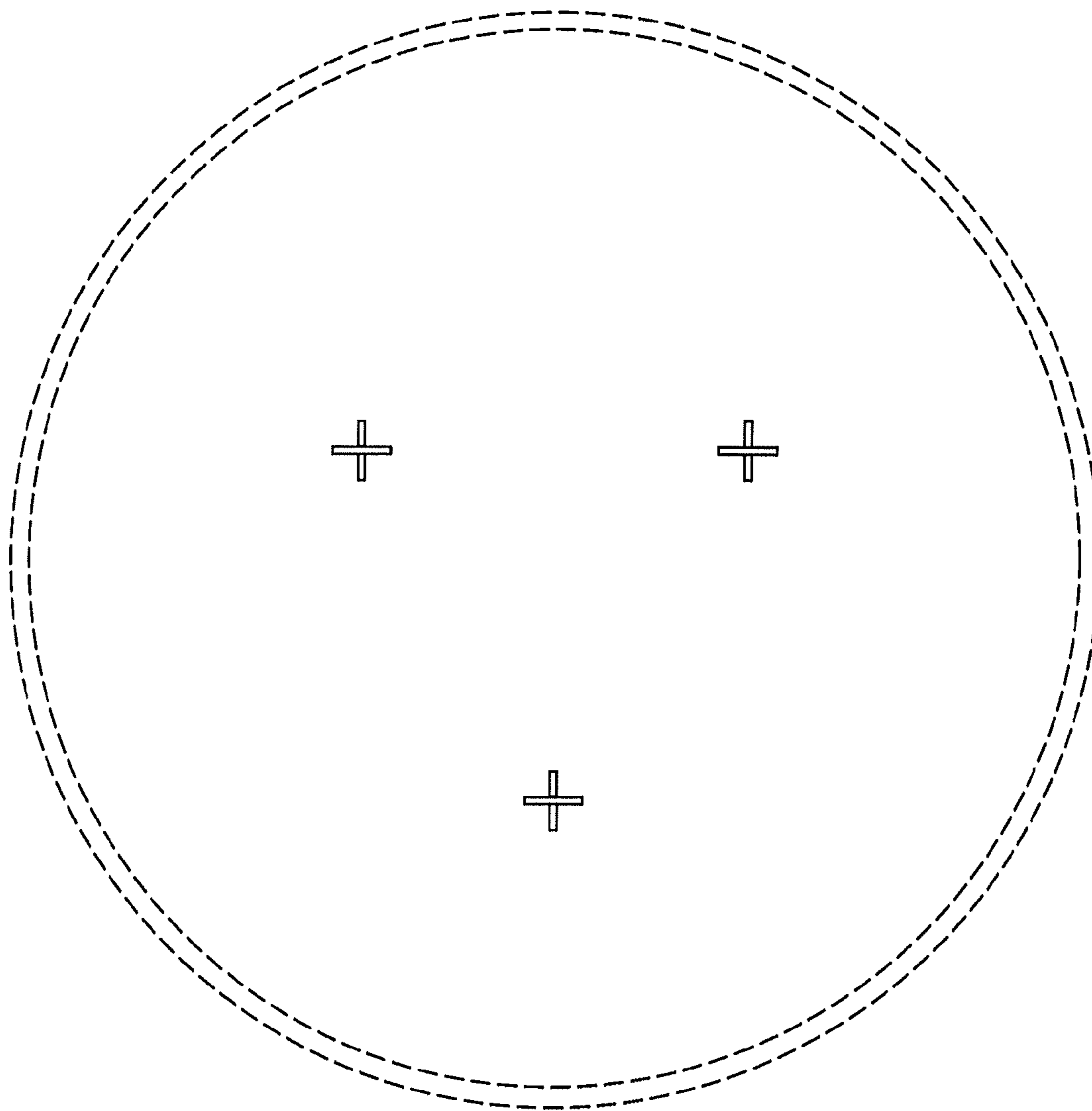
