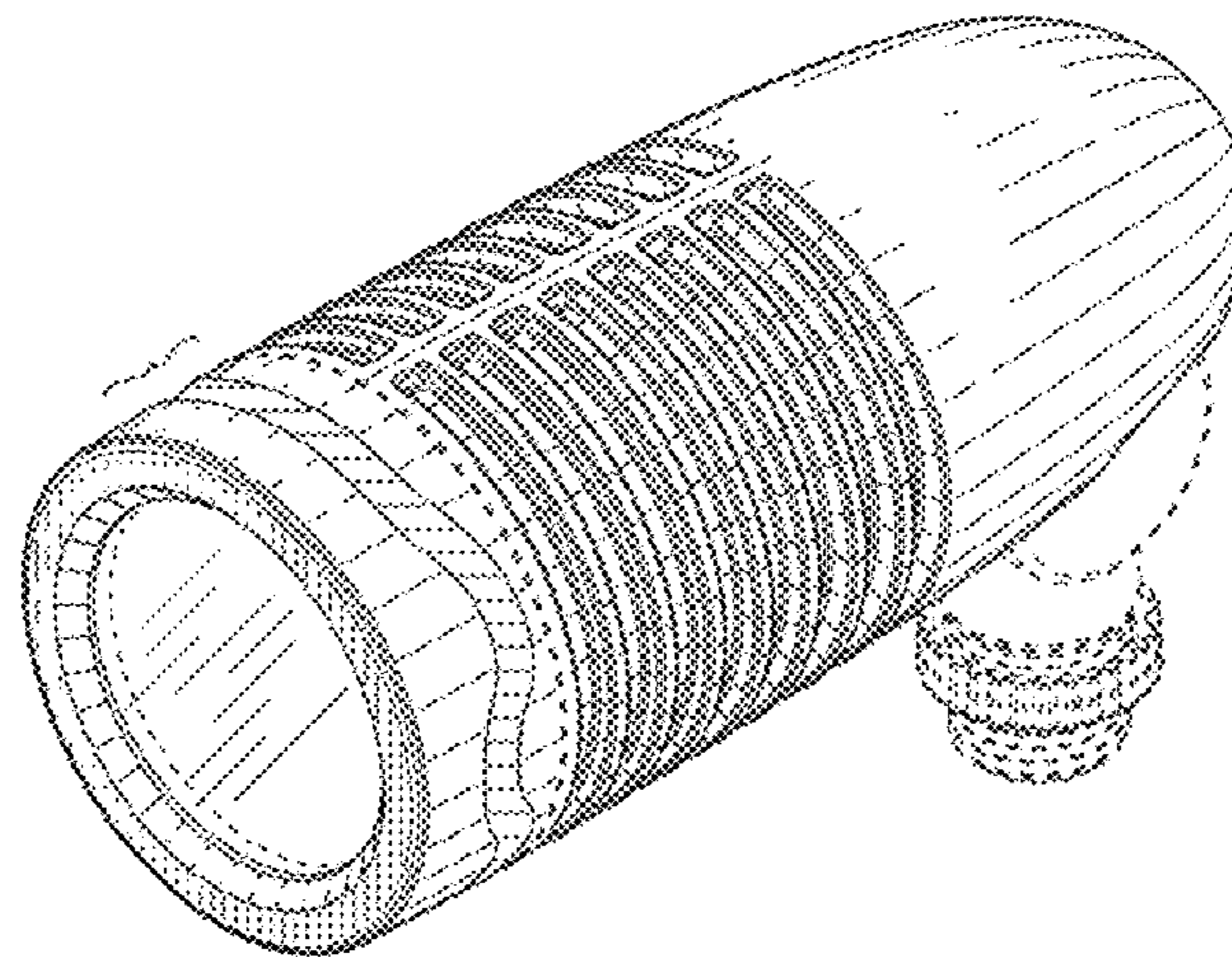
(57) **CLAIM**

The ornamental design for a bullet shaped LED light fixture,  
substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of an embodiment of  
the new design;  
FIG. 2 is a right side view of the embodiment;  
FIG. 3 is a rear view of the embodiment;  
FIG. 4 is a left side view of the embodiment  
FIG. 5 is a front view of the embodiment;  
FIG. 6 is a top view of the embodiment; and,  
FIG. 7 is a bottom view of the embodiment.  
The design consists of the features of shape, ornament and  
configuration of the article shown in the drawings. The bracketed  
separation is shown to indicate an indeterminate length.  
The broken lines shown in the drawings are for the purposes  
of illustrating portions of the article that form no part of the  
claimed design.

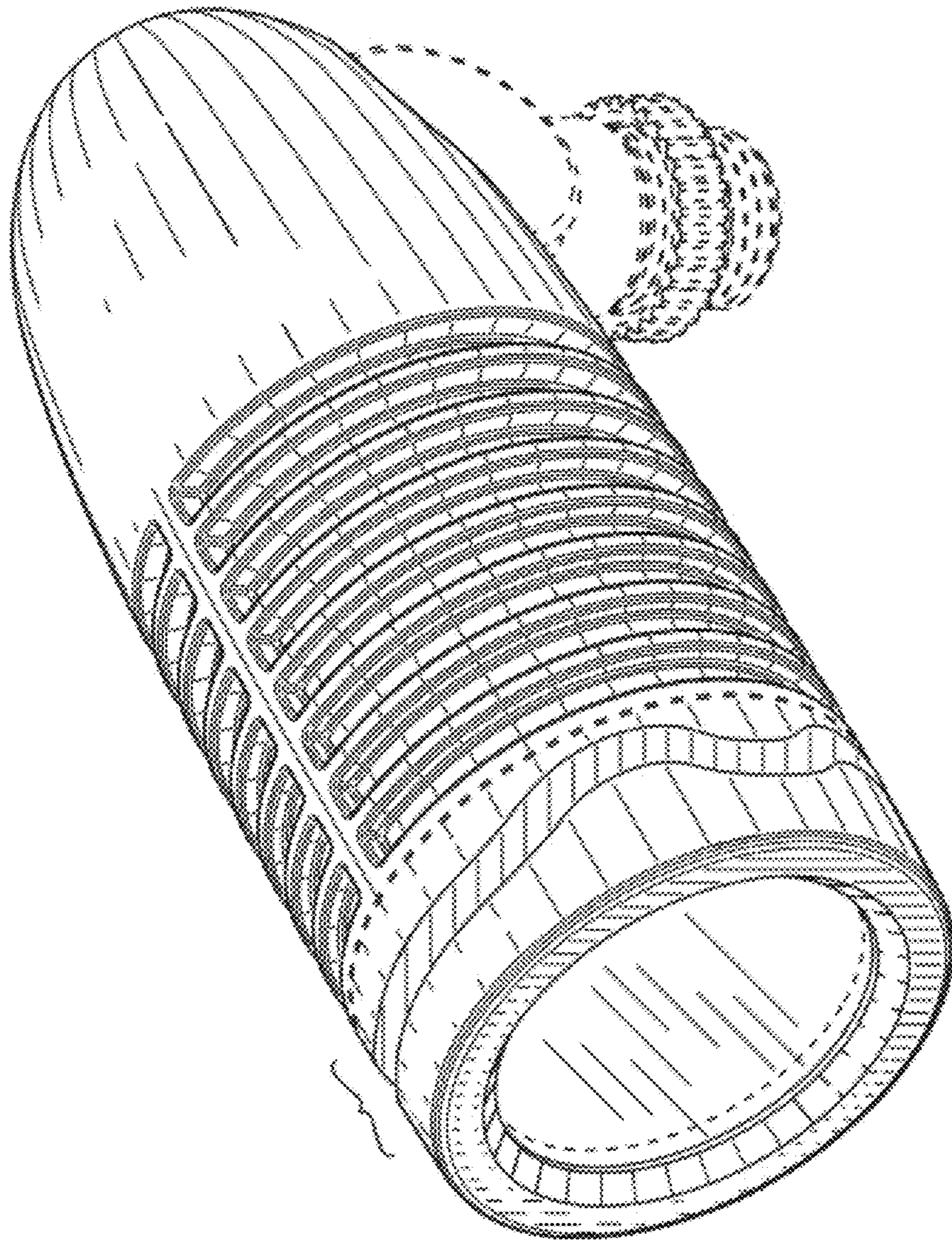

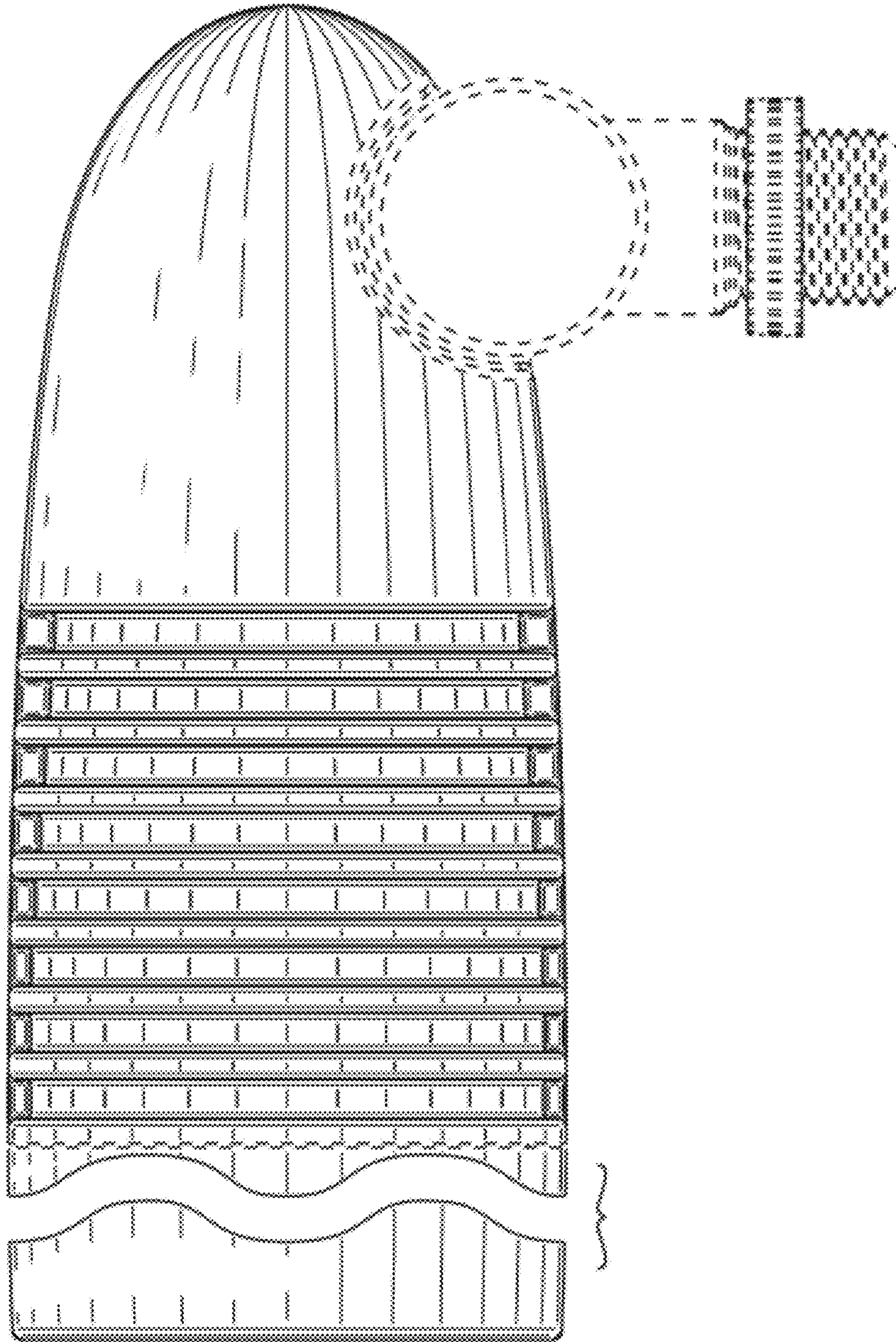

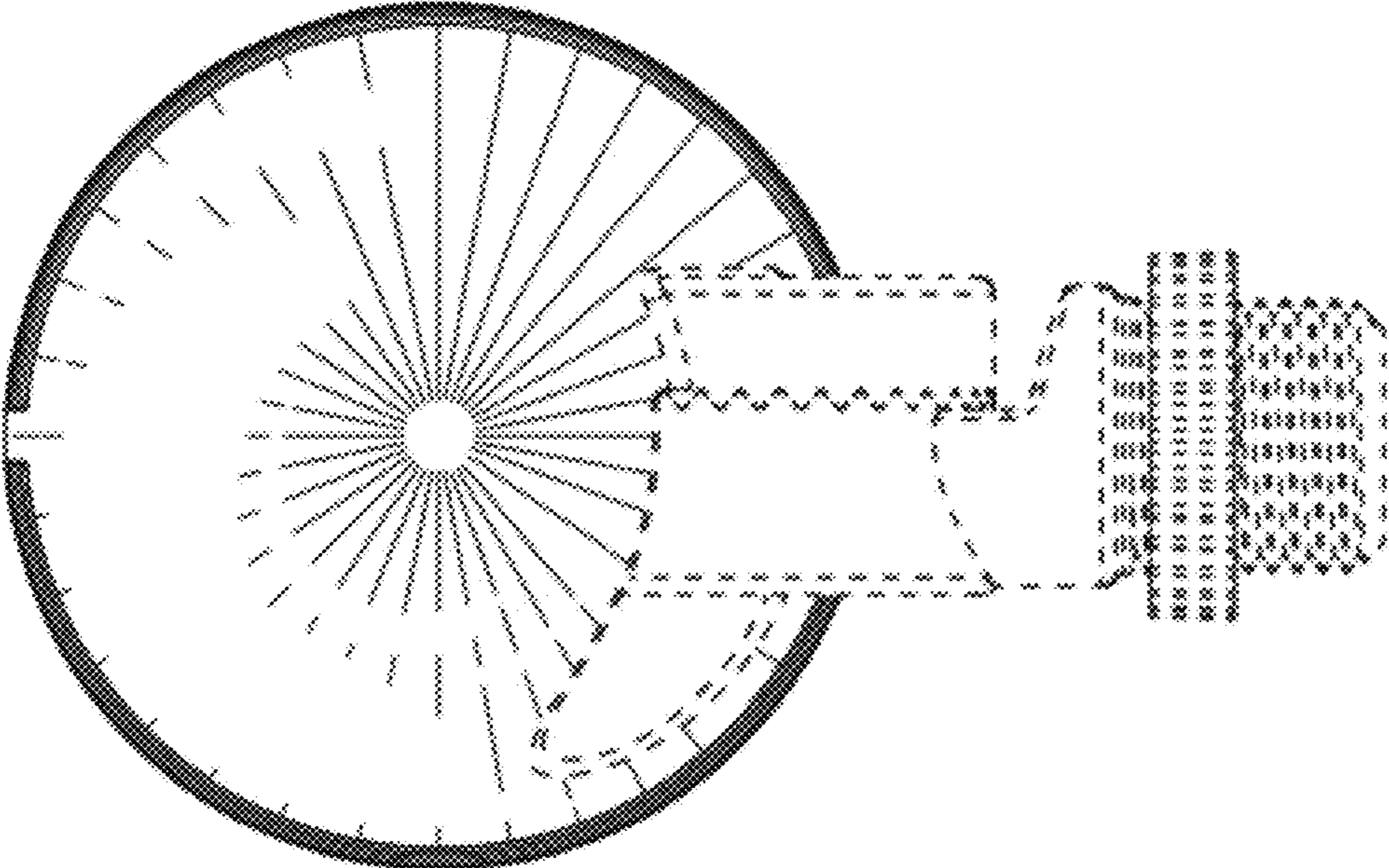

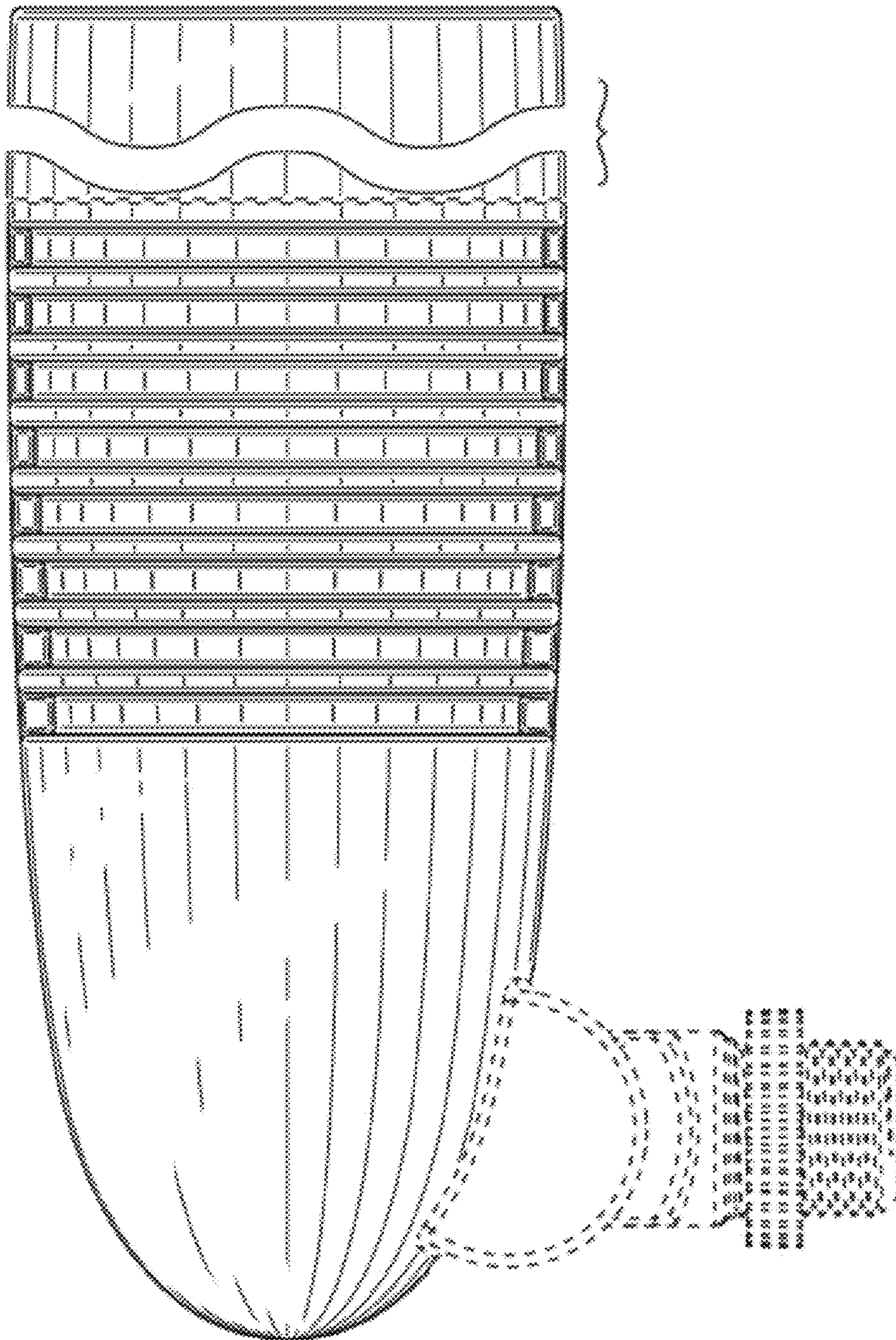

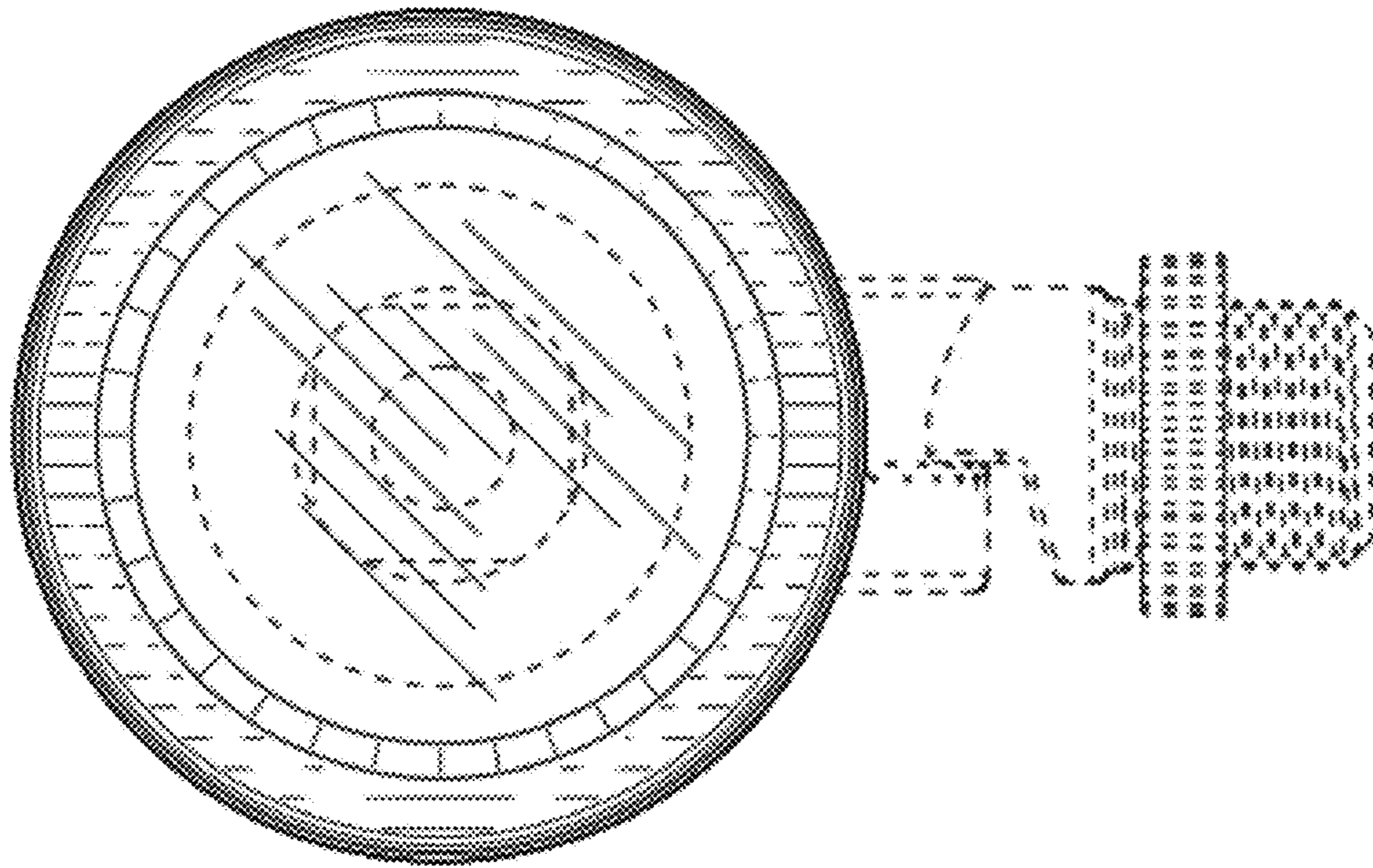

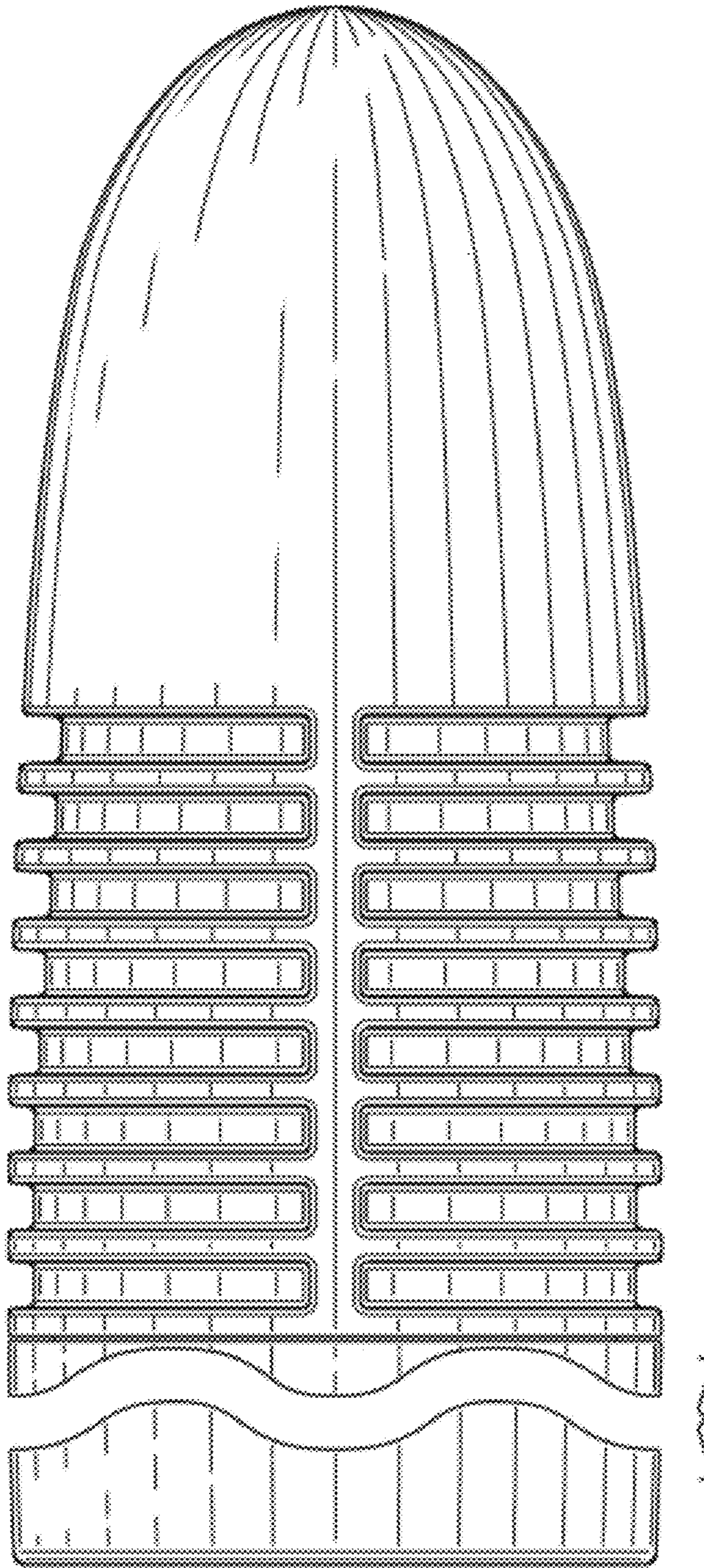

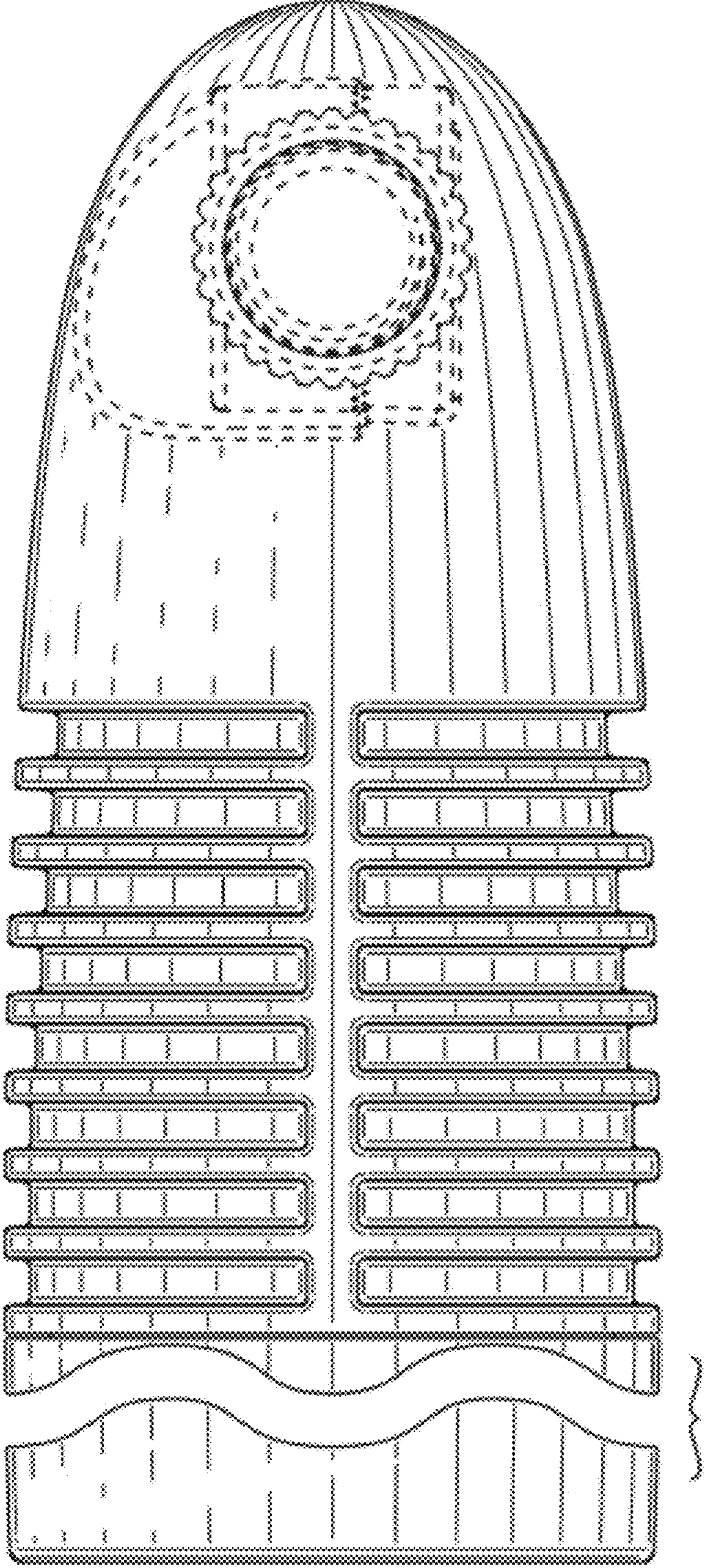
