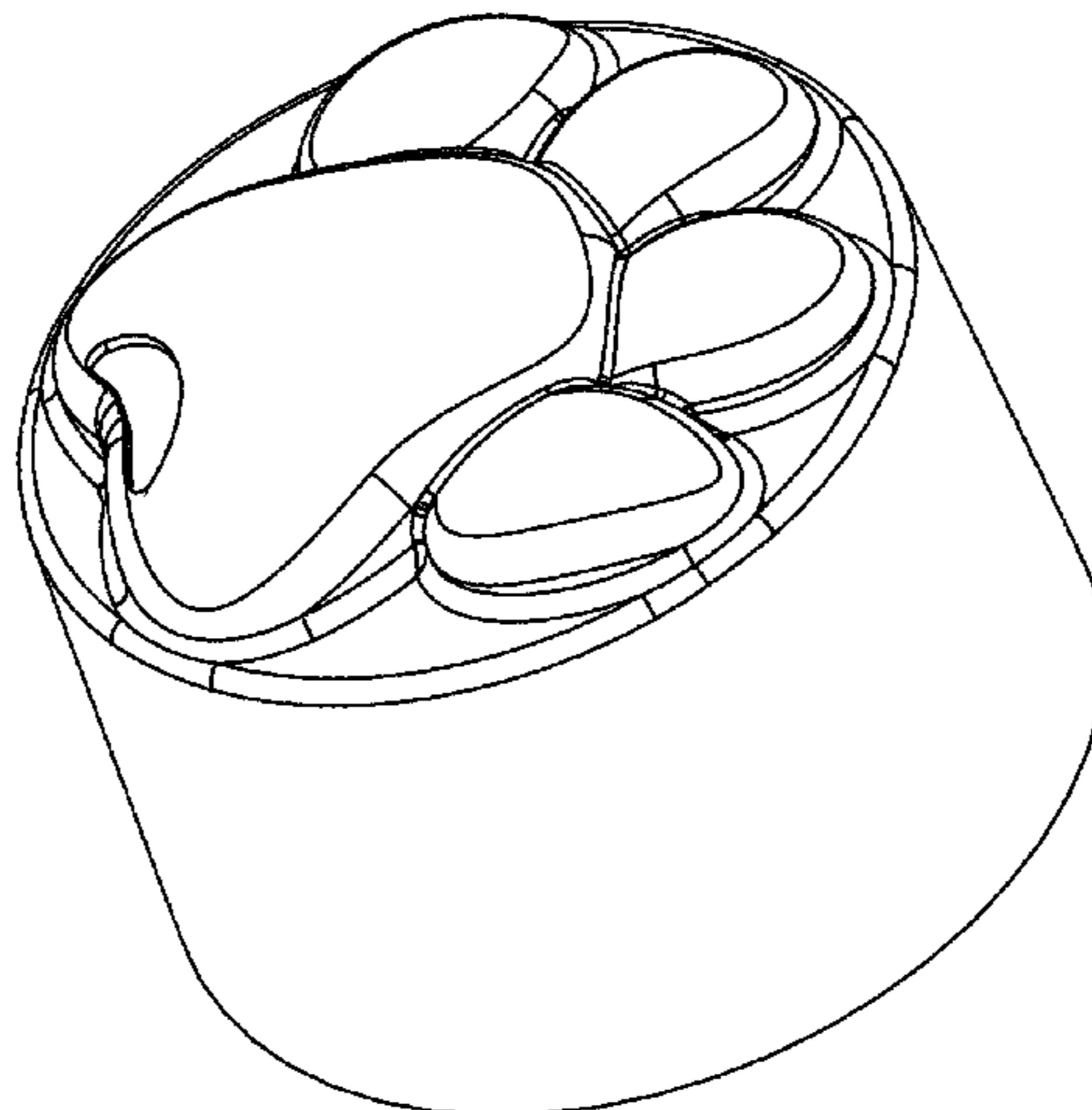
(57) **CLAIM**

I claim the ornamental design for an animal paw shaped pet treat dispensing puzzle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the animal paw shaped pet treat dispensing puzzle;
FIG. 2 is a top perspective view thereof; and,
FIG. 3 is a bottom interior view thereof.
This design invention relates to a treat dispensing puzzle toy for pets wherein treats may be inserted into receptacles therefor.

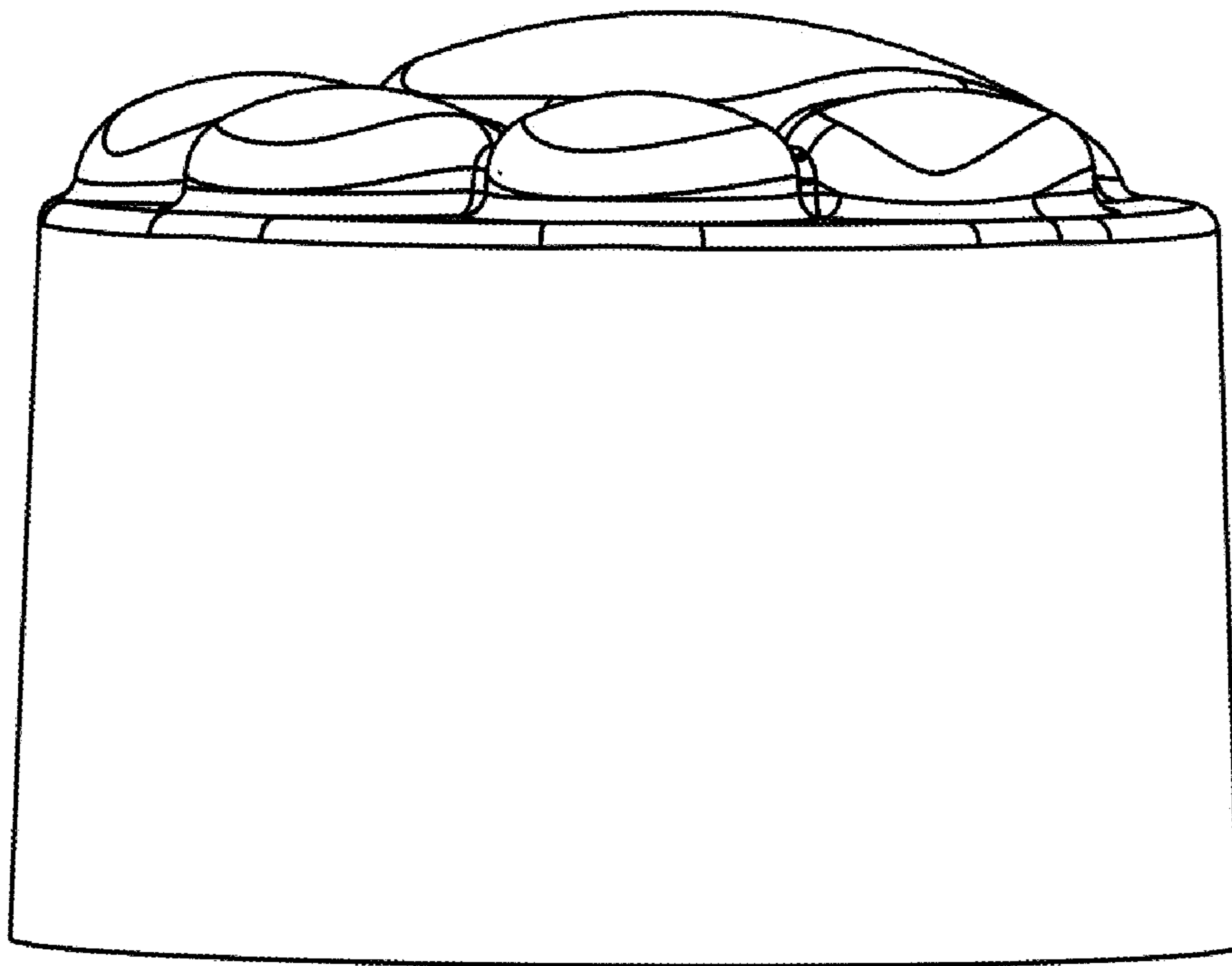

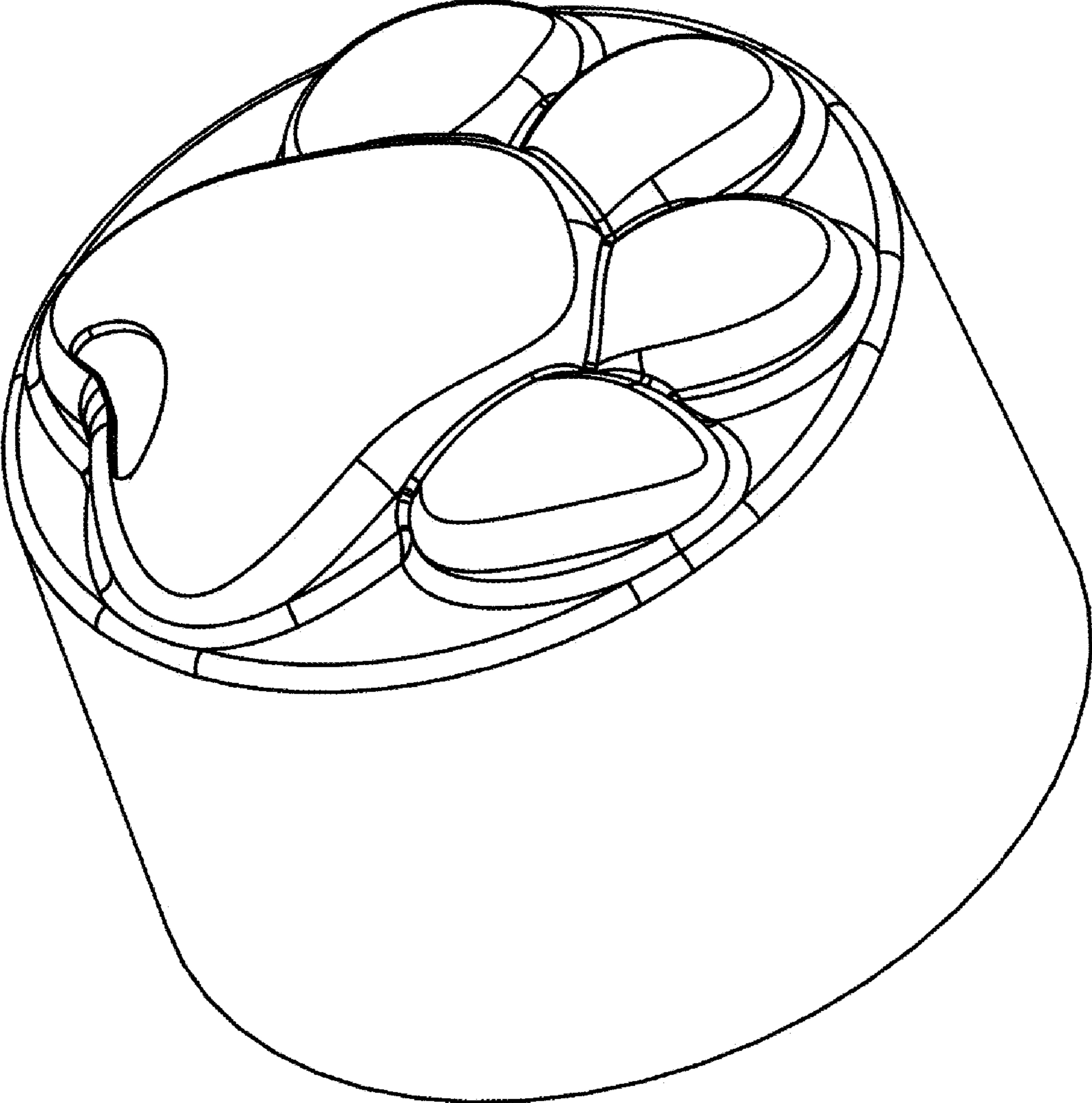
