FIG. 3 is a bottom view of our new design for a cookie.

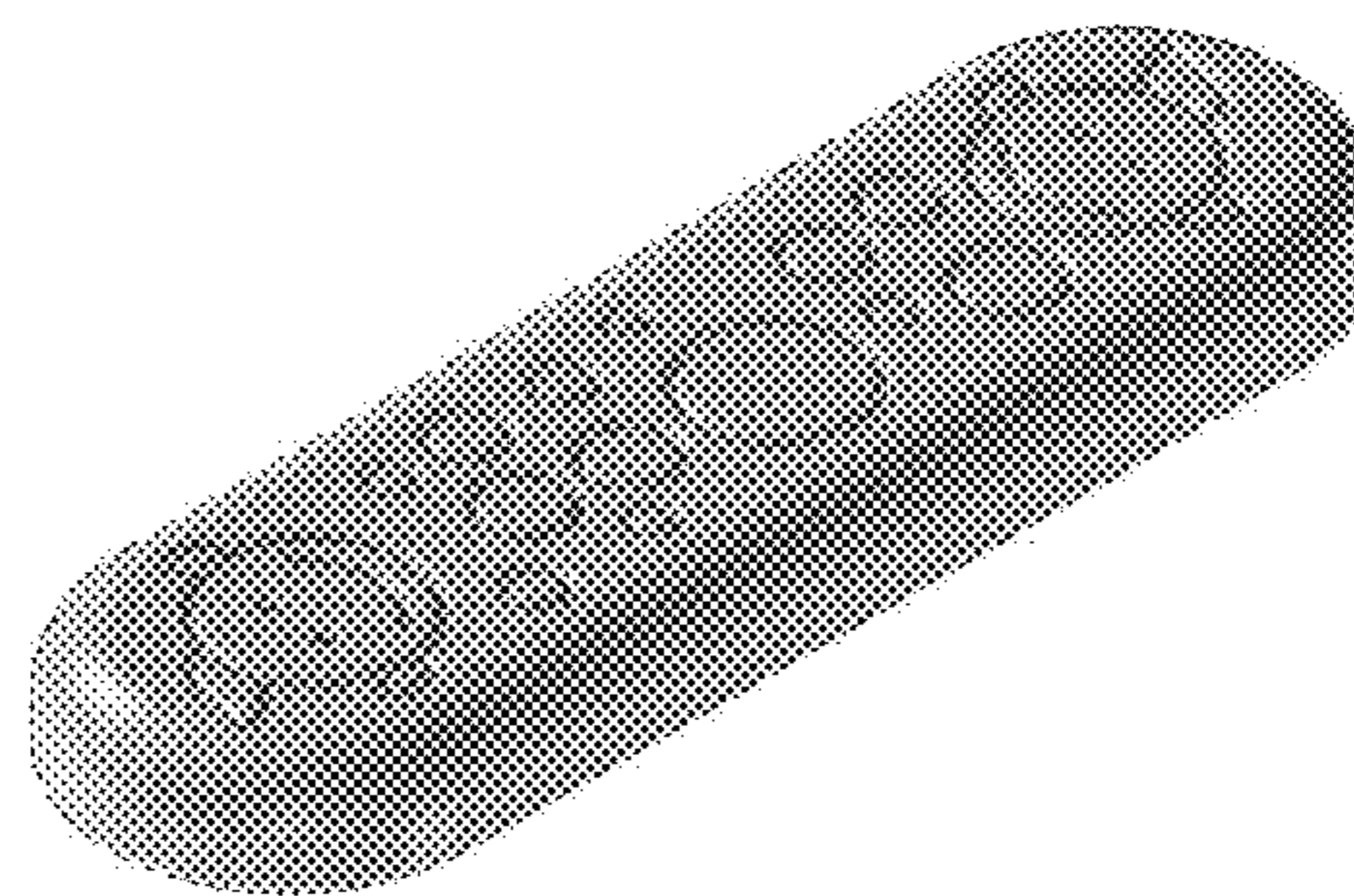
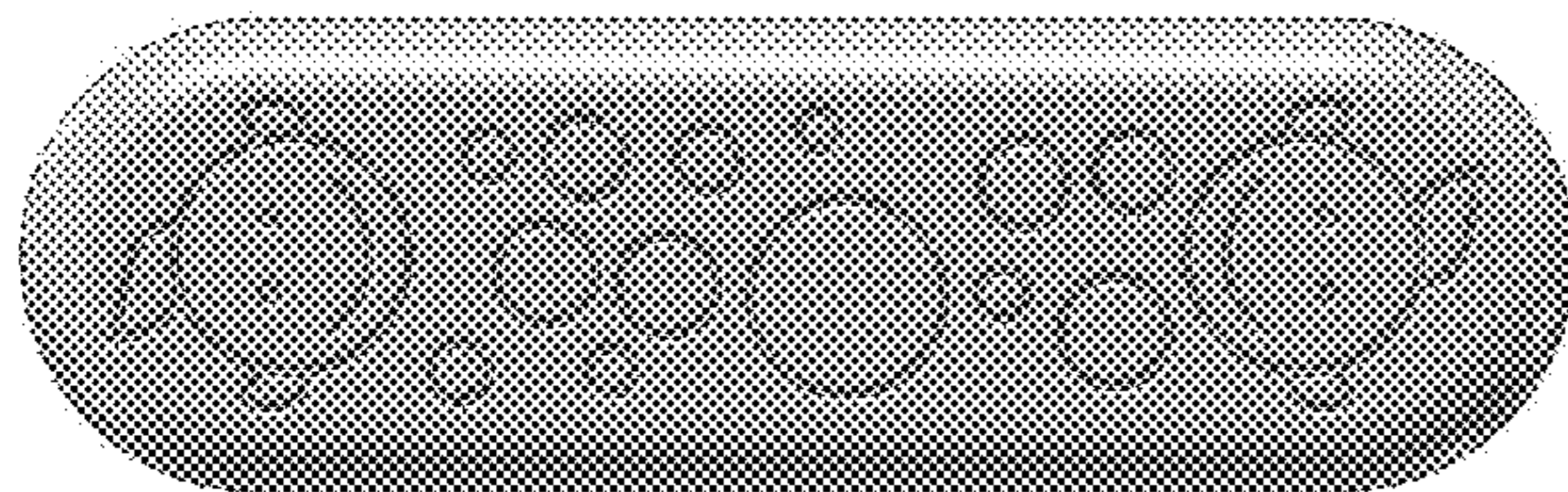
FIG. 4 is a right view of our new design for a cookie, the left view being a mirror image thereof.

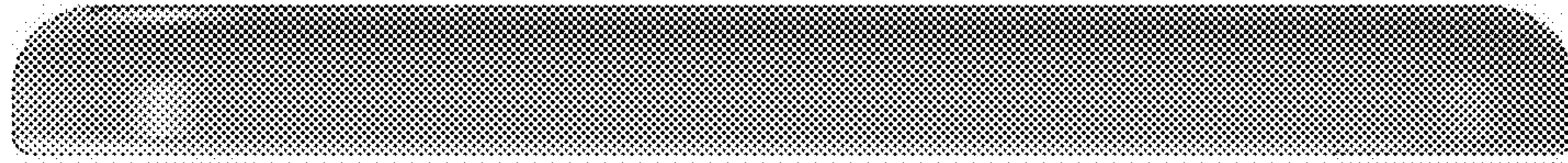

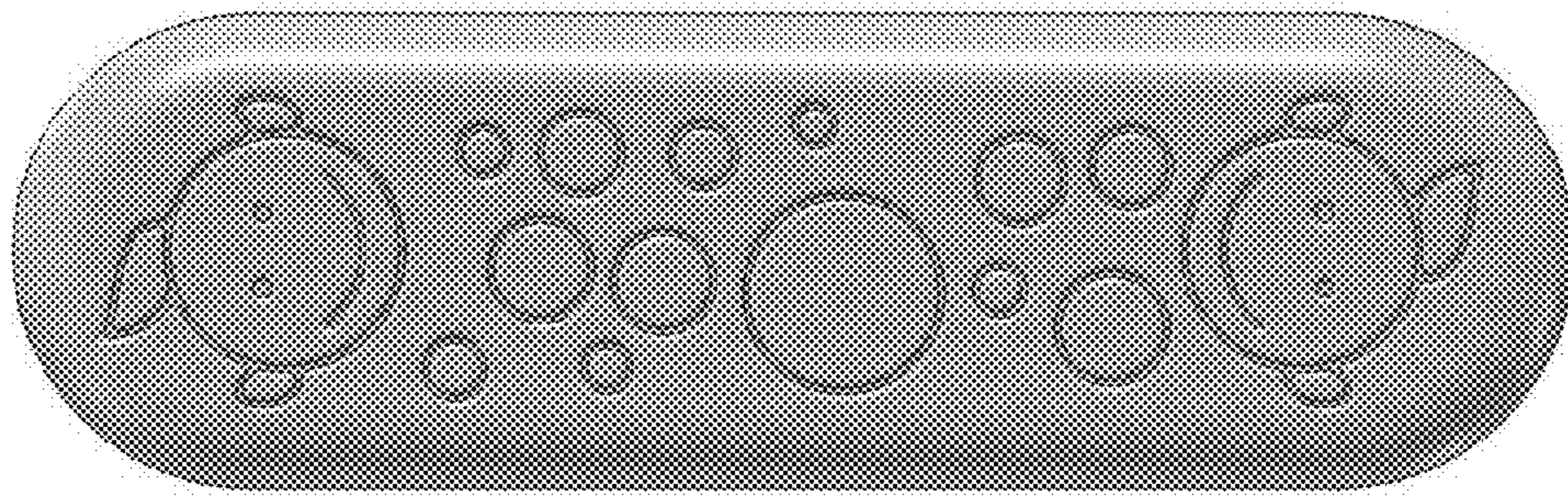

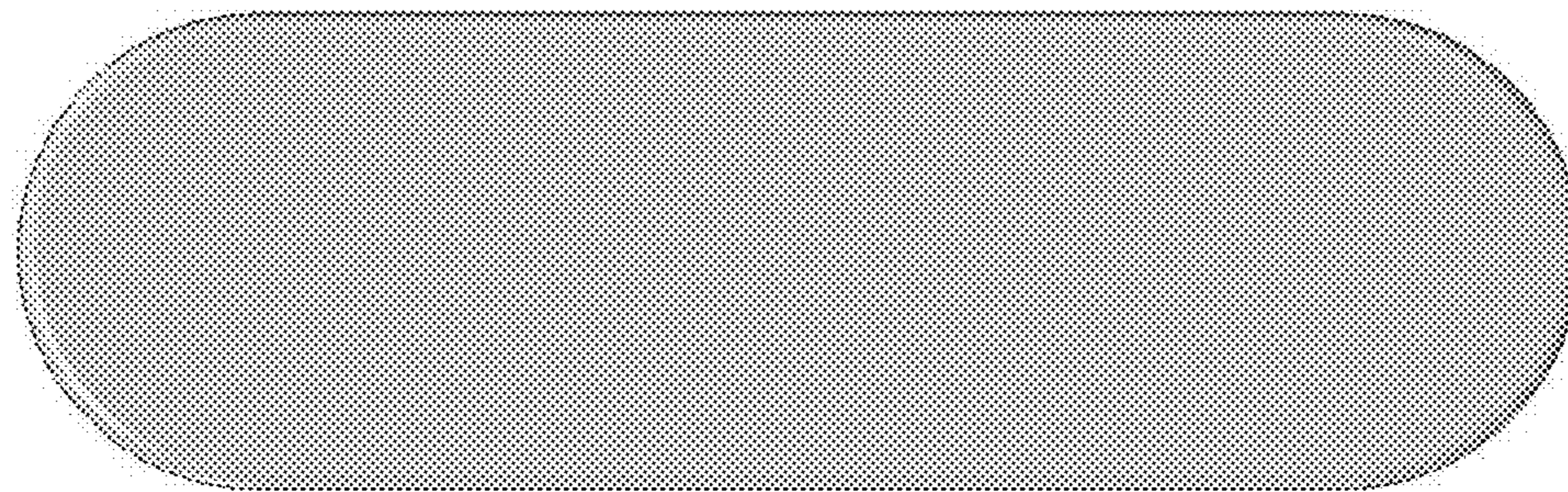

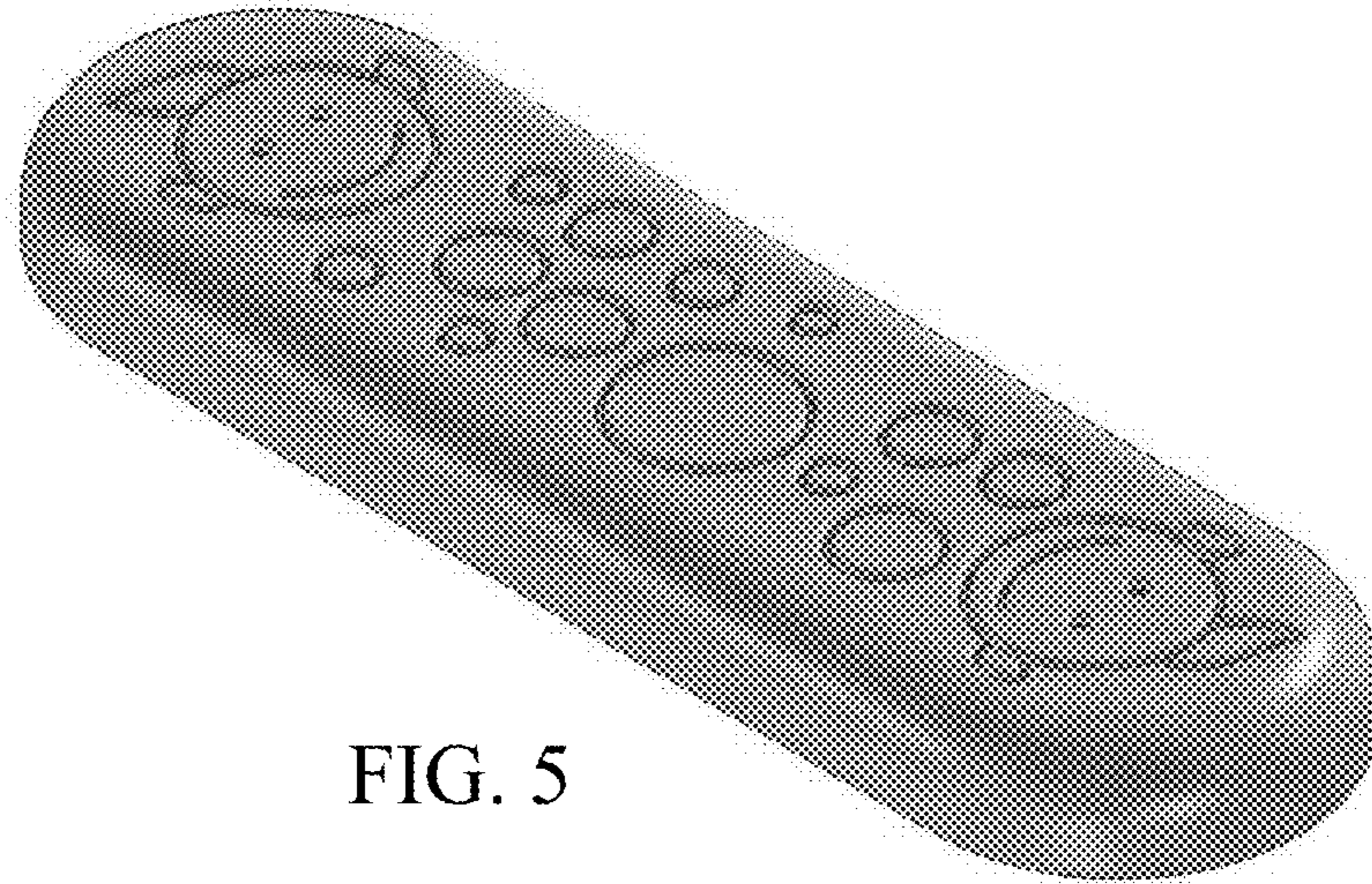

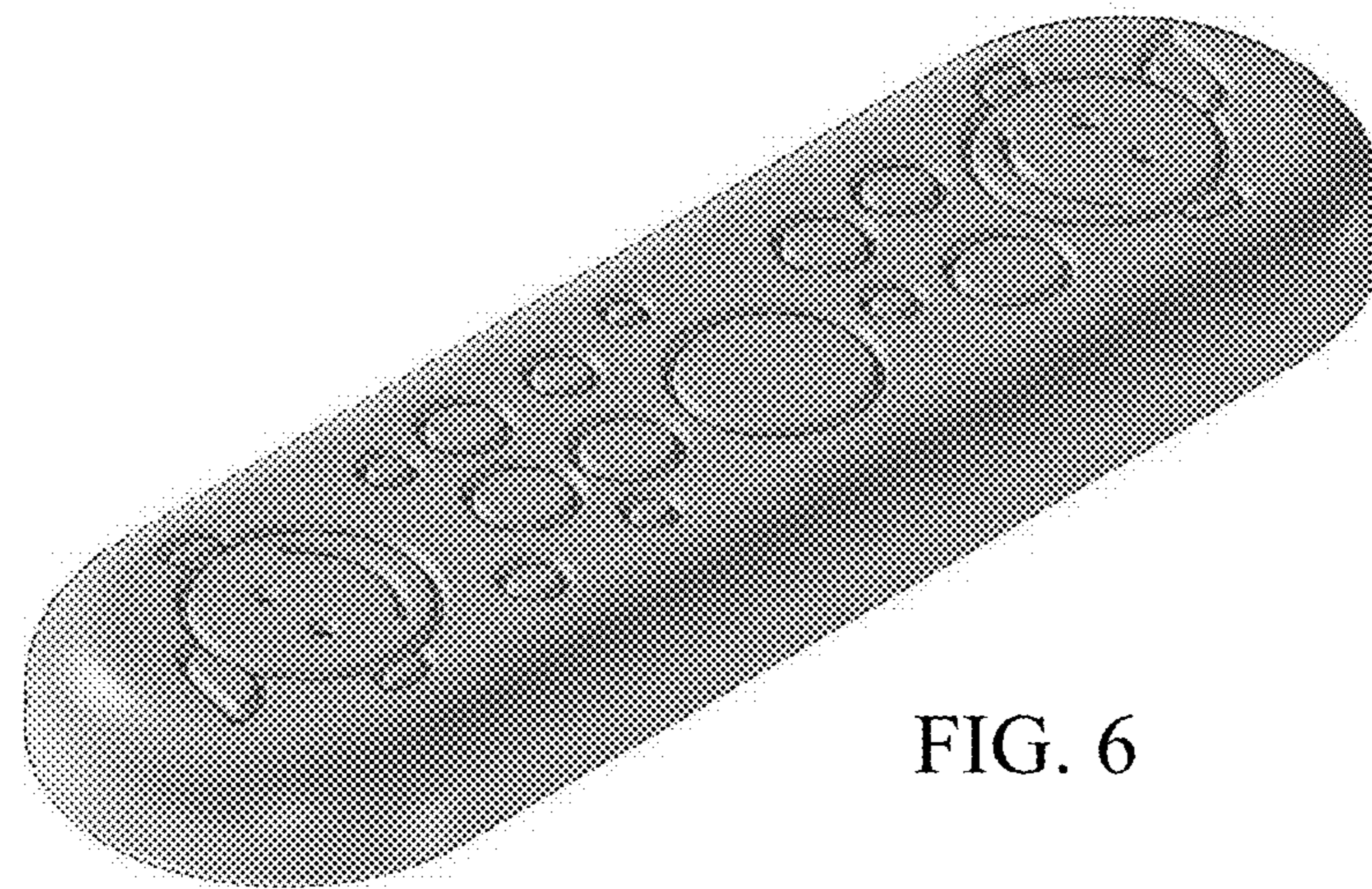

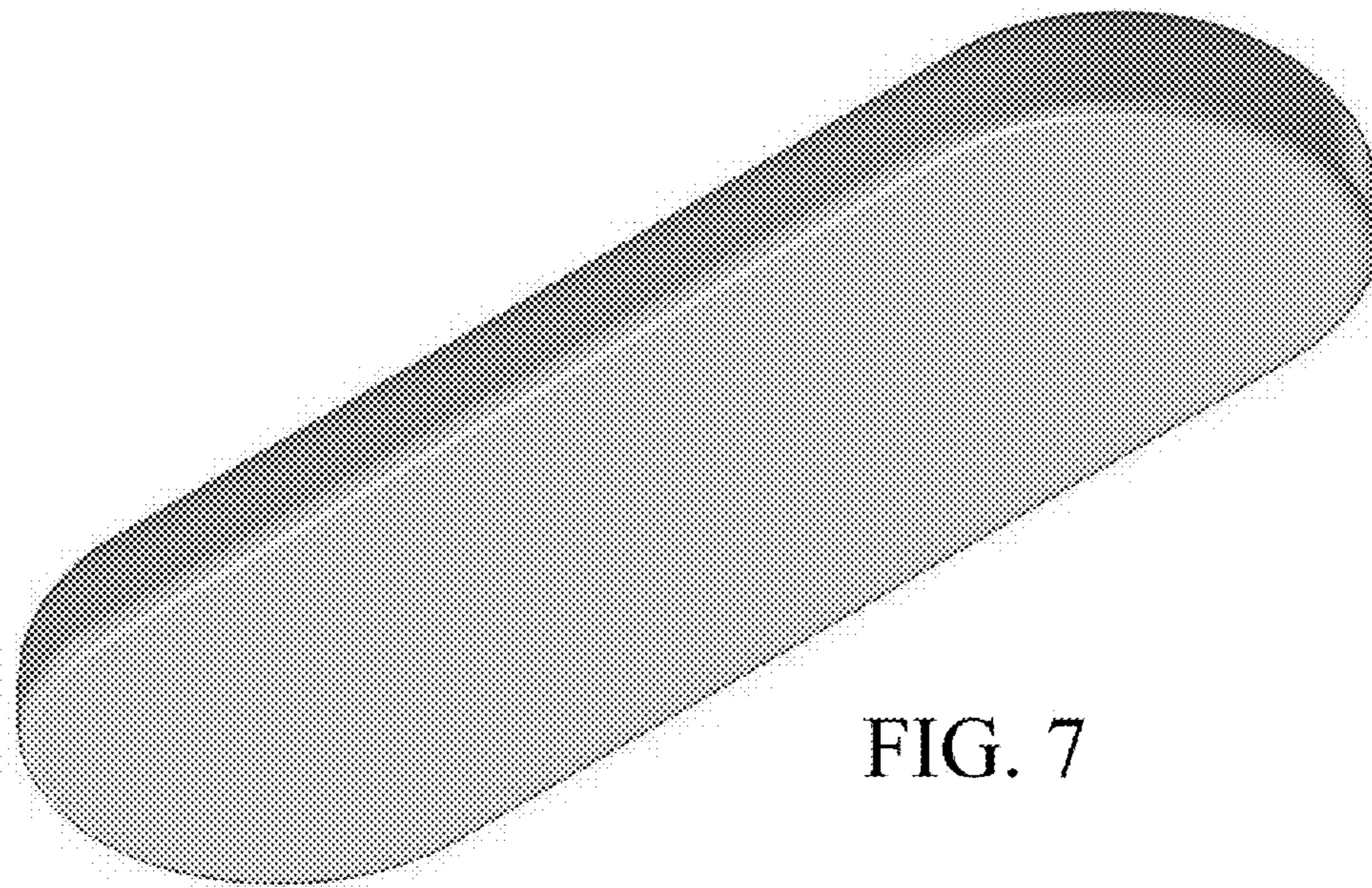
