The ornamental design for a combination baby poncho jacket, car seat cover, and shopping cart liner, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the subject design, taken from above;

FIG. 2 is a rear perspective view thereof, taken from below;

FIG. 3 is a left side view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side view thereof;

FIG. 9 is a perspective view of the subject design shown deployed as a shopping cart liner.

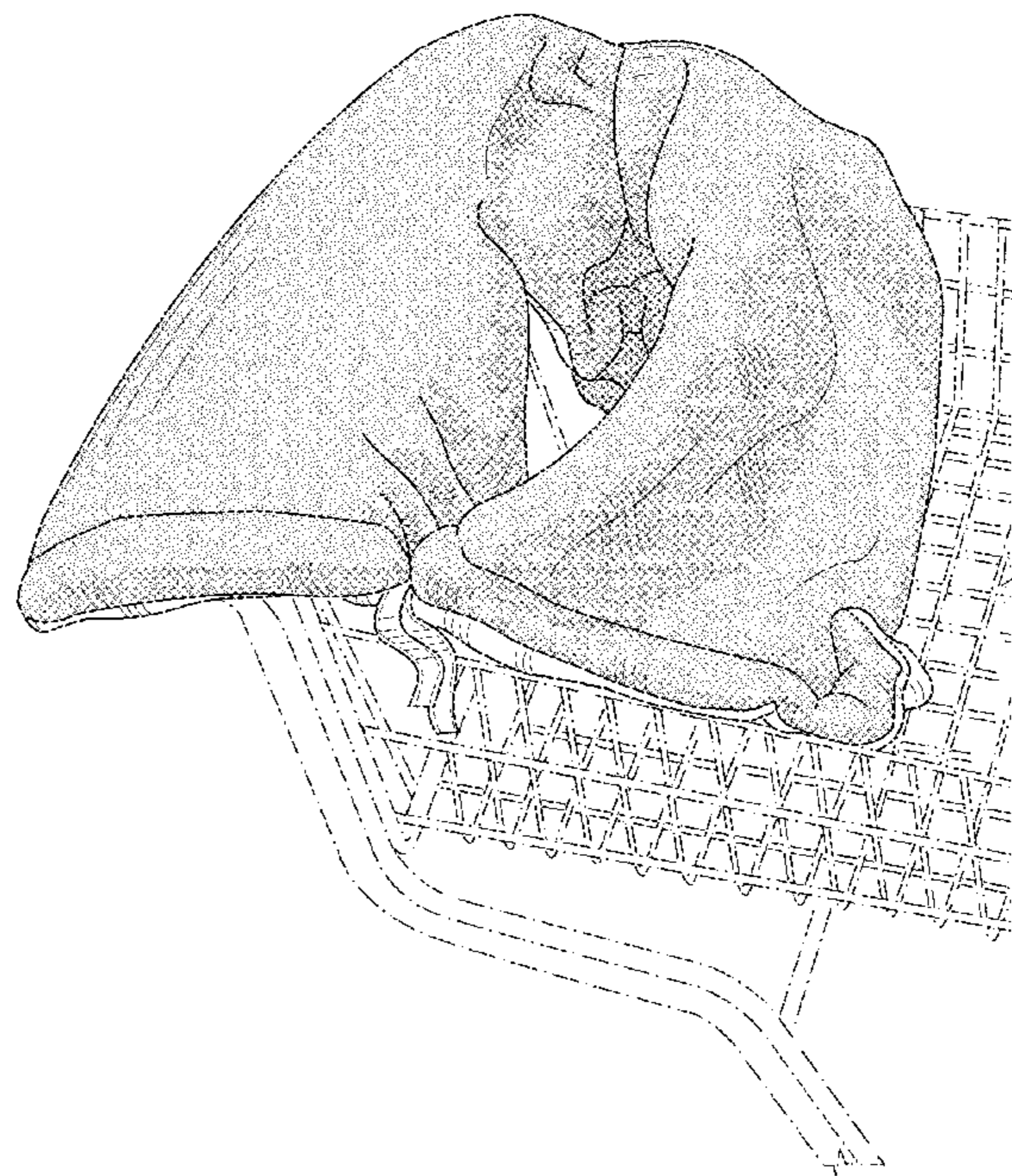
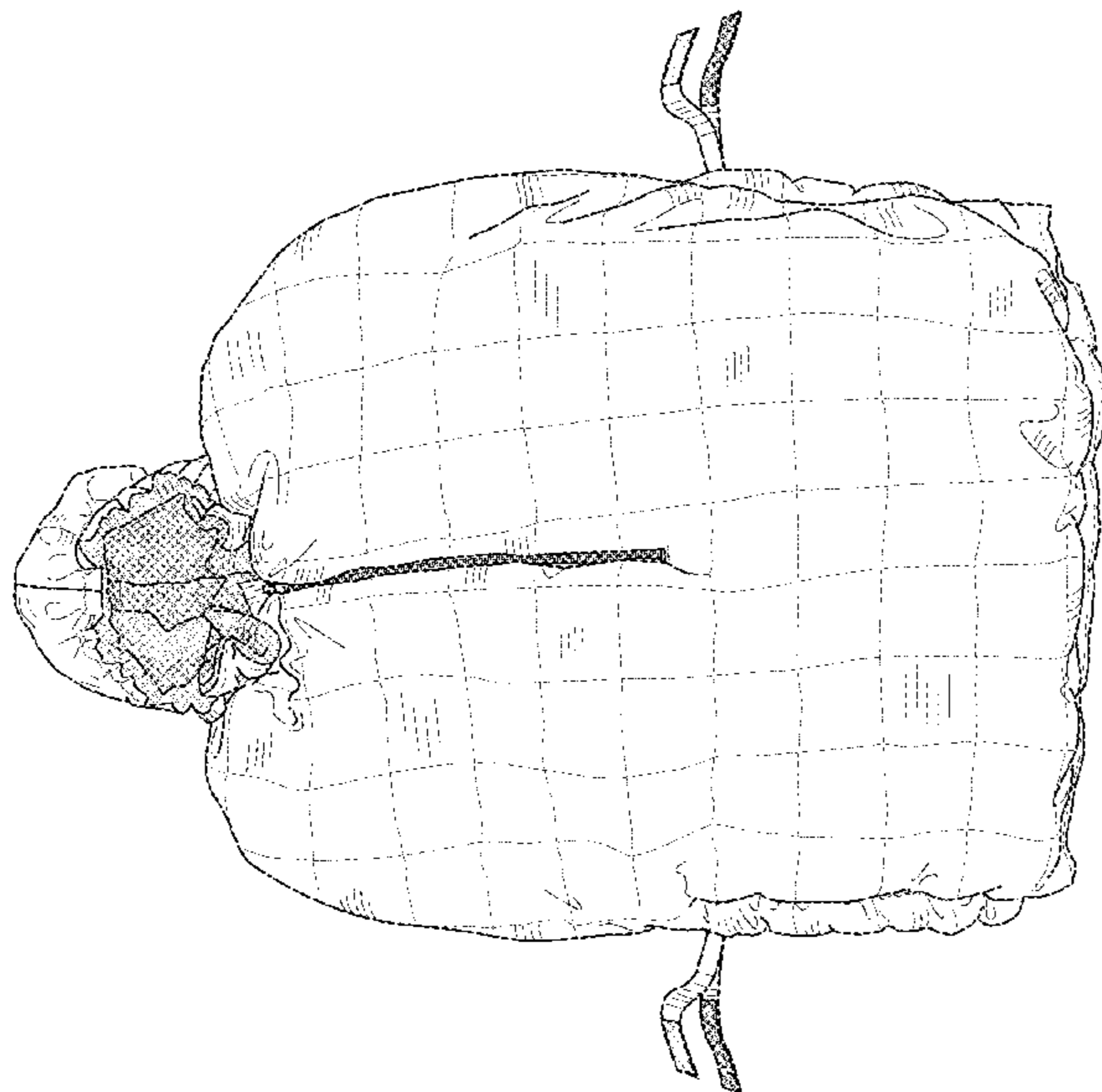

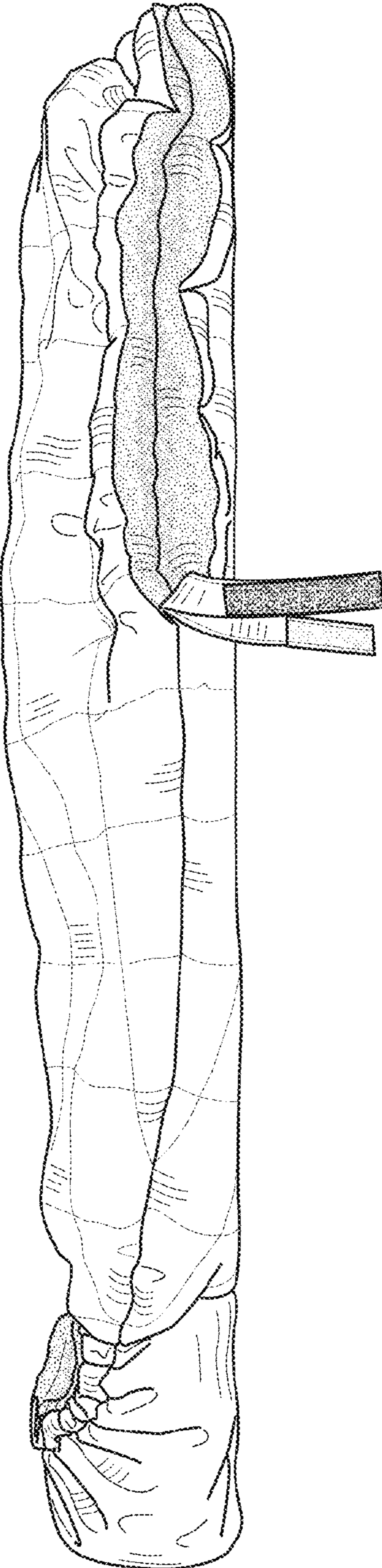

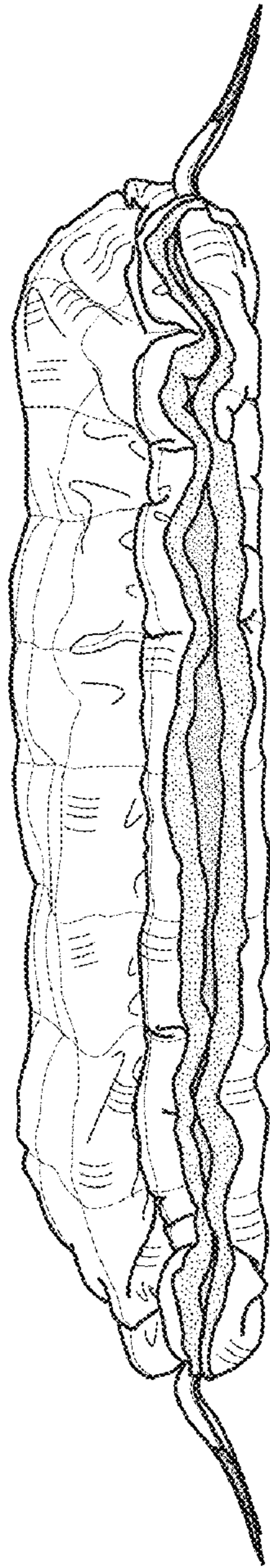

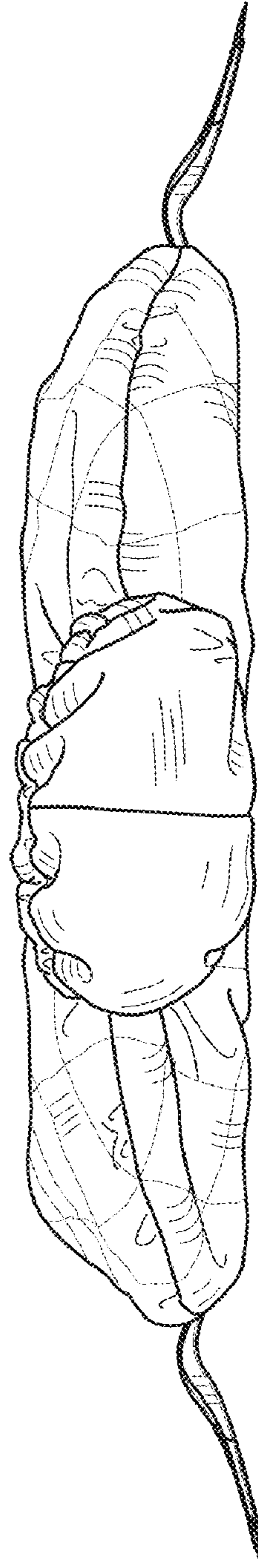

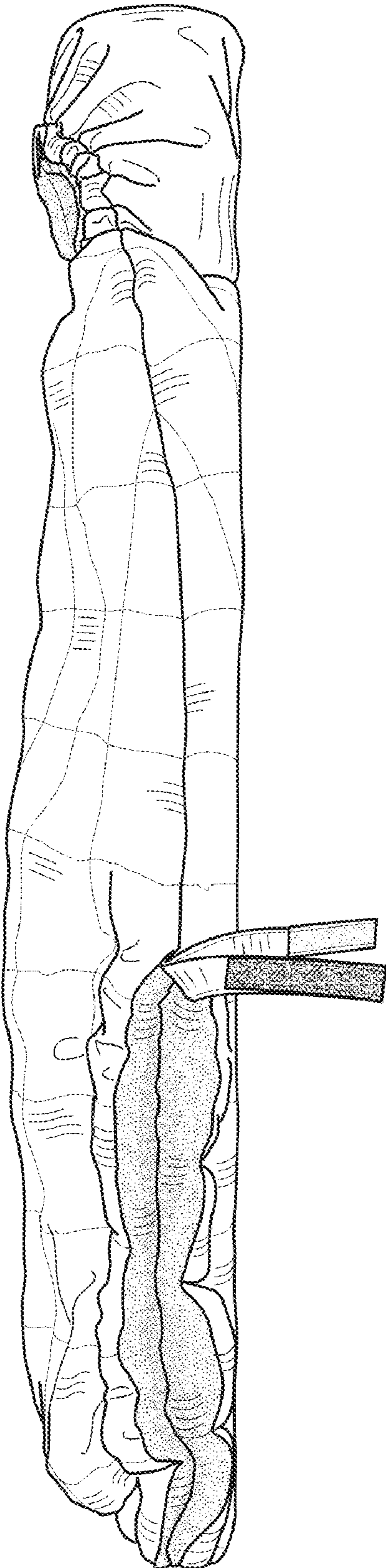

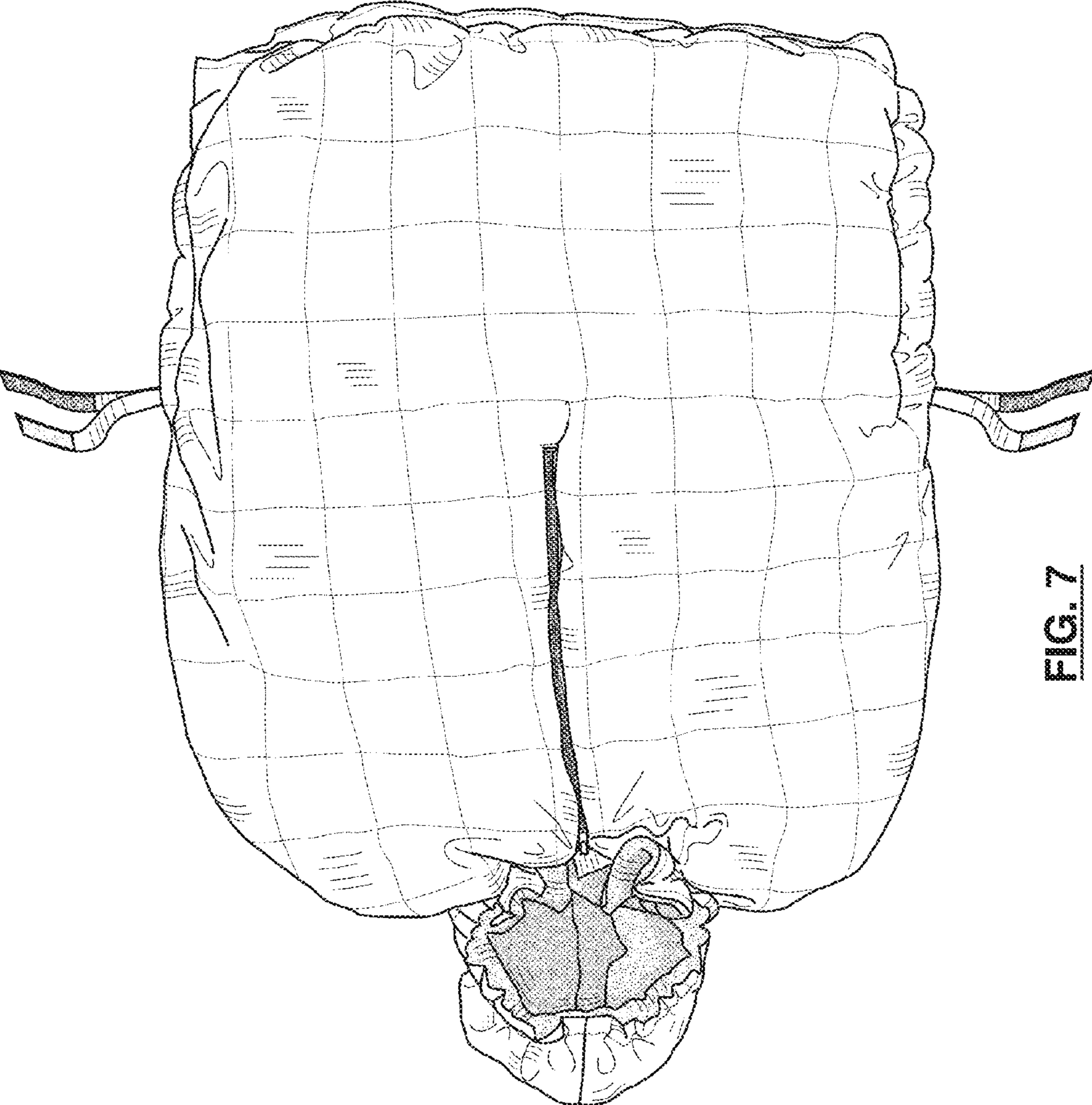

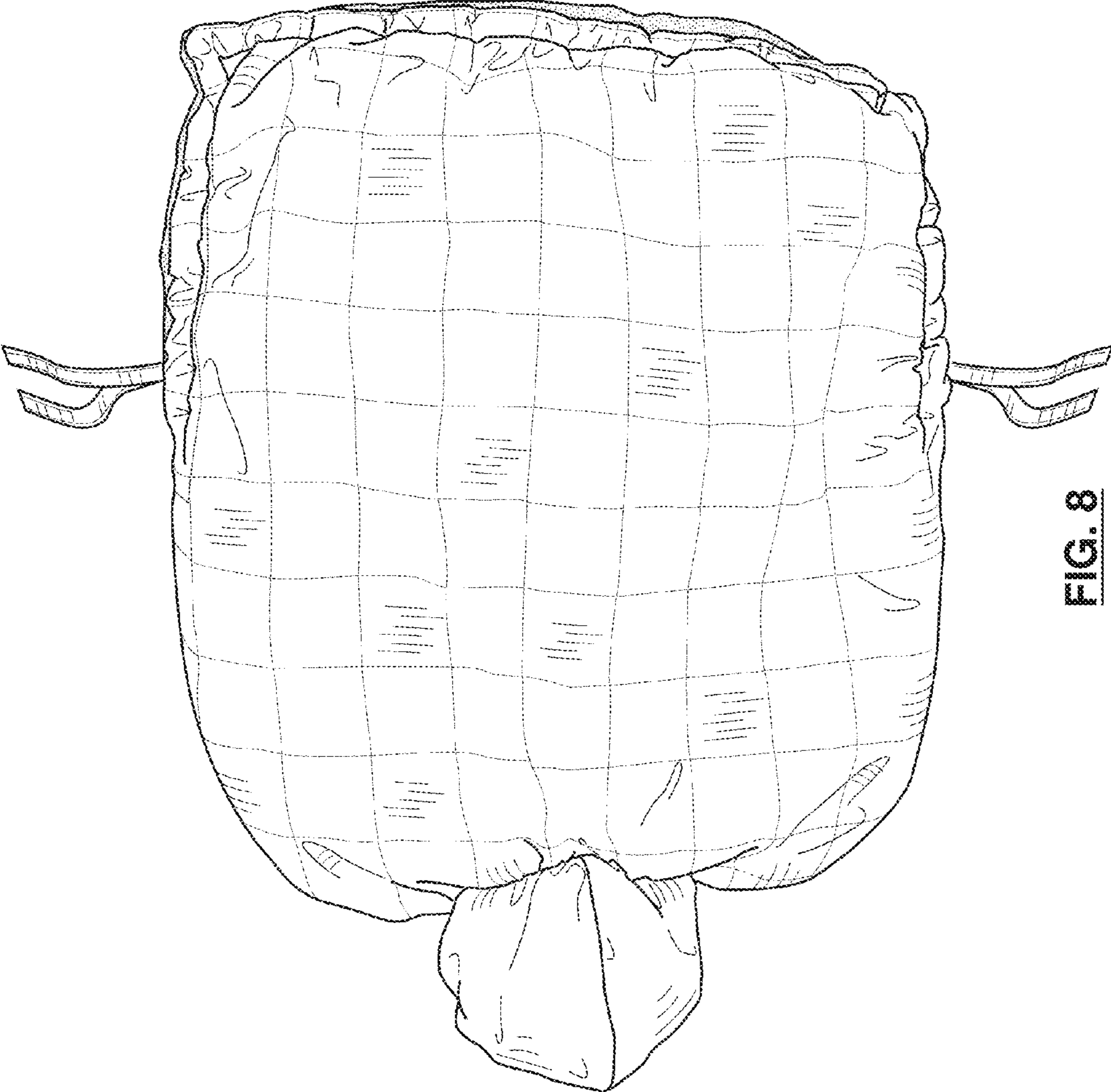

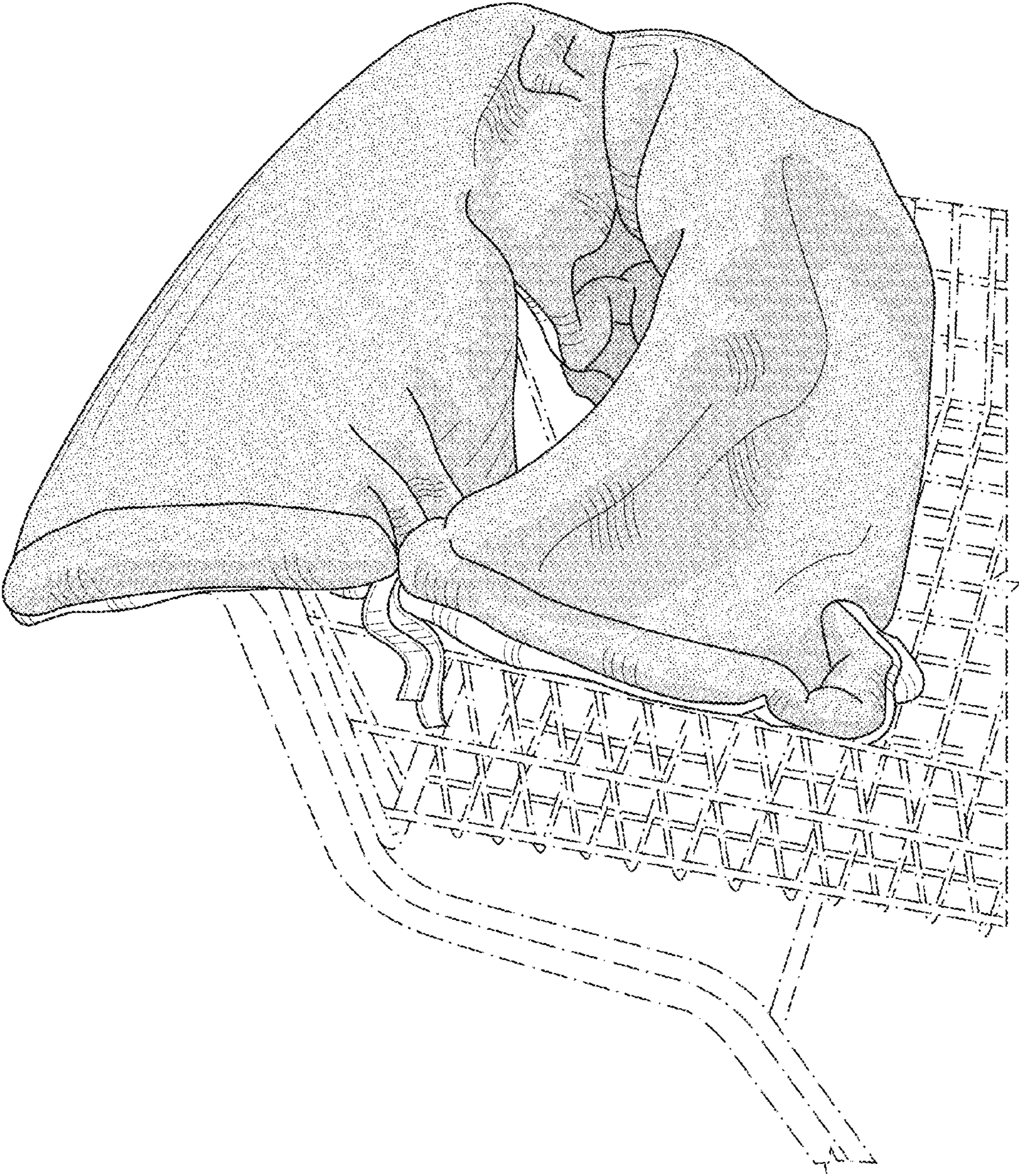
