(57) **CLAIM**

The ornamental design for a two-piece swimsuit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a two-piece swimsuit showing the new design.

FIG. 2 is a rear view thereof.

FIG. 3 is a right side view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a front view of a second embodiment of a two-piece swimsuit showing the new design.

FIG. 6 is a rear view thereof.

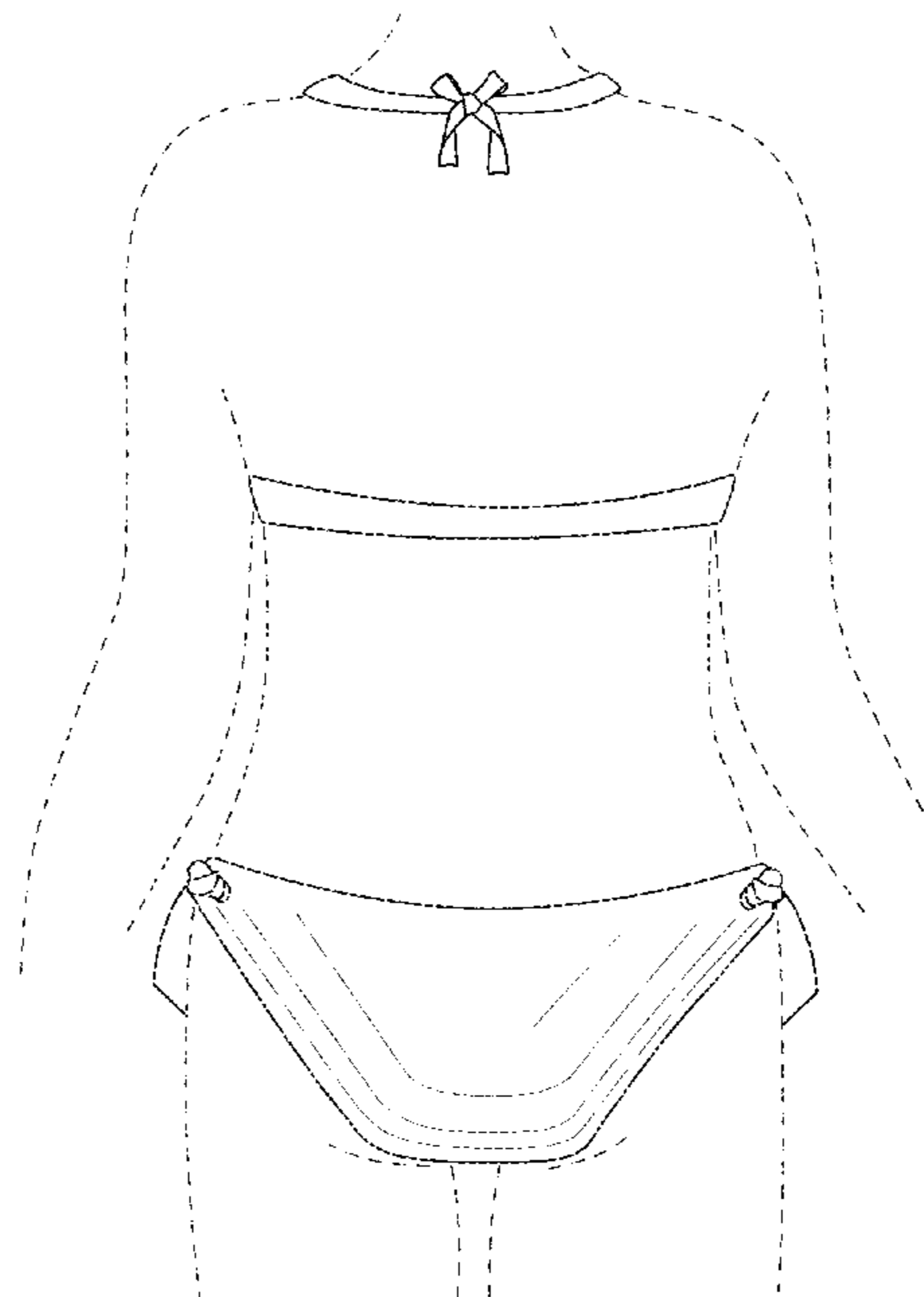
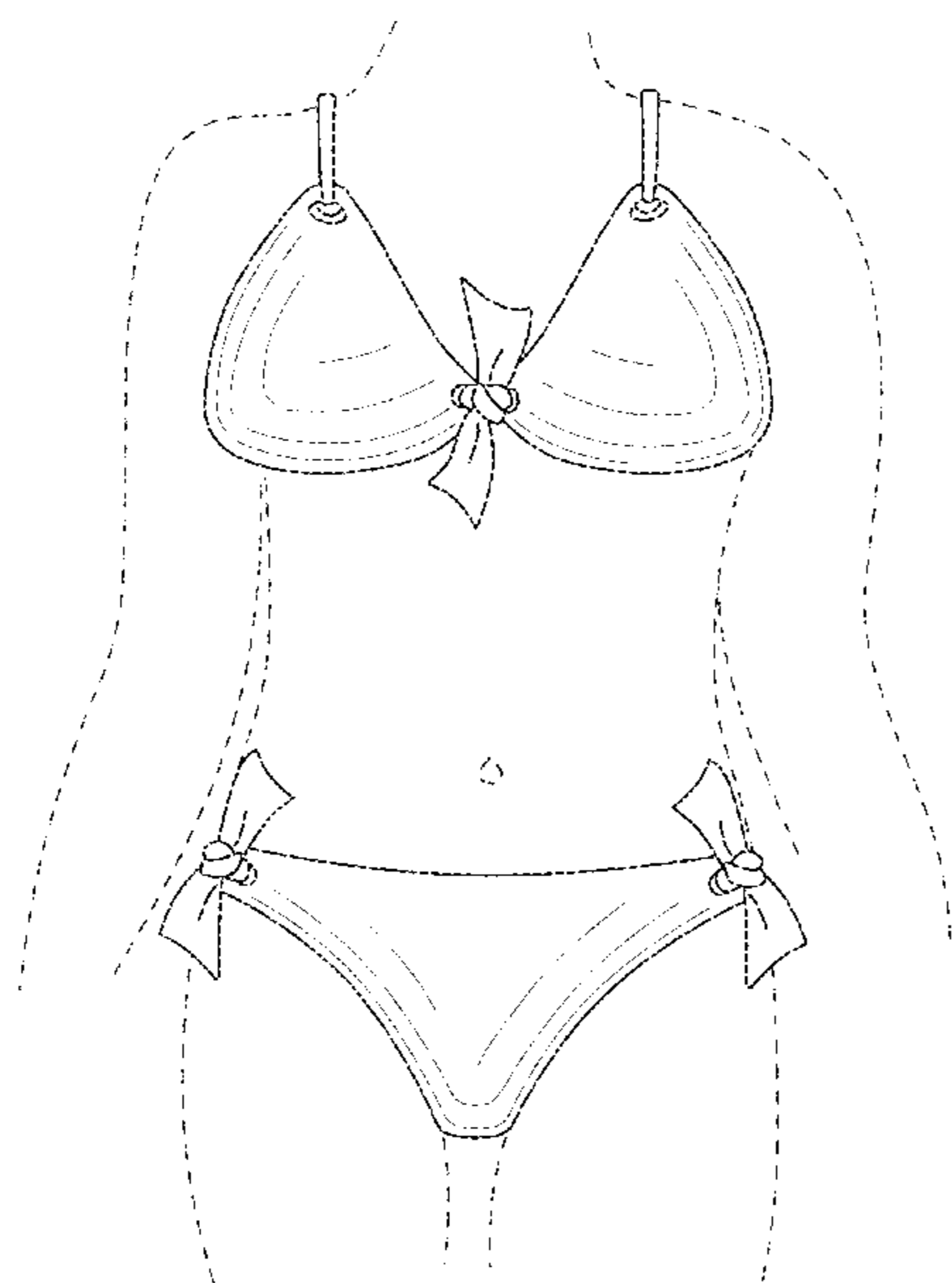
FIG. 7 is a right side view thereof; and,

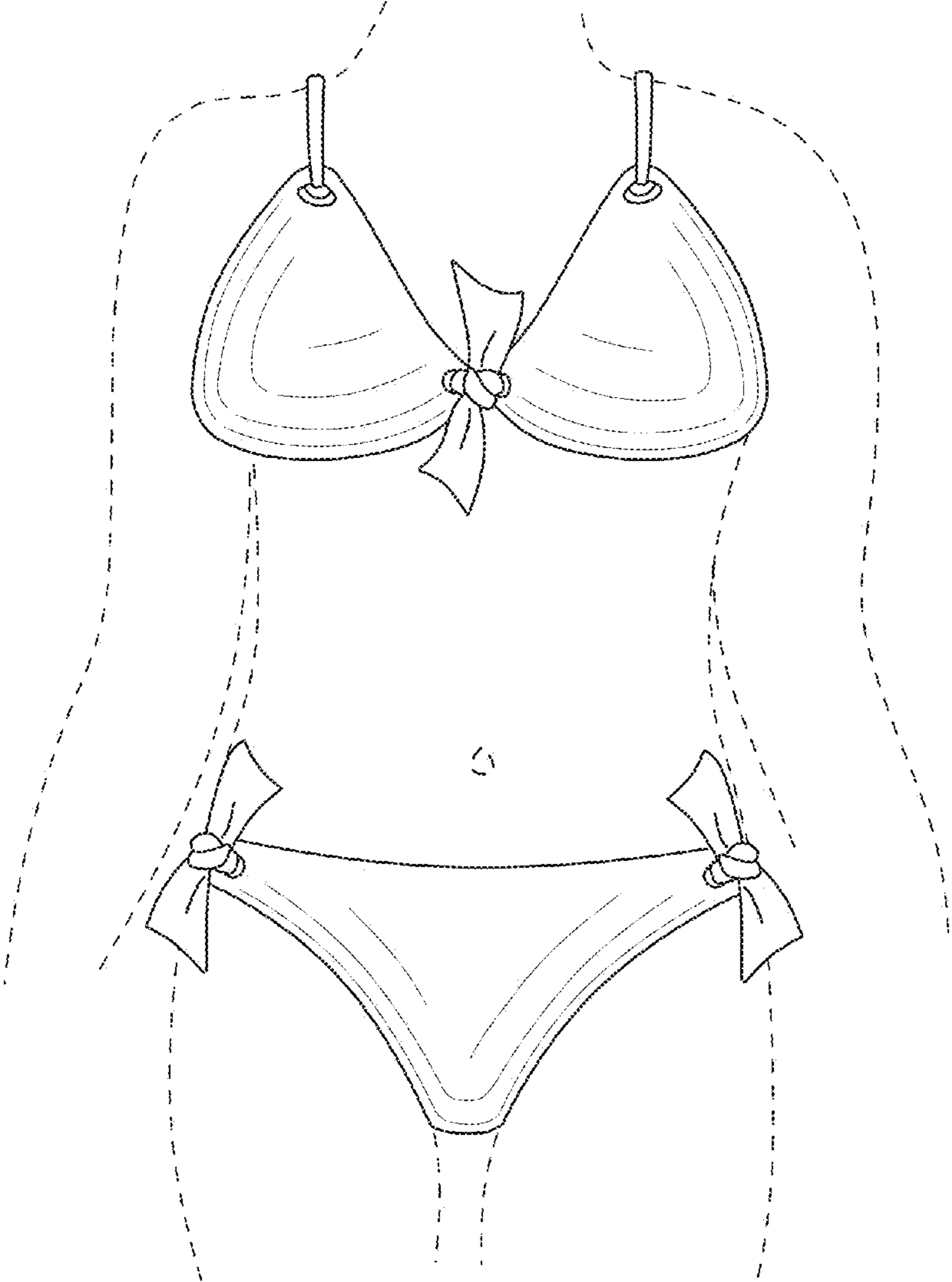

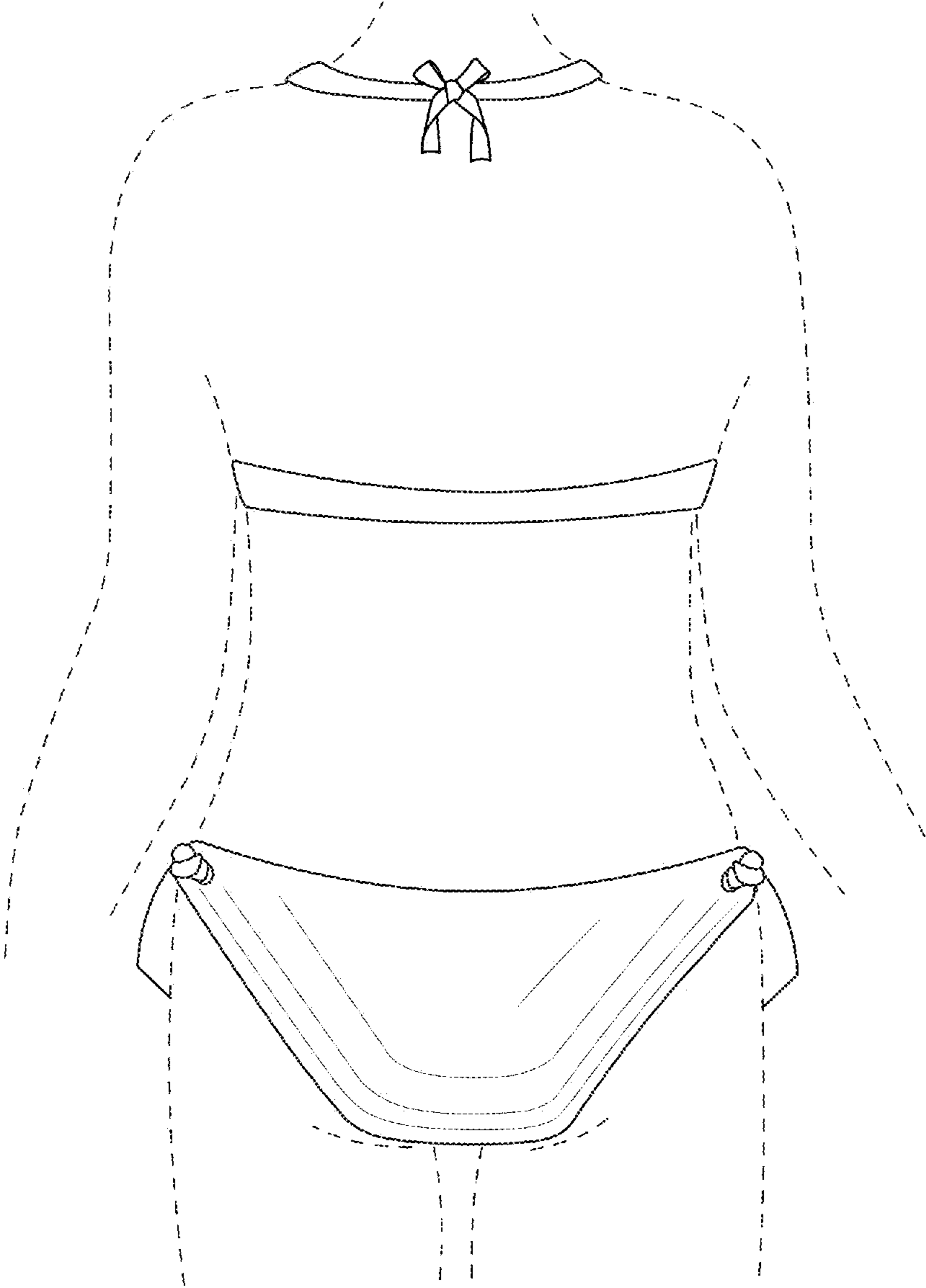

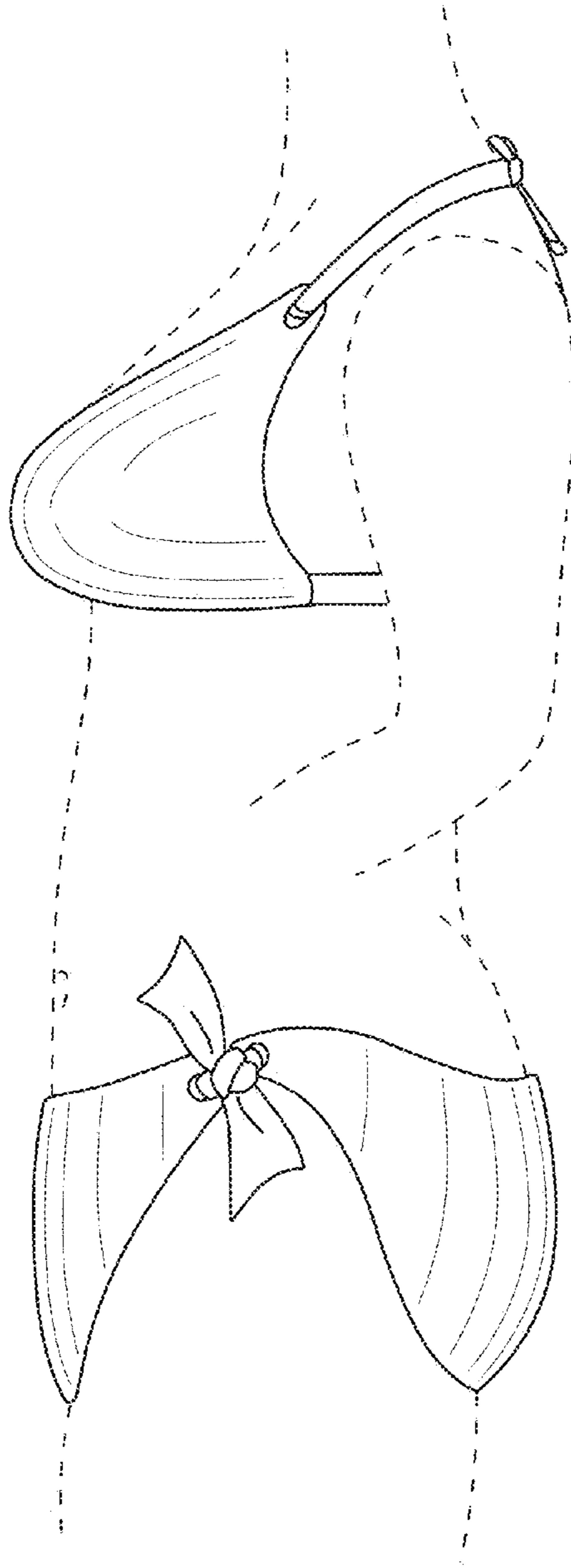

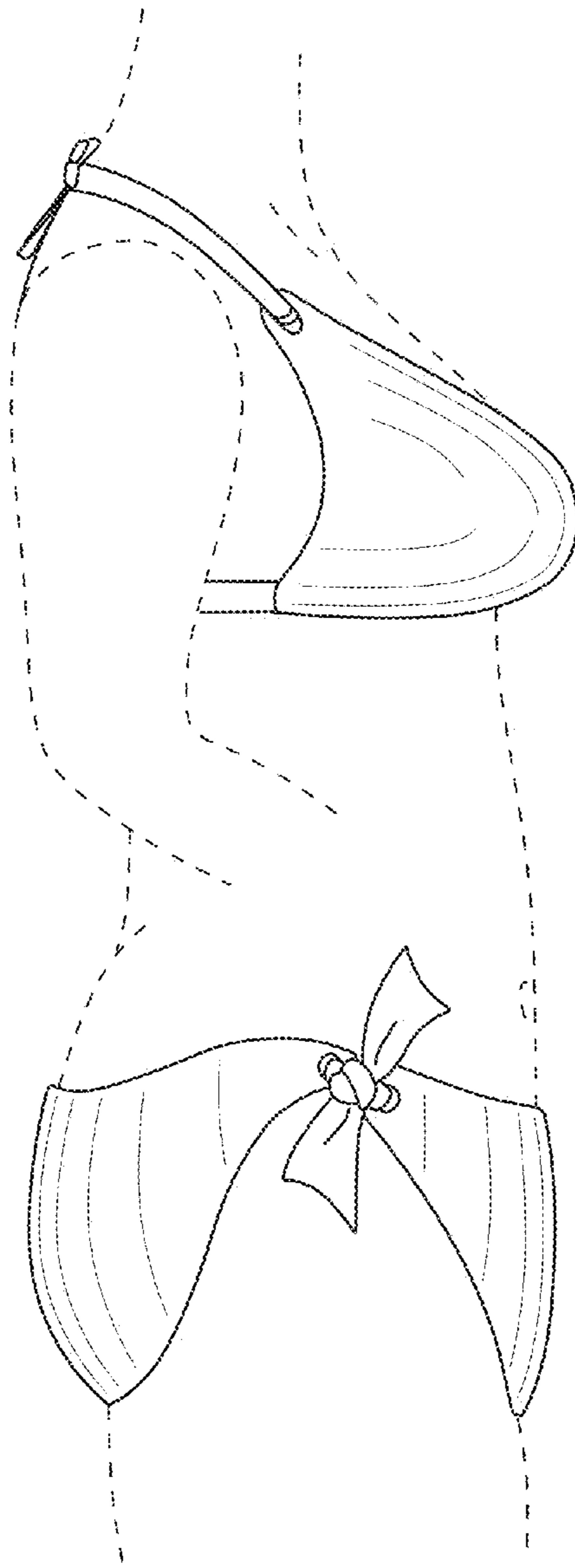

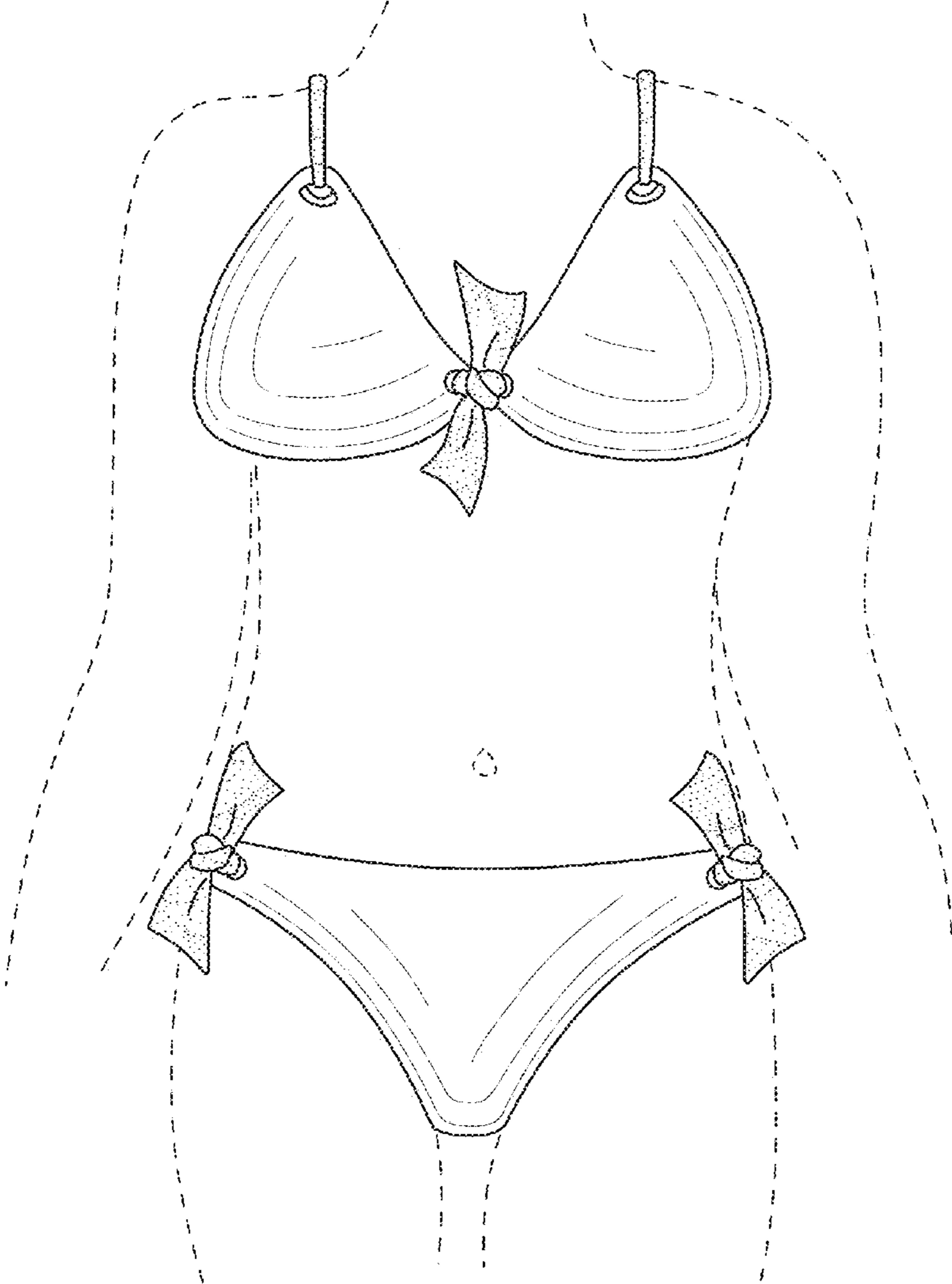

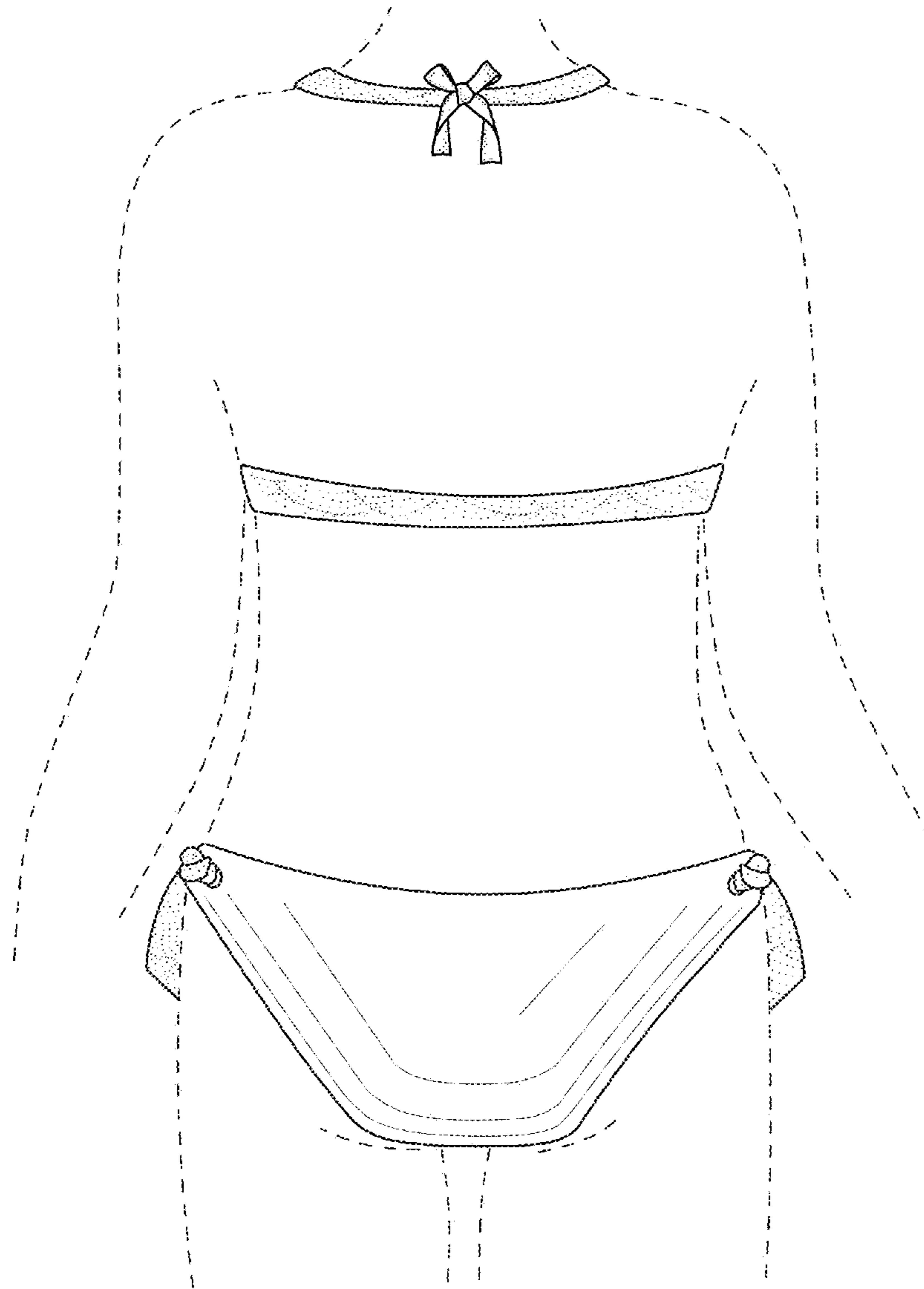

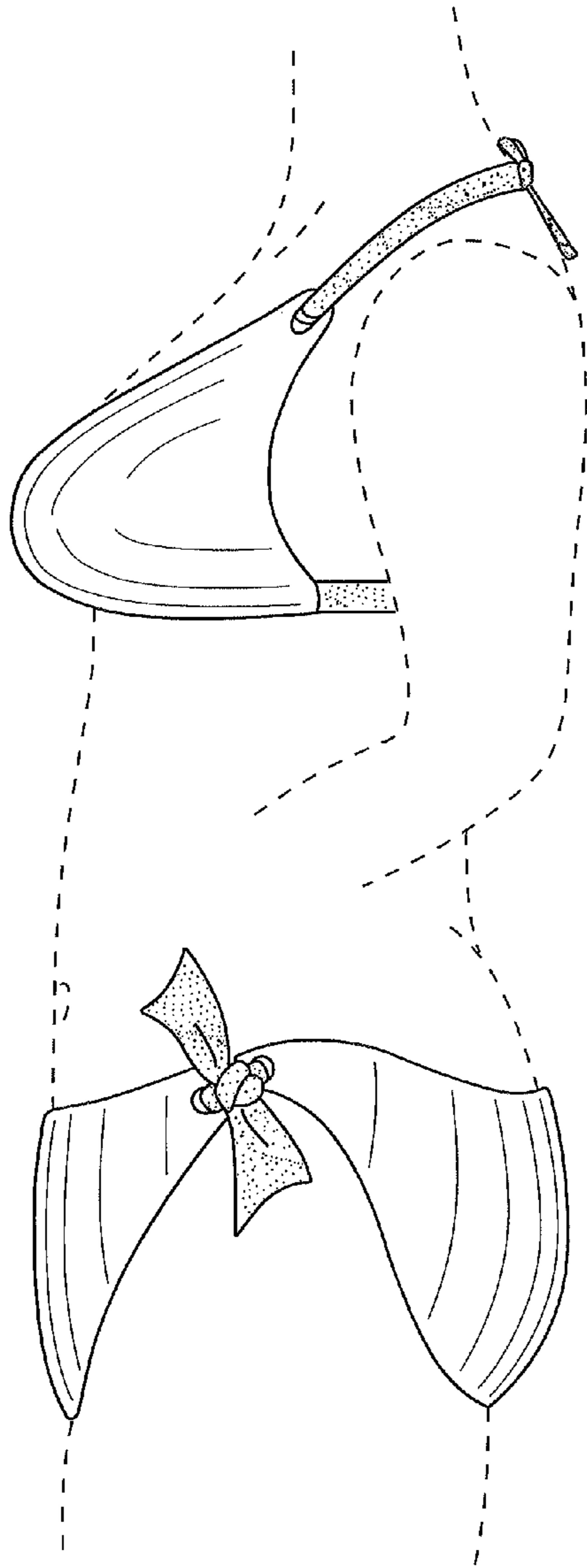

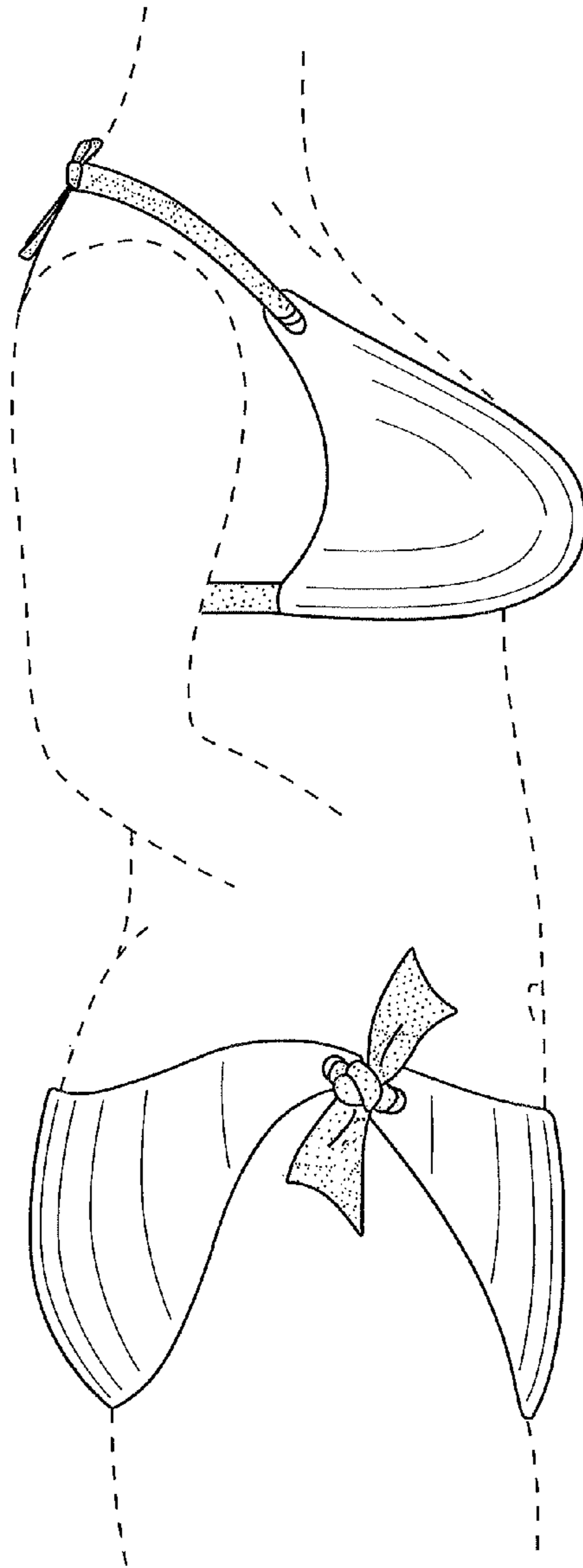
