The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front lateral perspective view of a shoe upper embodying my new design.

FIG. 2 is a front medial perspective view thereof;

FIG. 3 is a rear lateral perspective view thereof; and,

FIG. 4 is a rear medial perspective view thereof.

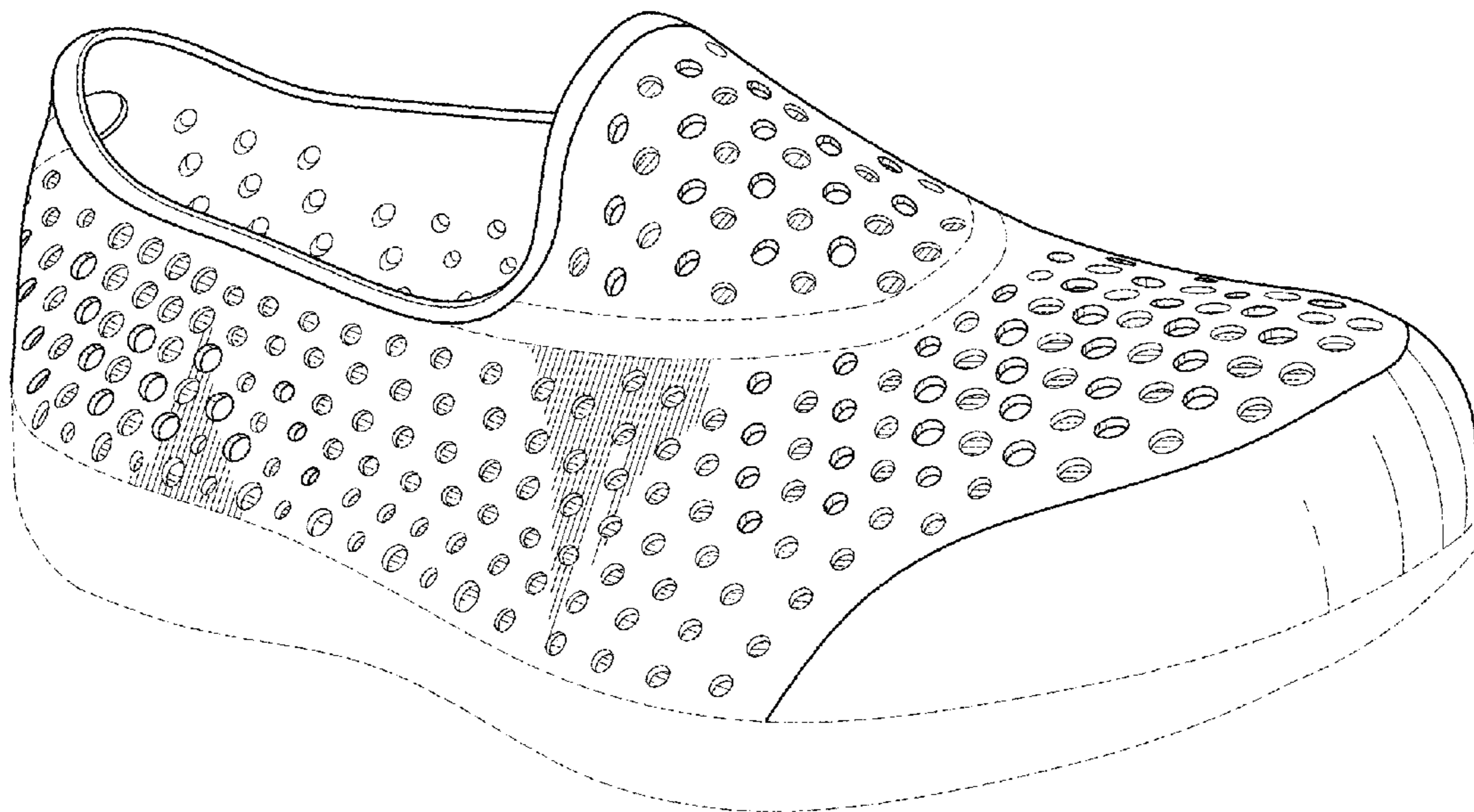
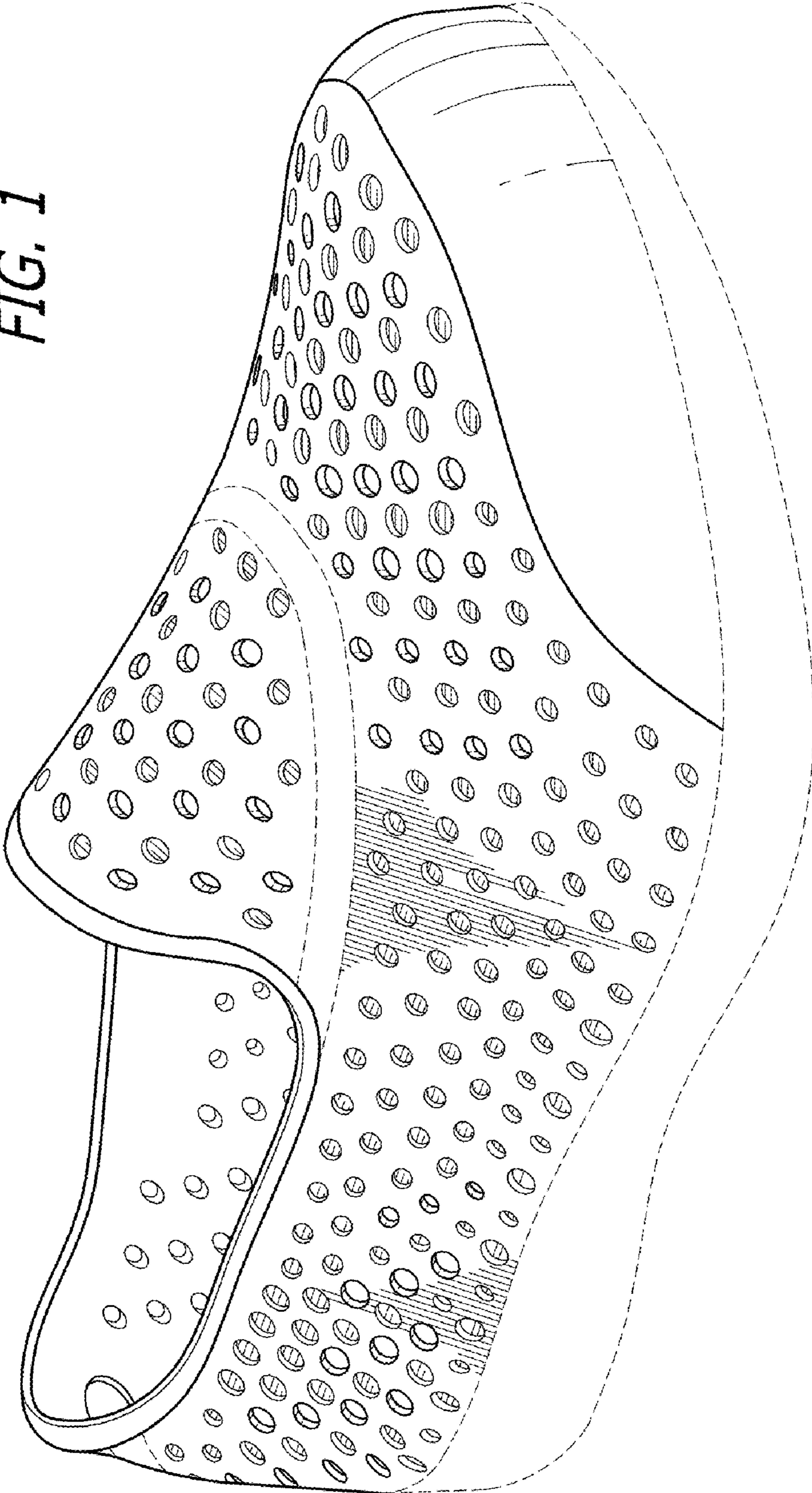

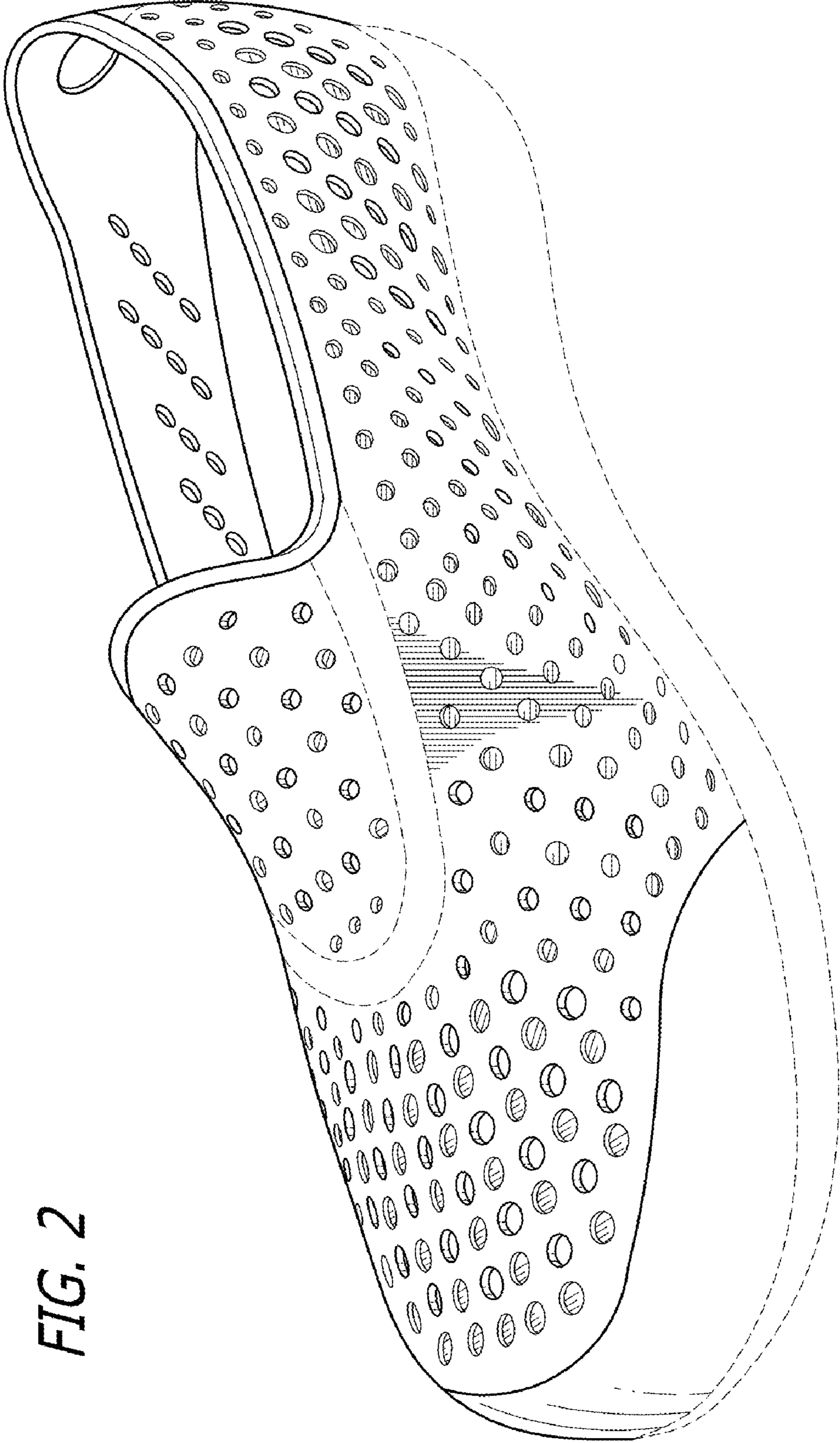

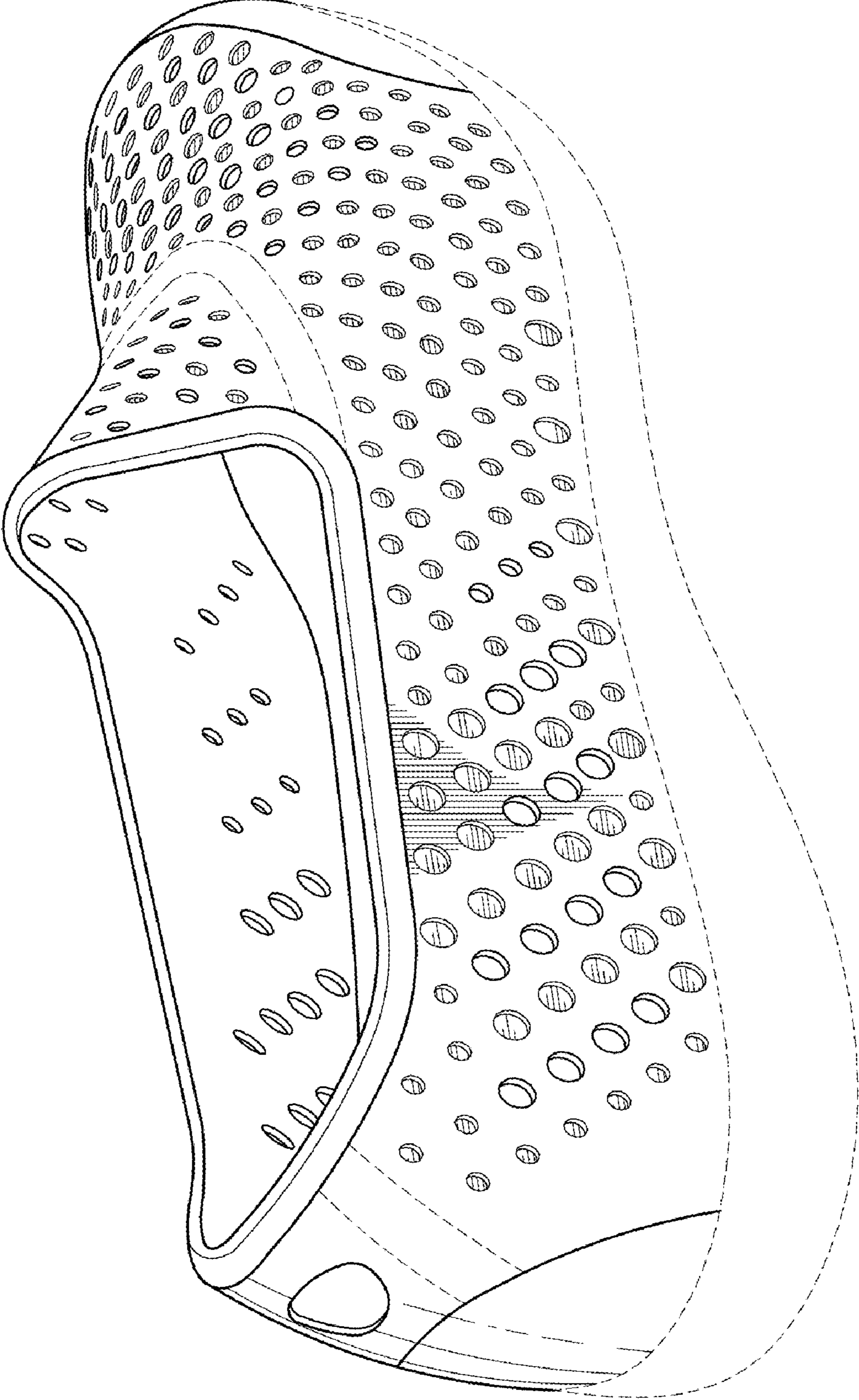
