FIG. 12 is a front elevation view of FIG. 11.

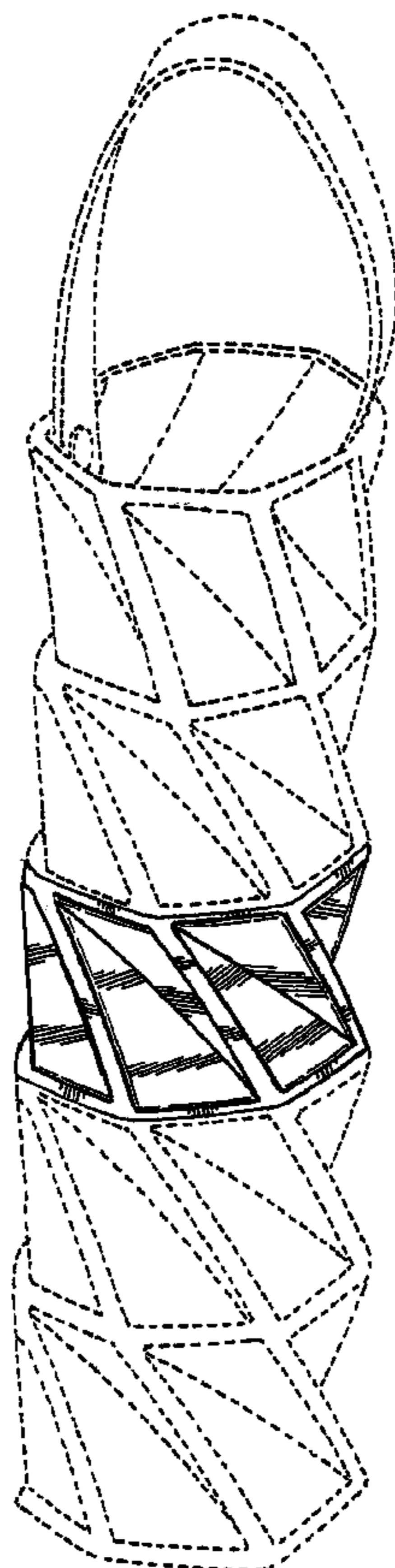
FIG. 13 is right side elevation view of FIG. 11.

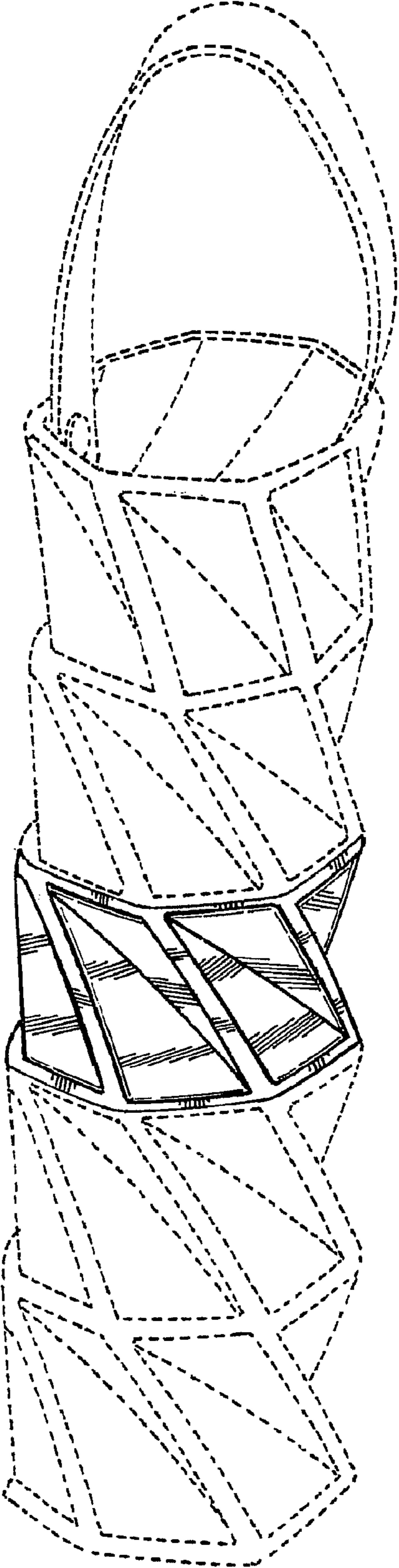
FIG. 14 is a top plan view of FIG. 11; and,

FIG. 15 is a bottom plan view of FIG. 11.

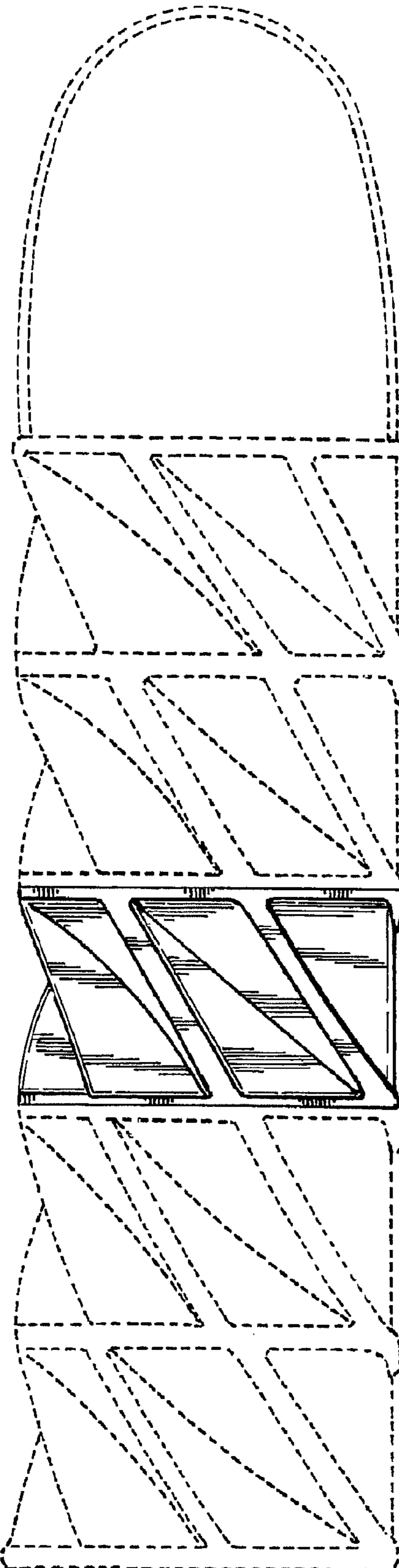

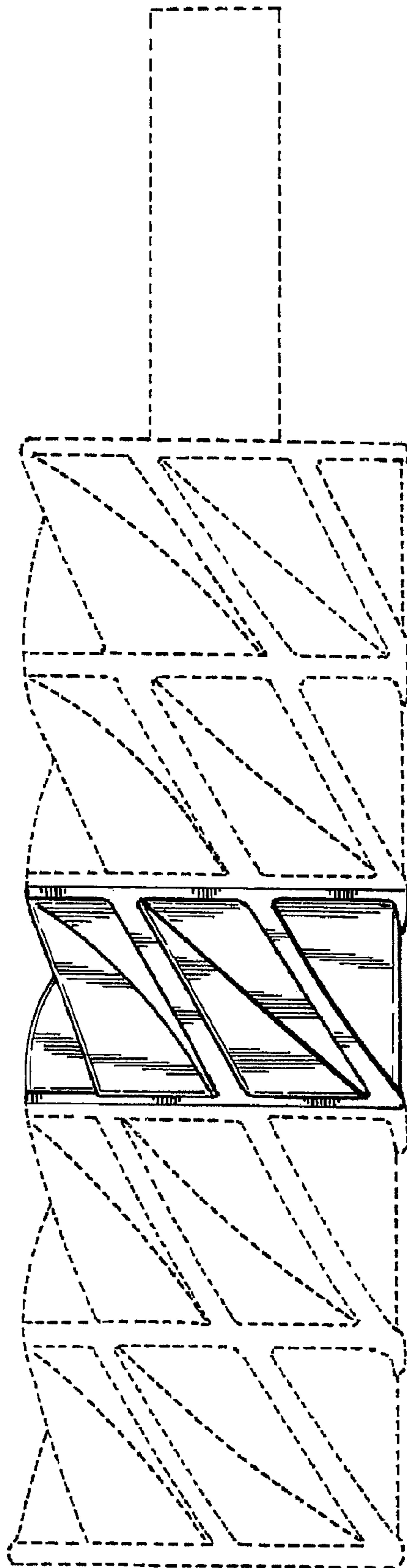




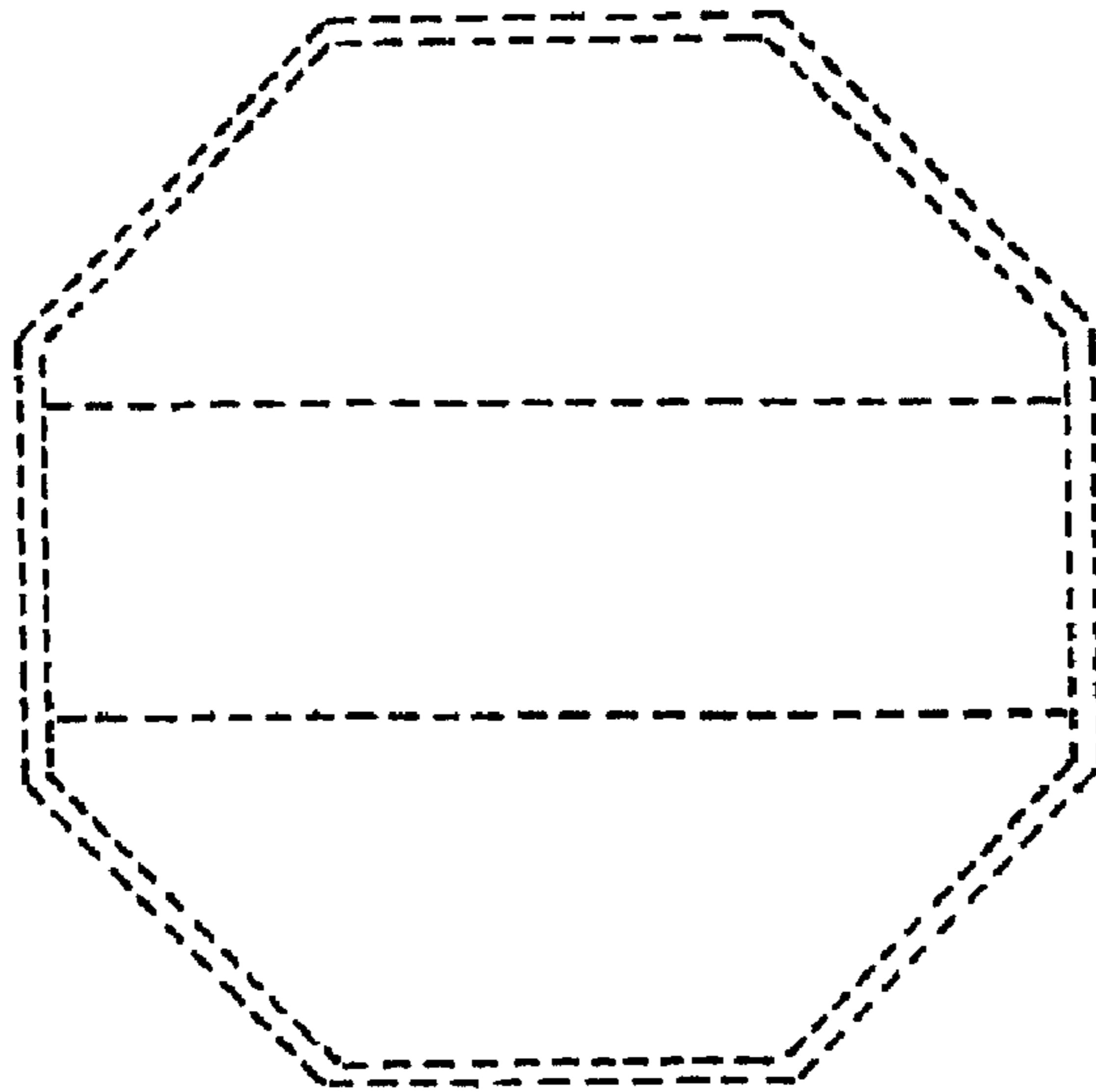

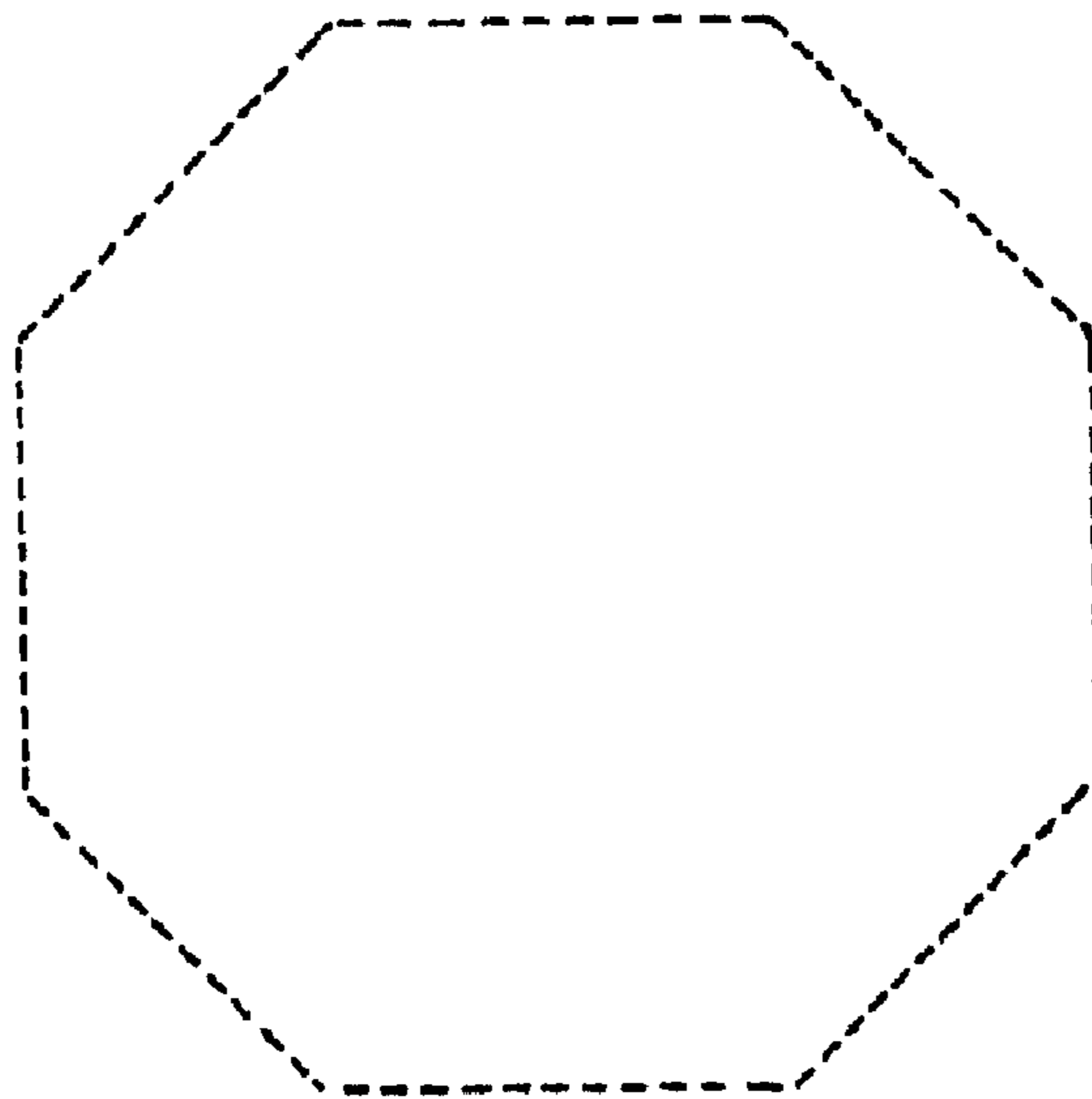

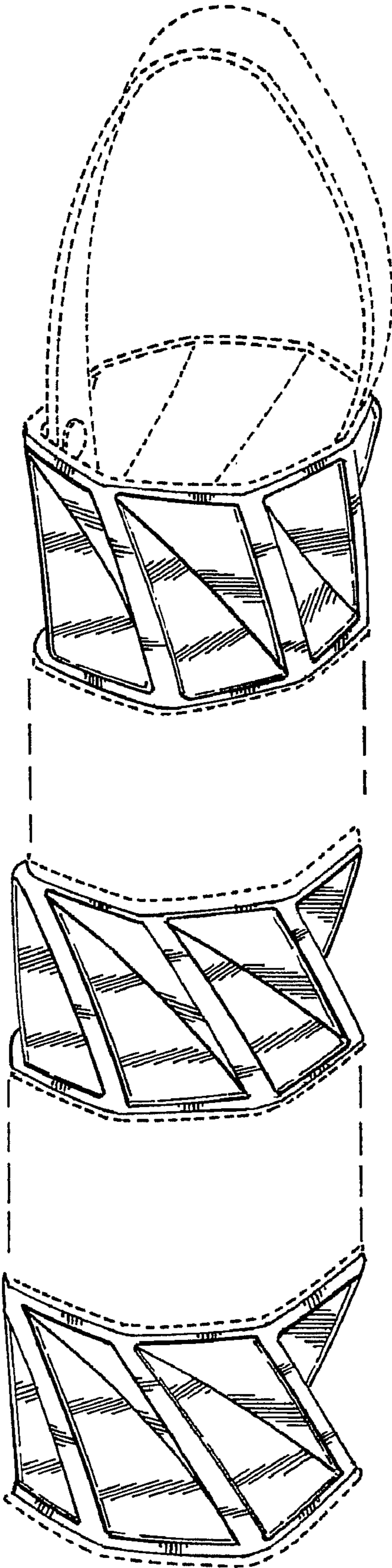

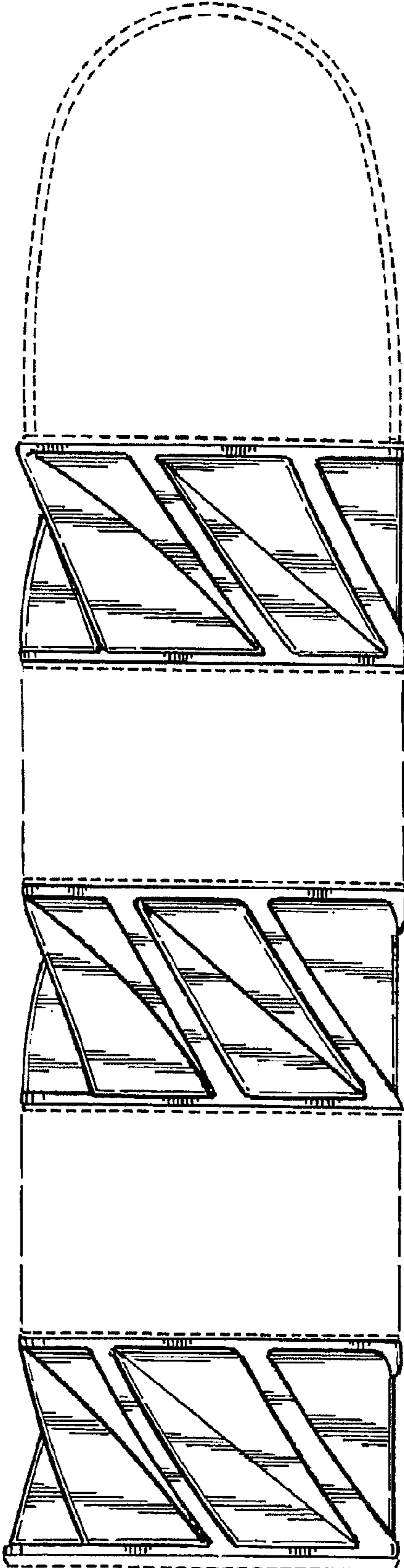

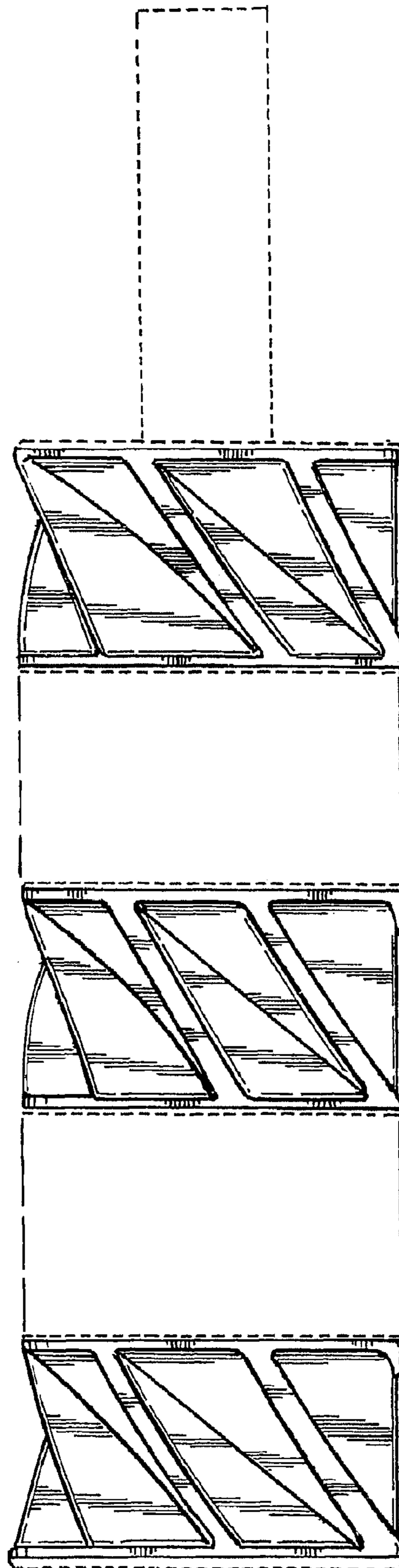

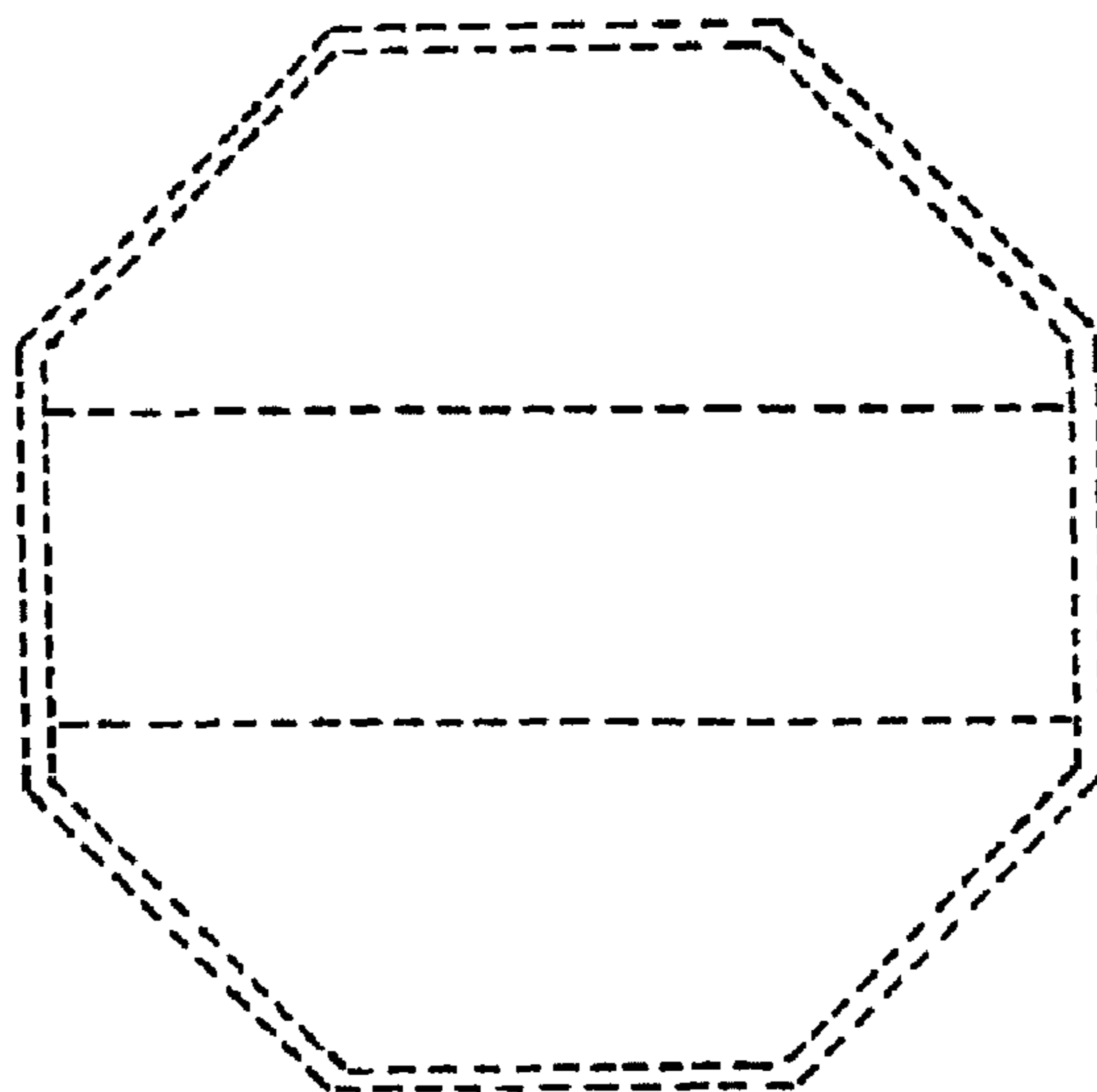

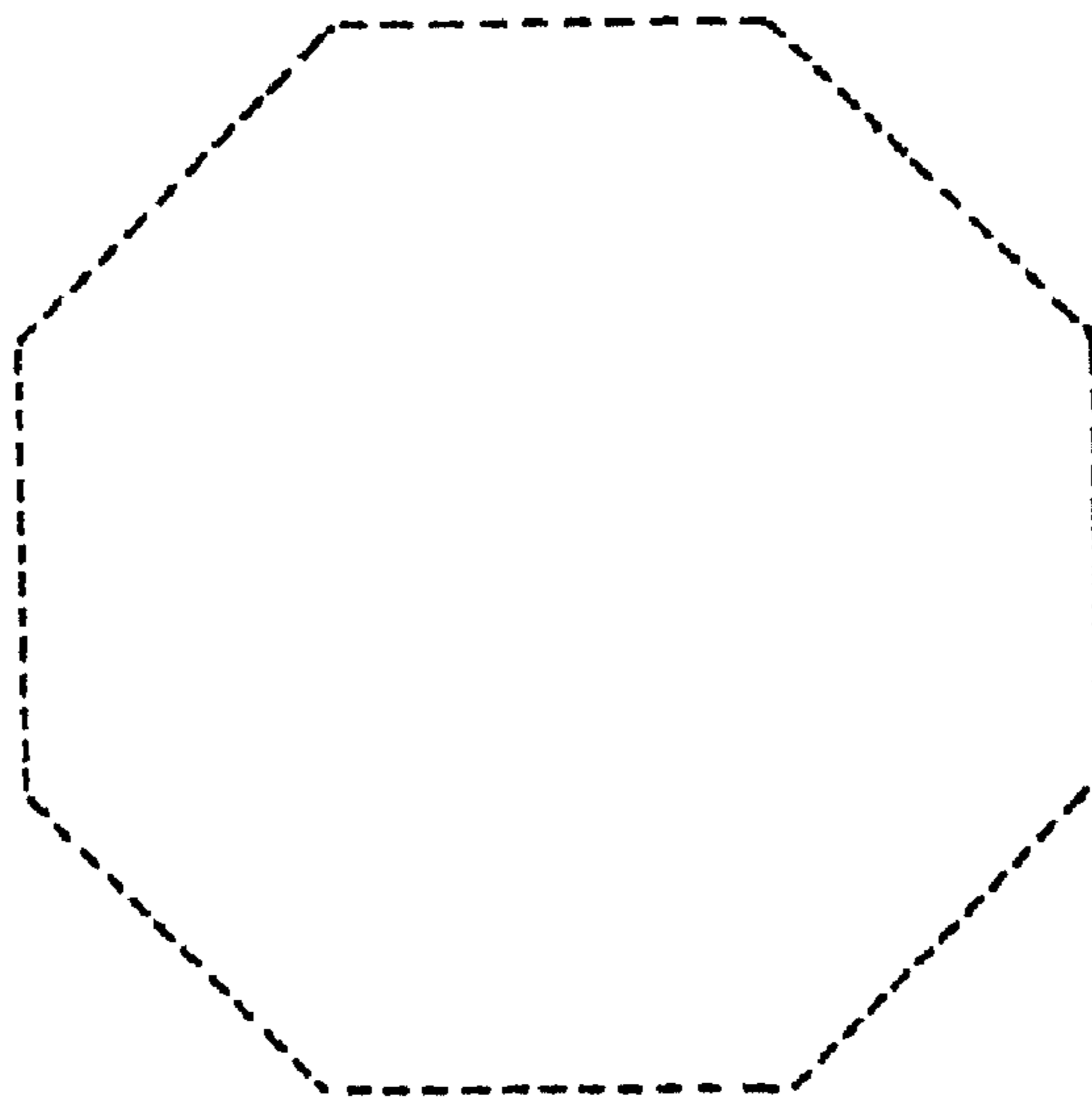

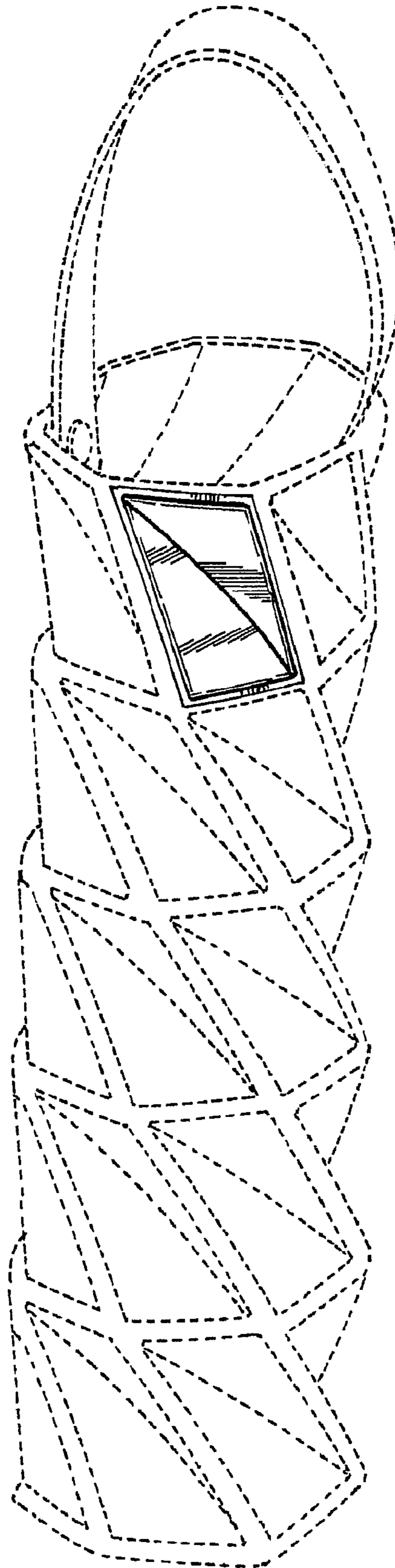




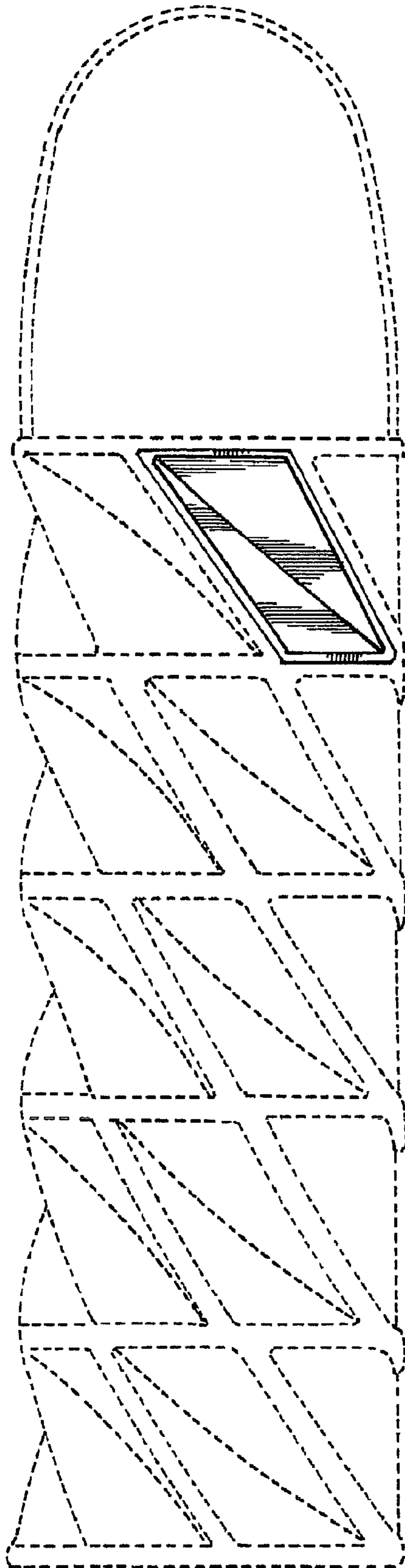

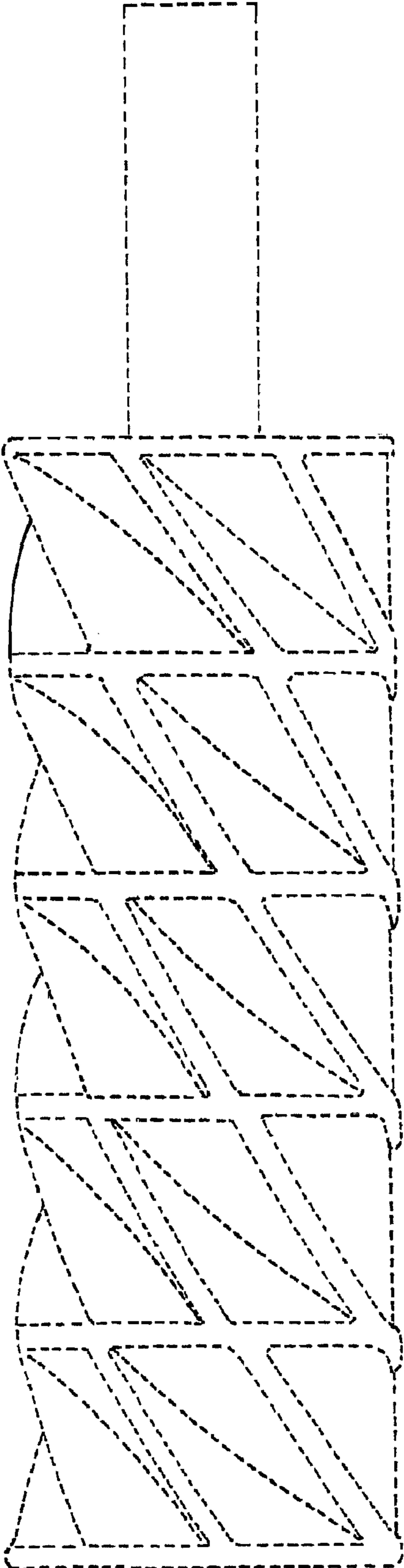
***Fig. 10***



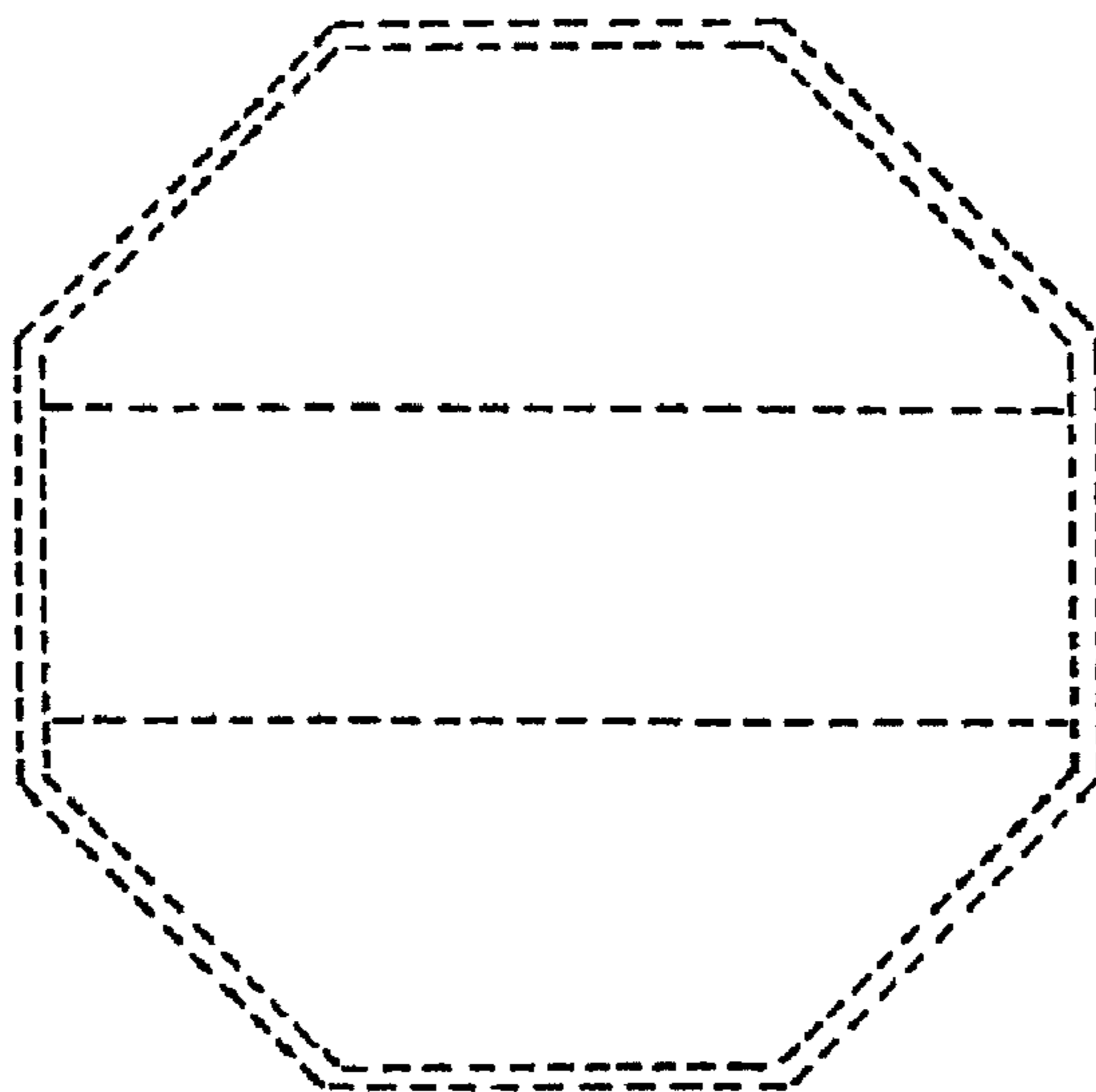

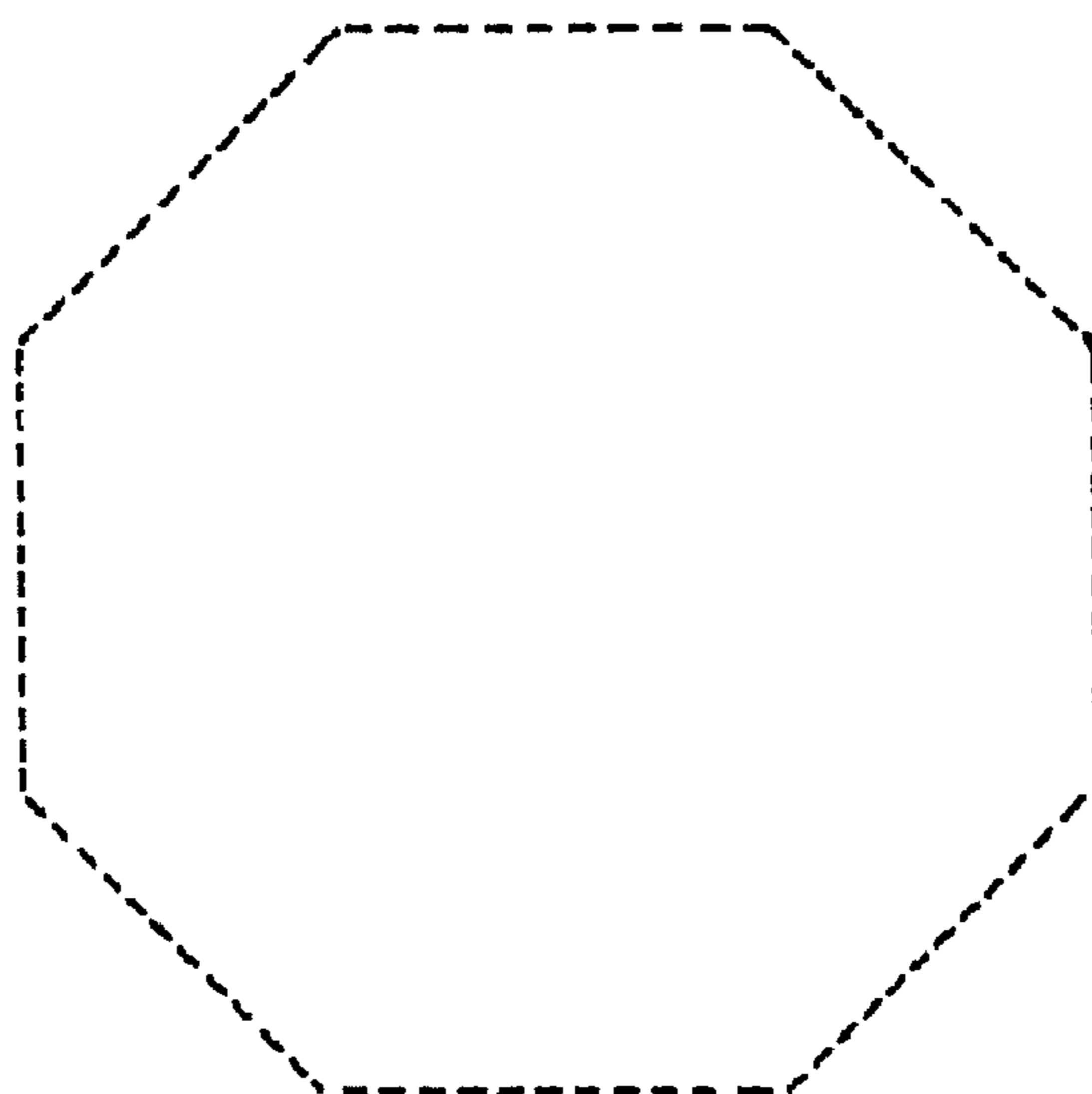
